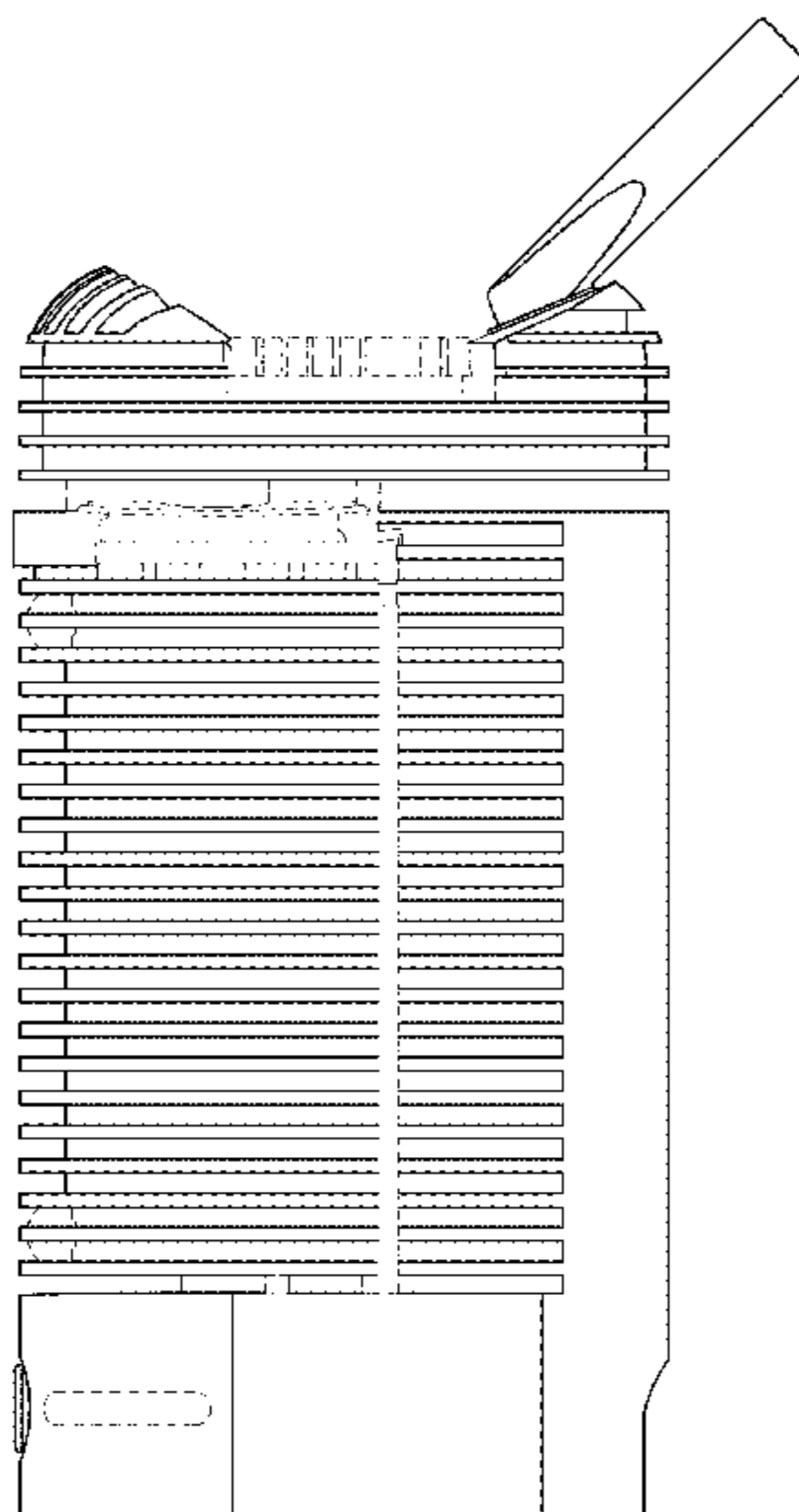
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a left side view of the evaporator; FIG. 2 is a rear side view thereof; FIG. 3 is a top view thereof; FIG. 4 is a front side view thereof; FIG. 5 is a bottom view thereof; and, FIG. 6 is a right side view thereof. 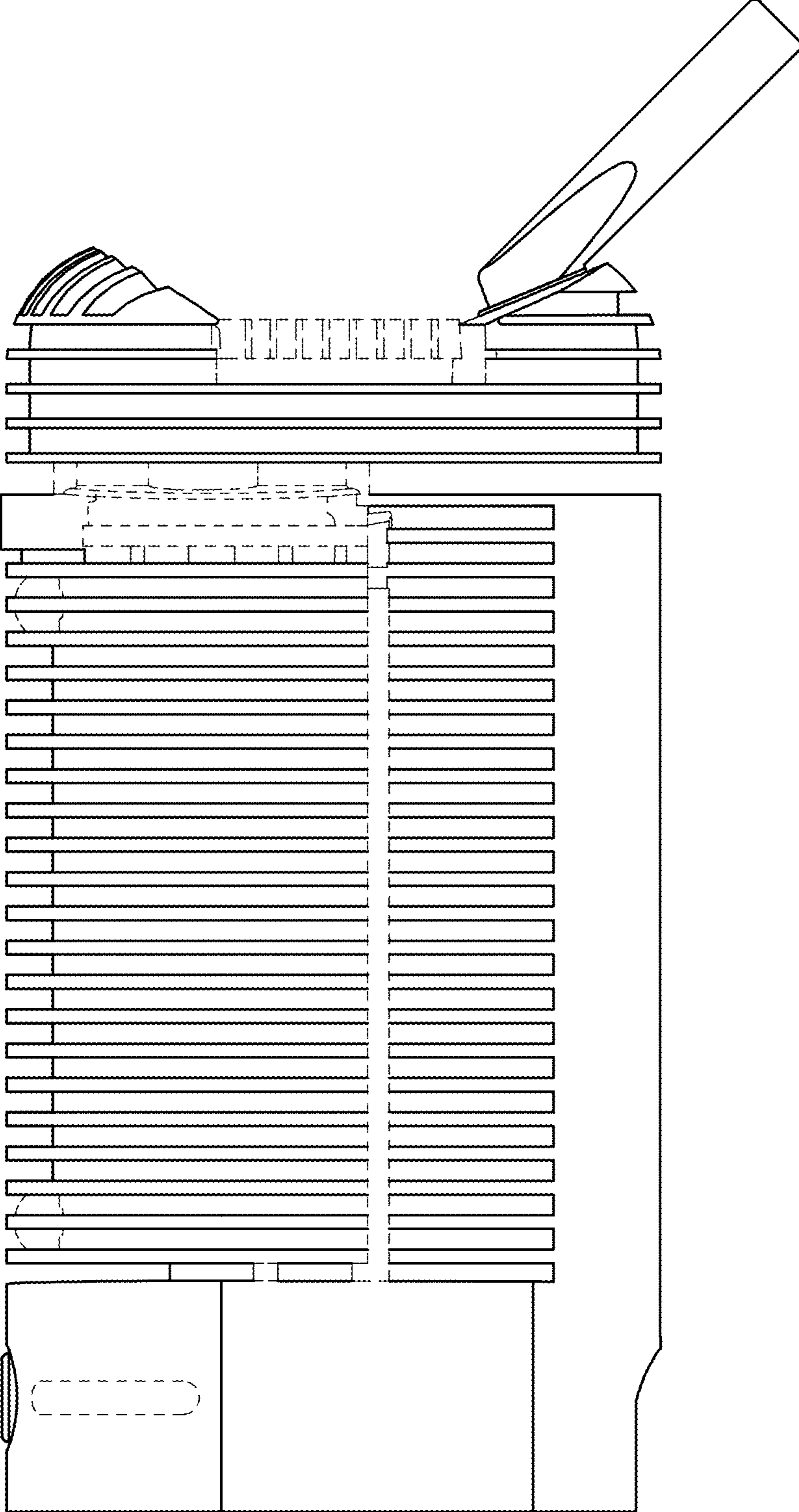

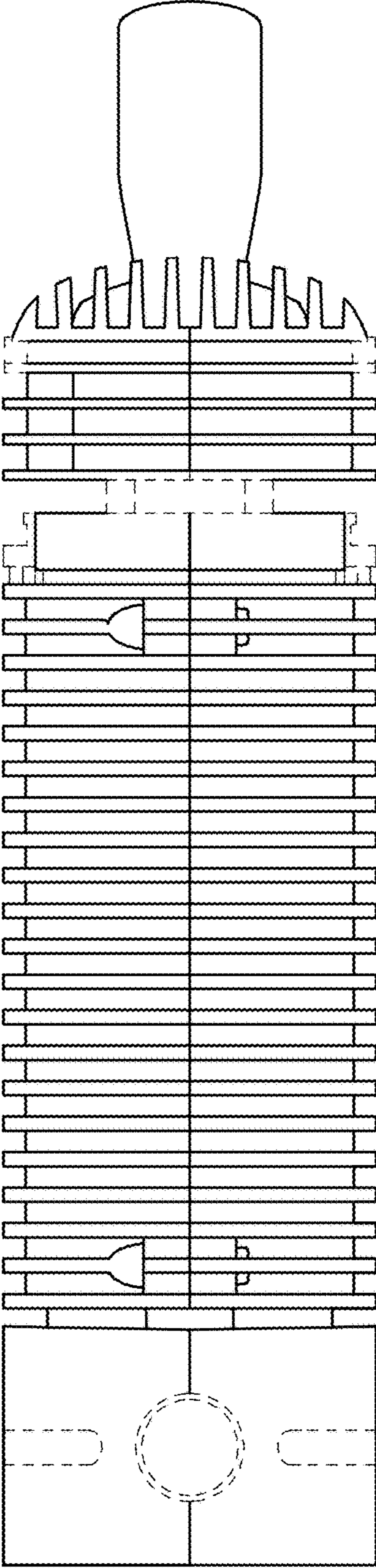

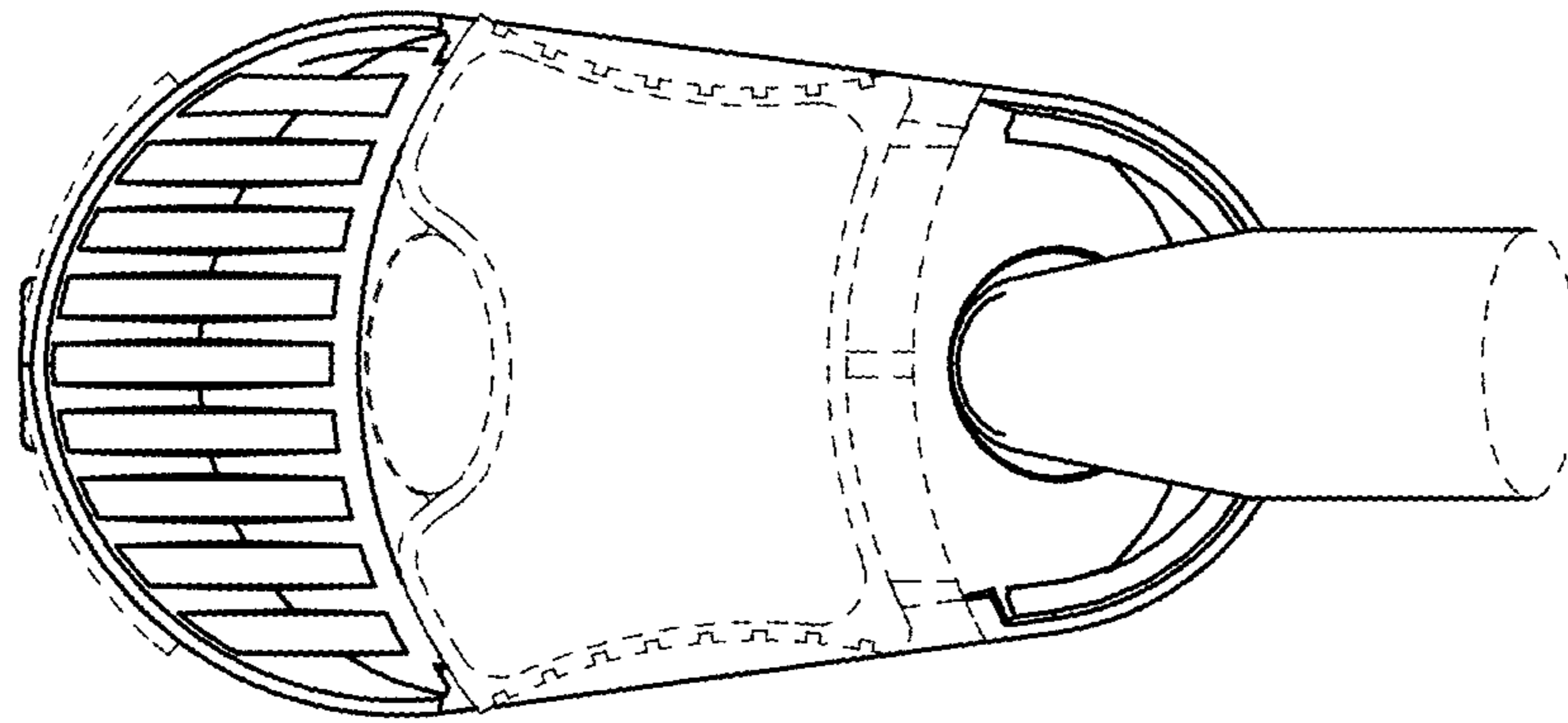

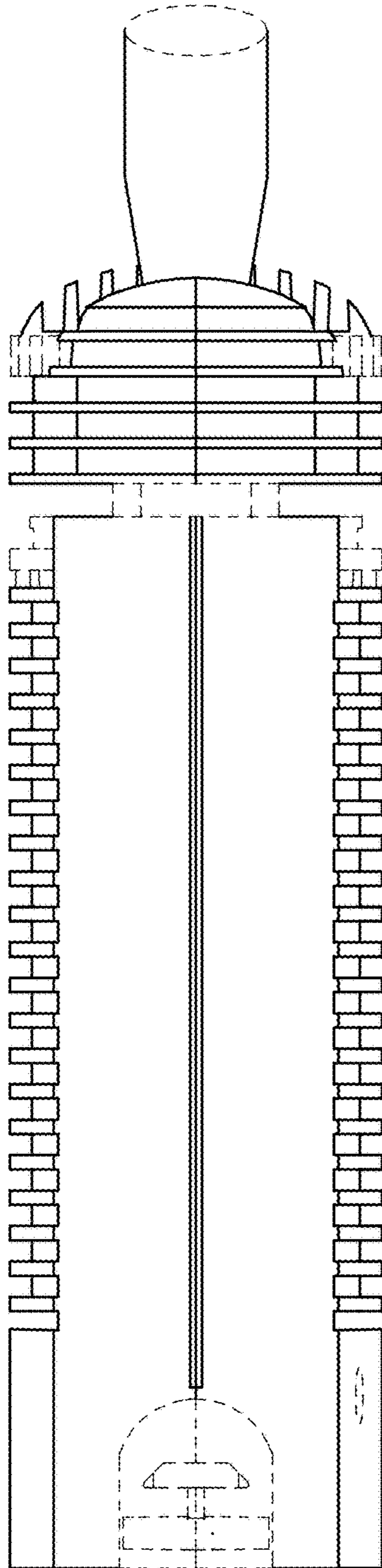

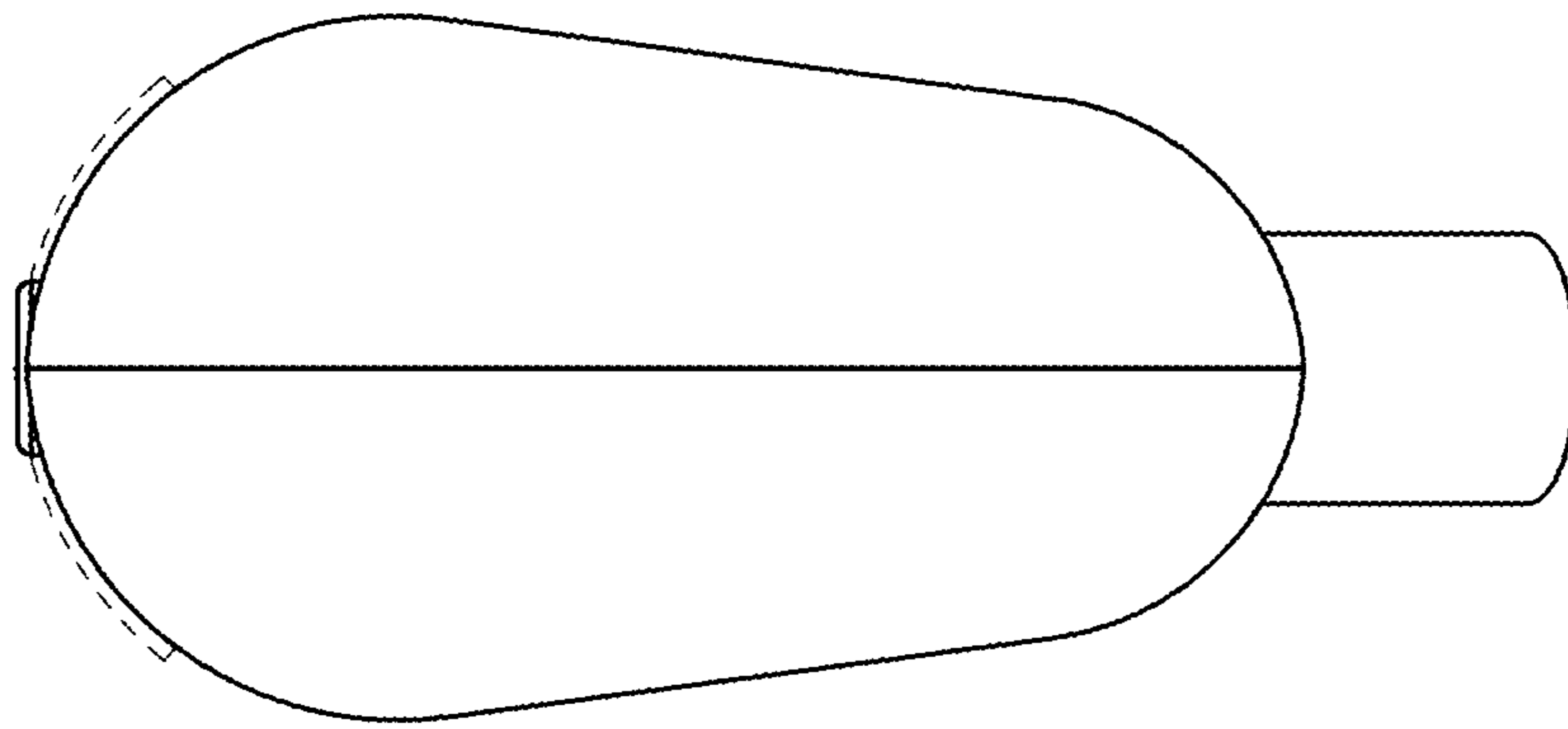

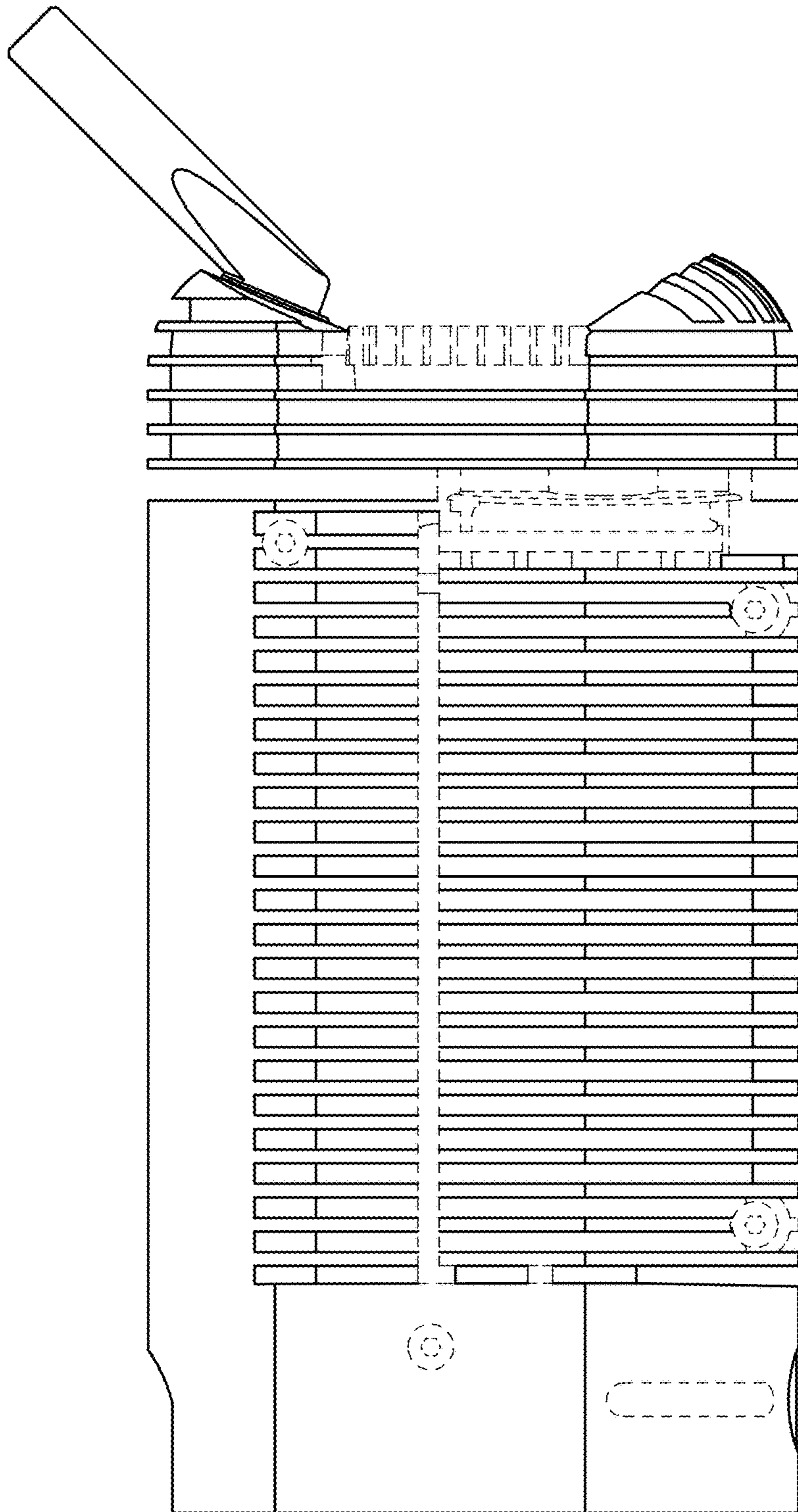
