FIG. 4 depicts a right side elevational view of the eye exam kiosk of the invention.

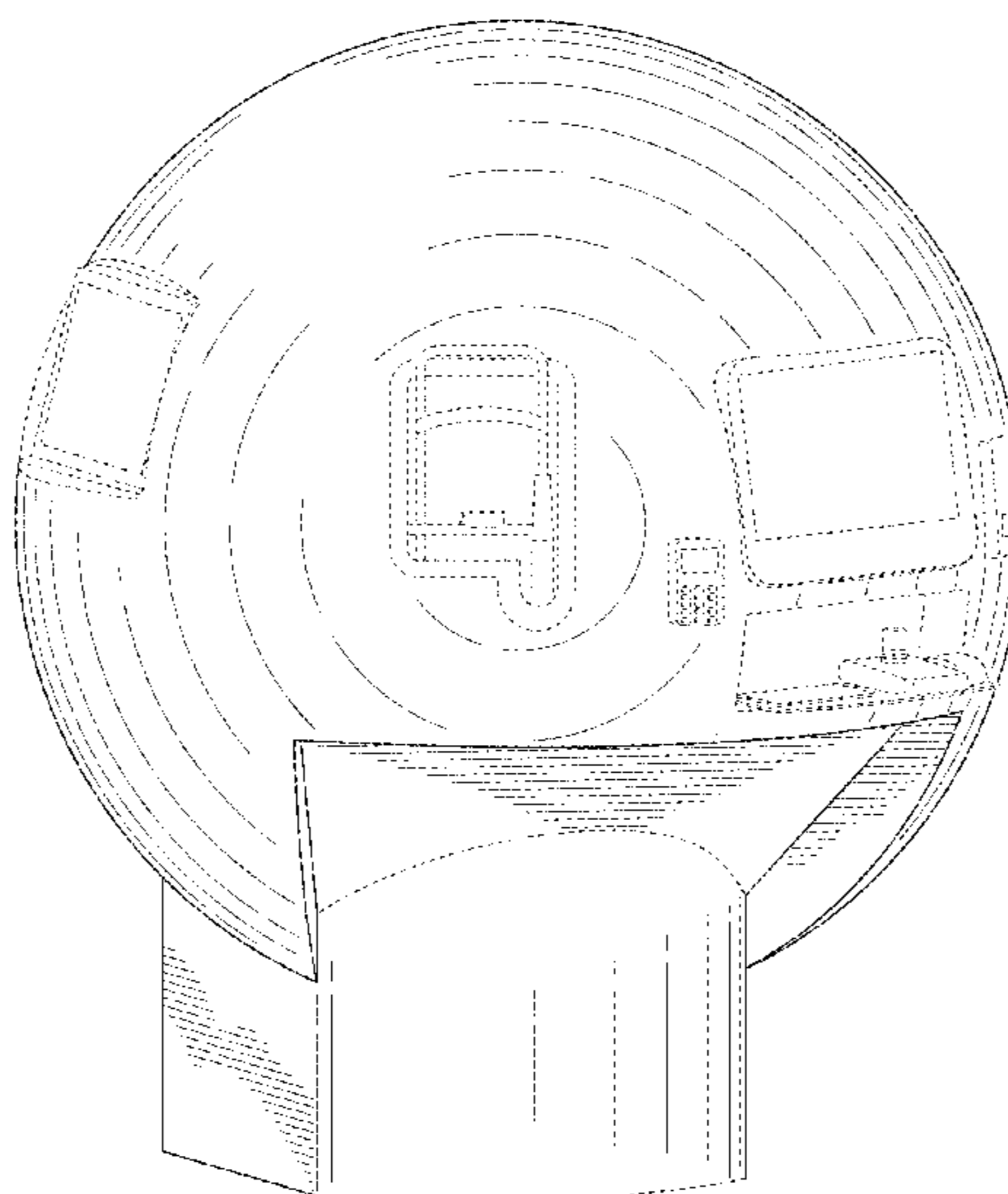
FIG. 5 depicts a left side elevational view of rod holder of the invention.

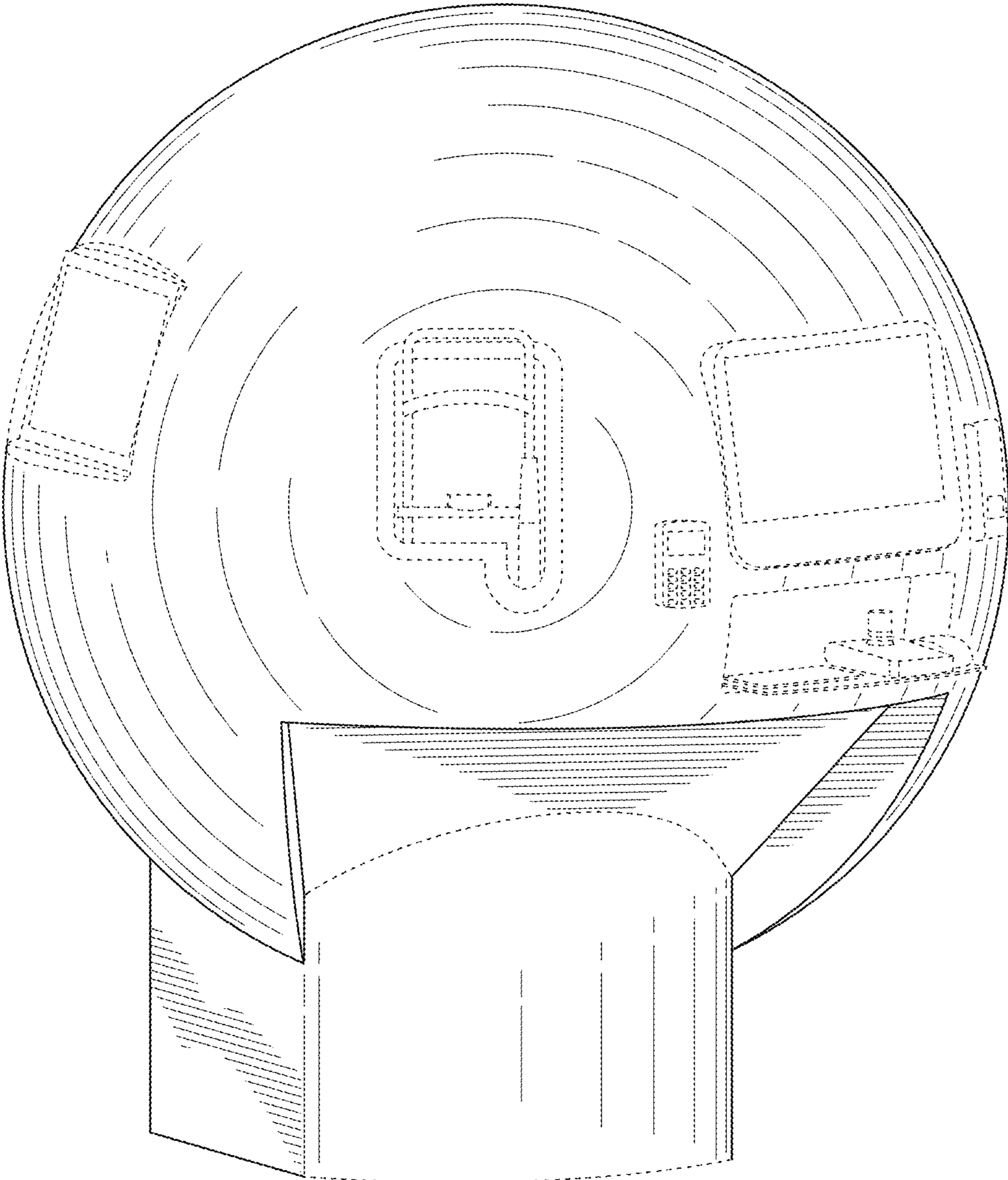

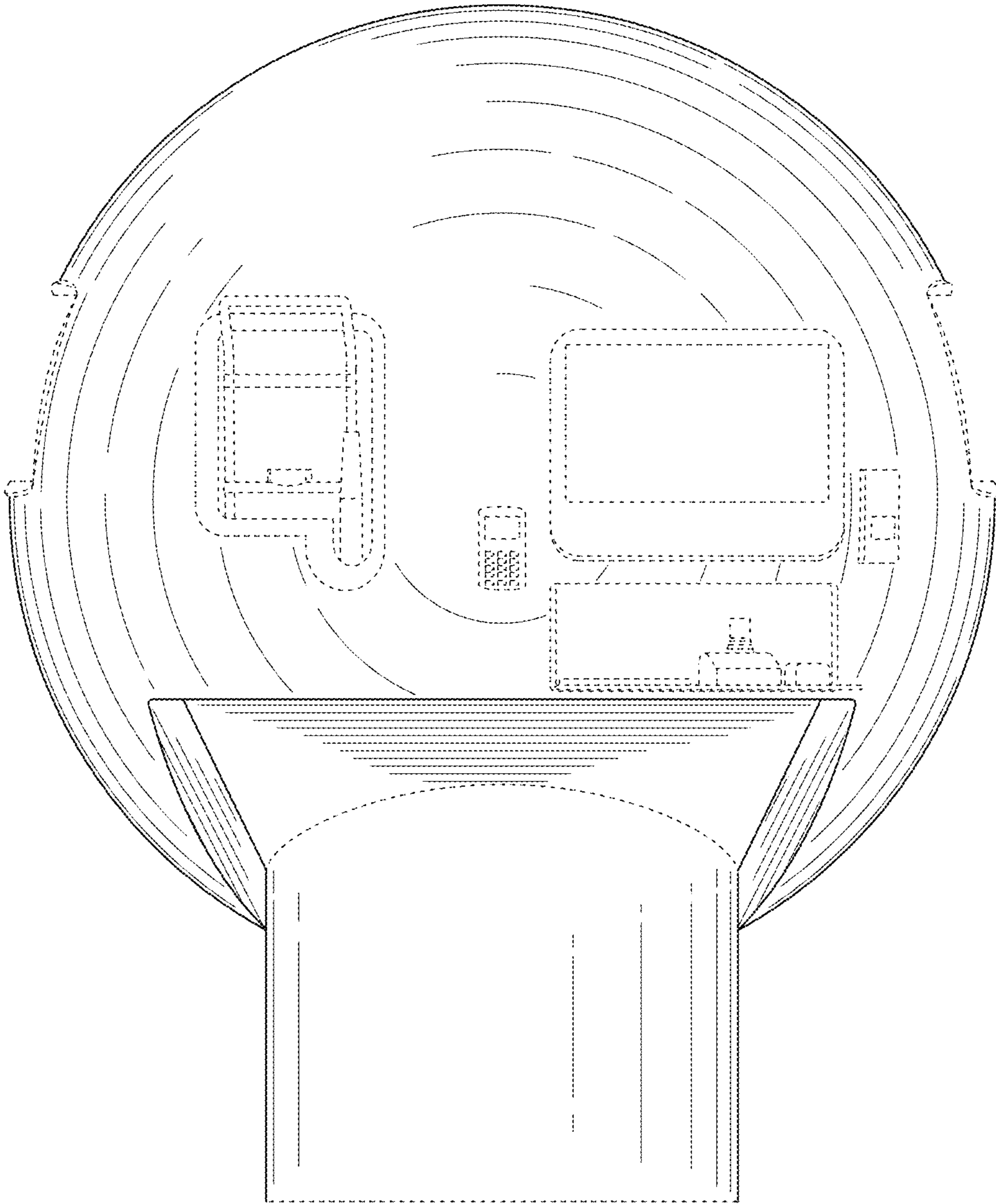

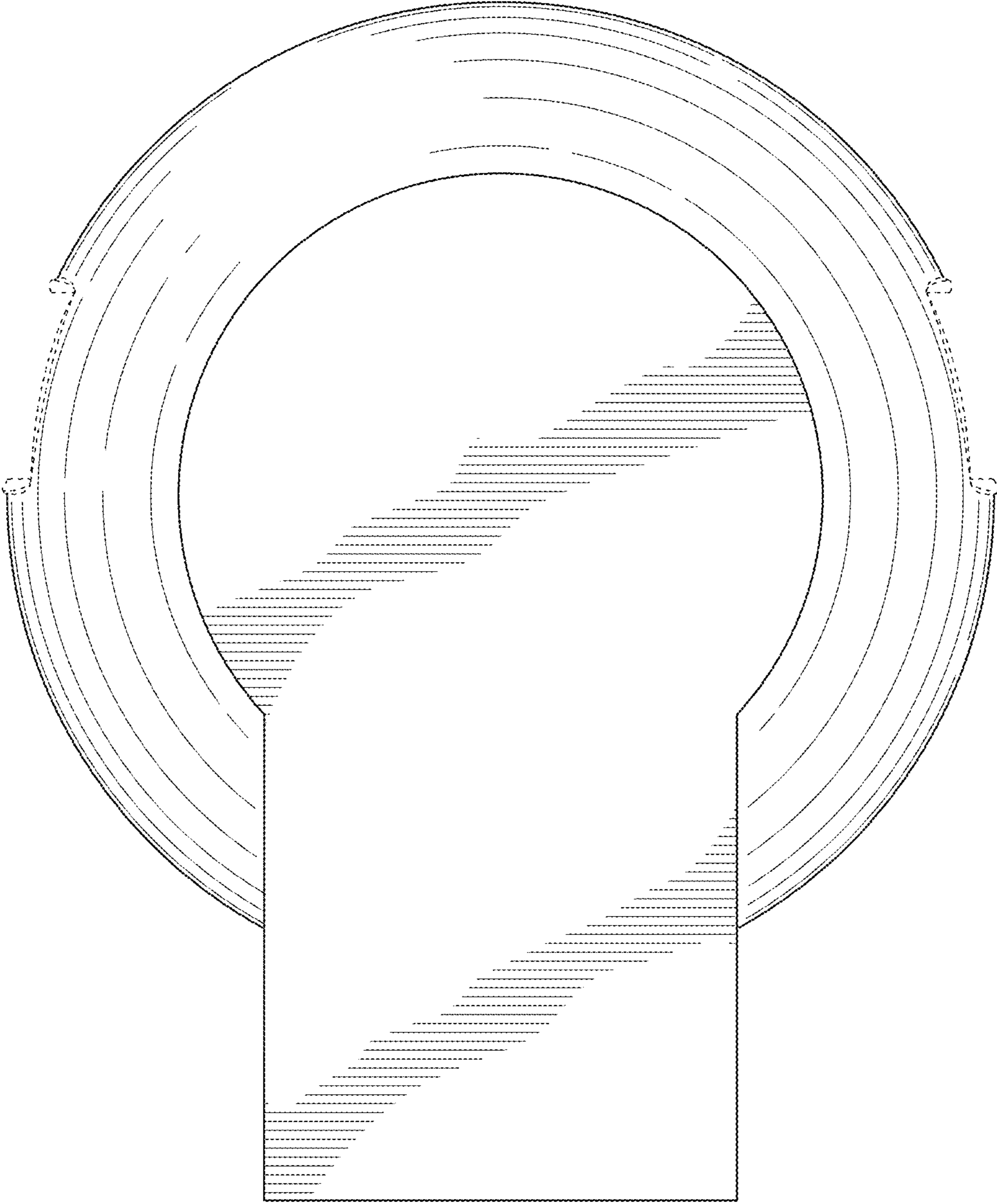

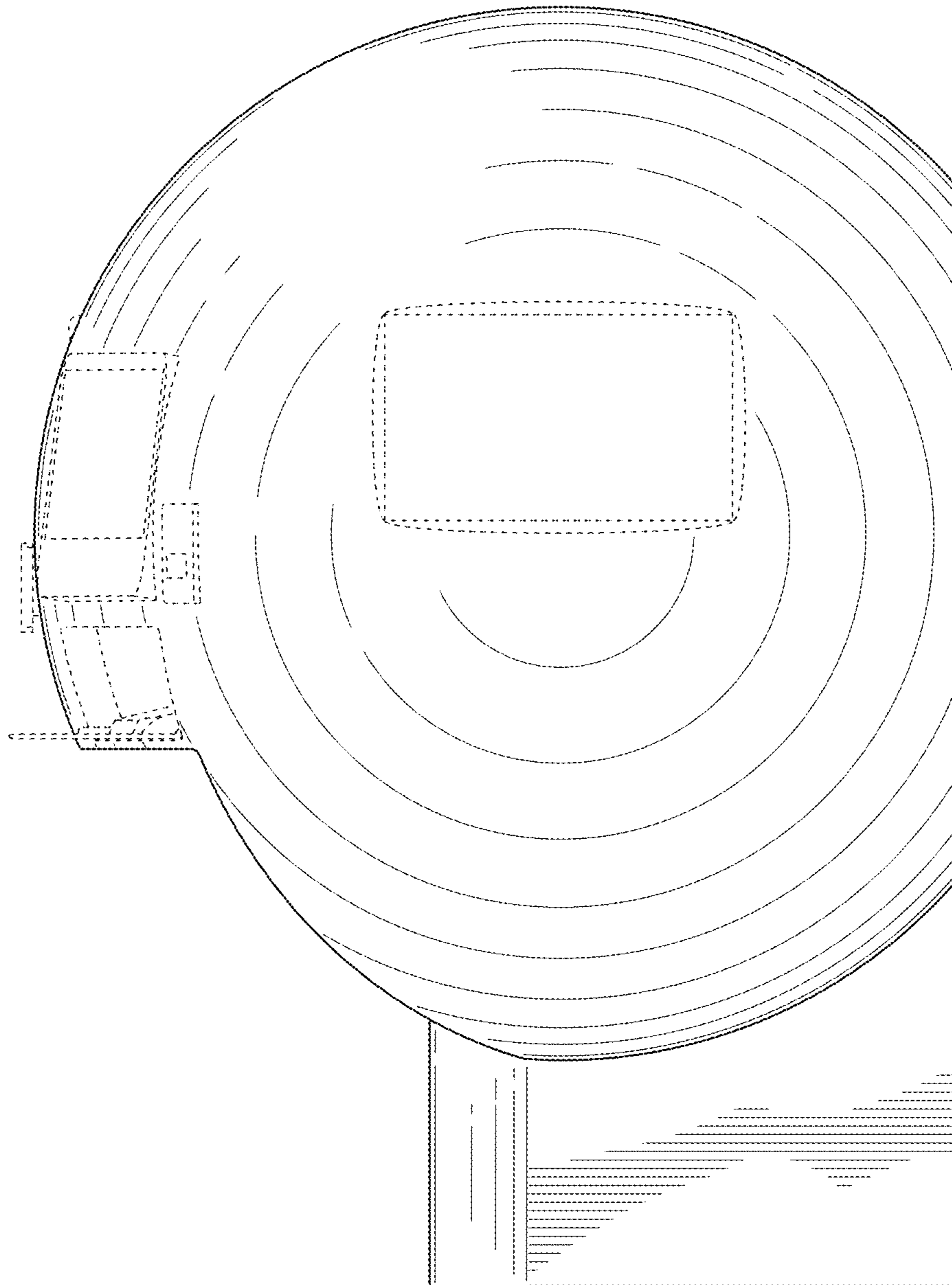

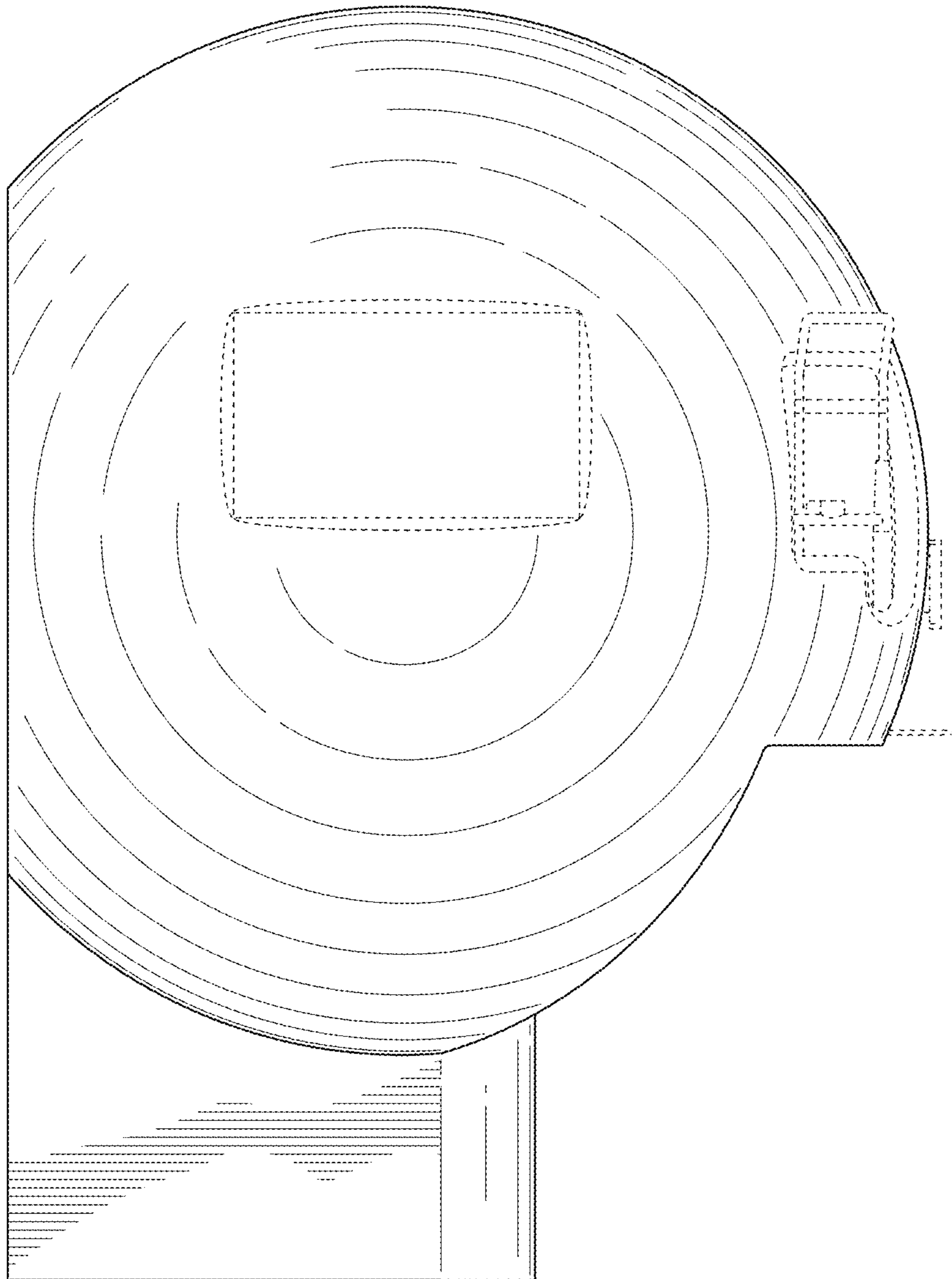

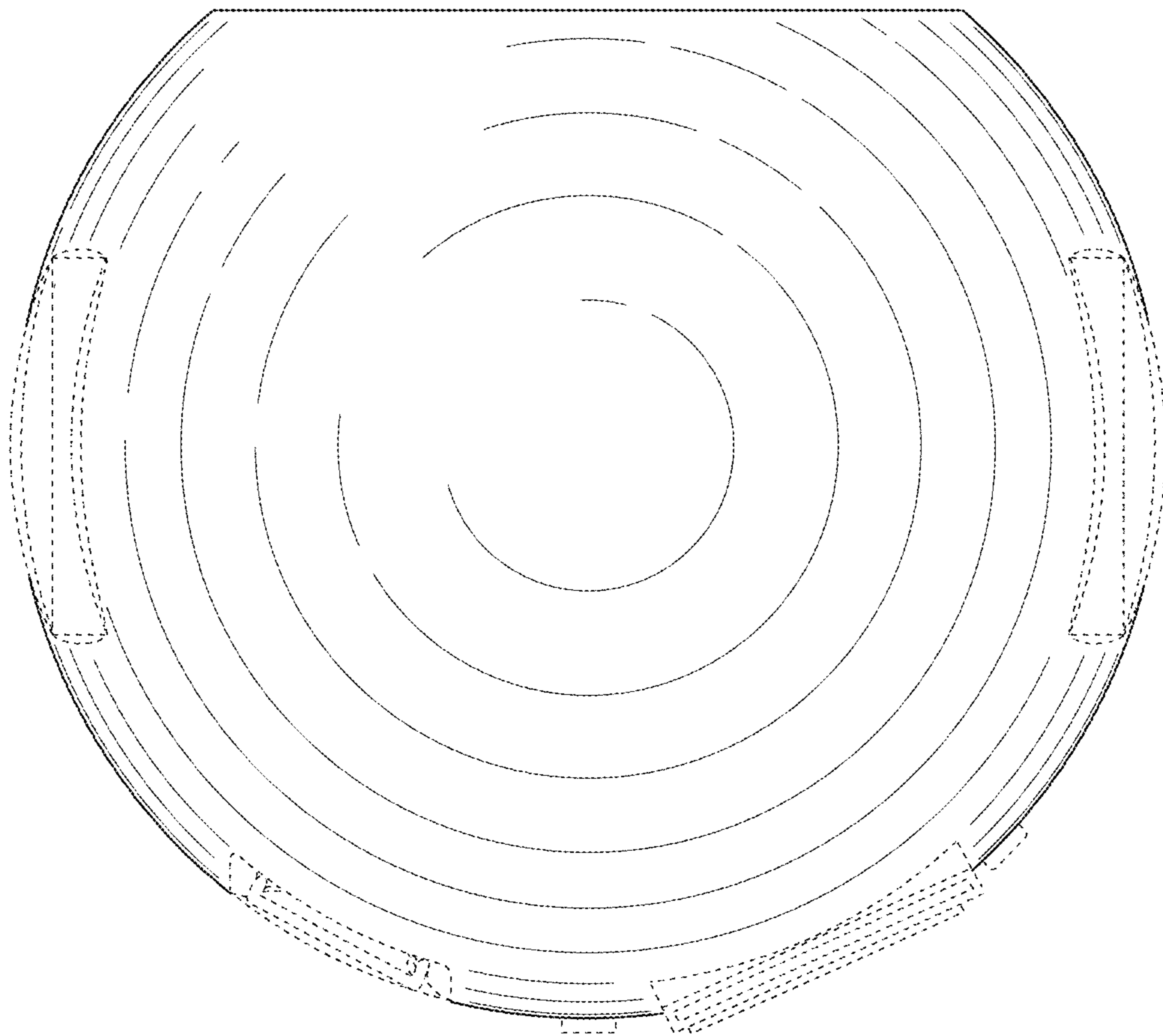

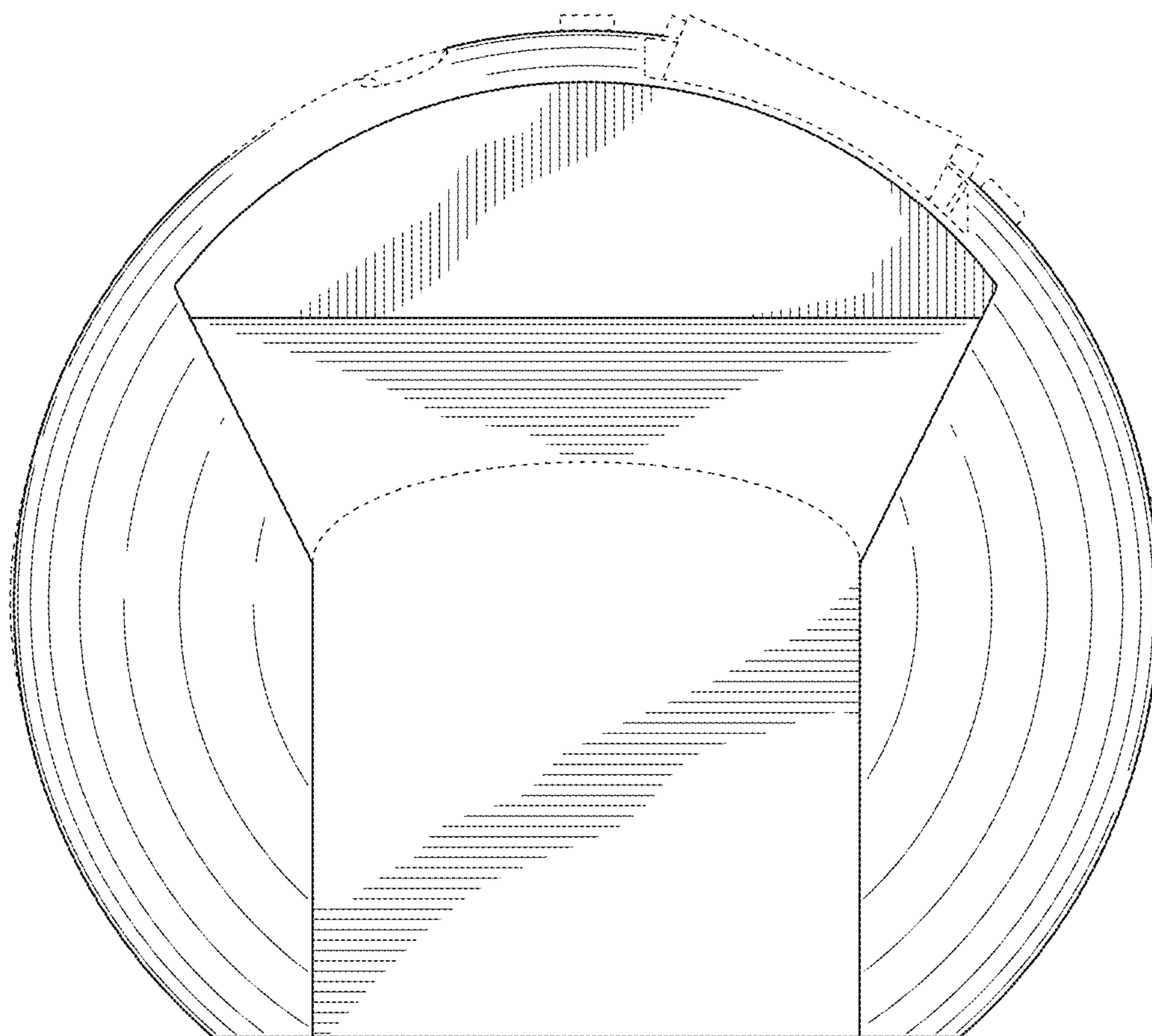
