(57) **CLAIM**

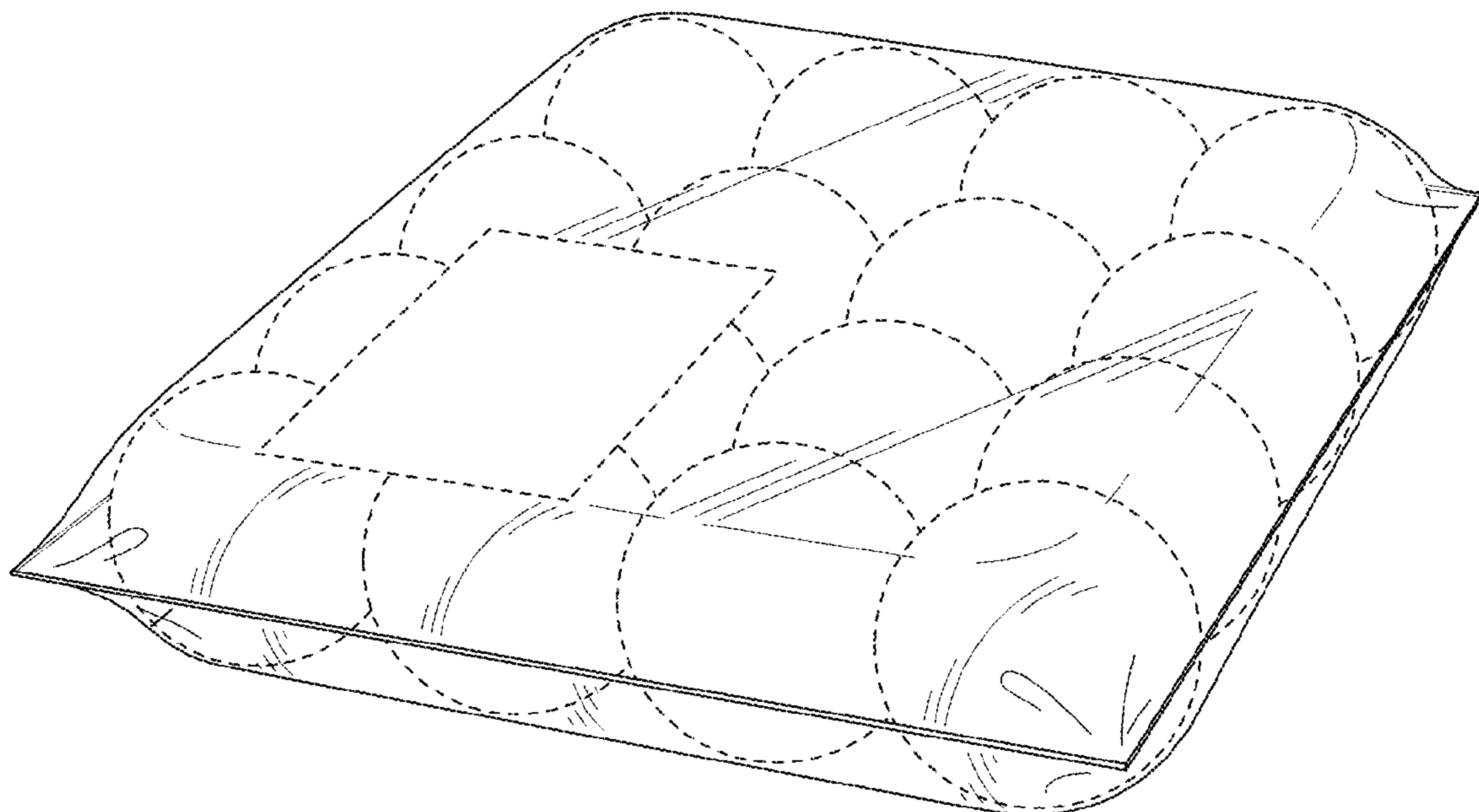
The ornamental design for a therapeutic bag, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the therapeutic bag. FIG. 2 is an enlarged top view of the therapeutic bag. FIG. 3 is an enlarged bottom view of the therapeutic bag. FIG. 4 is an enlarged front view of the therapeutic bag. FIG. 5 is an enlarged rear view of the therapeutic bag. FIG. 6 is an enlarged left side view of the therapeutic bag; and, FIG. 7 is an enlarged right side view of the therapeutic bag. The therapeutic bag can be sat upon by a human user for a therapeutic effect. The broken line showing of balls within the bag and a label on the bag is for the purpose of illustrating environment related to the claimed design and forms no part of the claimed design.

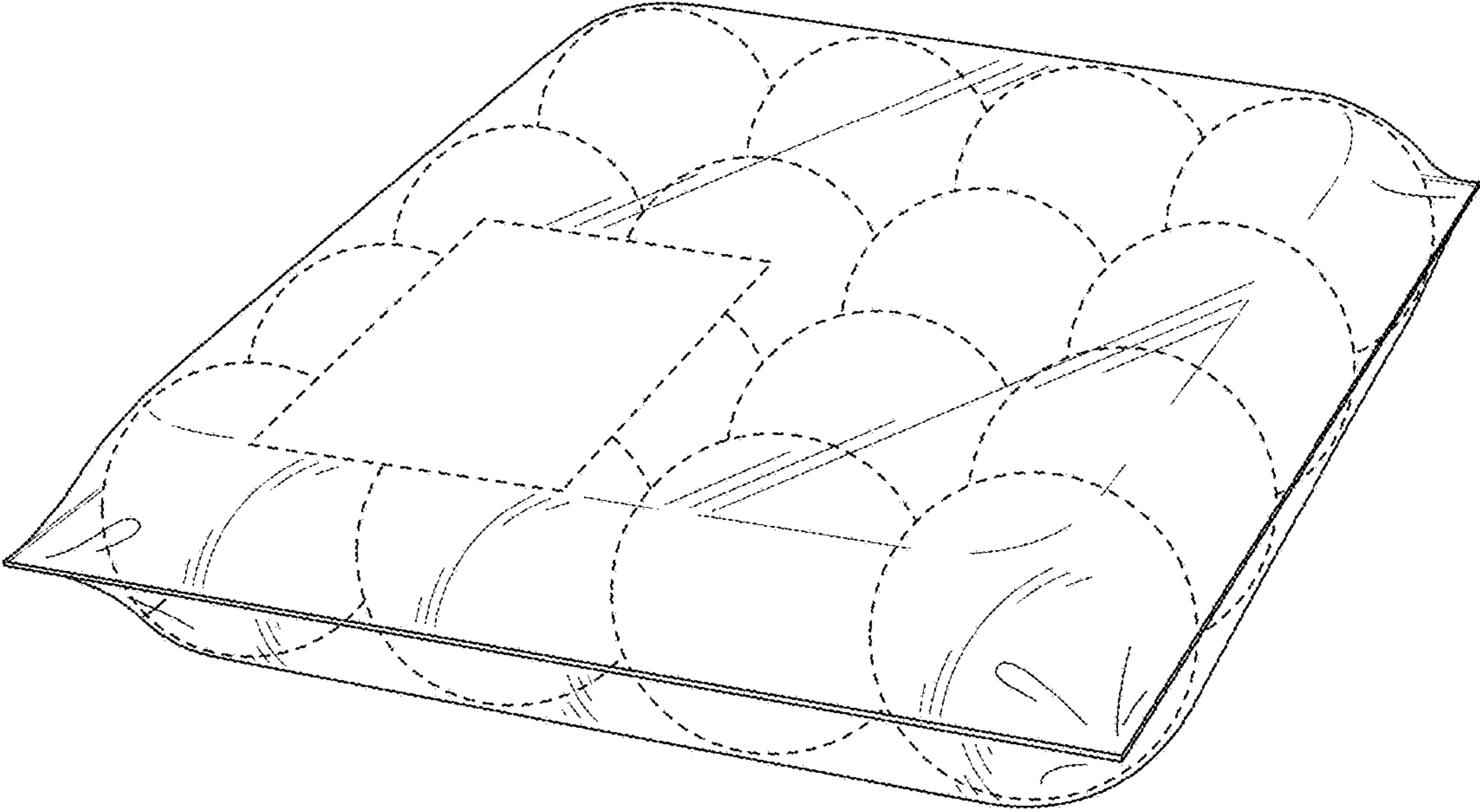

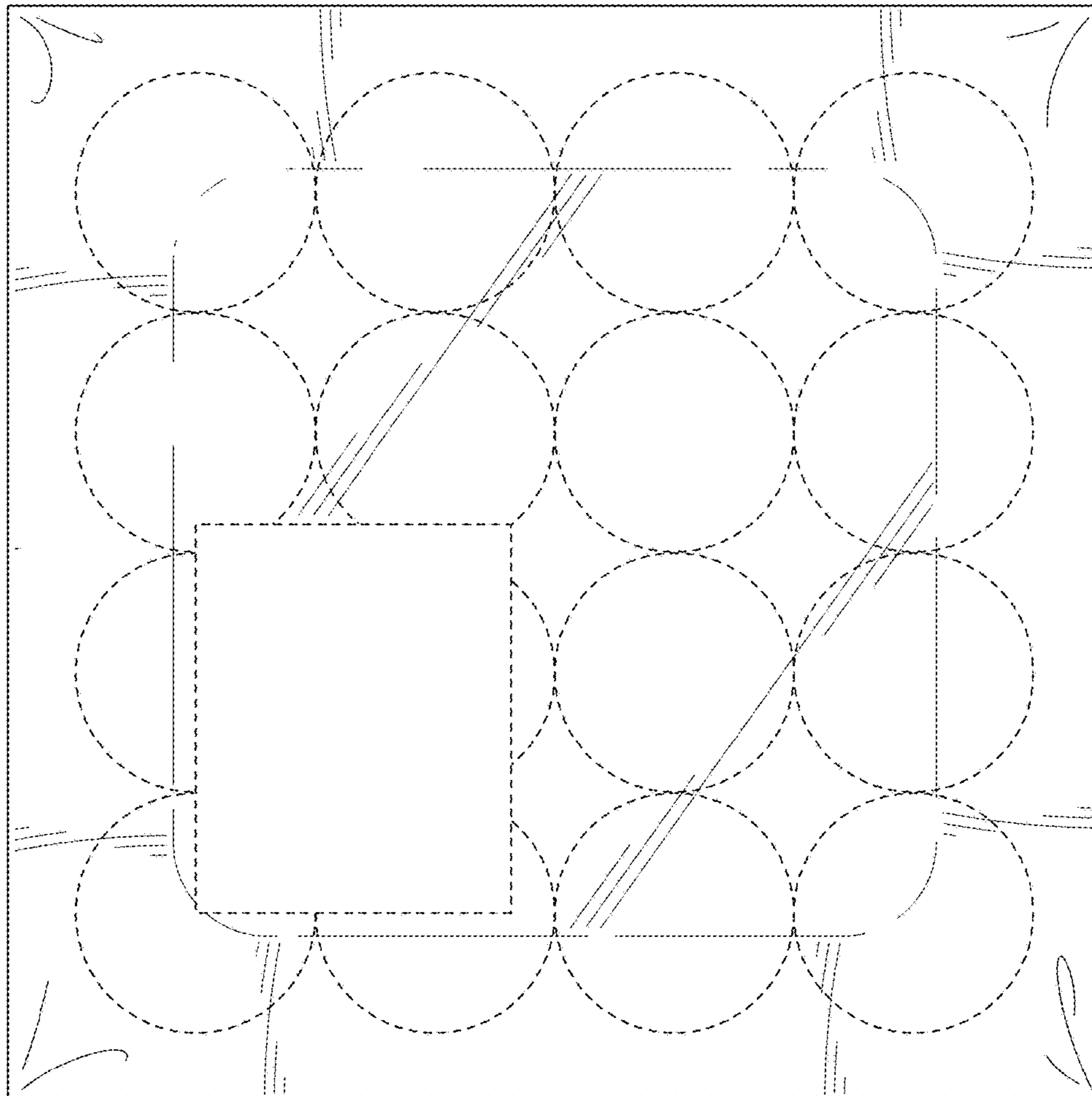

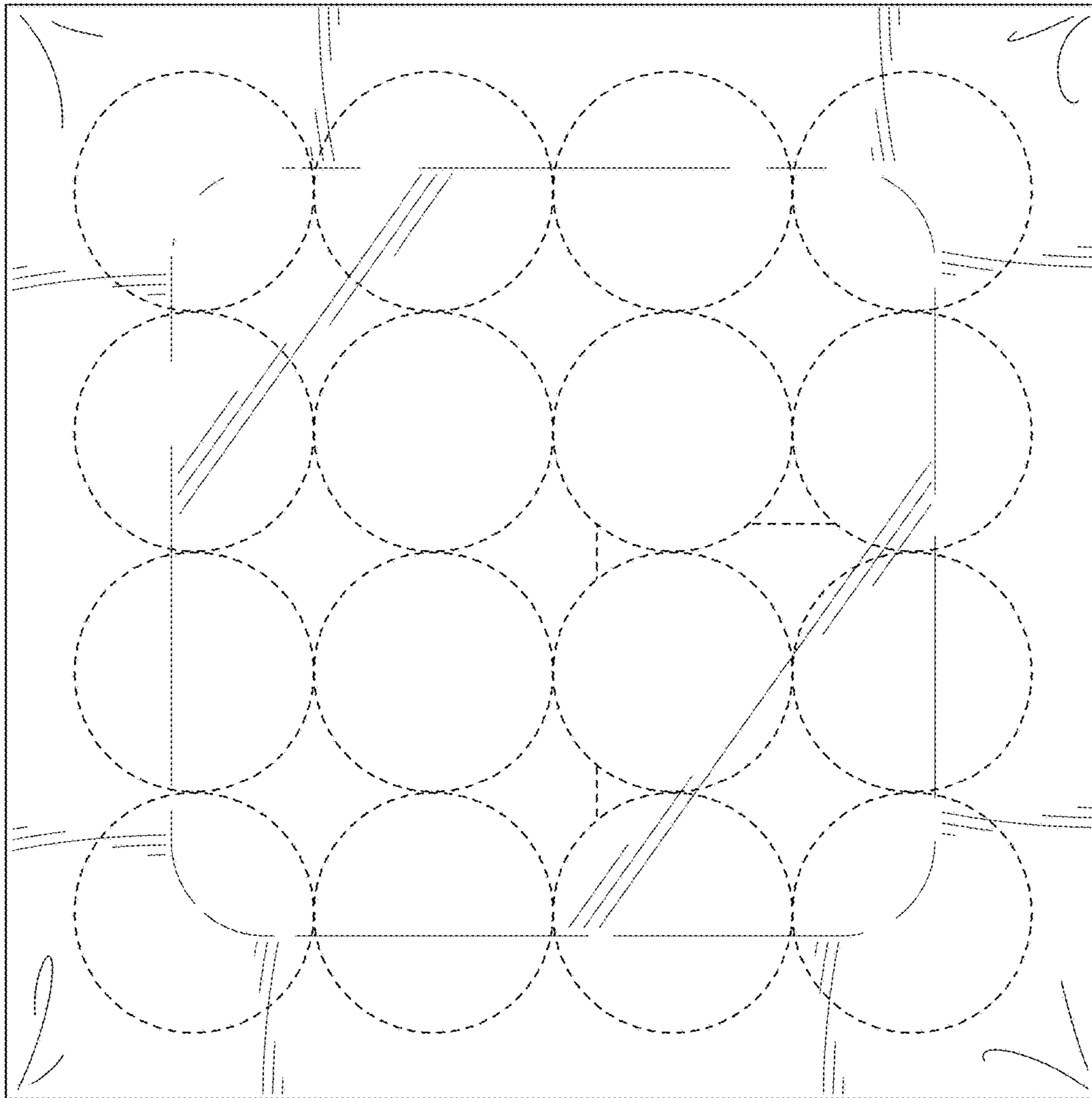

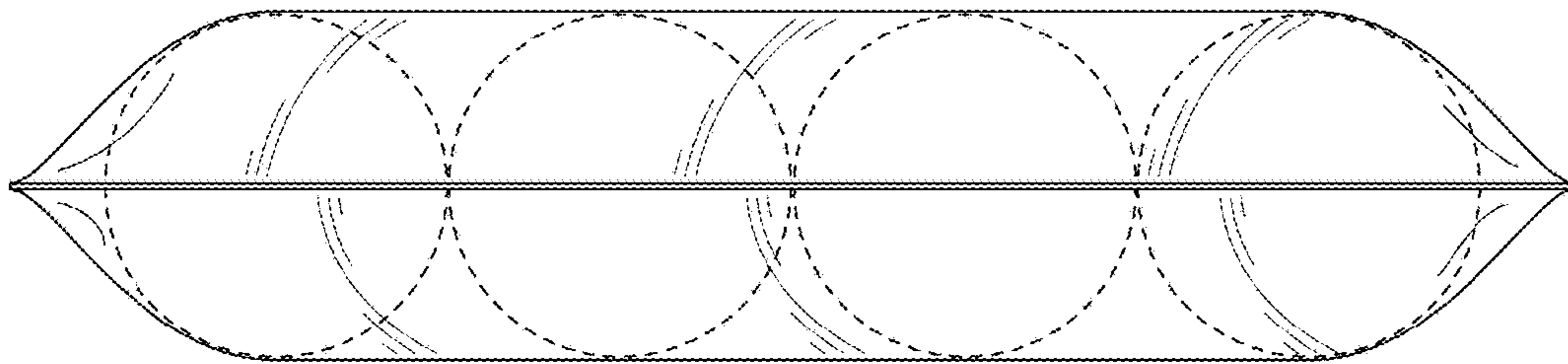

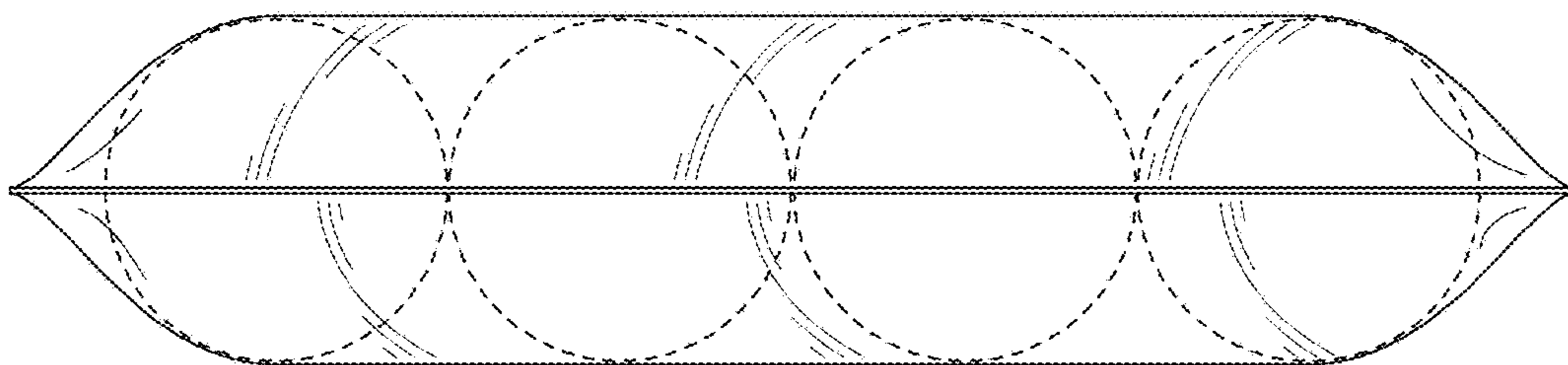

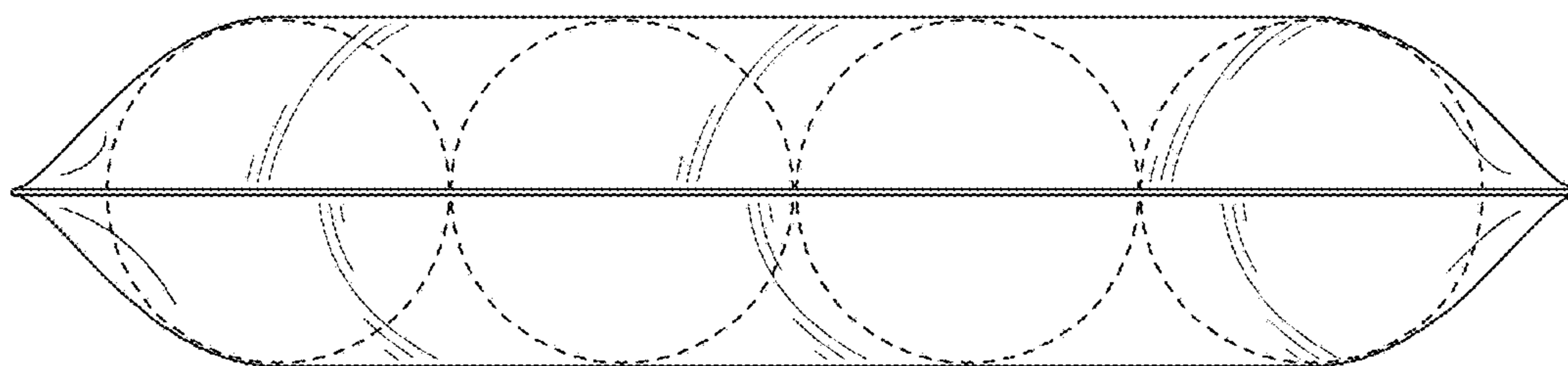

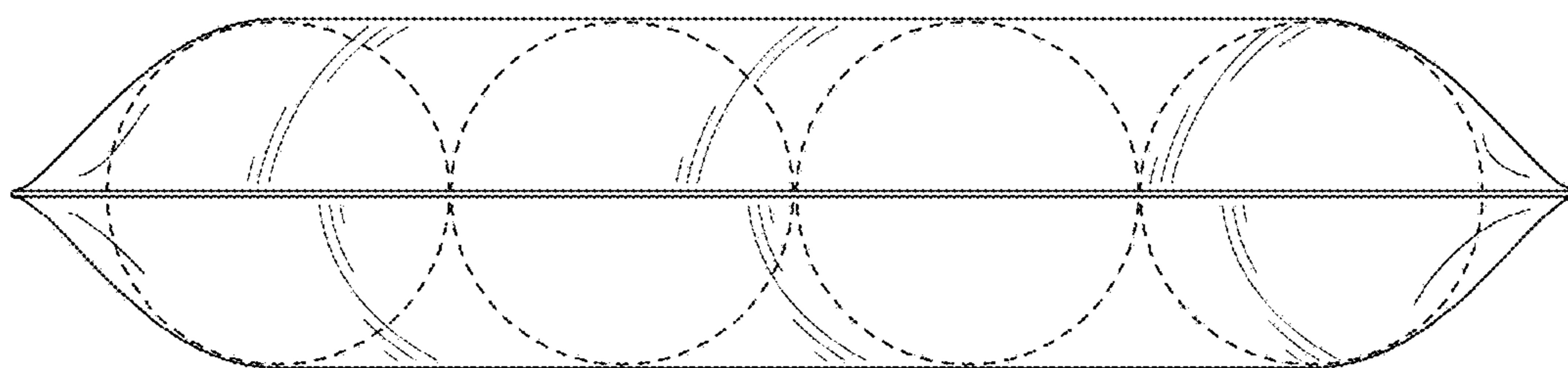
