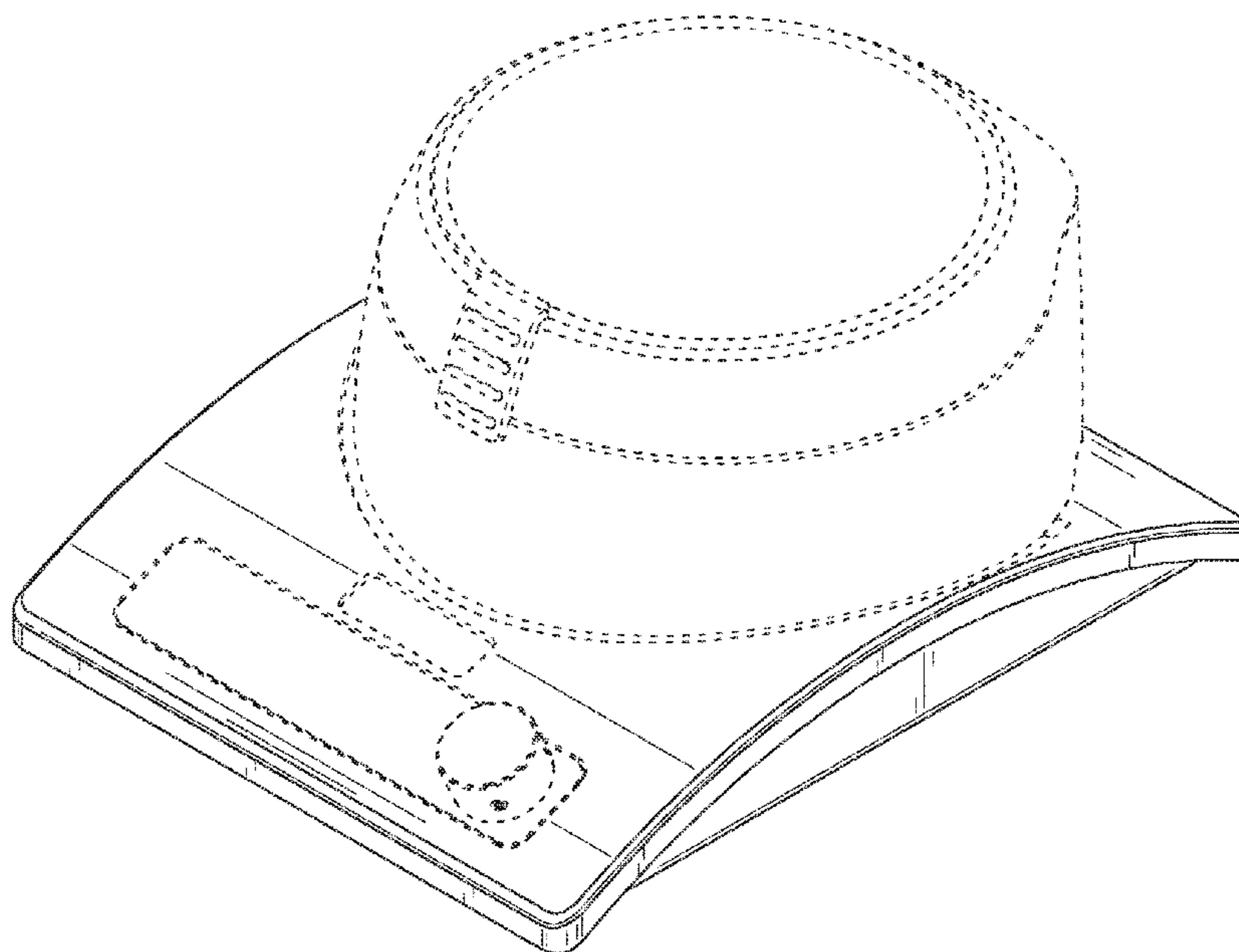
FIG. 1 is a perspective view of a laboratory device according to a first embodiment of the present invention.

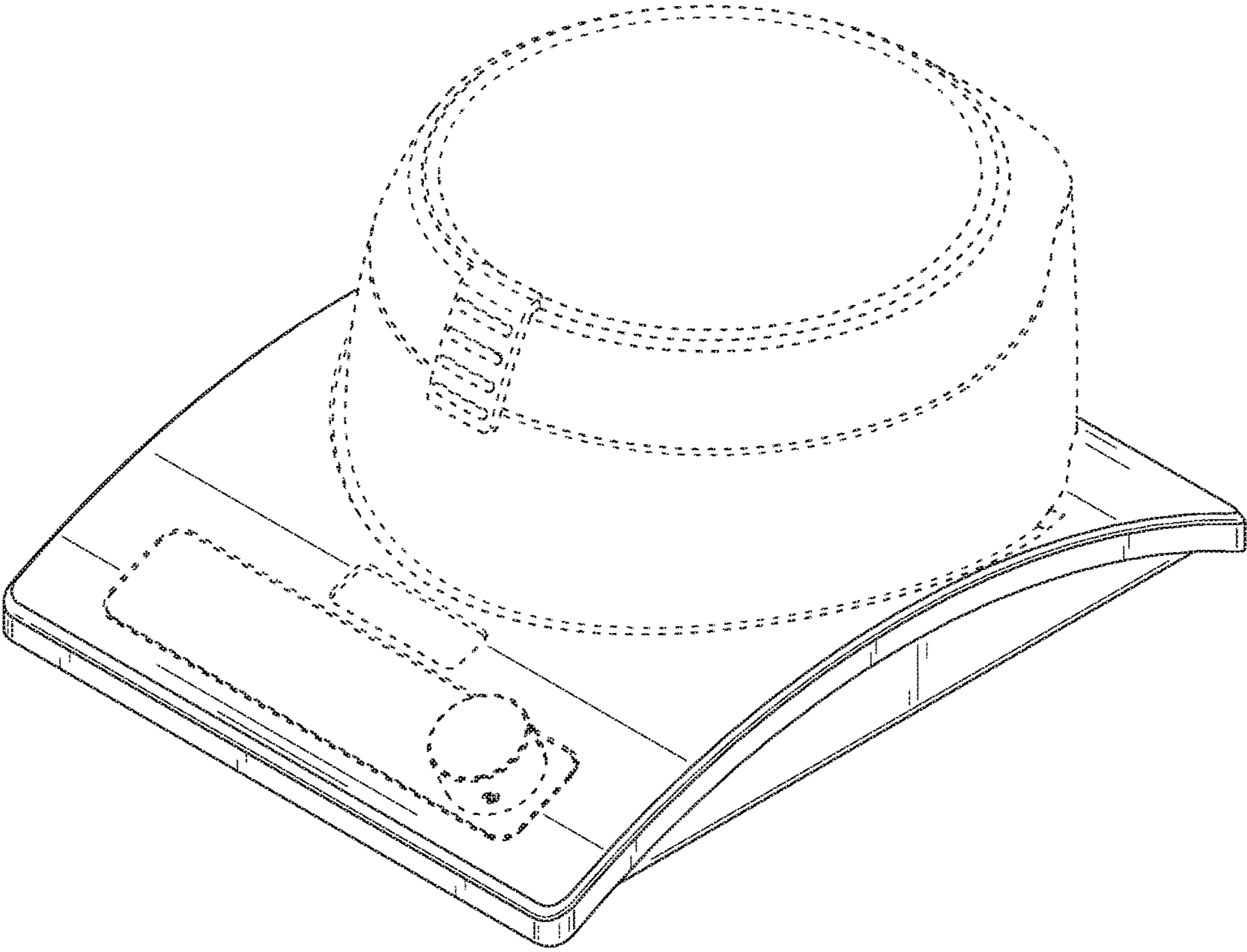

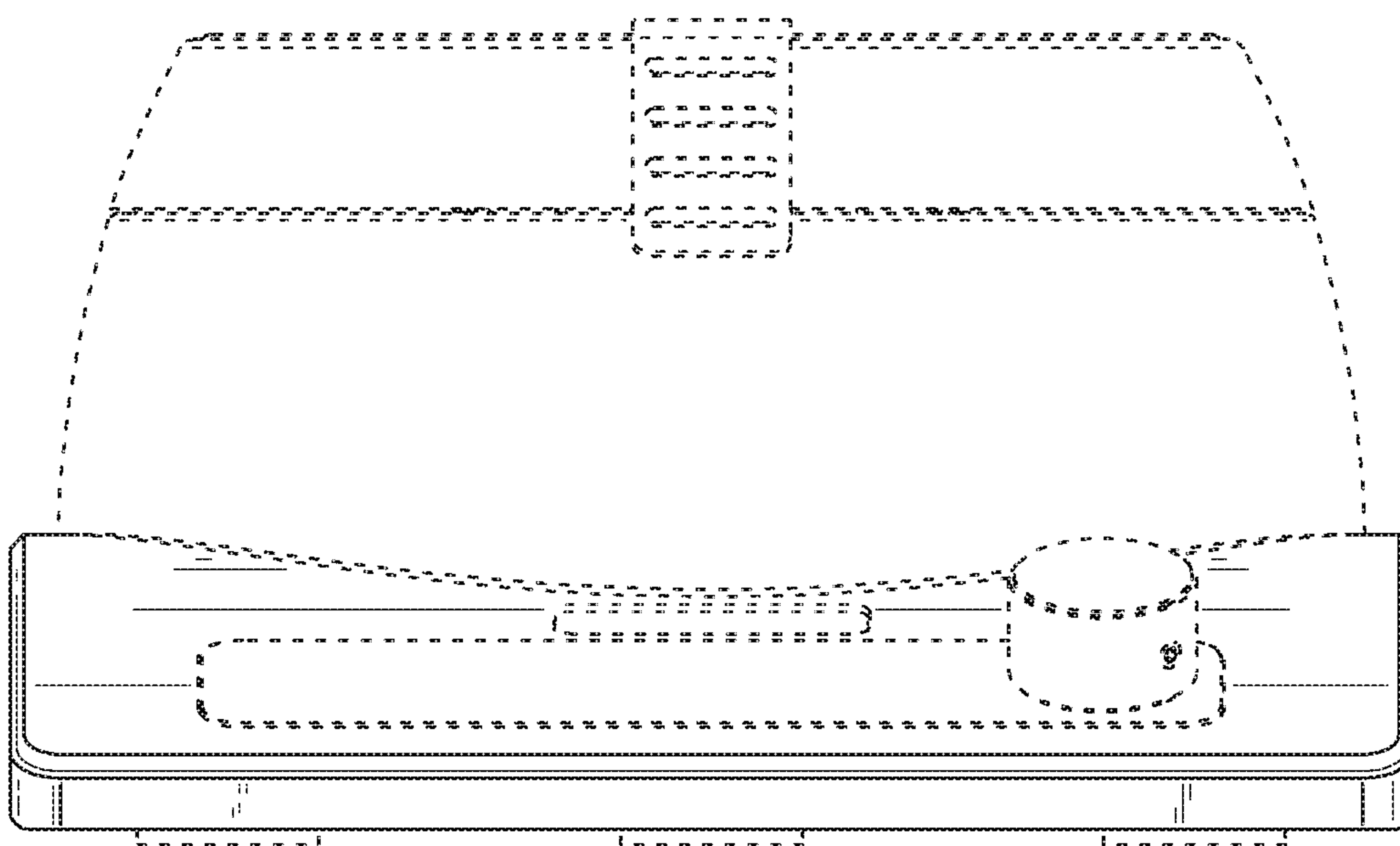

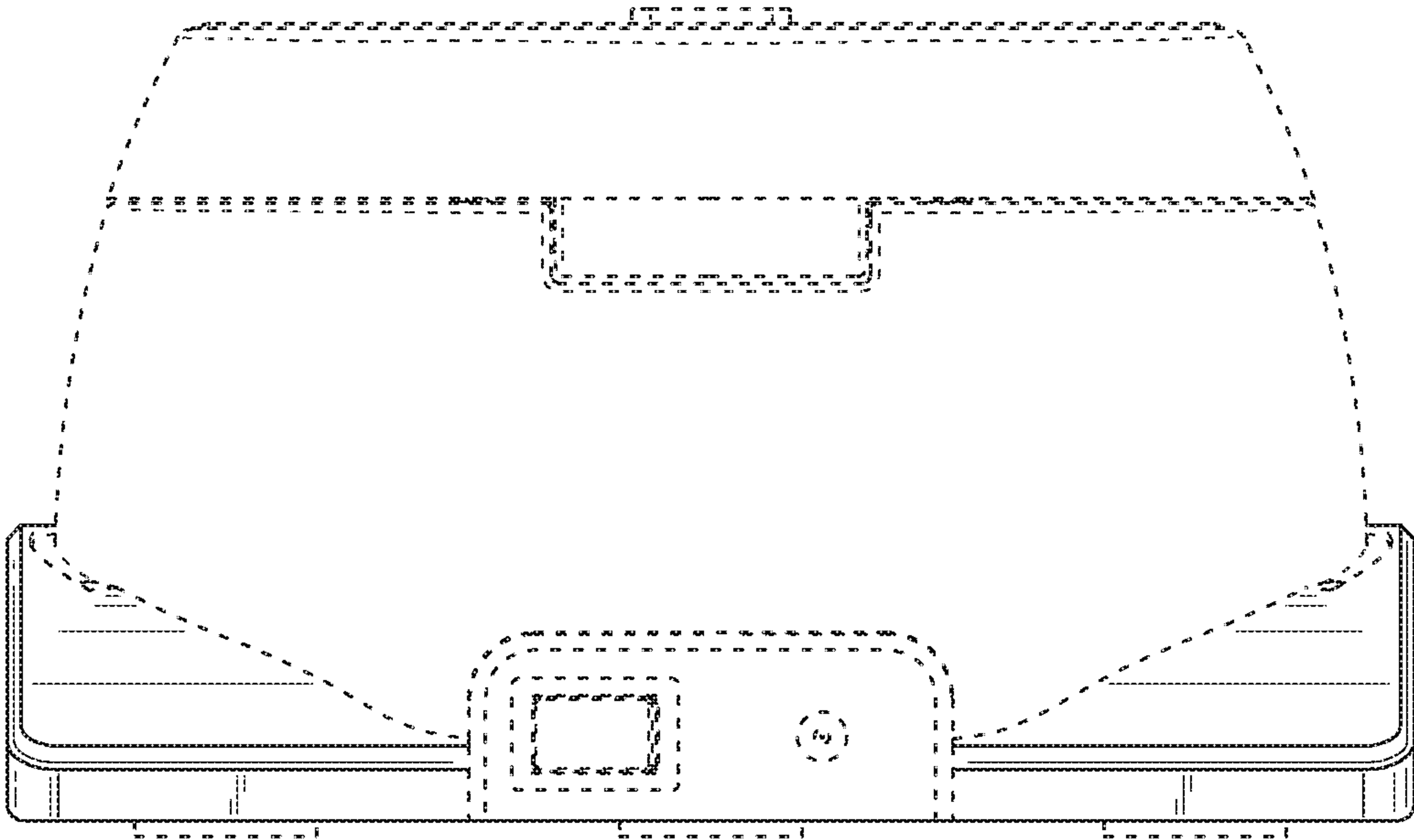

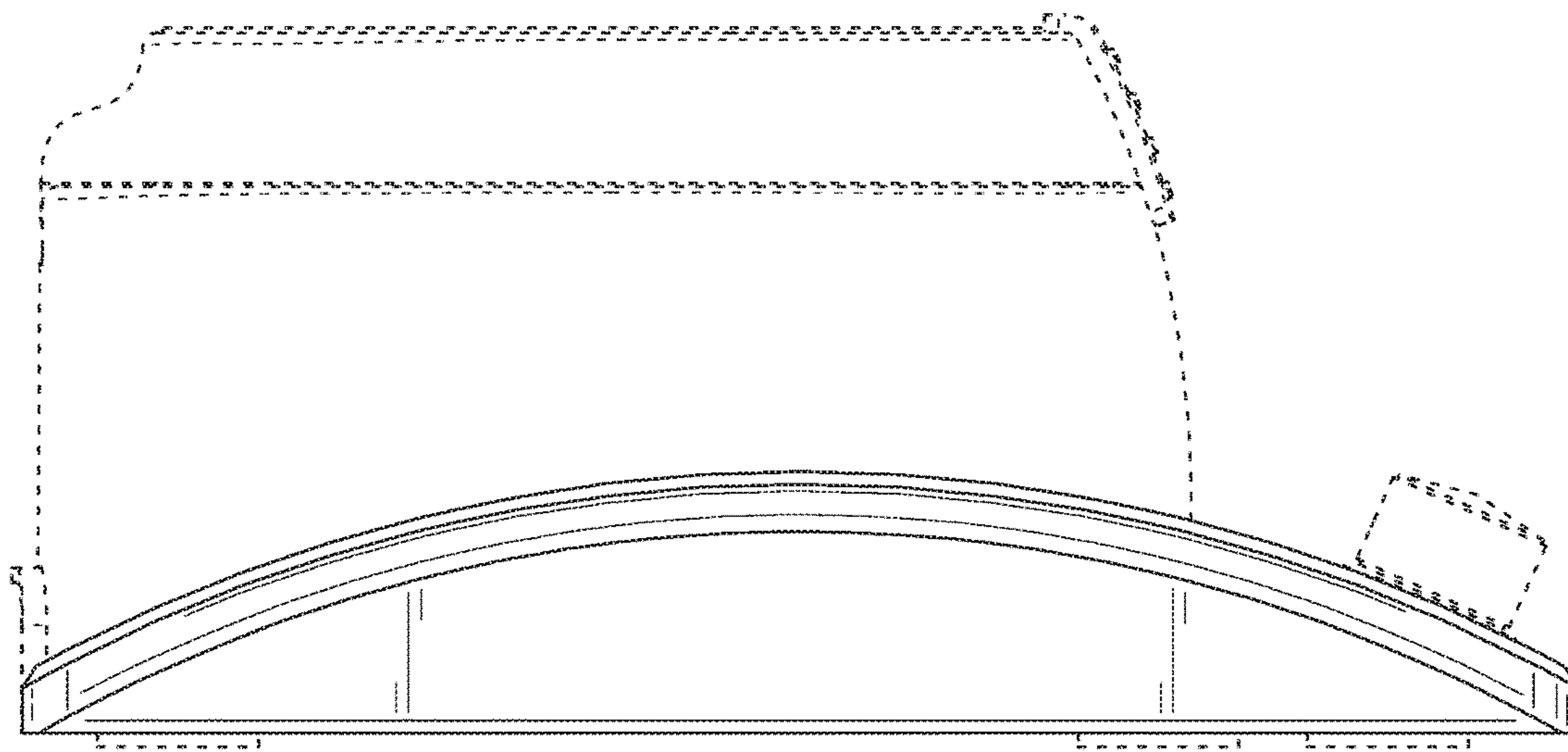

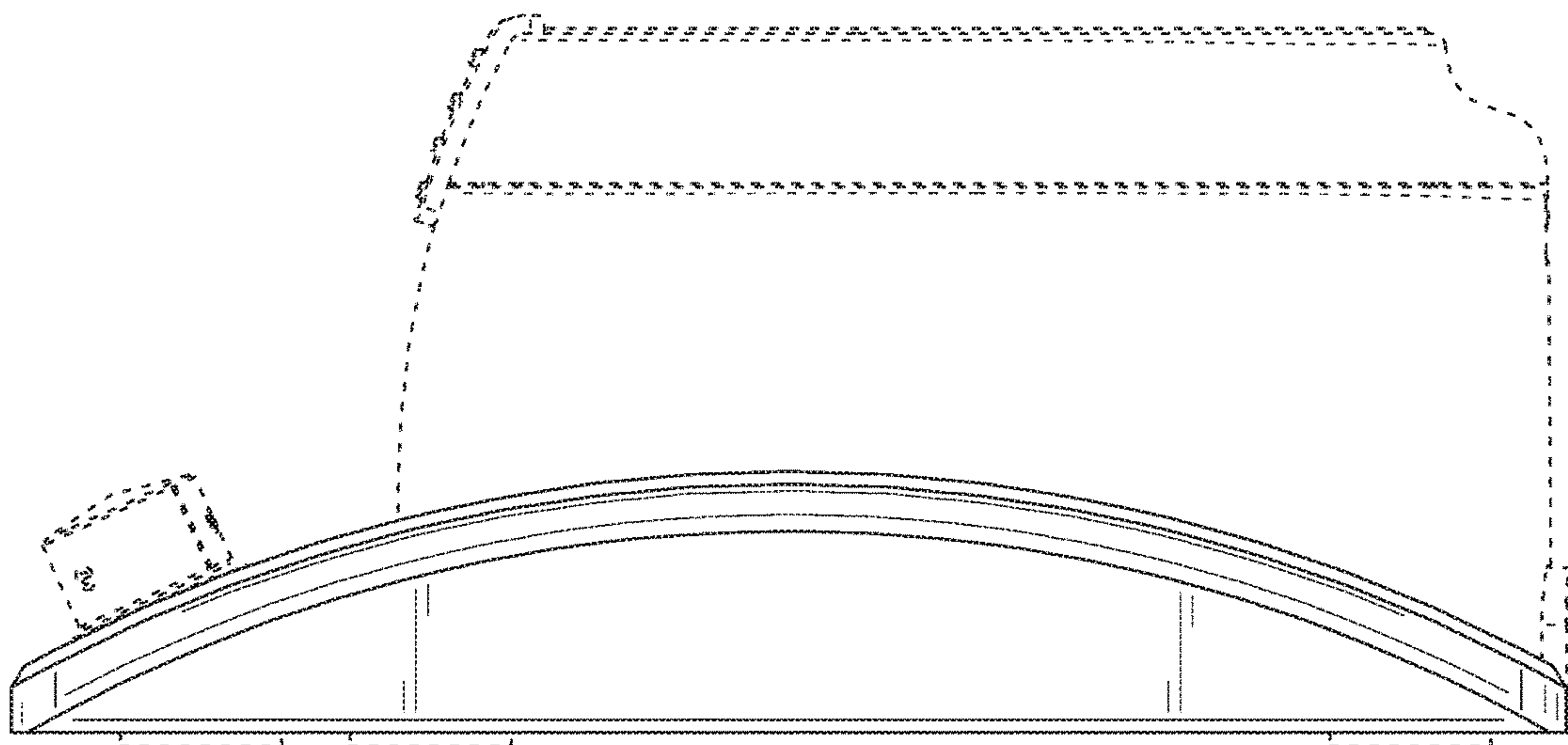

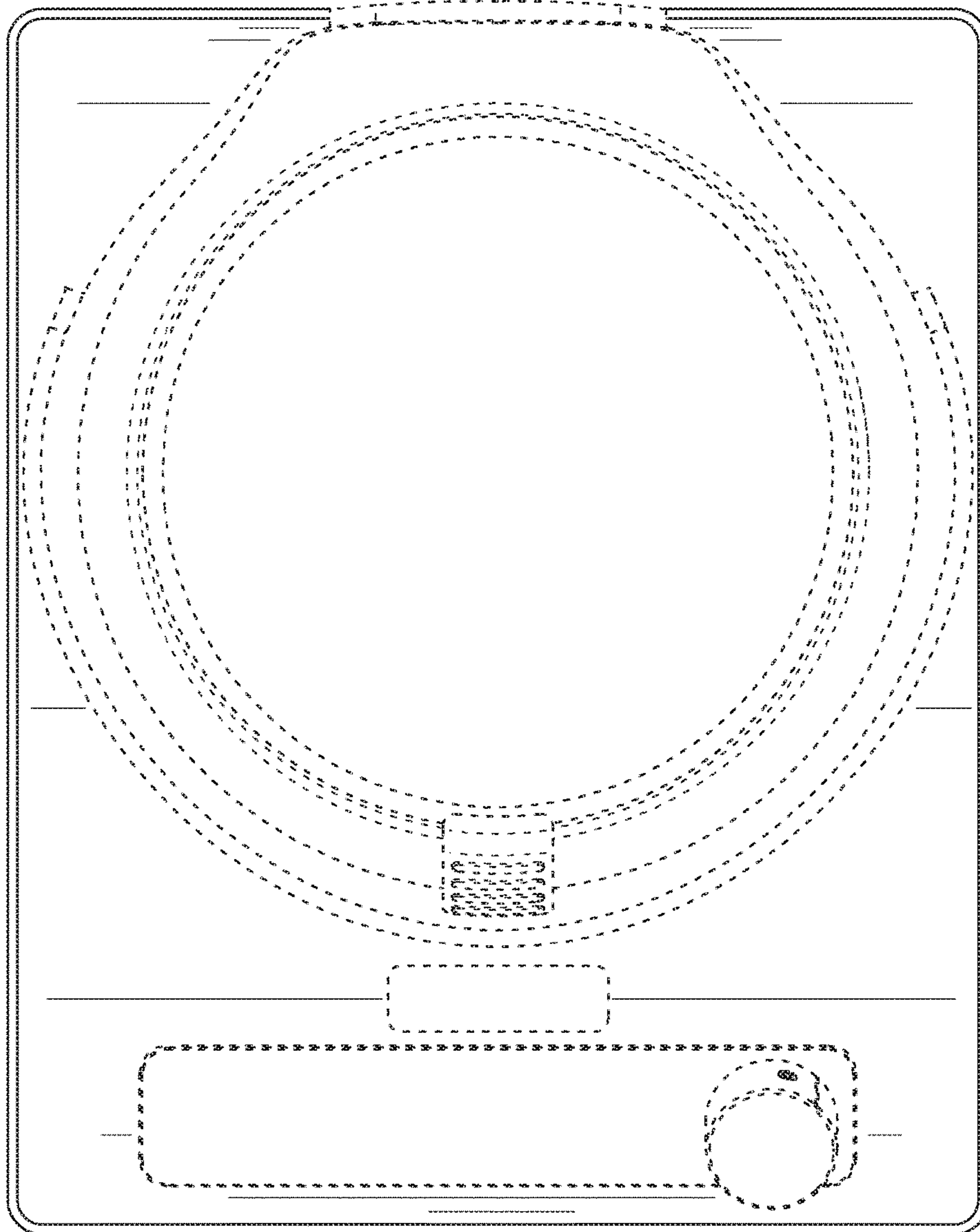

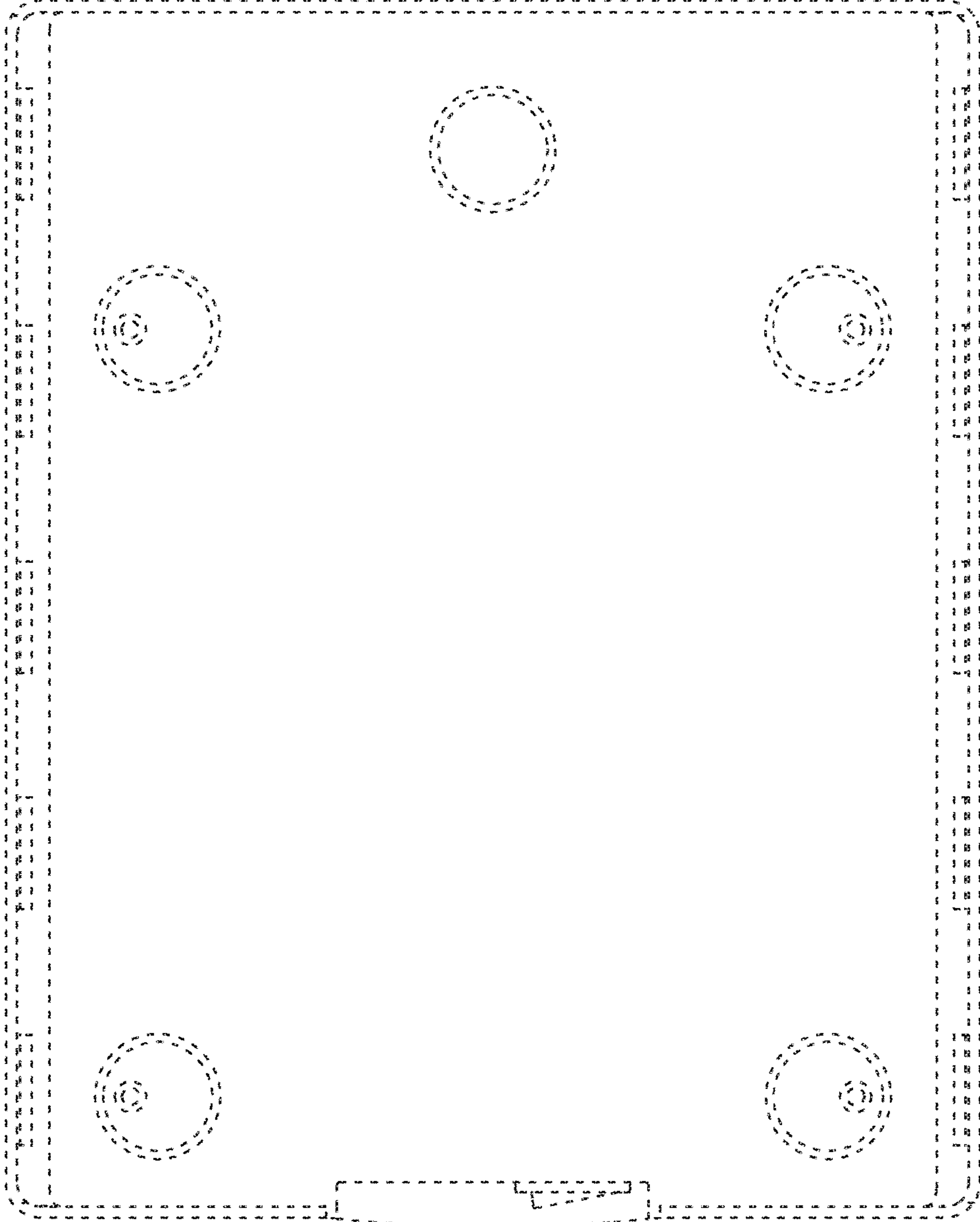
