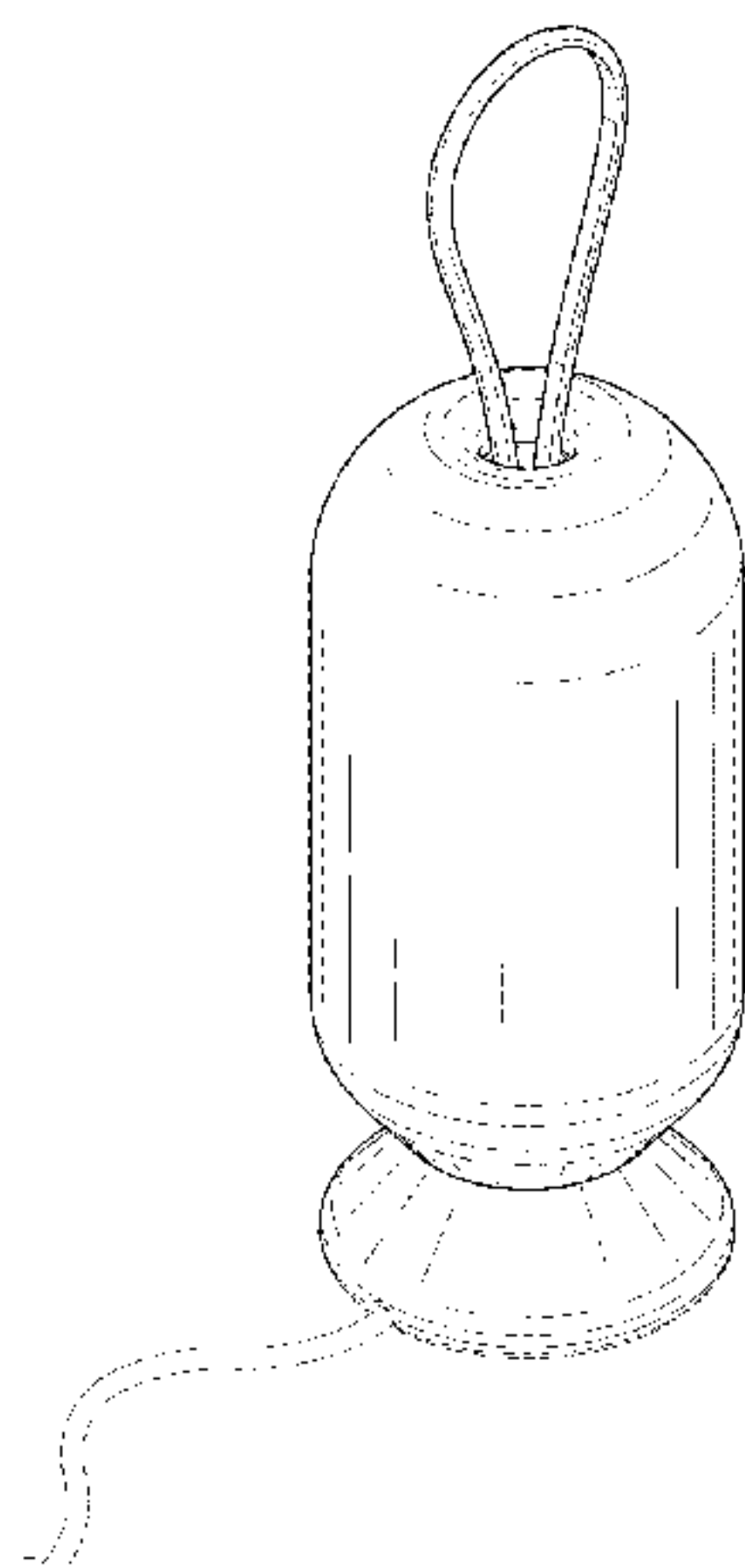


FIG. 21 is an isometric view thereof with the handle, the bulb, and the power cord omitted for clarity;

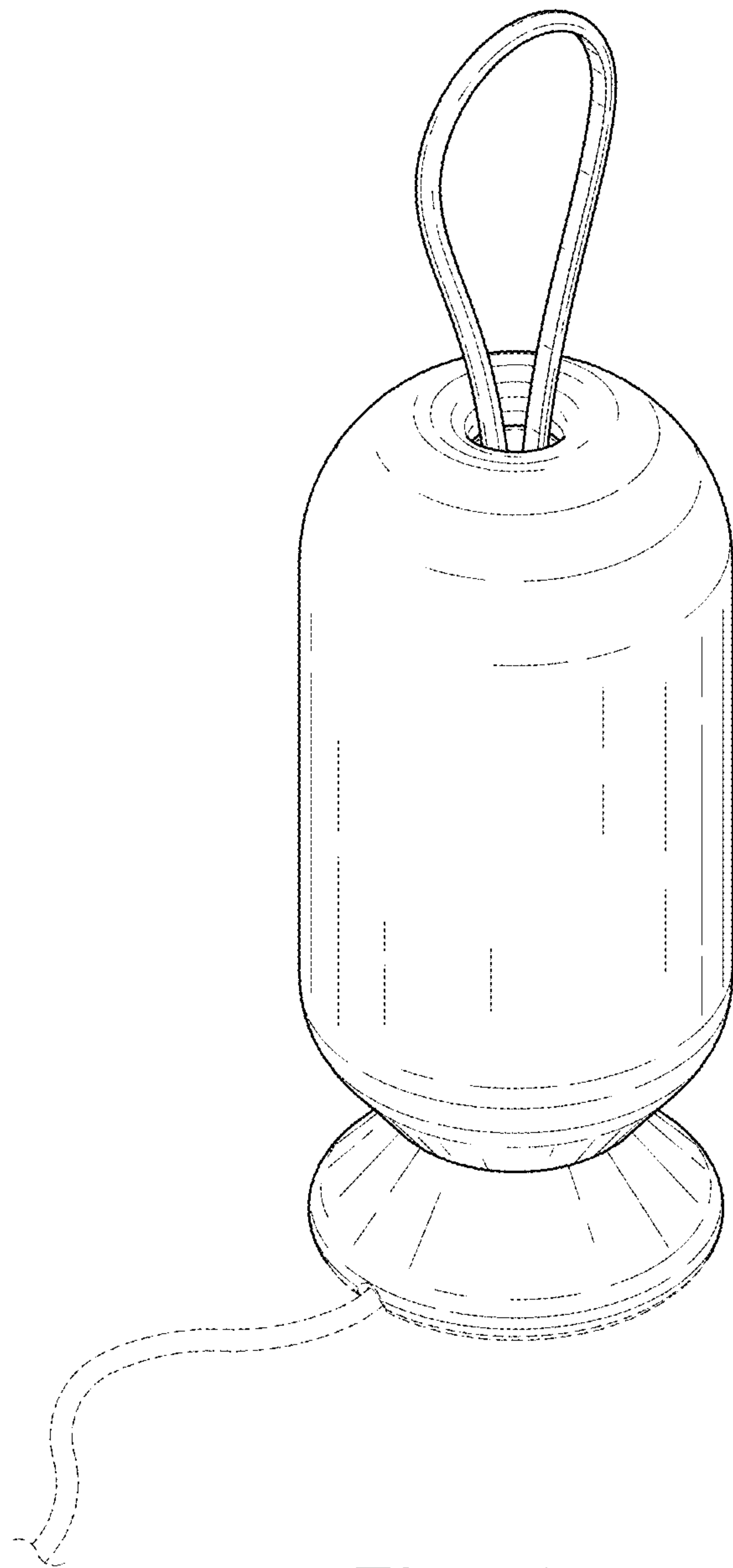

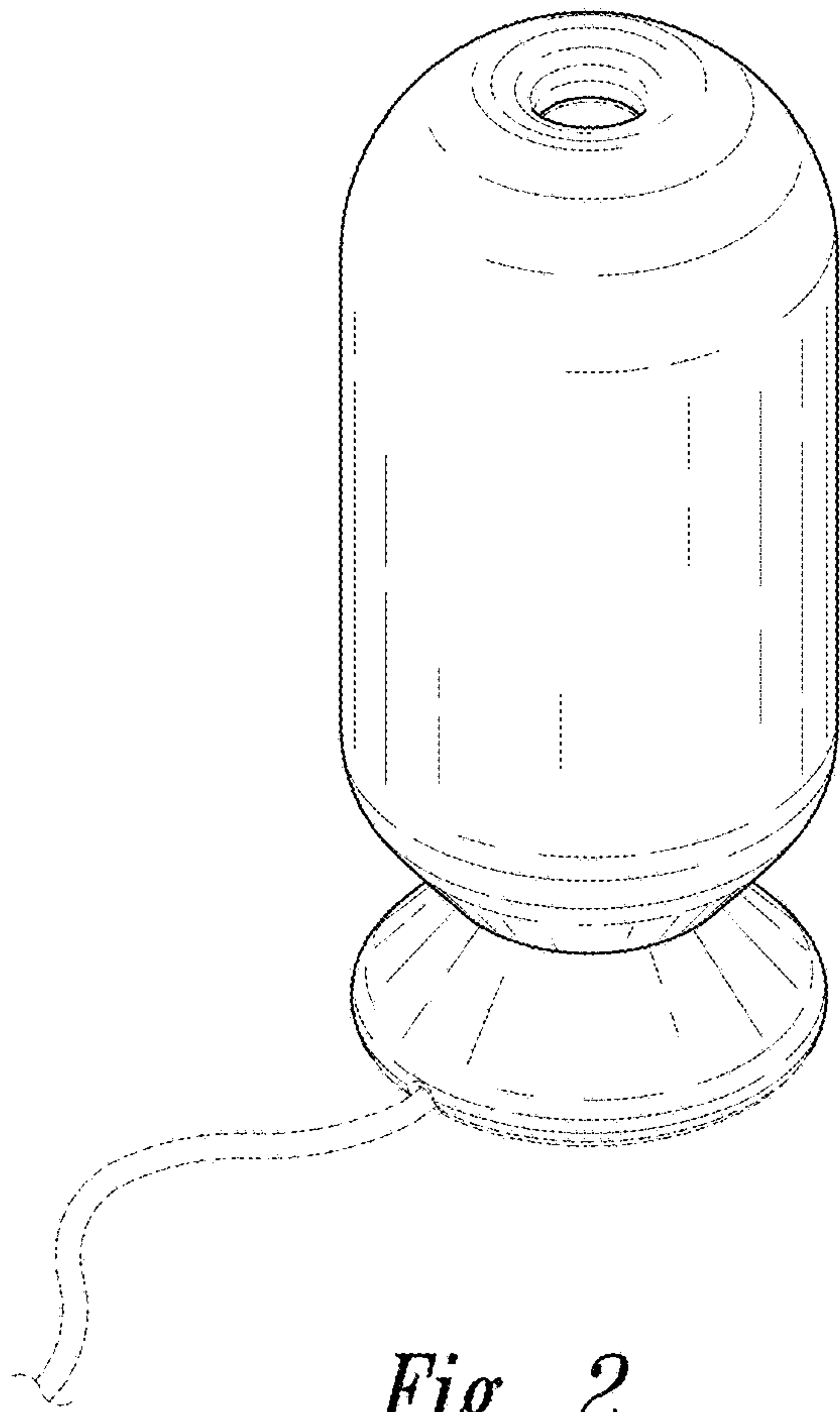

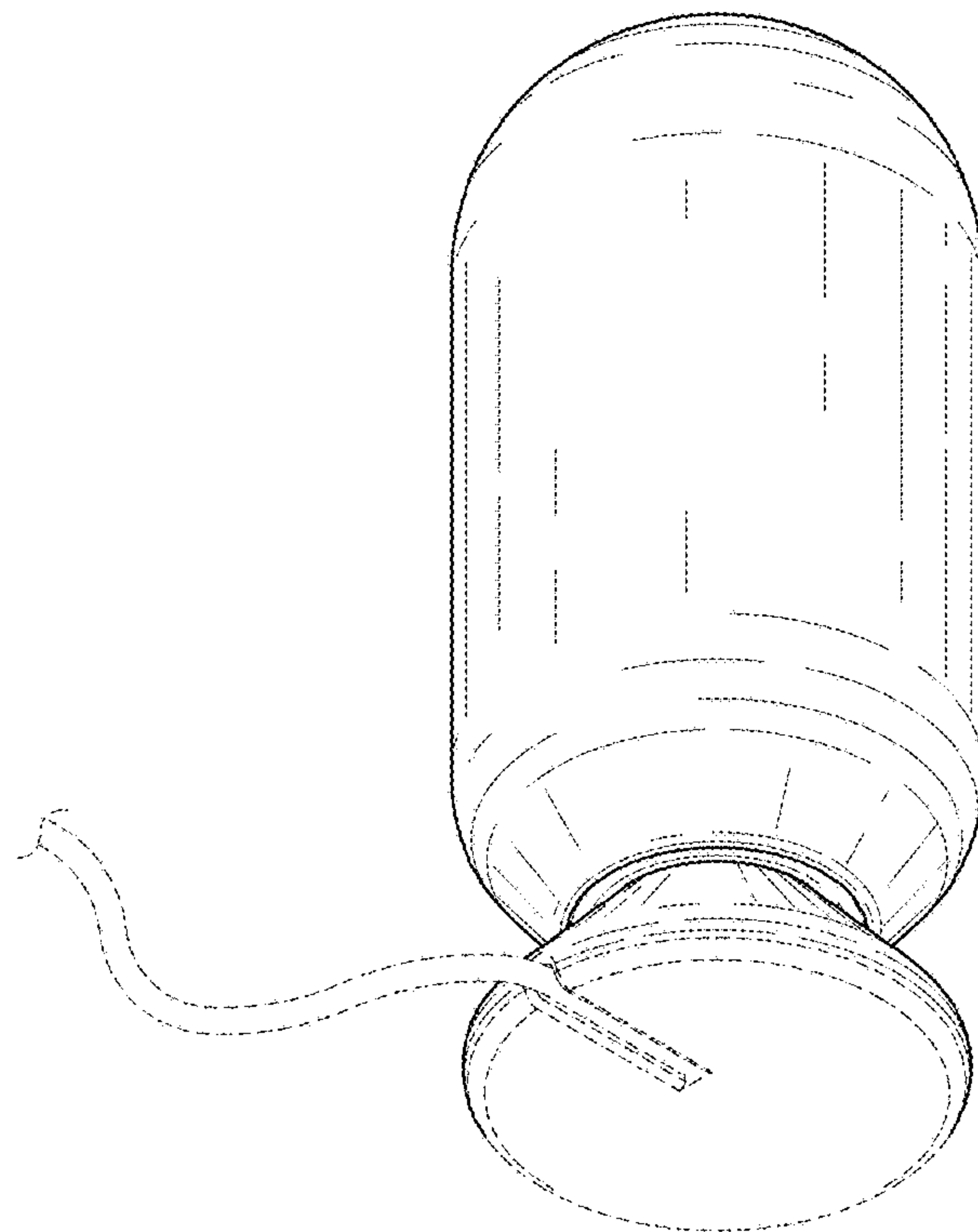

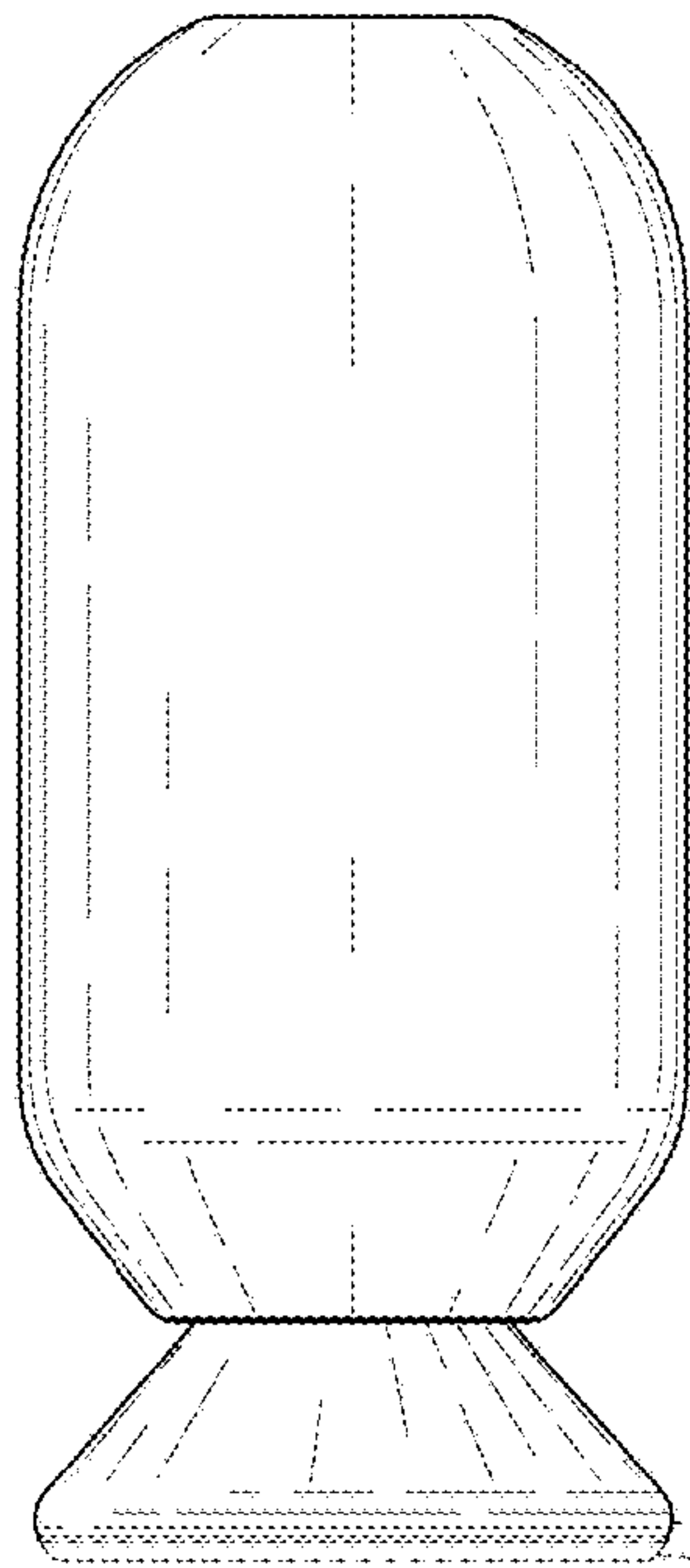

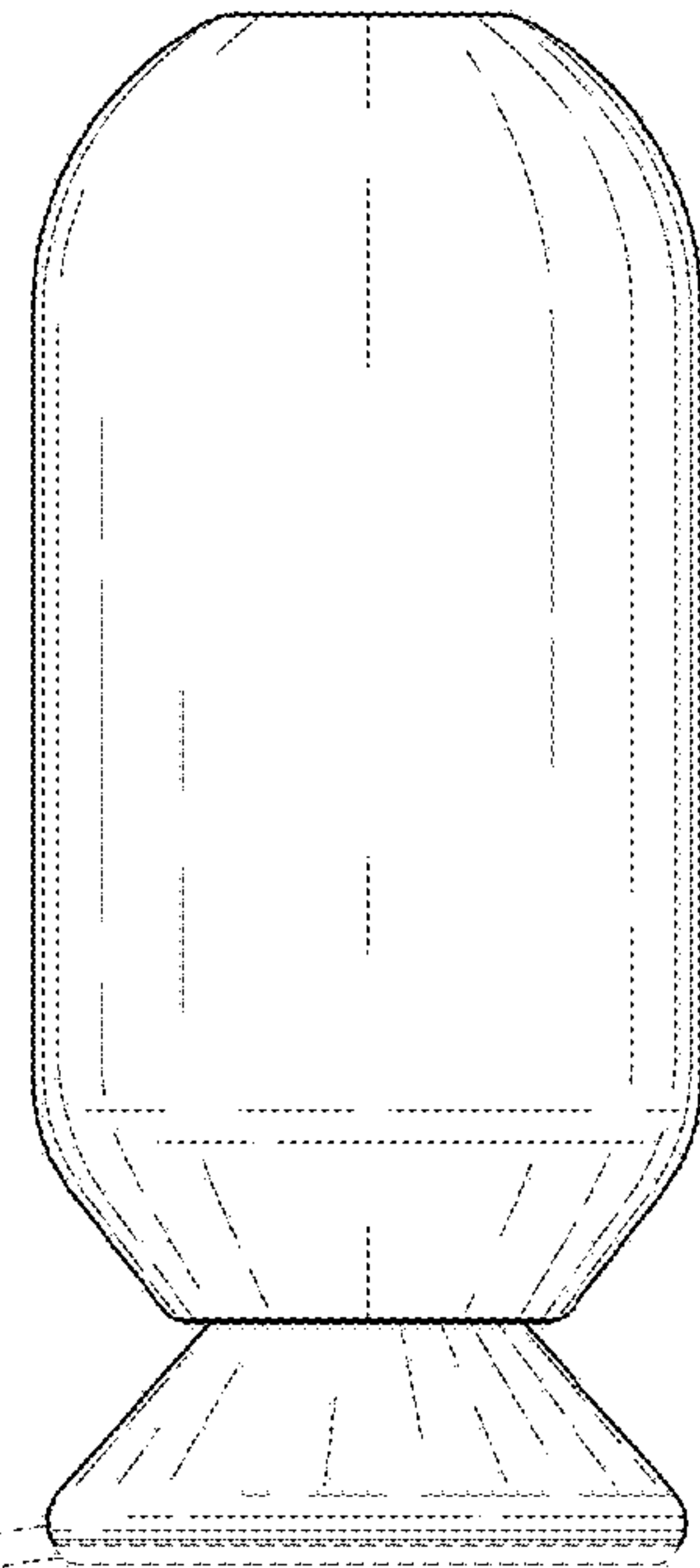

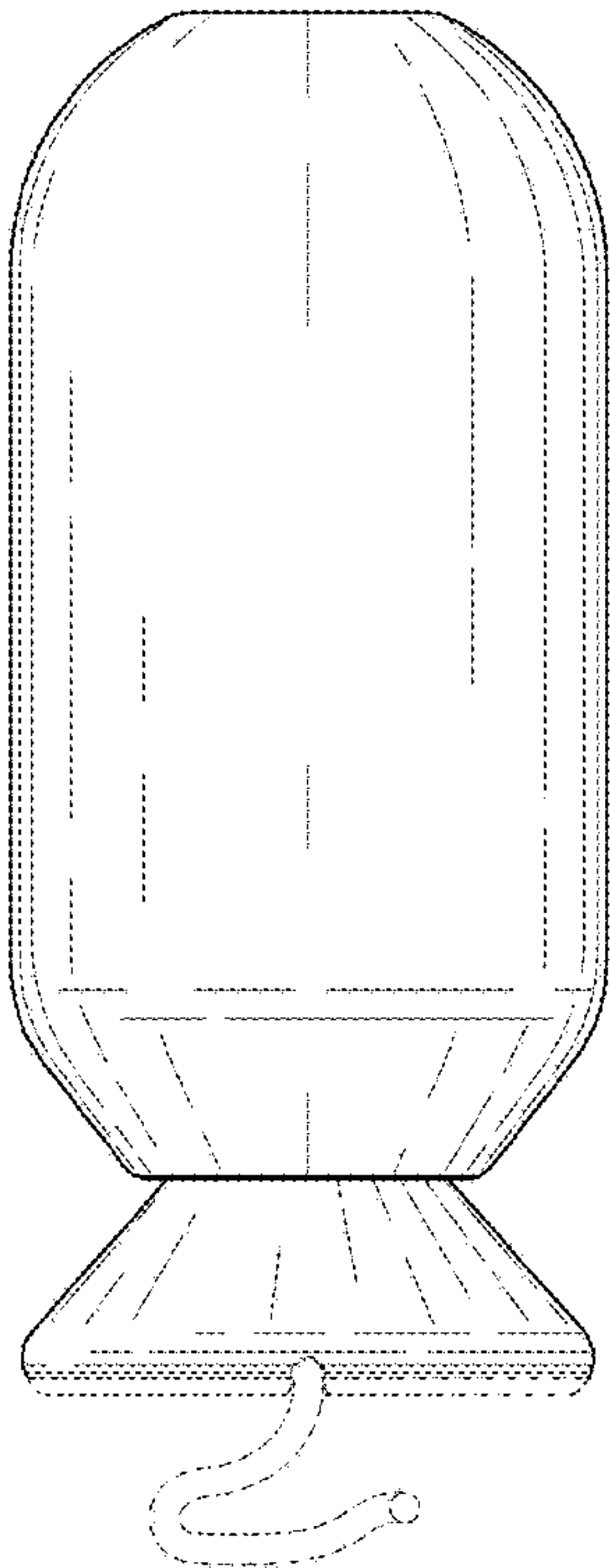

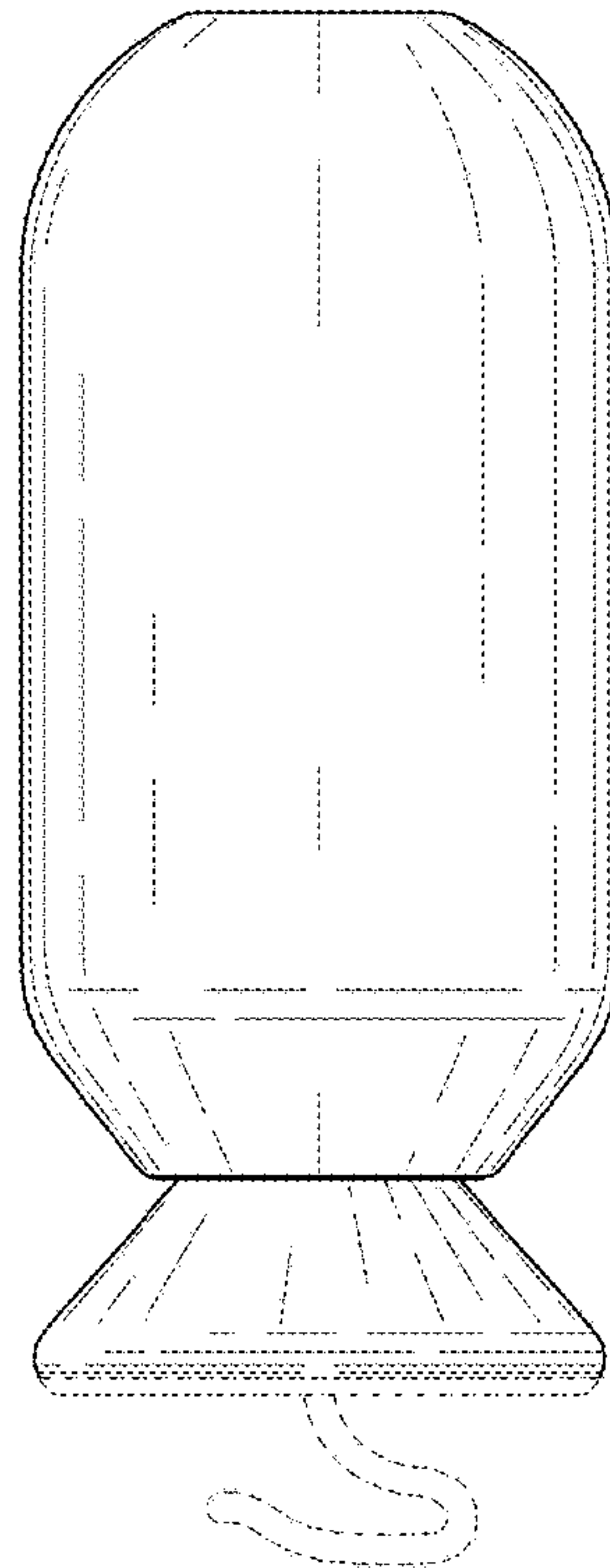

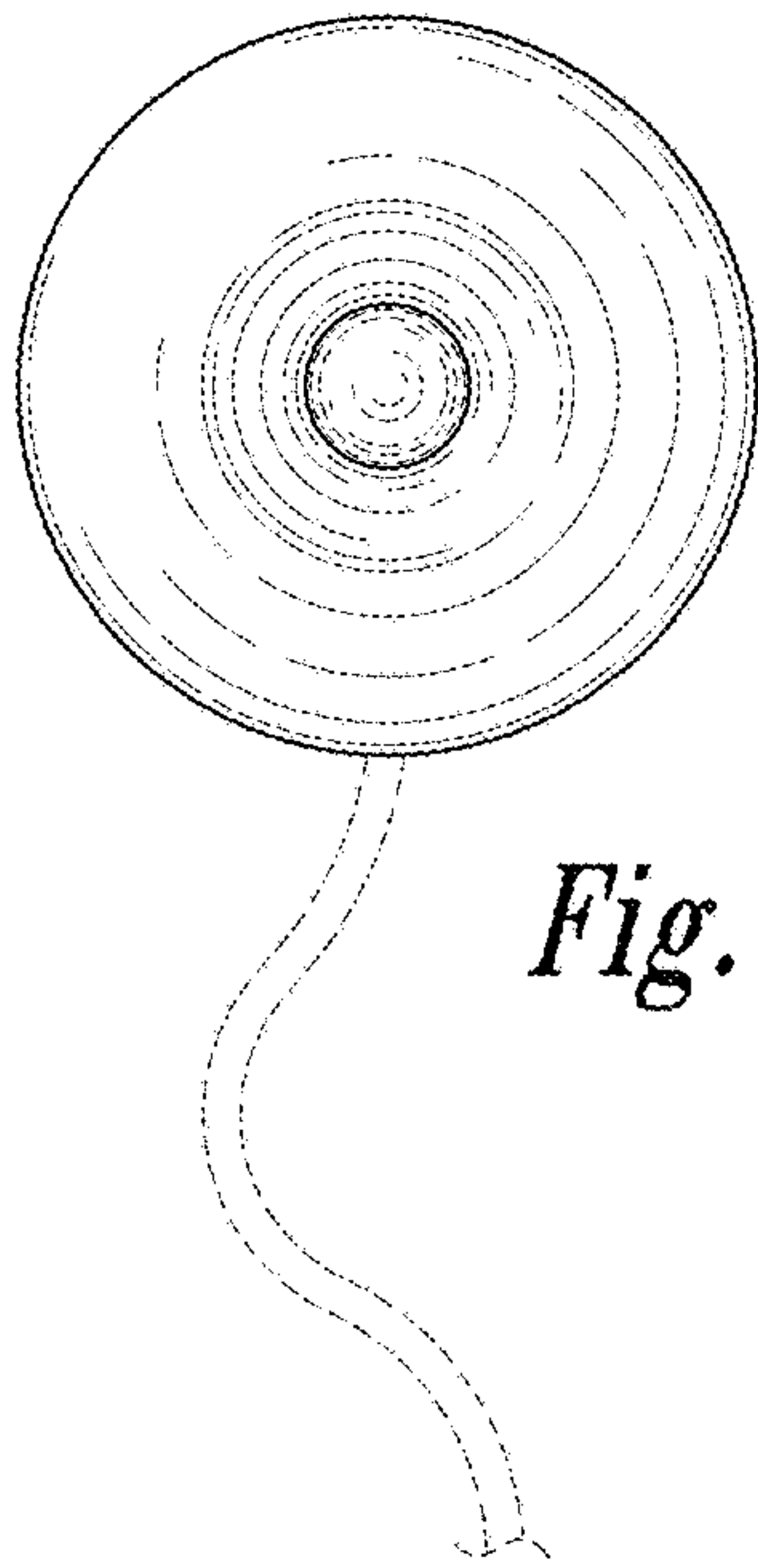

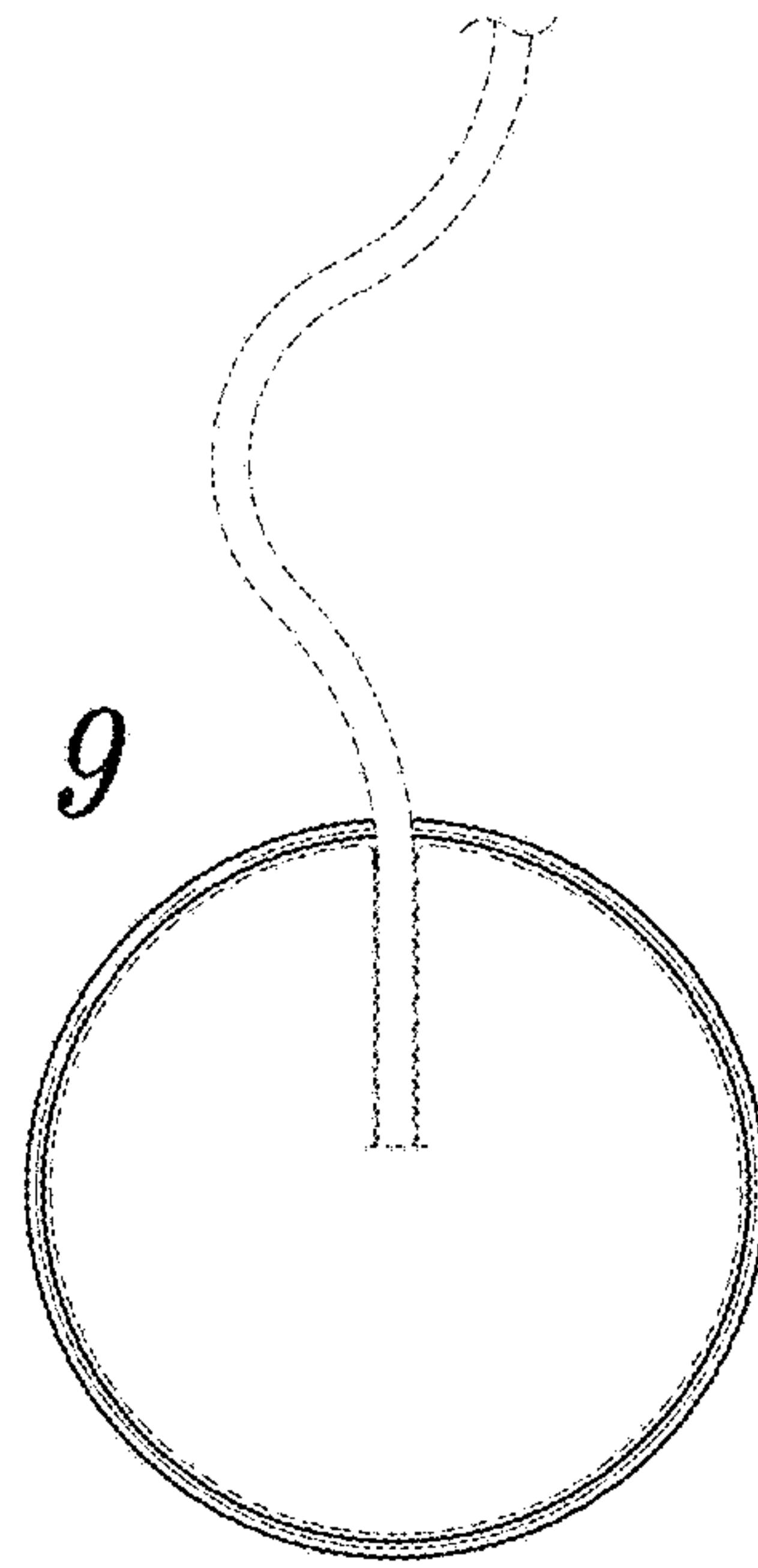

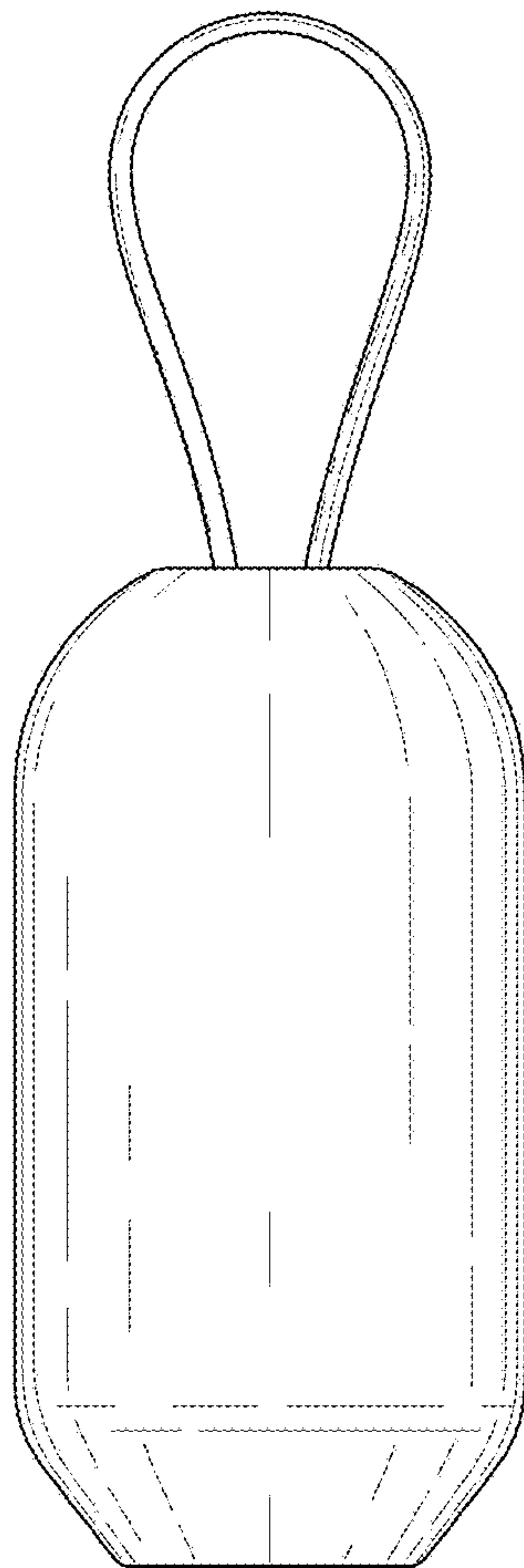

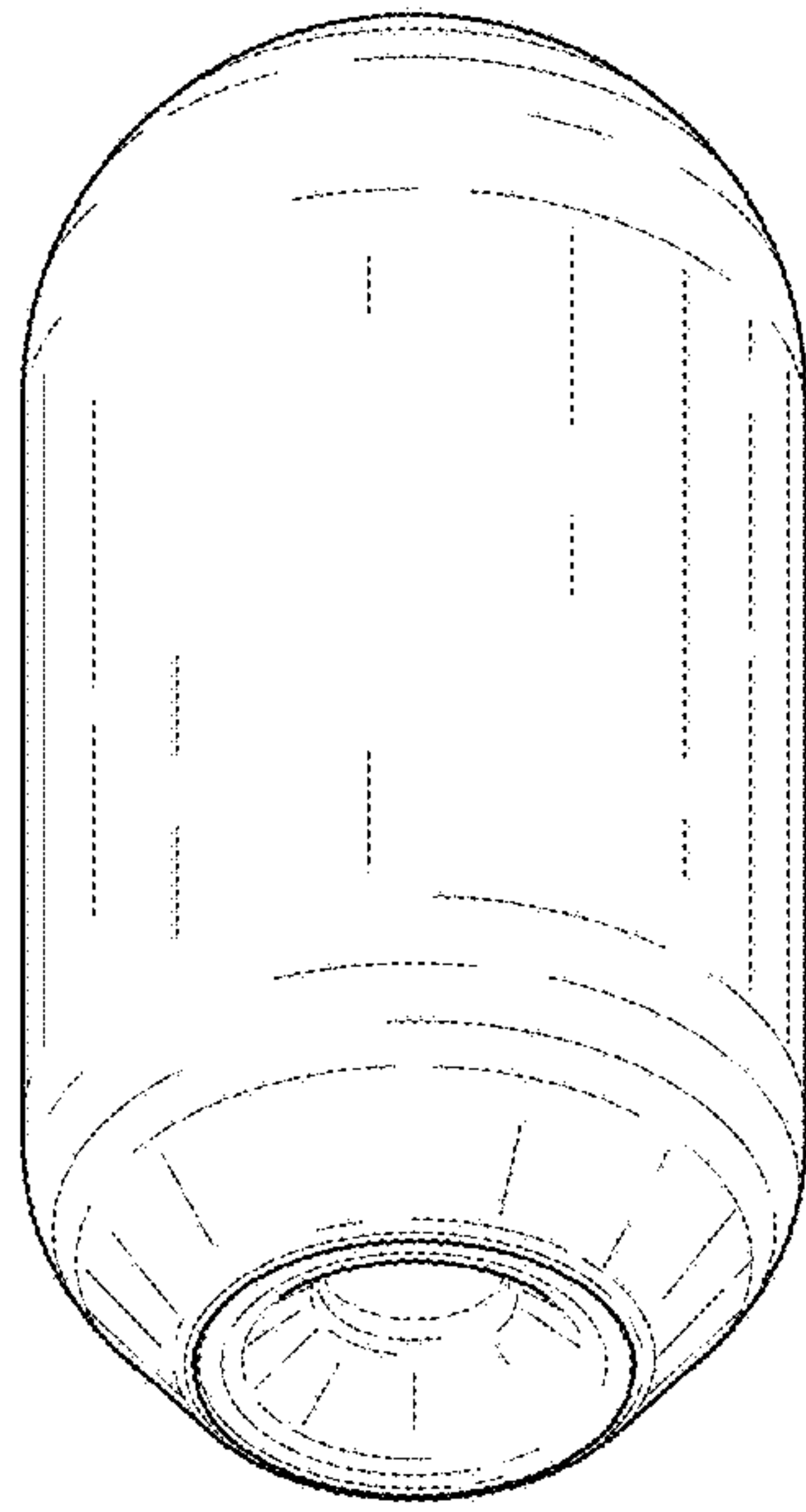

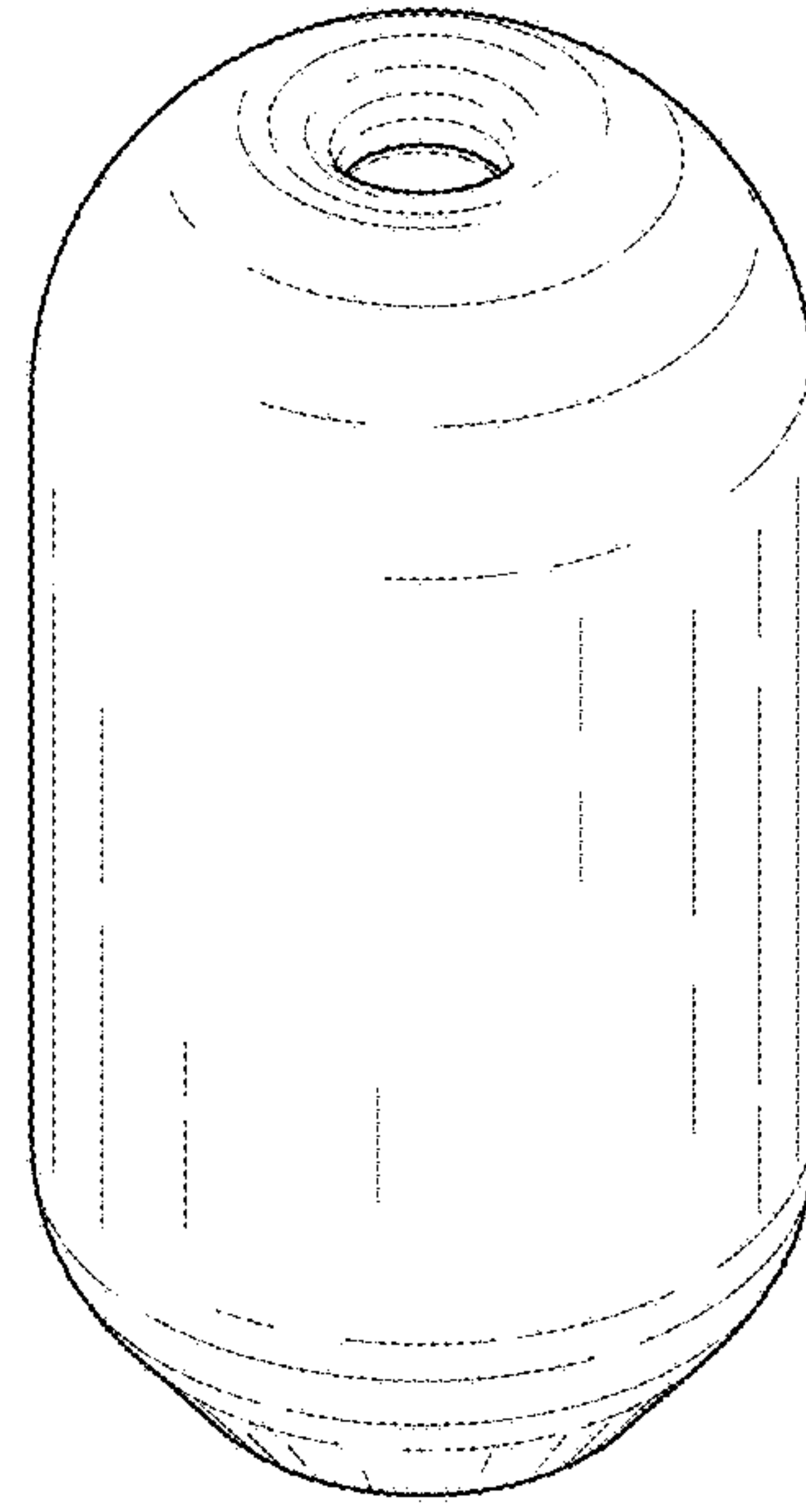

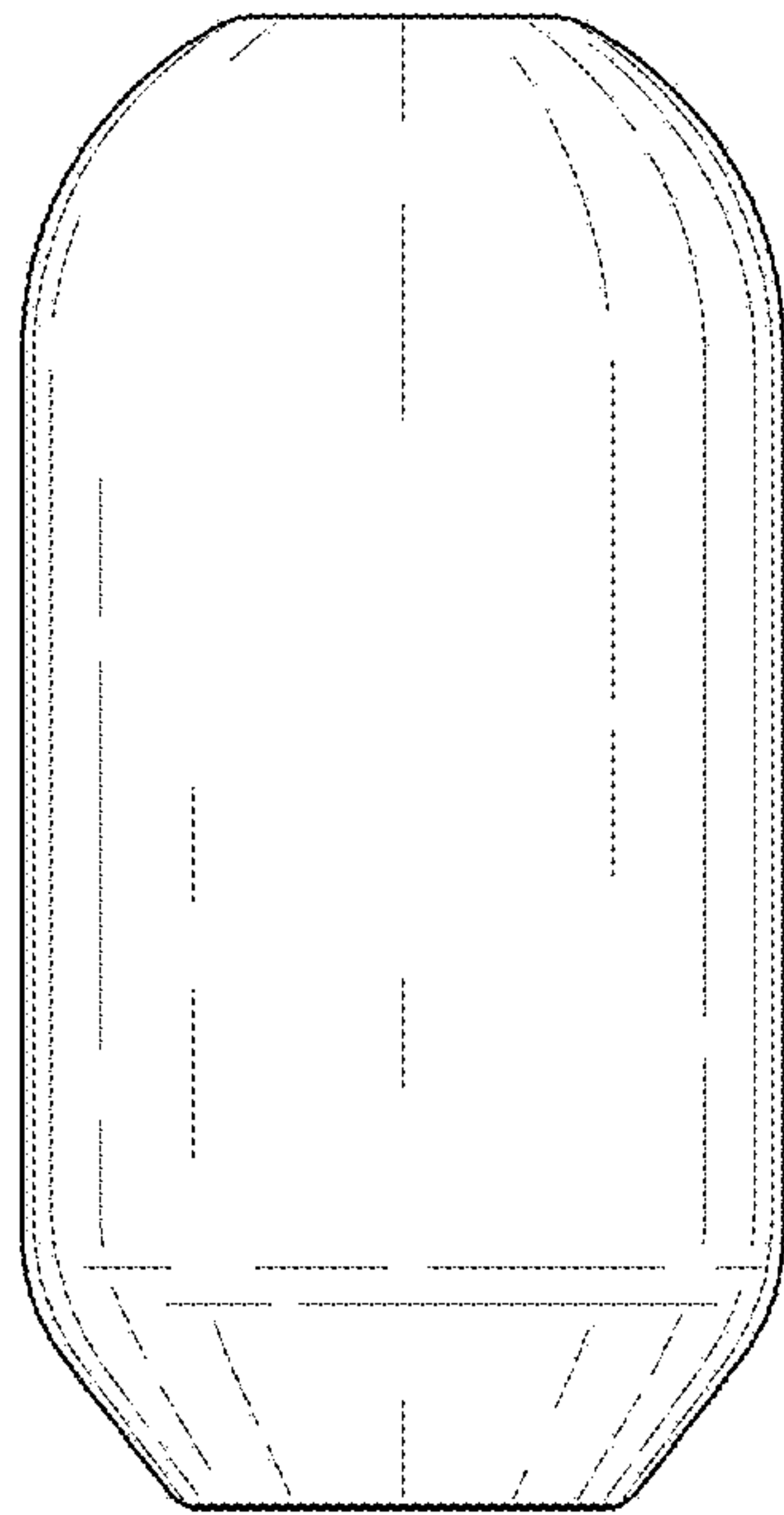

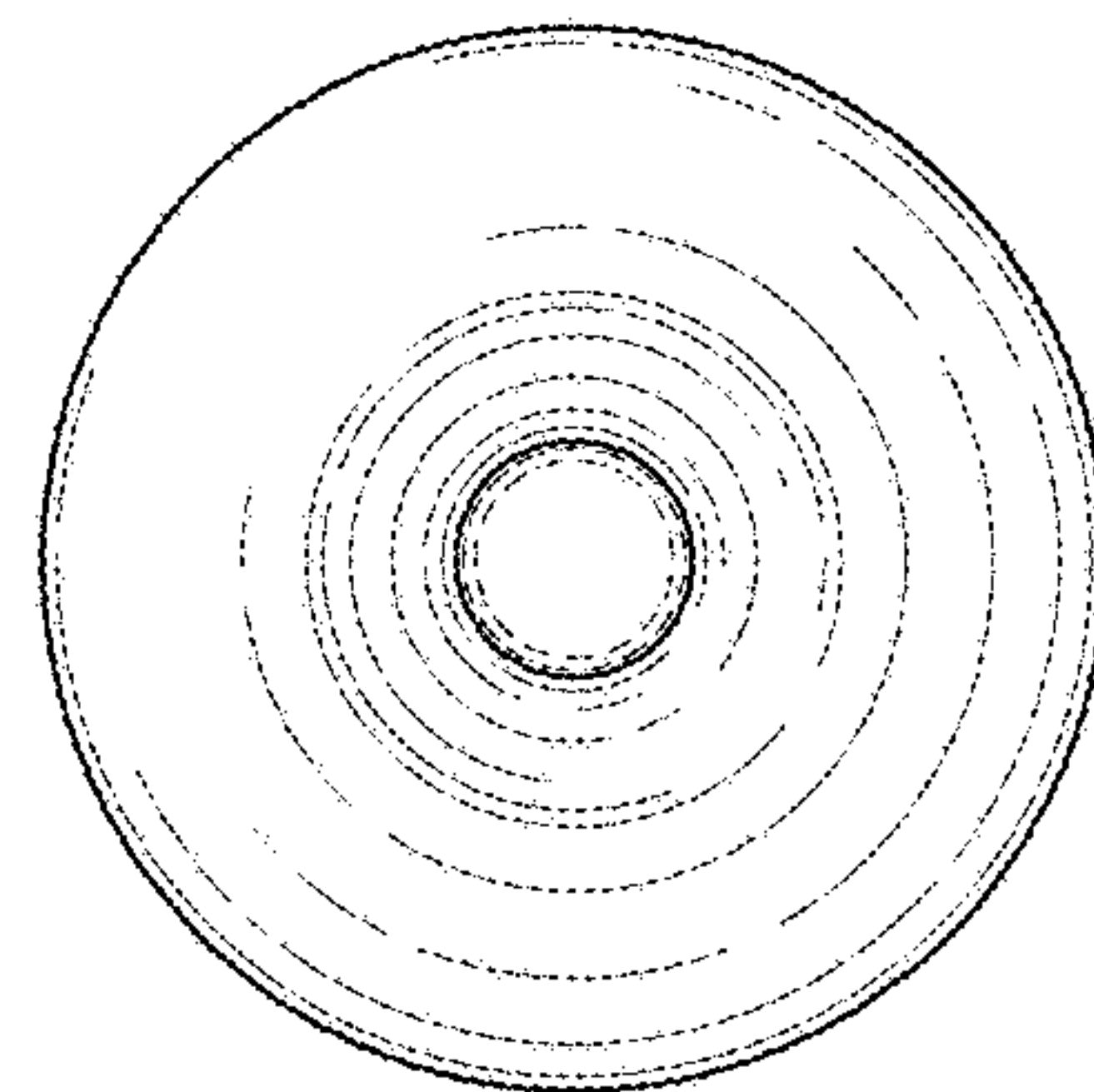

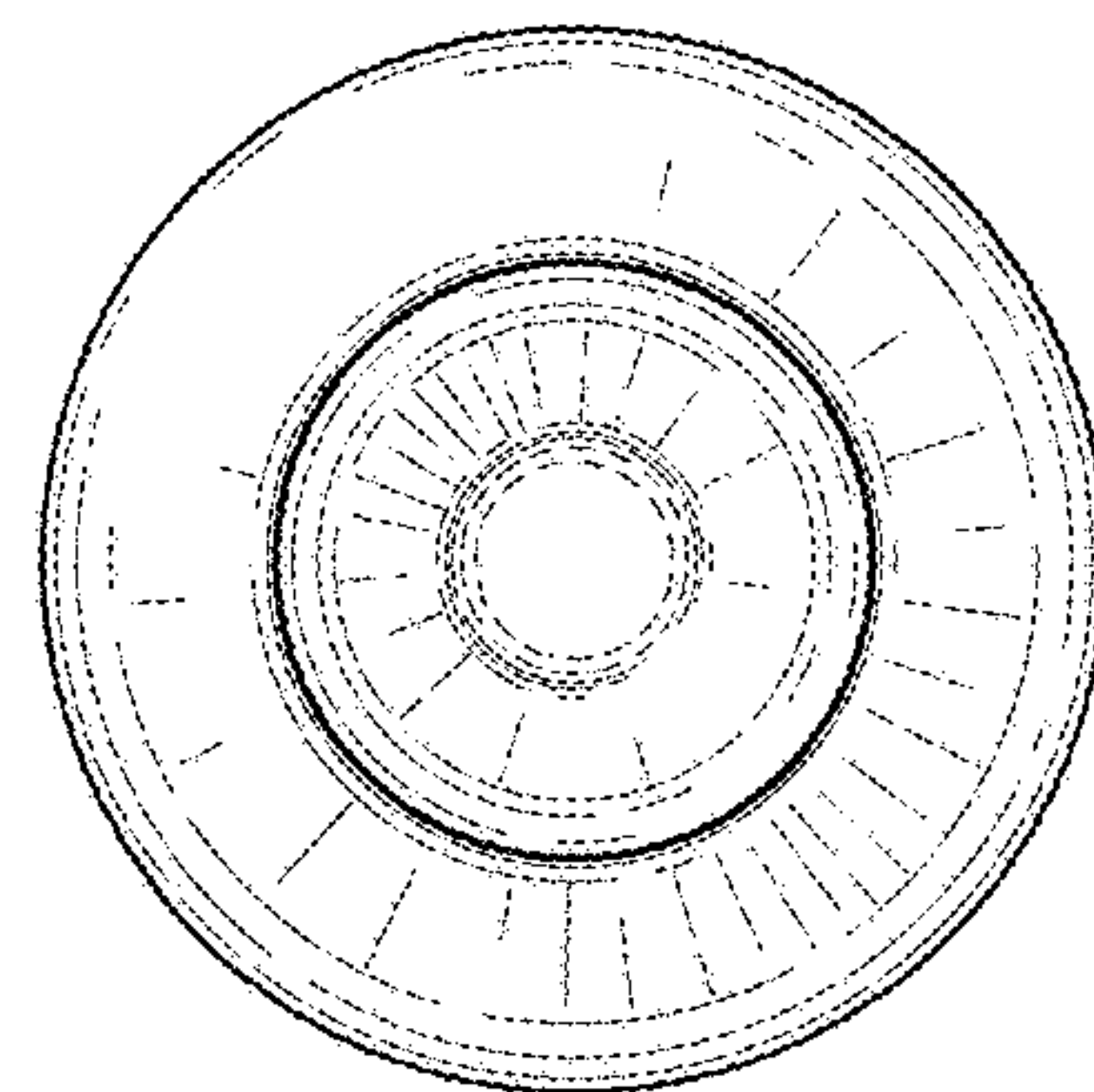

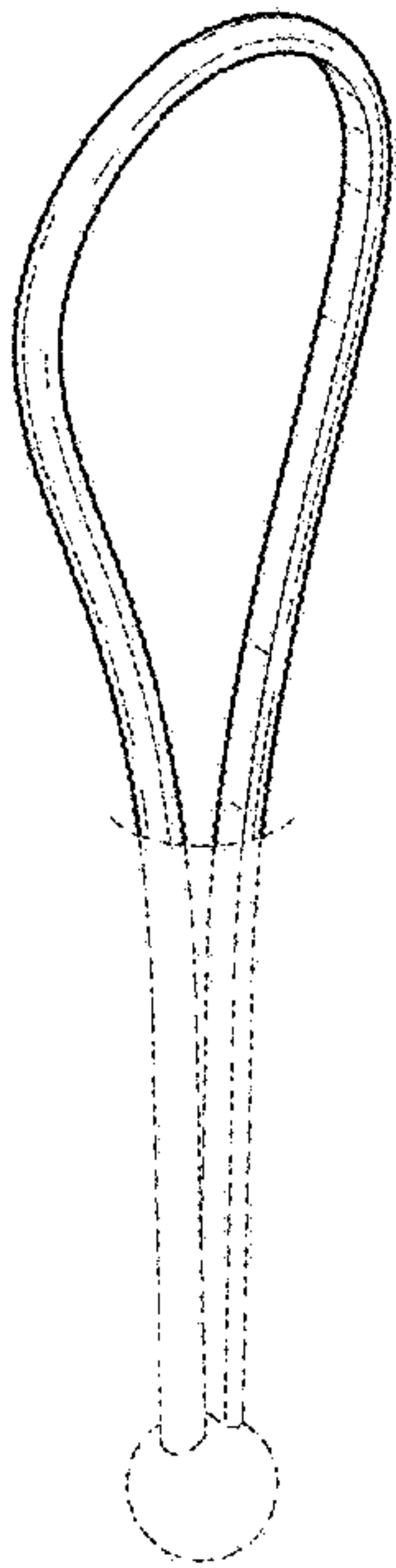

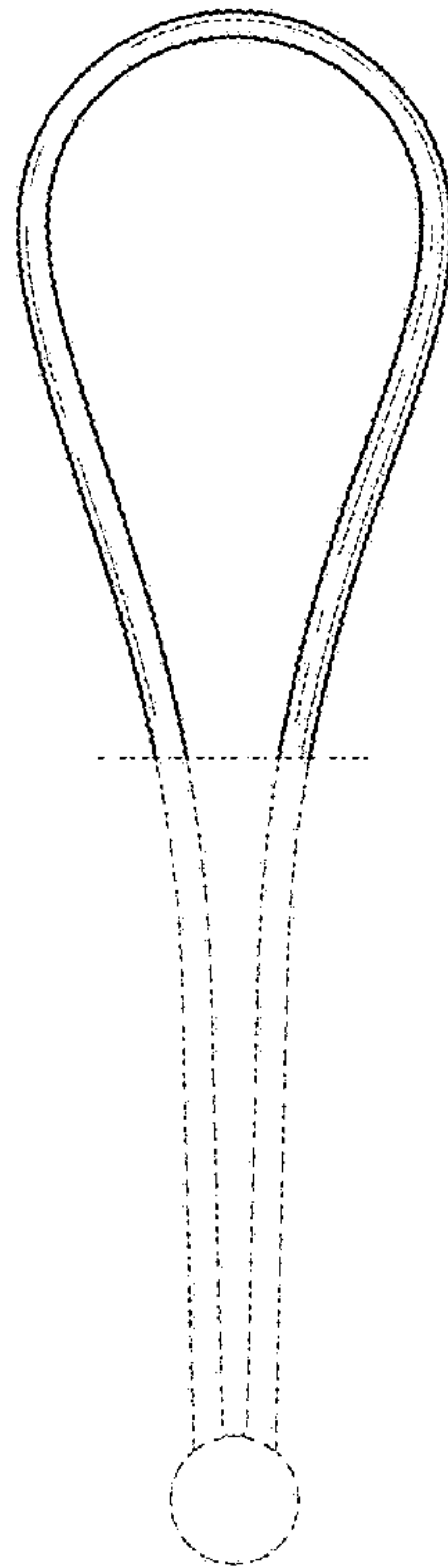

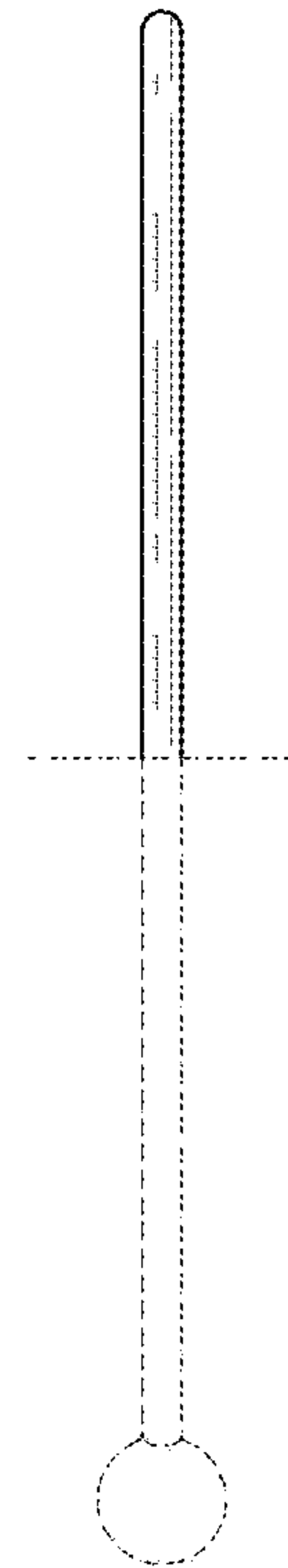

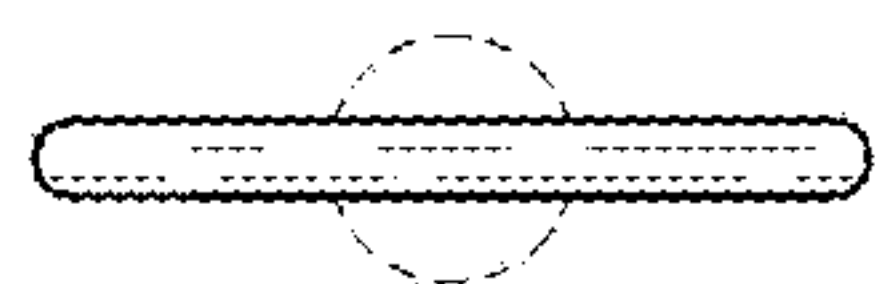

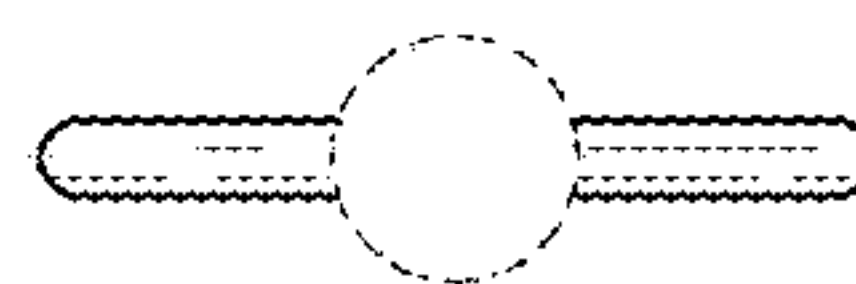

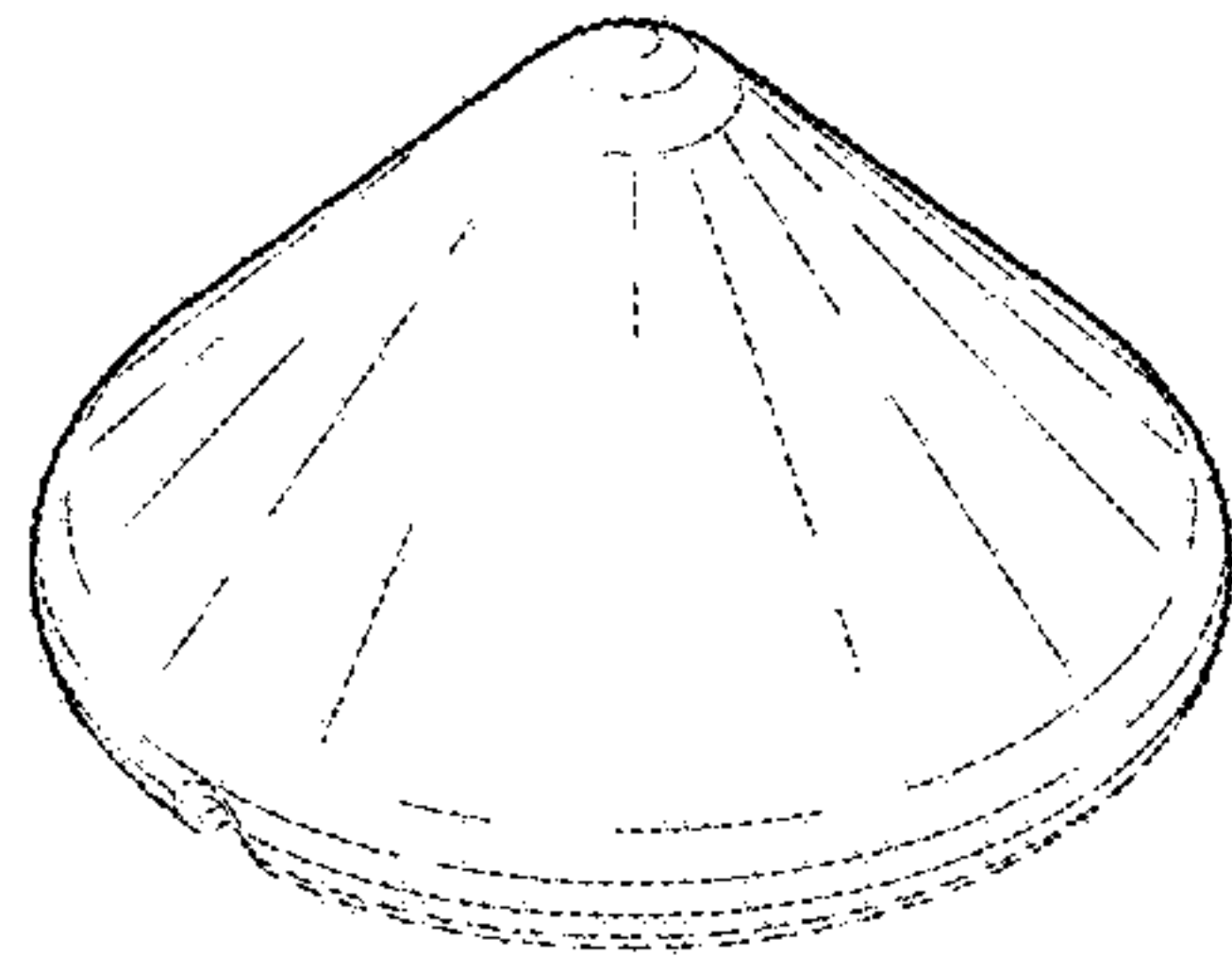

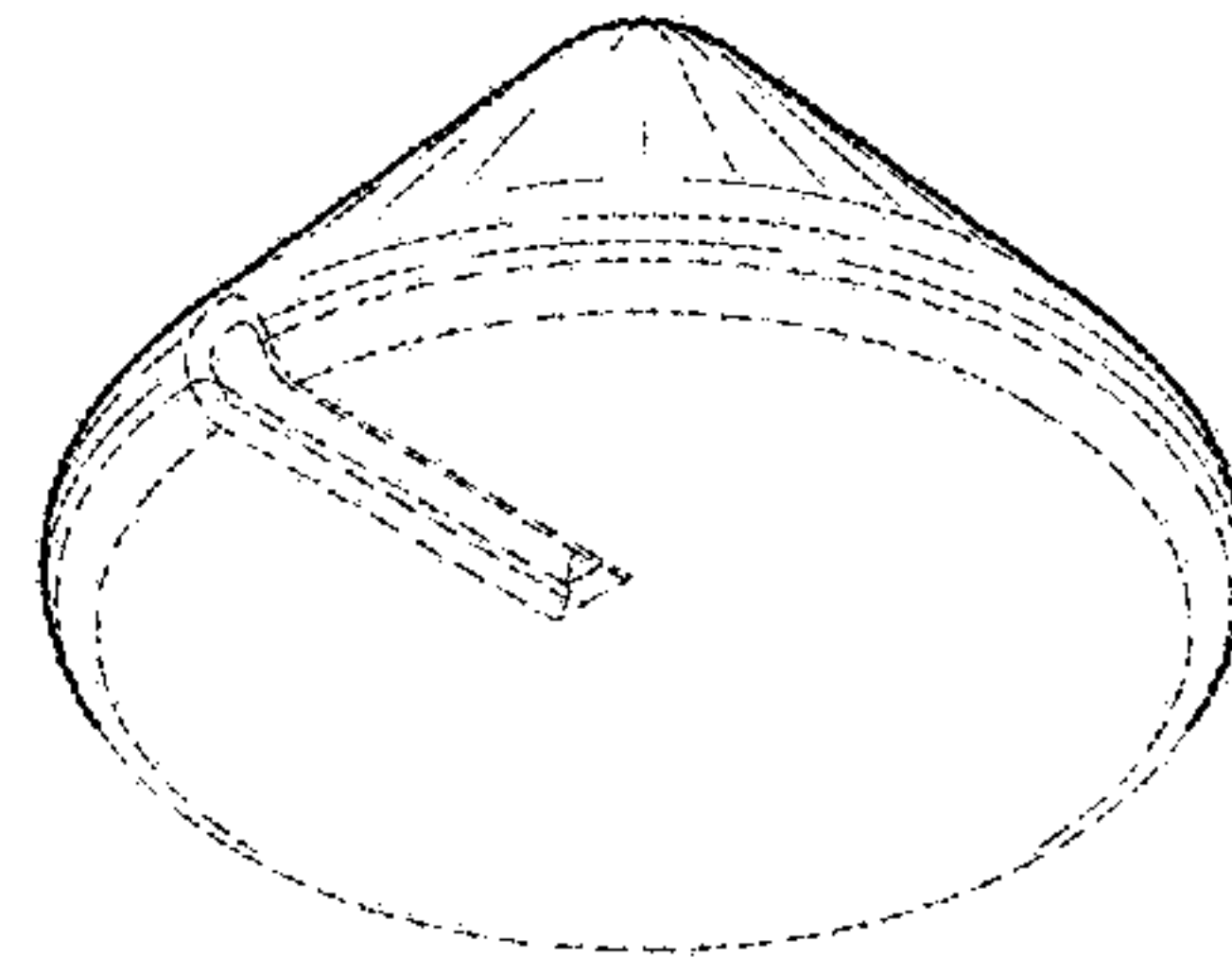

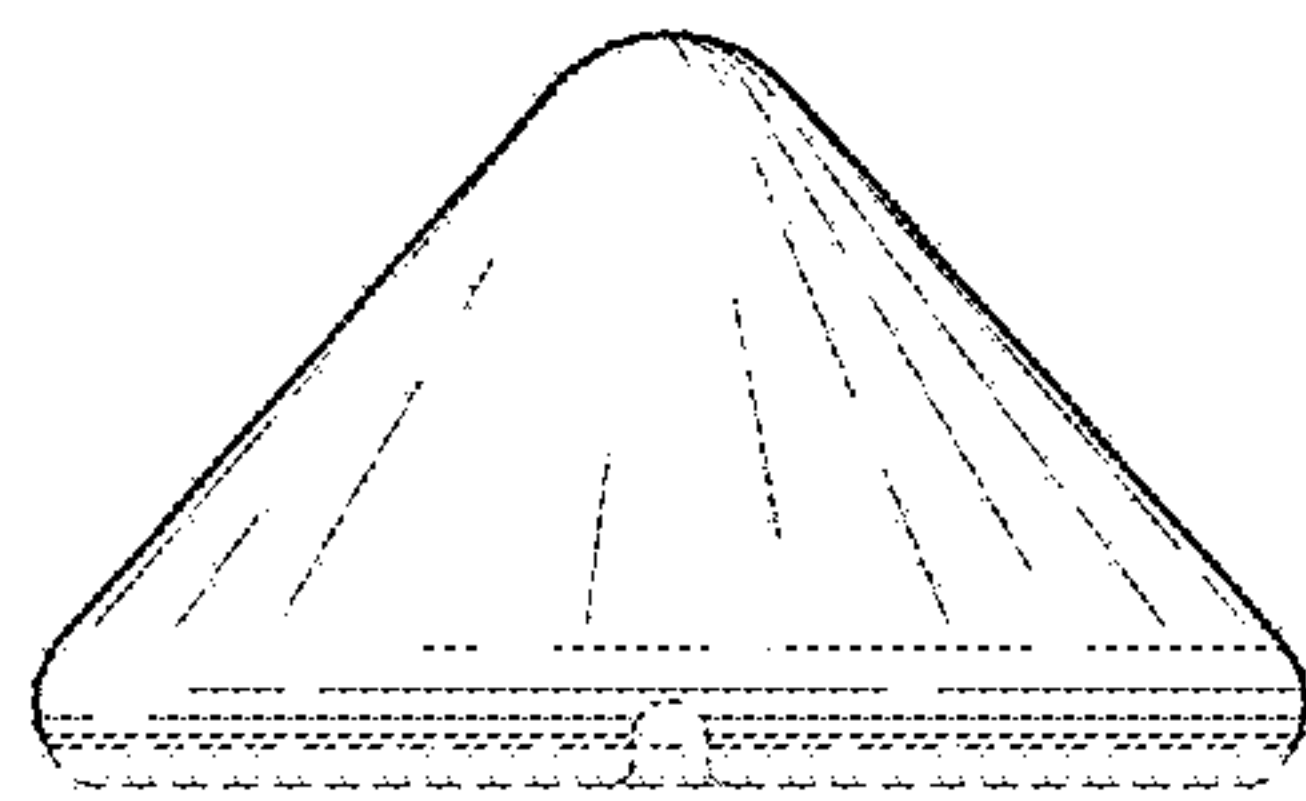

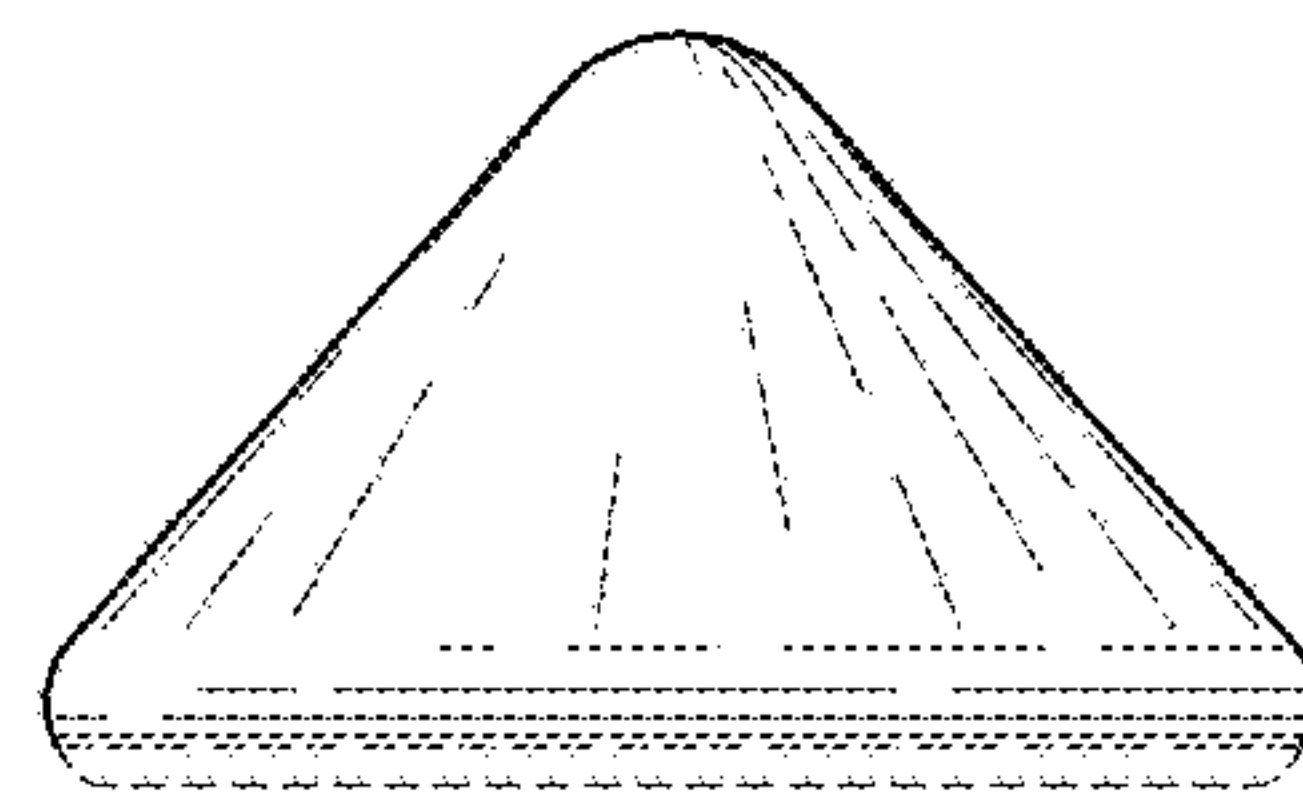

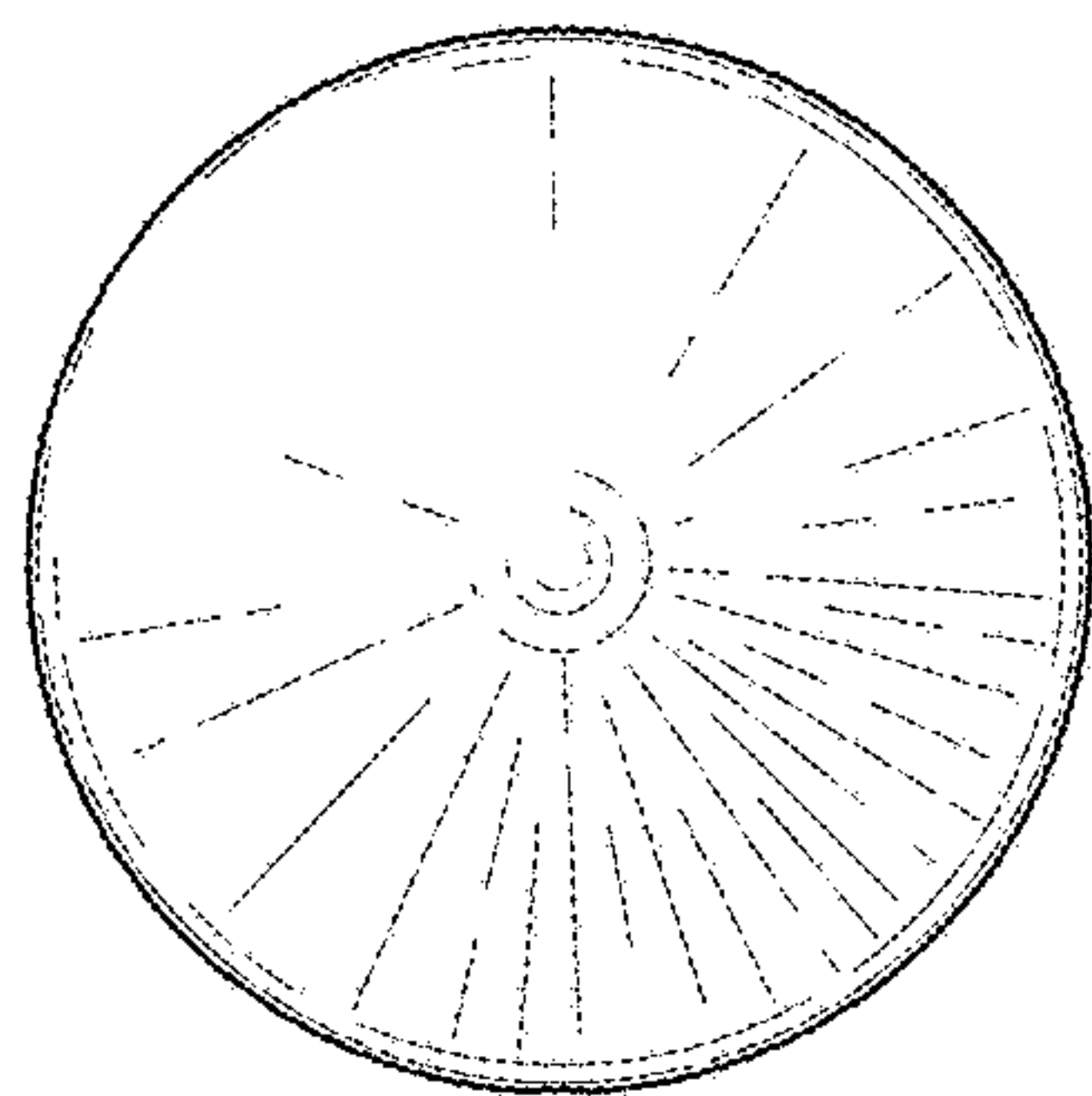

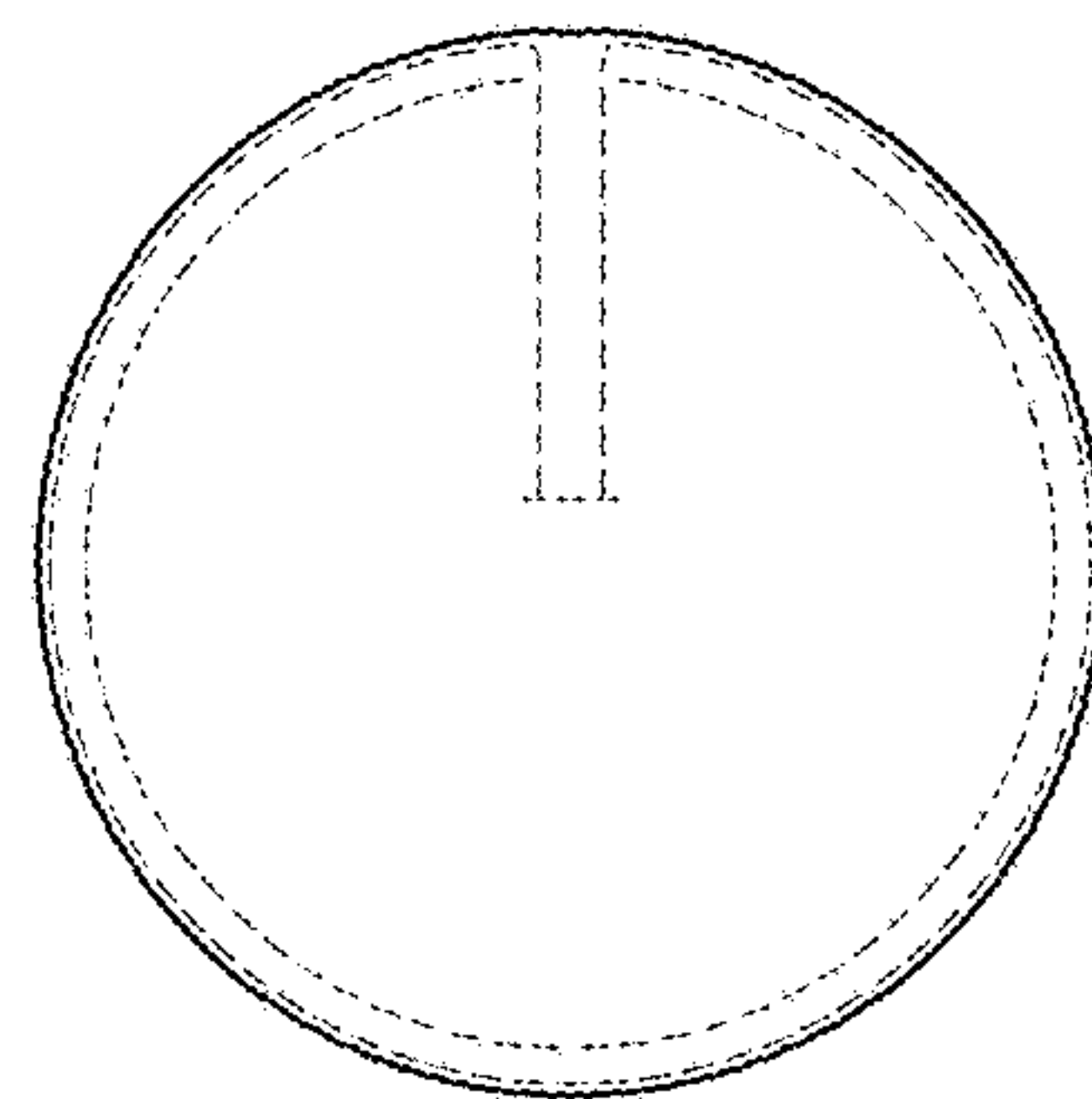
