The ornamental design for a vaporizer pen, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a vaporizer pen showing our new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a top plan view thereof;
FIG. 5 is a bottom plan view thereof;
FIG. 6 is a left side elevational view thereof; and,
FIG. 7 is a right side elevational view thereof.
The broken lines in the drawings depict a portion of the vaporizer pen that form no part of the claimed design.

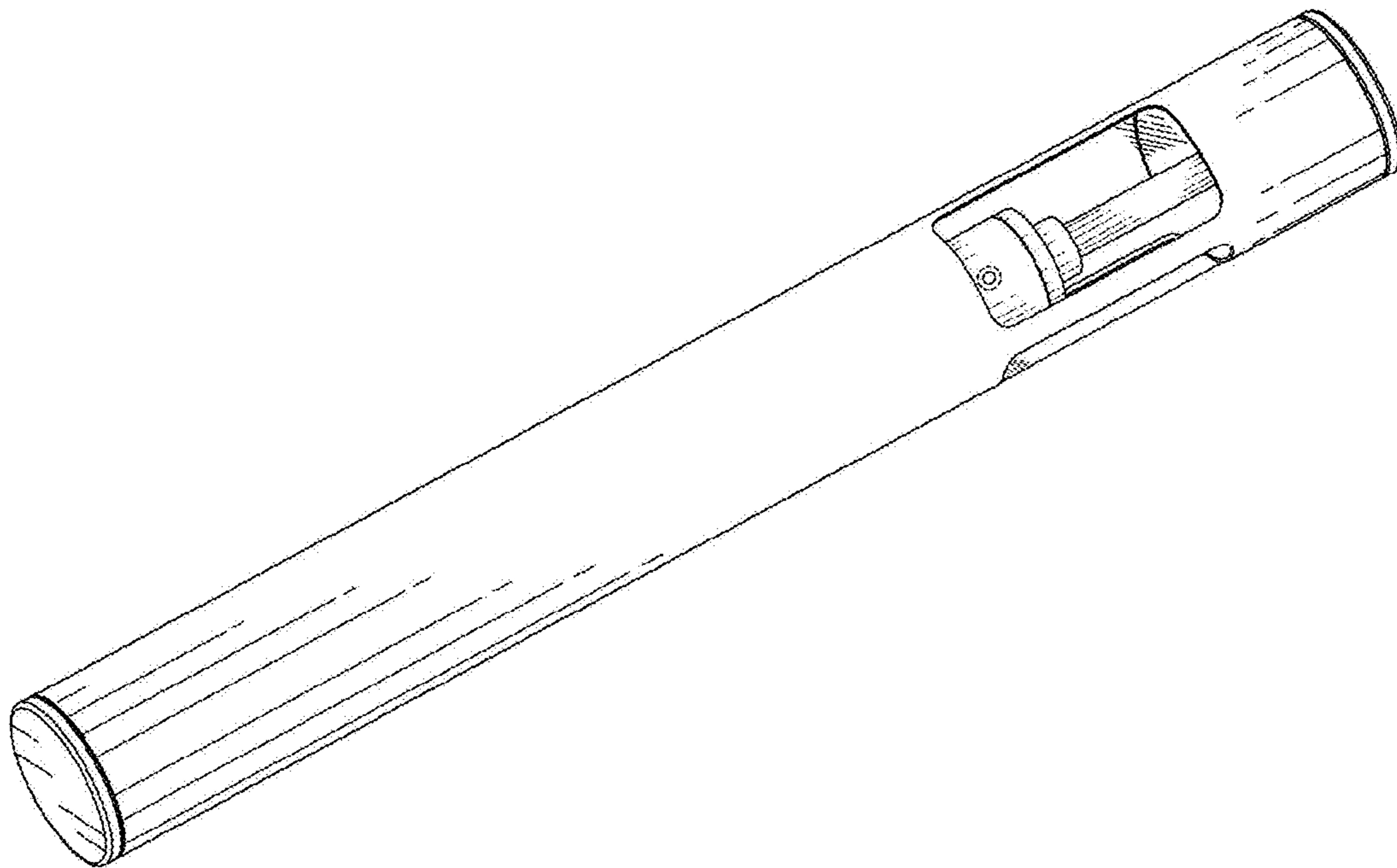

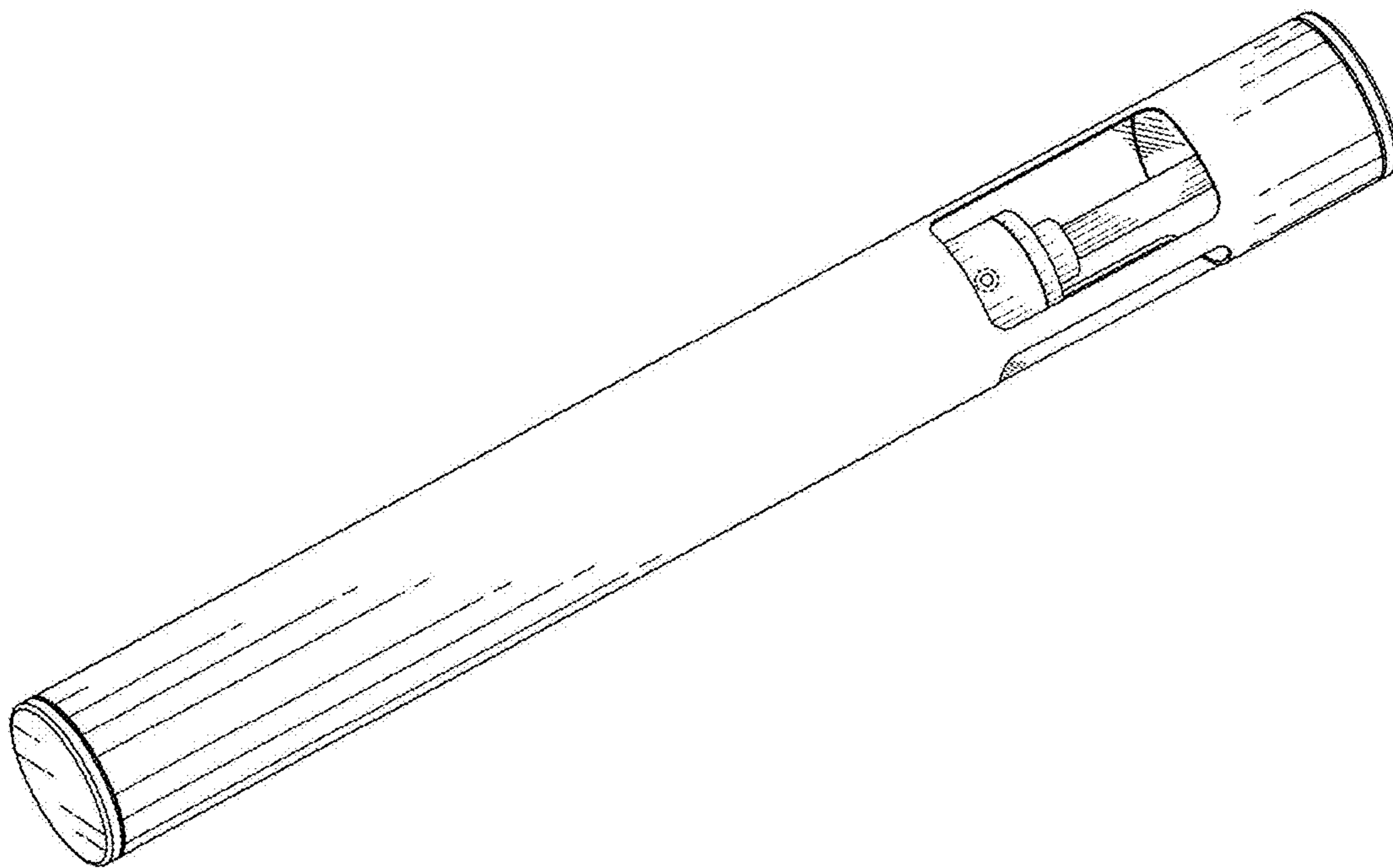

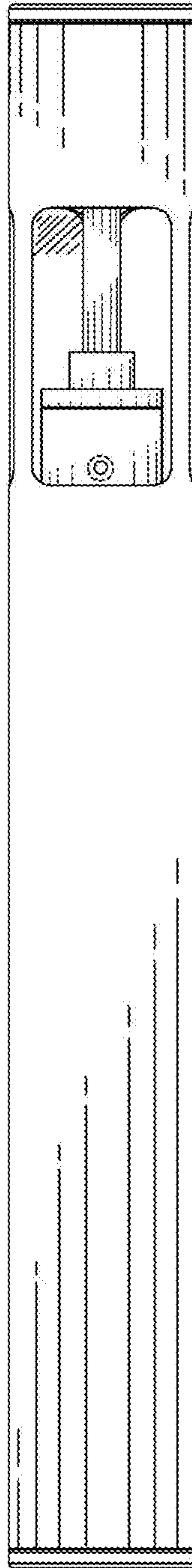

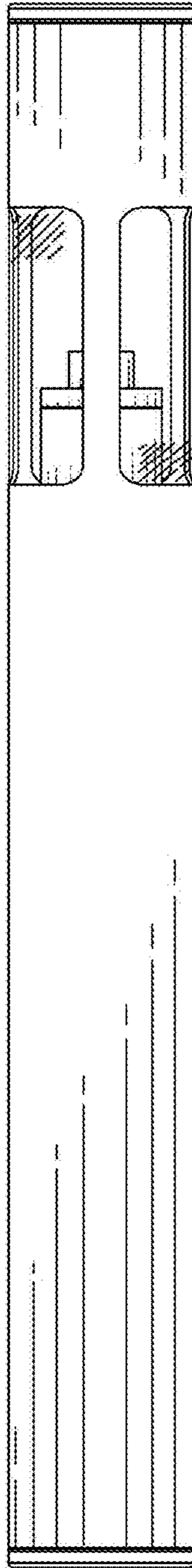

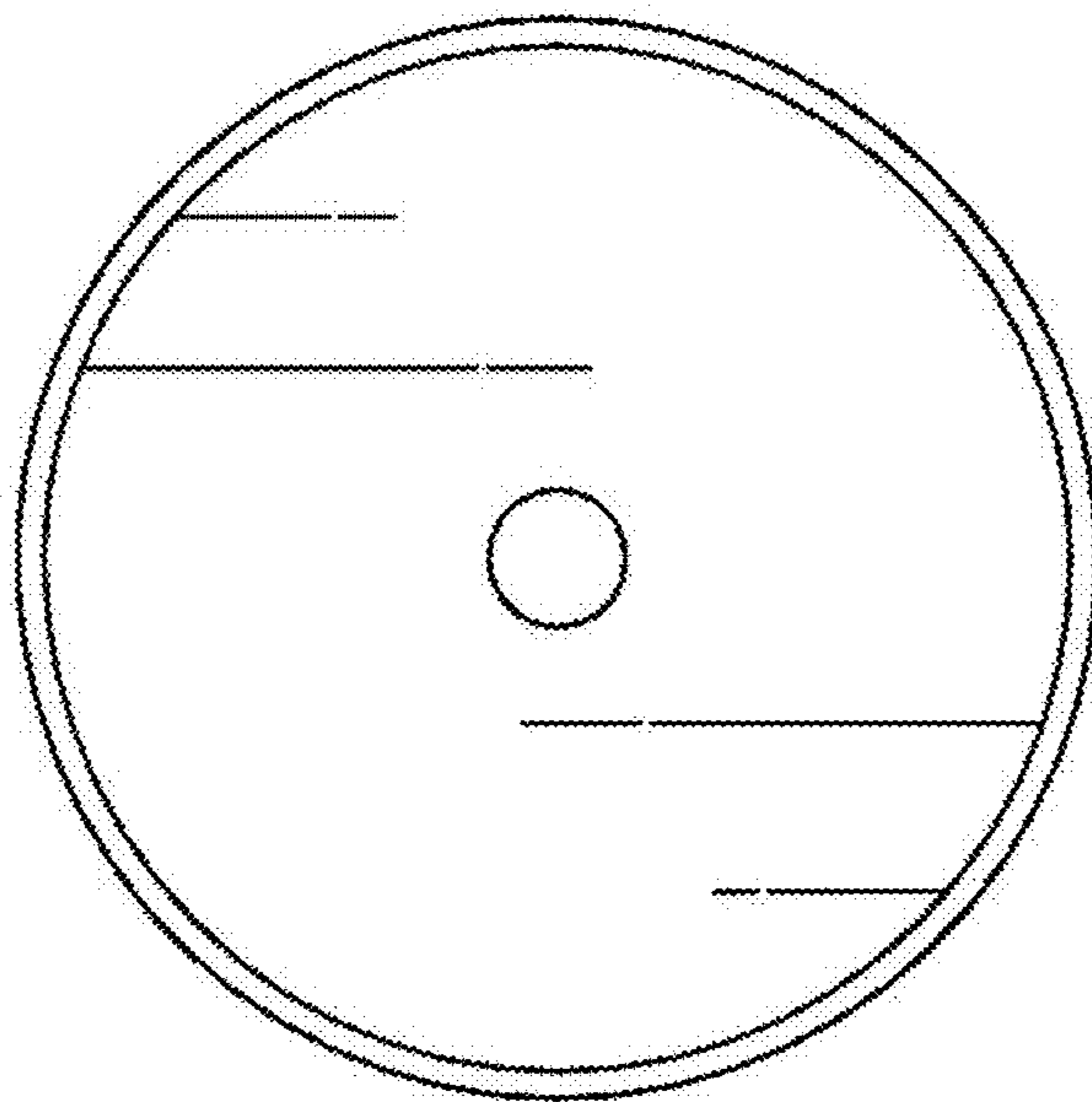

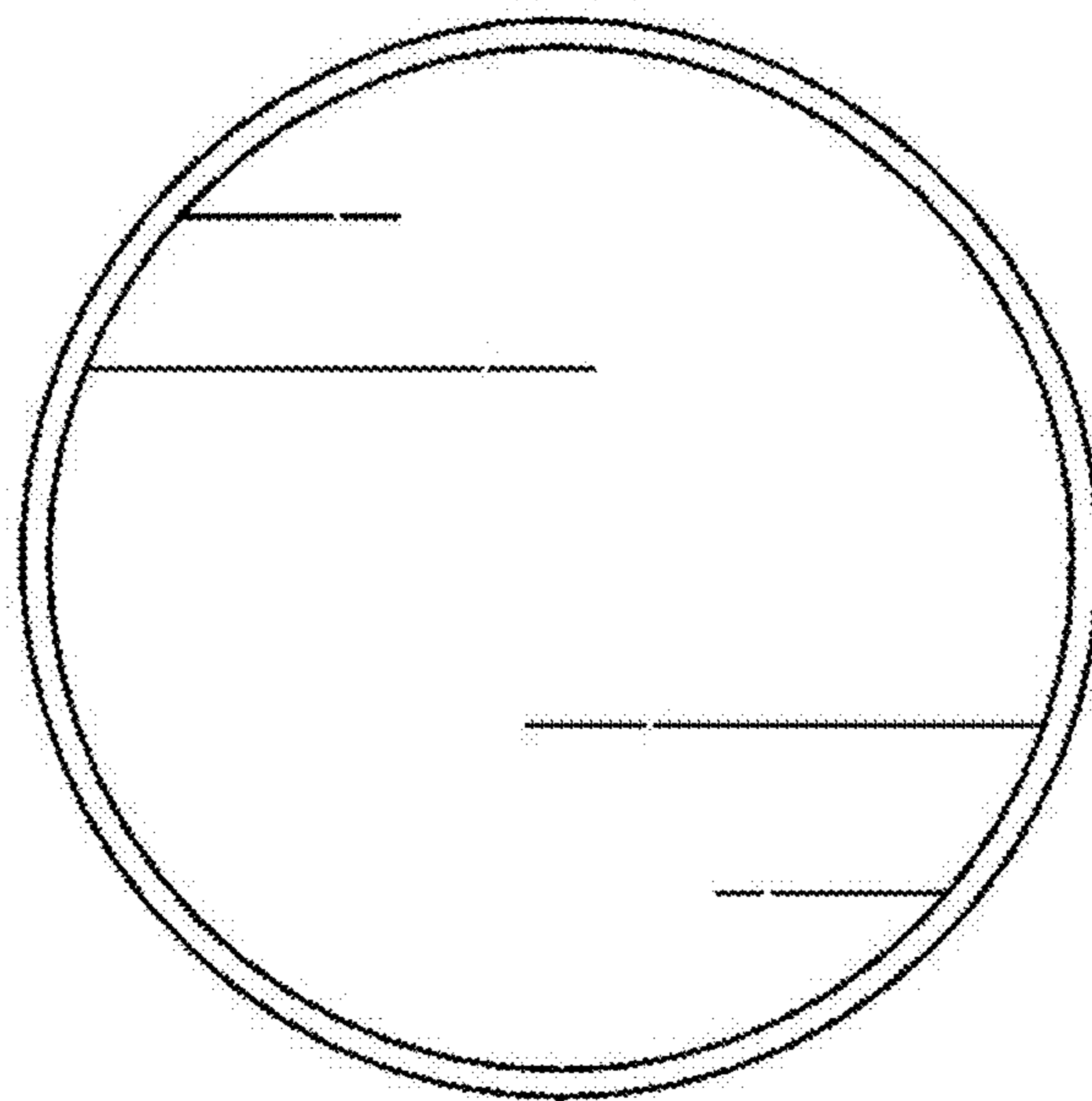

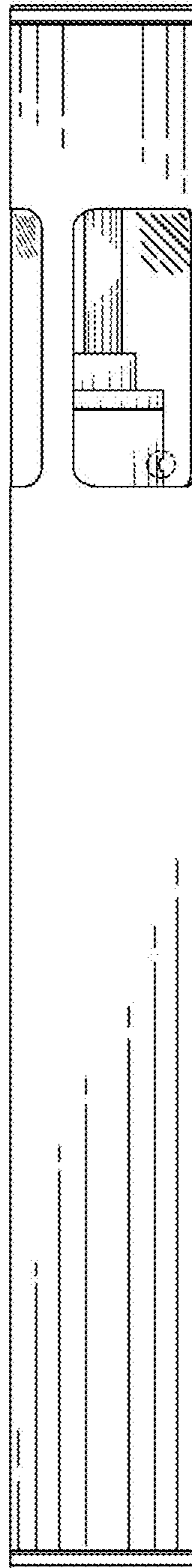
