DESCRIPTION

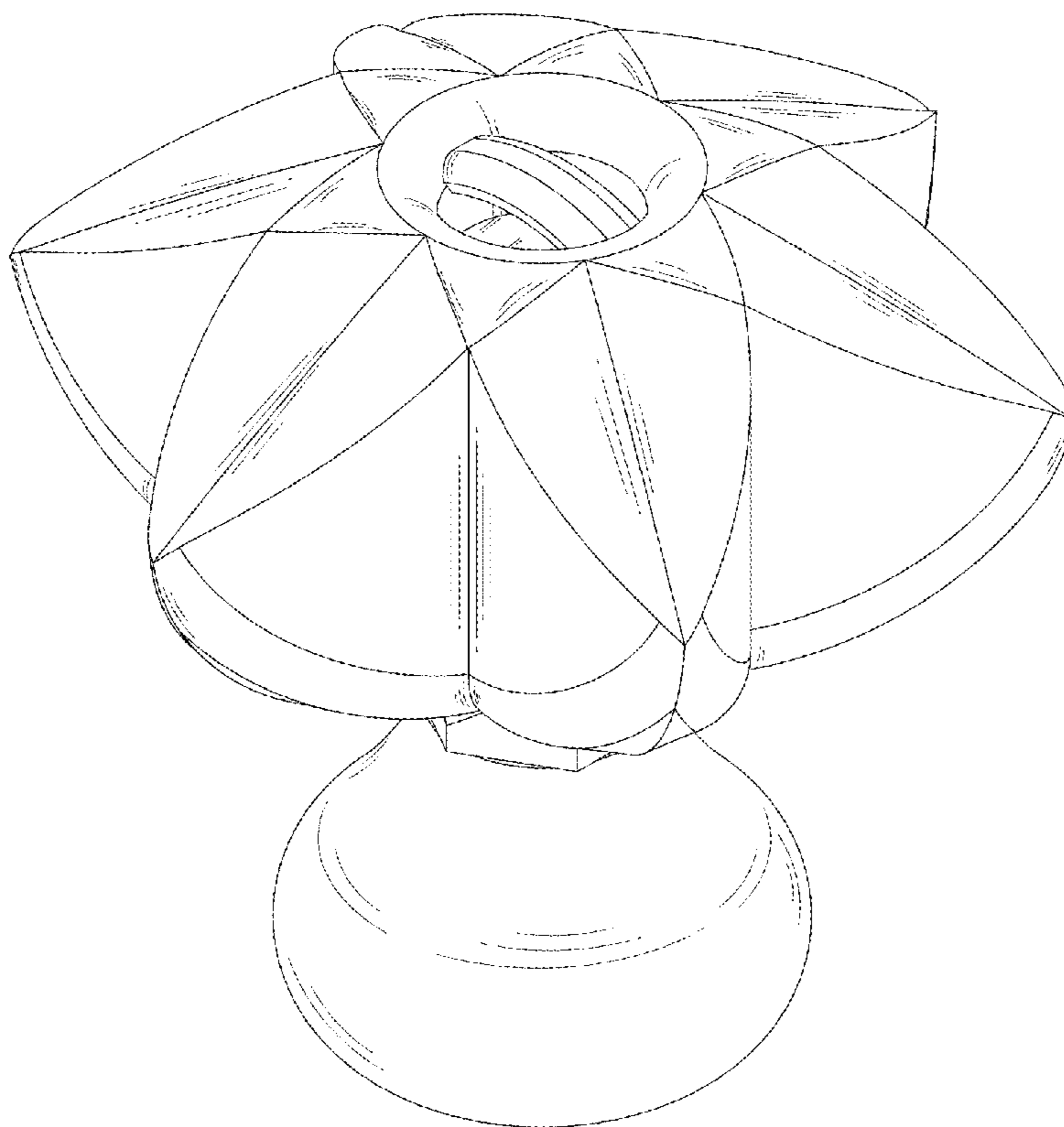
FIG. 1 is a perspective view of a hair accessory showing my new design thereof;

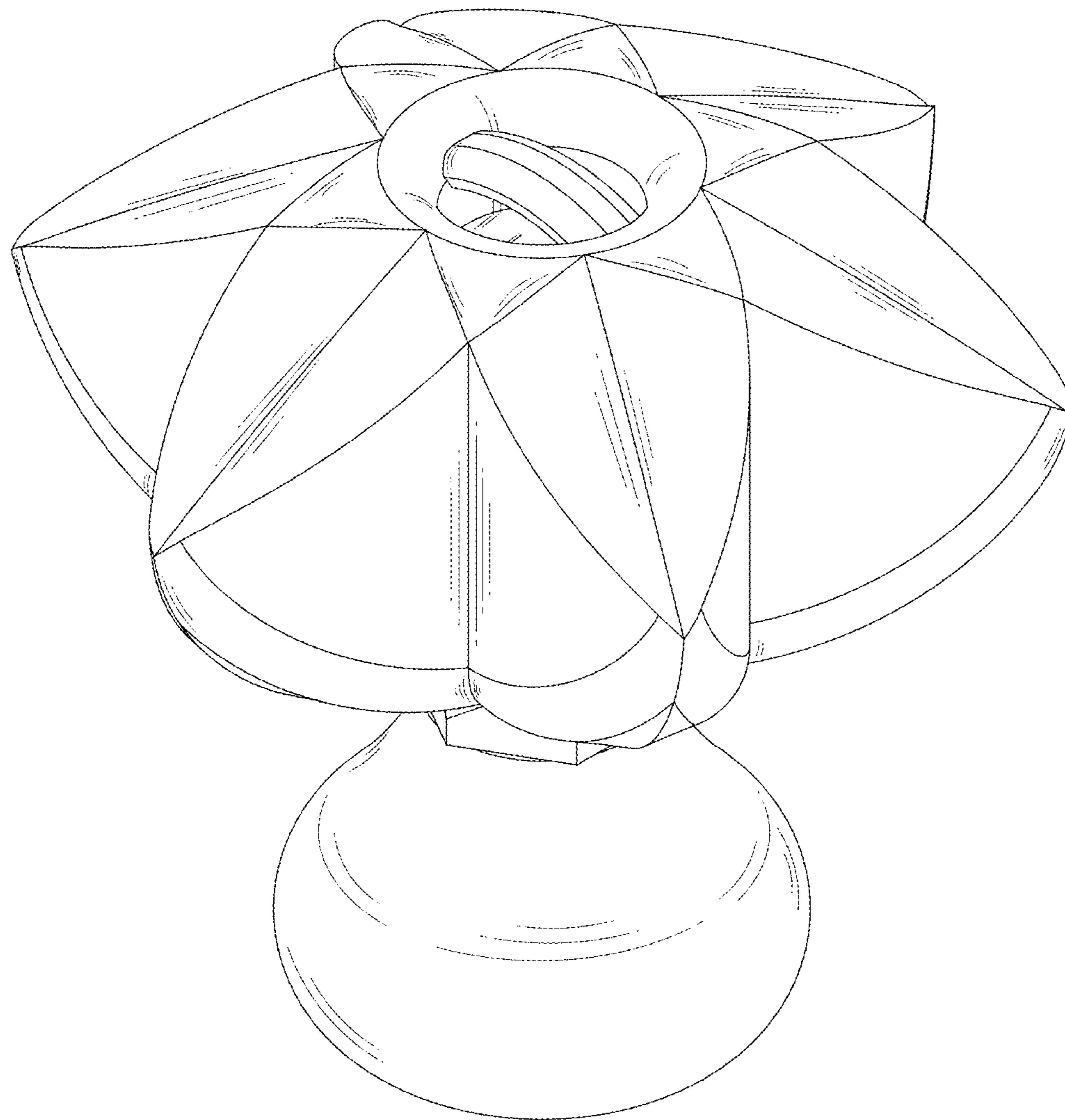

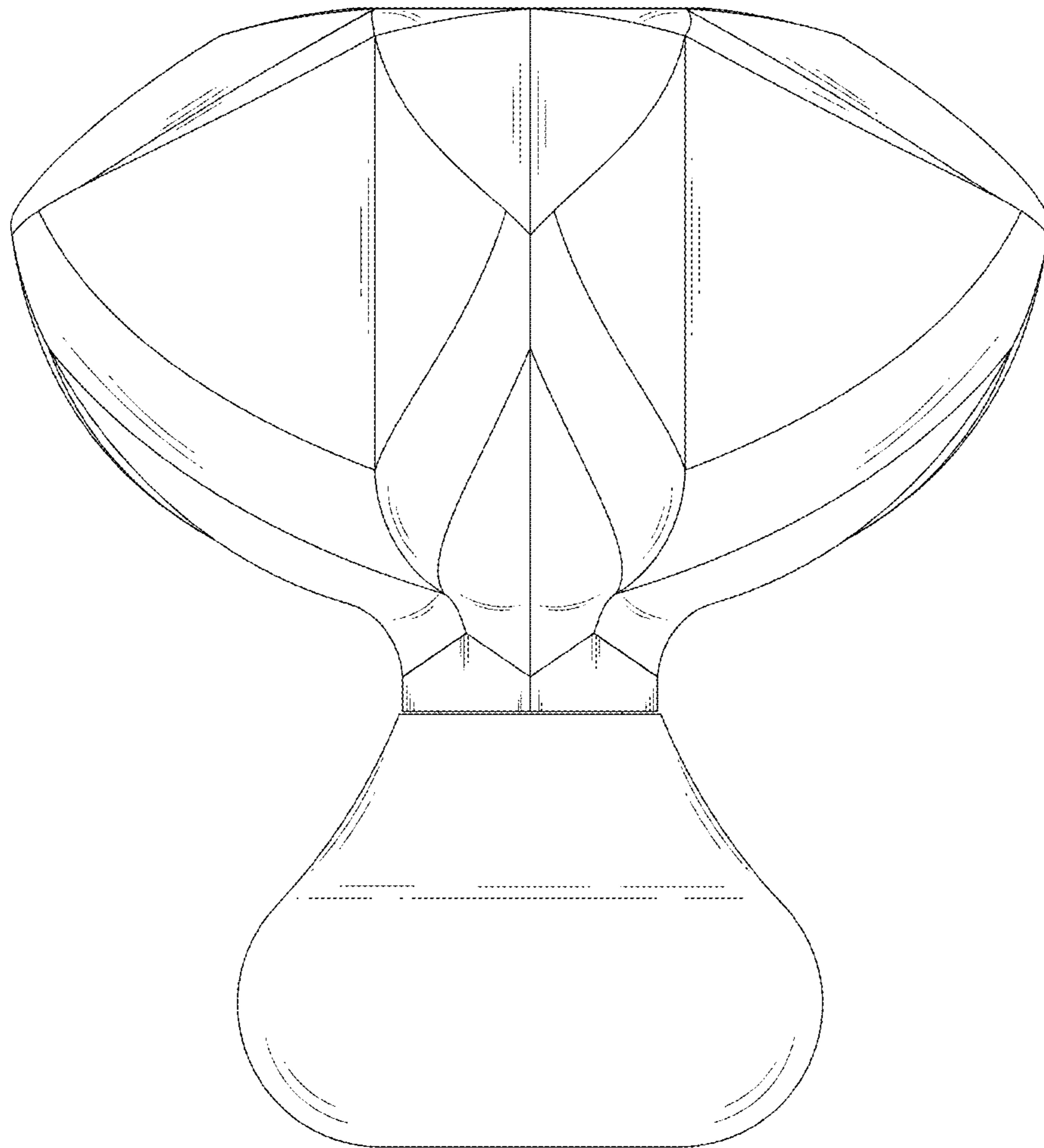

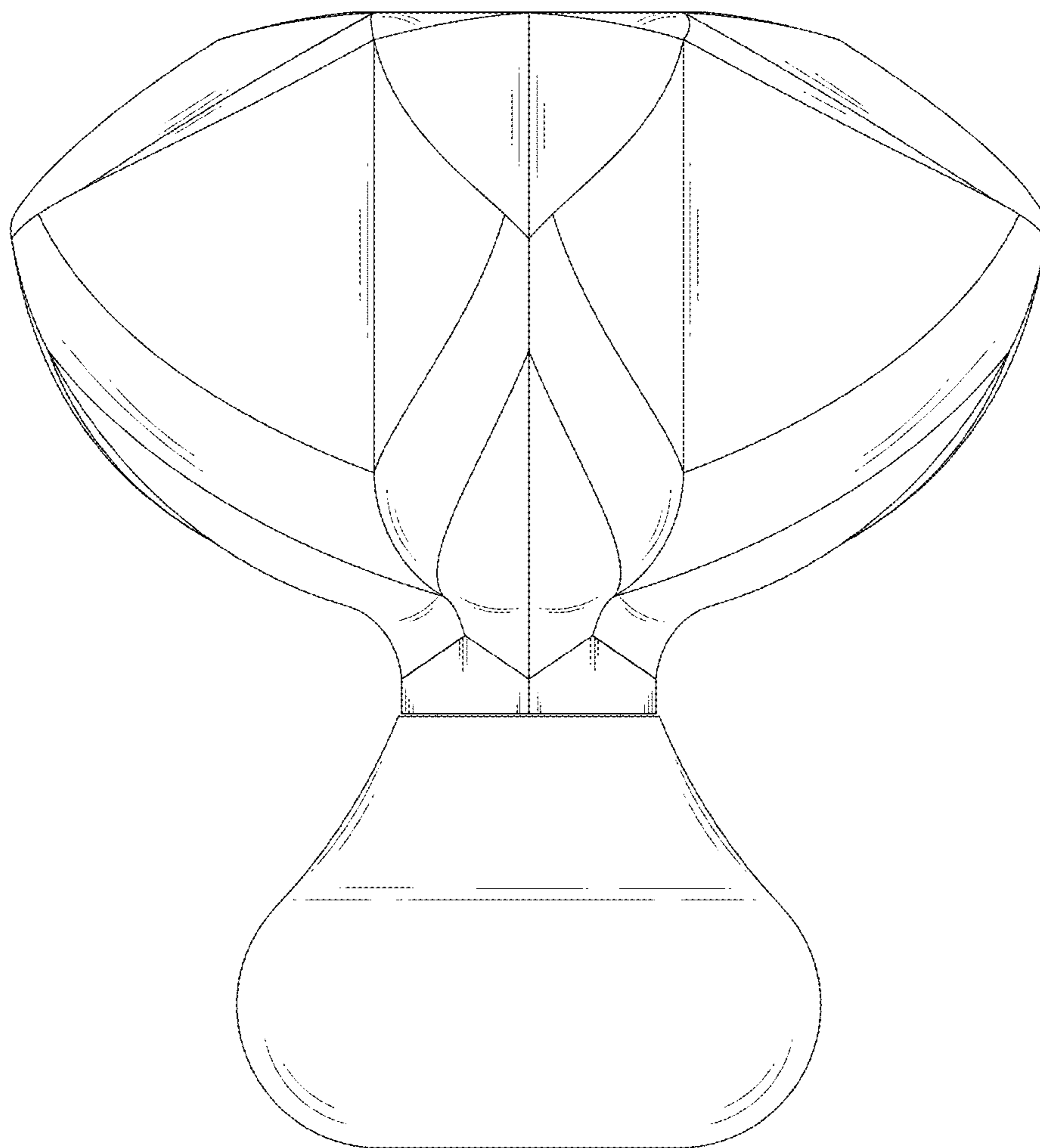

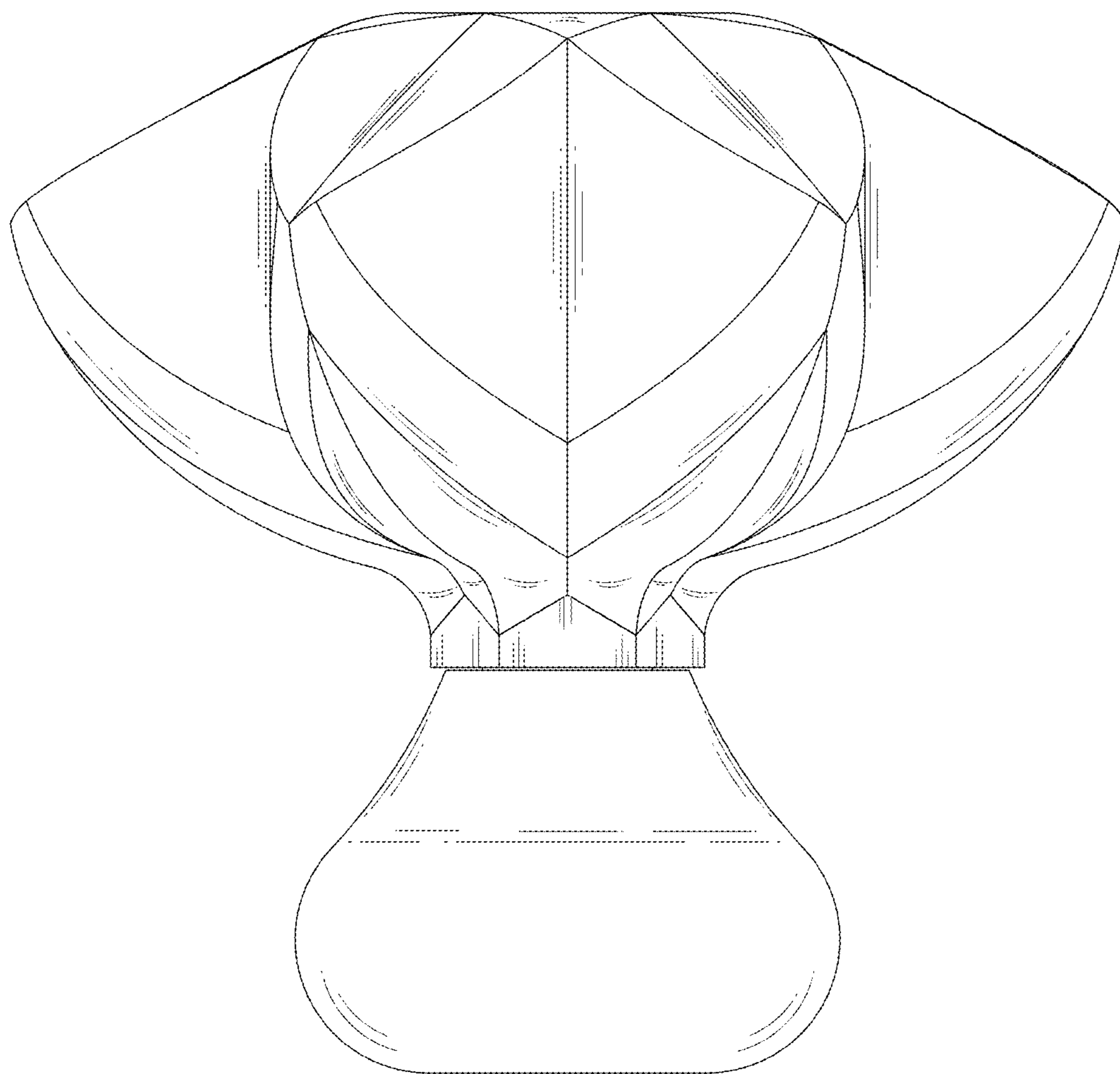

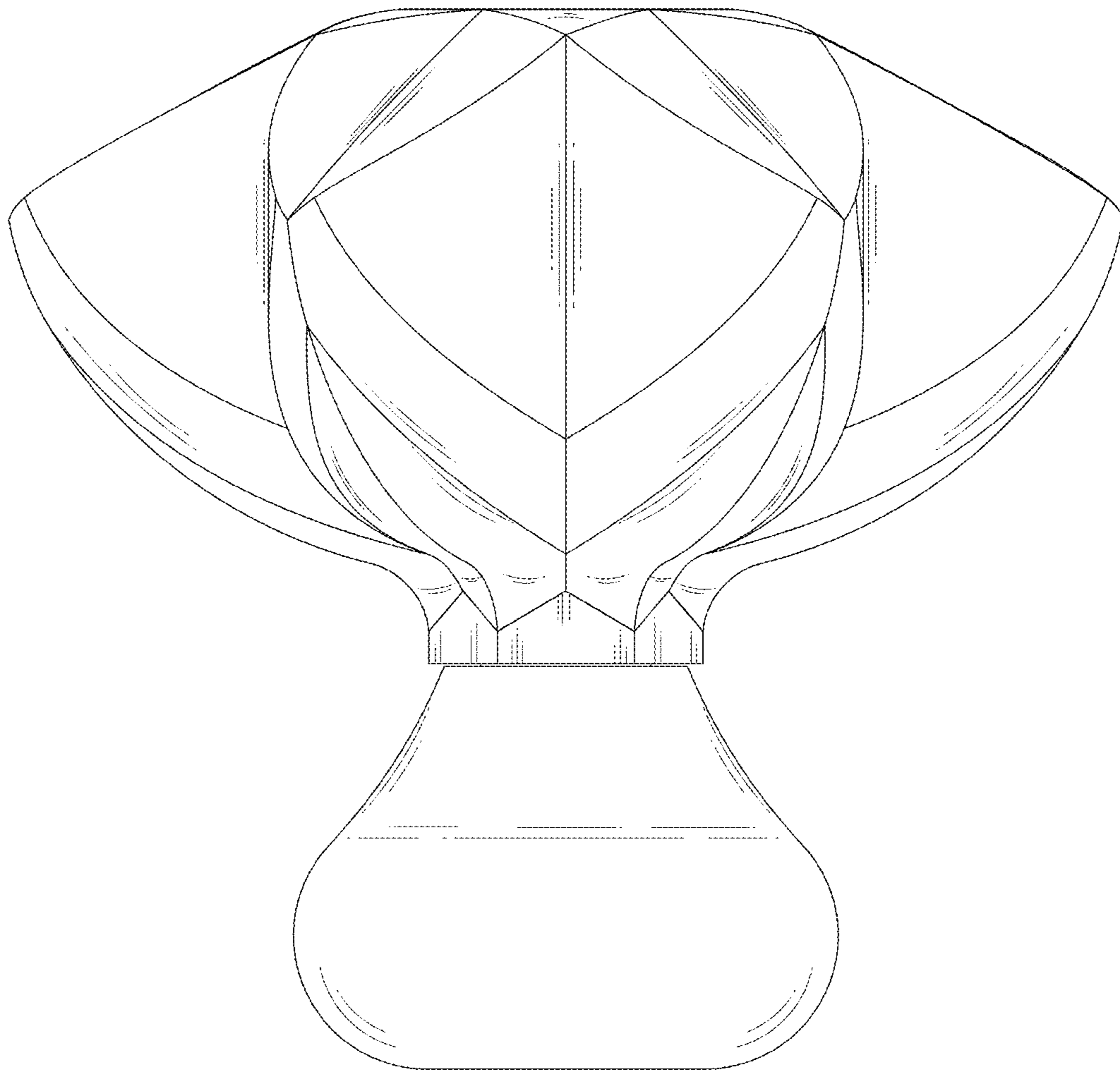

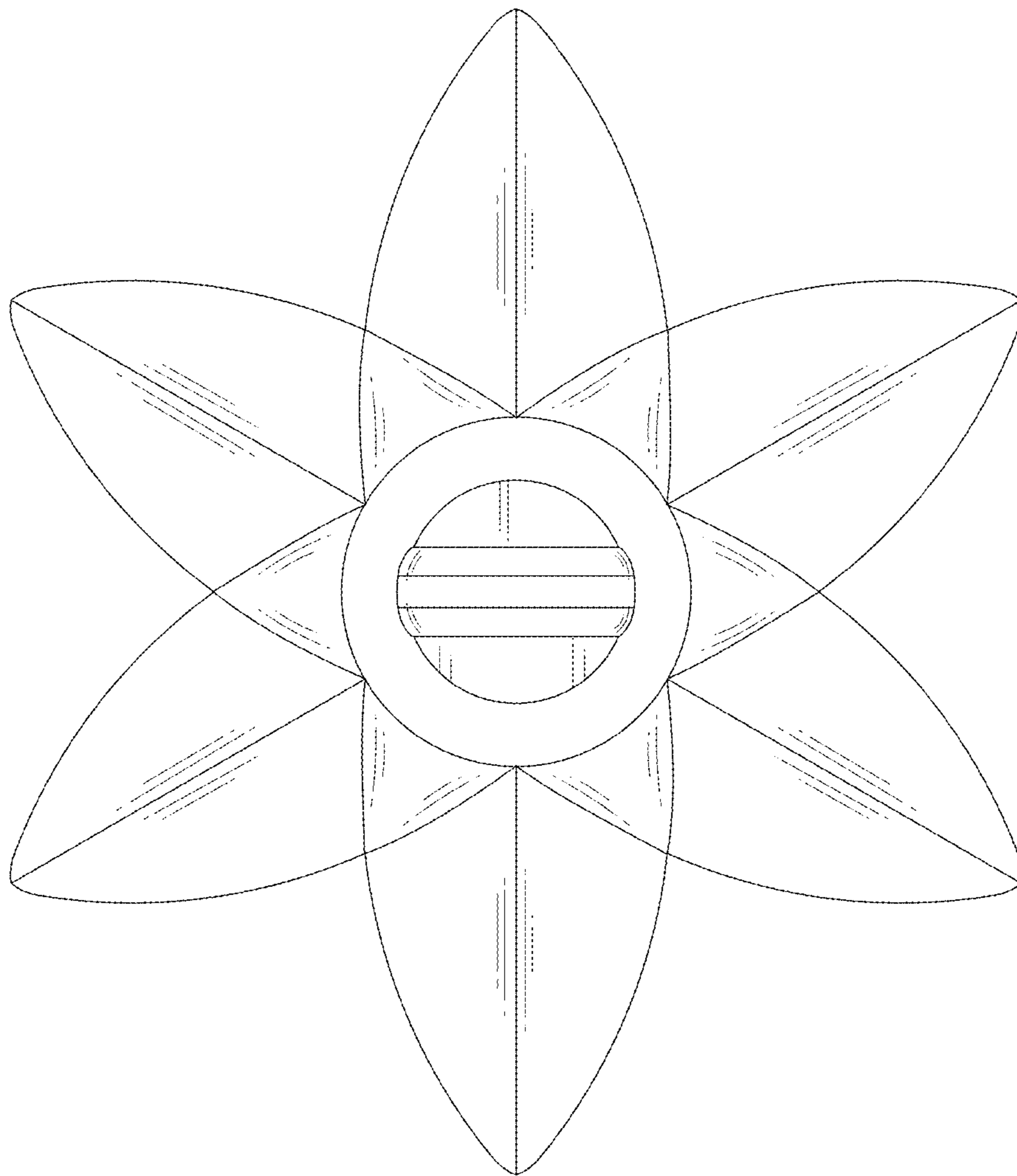

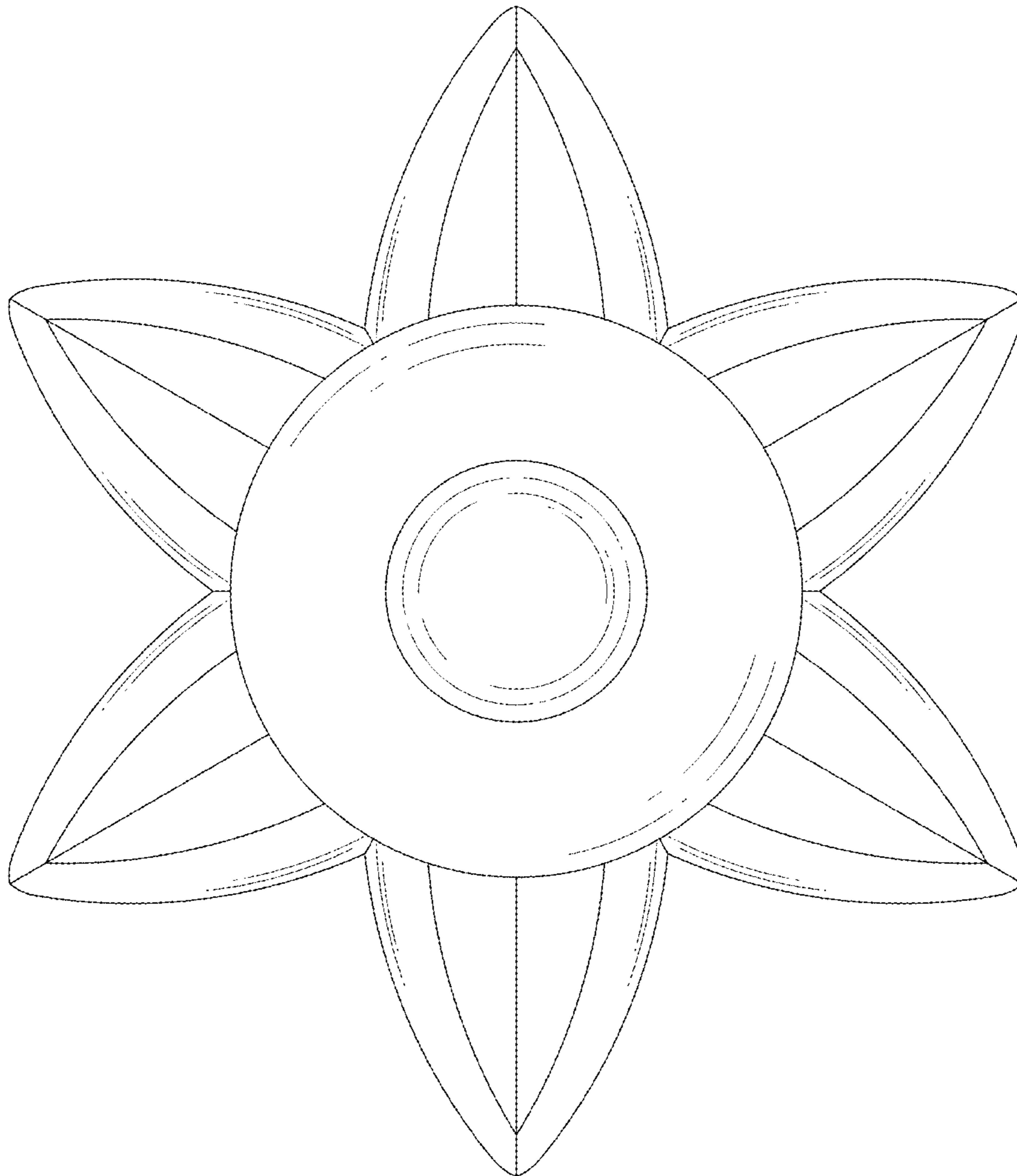

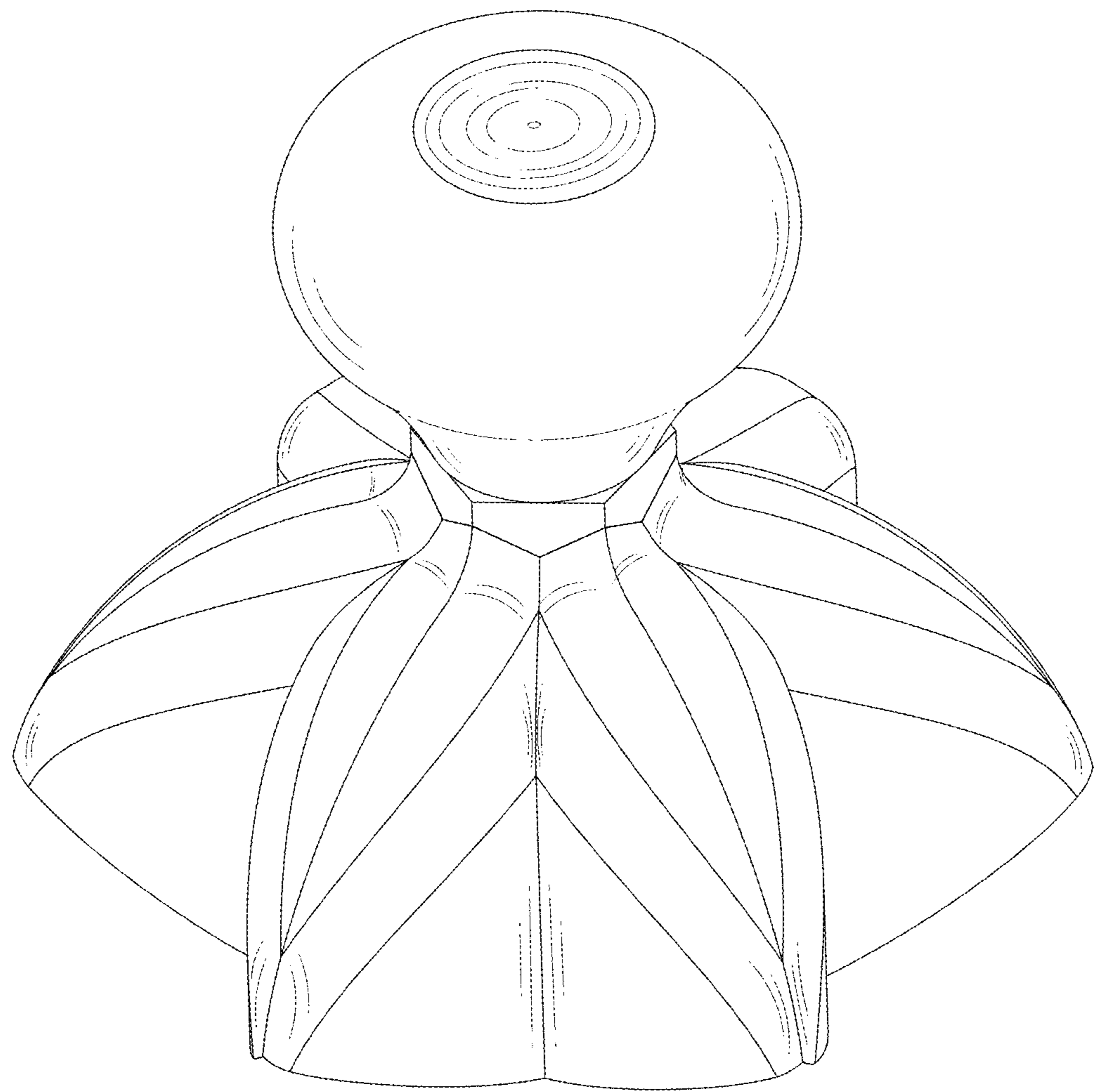
