(57) **CLAIM**

The ornamental design for a razor handle, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a razor handle of the present invention;

FIG. 2 is a front view of the razor handle of FIG. 1;

FIG. 3 is a back view of the razor handle of FIG. 1;

FIG. 4 is a right side view of the razor handle of FIG. 1;

FIG. 5 is a left side view of the razor handle of FIG. 1;

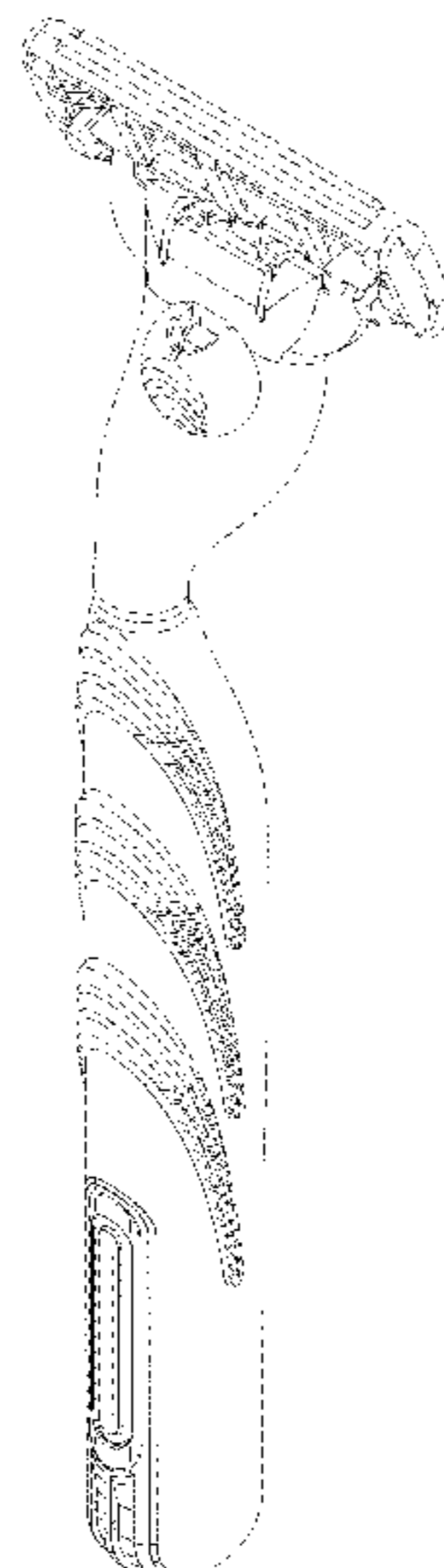
FIG. 6 is a top view of the razor handle of FIG. 1; and,

FIG. 7 is a bottom view of the razor handle of FIG. 1.

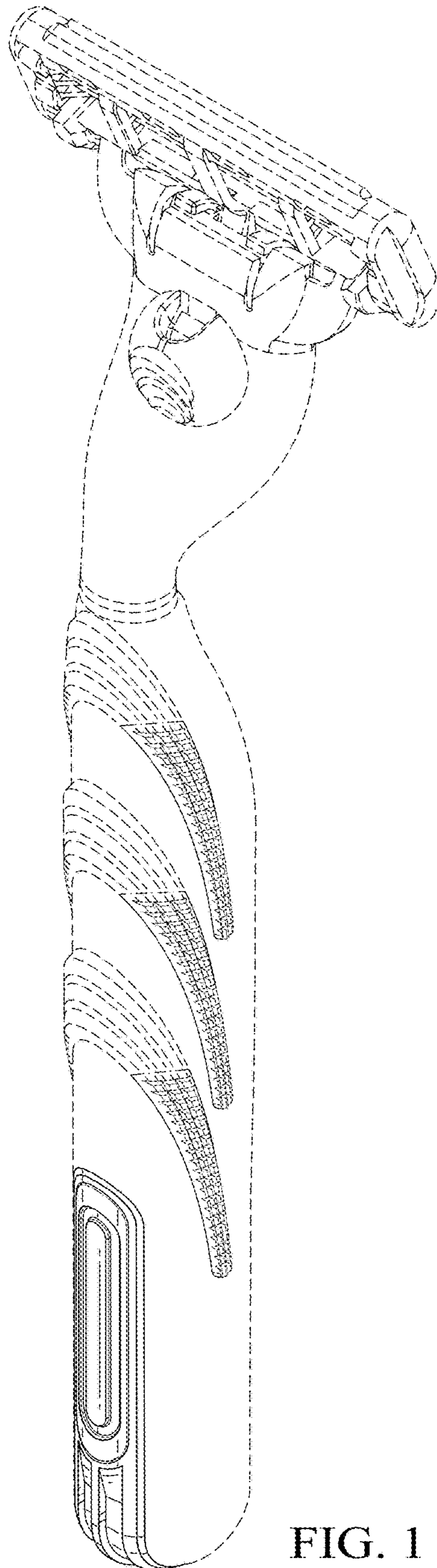

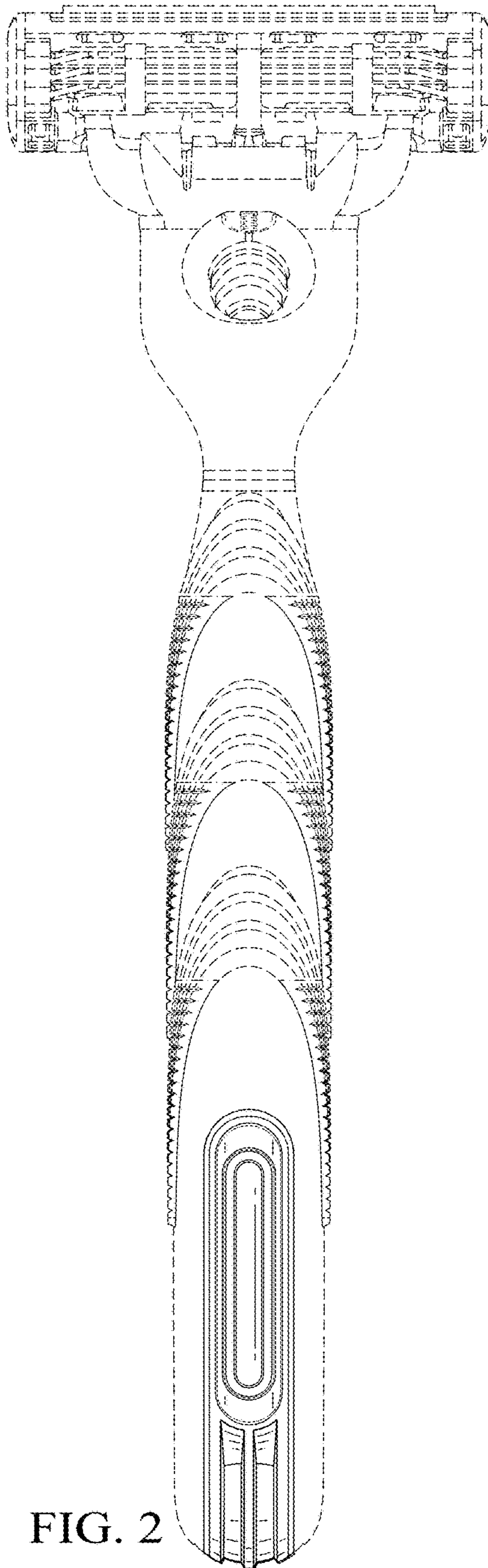

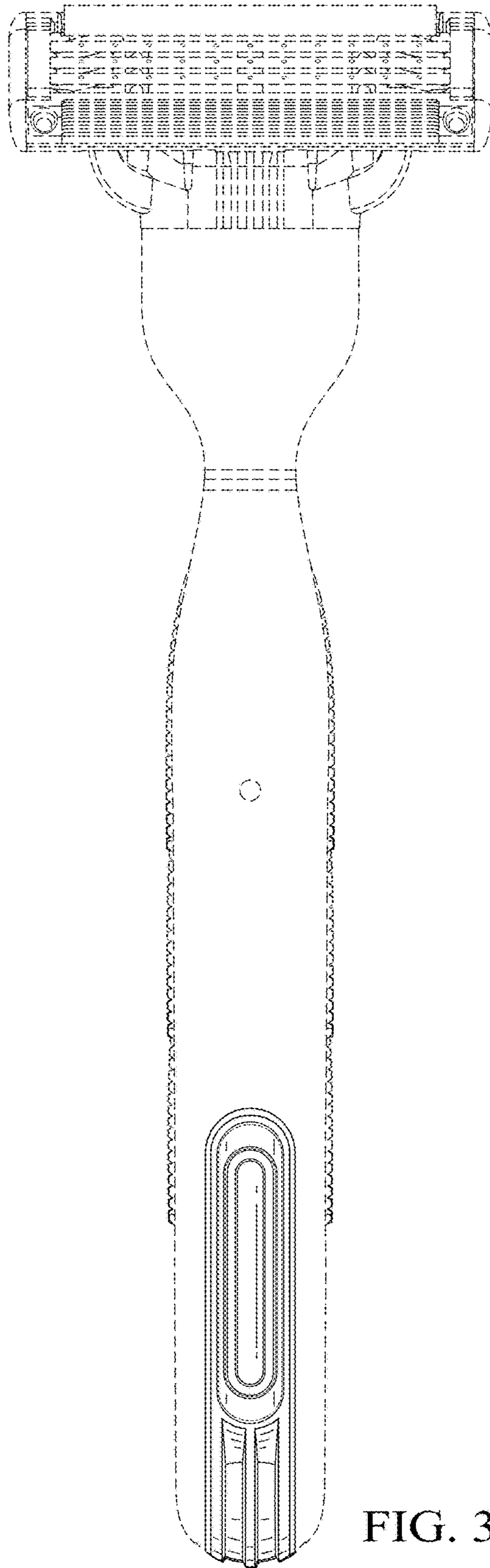

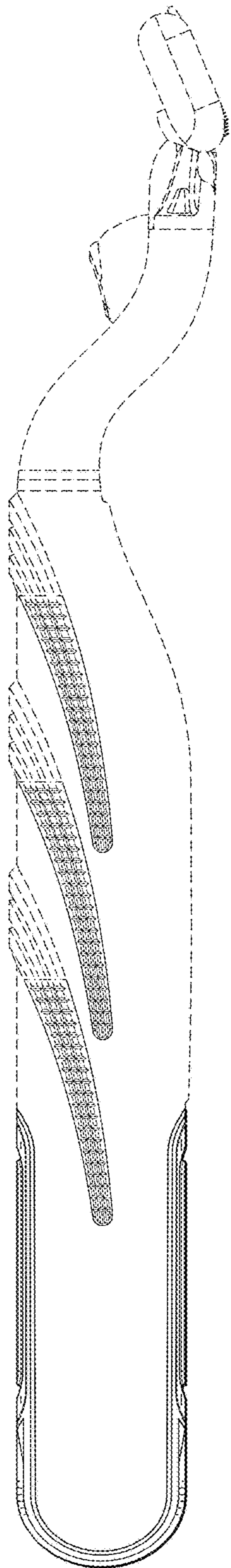

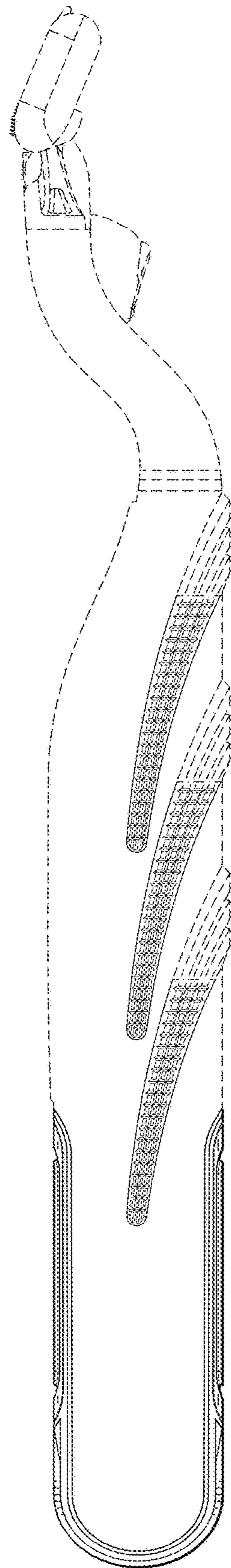

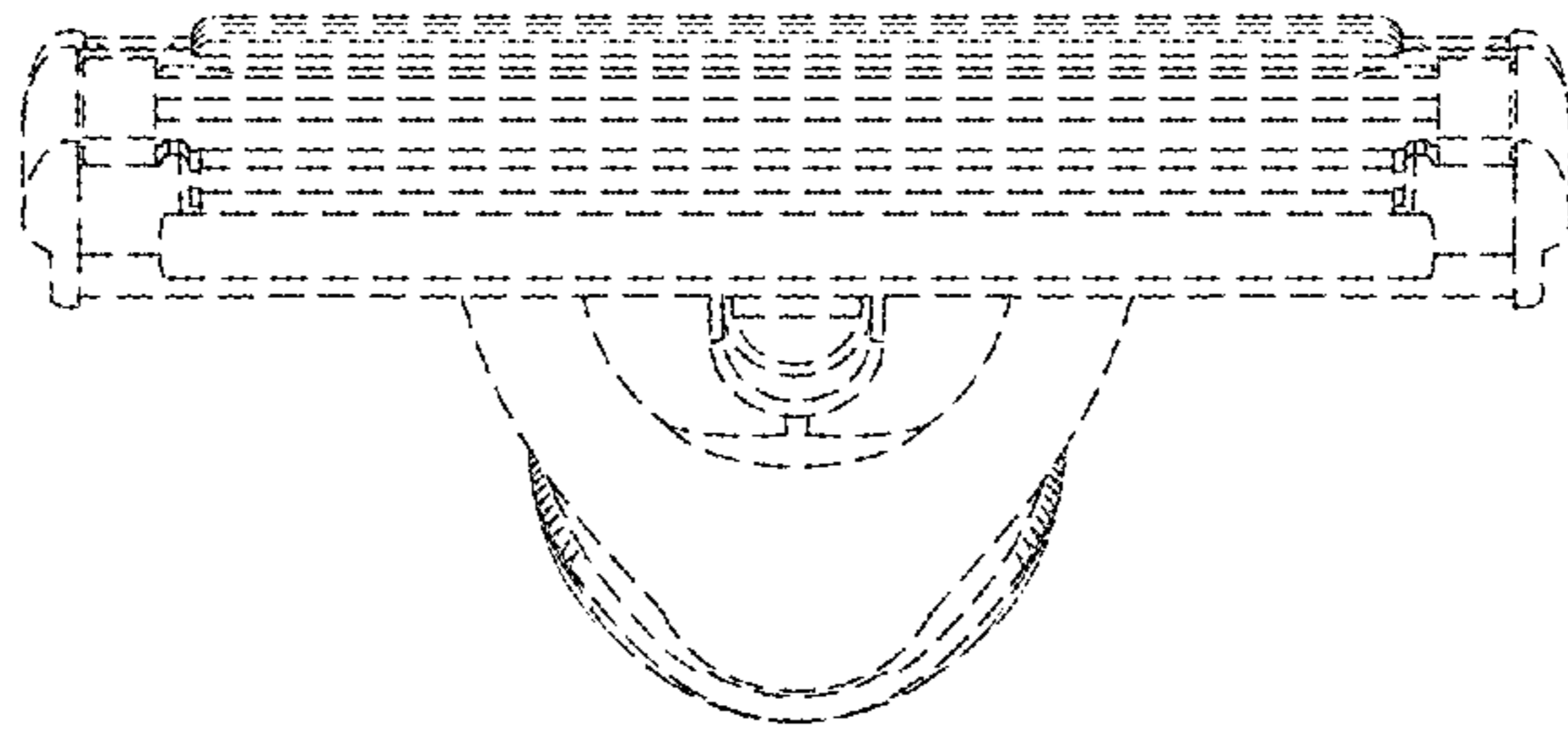

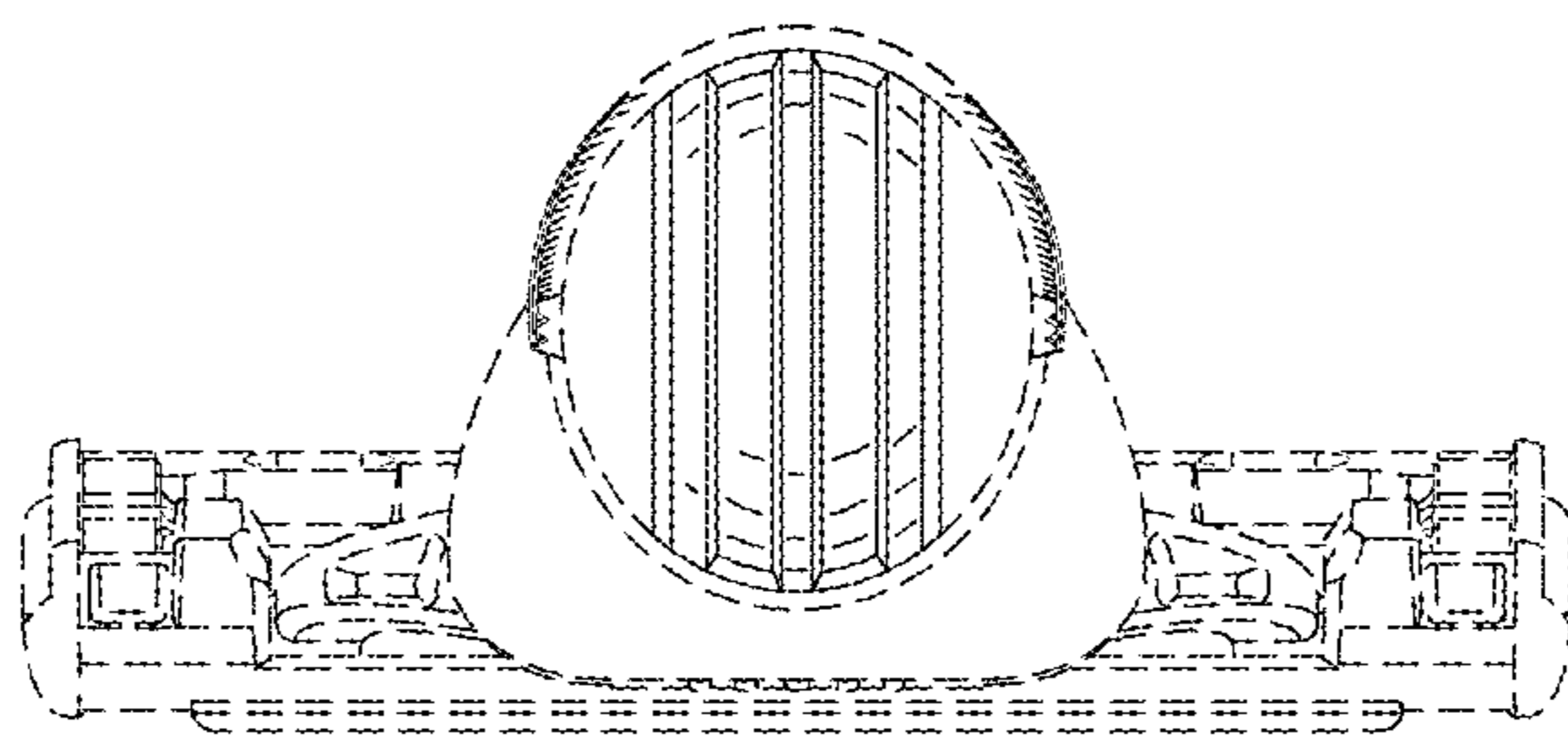
