FIG. 2 is a rear elevation view thereof, showing the mirror surface of the lip balm casing;

FIG. 5 is a top plan view thereof;
FIG. 6 is a bottom plan view thereof;
FIG. 7 is a rear elevation view thereof, showing a cap of the lip balm casing in an open position to expose an upper end of a lip balm stick;

FIG. 9 is a rear isometric view thereof, showing a bottom portion of the lip balm casing in a twisted position; and,
FIG. 10 is a top plan view of FIG. 9.

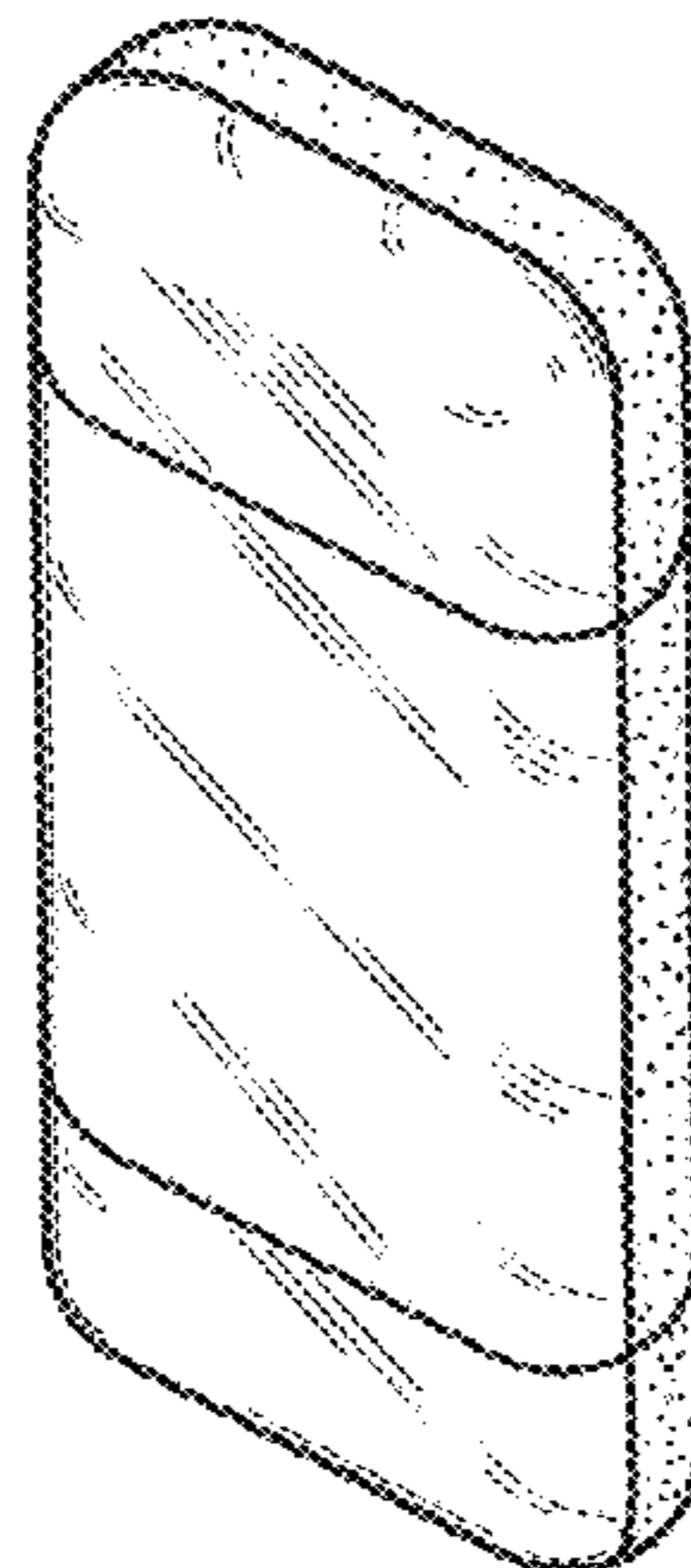

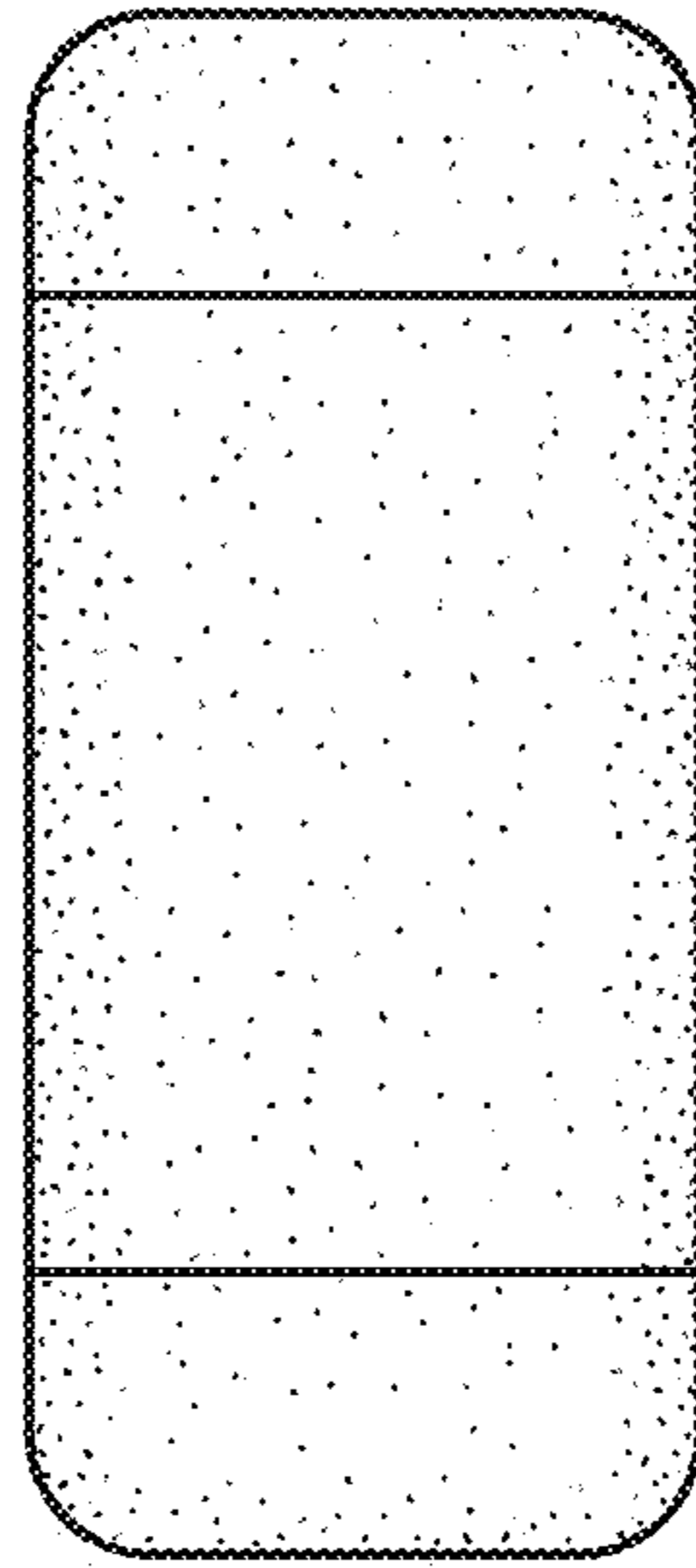

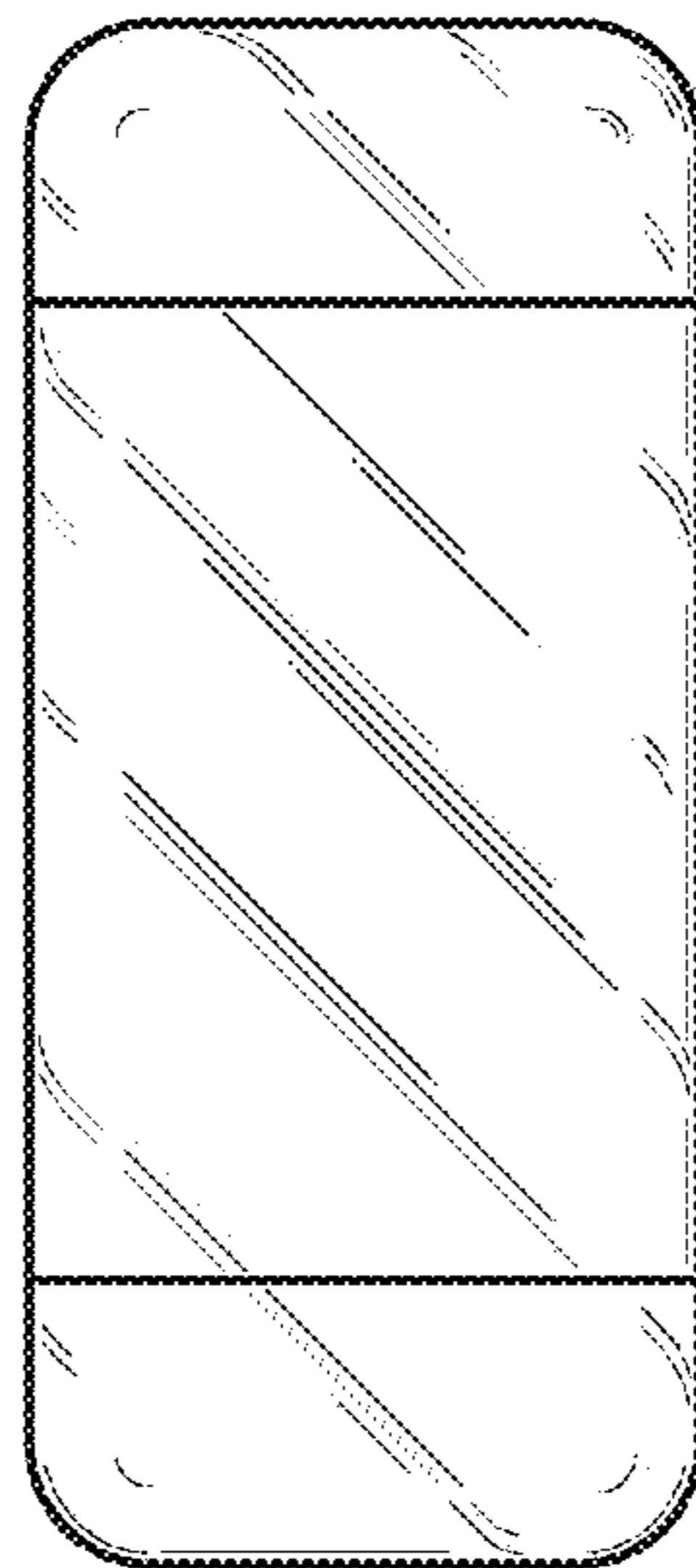

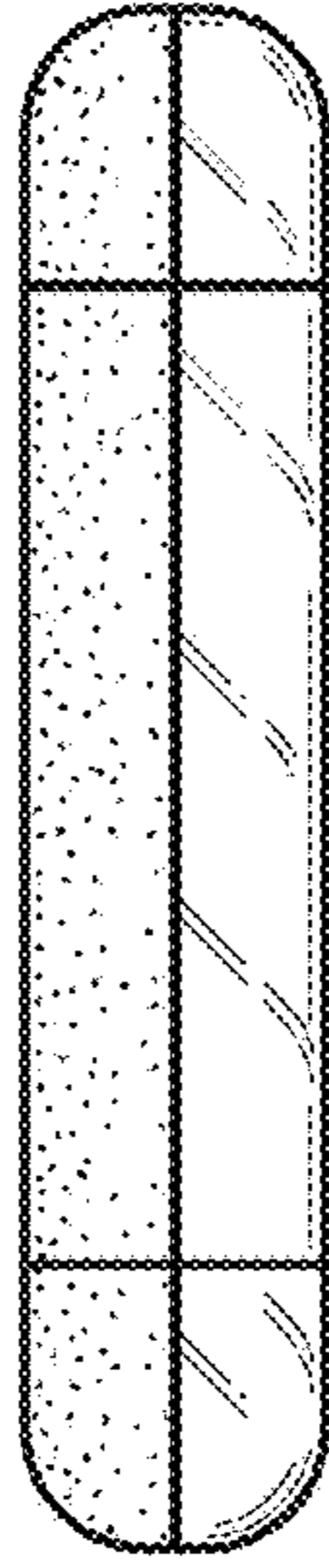

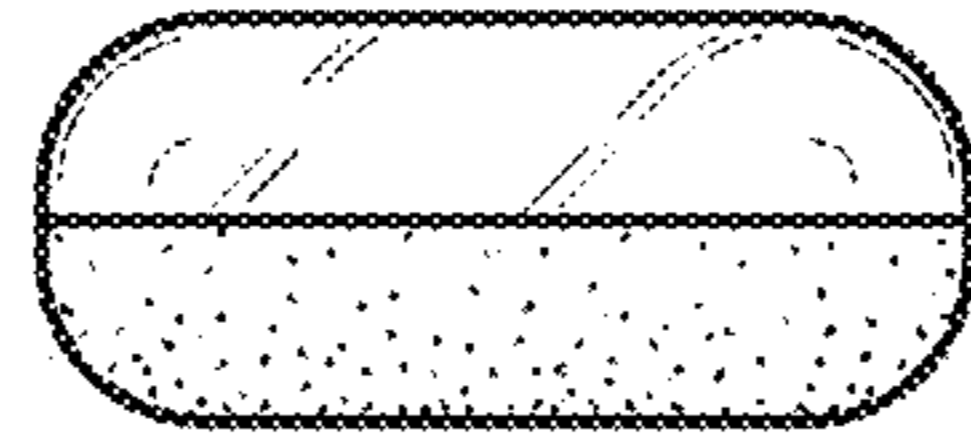

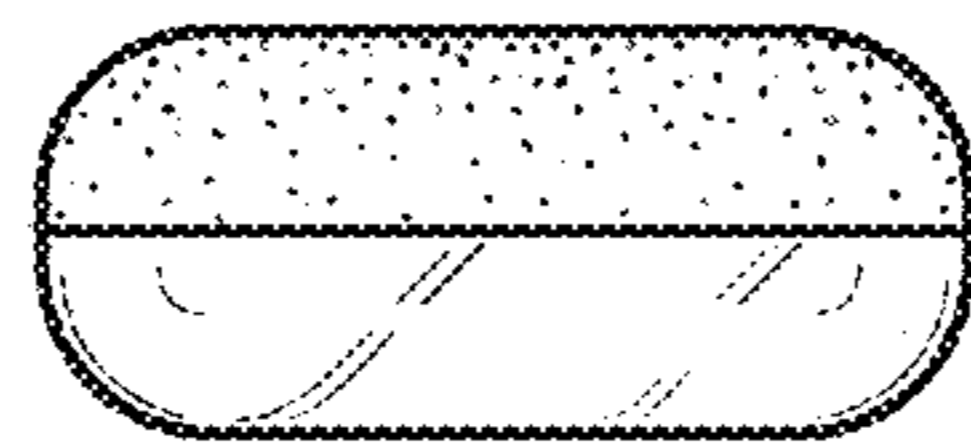

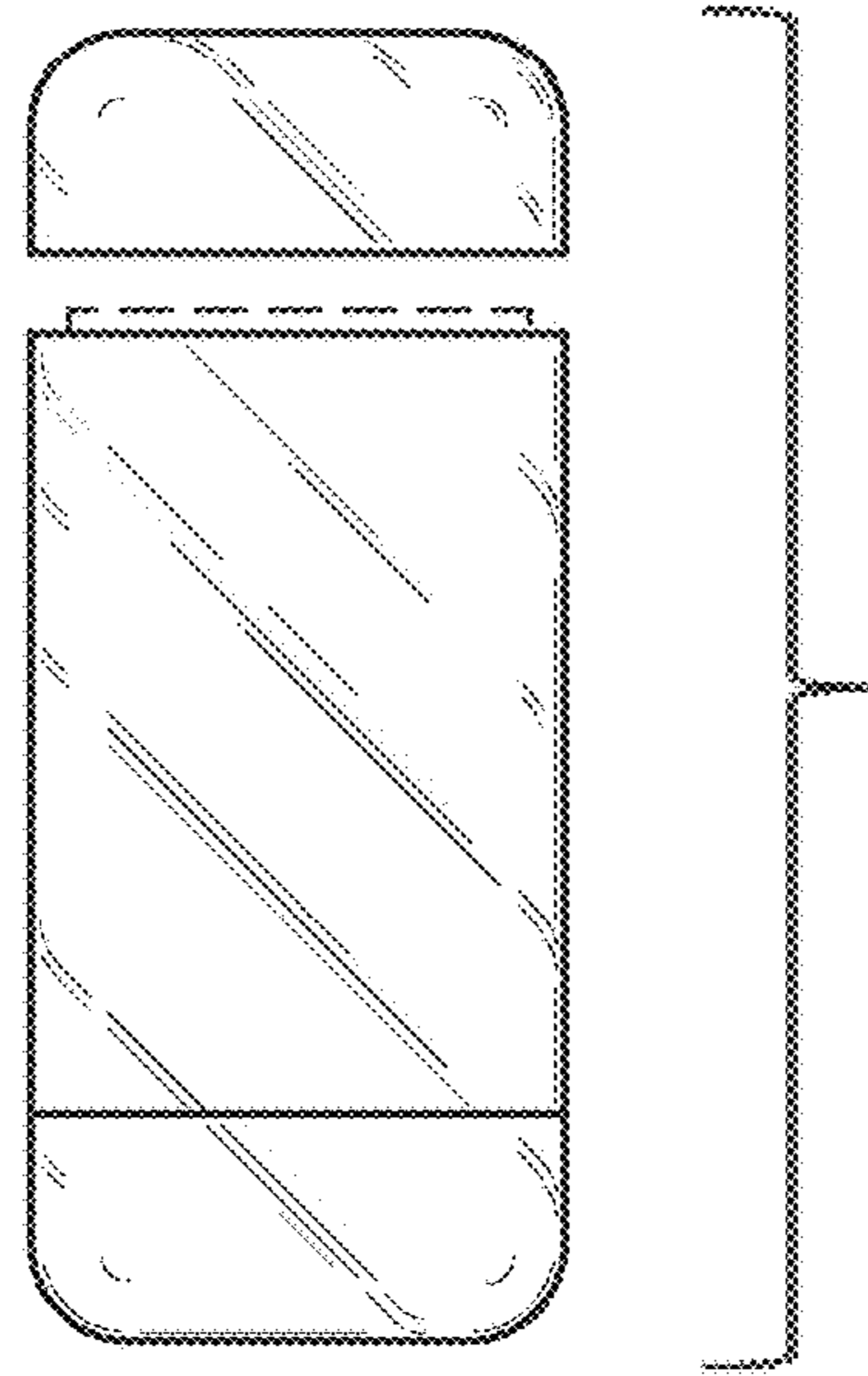

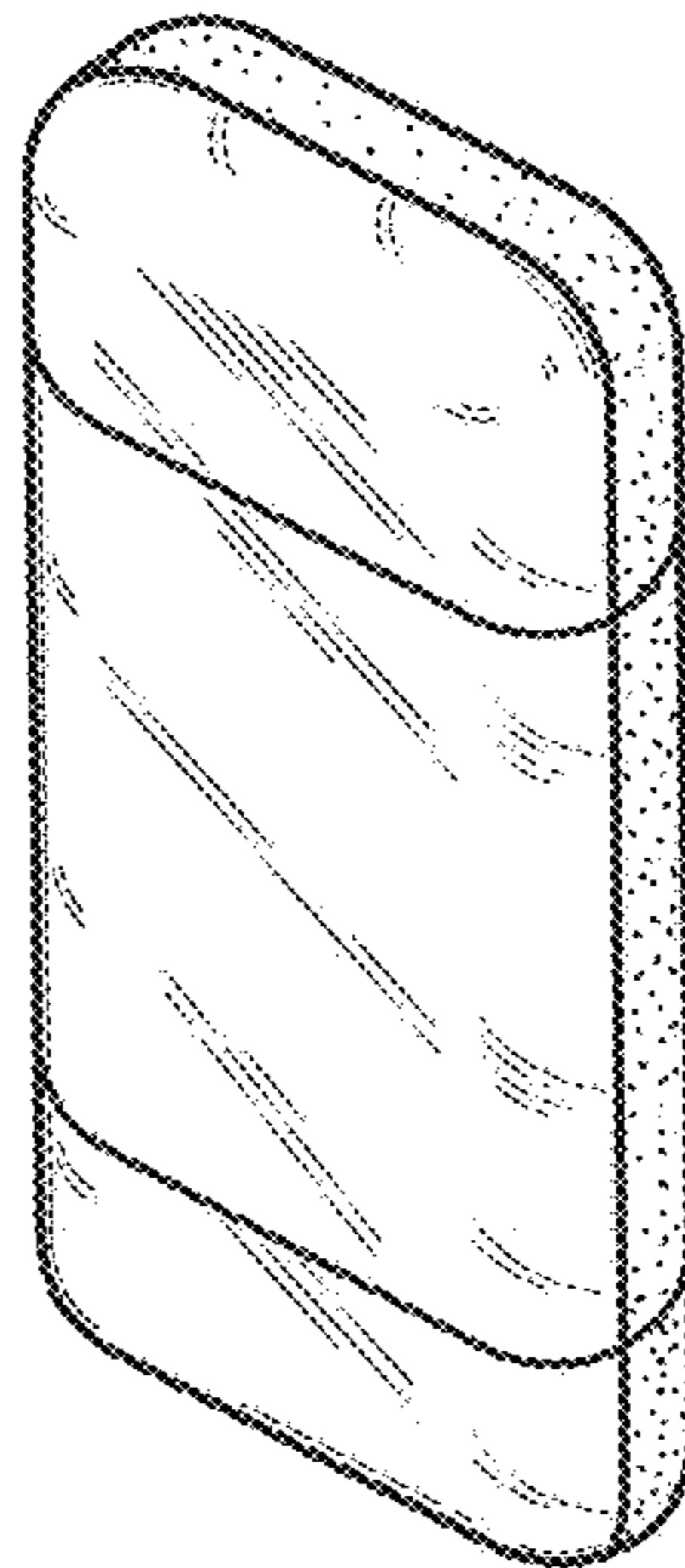

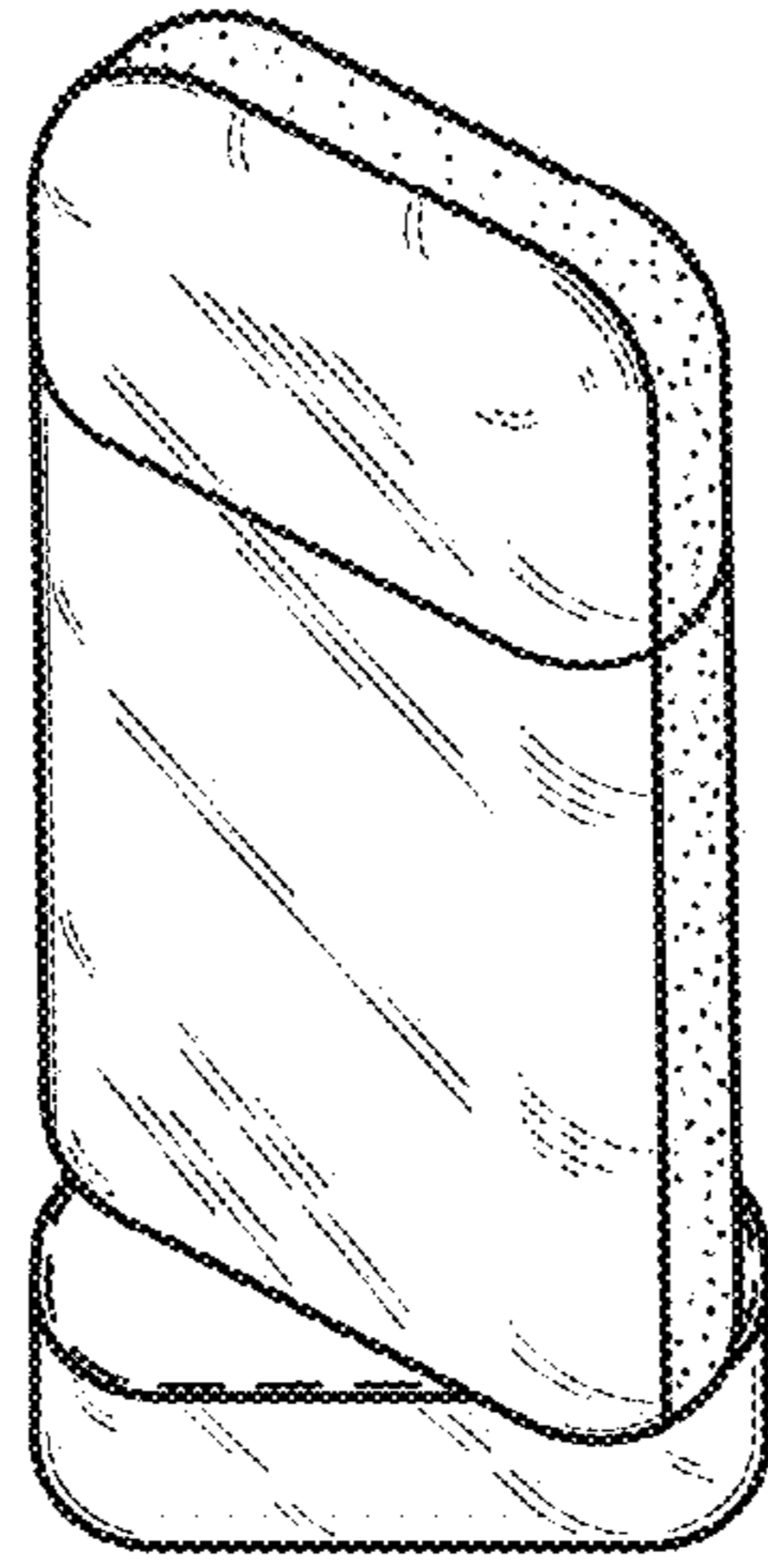

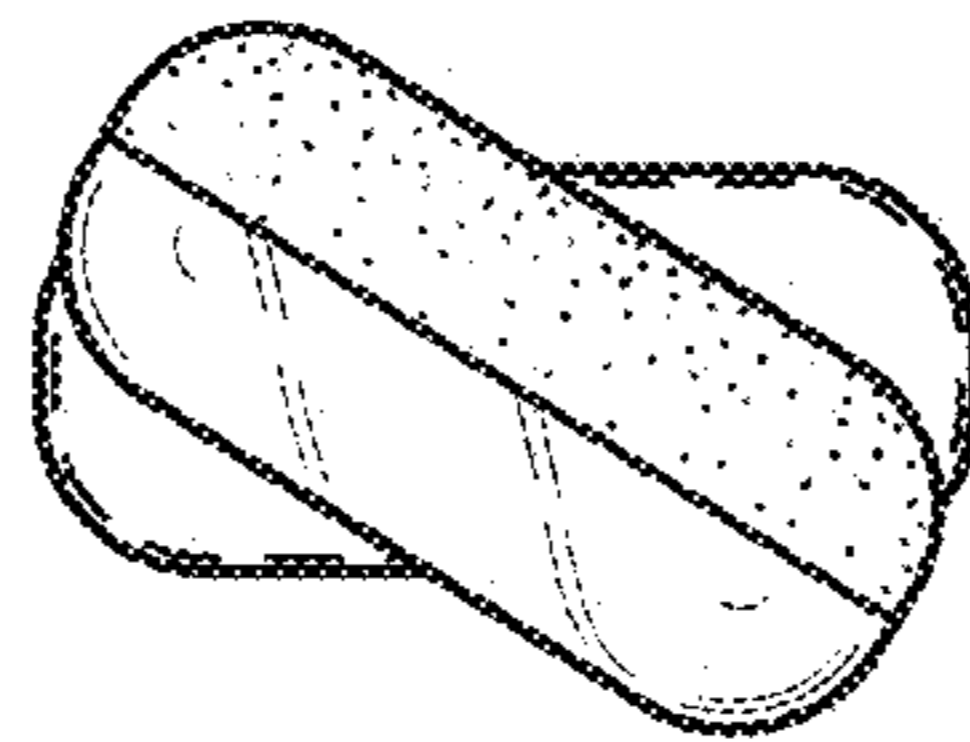
