(57) **CLAIM**

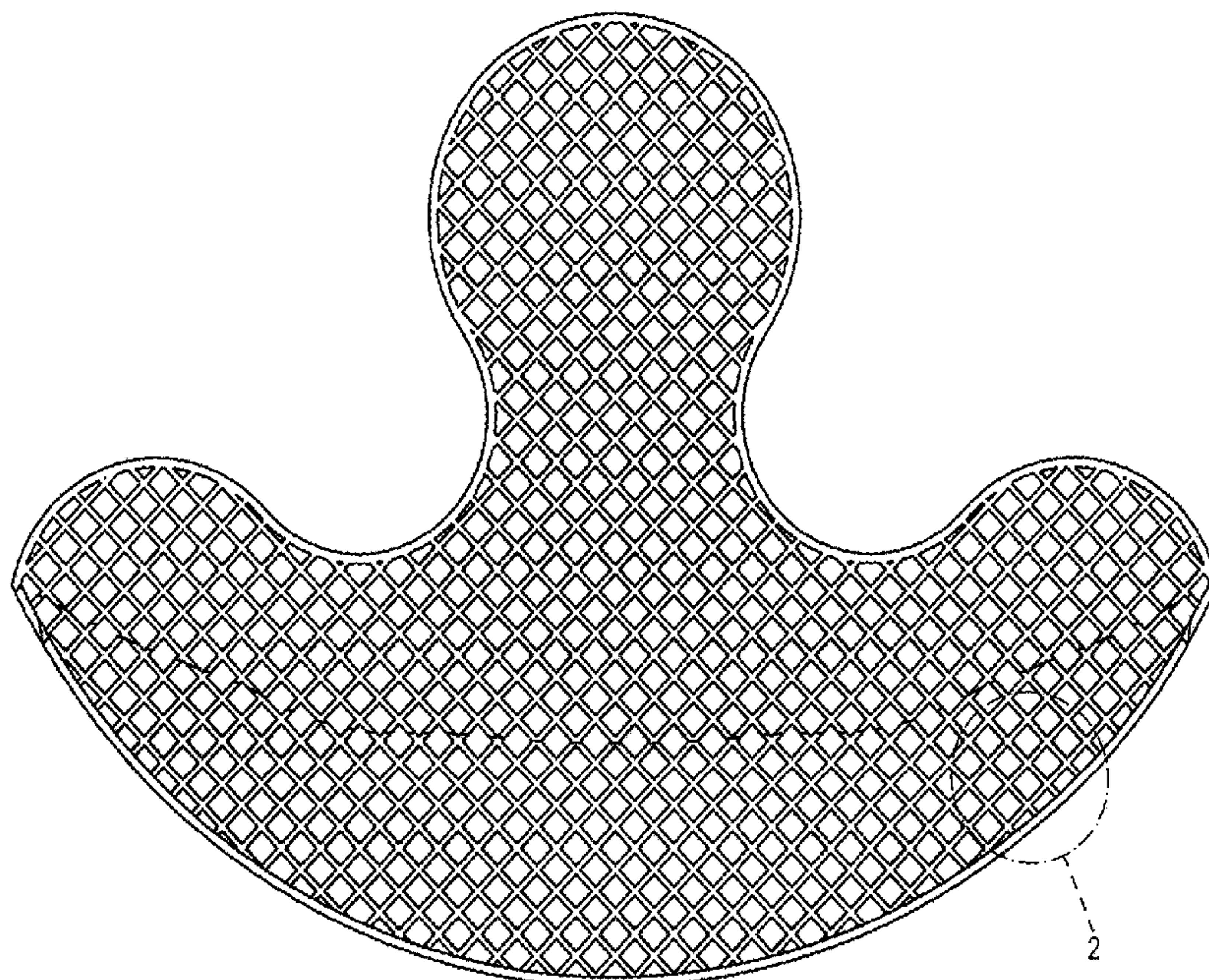
The ornamental design for an cup insert for wireless brassiere, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of a cup insert for wireless brassiere showing our design;

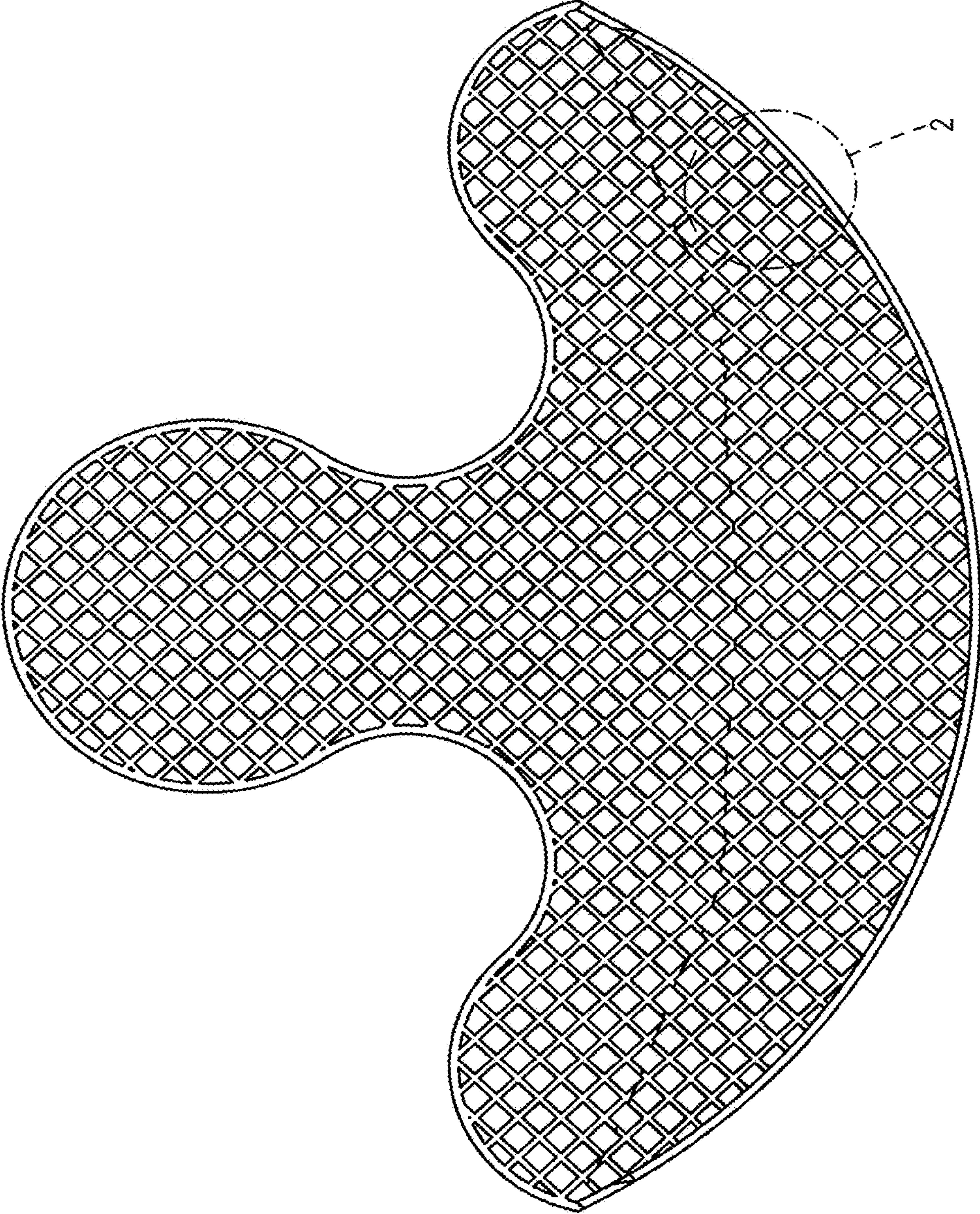

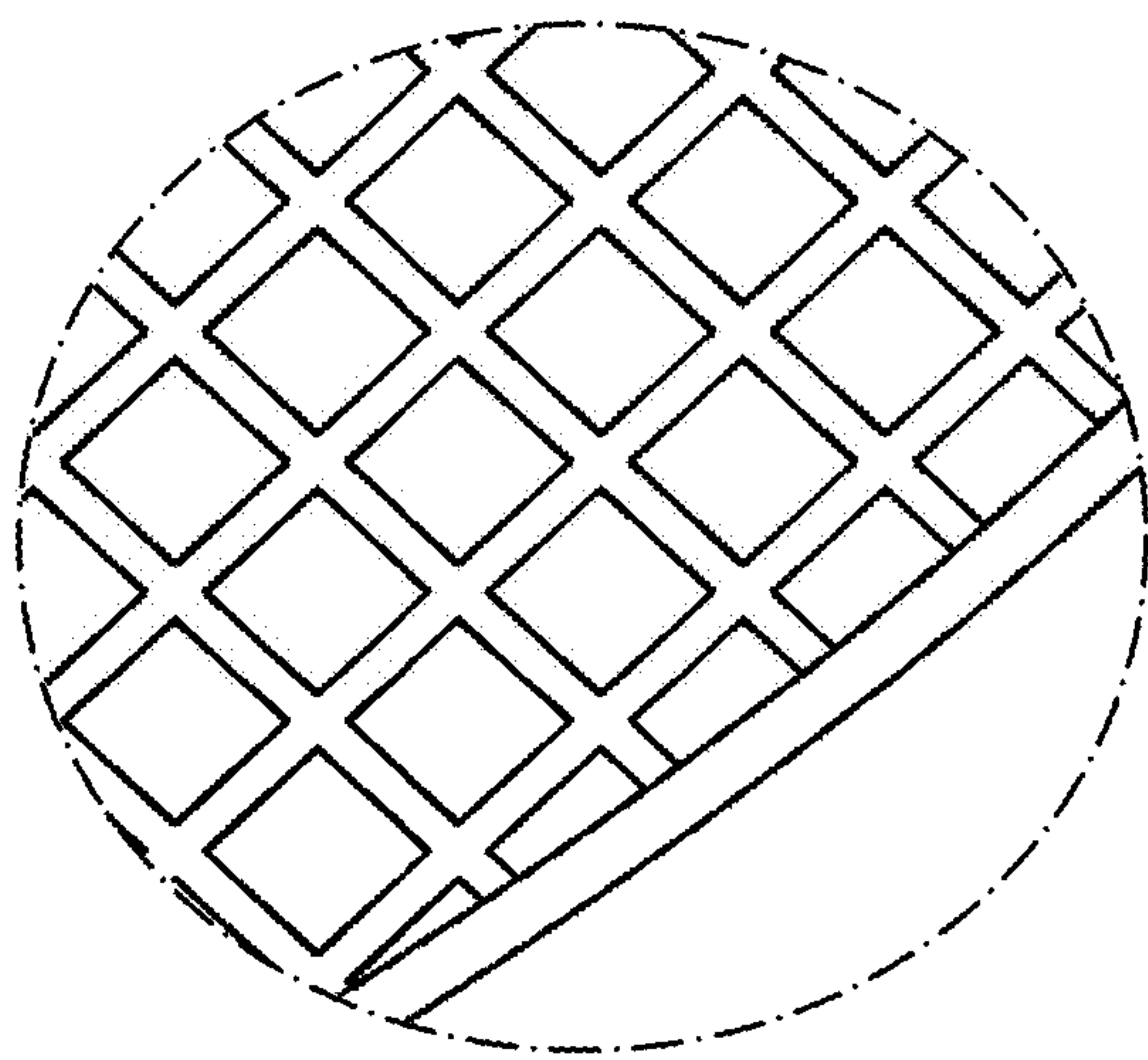
