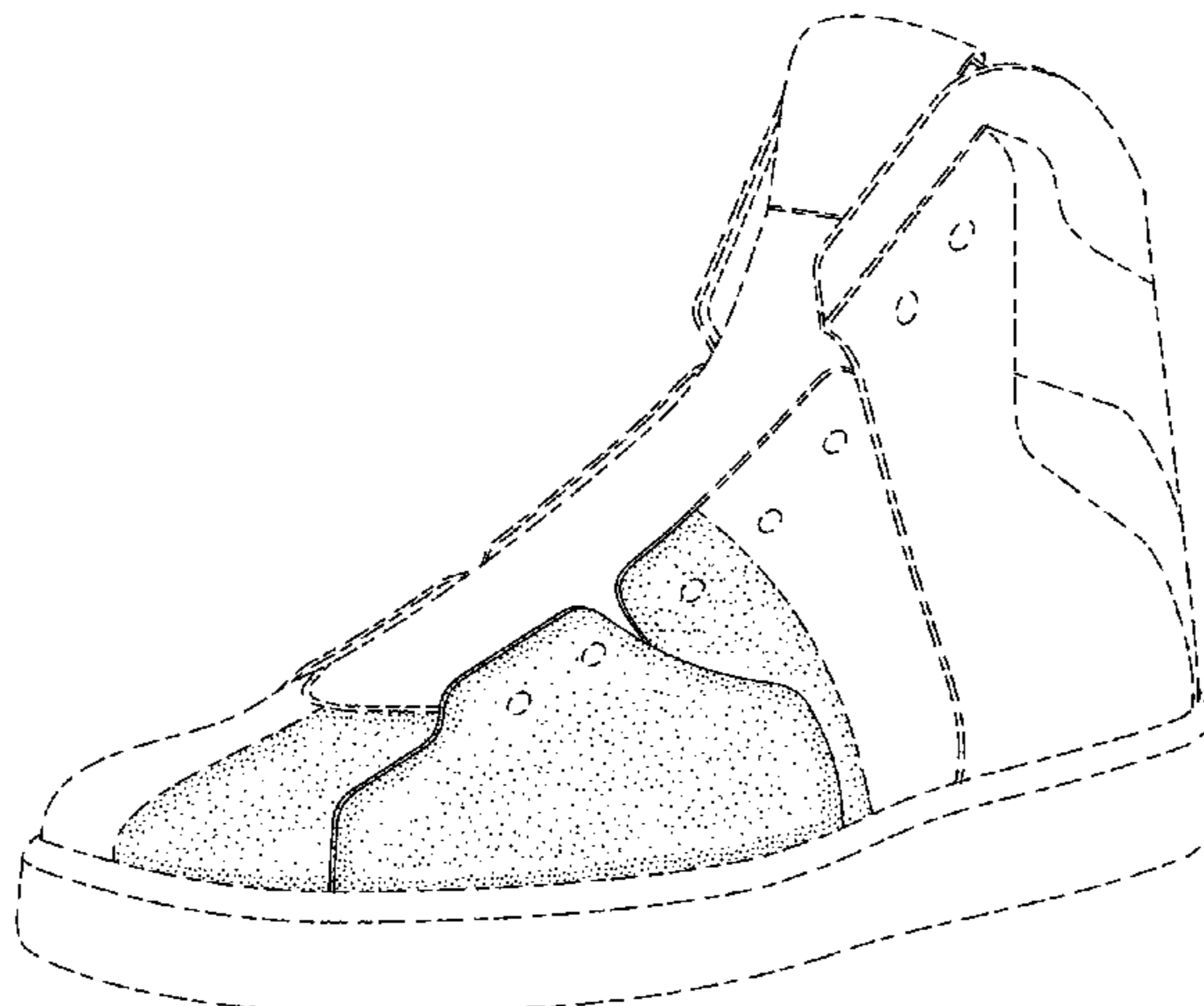
(57) **CLAIM**

The ornamental design for a shoe upper, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a shoe upper showing our new design;
FIG. 2 is a side view thereof;
FIG. 3 is a second side view thereof;
FIG. 4 is a front view thereof;
FIG. 5 is a rear view thereof;
FIG. 6 is a top view thereof; and,
FIG. 7 is a bottom view thereof.
The broken lines immediately adjacent to the shaded area represent unclaimed boundaries of the design. The three unshaded circular regions, demarcated by broken lines, within the shaded area represent unclaimed subject matter and form no part of the claimed design. The broken lines showing the remainder of the shoe represent unclaimed subject matter and form no part of the claimed design.

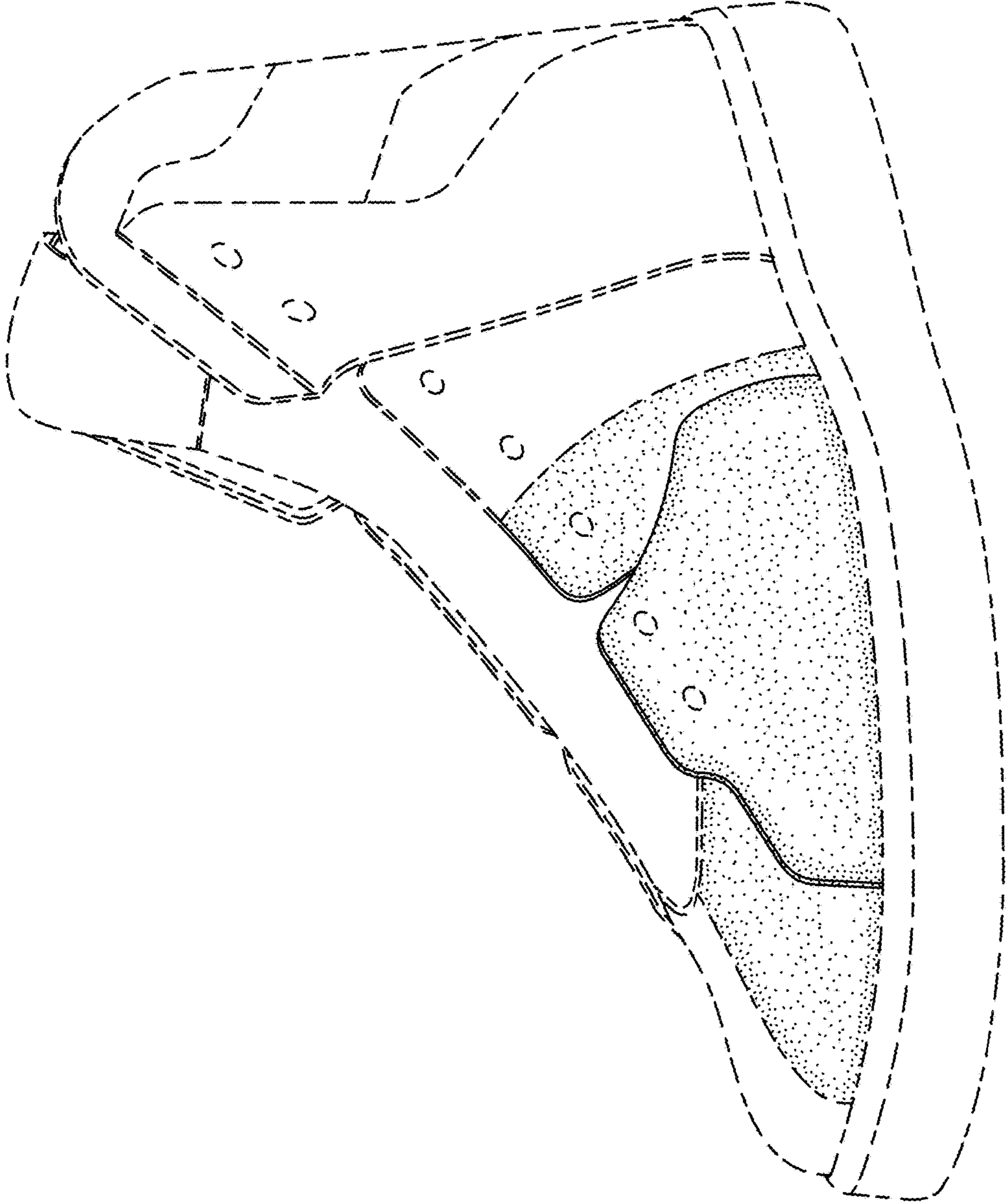

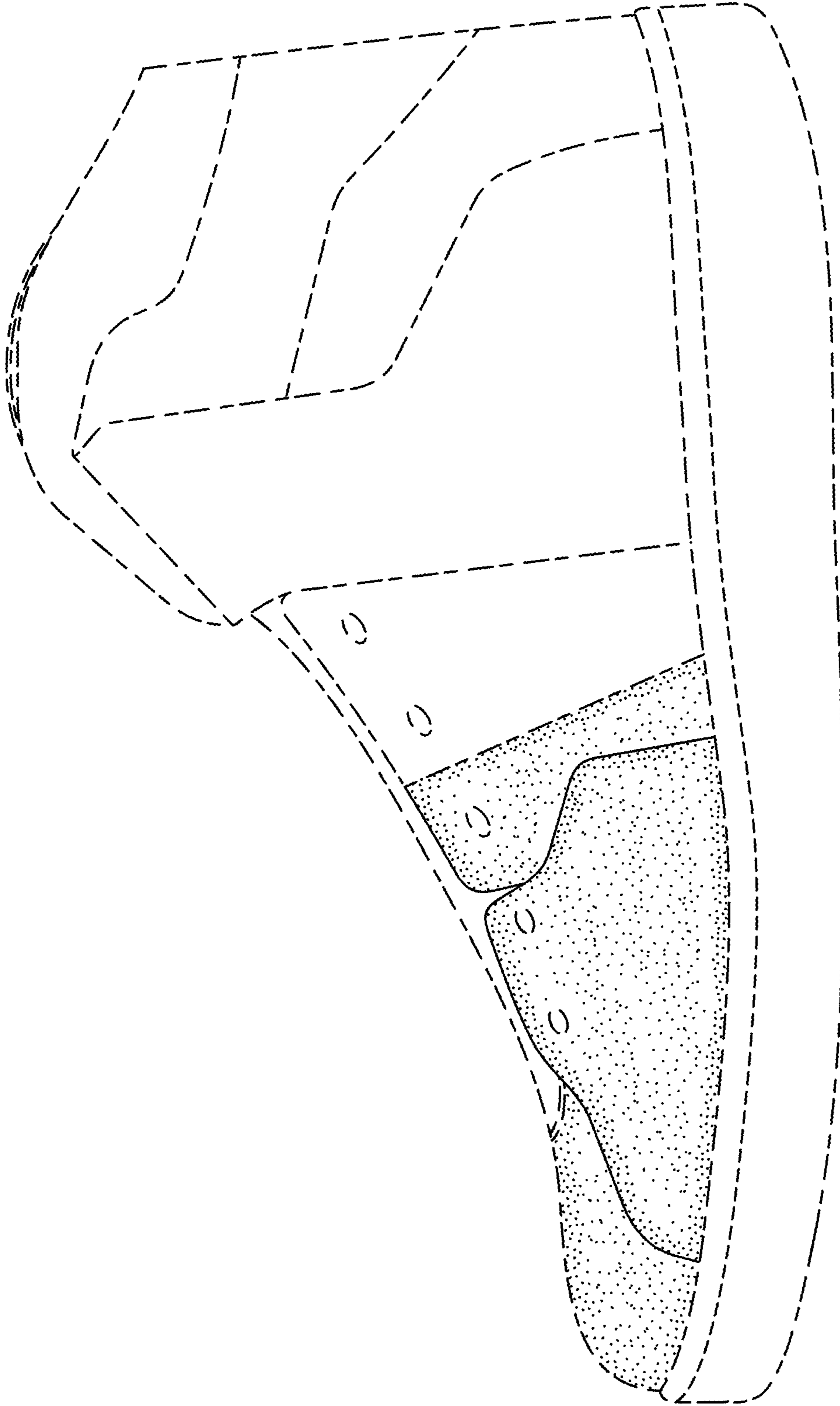

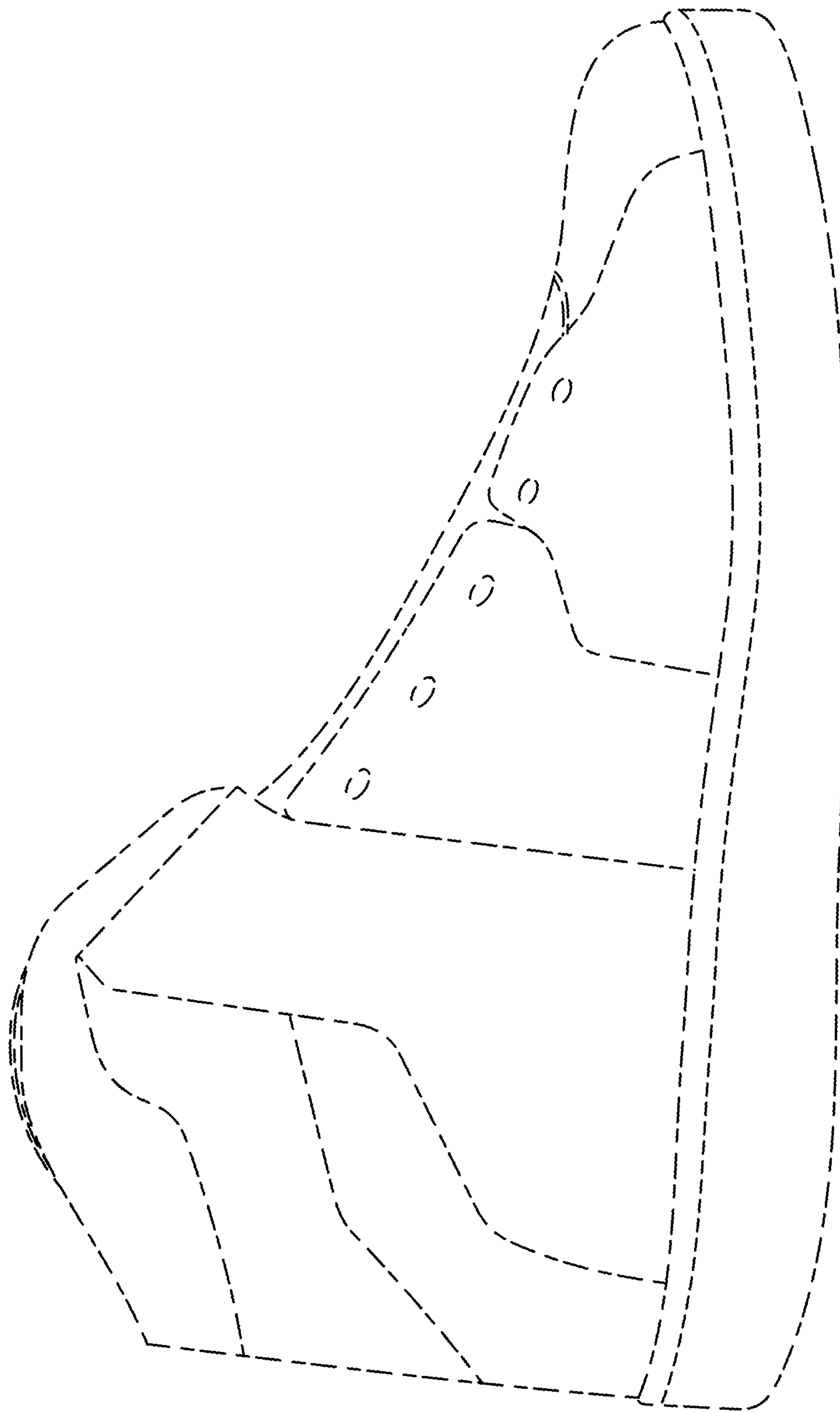

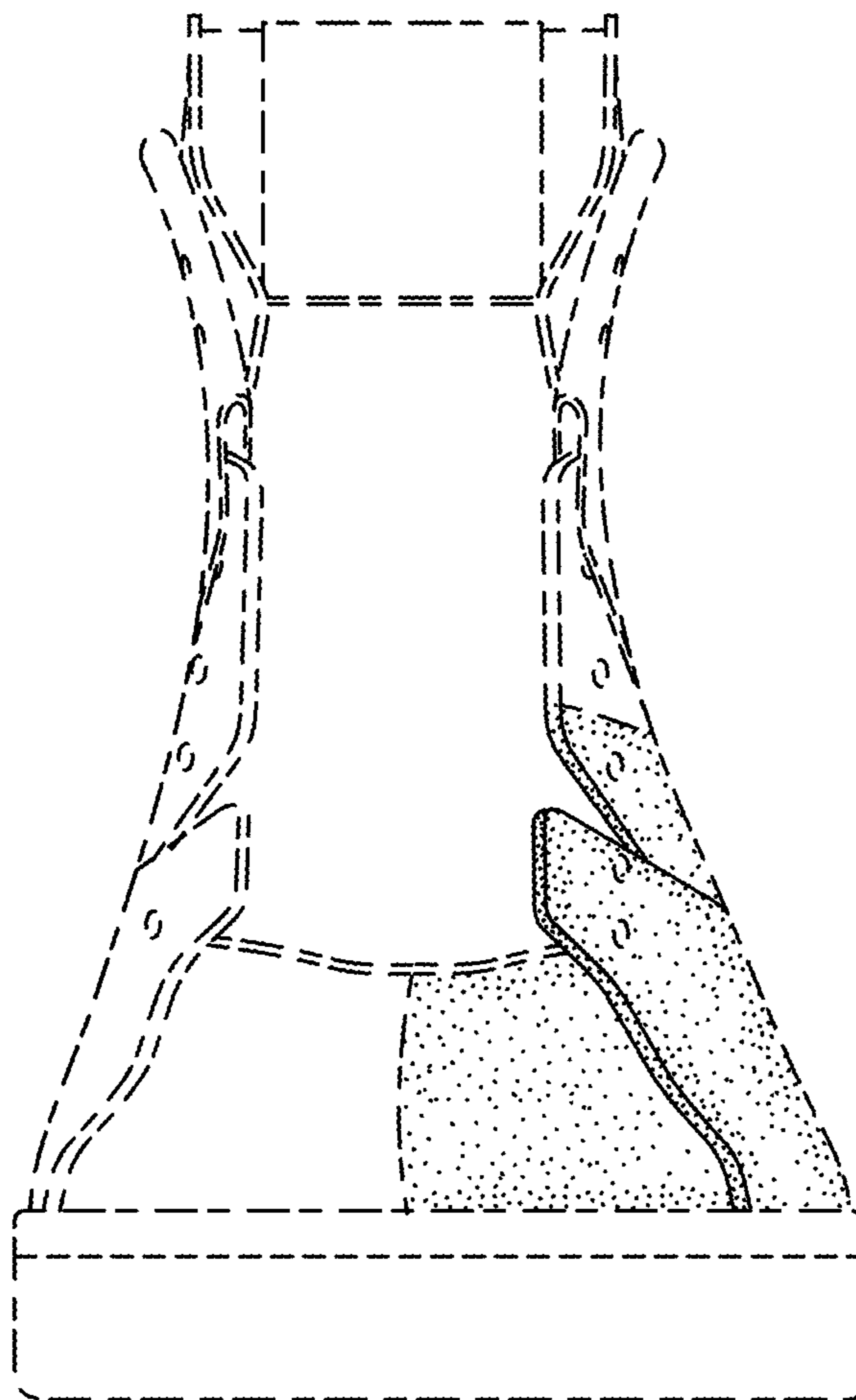

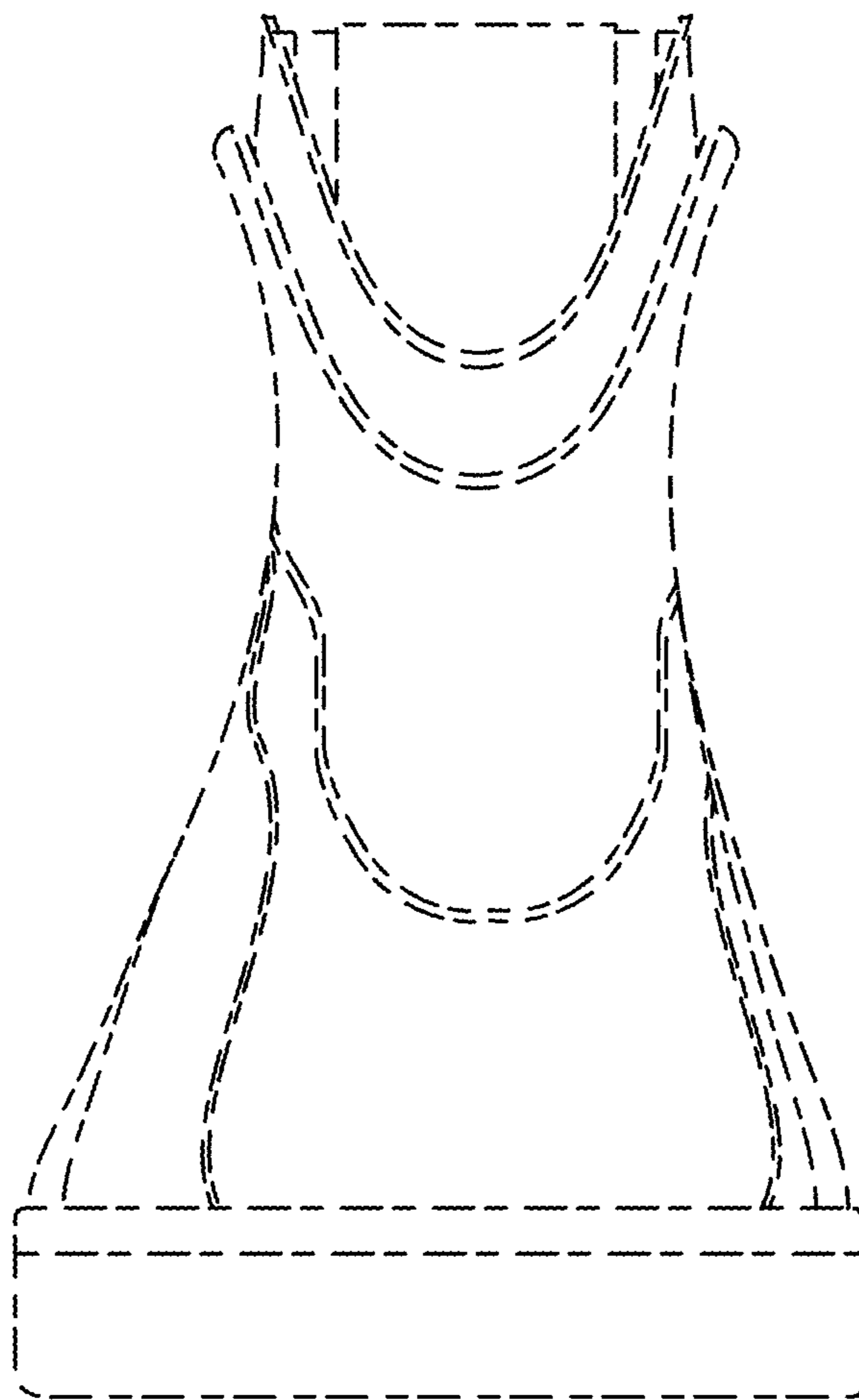

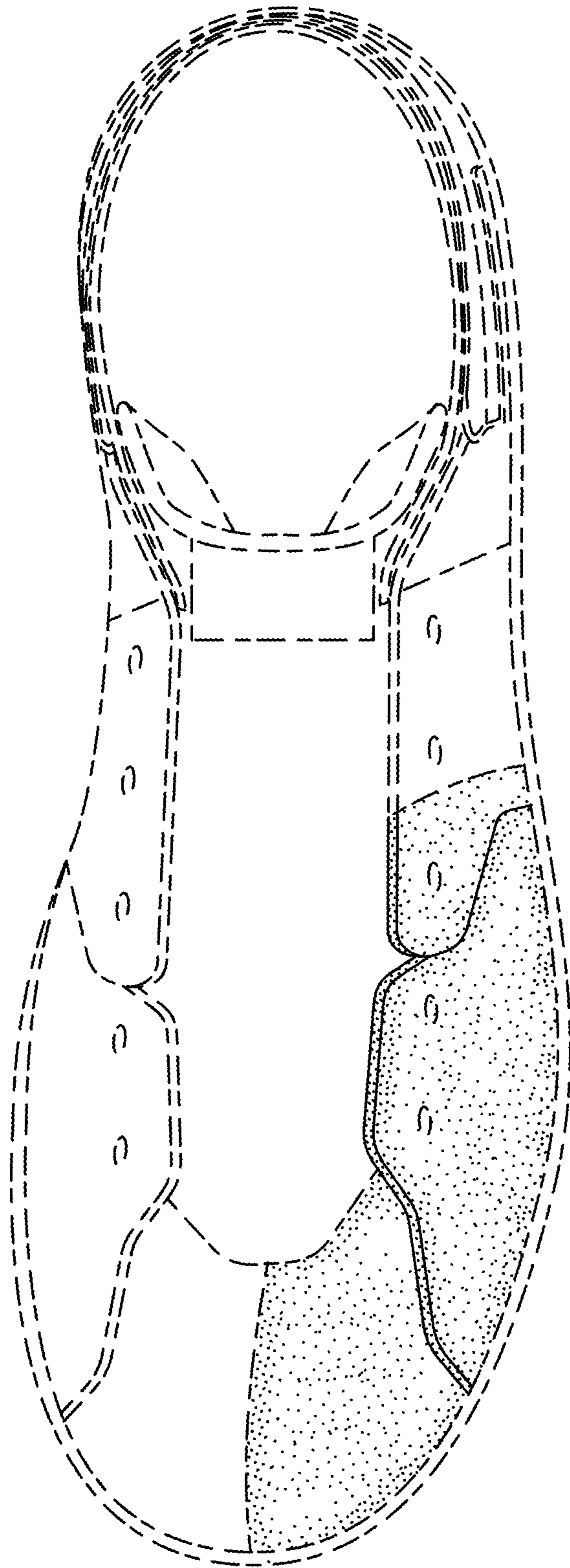

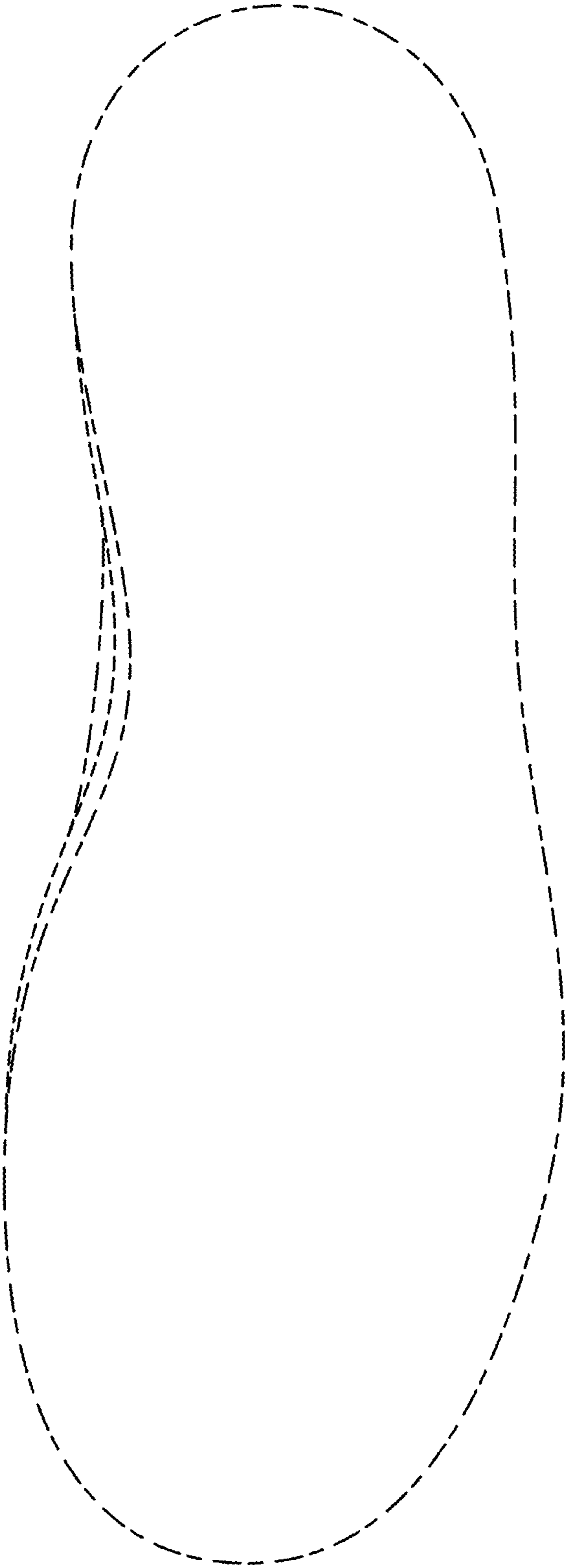
