FIG. 8 is a top view thereof, the broken lines illustrate portions of the tool box and form no part of the claimed design.

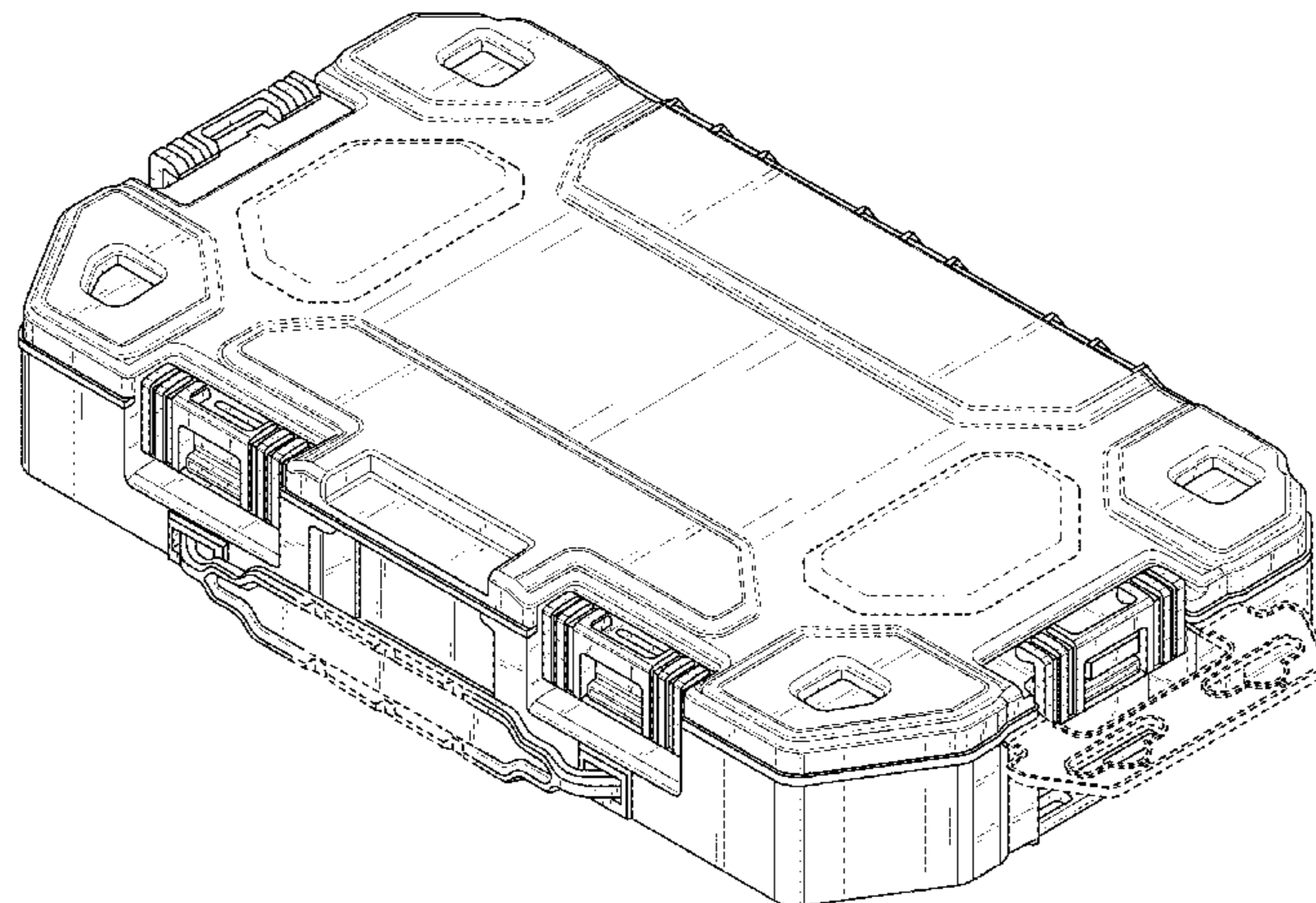
FIG. 9 is a front view thereof, the broken lines illustrate portions of the tool box and form no part of the claimed design.

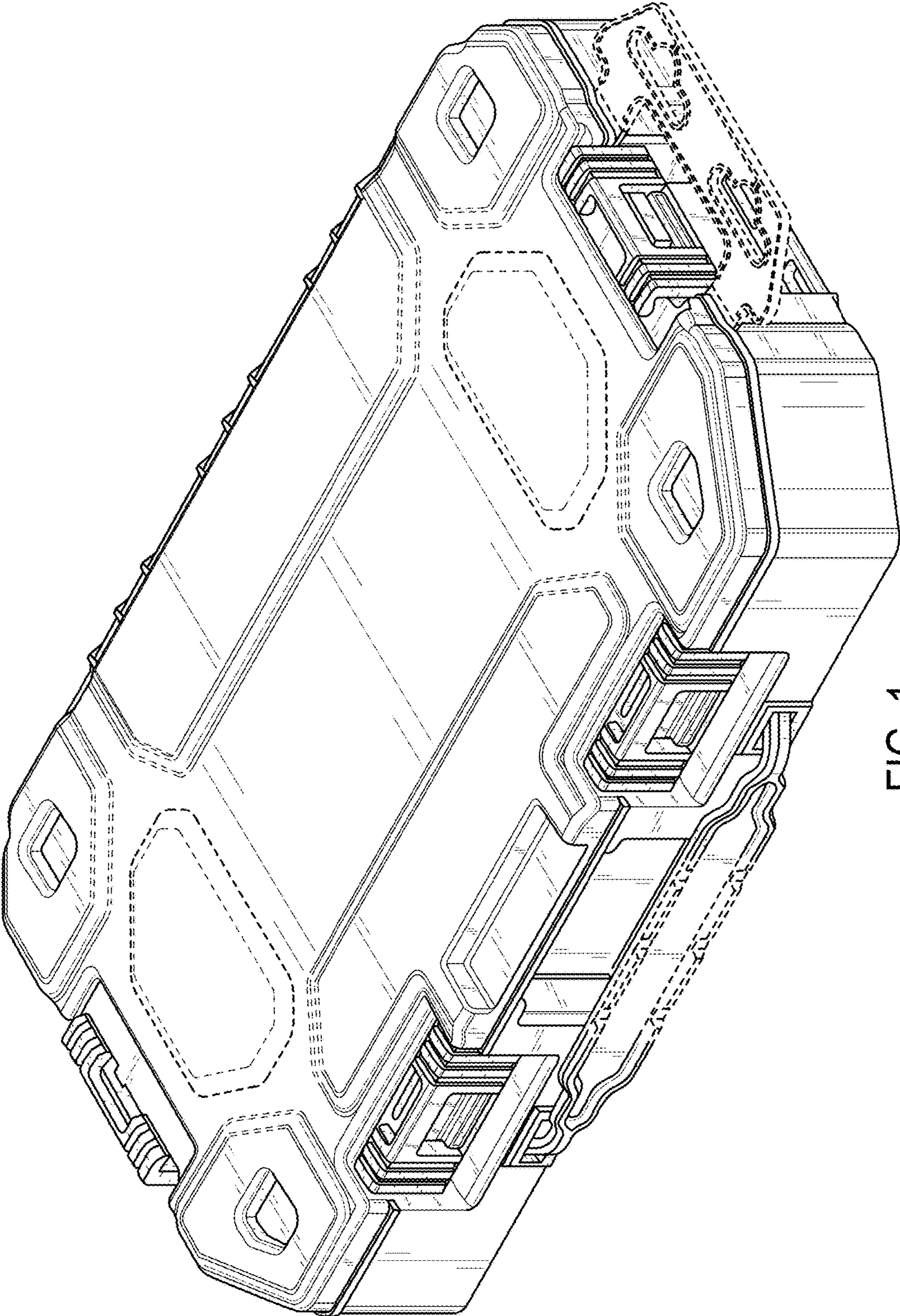

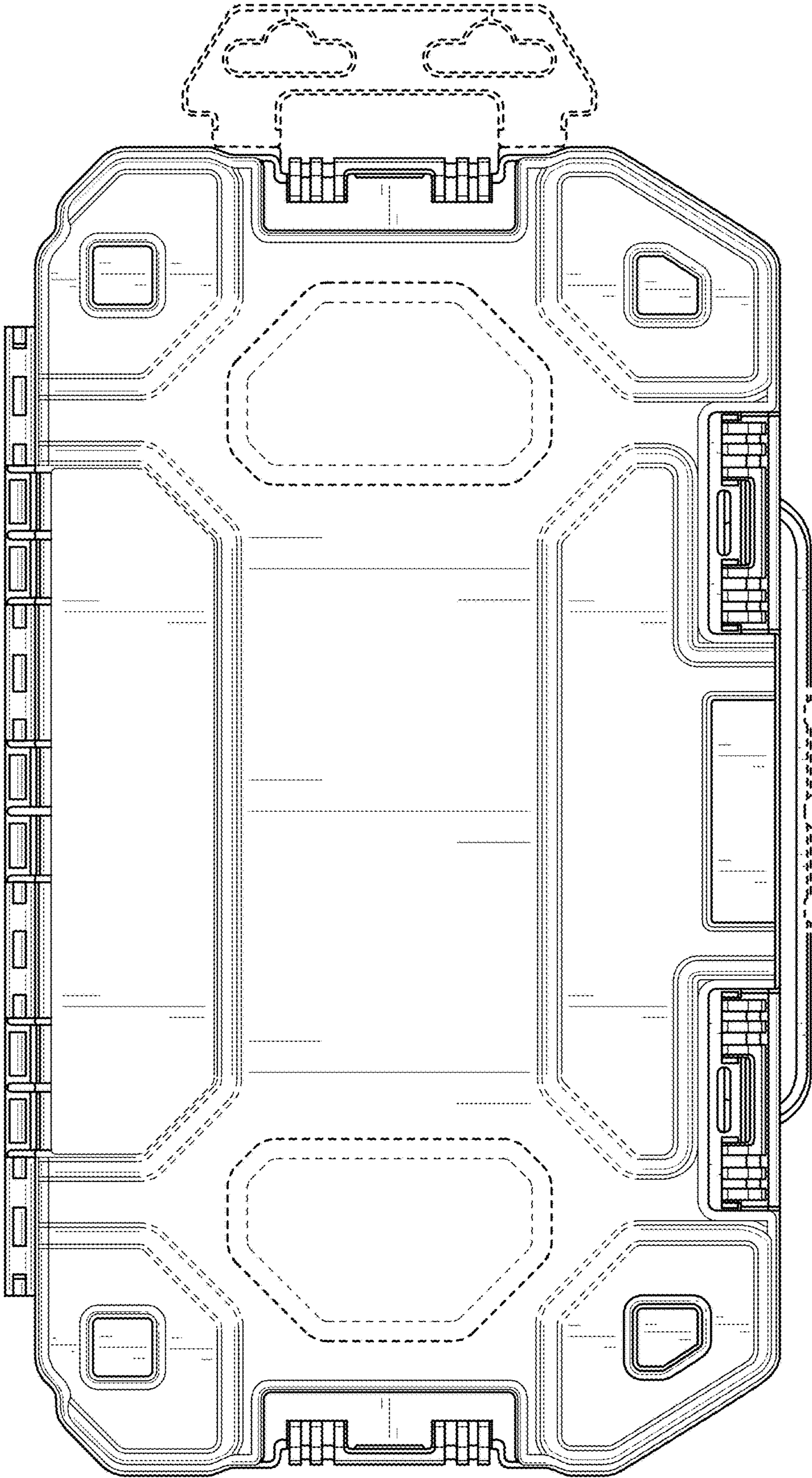

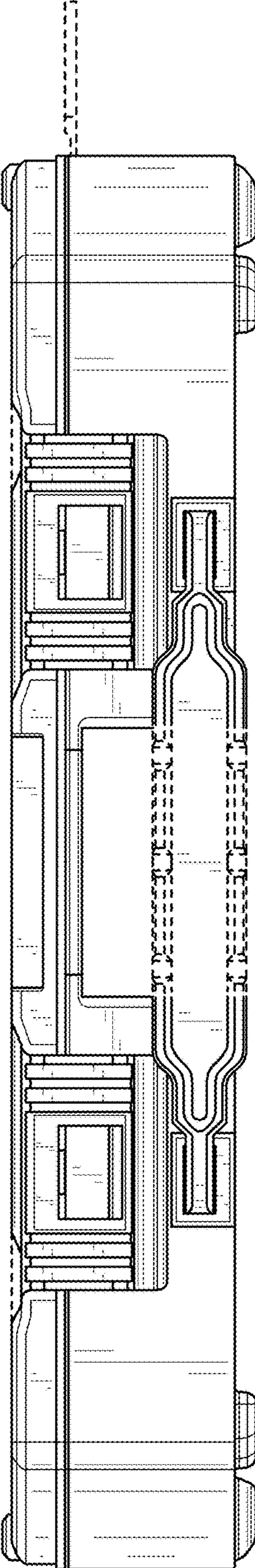

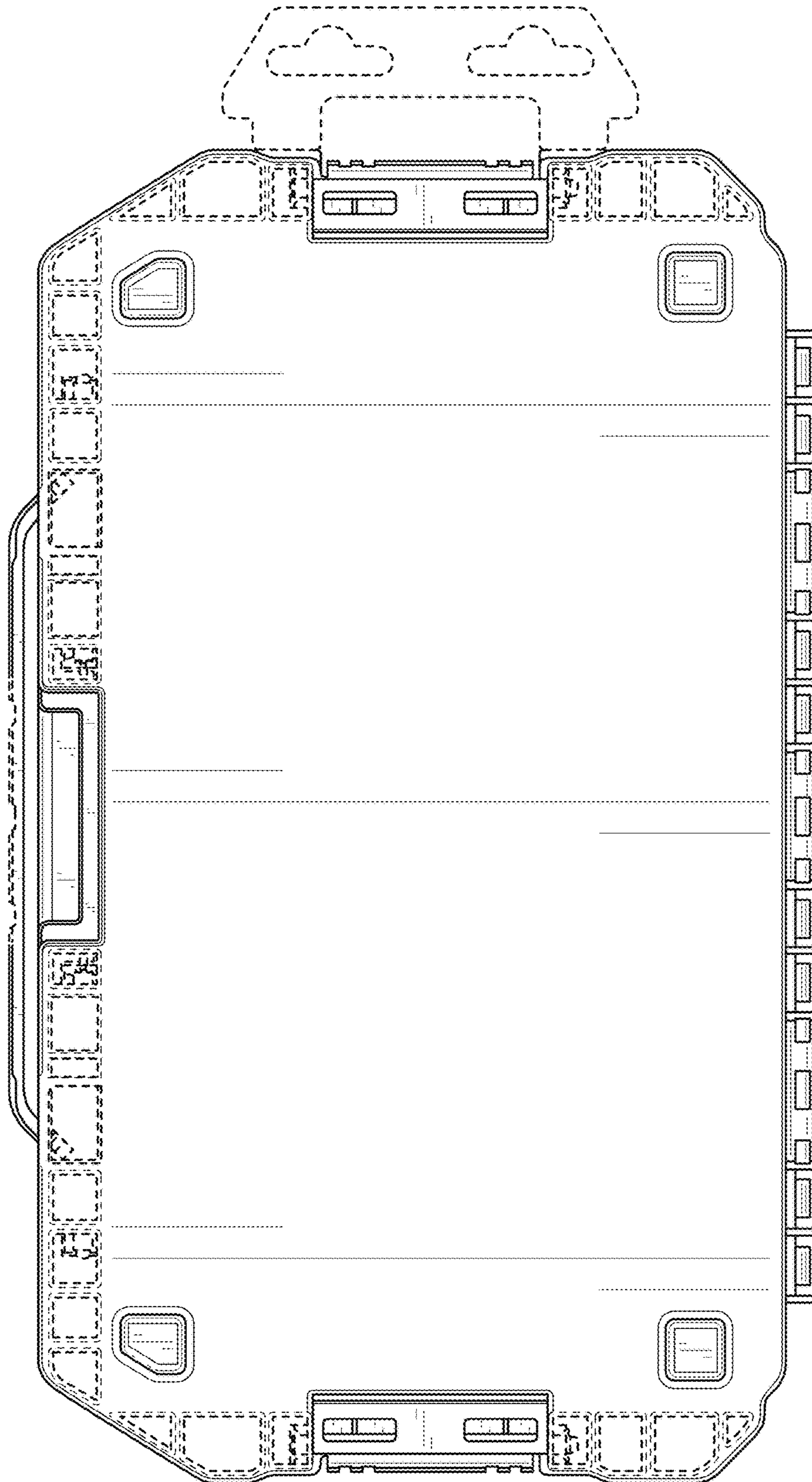

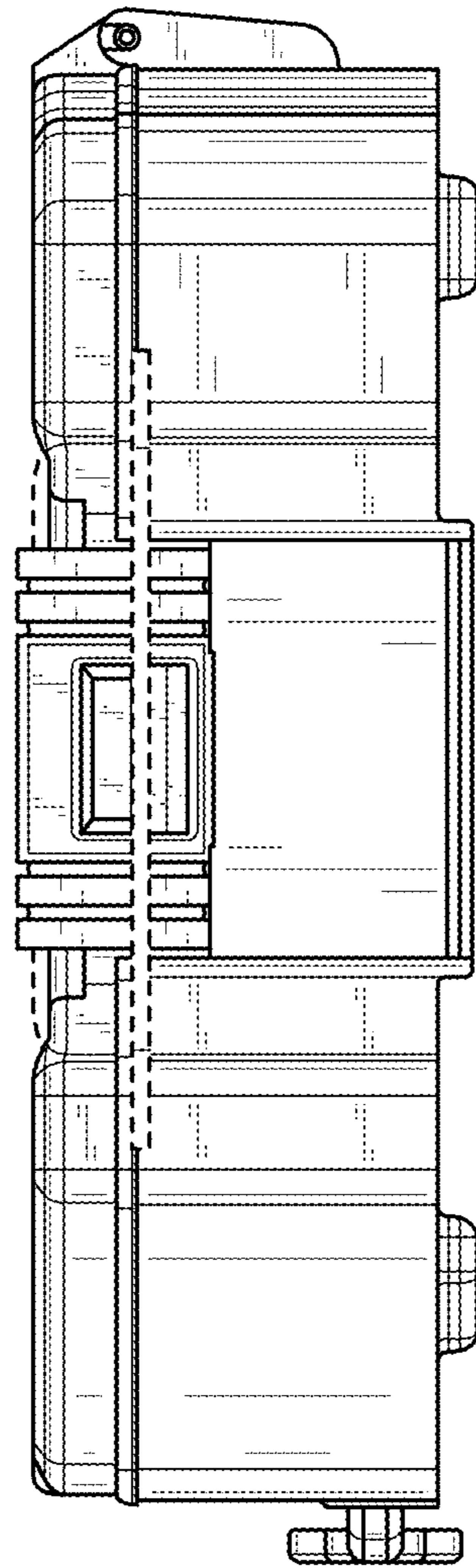

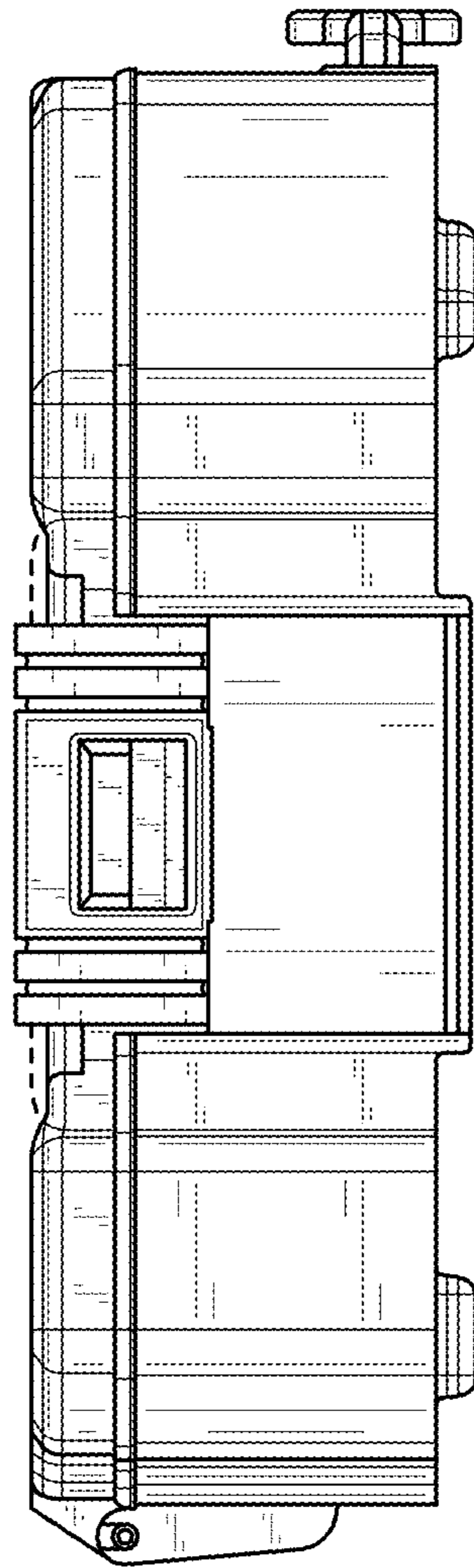

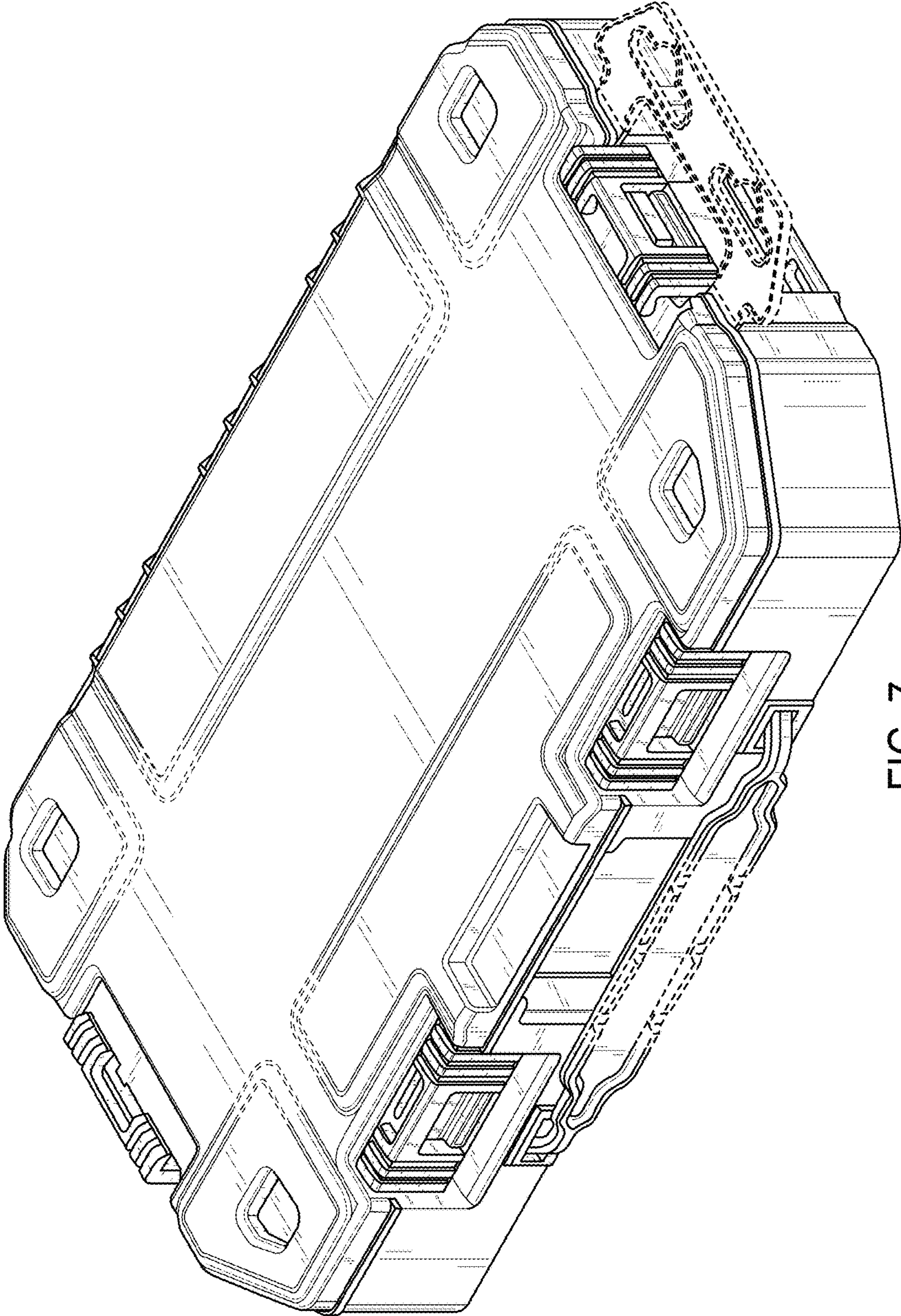

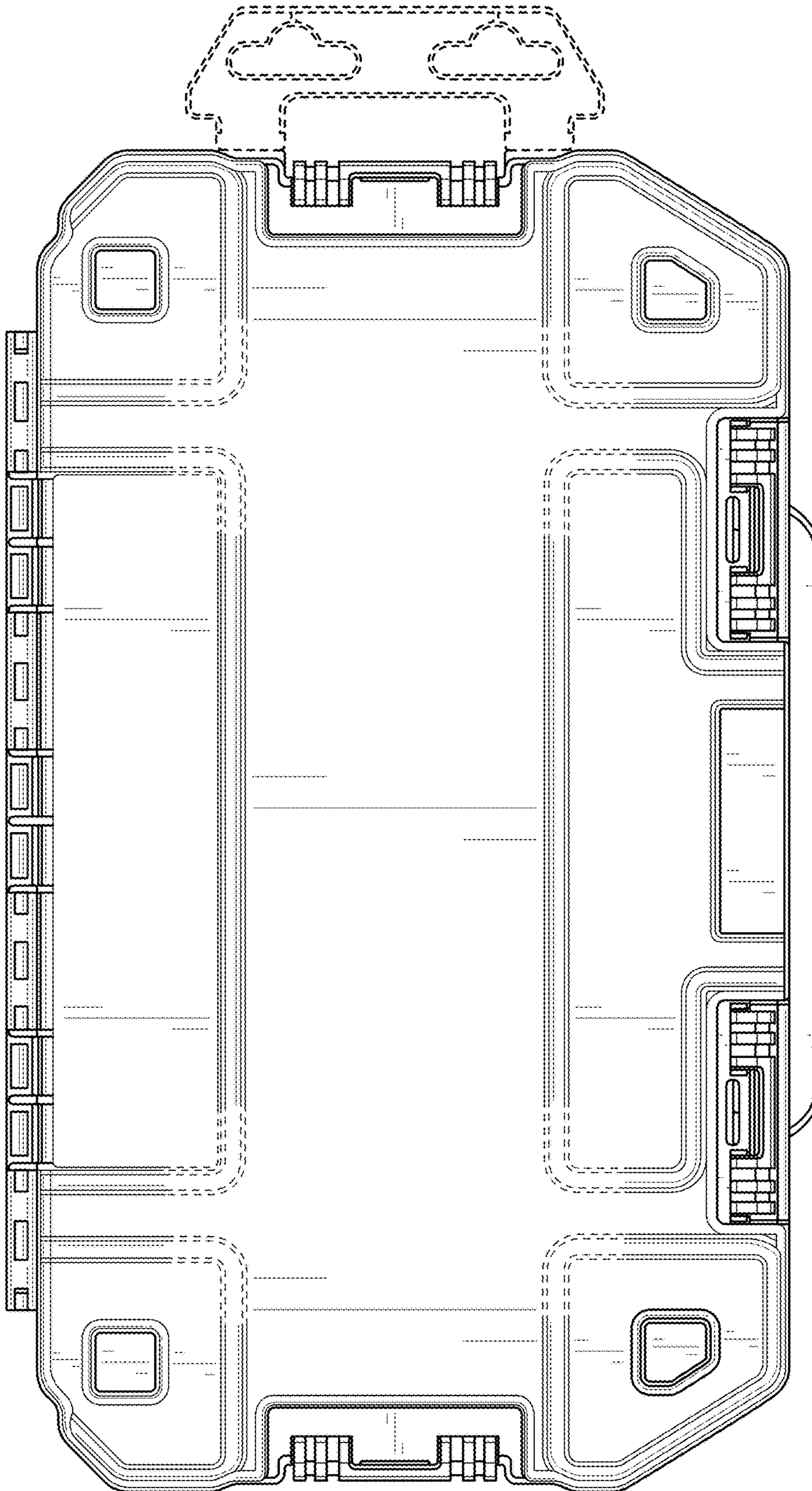

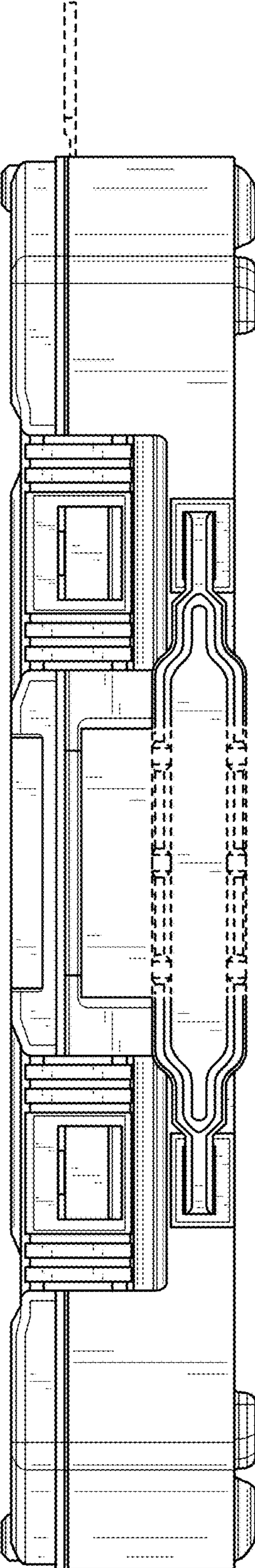

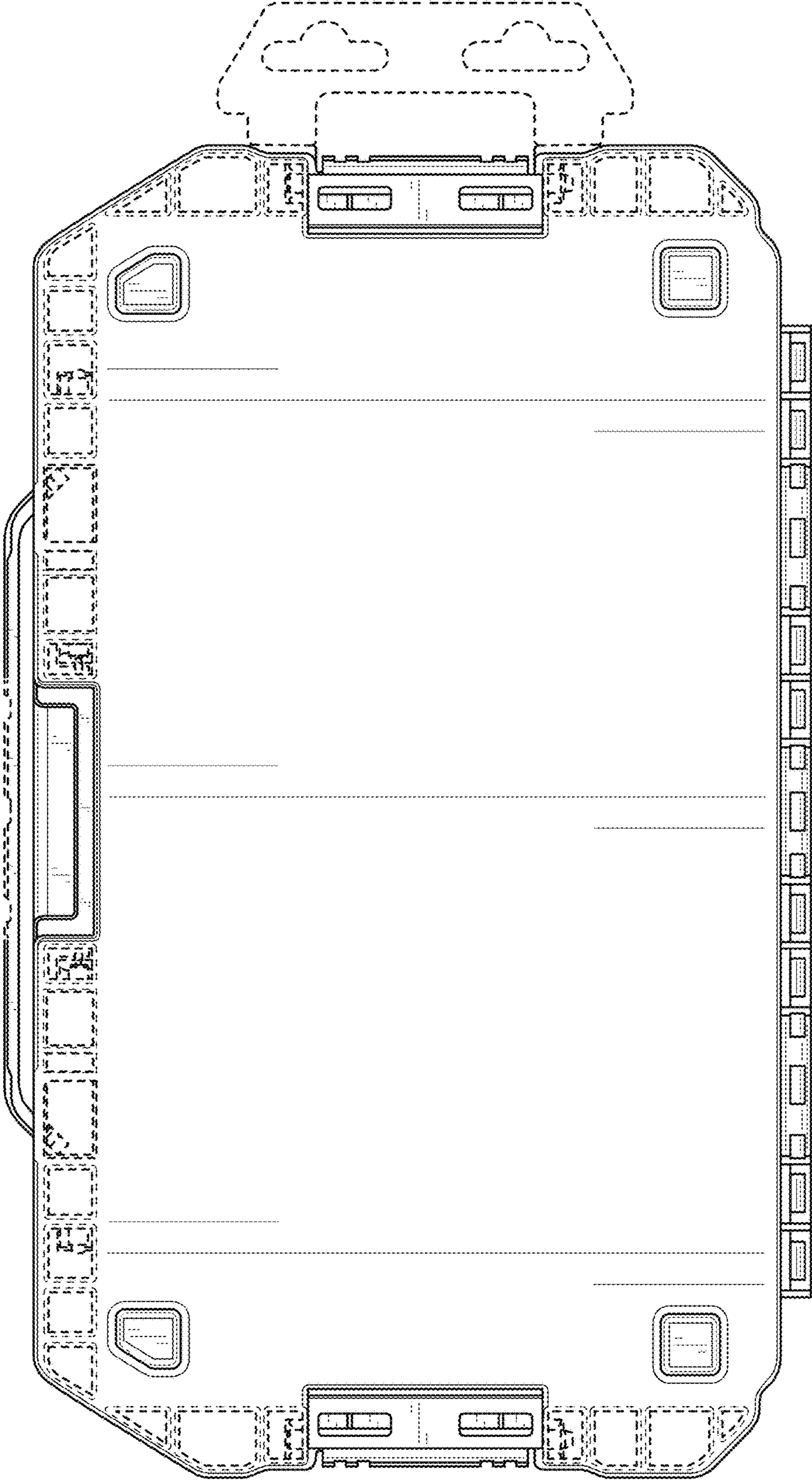

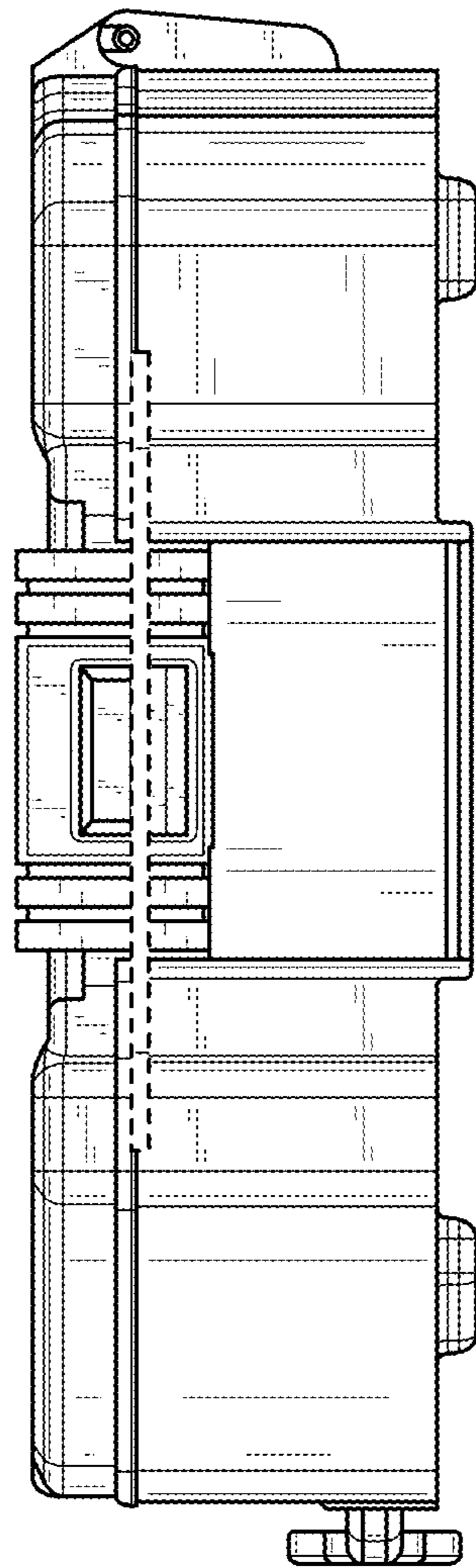

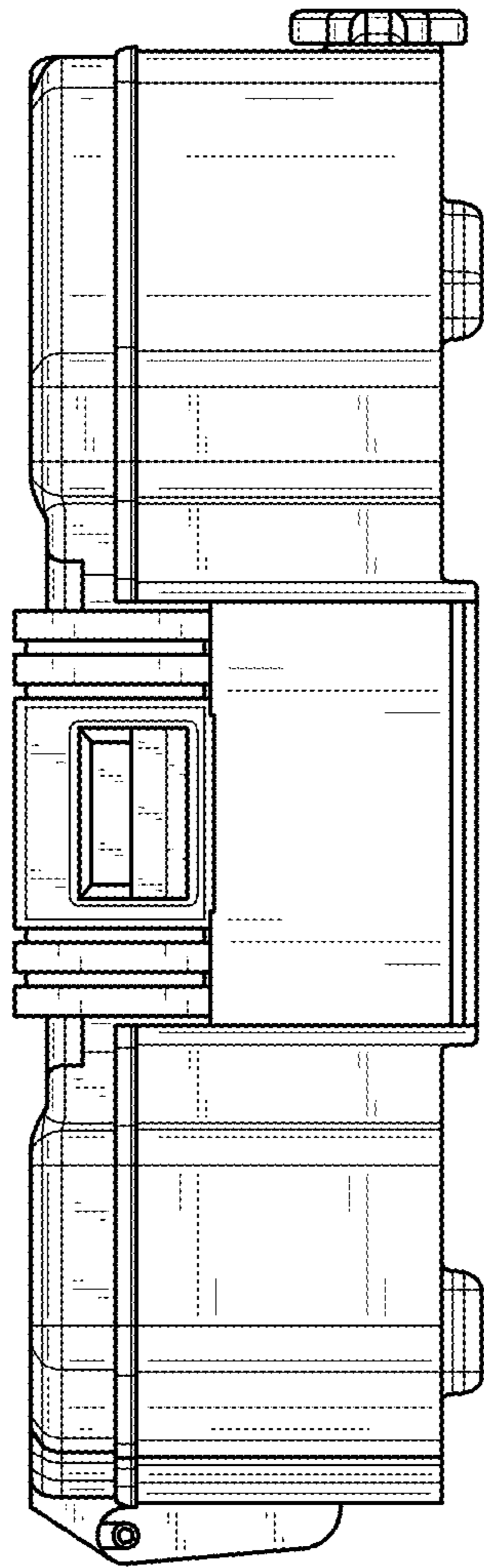
