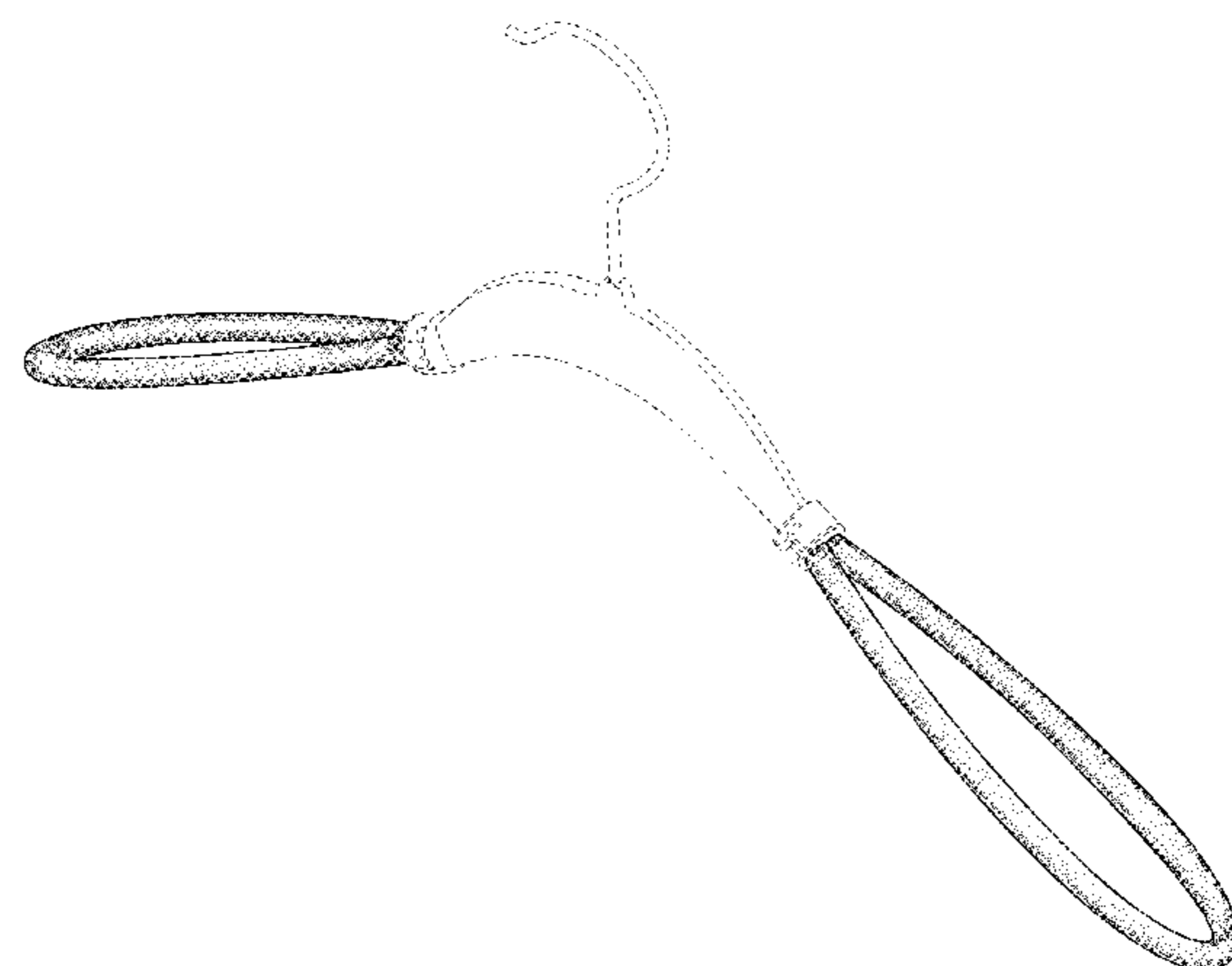
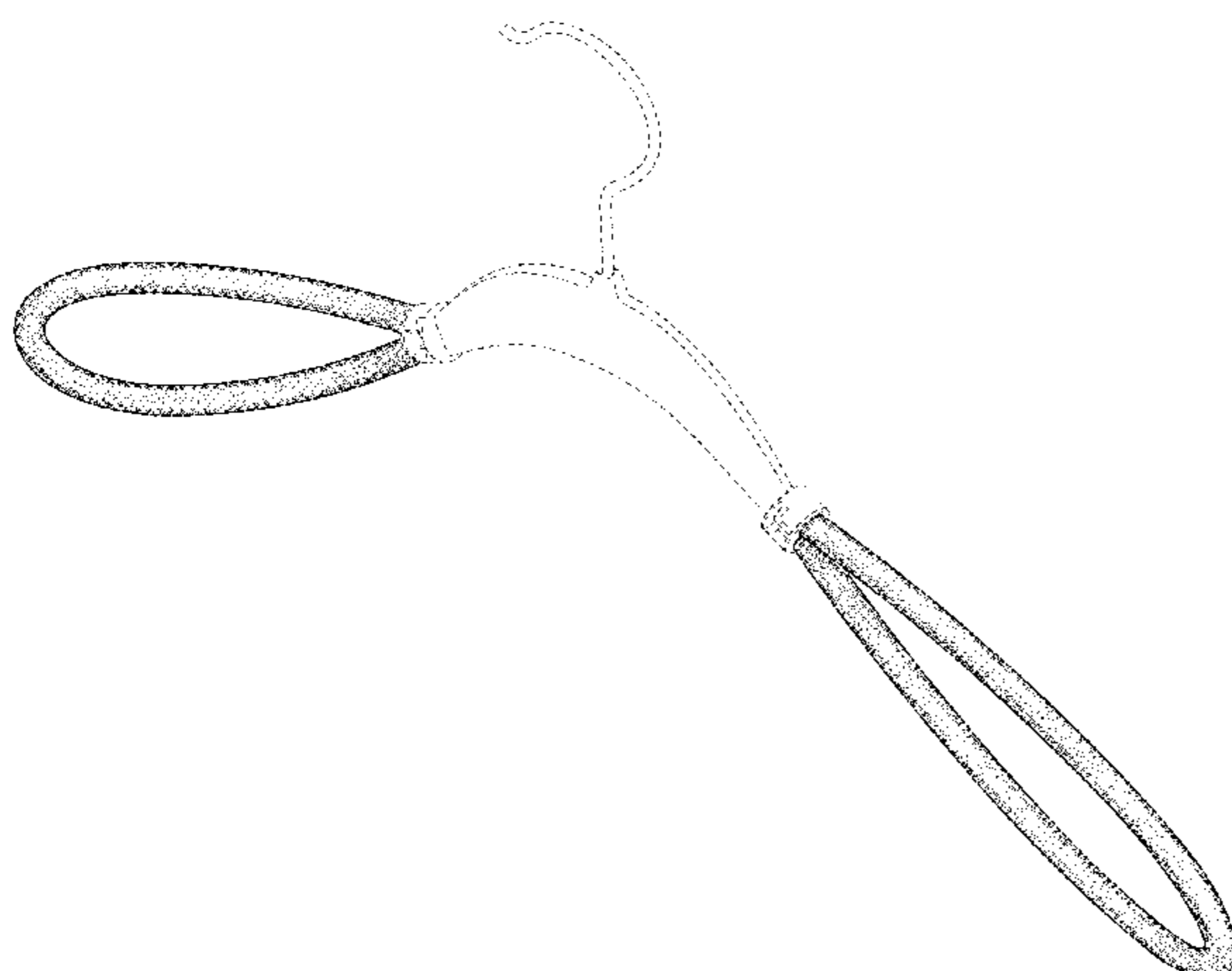
(57) **CLAIM**

The ornamental design for a garment hanger, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a first embodiment of a garment hanger showing my new design; FIG. 2 is a side view thereof; FIG. 3 is a second side view thereof; FIG. 4 is a top view thereof; FIG. 5 is a bottom view thereof; FIG. 6 is an end view thereof; FIG. 7 is a second end view thereof; FIG. 8 is a perspective view of the garment hanger showing each of the shoulder portions in an alternative orientation; FIG. 9 is a side view thereof; FIG. 10 is a second side view thereof; FIG. 11 is a top view thereof; FIG. 12 is a bottom view thereof; FIG. 13 is an end view thereof; and, FIG. 14 is a second end view thereof. The broken lines in the Figures are for the purpose of illustrating unclaimed portions of the garment hanger and form no part of the claimed design. The stippling in the Figures is provided to show contour and not surface ornamentation.

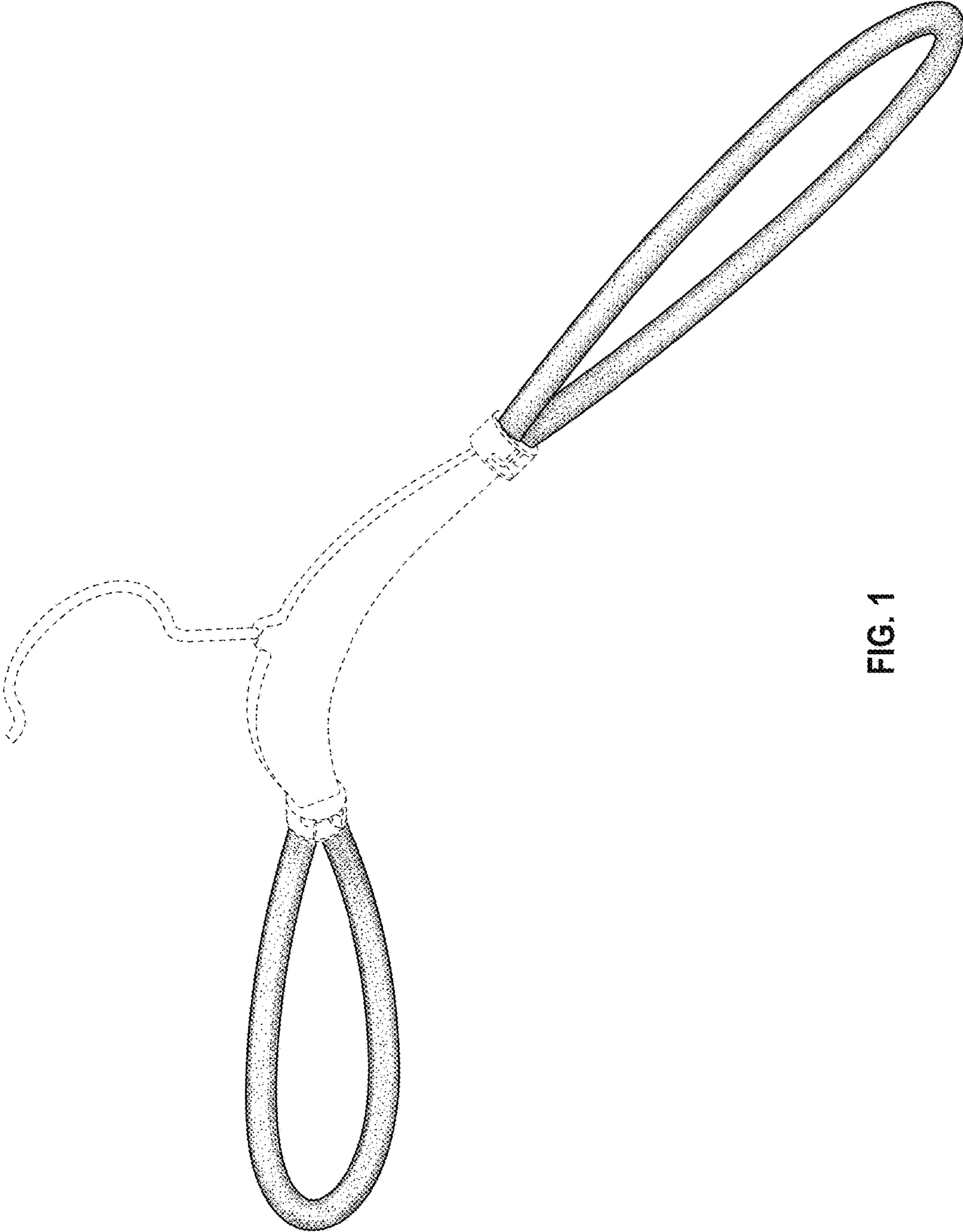

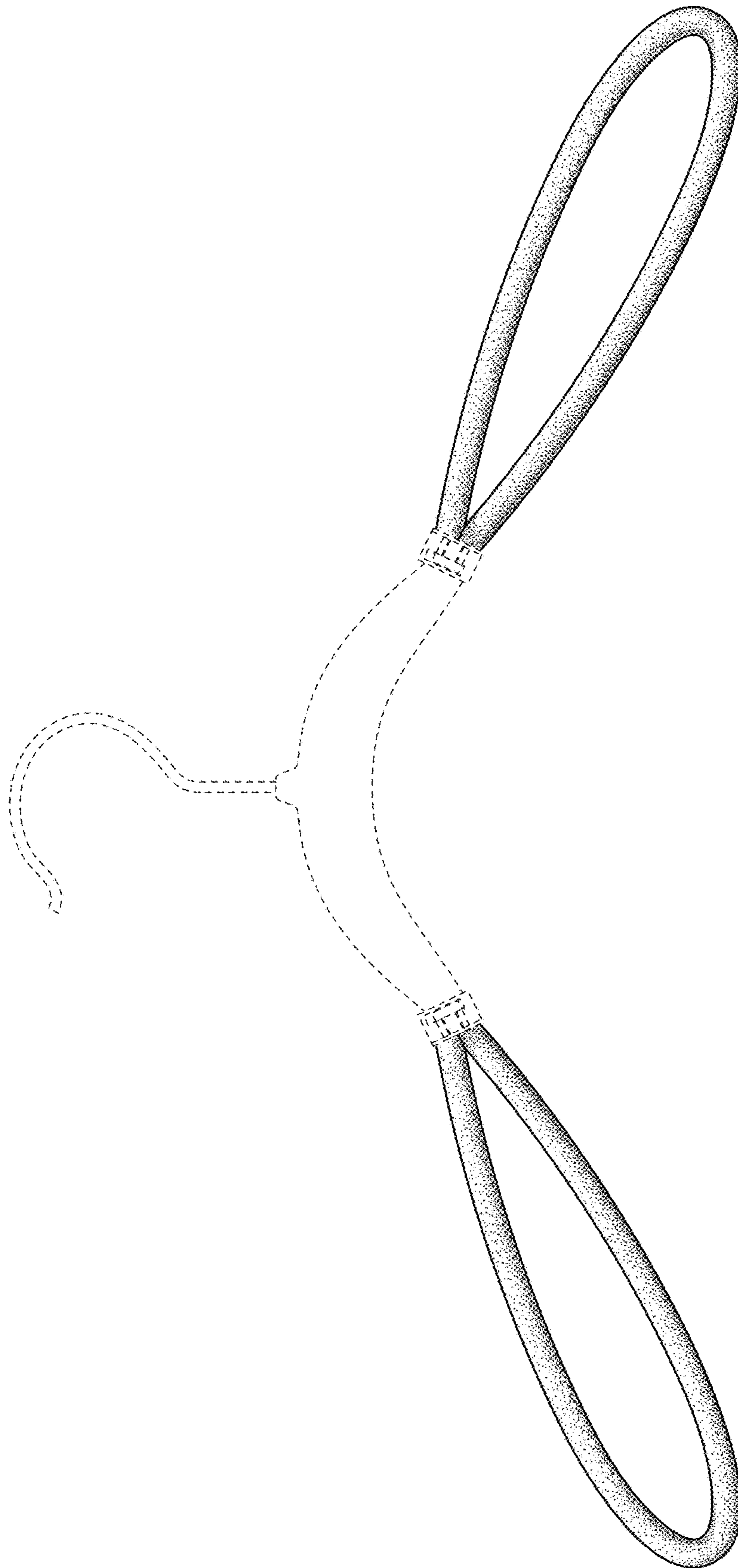

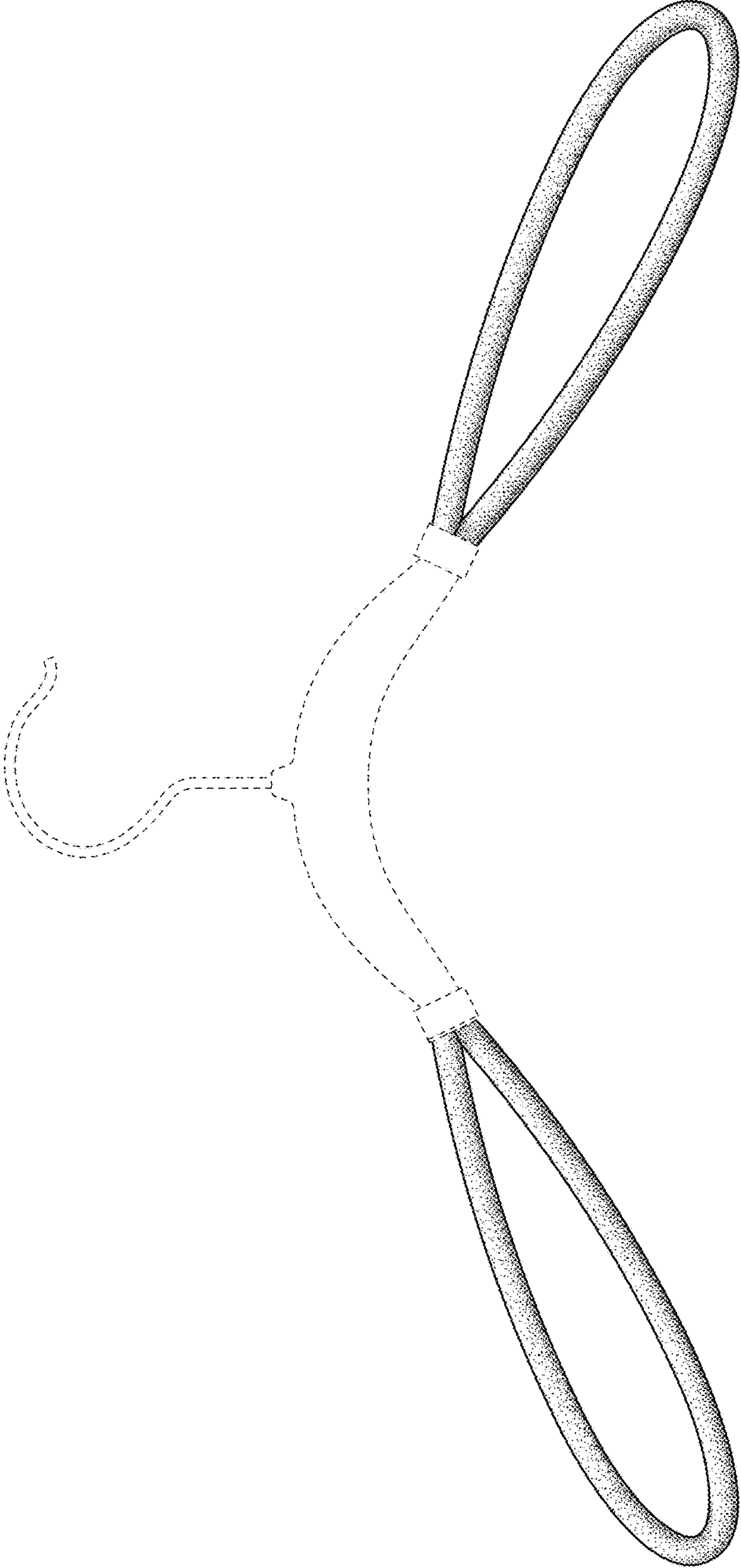

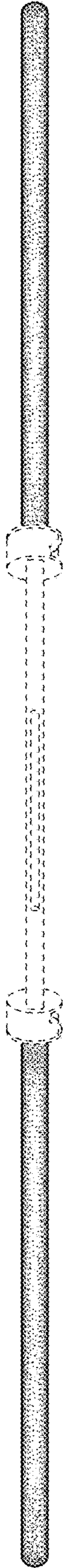

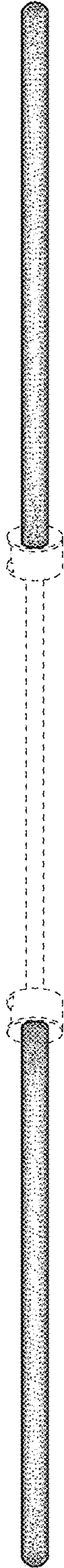

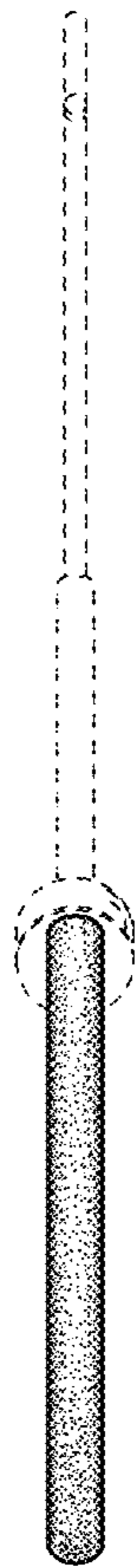

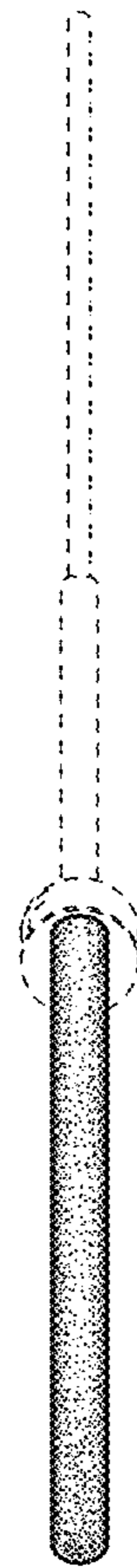

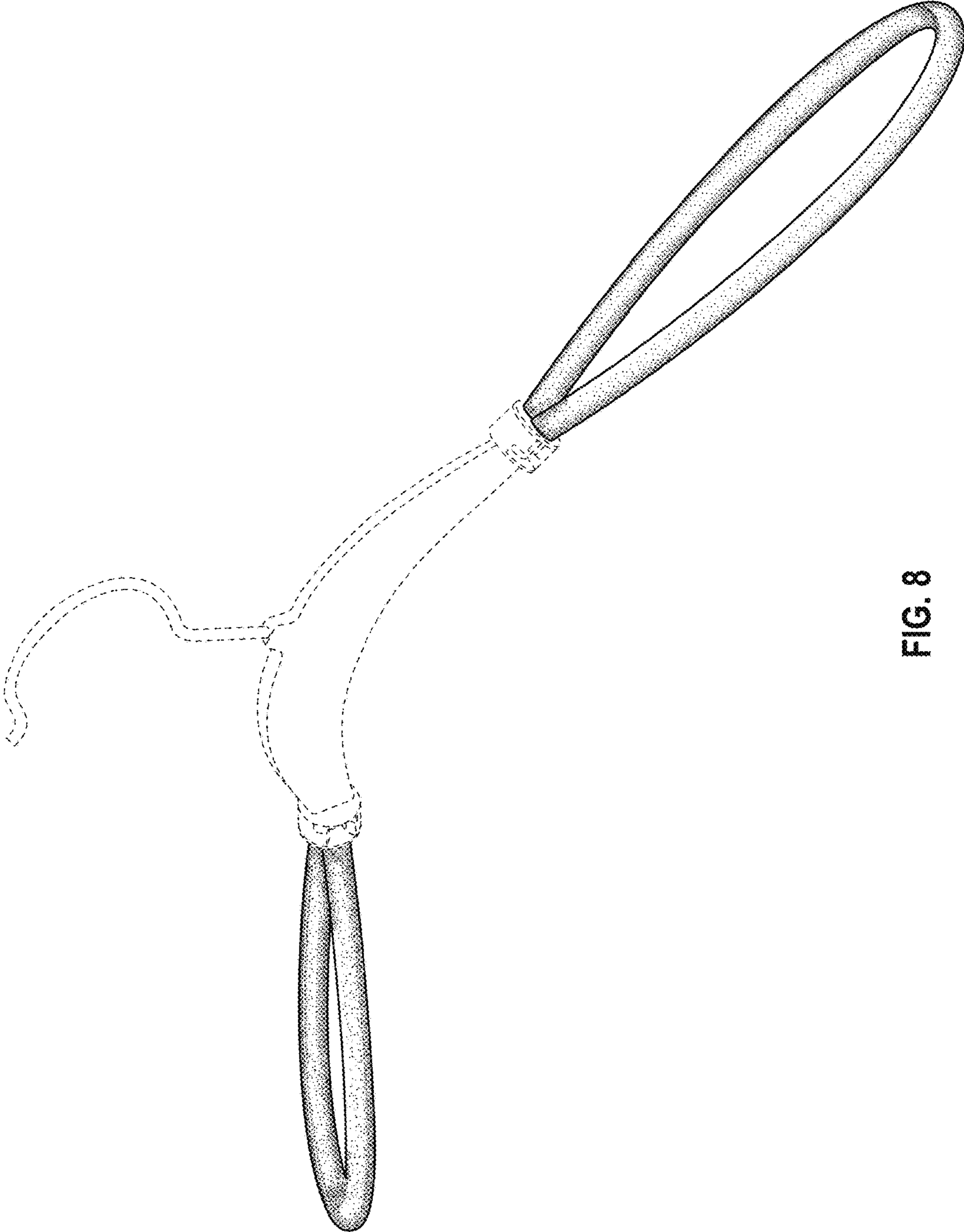

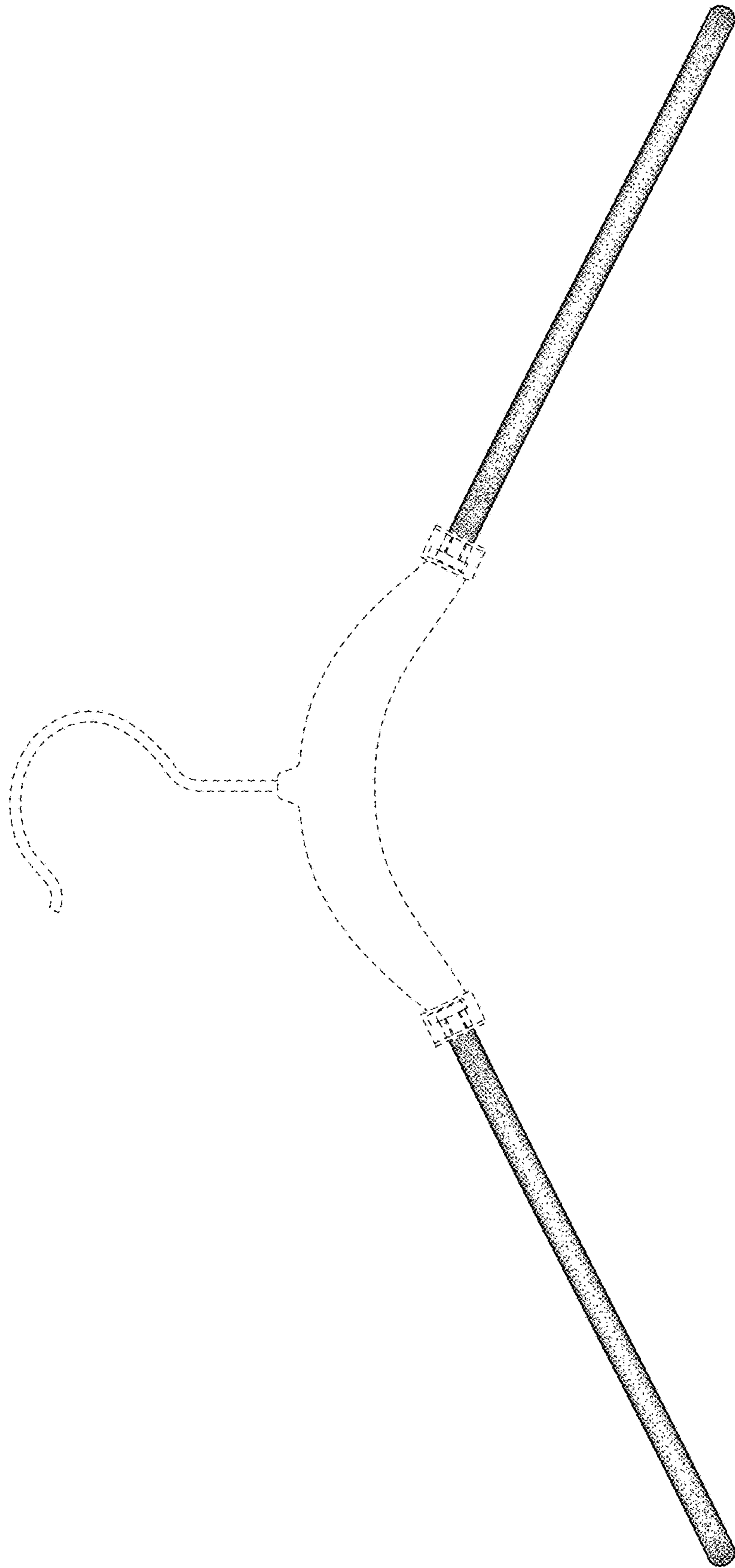

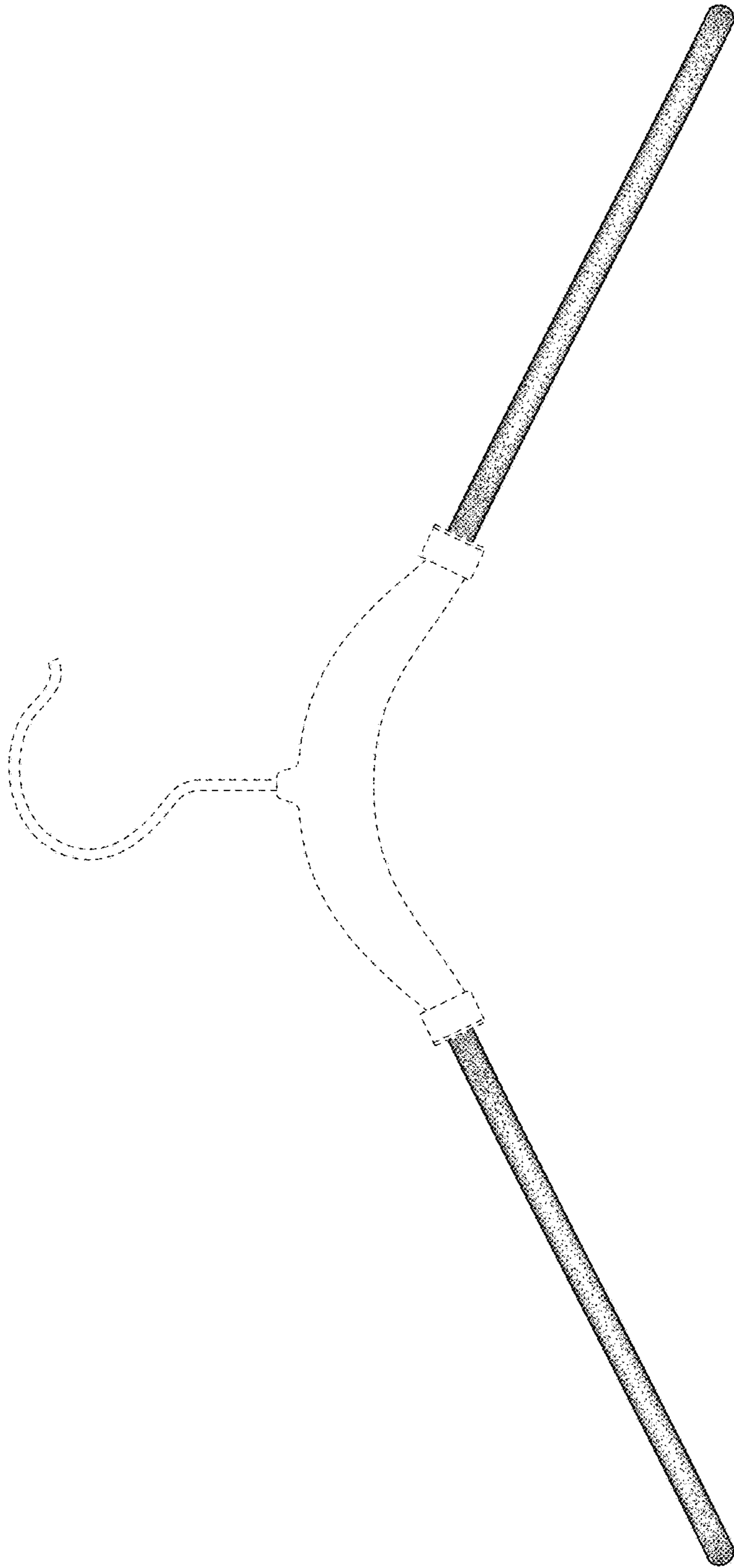

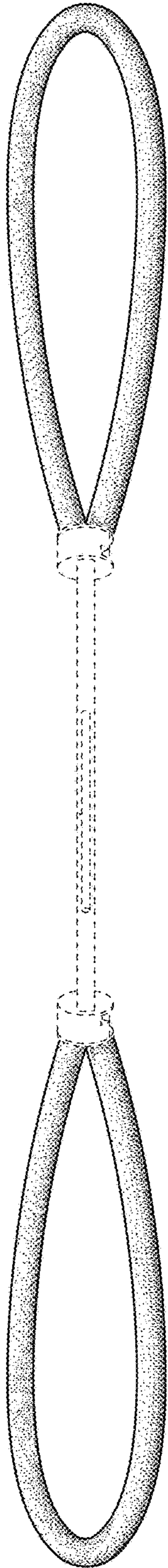

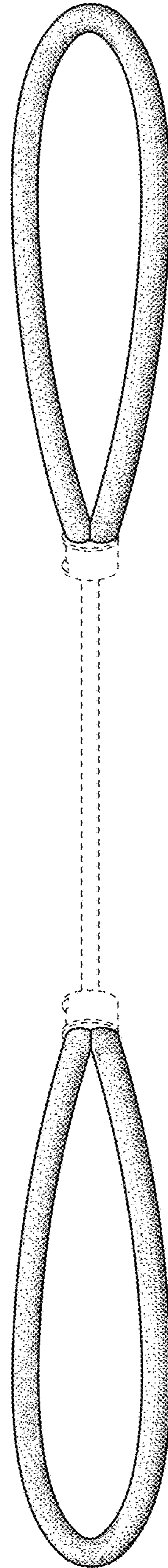

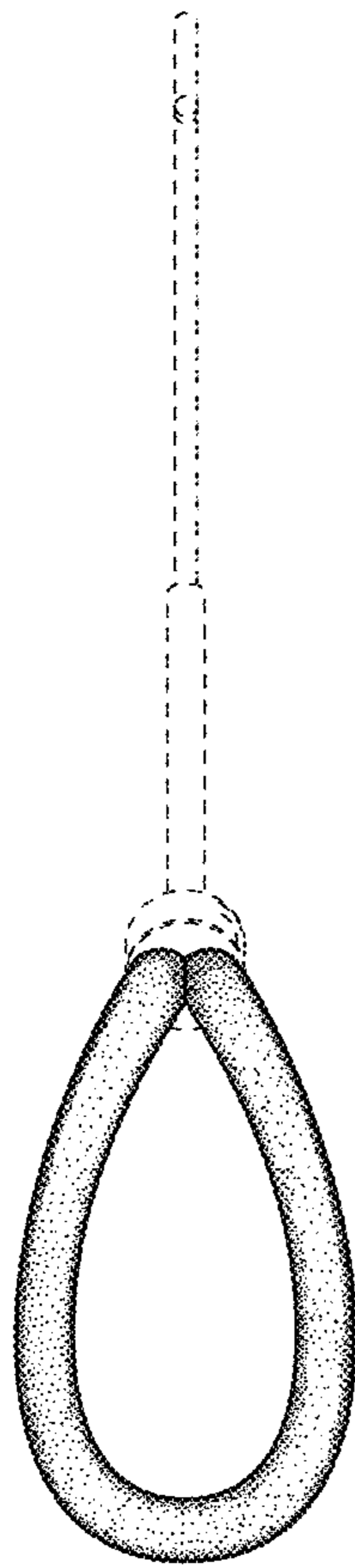

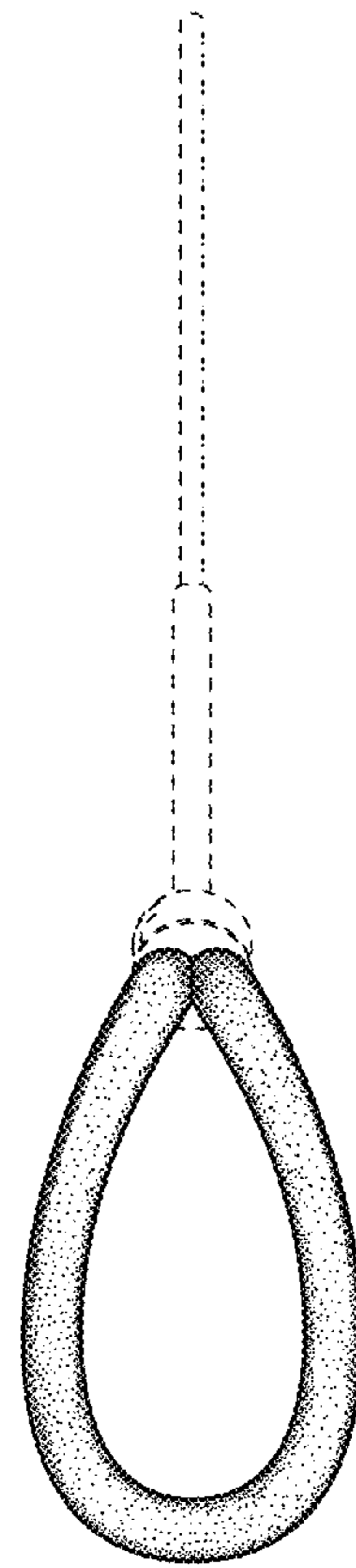
