(57) **CLAIM**

The ornamental design for a collapsible plastic hook for a plastic garment hanger, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a collapsible plastic hook for a plastic garment hanger hook showing my new design;

FIG. 2 is a front elevation view thereof;

FIG. 3 is a right side elevation view thereof;

FIG. 4 is a rear elevation view thereof;

FIG. 5 is a left side elevation view thereof;

FIG. 6 is an enlarged partial view thereof taken from the broken circle shown in FIG. 2;

FIG. 7 is a front perspective view thereof showing the collapsible plastic hook in a collapsed position;

FIG. 8 is a top view of the collapsible plastic hook in the collapsed position;

FIG. 9 is a front elevation view of the collapsible plastic hook in the collapsed position;

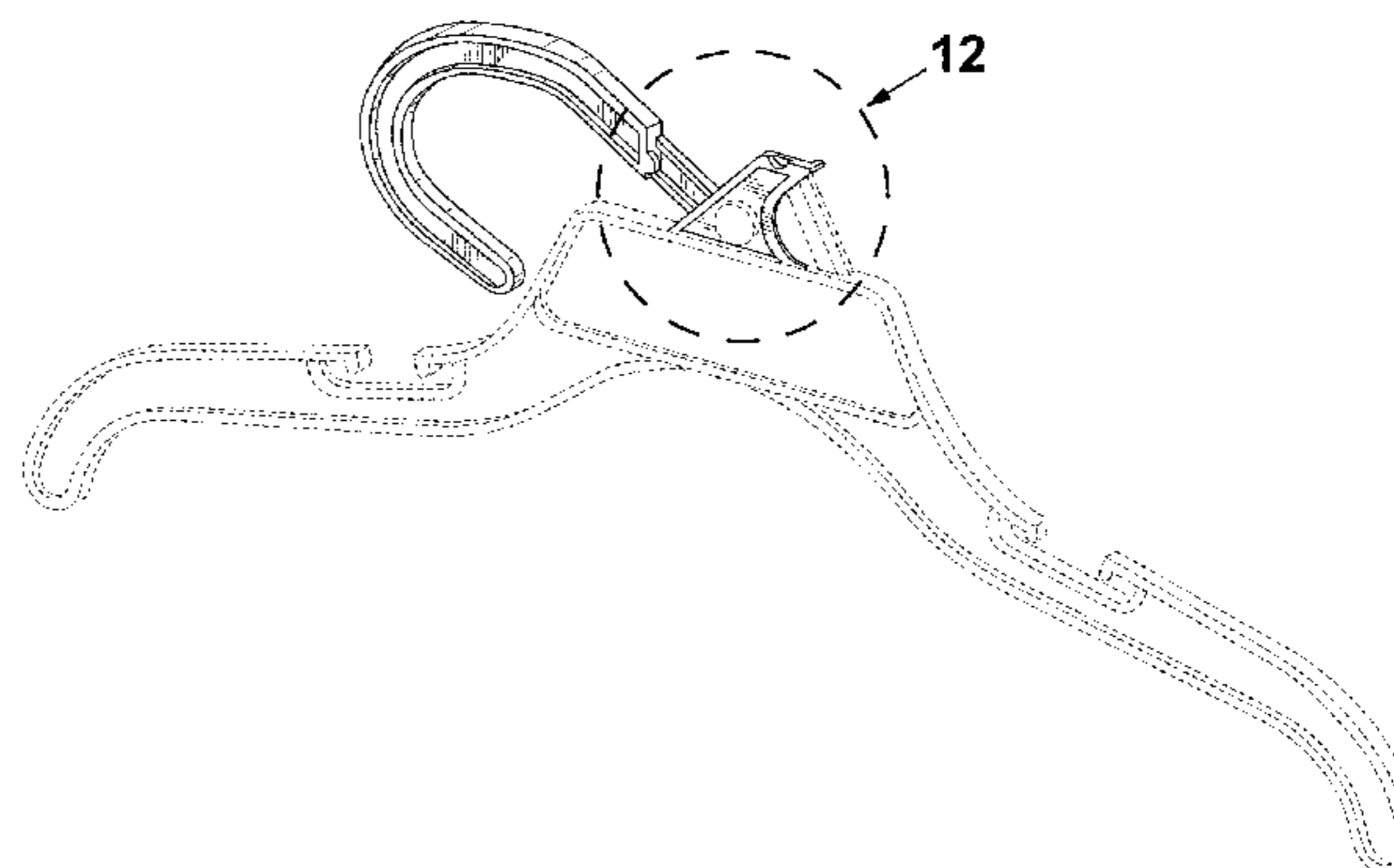
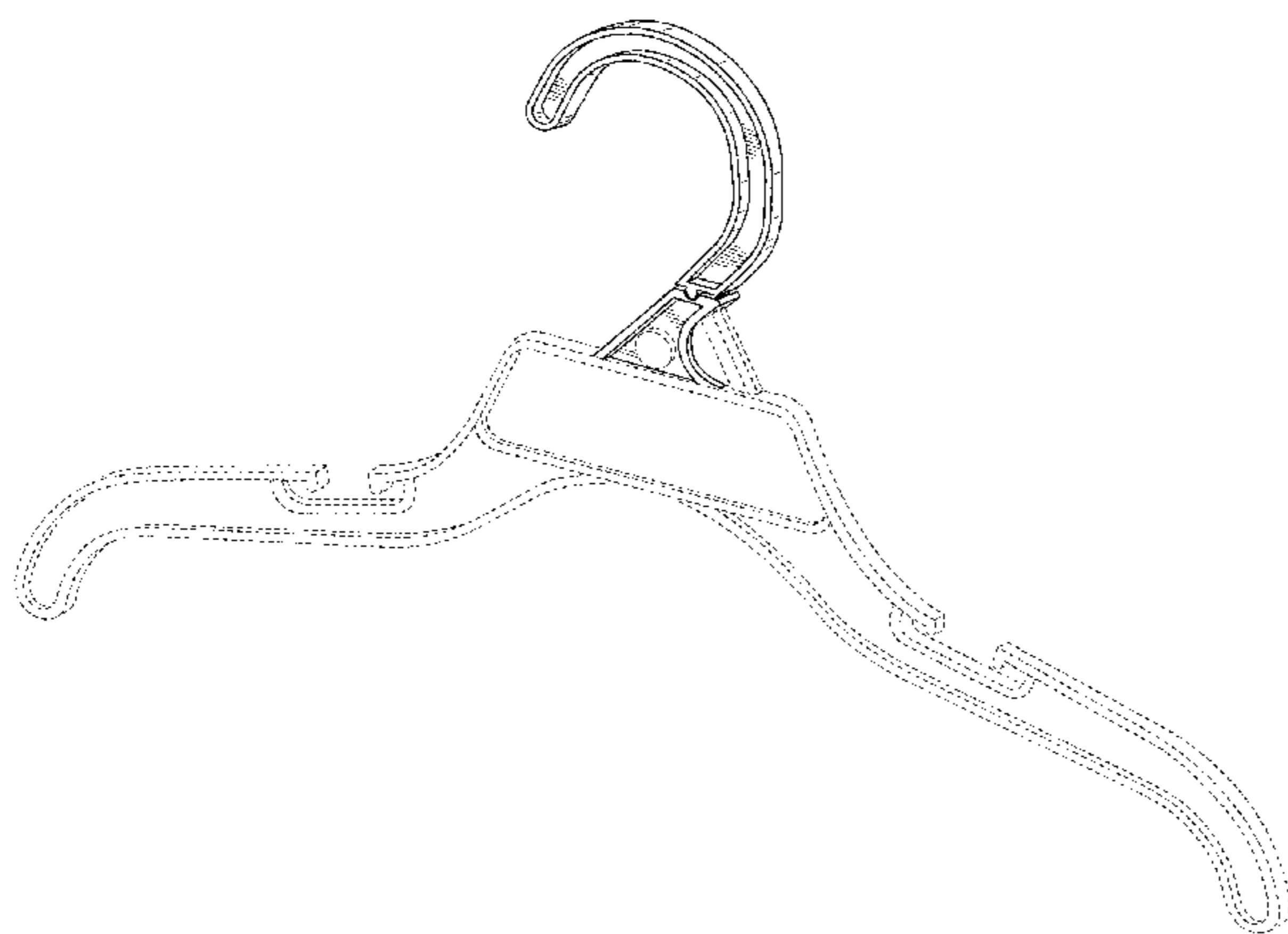
FIG. 10 is a rear elevation view of the collapsible plastic hook in the collapsed position;

FIG. 11 is an enlarged sectional view taken along lines 11-11 of FIG. 10; and,

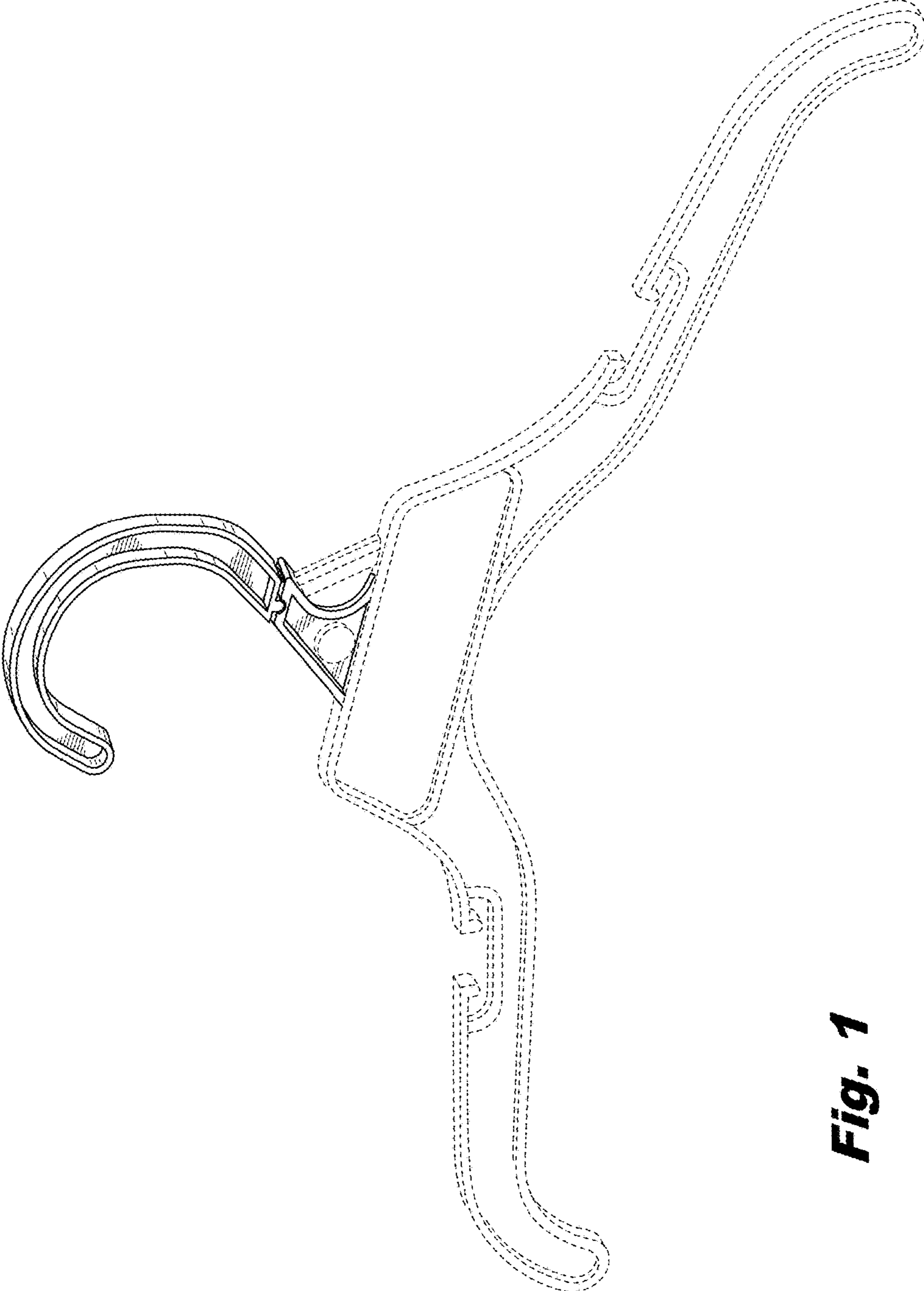

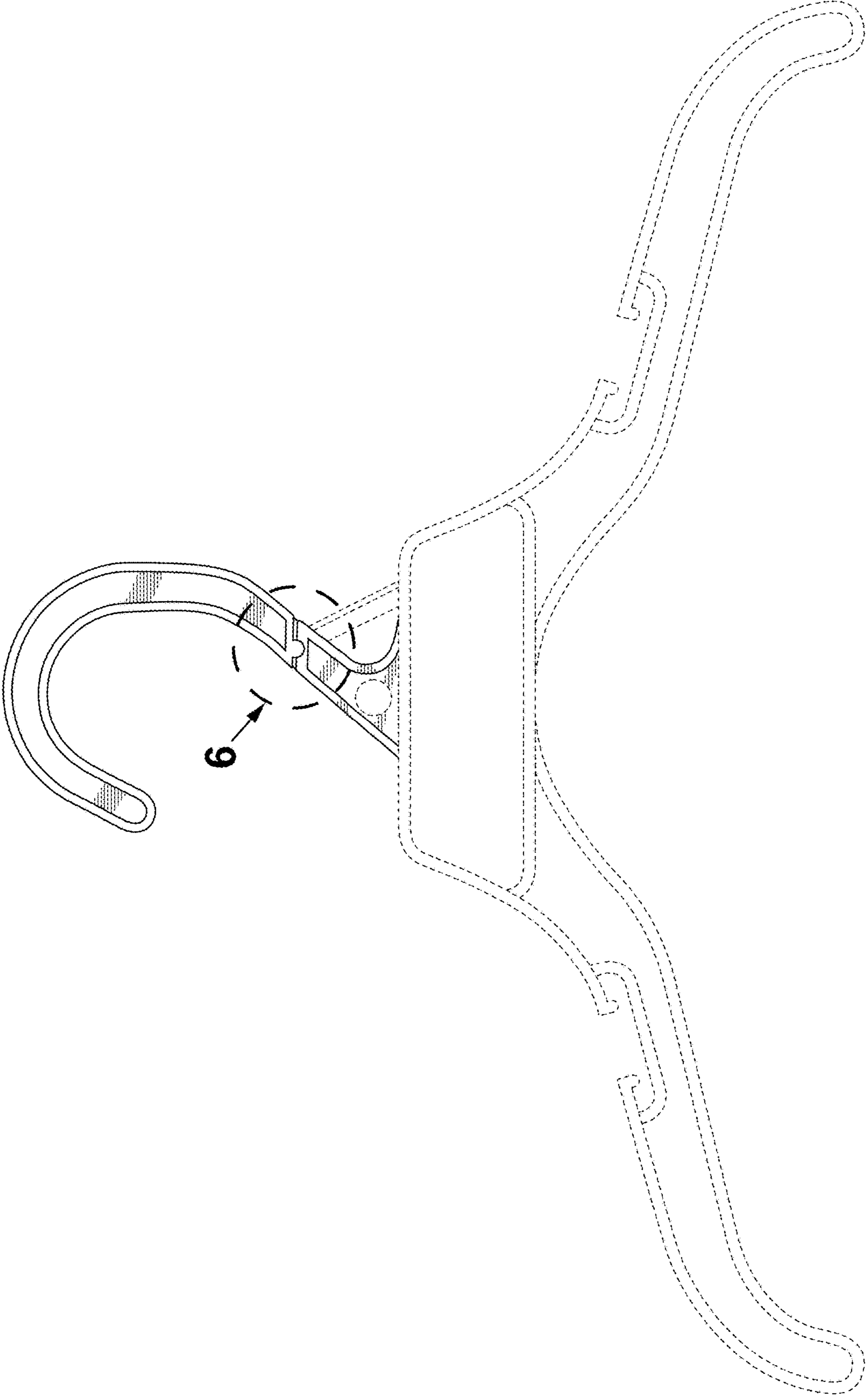

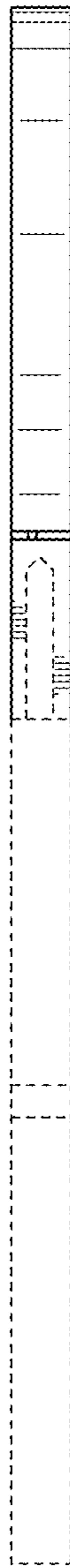

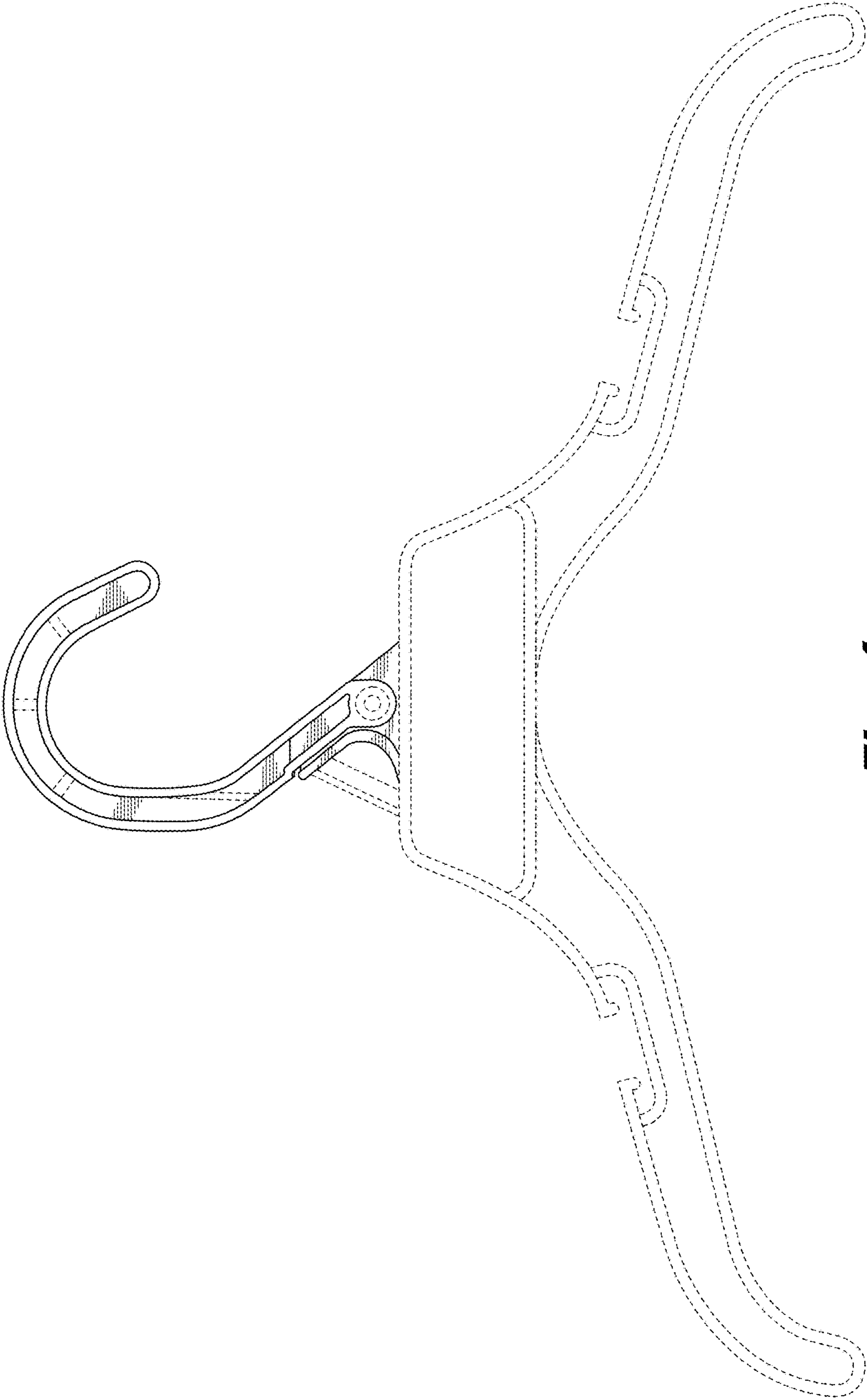

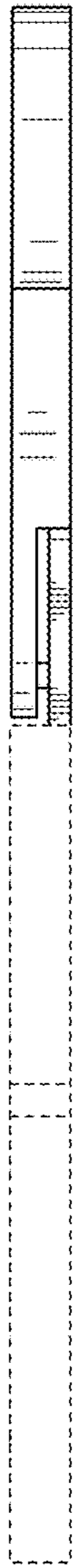

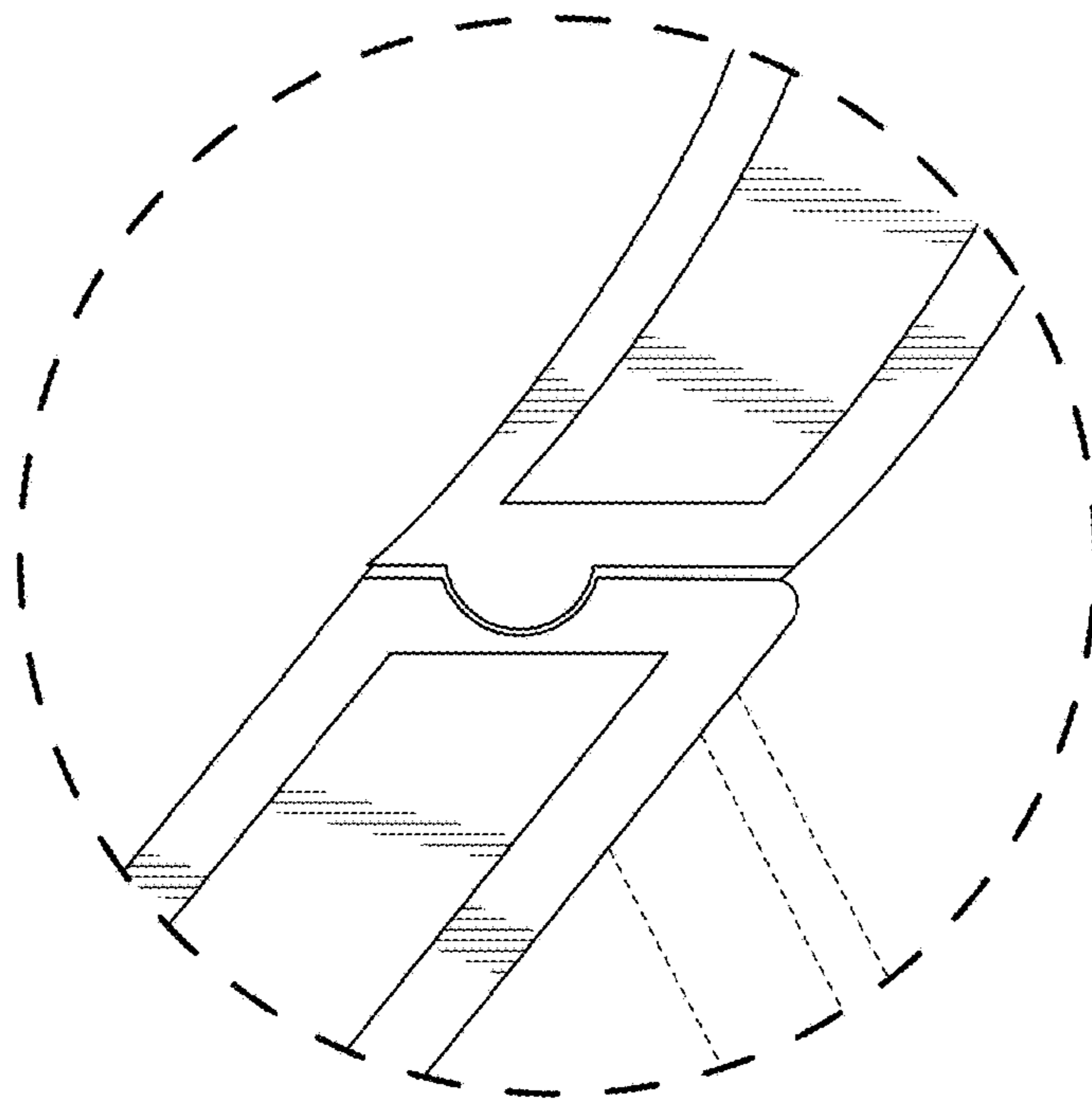

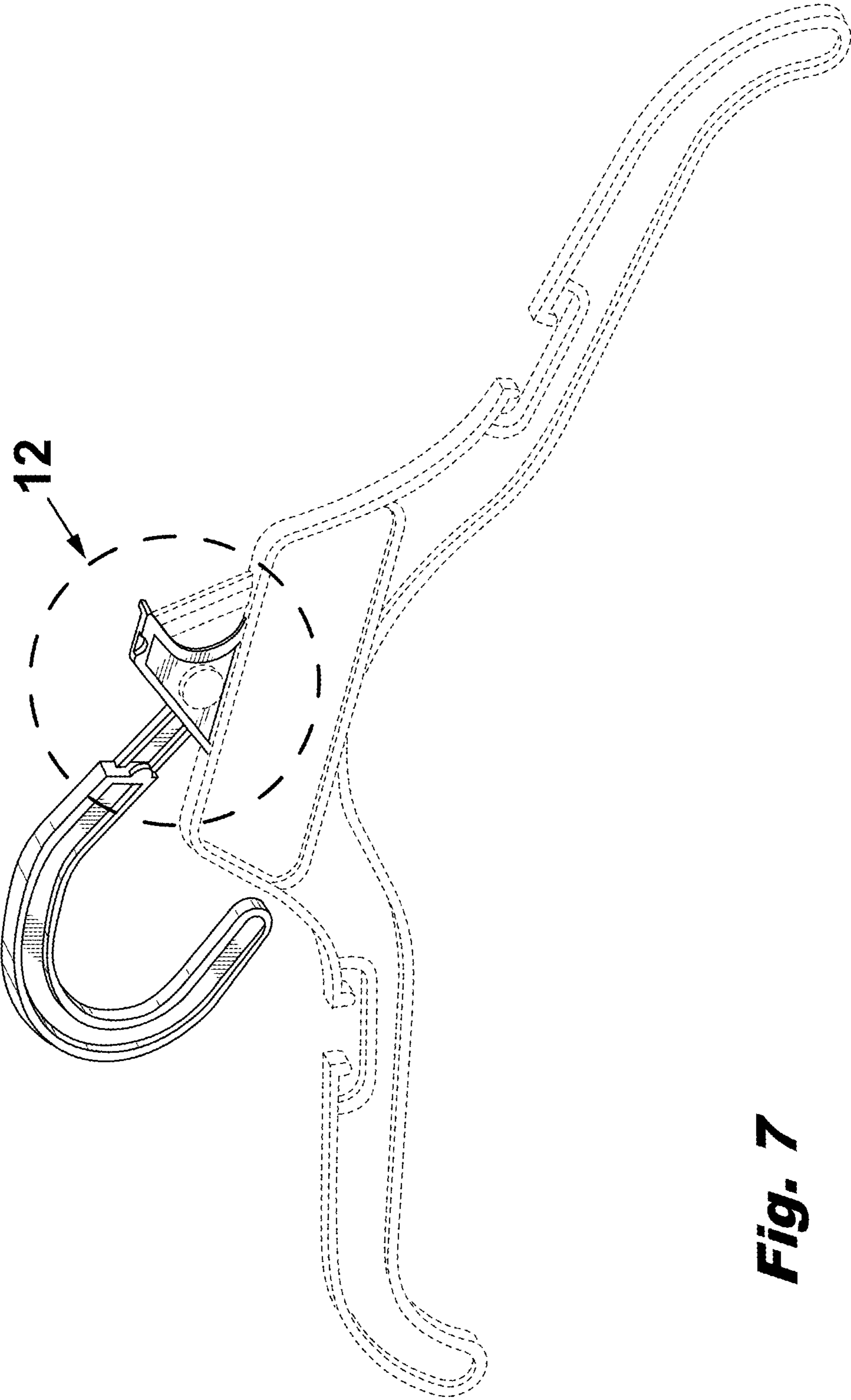

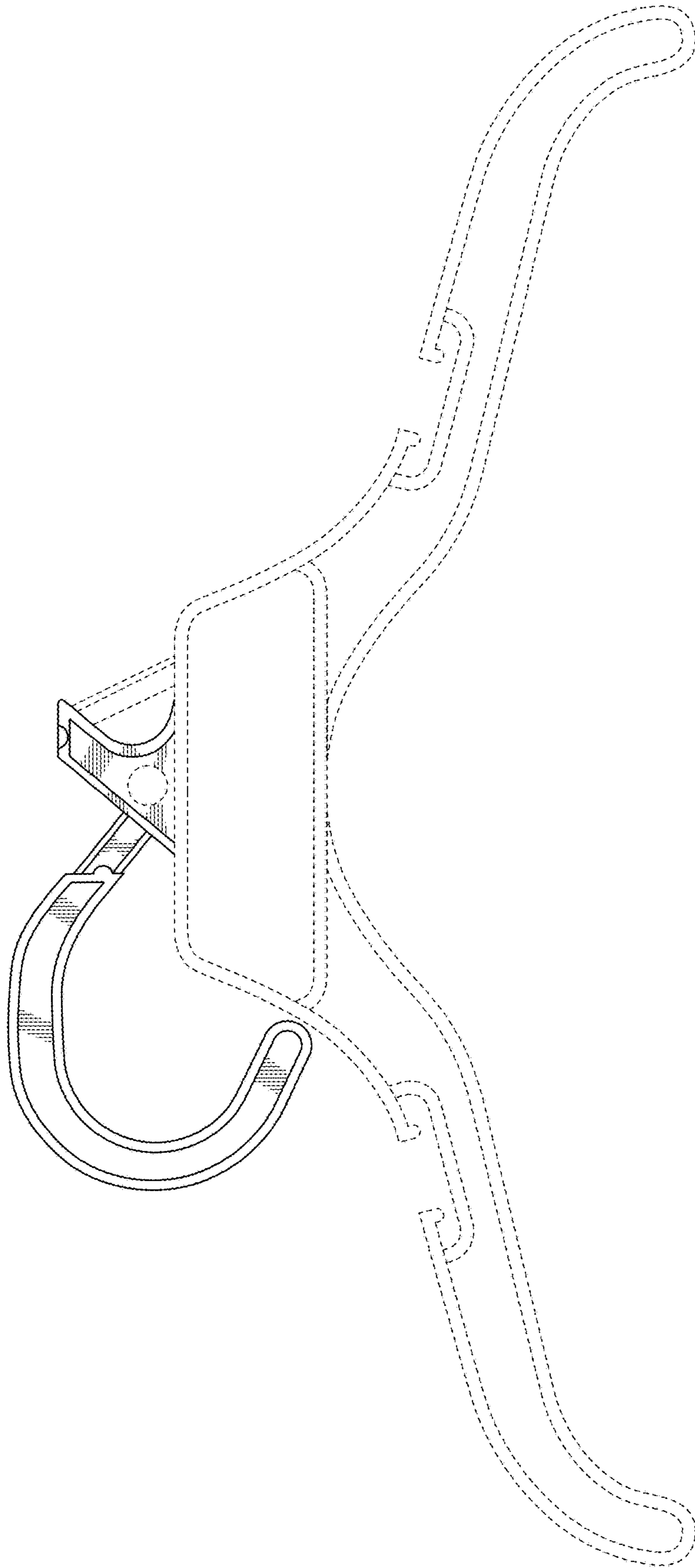




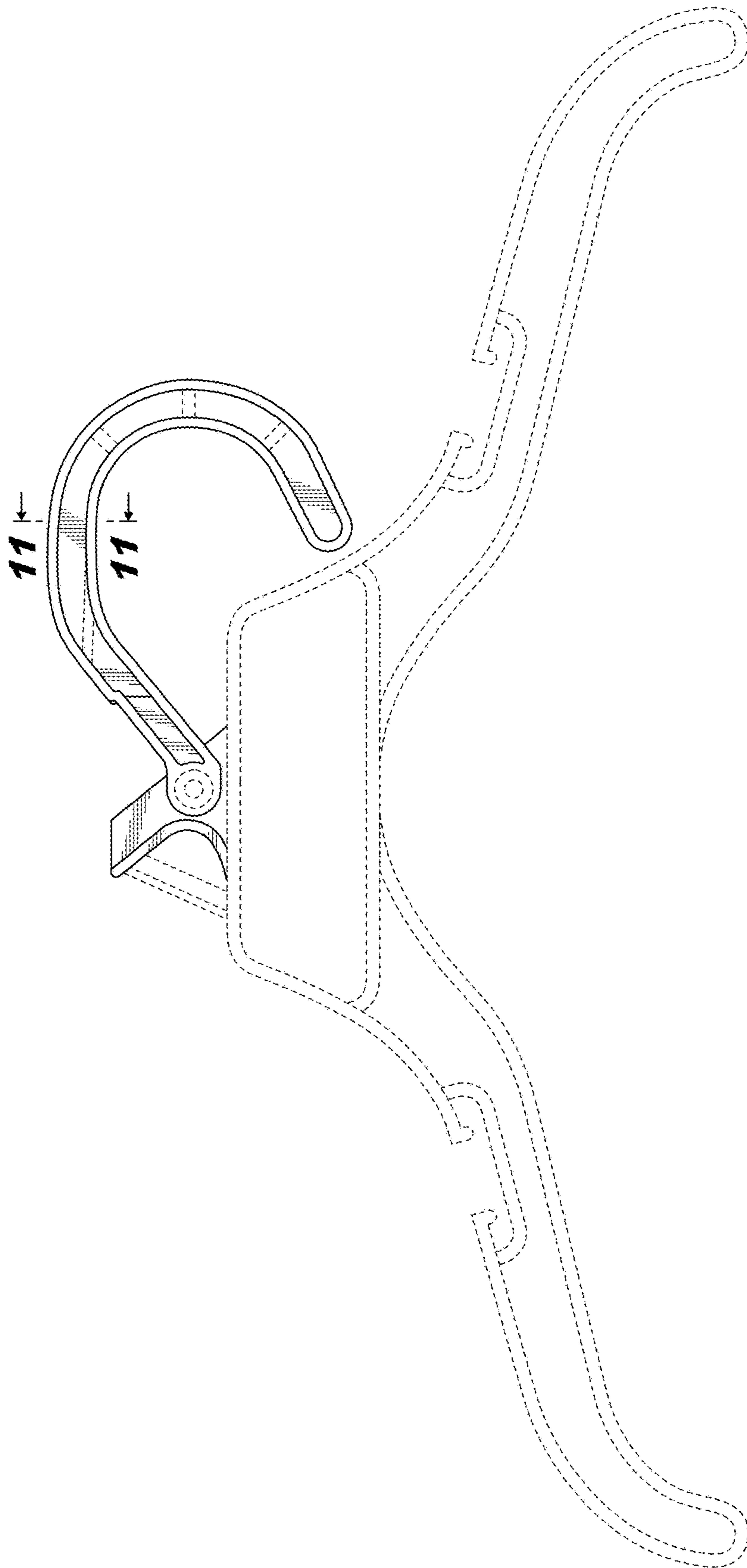

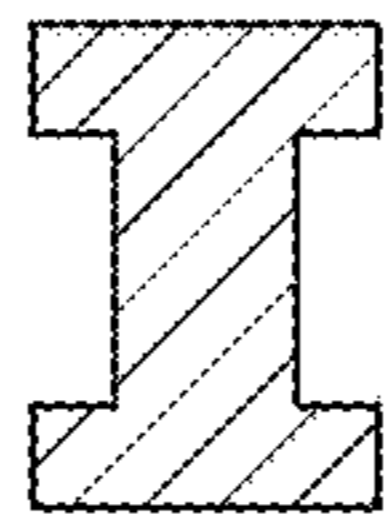

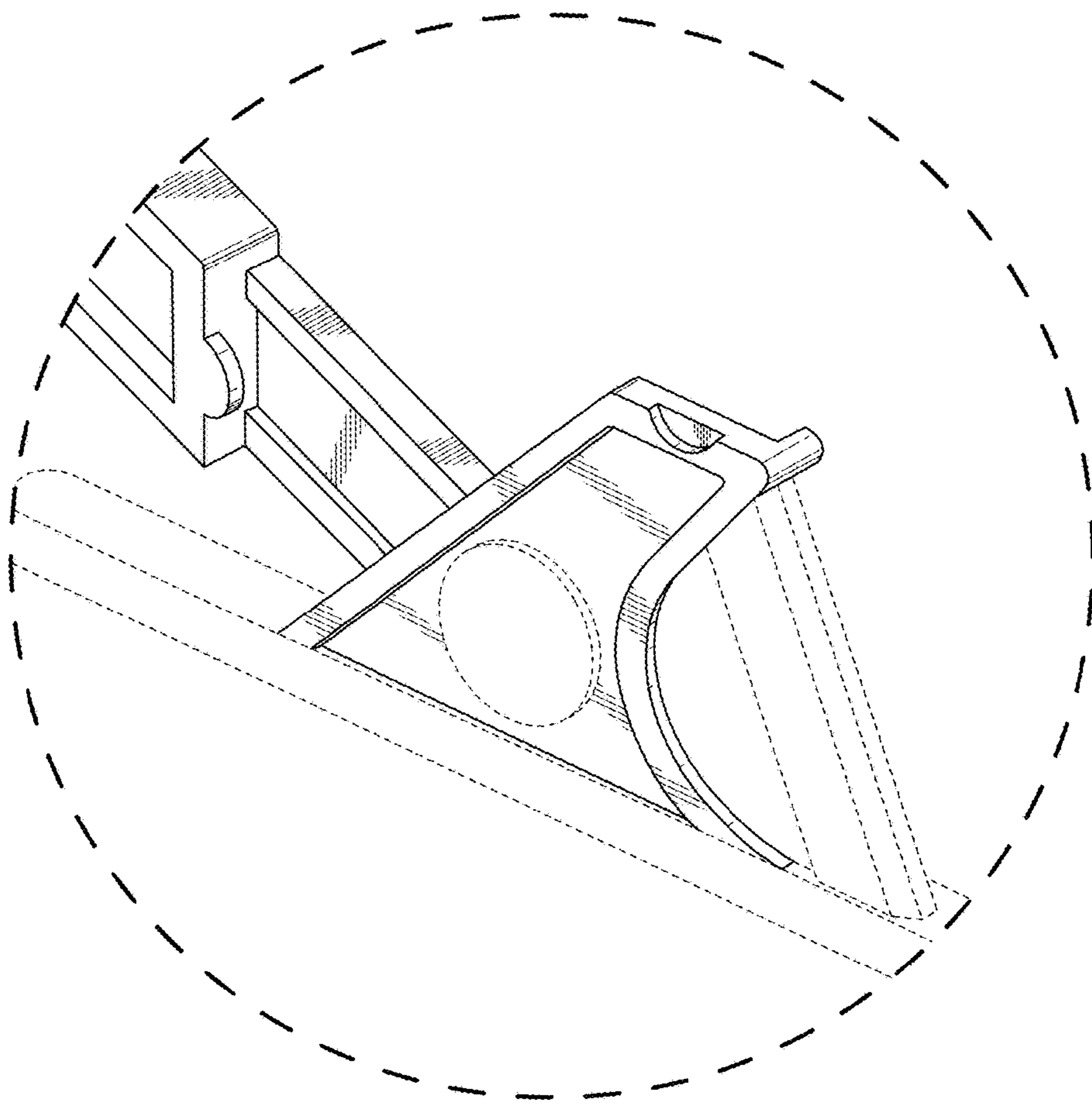
