DESCRIPTION

FIG. 1 is an upper right perspective view of a first embodiment of a package.

FIG. 2 is a lower left perspective view of the package of FIG. 1.

FIG. 3 is a front elevation view of the package of FIG. 1.

FIG. 4 is a rear elevation view of the package of FIG. 1.

FIG. 5 is a left side elevation view of the package of FIG. 1.

FIG. 6 is a right side elevation view of the package of FIG. 1.

FIG. 7 is a top plan view of the package of FIG. 1.

FIG. 8 is a bottom plan view of the package of FIG. 1.

FIG. 9 is an upper right perspective view of a second embodiment of a package.

FIG. 10 is a lower left perspective view of the package of FIG. 9.

FIG. 11 is a front elevation view of the package of FIG. 9.

FIG. 12 is a rear elevation view of the package of FIG. 9.

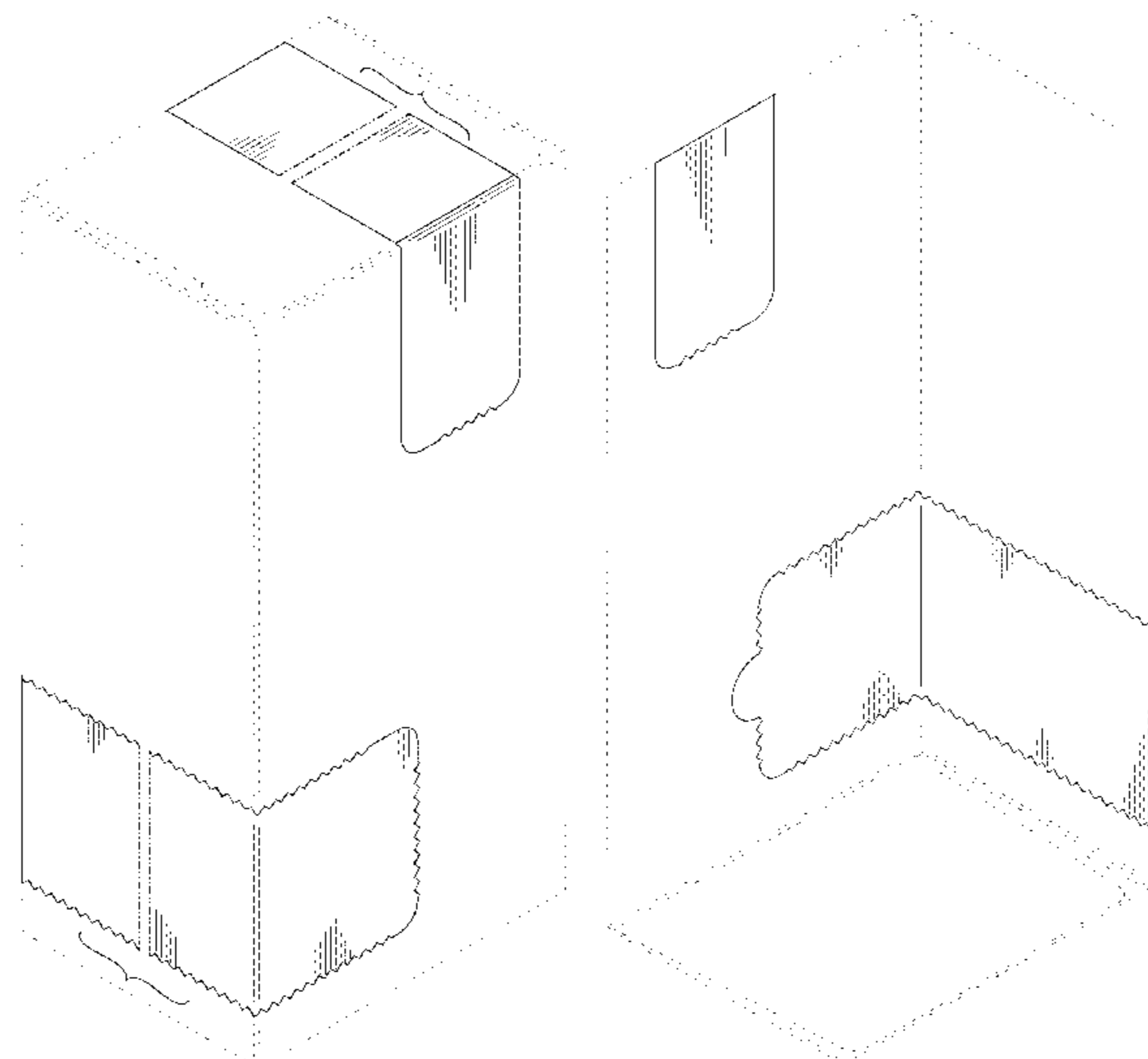
FIG. 13 is a left side elevation view of the package of FIG. 9.

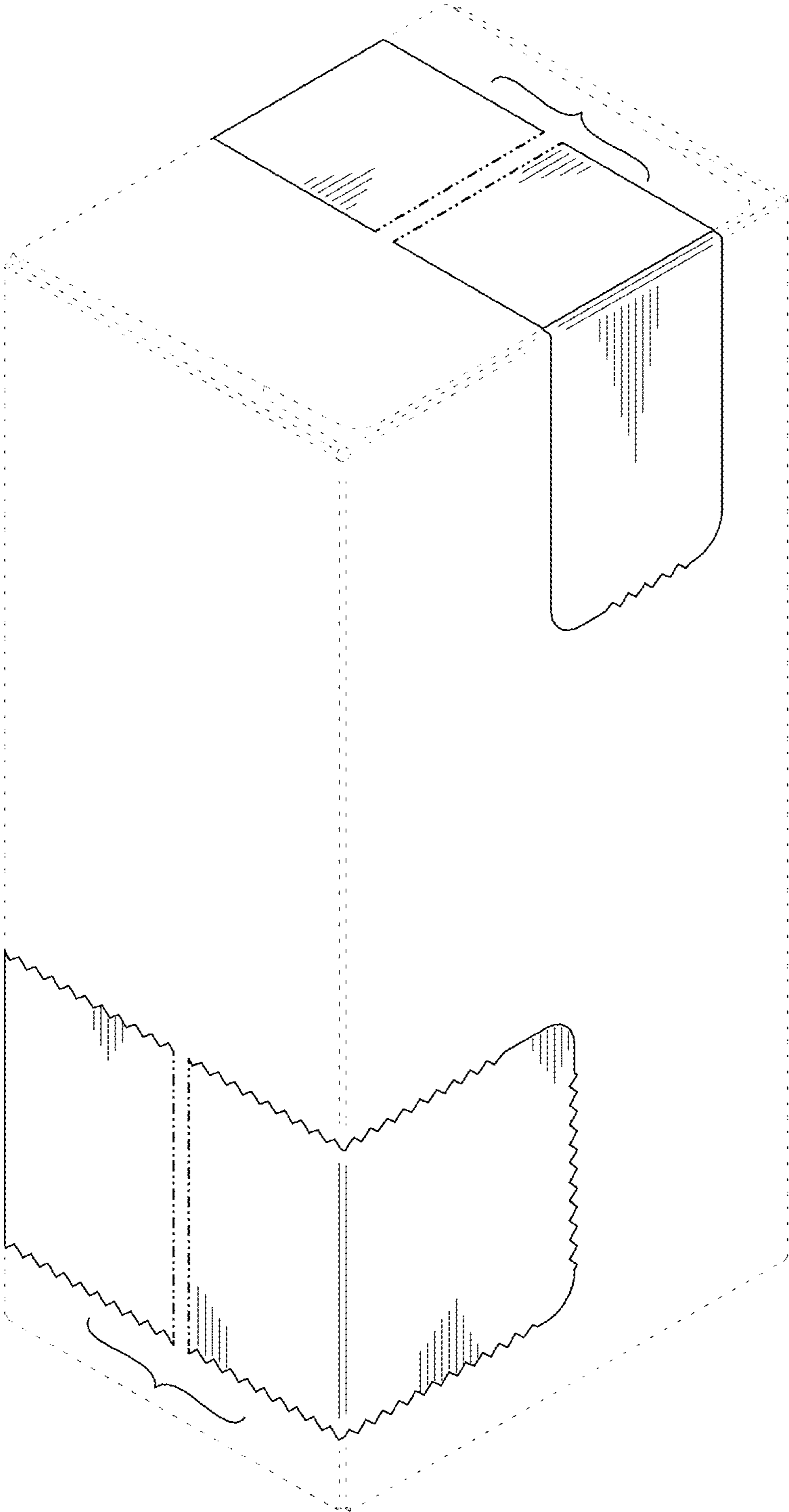

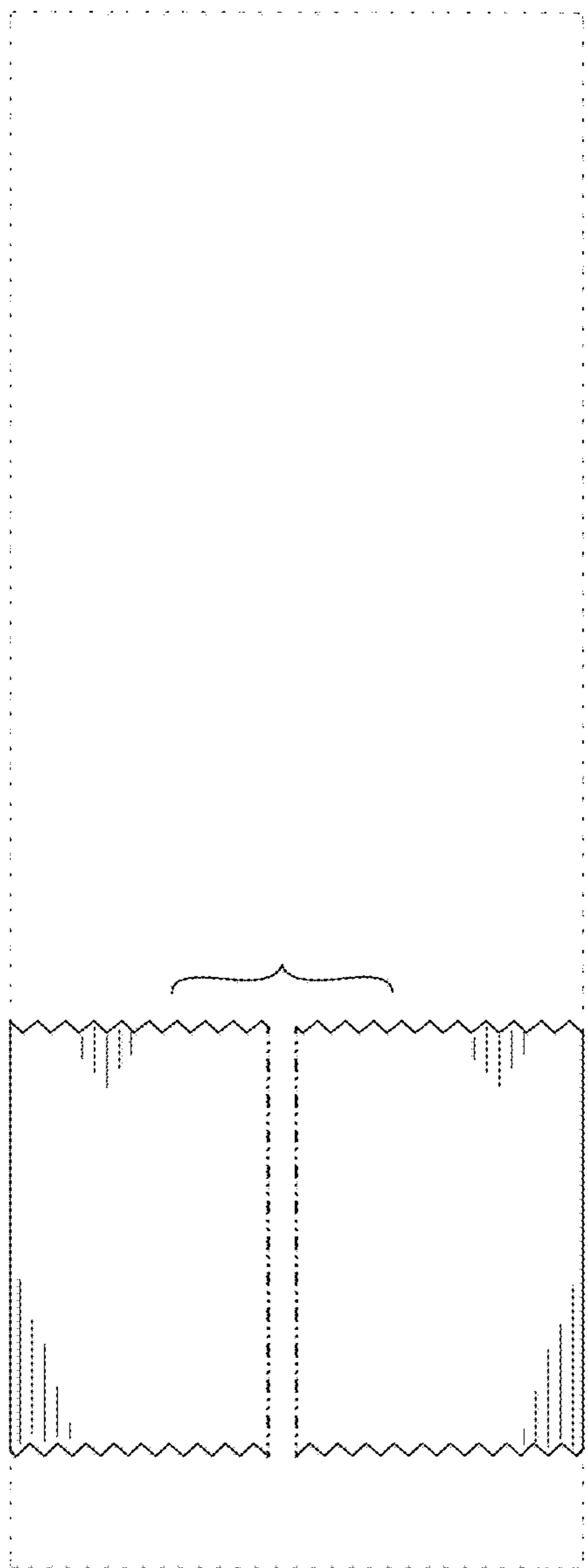

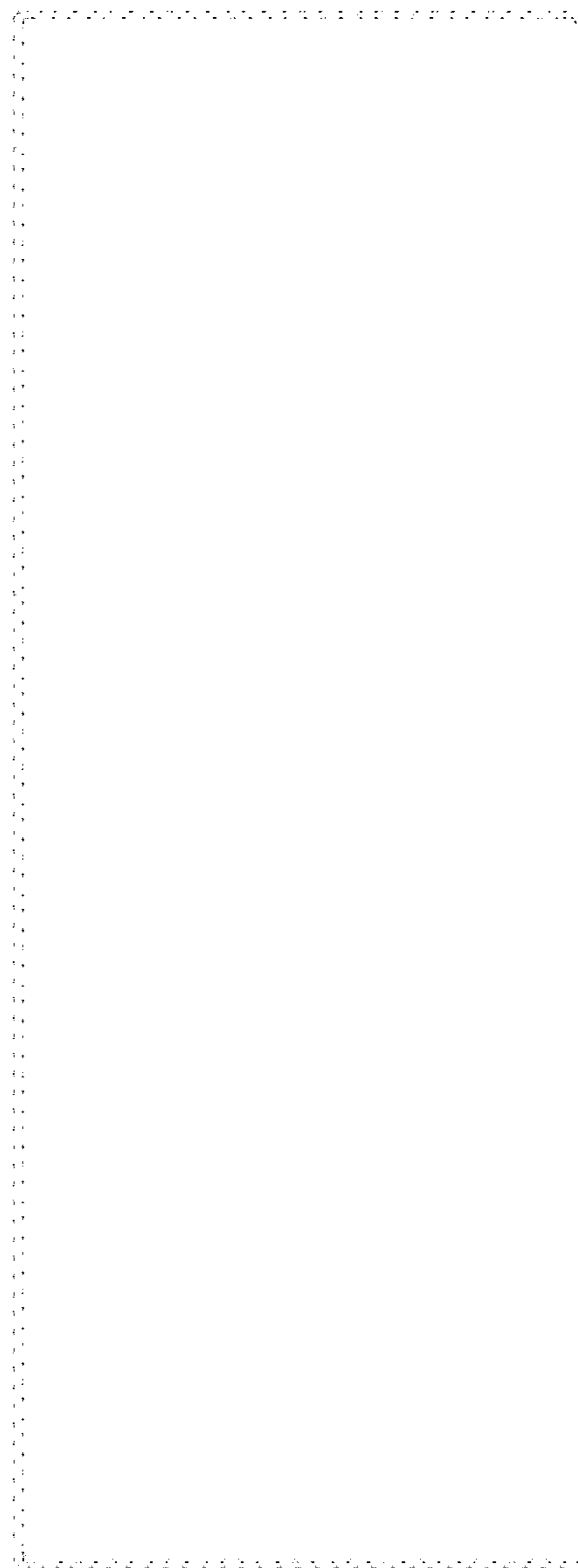

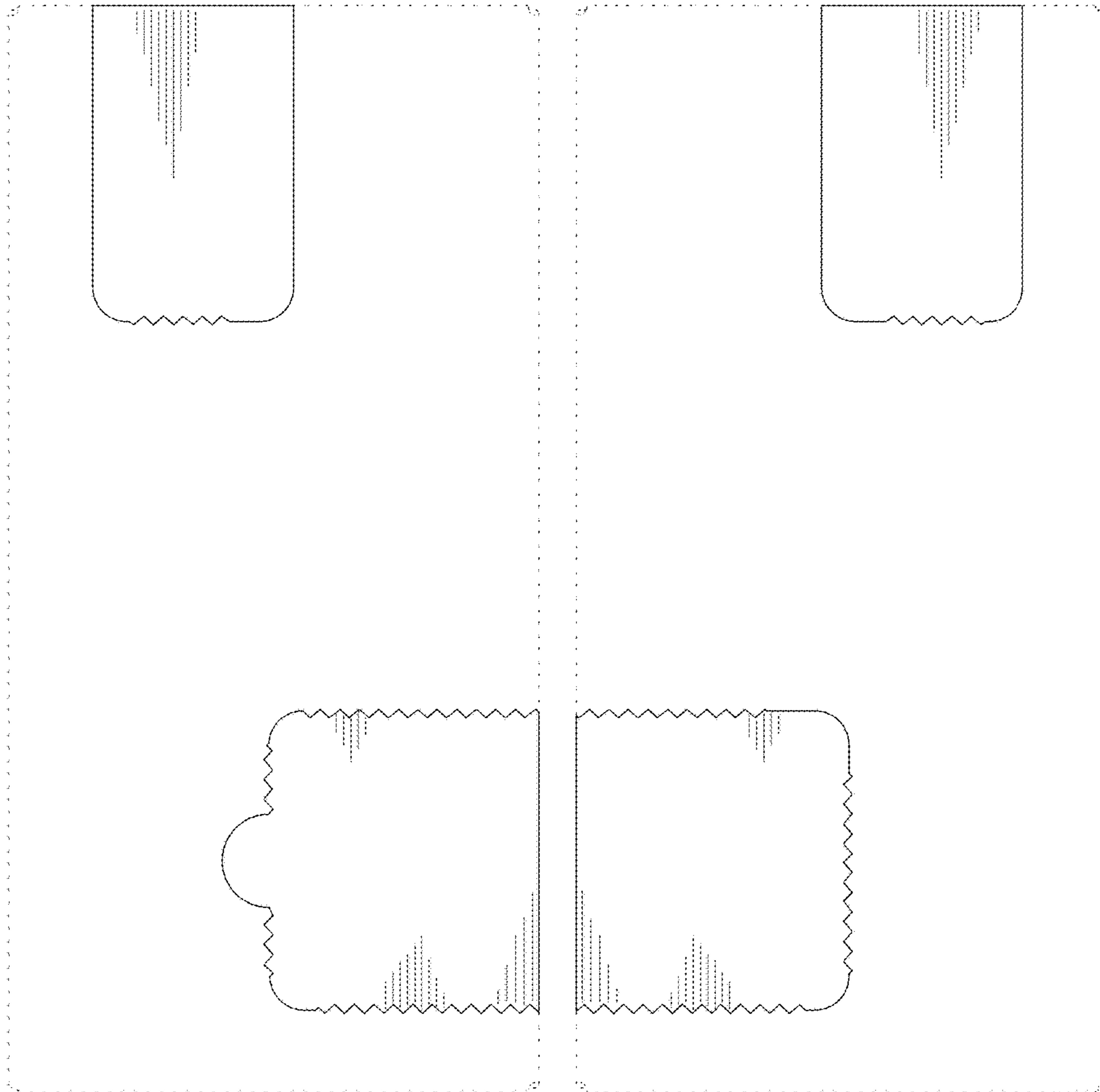

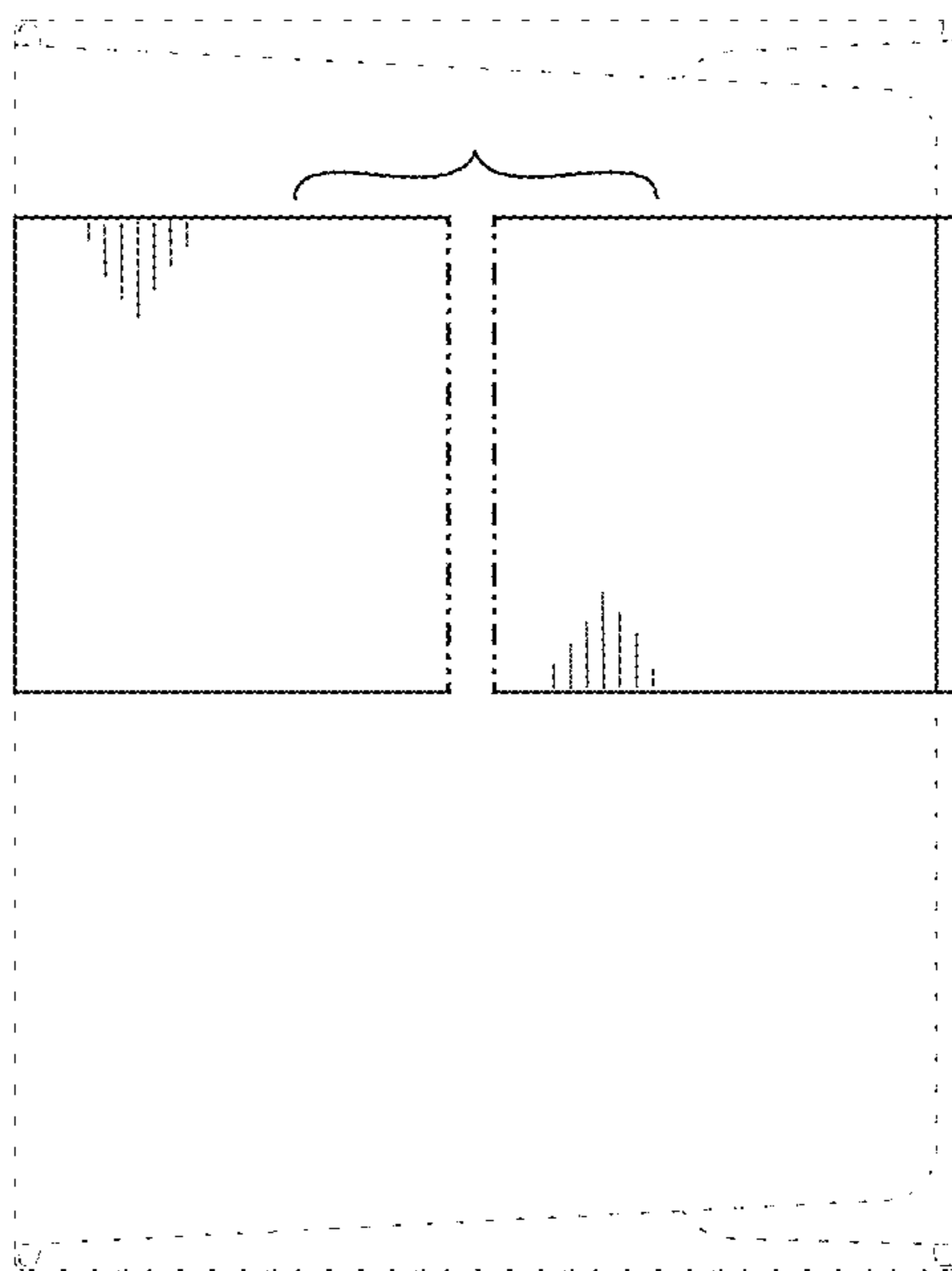

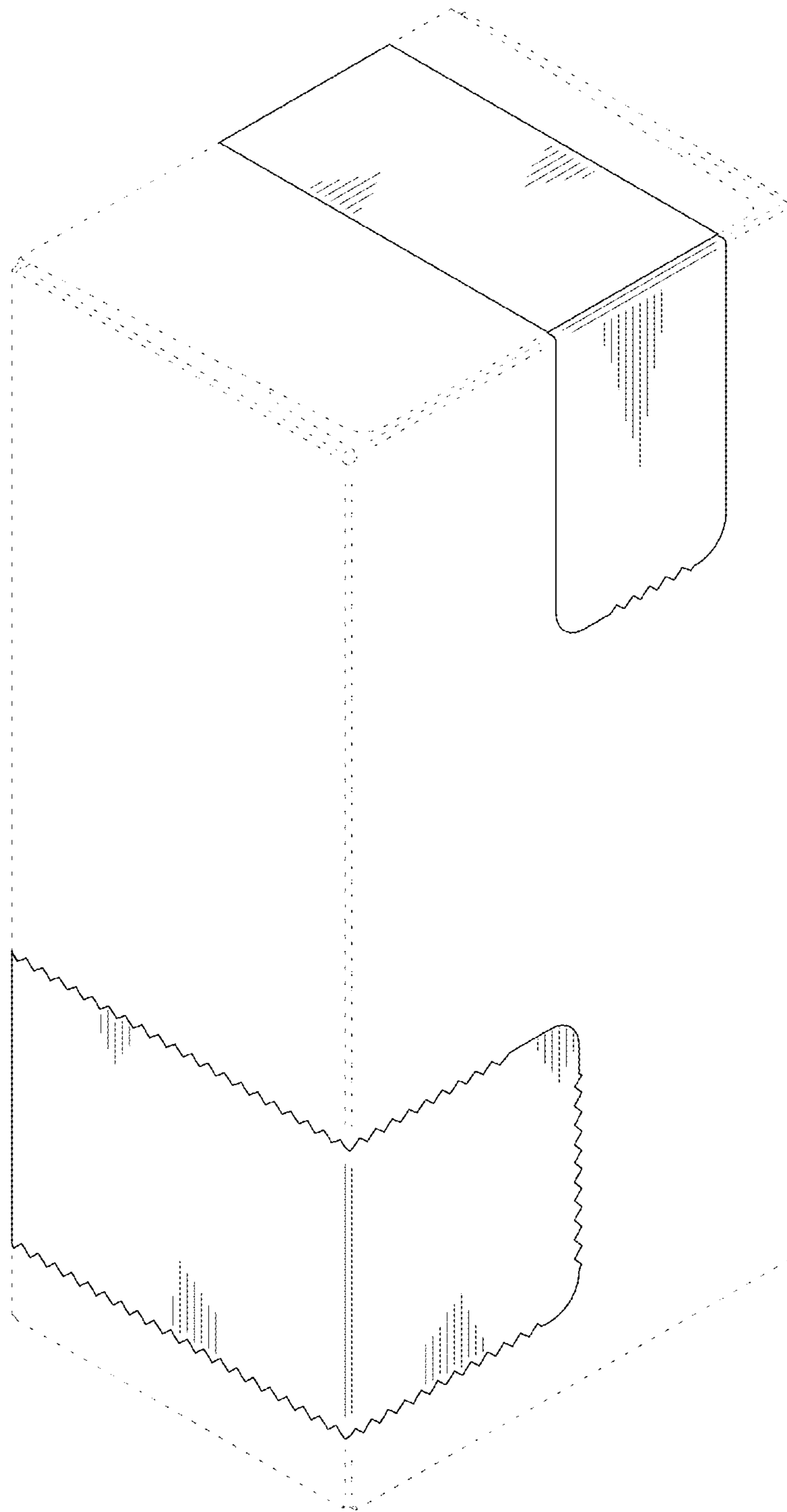

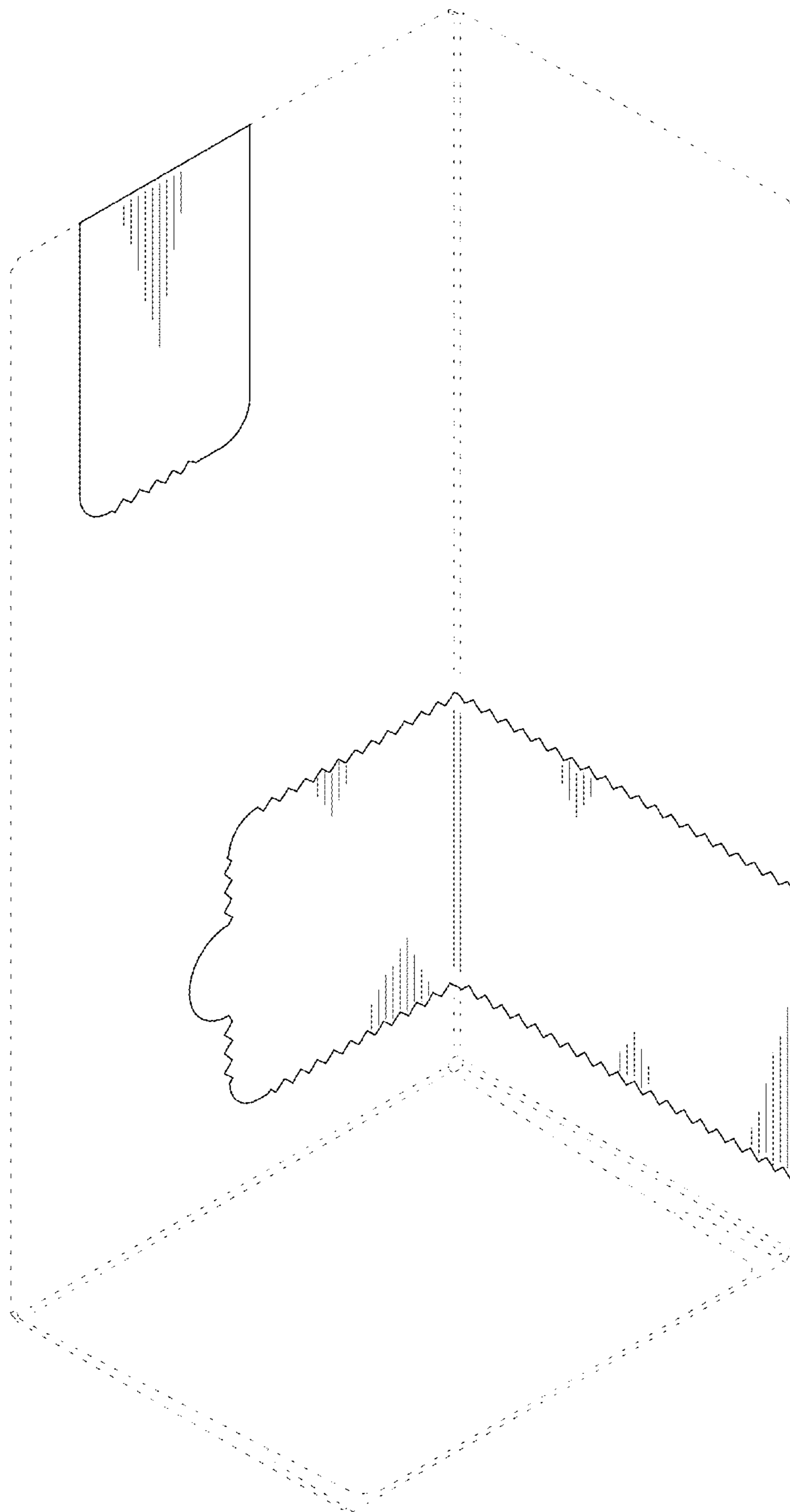

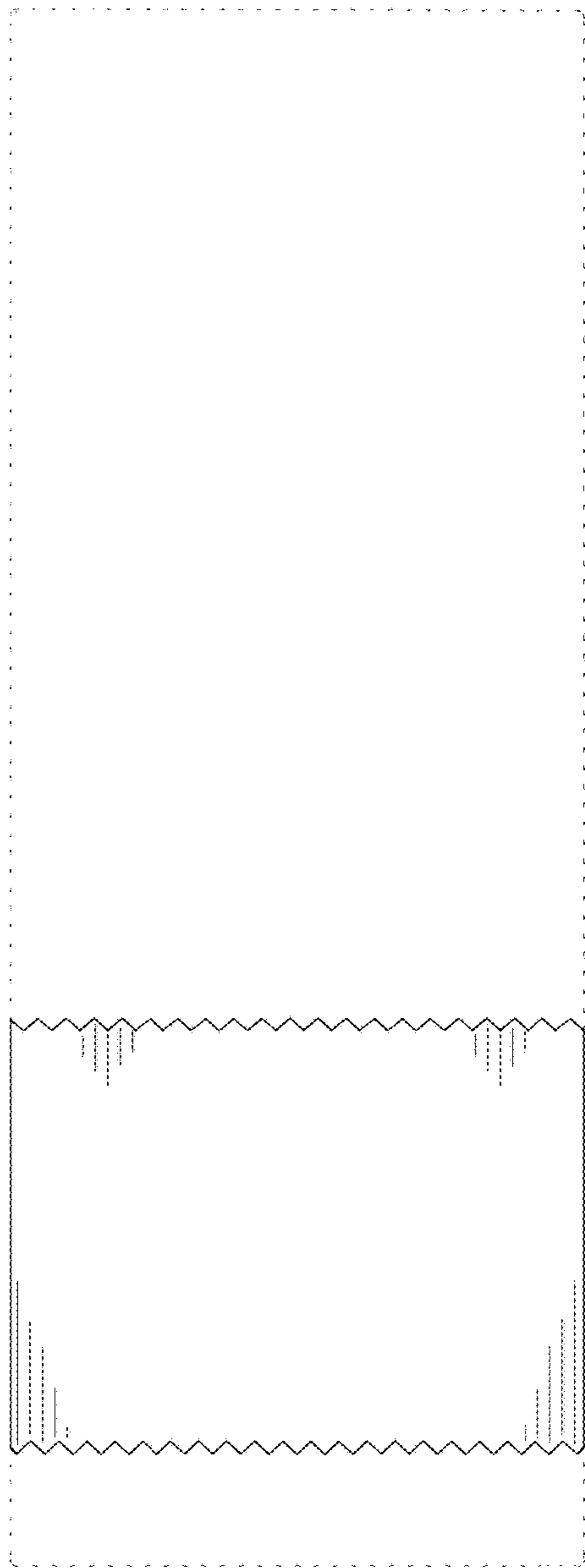

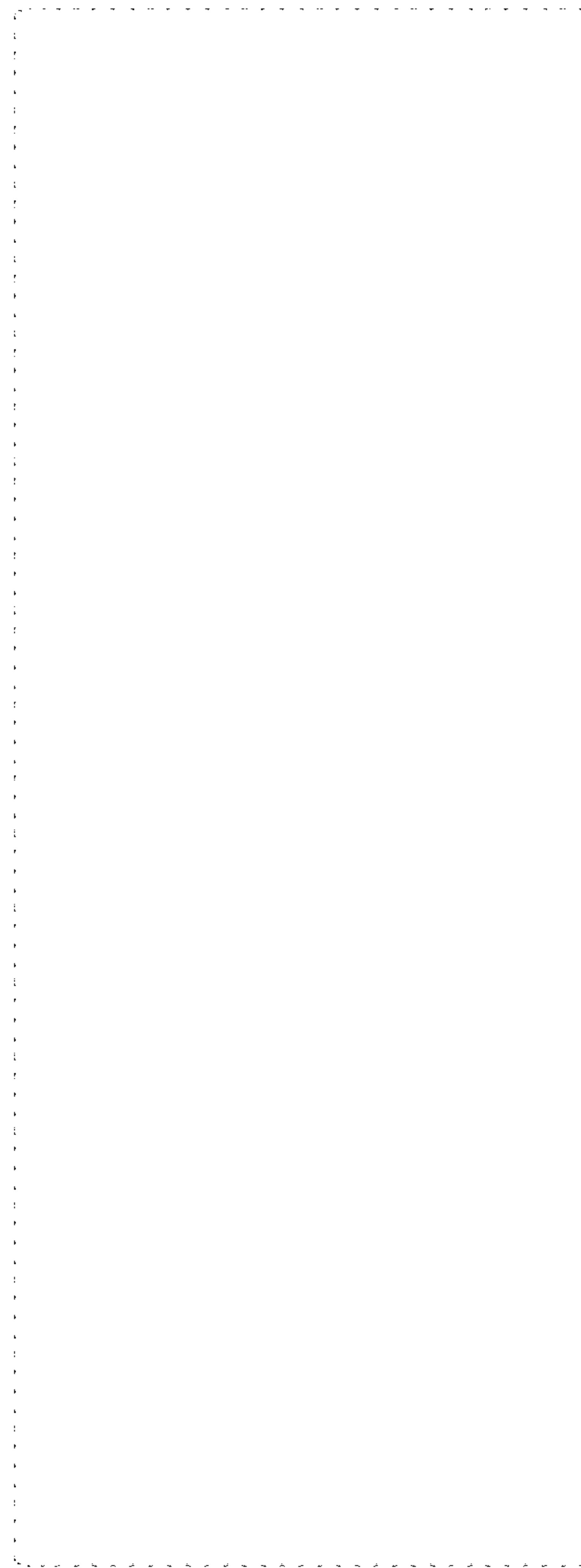

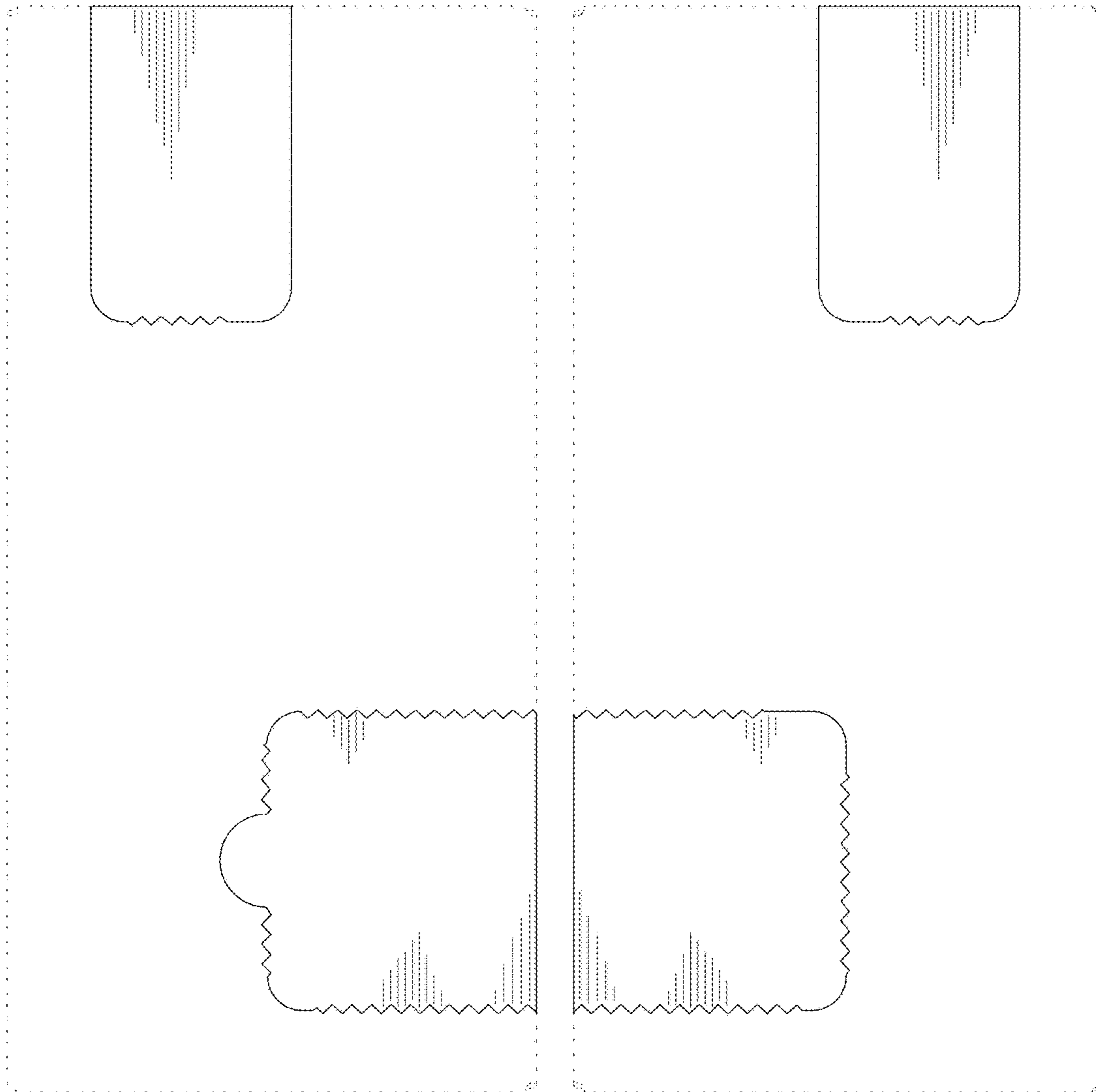

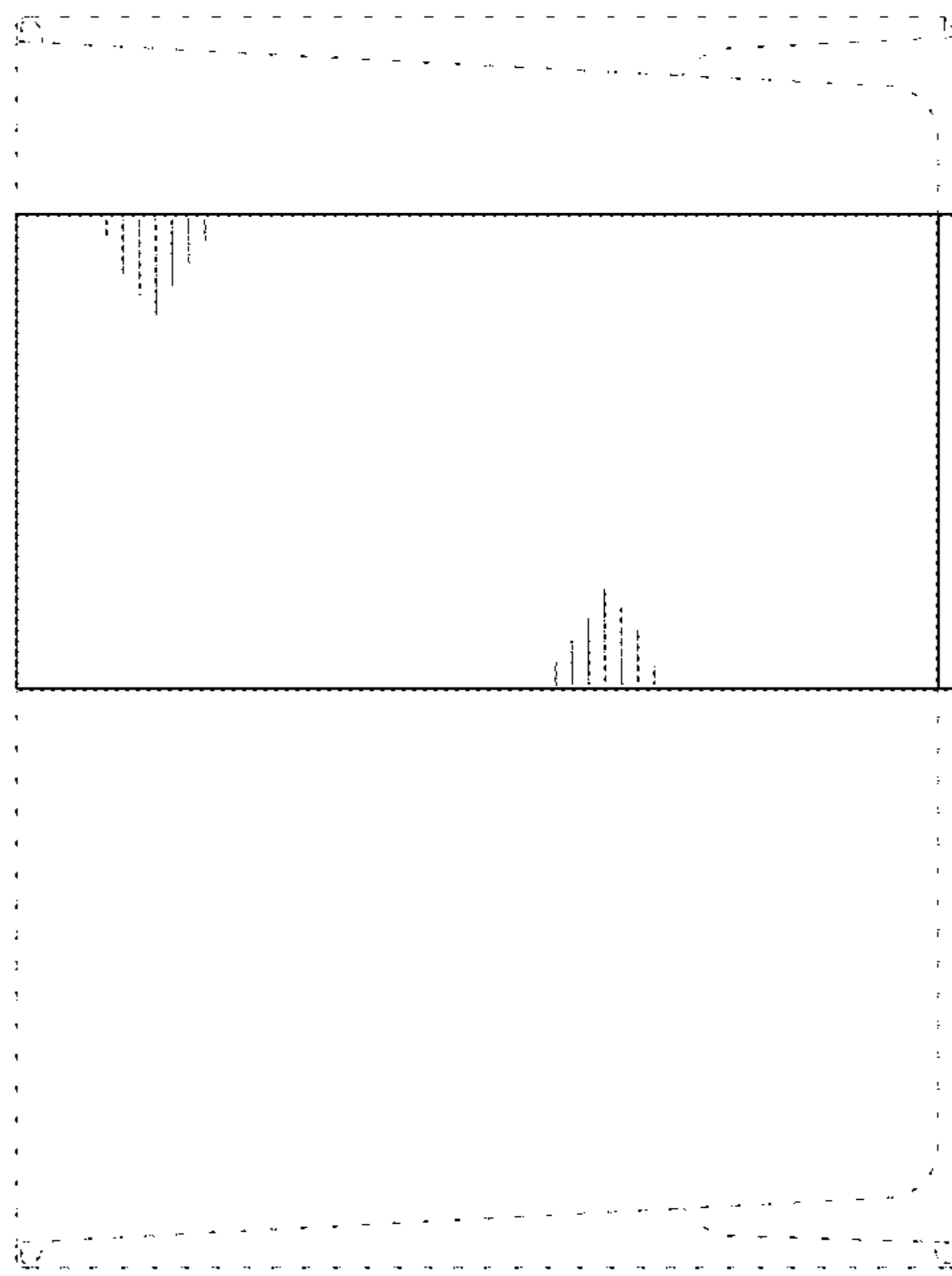
