(57) **CLAIM**

We claim the ornamental design for a bottle, as shown and
described.

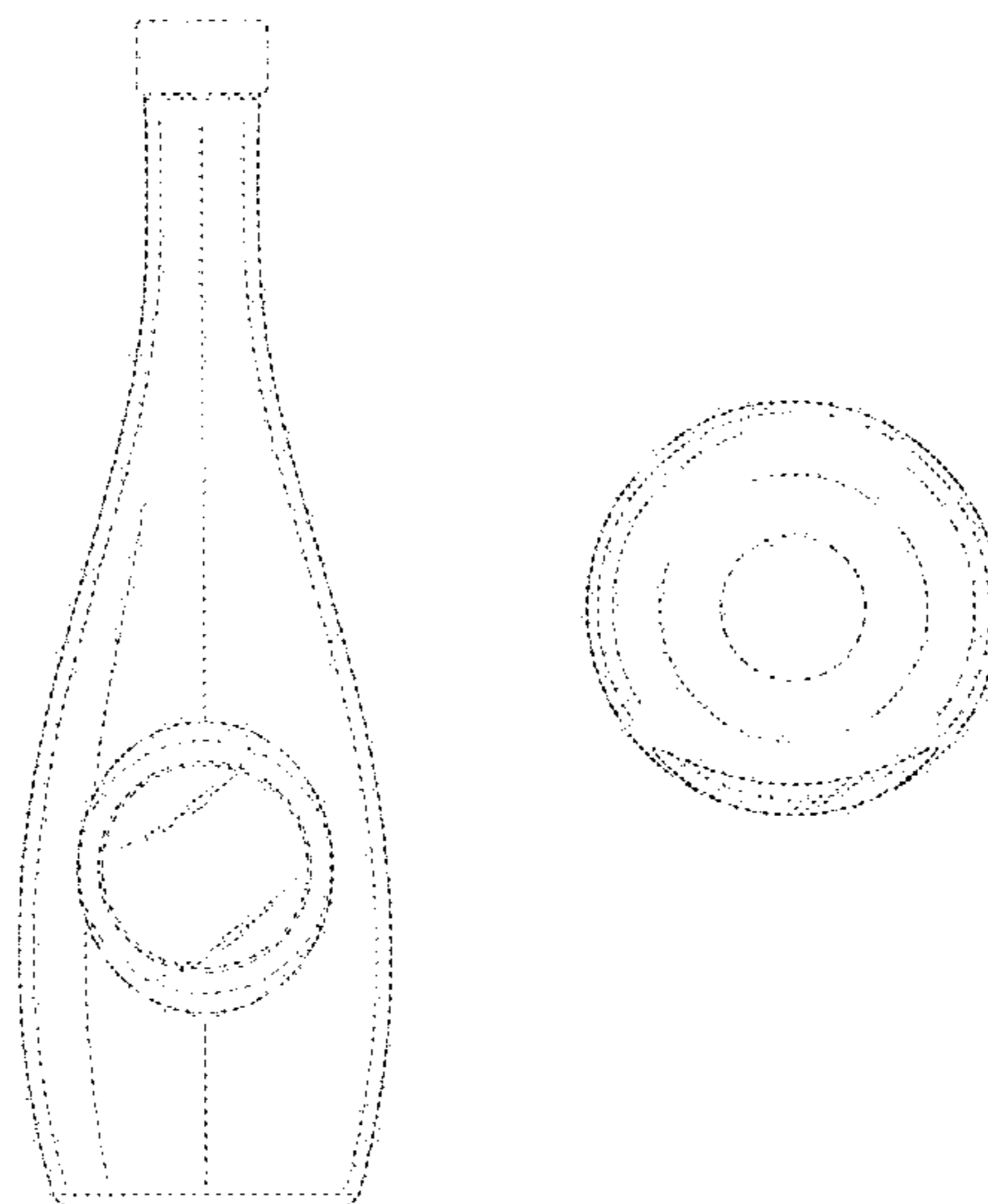
DESCRIPTION

FIG. 1 is a front, left side perspective view of a bottle
showing our new design;
FIG. 2 is a front view of the bottle of FIG. 1;
FIG. 3 is a rear view of bottle of FIG. 1;
FIG. 4 is a right side view of the bottle of FIG. 1;
FIG. 5 is a left side view of the bottle of FIG. 1;
FIG. 6 is a top view of the bottle of FIG. 1; and,
FIG. 7 is a bottom view of the bottle of FIG. 1.

The claim is directed towards a bottle with a transparent
sidewall feature covering an unclaimed recessed compart-
ment in the bottle sidewall.

The portions of the bottle in broken lines and any surfaces
not shown in the drawings, including interior surfaces, form
no part of the claimed invention.

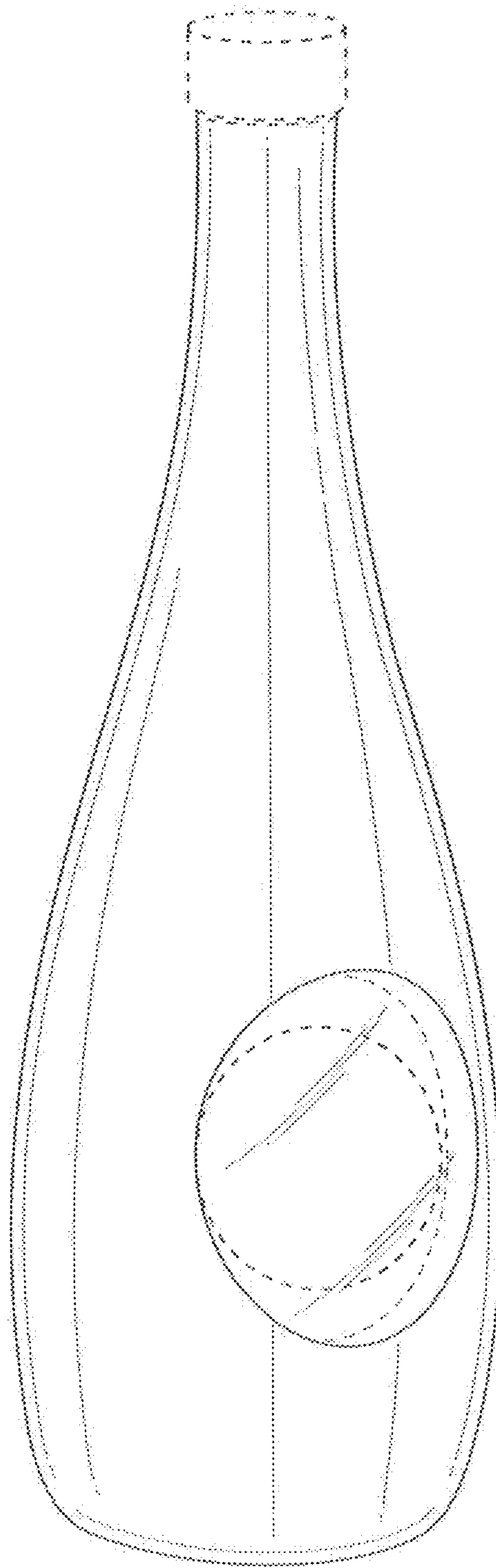

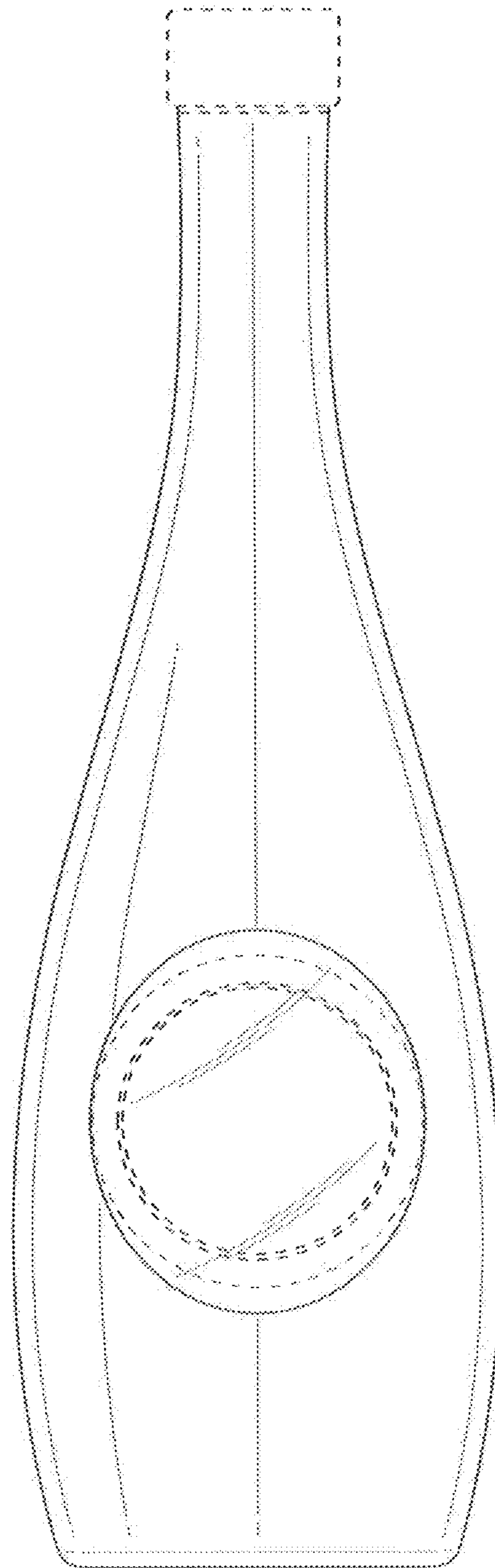

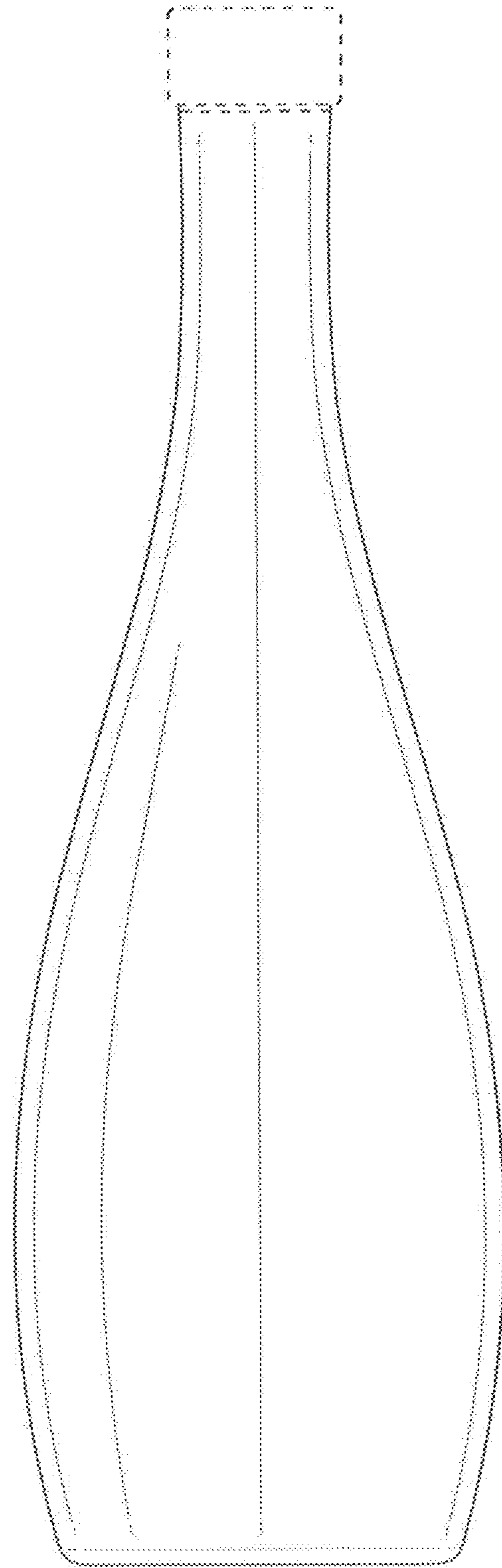

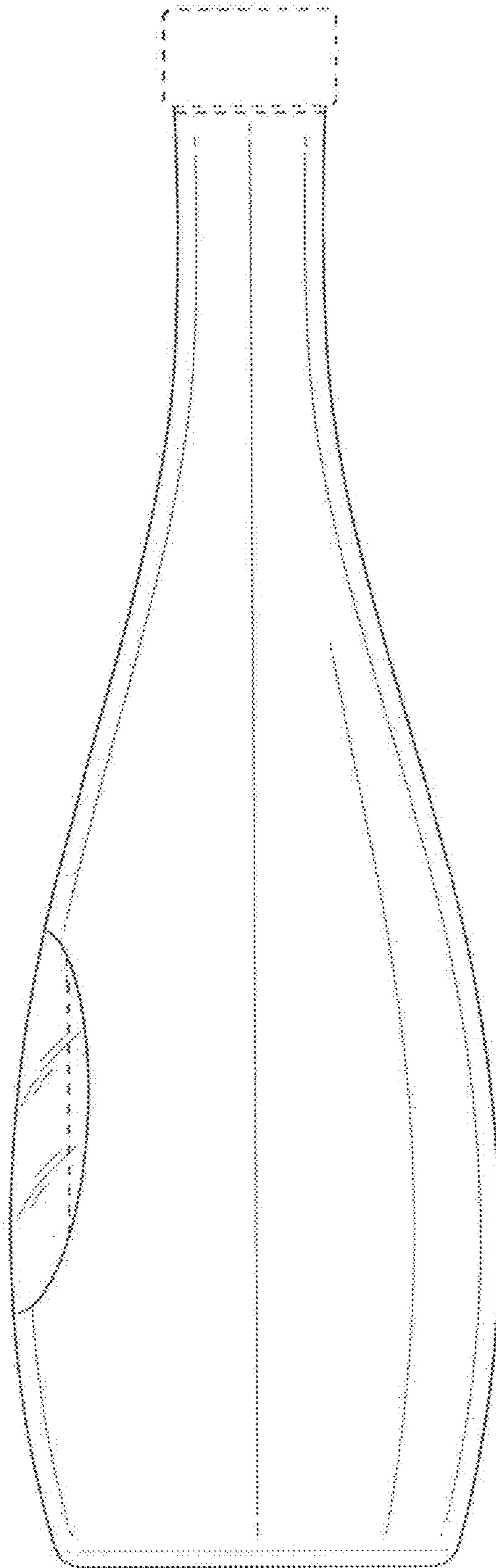

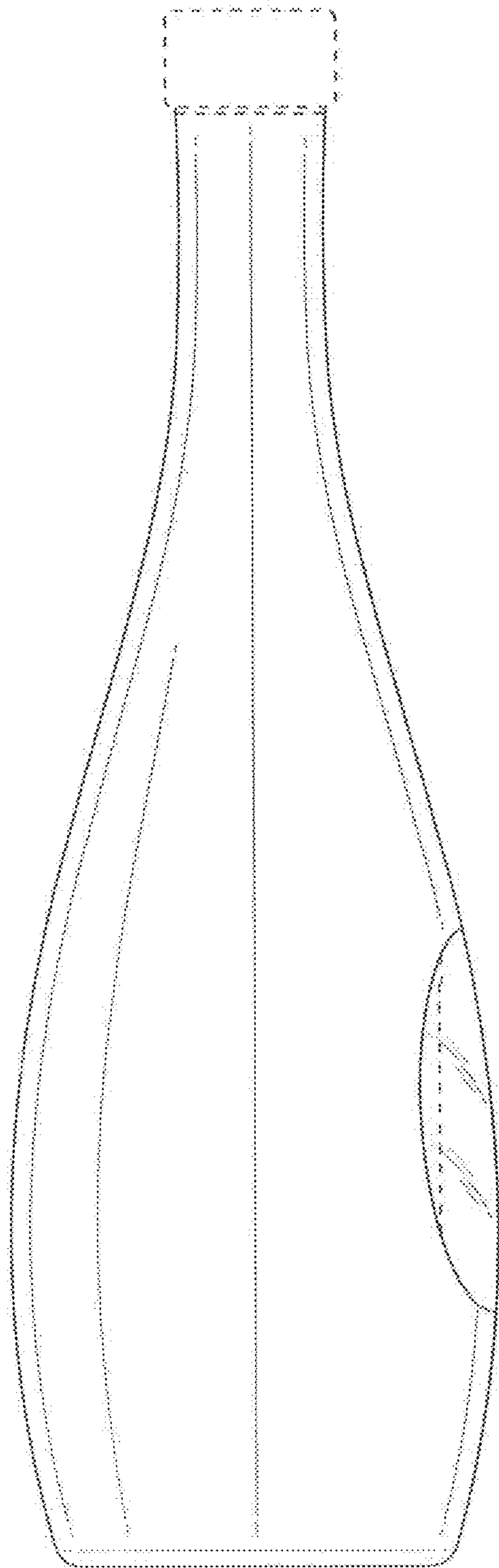

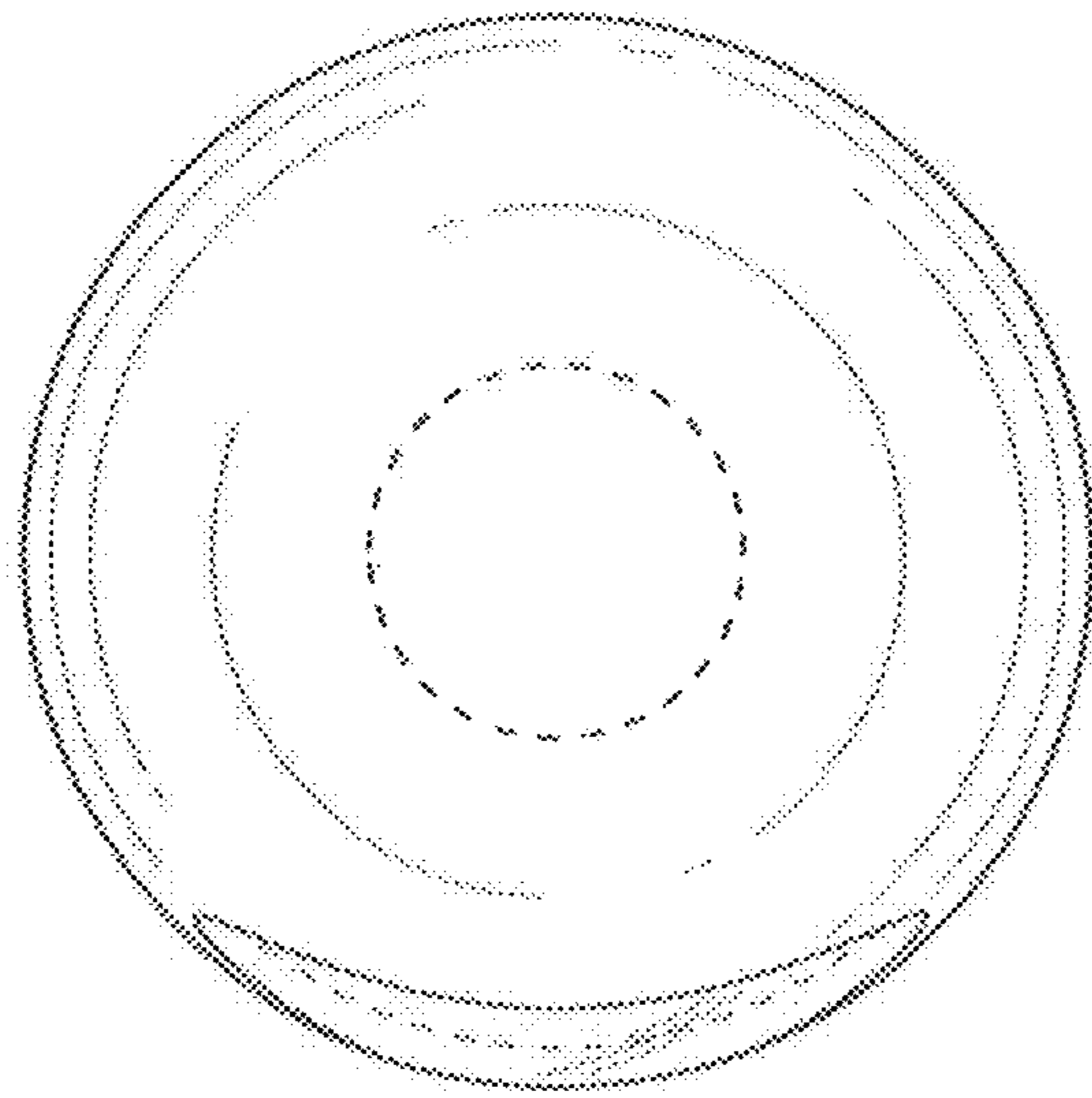

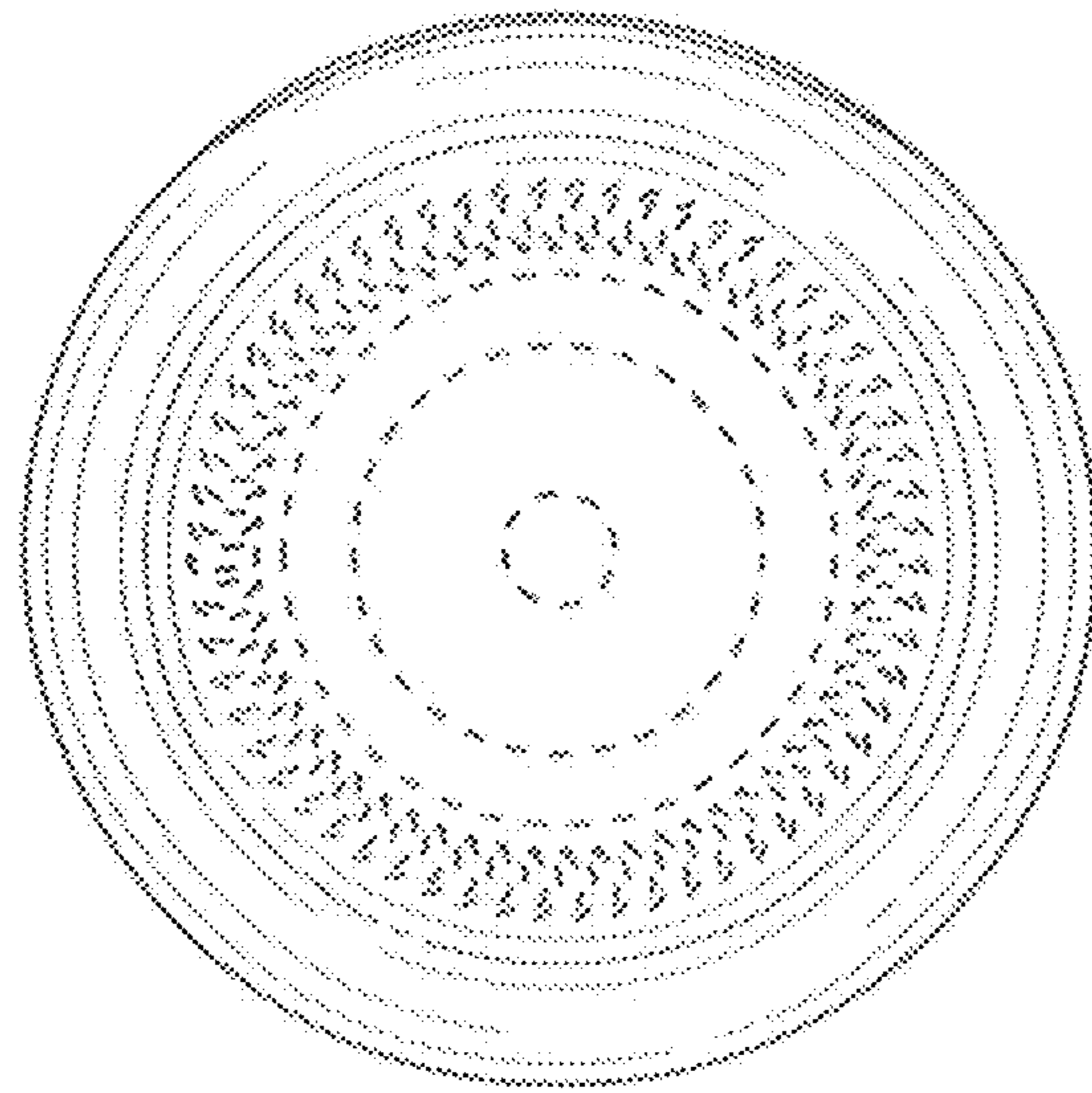
