FIG. 4 is a top view of the force measurement device of FIG. 1.

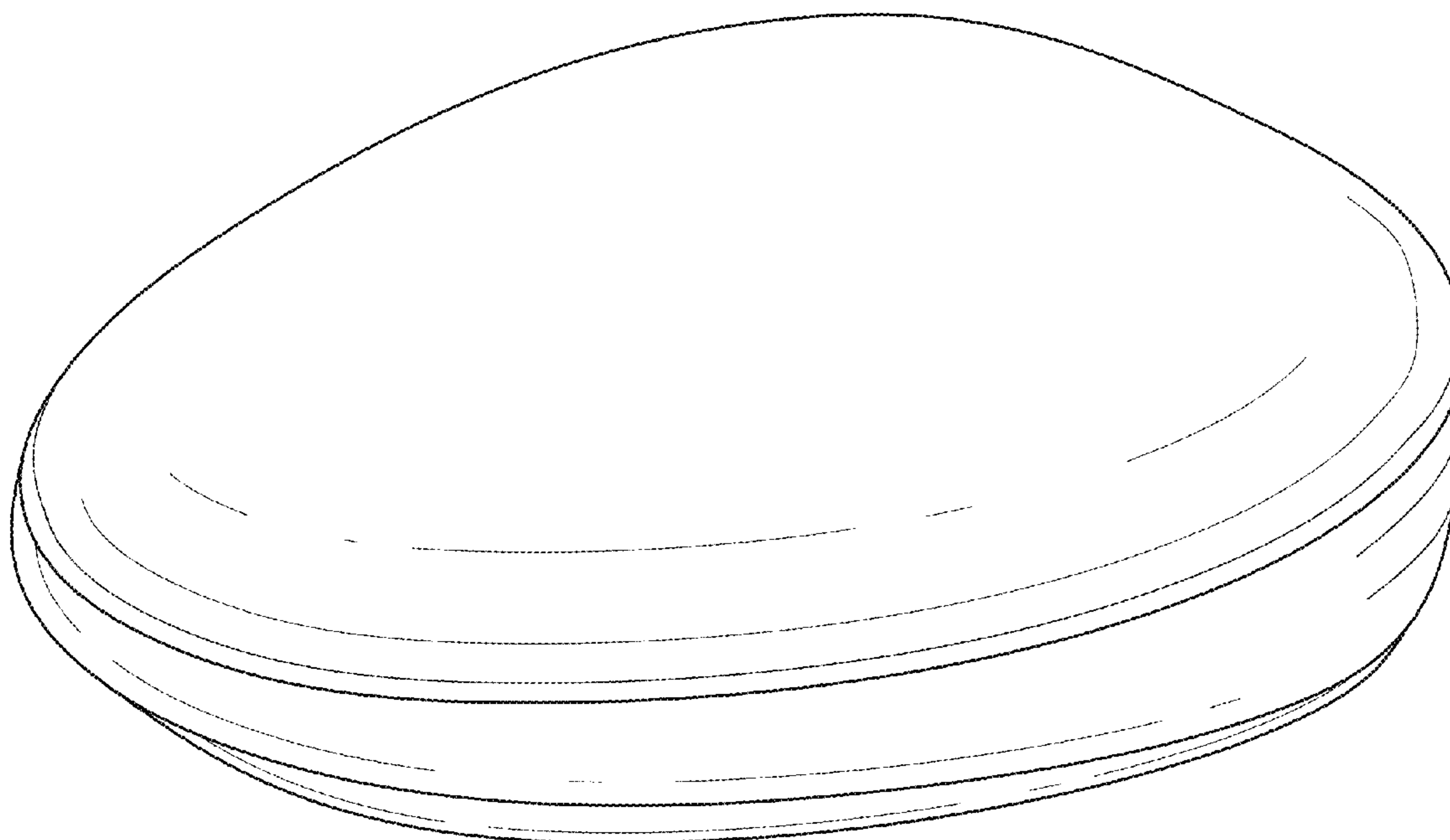
FIG. 5 is a bottom view of the force measurement device of FIG. 1.

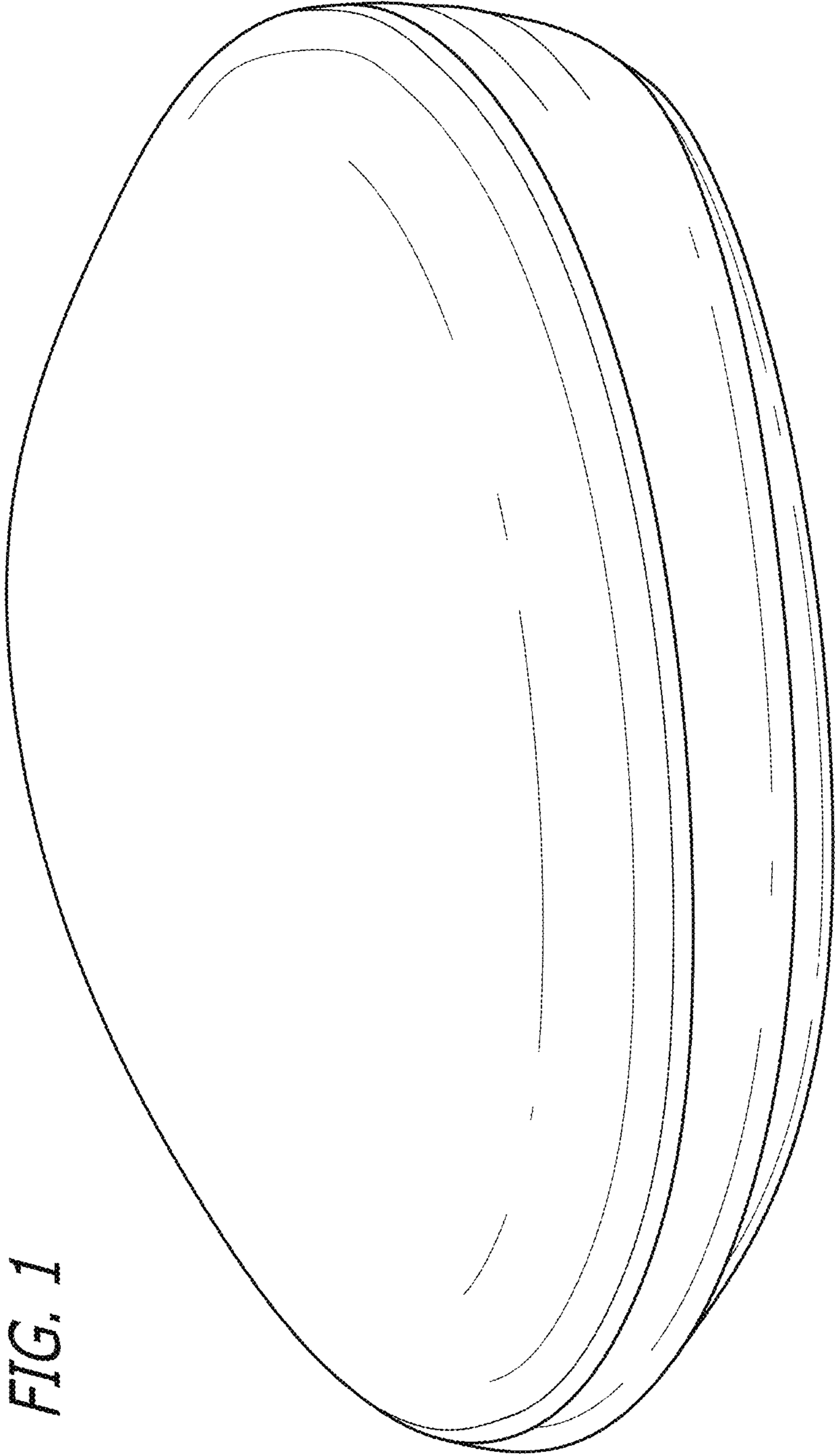

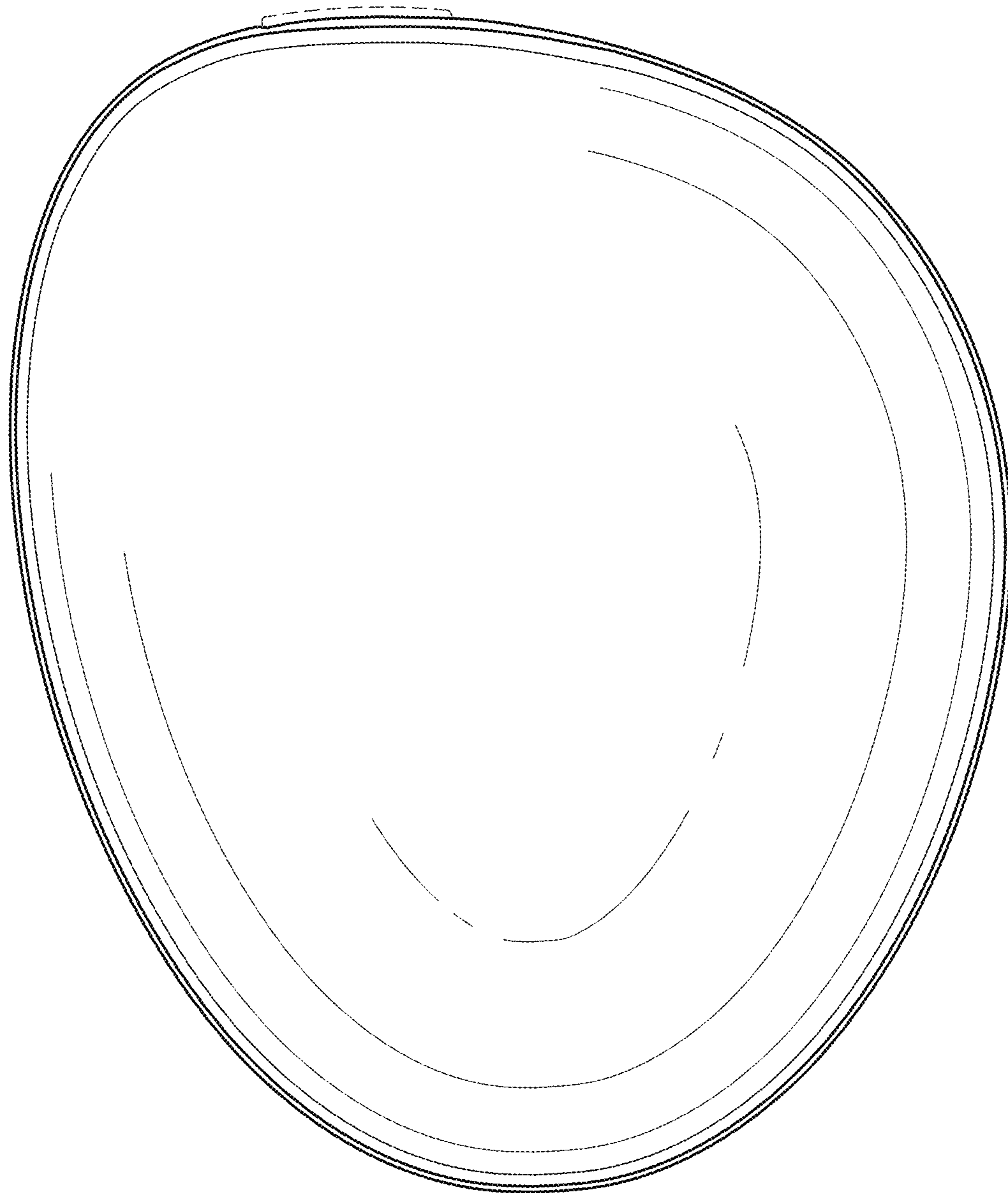

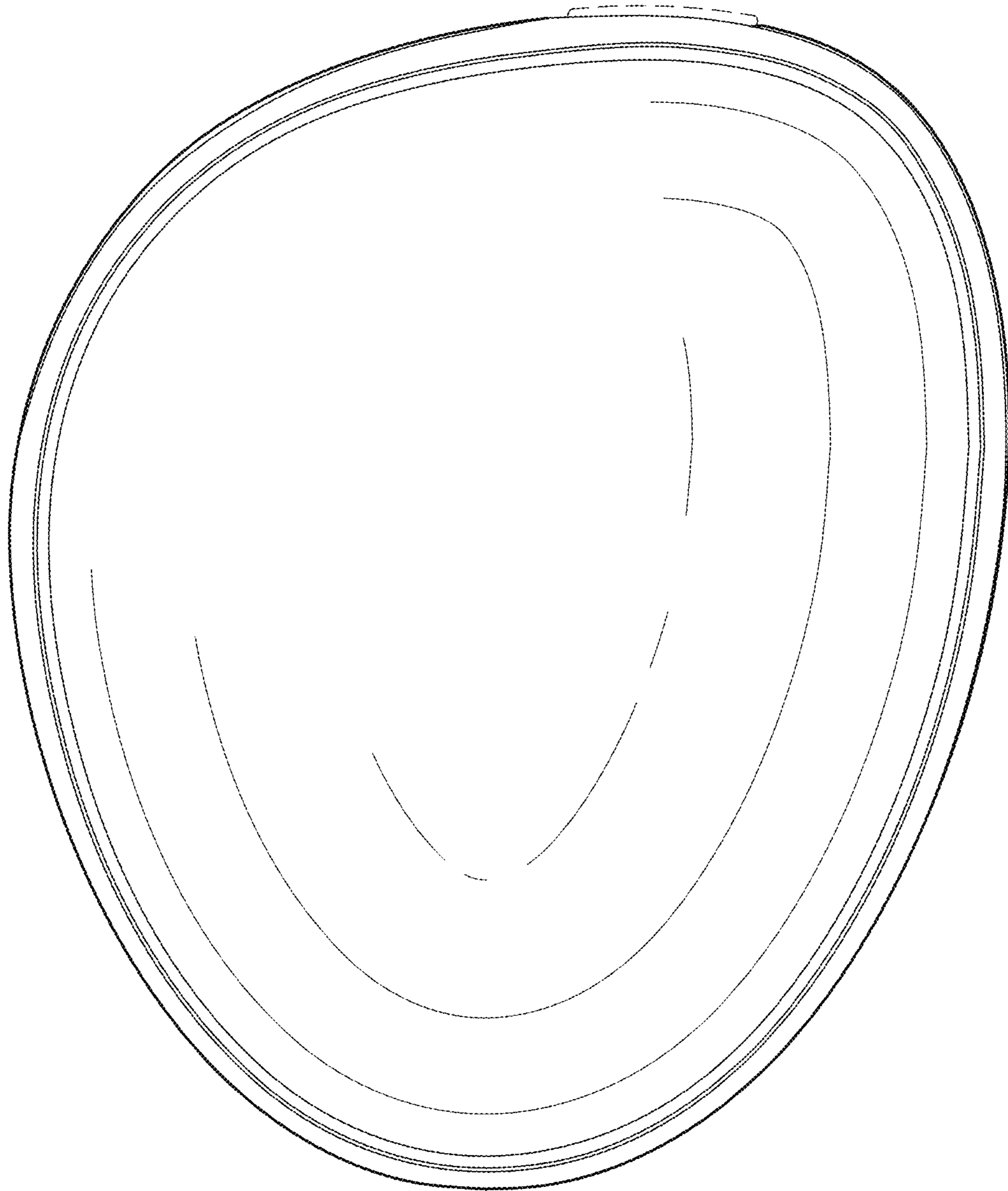

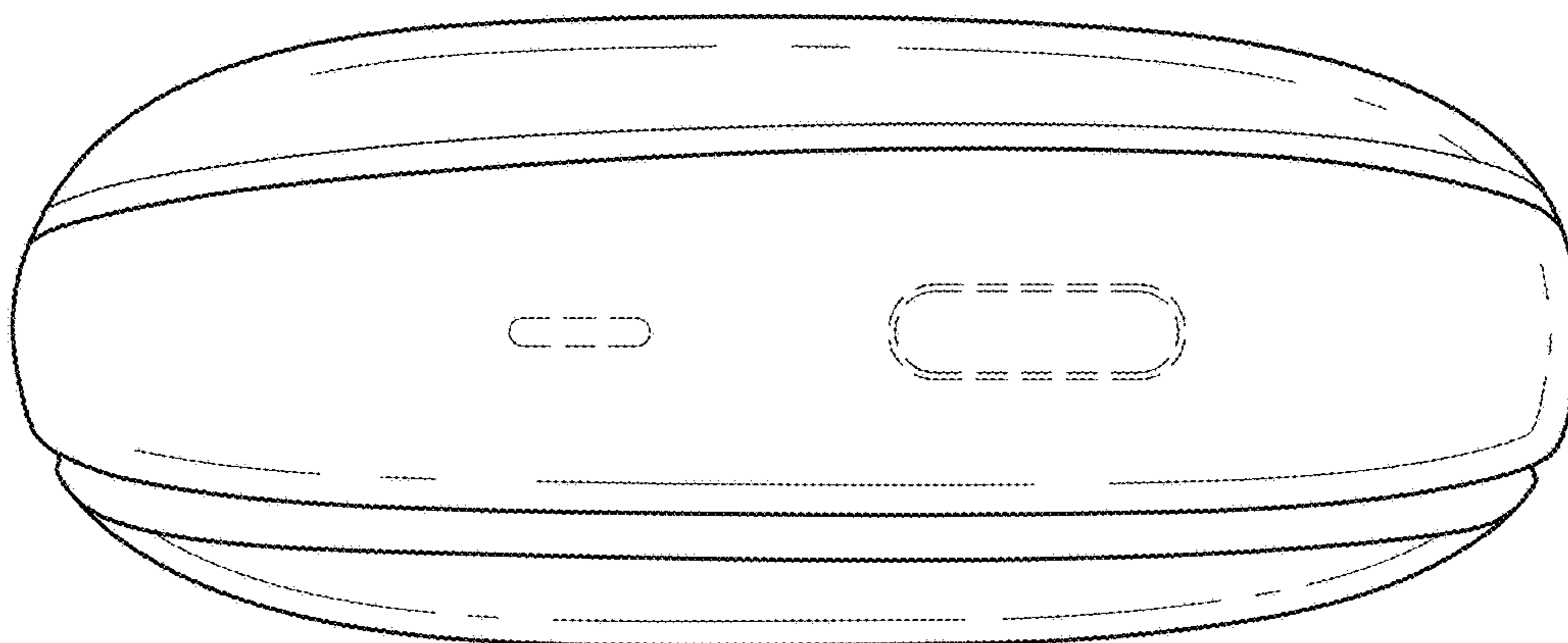

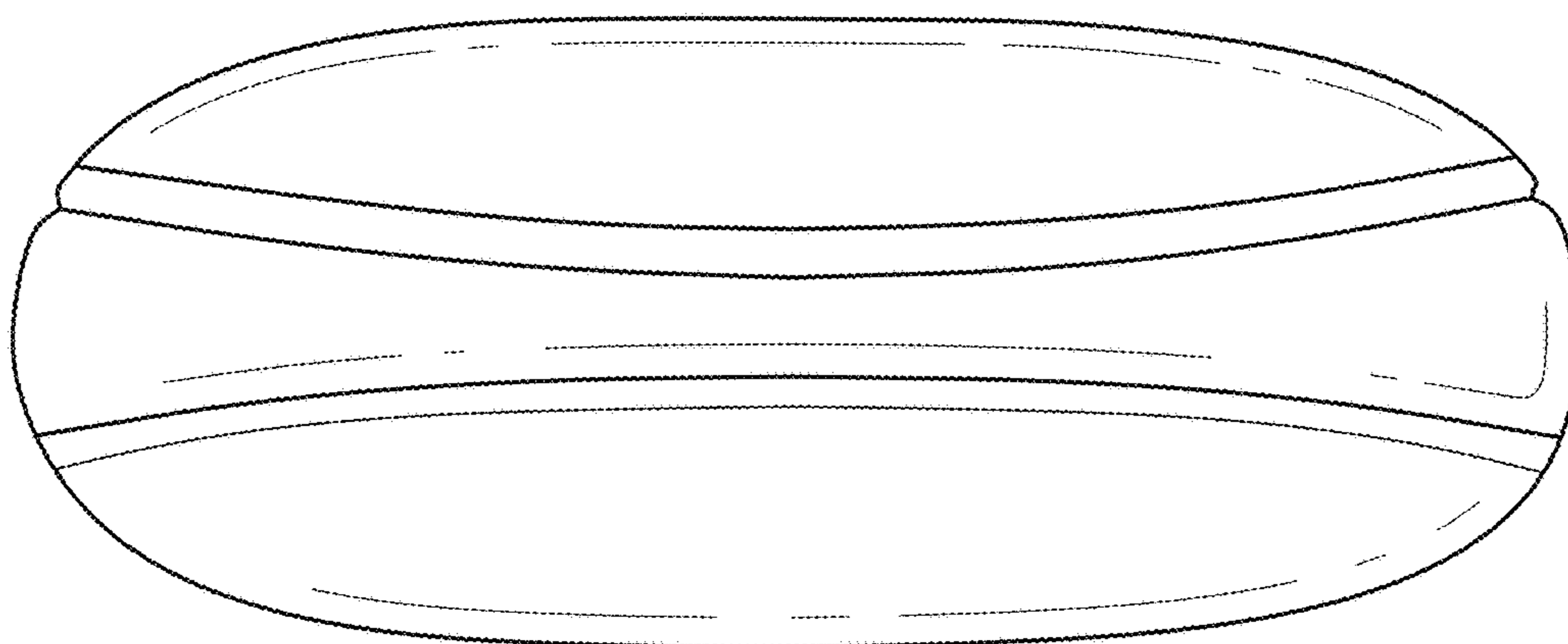

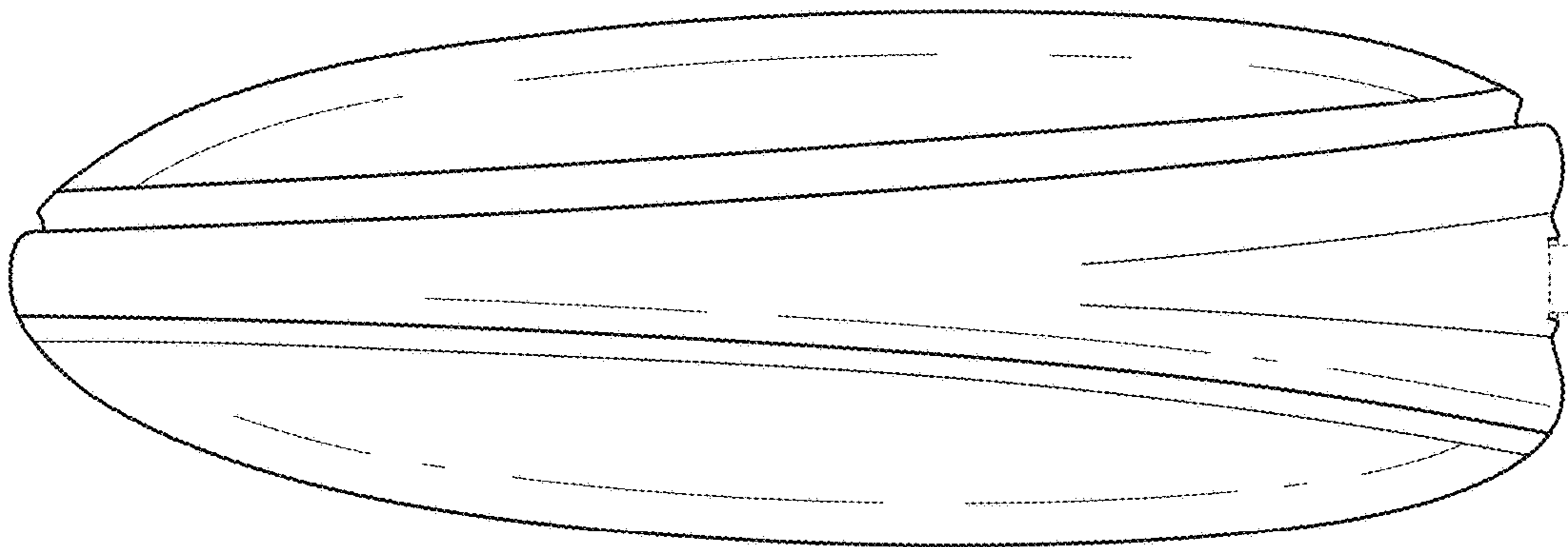

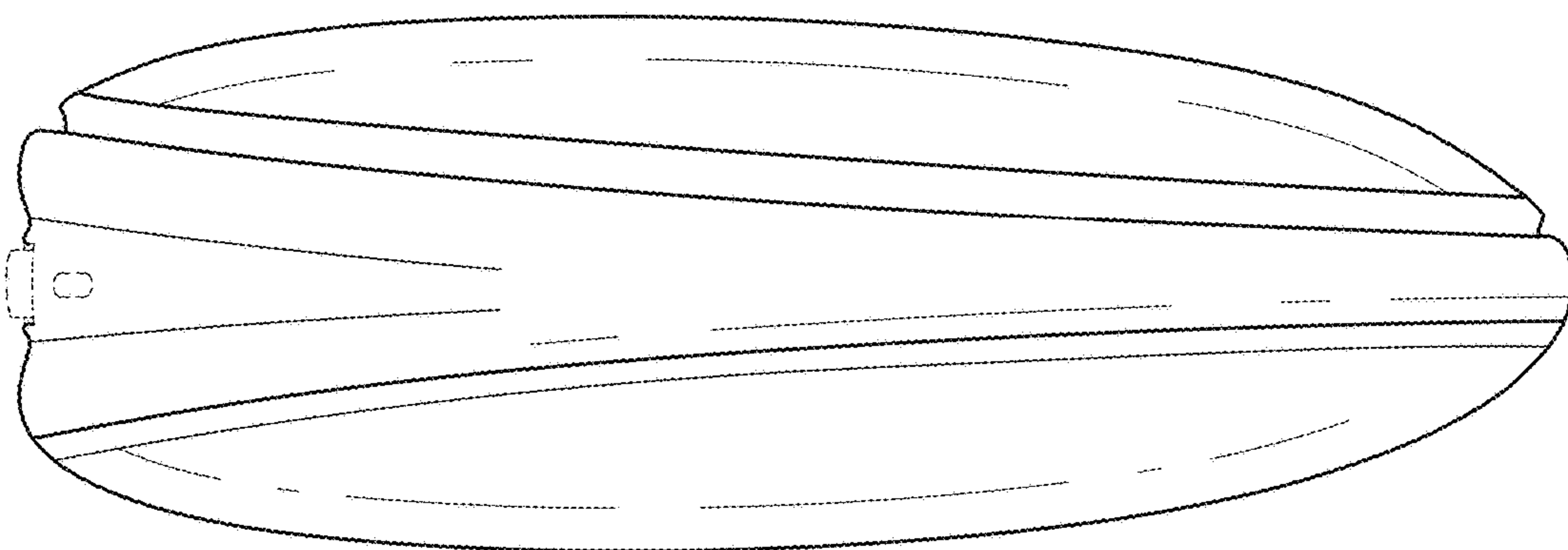
