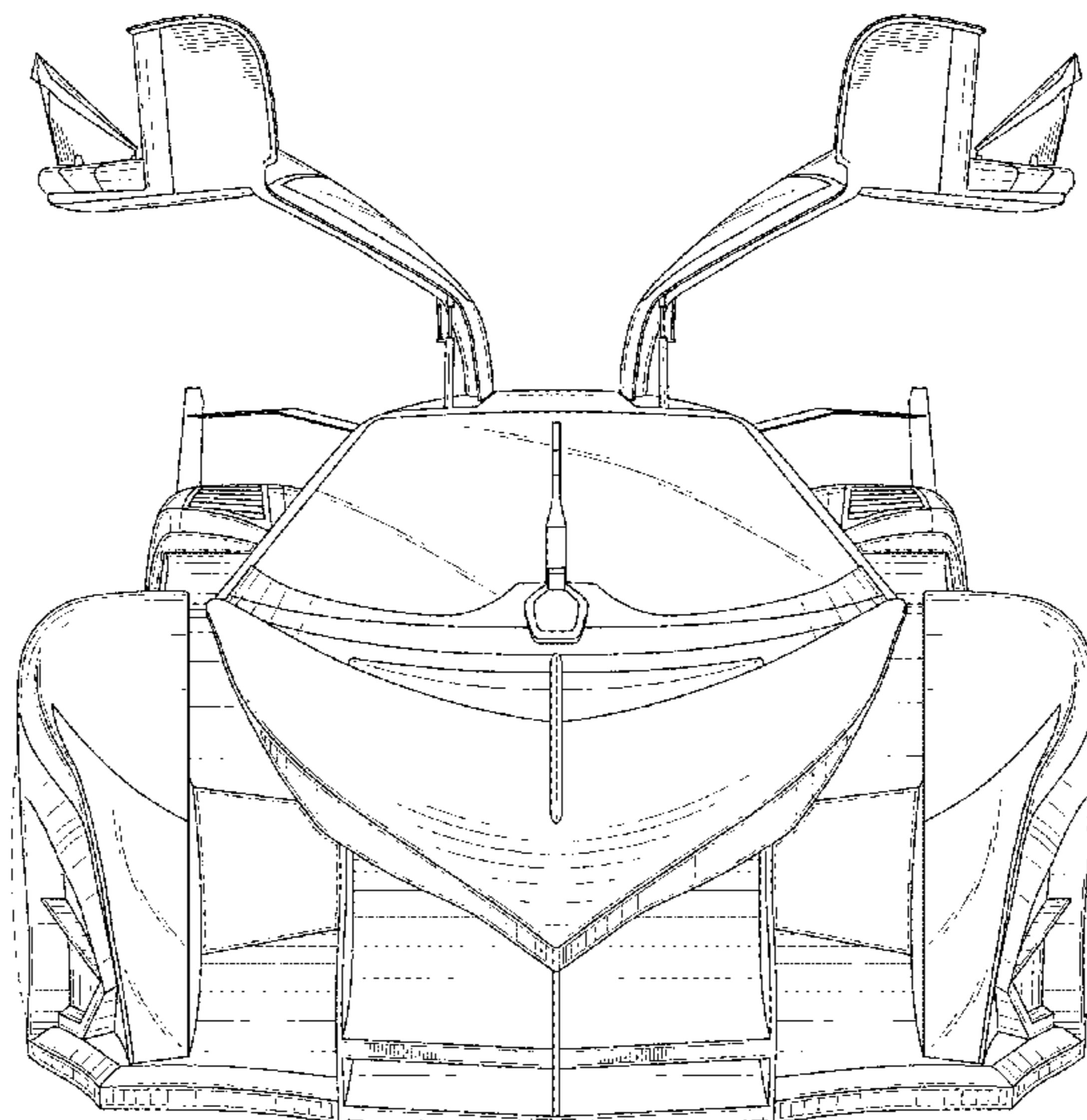
(57) **CLAIM**

The ornamental design for an automobile, toy replica and/or other replicas, as shown and described.

DESCRIPTION

FIG. 1 is a front and left side perspective view of an automobile, toy replica and/or other replicas showing my new design, the front and right side perspective view being a mirror image thereof;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a left side elevational view thereof, the right side elevational being a mirror image thereof;
FIG. 4 is a top and front perspective view thereof;
FIG. 5 is a top and rear perspective view thereof;
FIG. 6 is front elevational view thereof with the doors in open position; and,
FIG. 7 is another top and front perspective view thereof with the doors in open position.

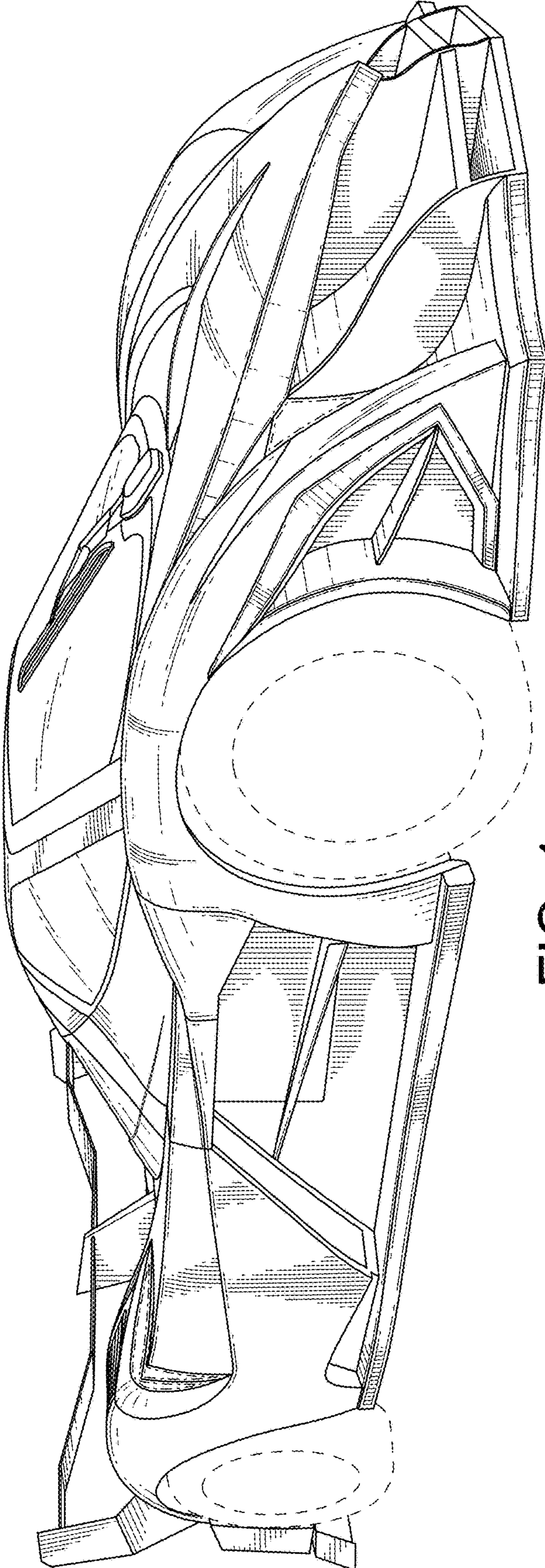

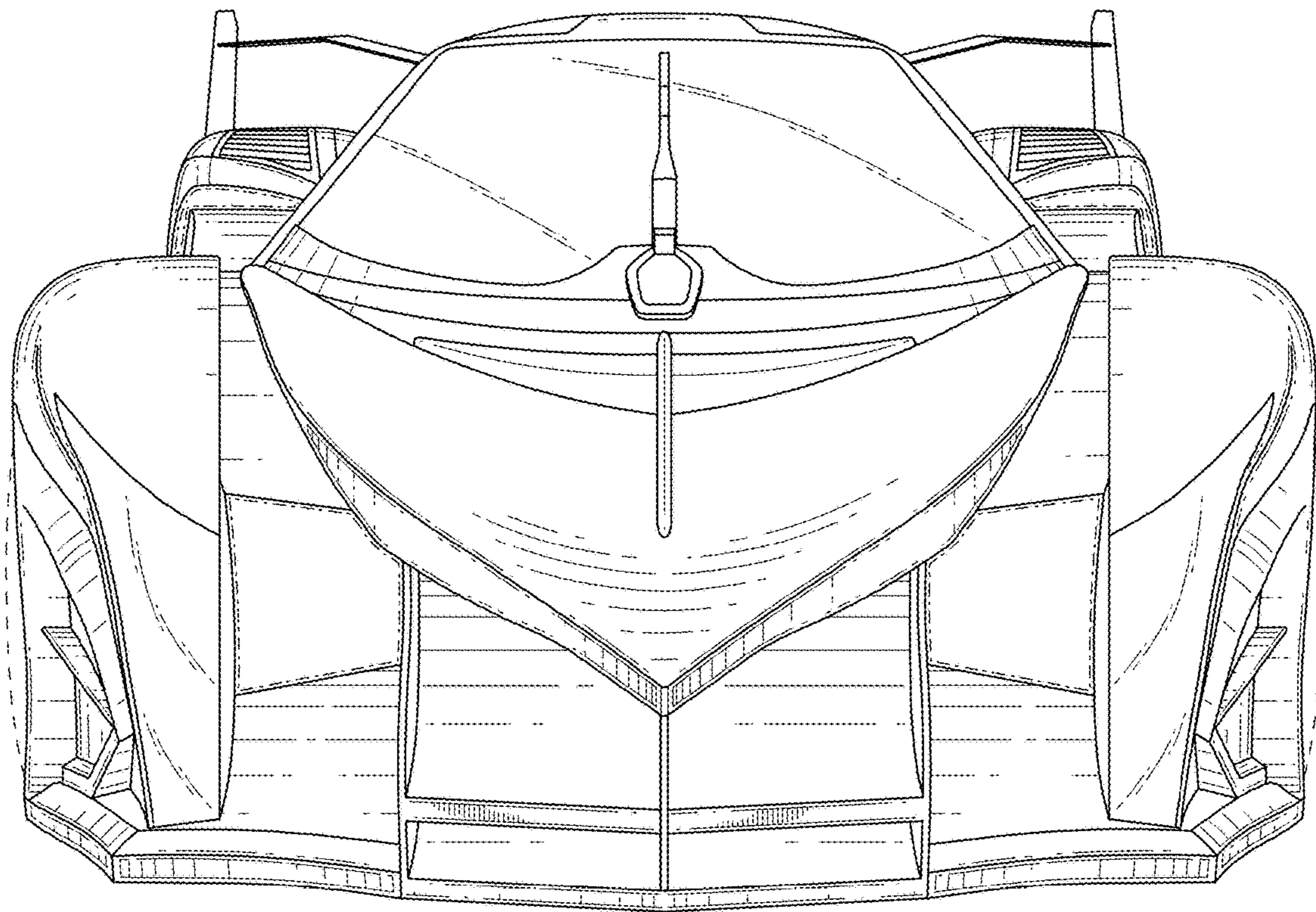

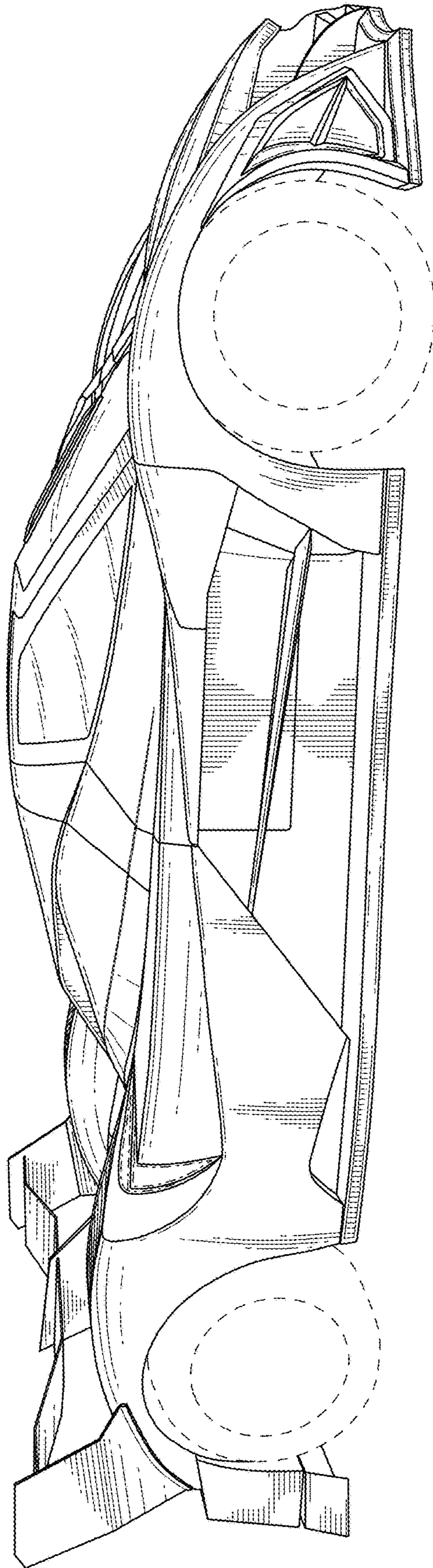

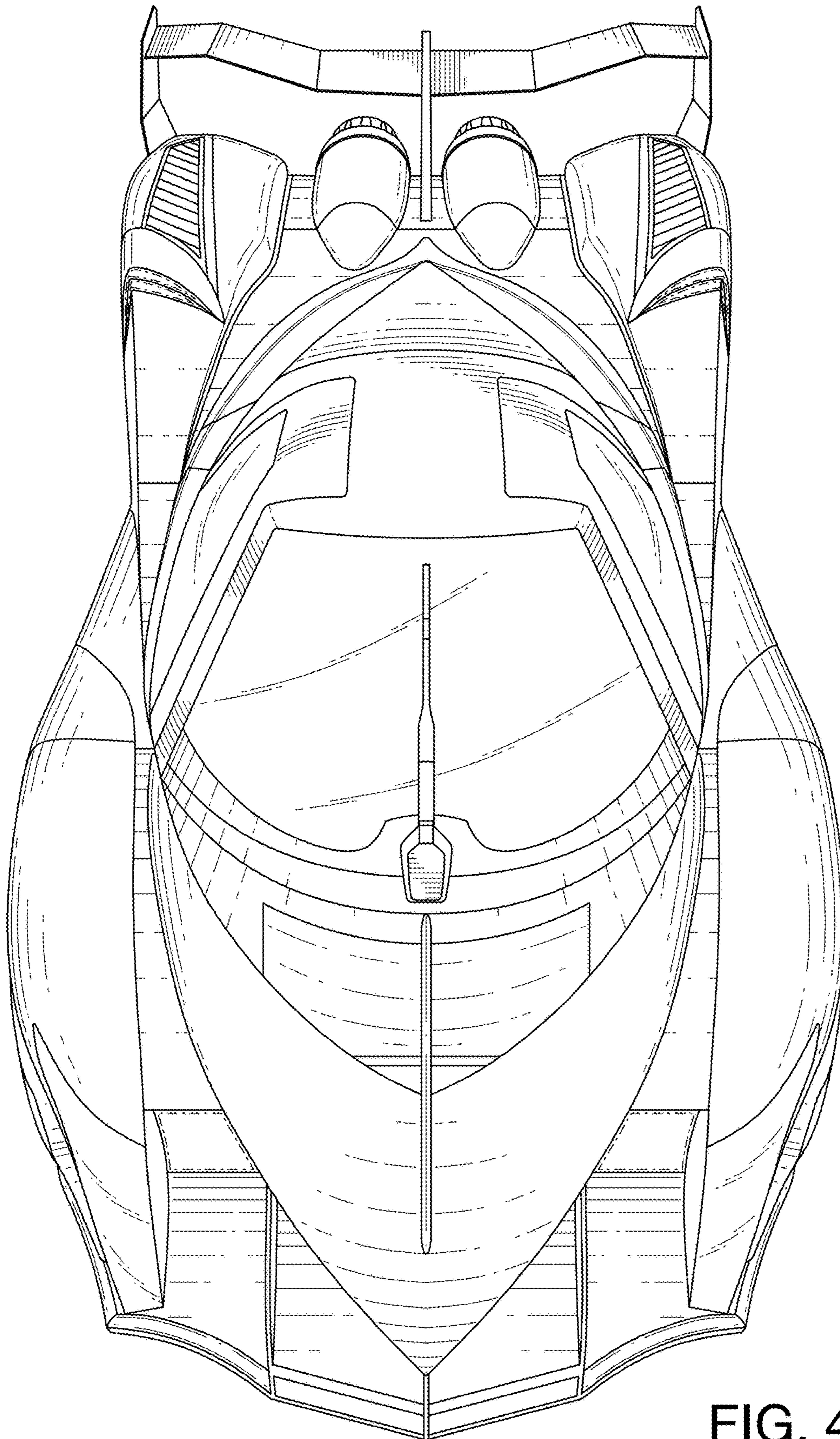

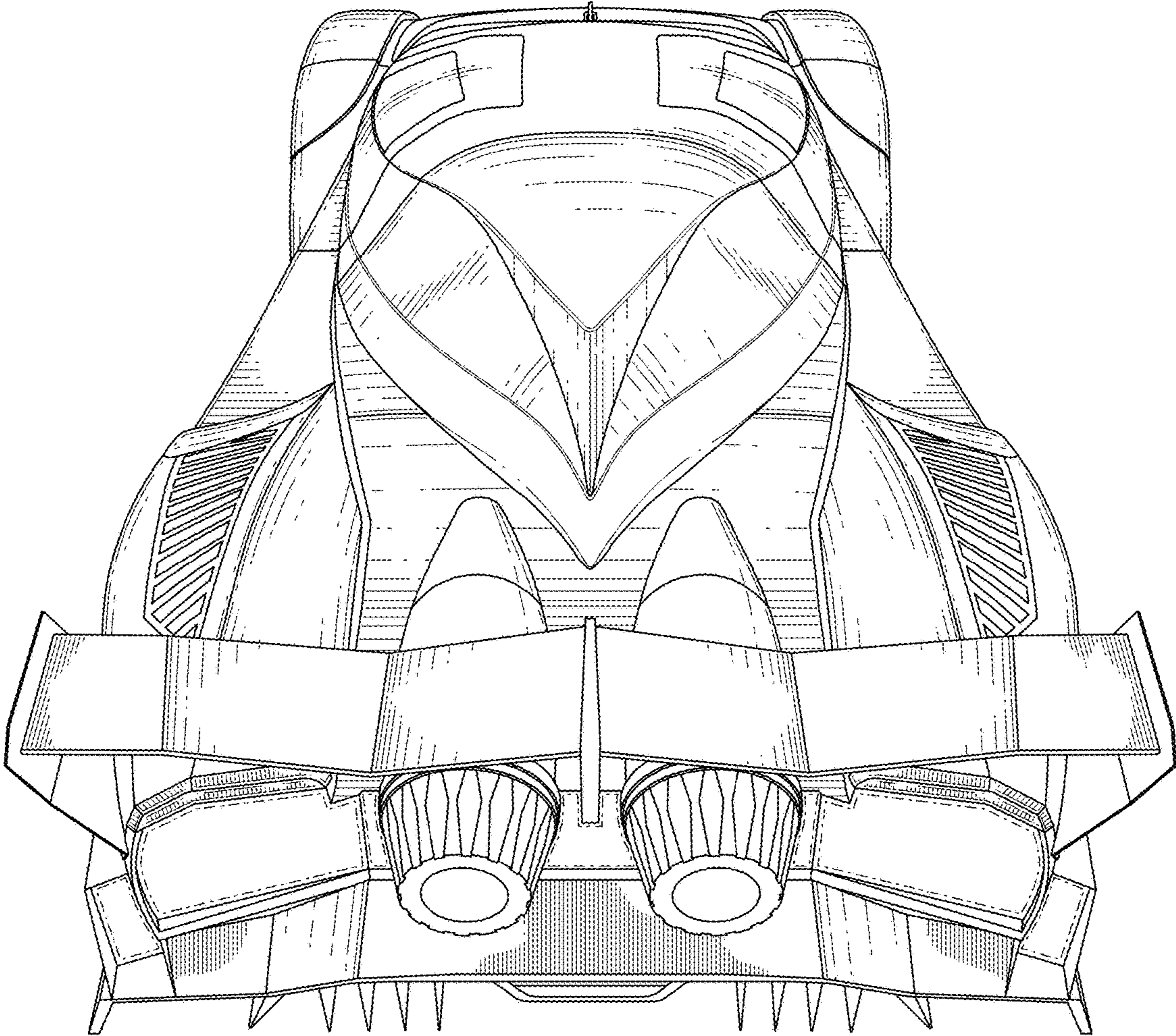

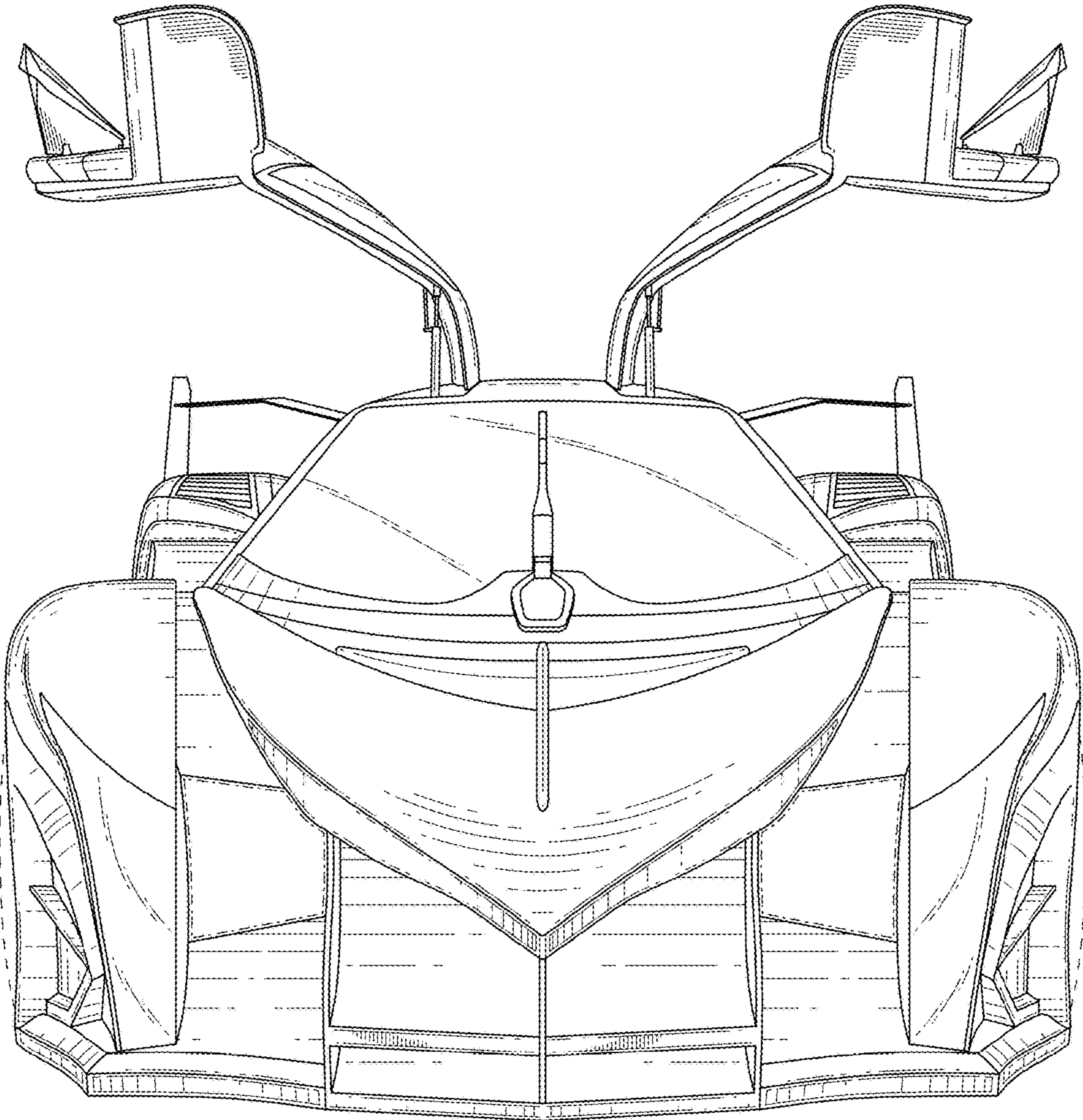

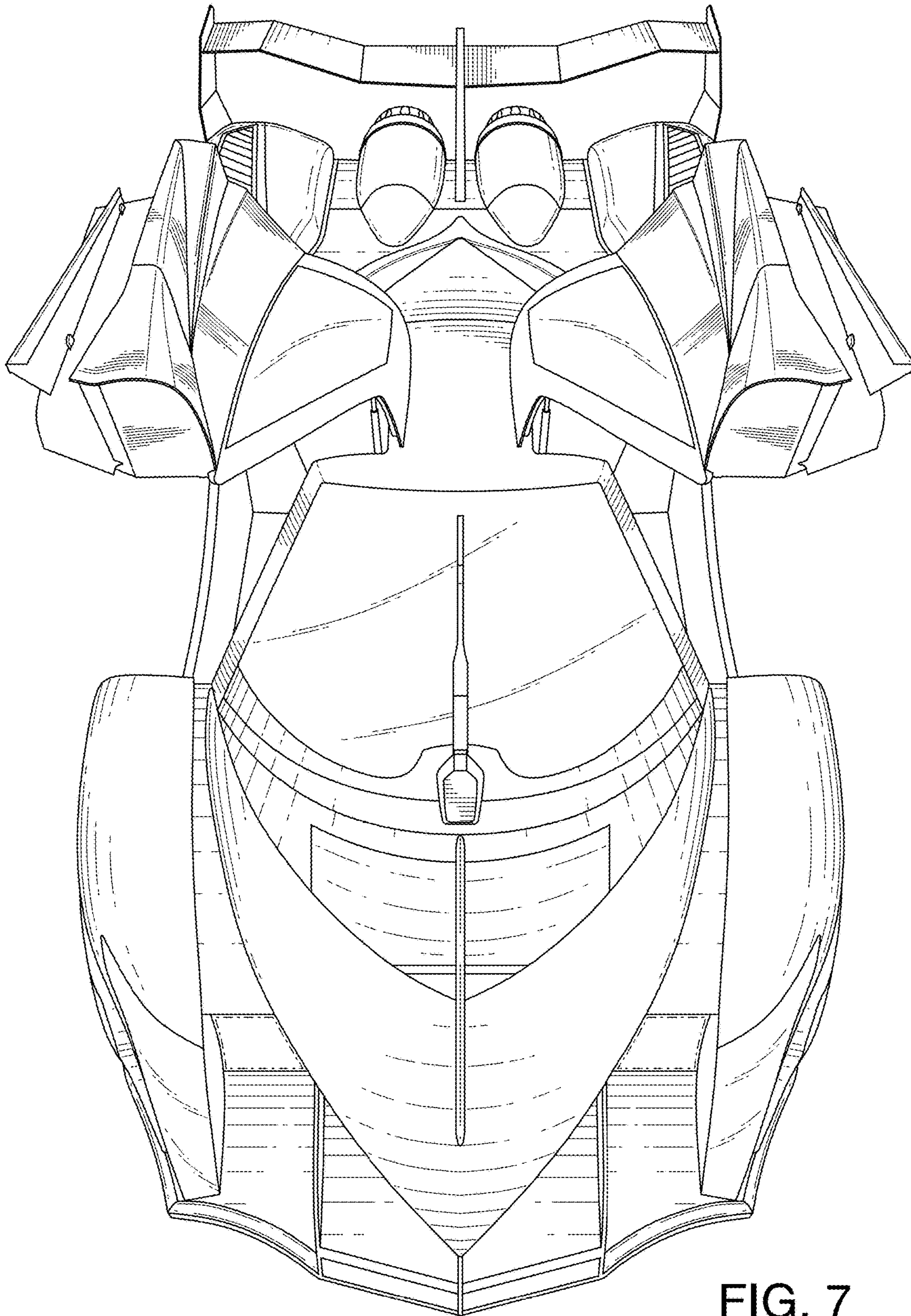
