(57) **CLAIM**

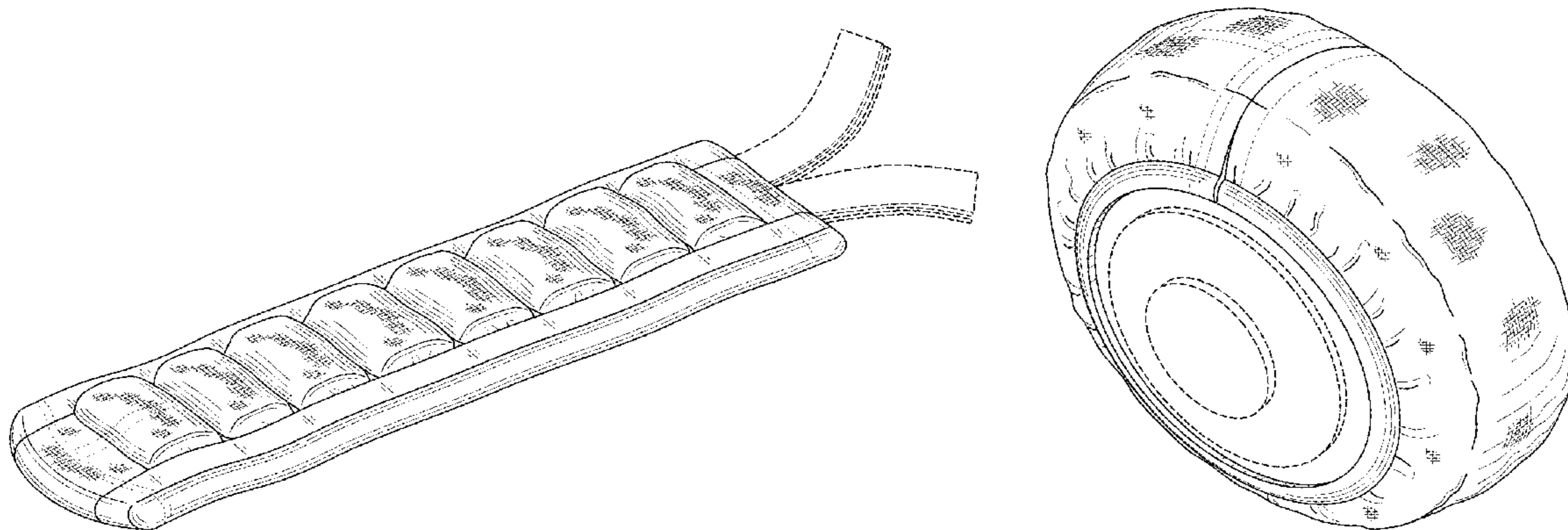
An ornamental design for a removable caster cover, substantially as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a removable caster cover, showing my new design;
 FIG. 2 is a top view thereof, showing an exterior side;
 FIG. 3 is a bottom view thereof, showing an interior side;
 FIG. 4 is a right side view thereof;
 FIG. 5 is a left side view thereof;
 FIG. 6 is a rear view thereof;
 FIG. 7 is a front view thereof;
 FIG. 8 is a perspective view thereof, in a curved configuration;
 FIG. 9 is a top perspective view there, in a curved configuration around a caster;
 FIG. 10 is a top view thereof, the bottom view being identical;
 FIG. 11 is a front view thereof; and,
 FIG. 12 is a left side view thereof, the right side being identical.

The broken line showing is included for the purpose of illustrating unclaimed subject matter and forms no part of the claimed design. The broken line showing of the caster in FIGS. 9-12 is included to illustrate environment and form no part of the claimed design.

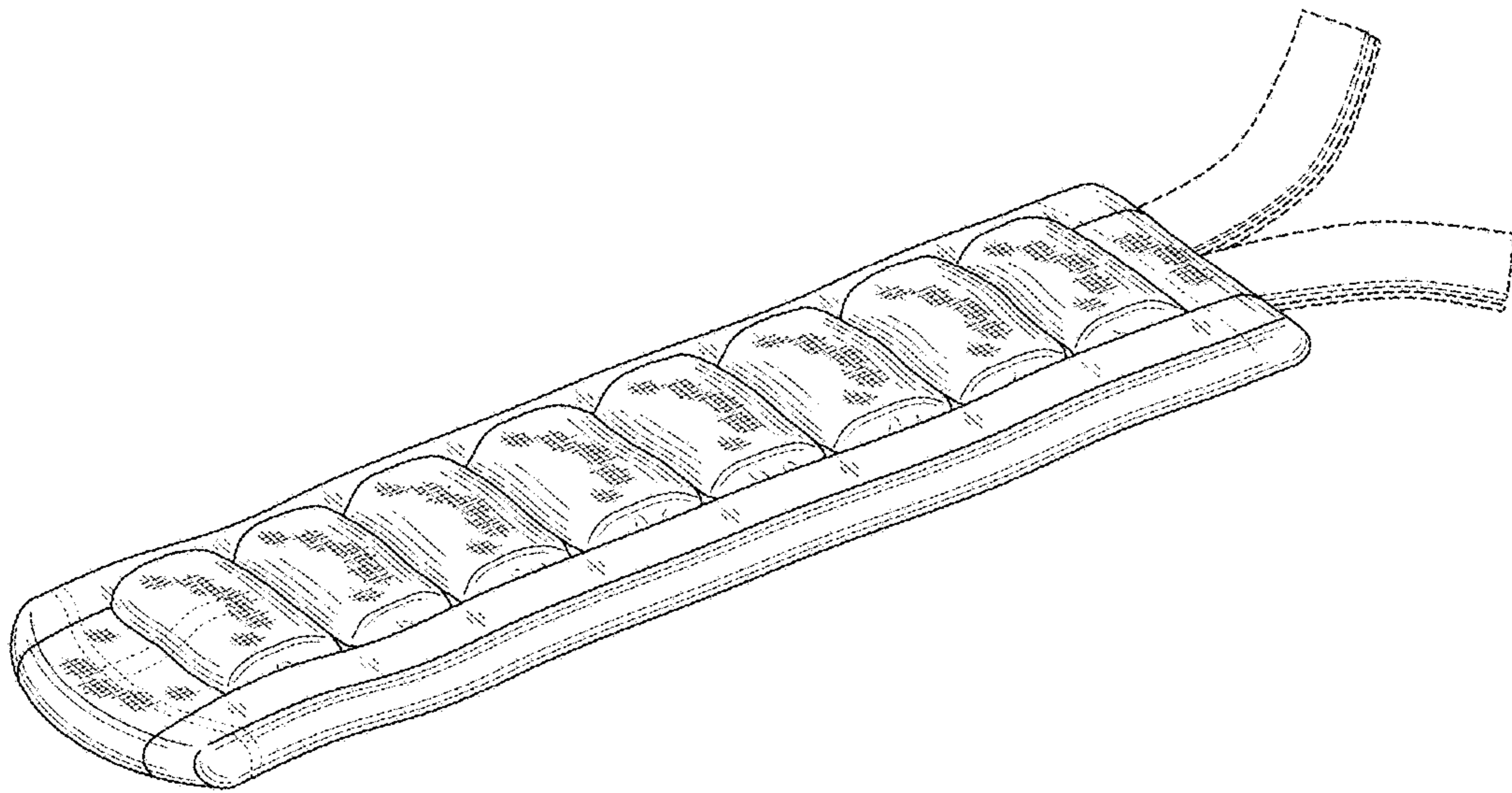

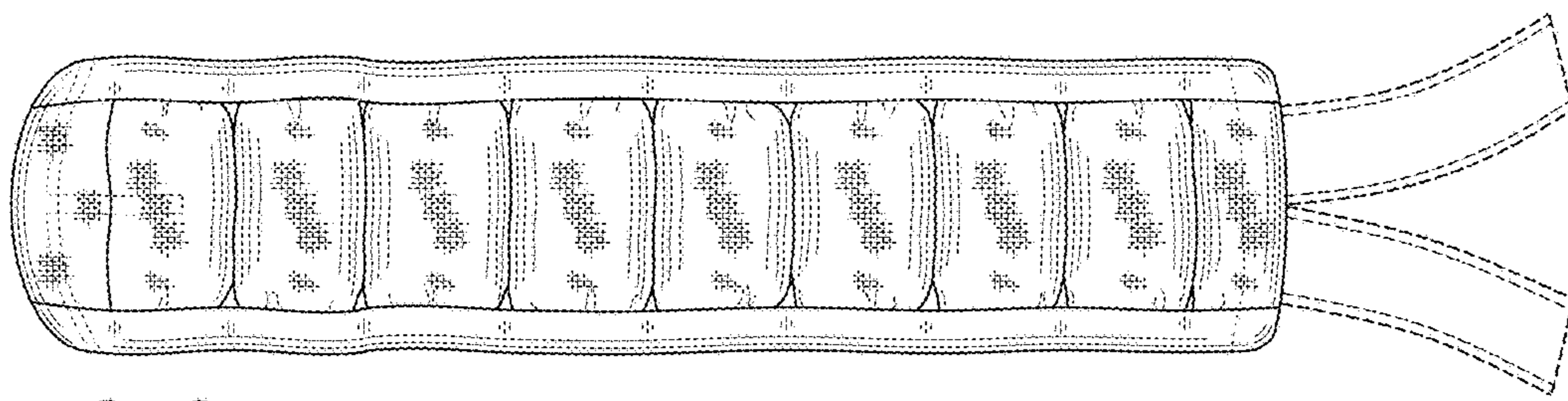

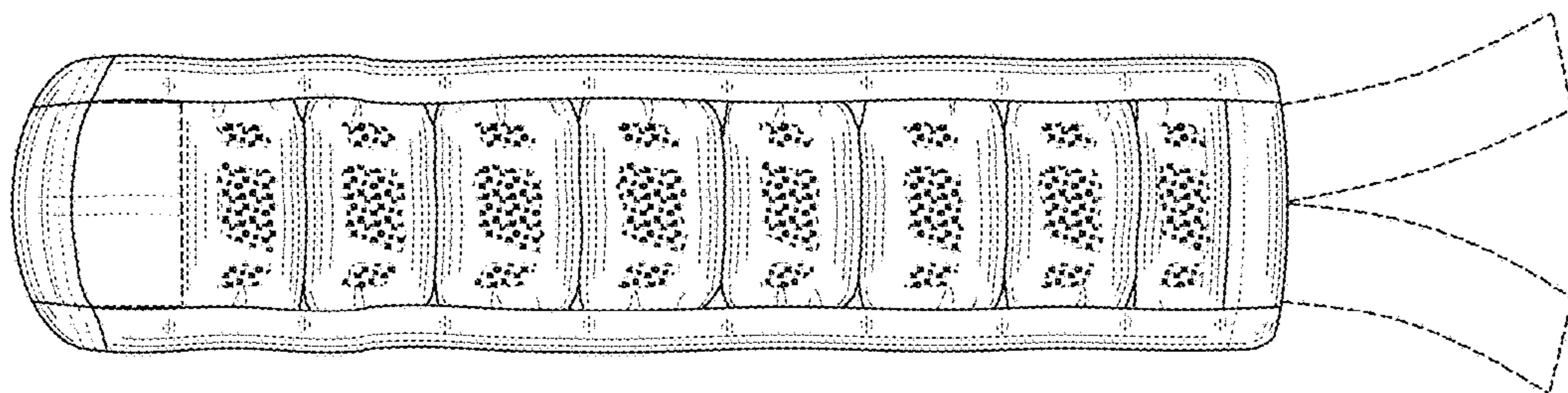

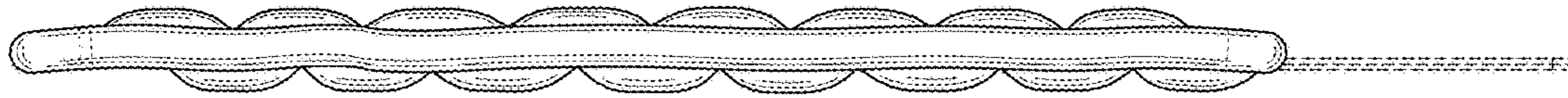

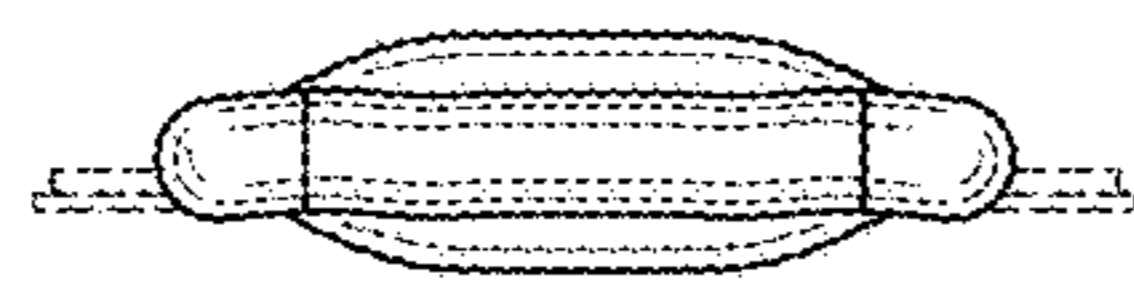

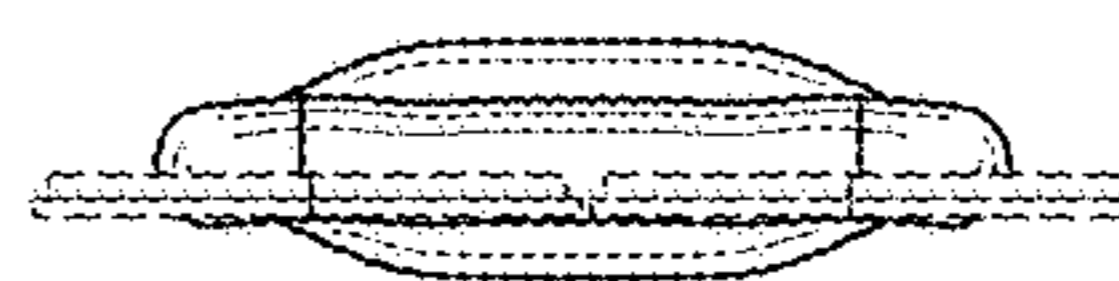

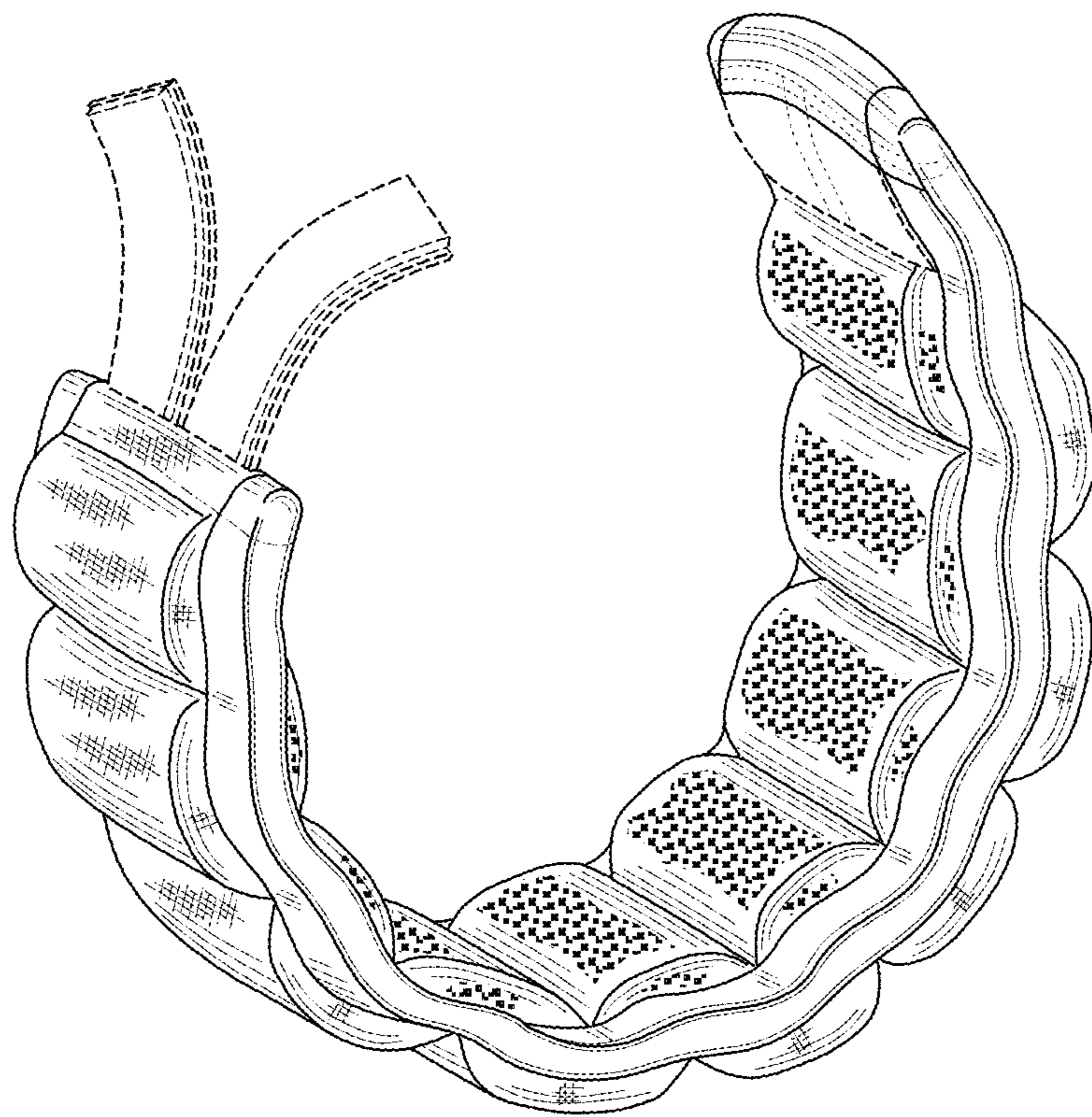

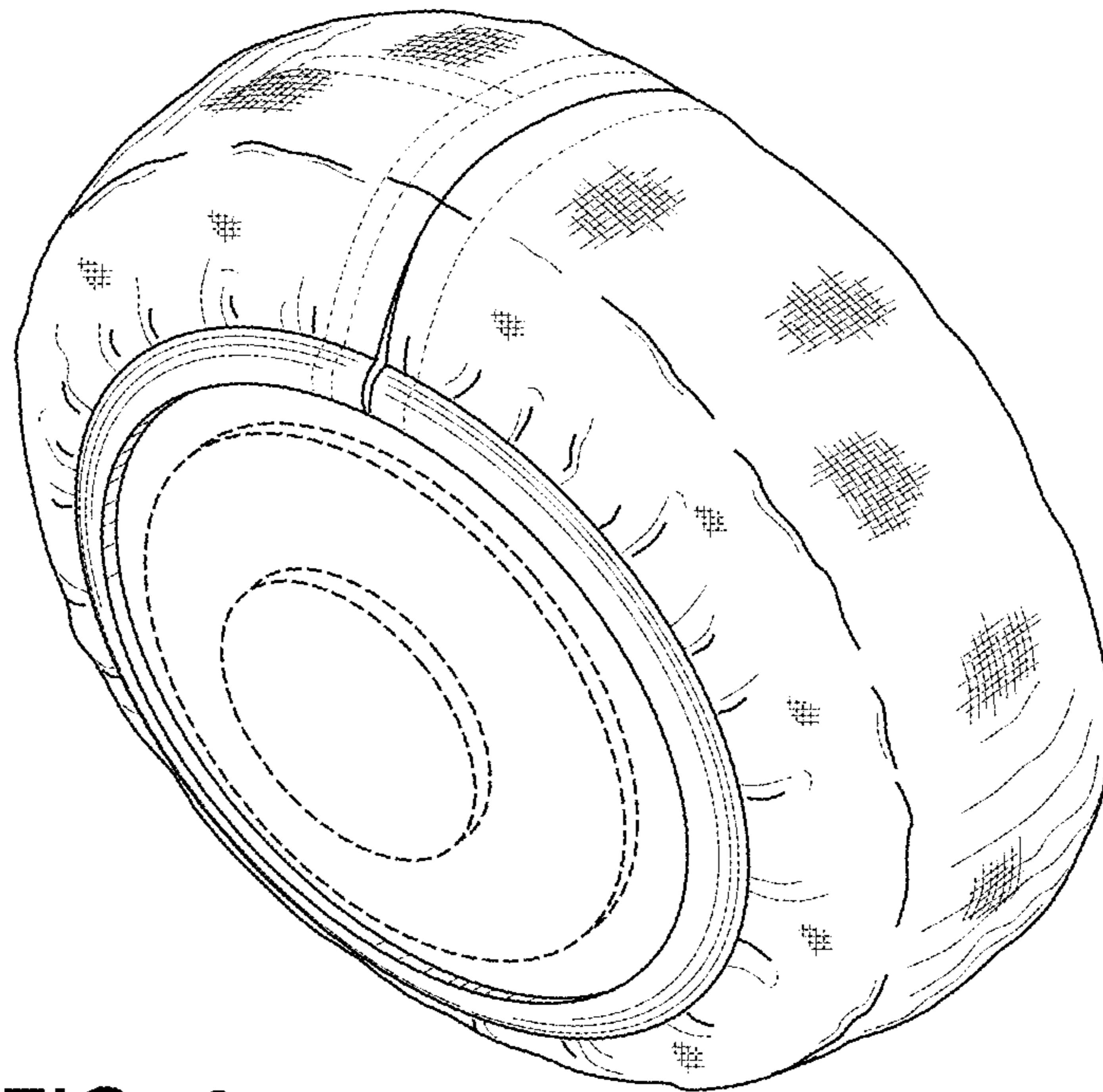

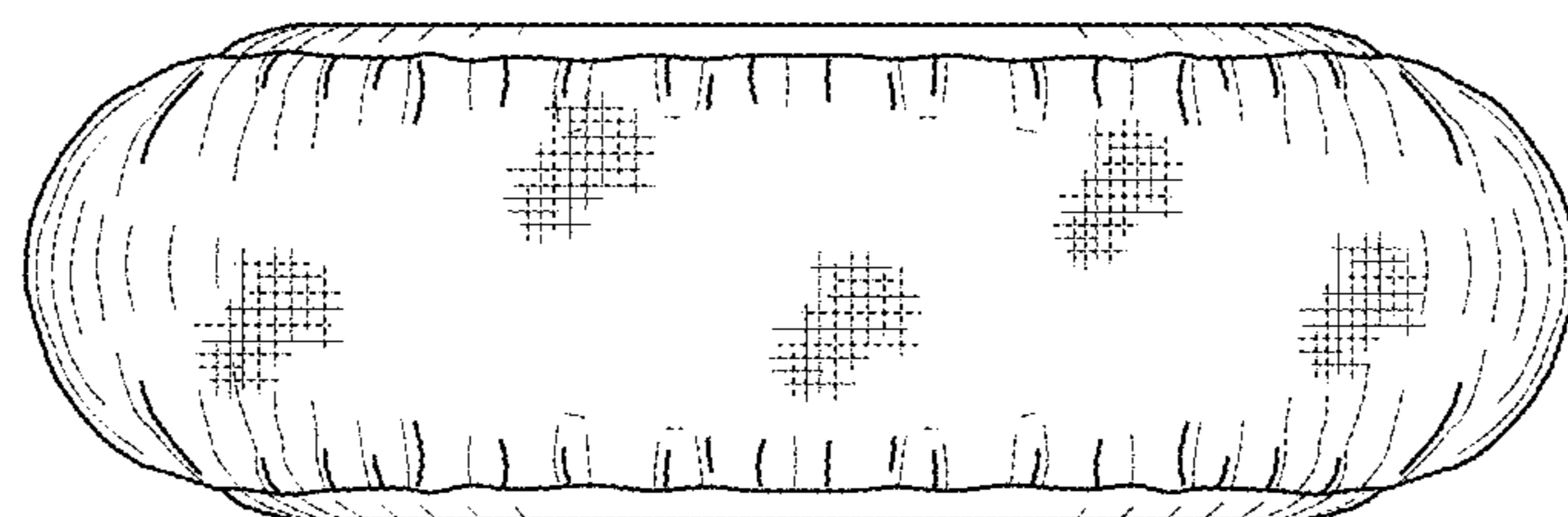

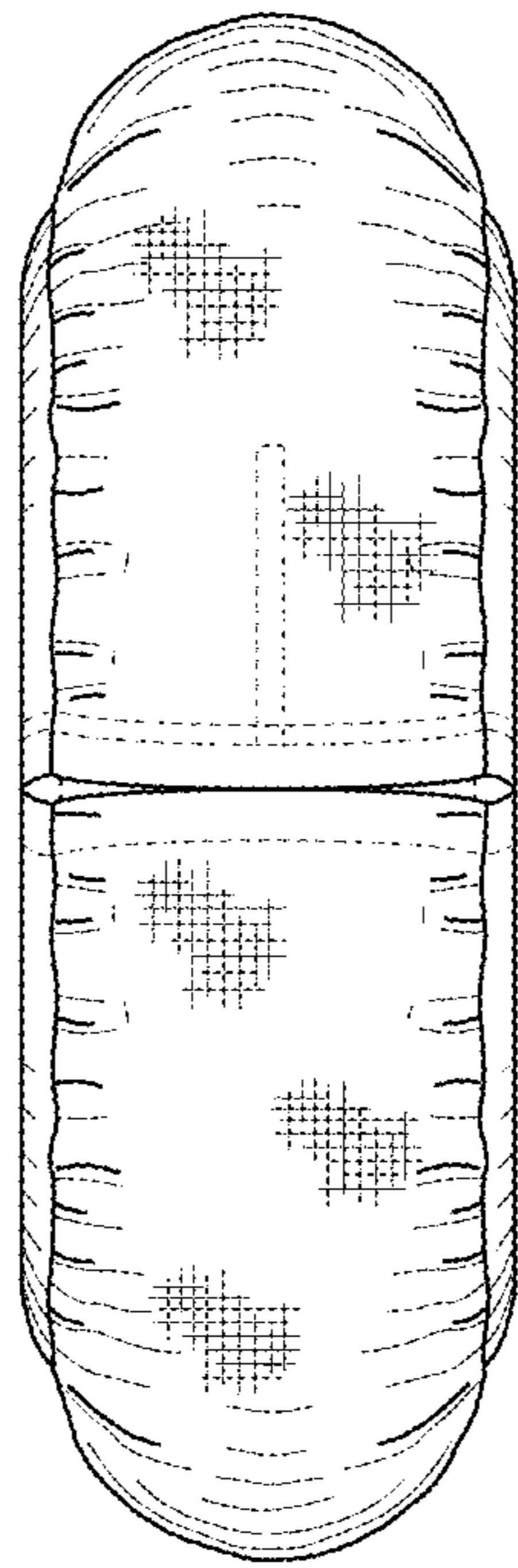

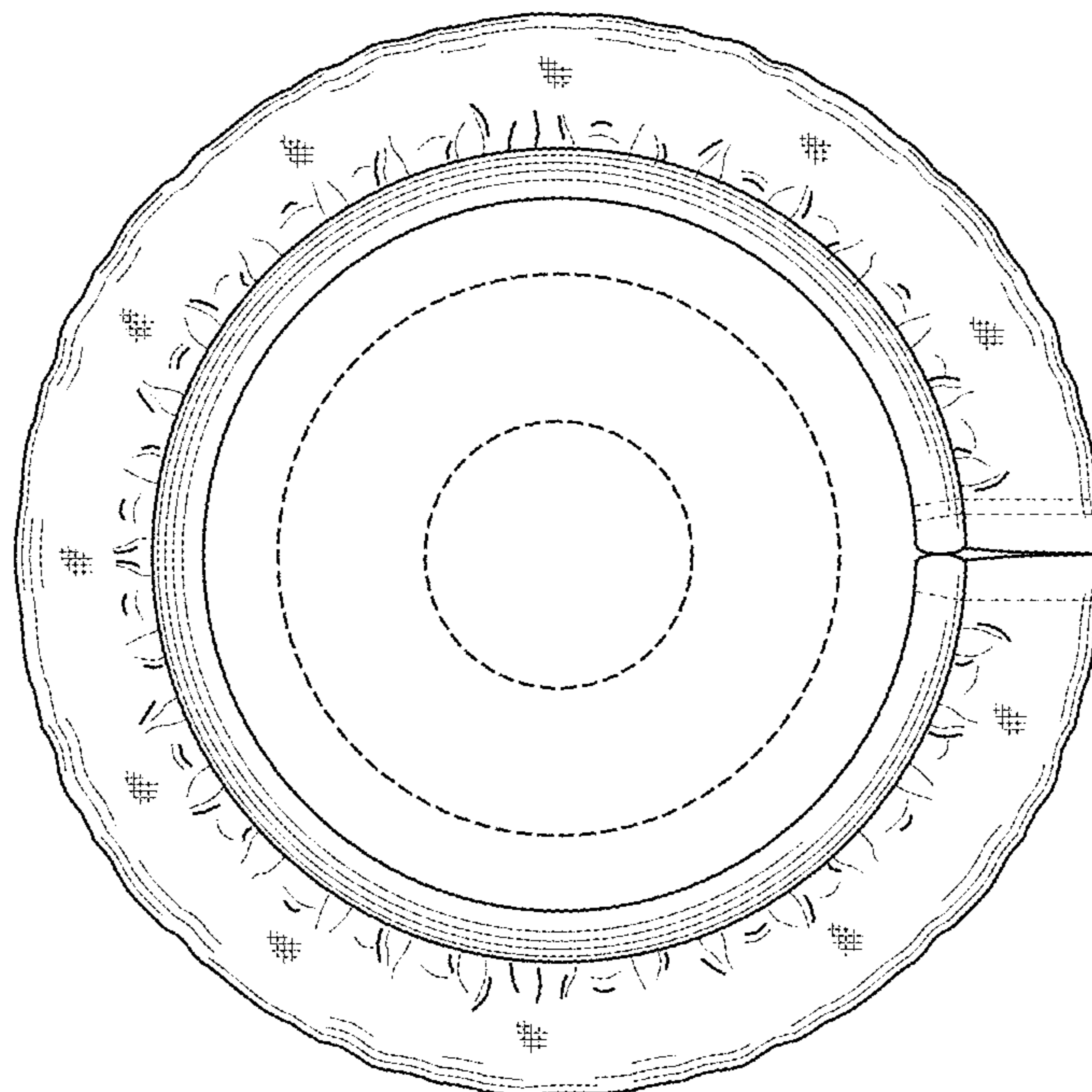
