(57) **CLAIM**

The ornamental design for a display screen with graphical user interface, as shown and described.

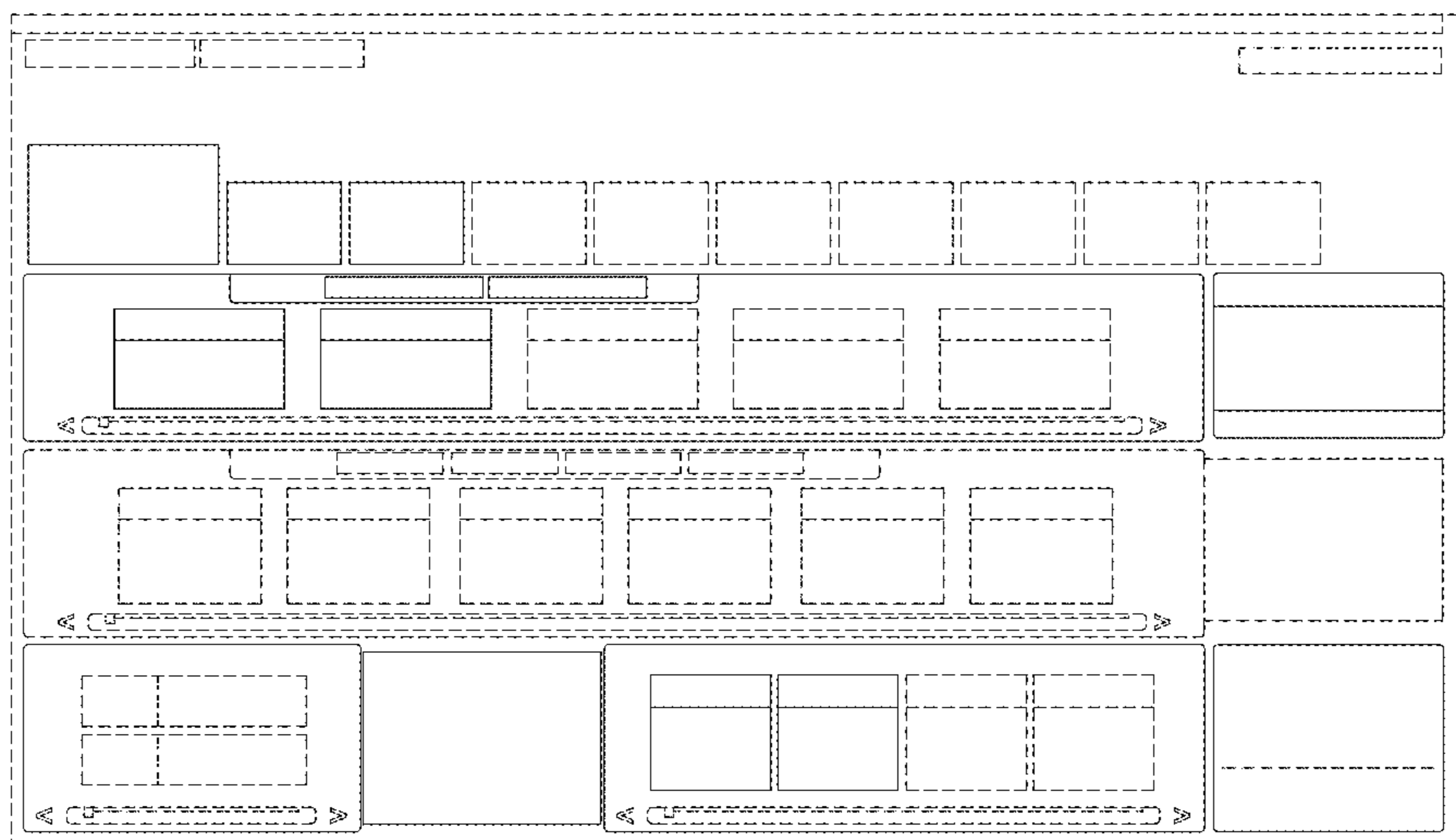
DESCRIPTION

FIG. 1 is a front elevation view of a display screen with graphical user interface in accordance with the new design; and,

FIG. 2 is a front elevation view of the display screen with a graphical user interface shown in FIG. 1 with additional environment shown in broken lines.

The outermost broken line rectangle in the drawing figures shows a display screen and defines the bounds of the claimed design; all other broken lines in the drawing figures show environmental structure. All broken lines form no part of the claimed design.

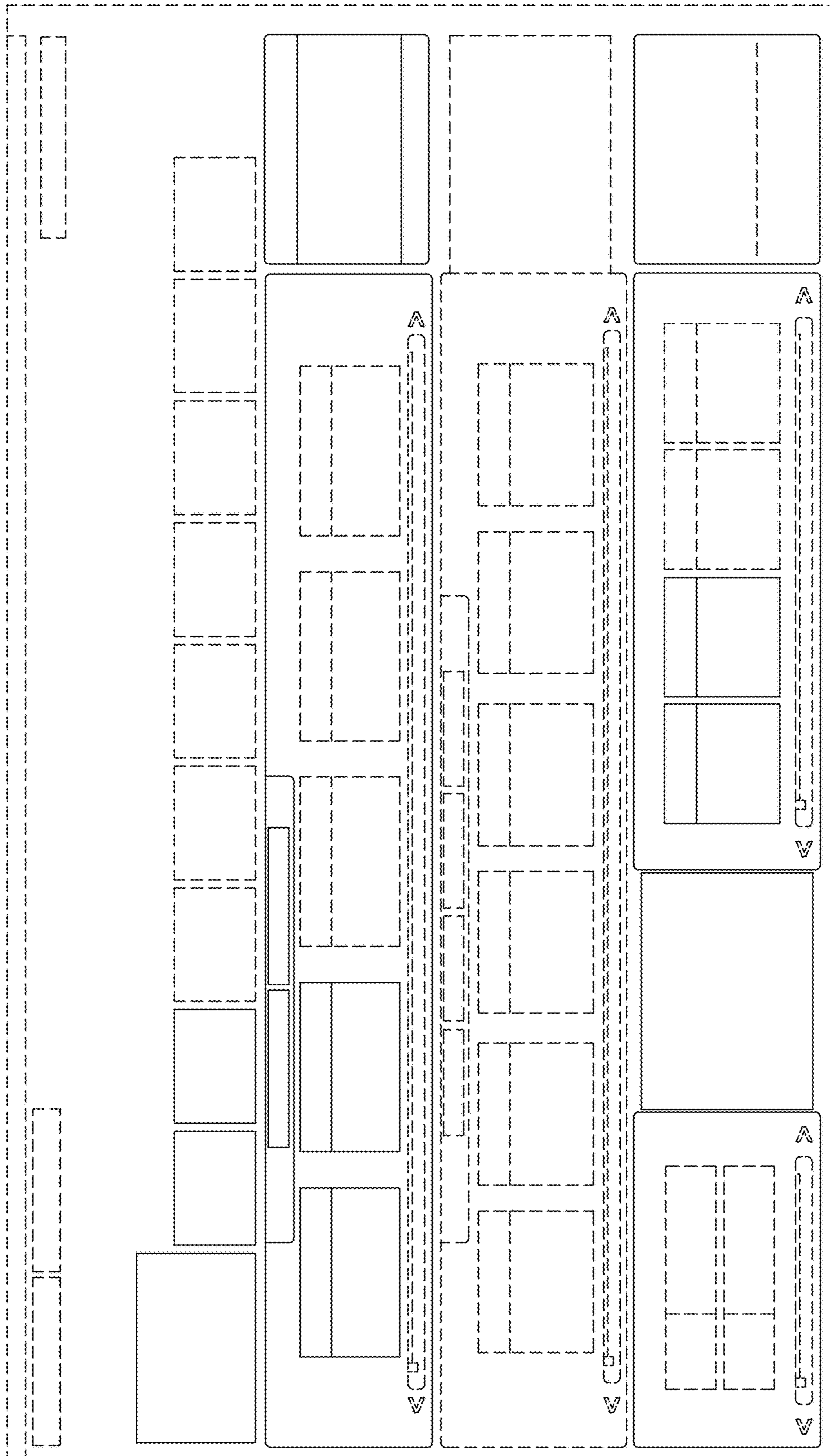

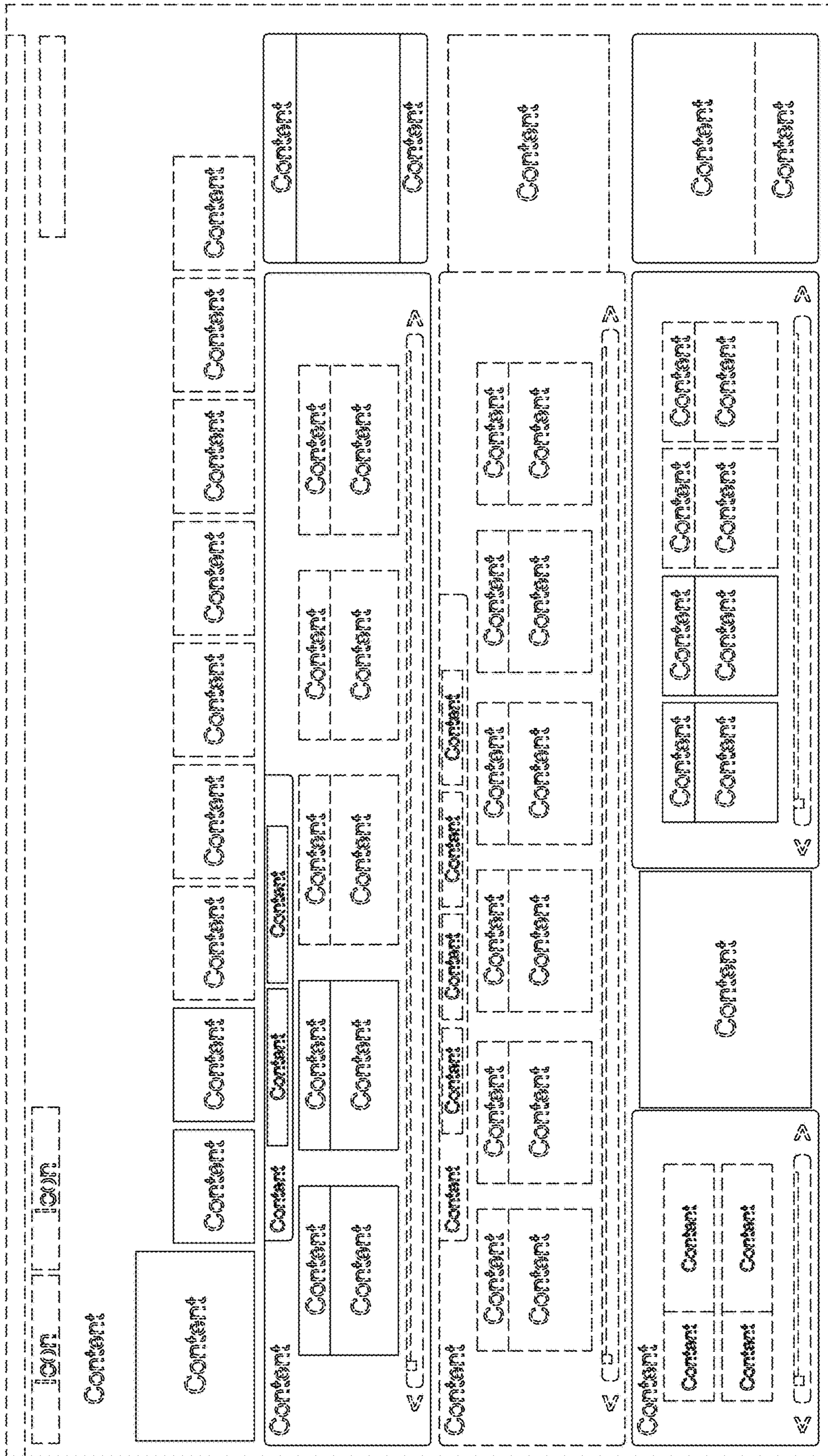
