(57) **CLAIM**

The ornamental design for a contact lens insertion and remover device, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the contact lens insertion and remover device according to my new design; and,
 FIG. 2 is a back view of the contact lens insertion and remover device; and,
 FIG. 3 is a side view of contact lens insertion and remover device; and,
 FIG. 4 is a back view of the contact lens insertion and remover device with a contact lens for the human eye placed upon the top; and,
 FIG. 5 is a top vertical view of the contact lens insertion and remover device showing the reniform top portion where the contact lens is placed.
 The broken lines shown in the FIG. 4 drawing are included for the purposes of illustrating environmental structure and form no part of the claim design.

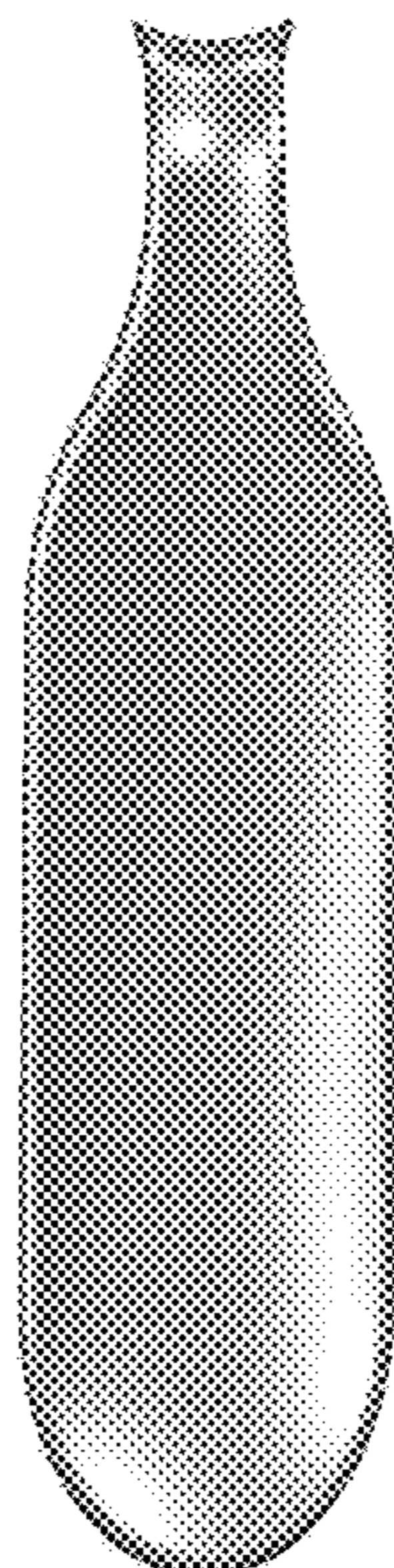

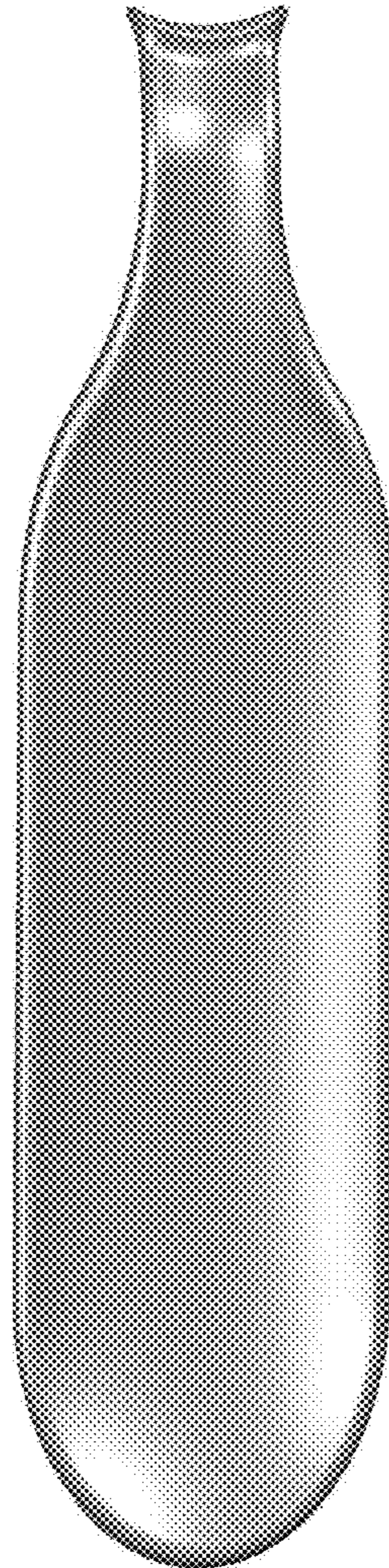

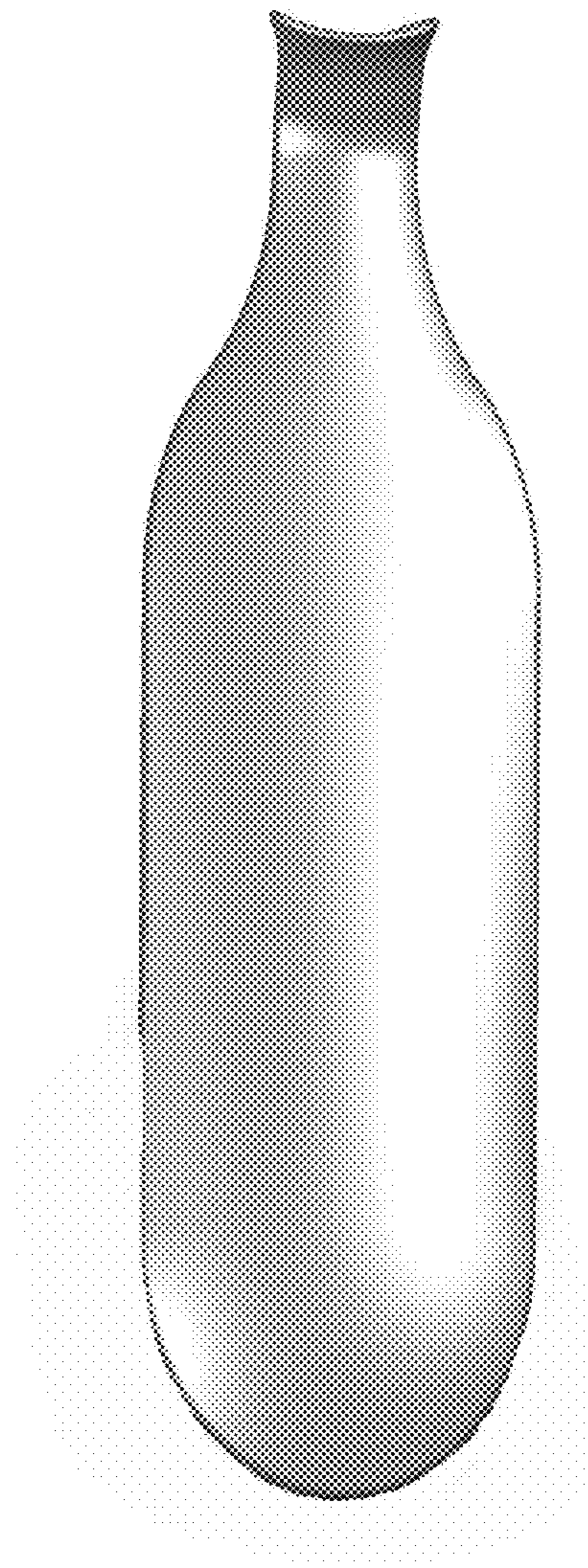

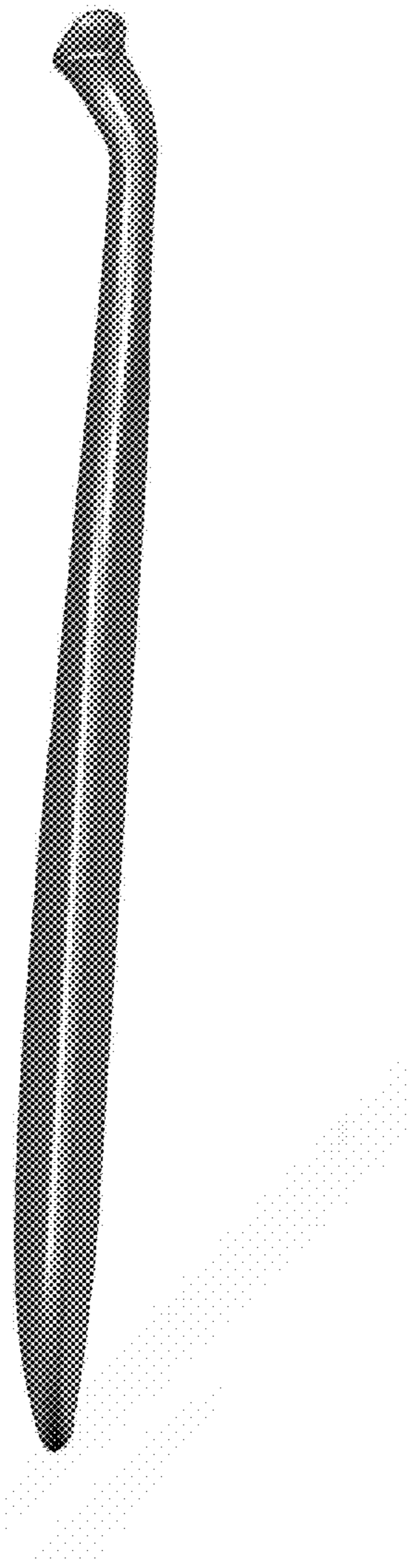
