DESCRIPTION

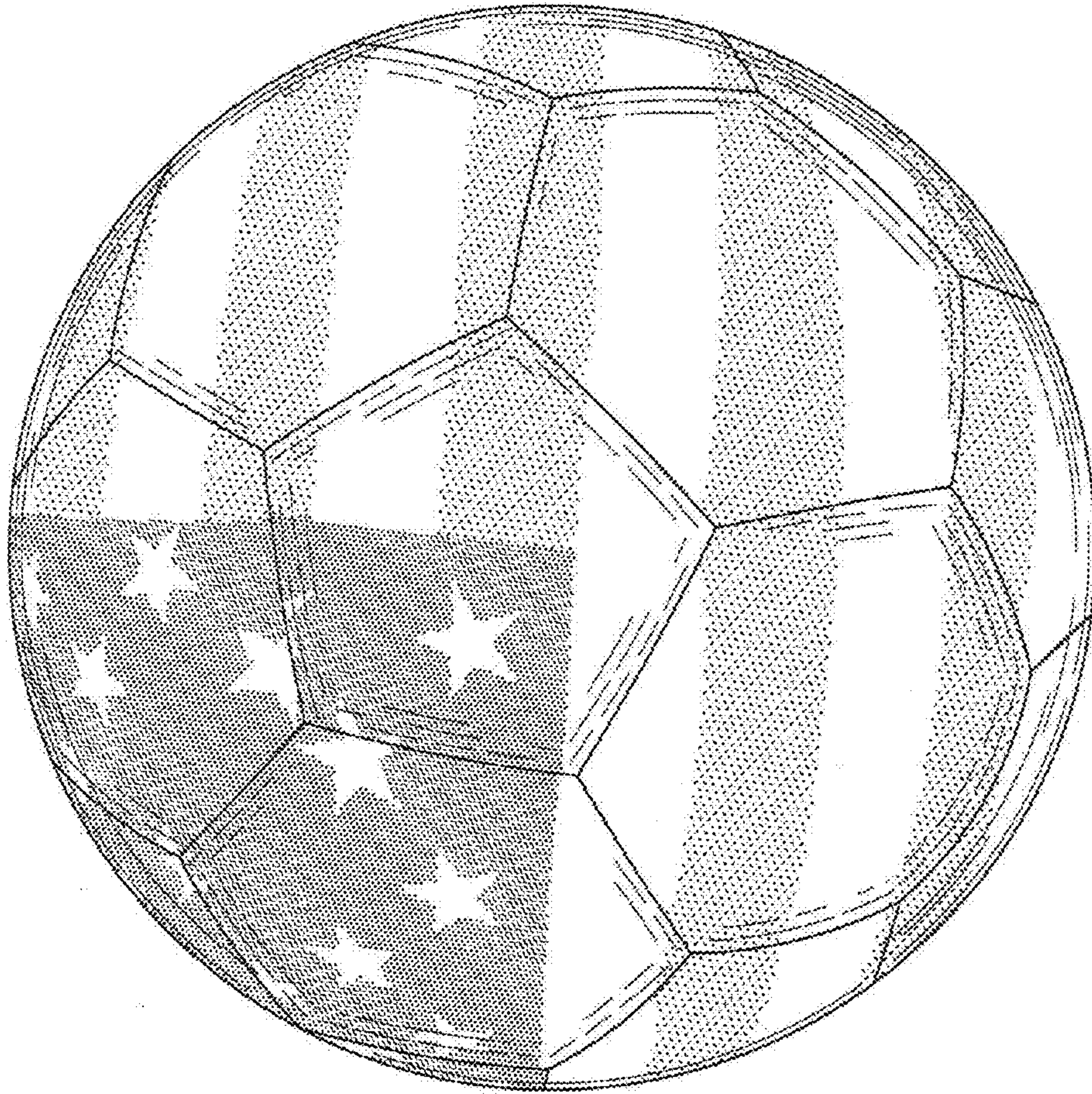
FIG. 1 is a front view of a soccer ball showing my new design;

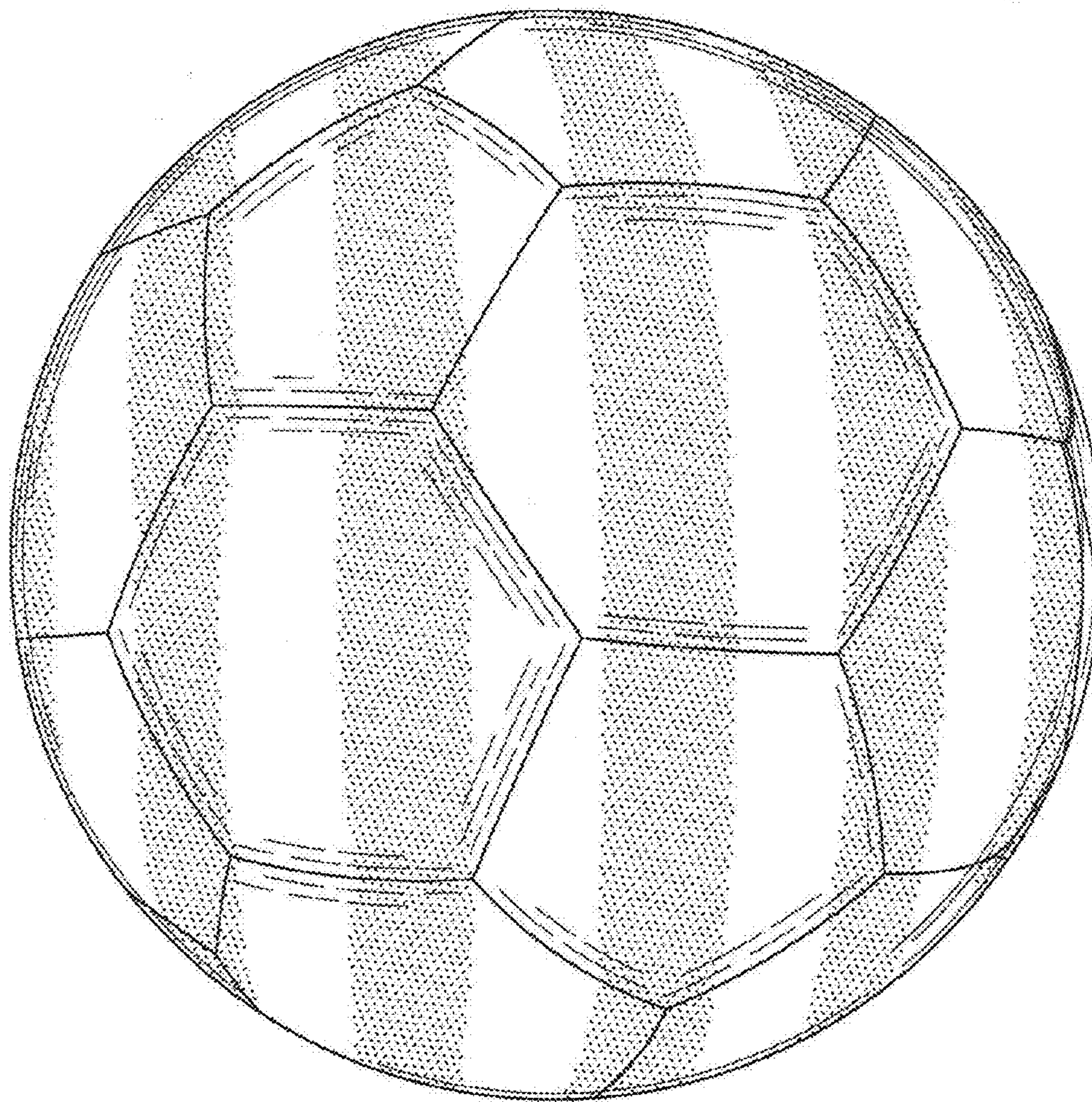

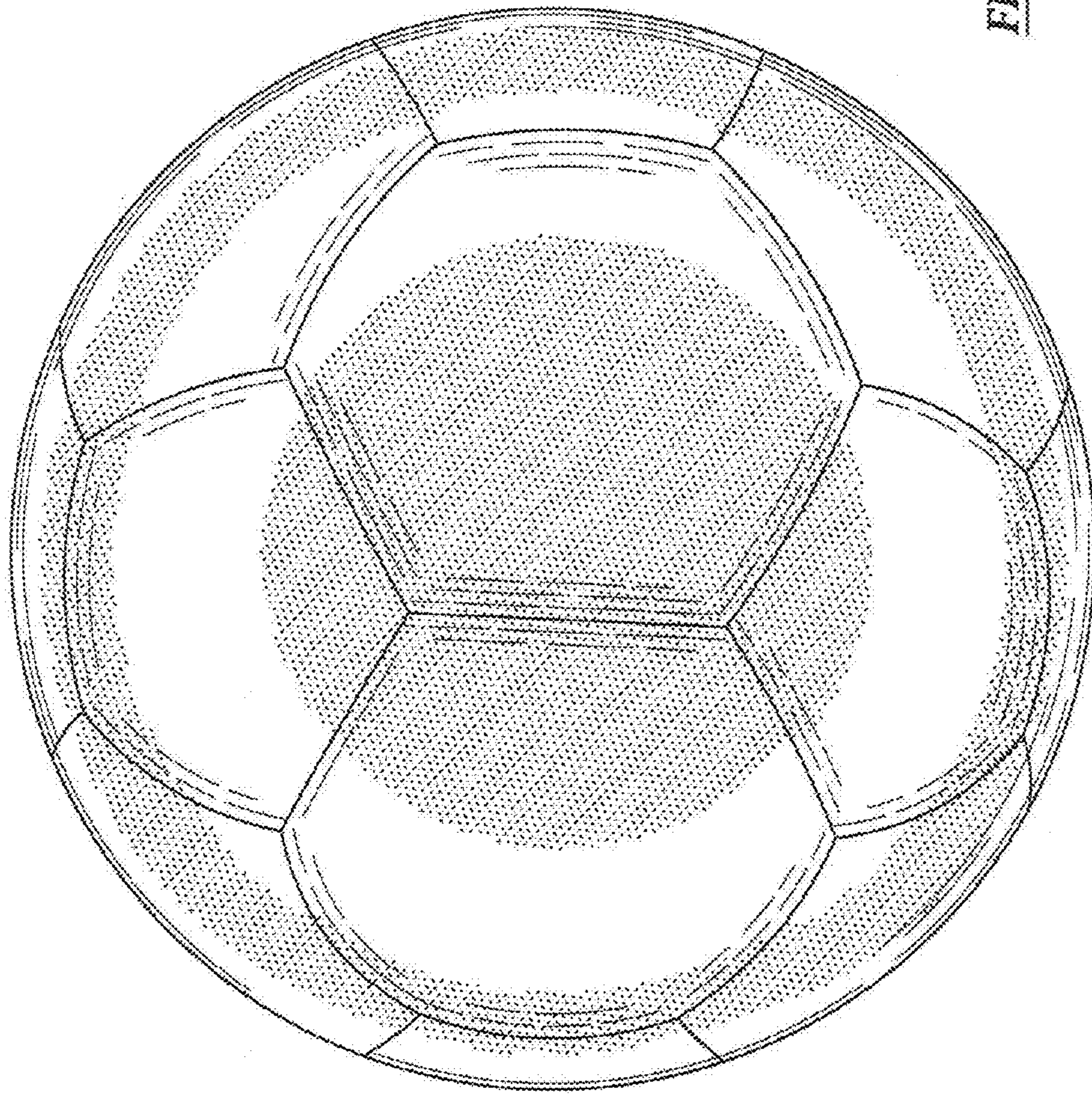
