The ornamental design for a golf club head, as shown and described.

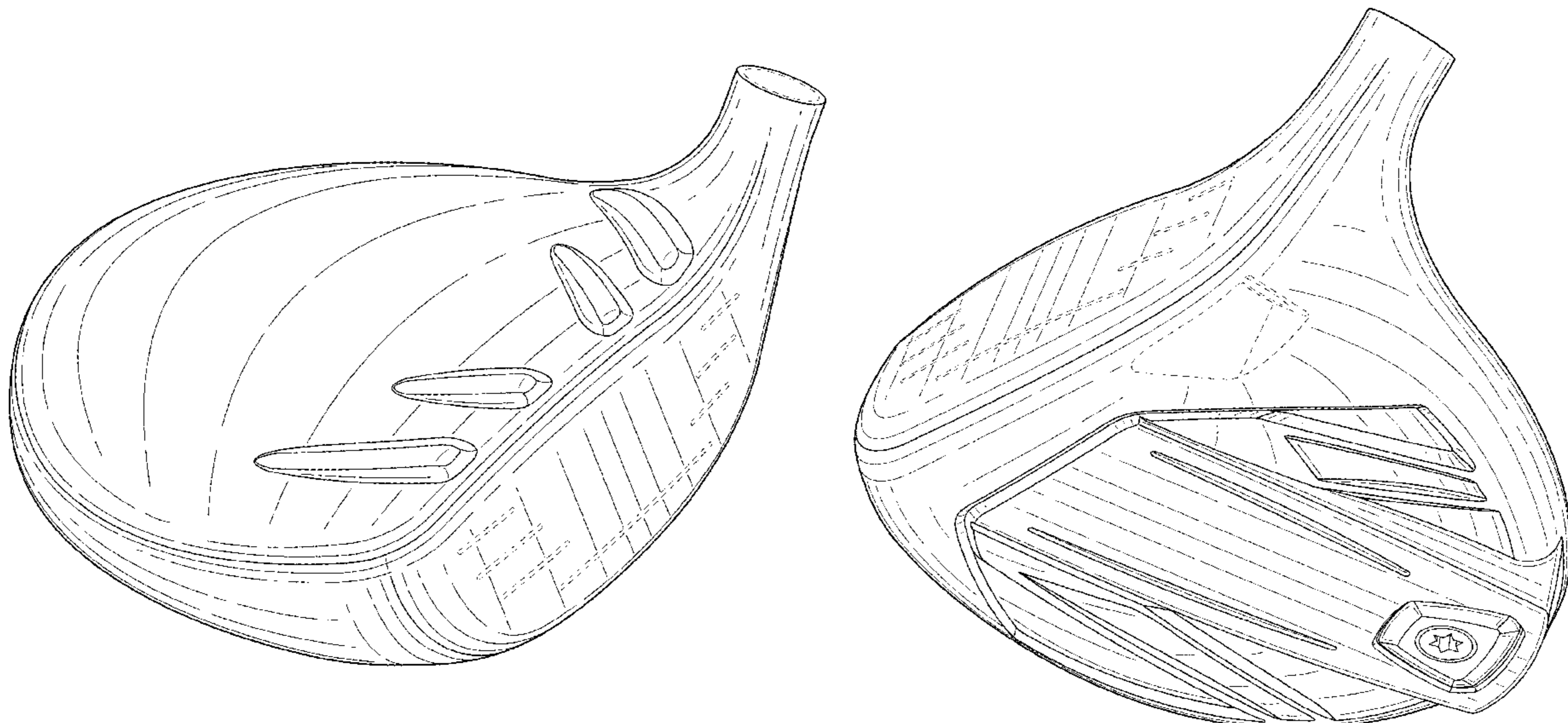
**DESCRIPTION**

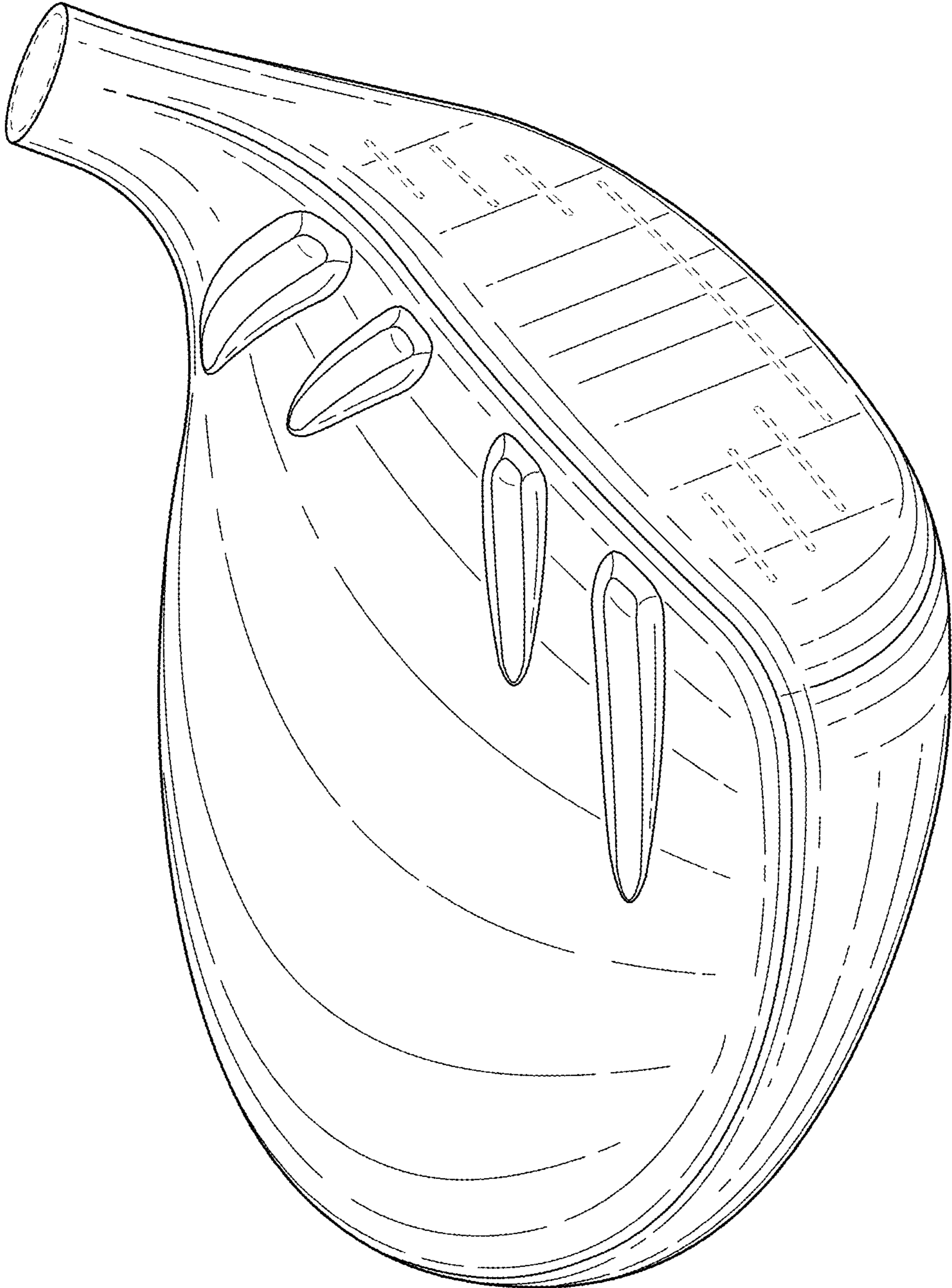

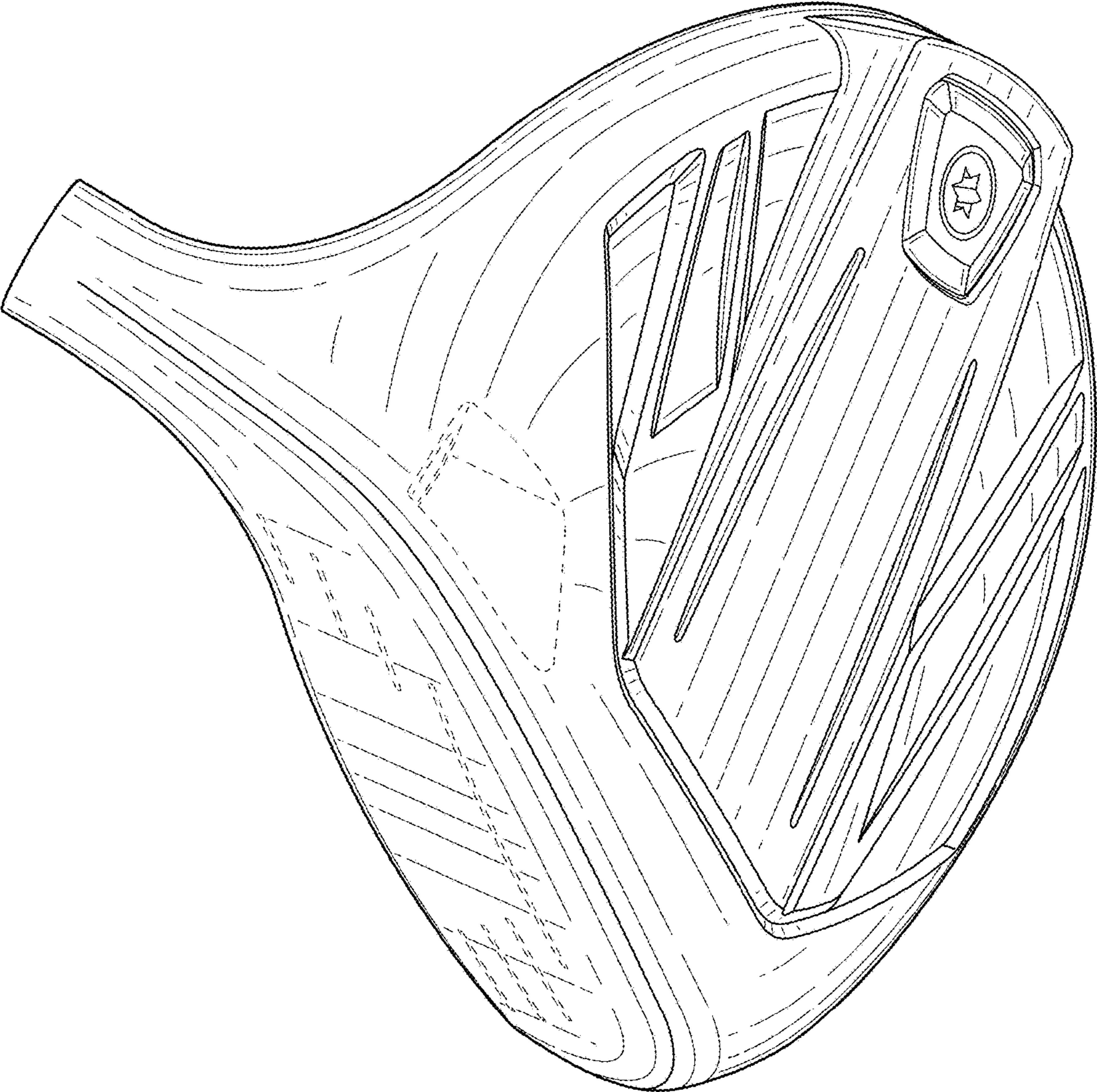
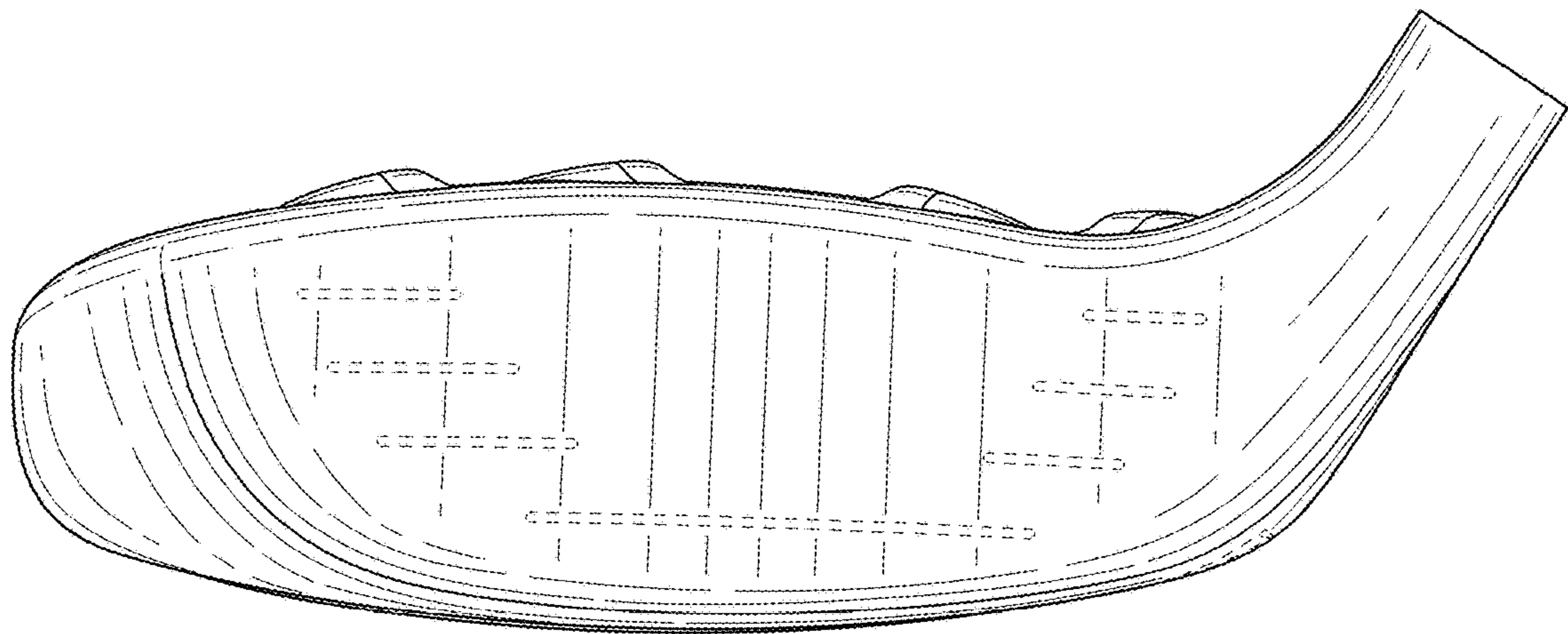
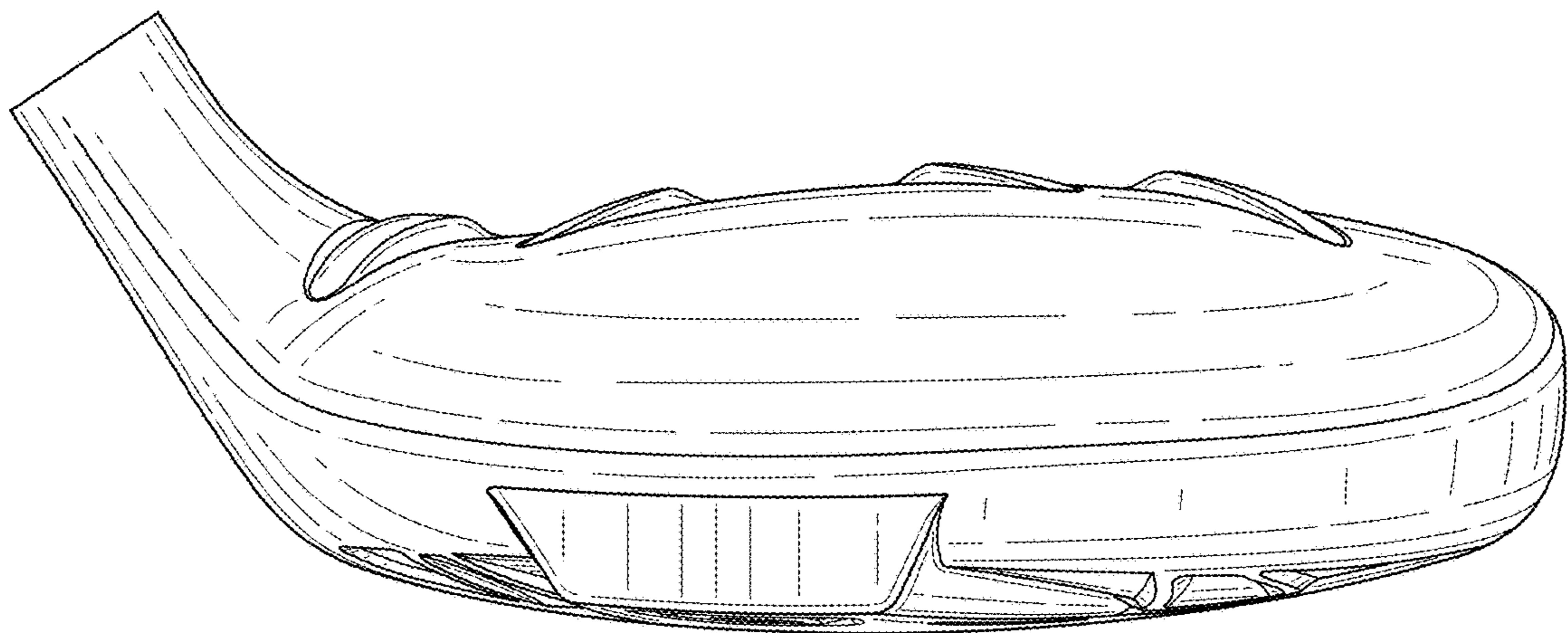


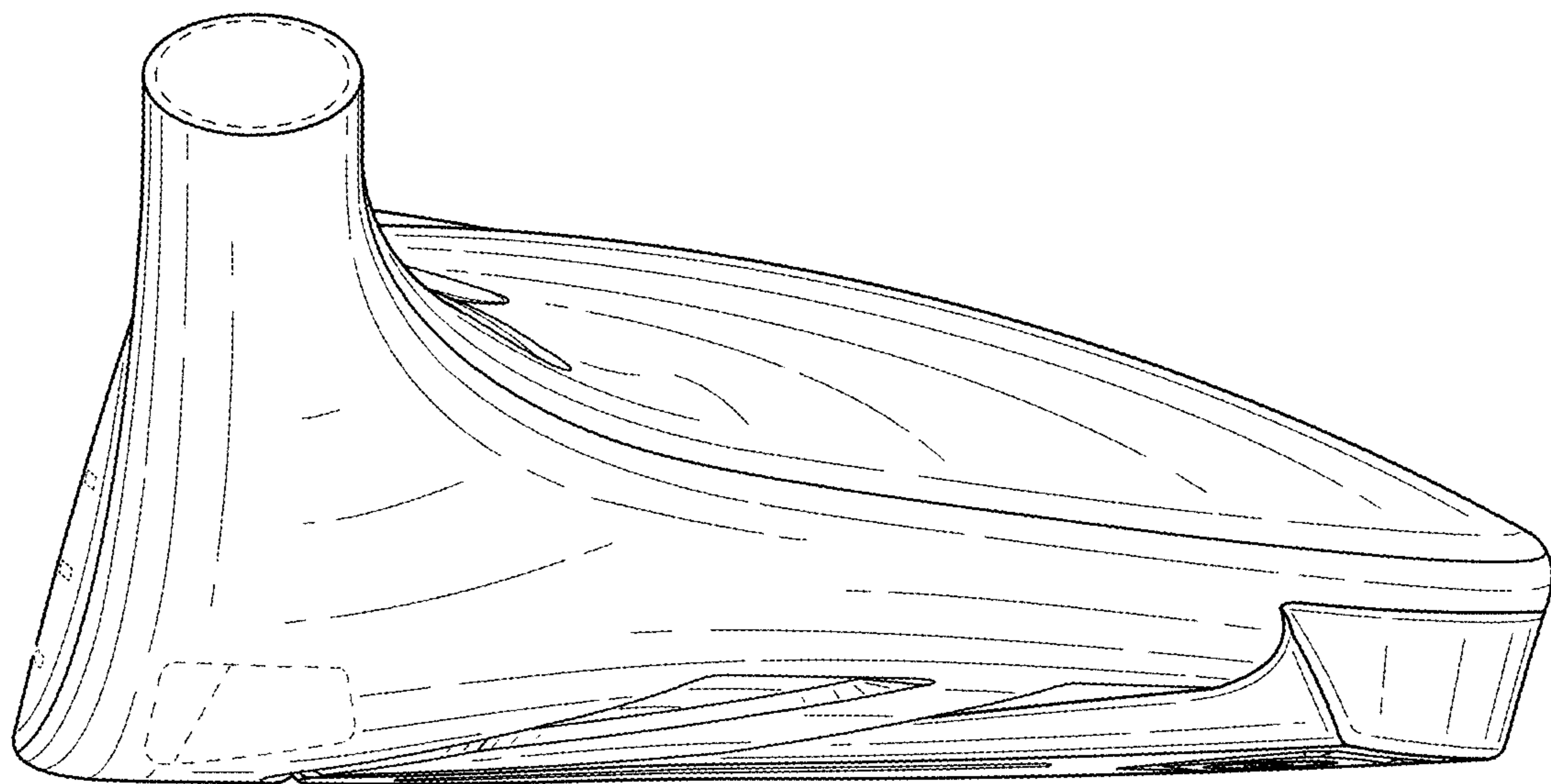

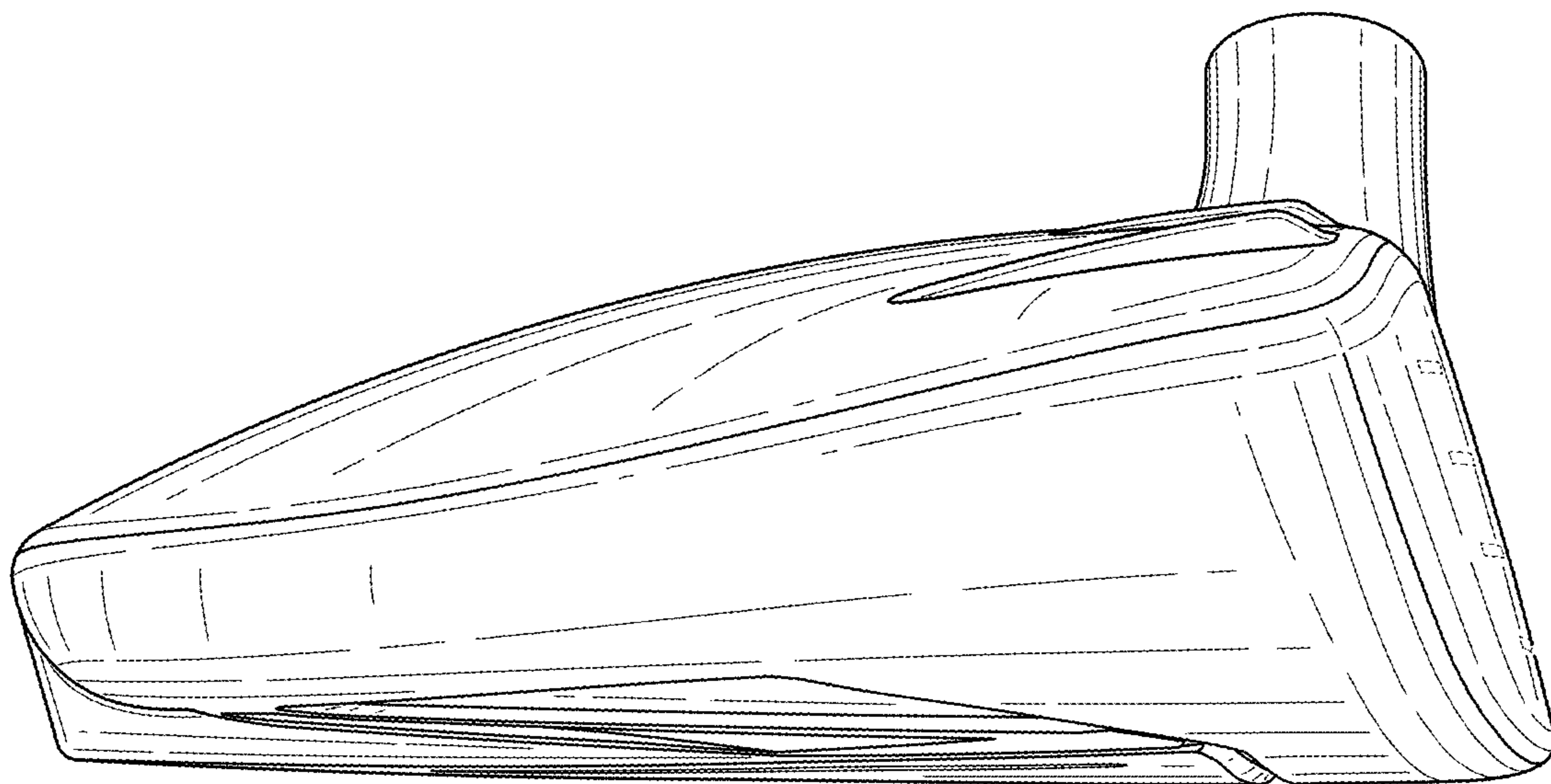

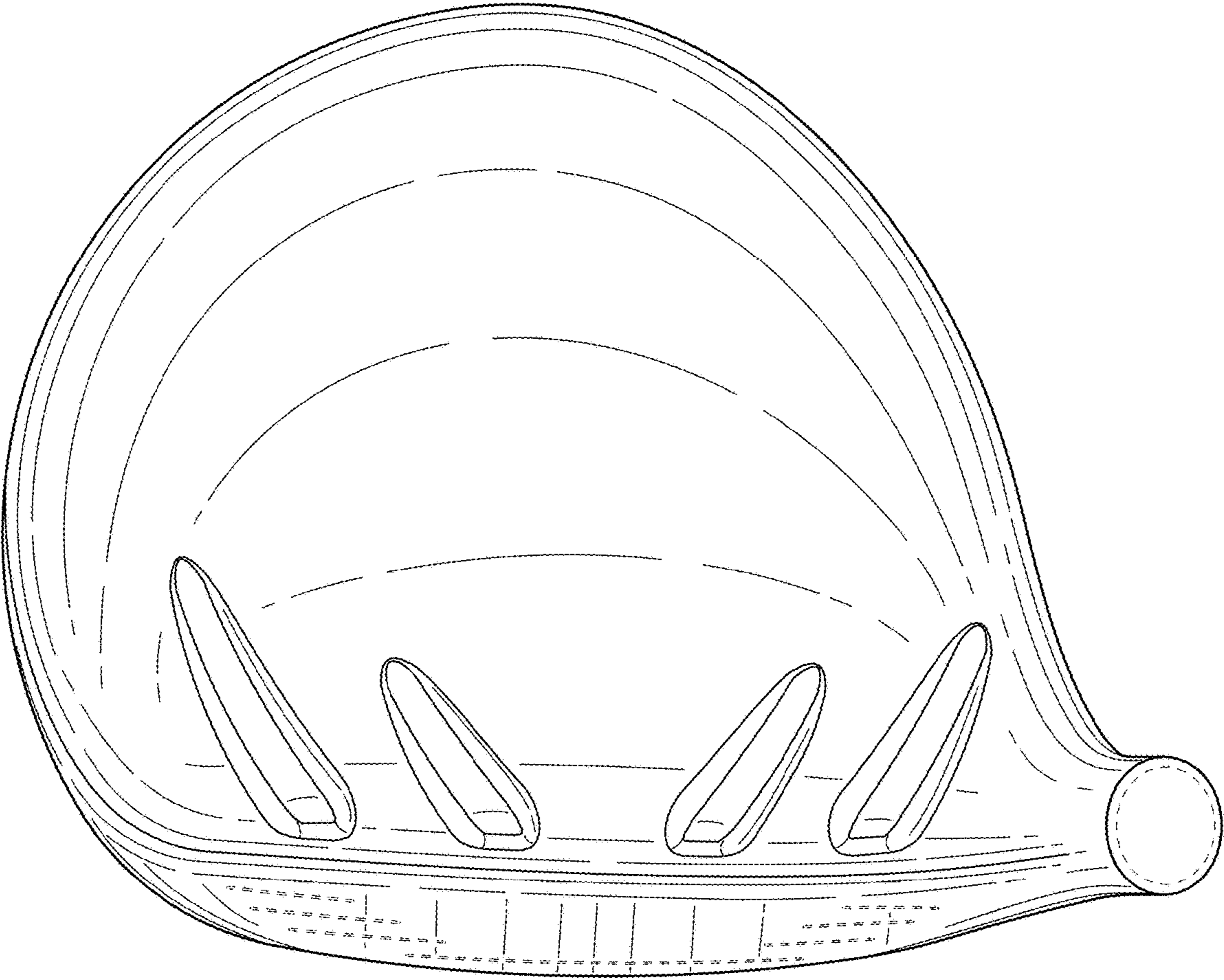

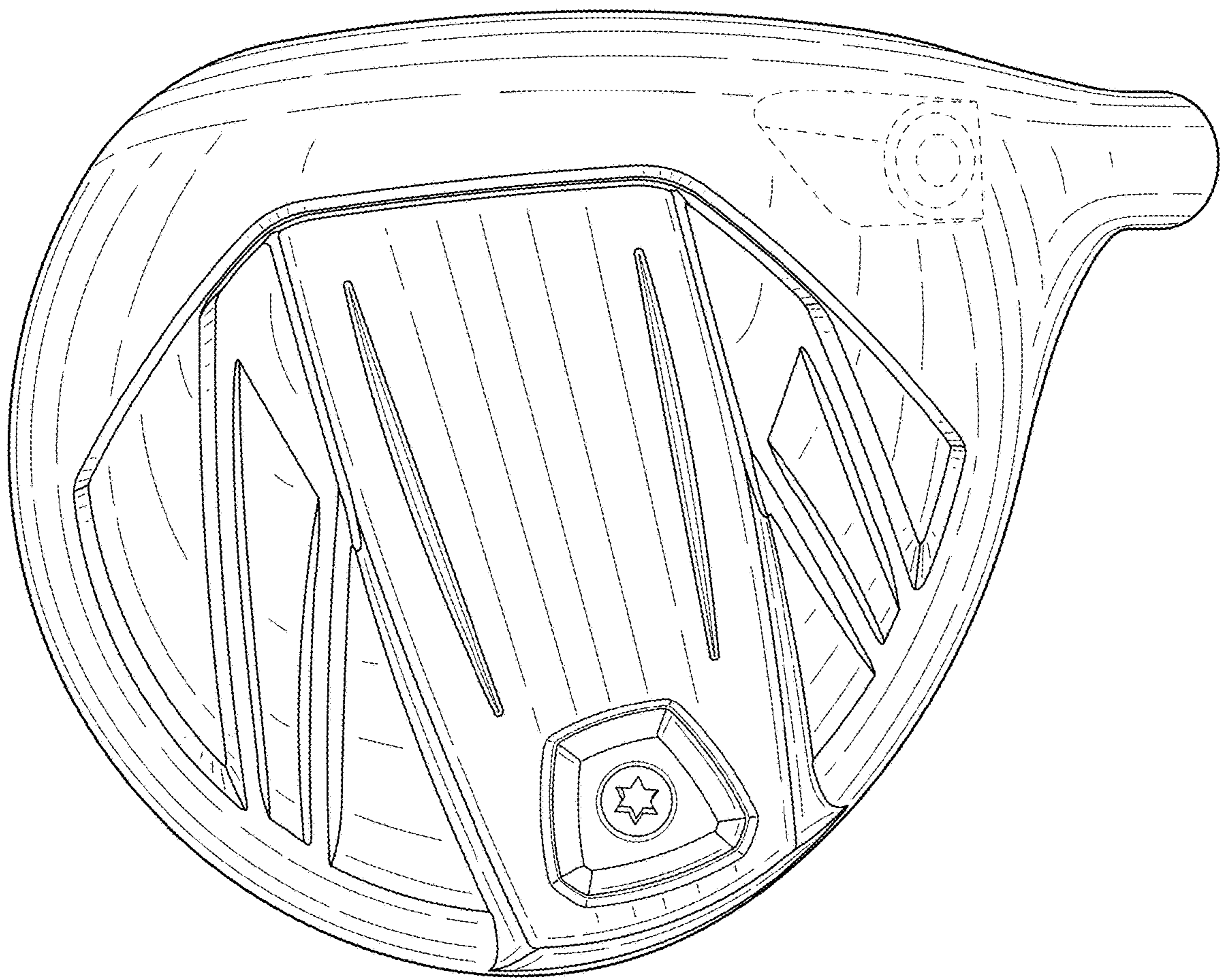
