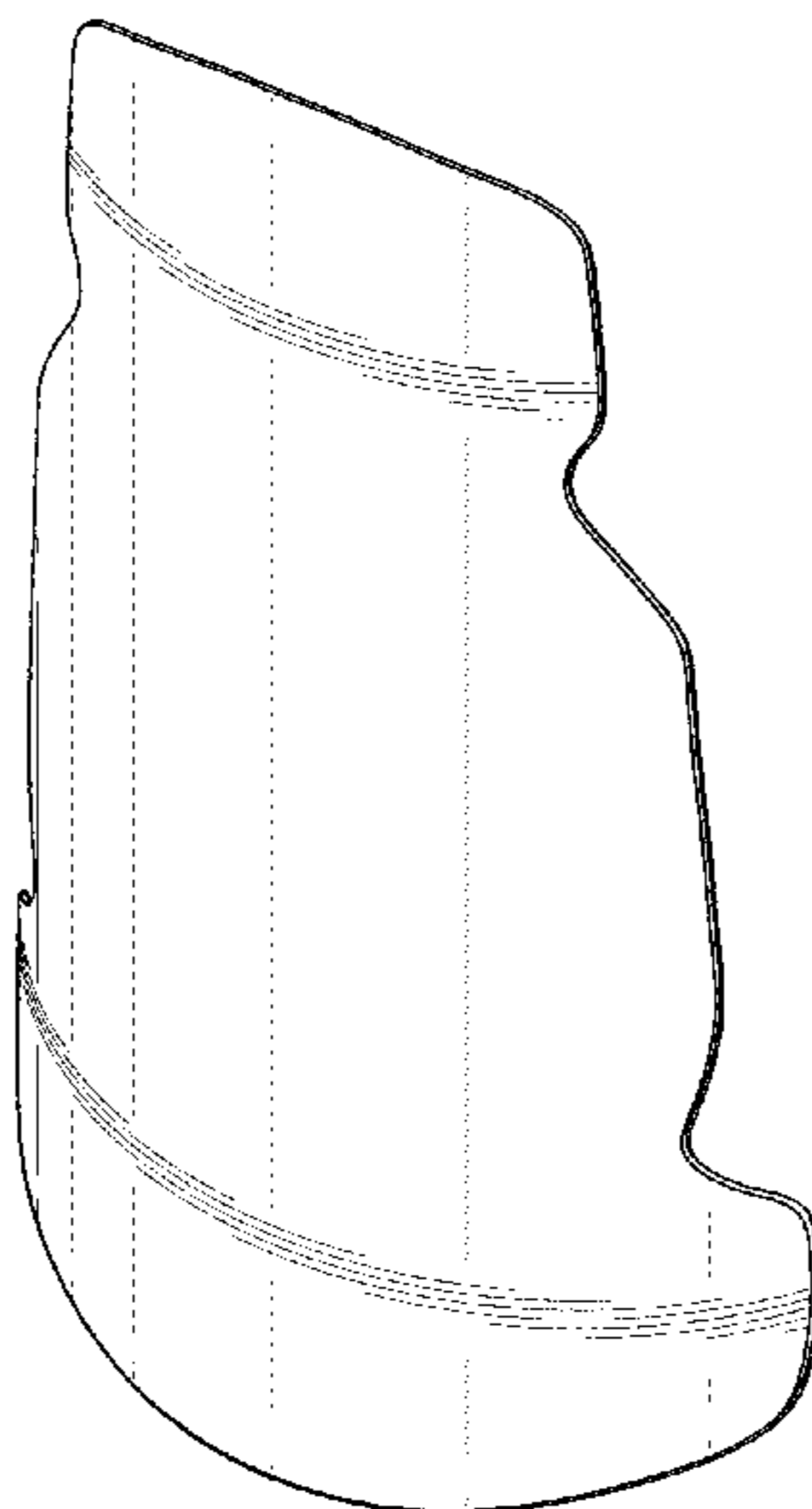
(57) **CLAIM**

The ornamental design for a contoured hair coloring board, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a contoured hair coloring board.
FIG. 2 is a front view of a contoured hair coloring board.
FIG. 3 is a side view of a contoured hair coloring board, the opposite side view being a mirror image thereof.
FIG. 4 is a back view of a contoured hair coloring board.
FIG. 5 is a top view of a contoured hair coloring board; and,

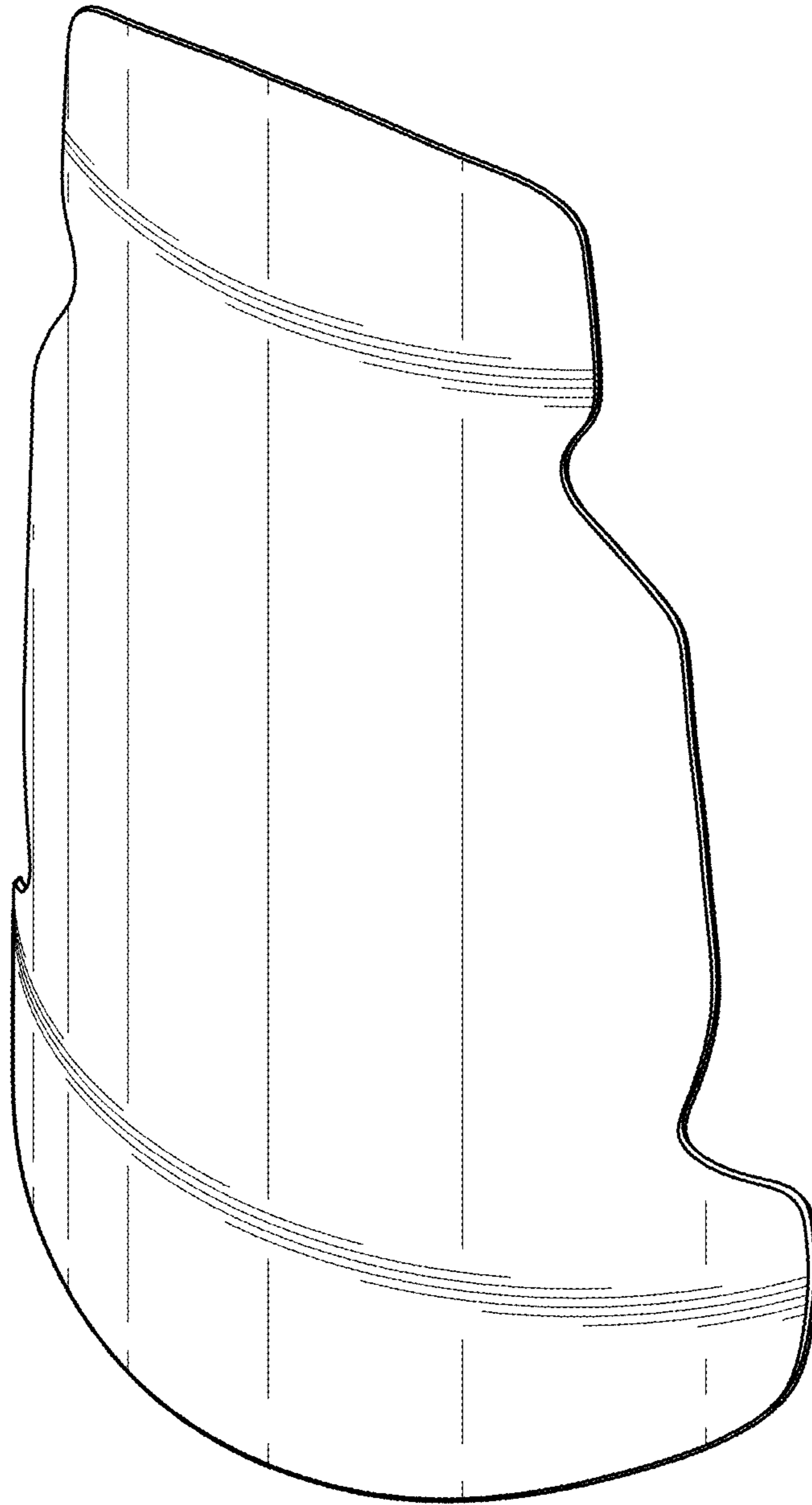

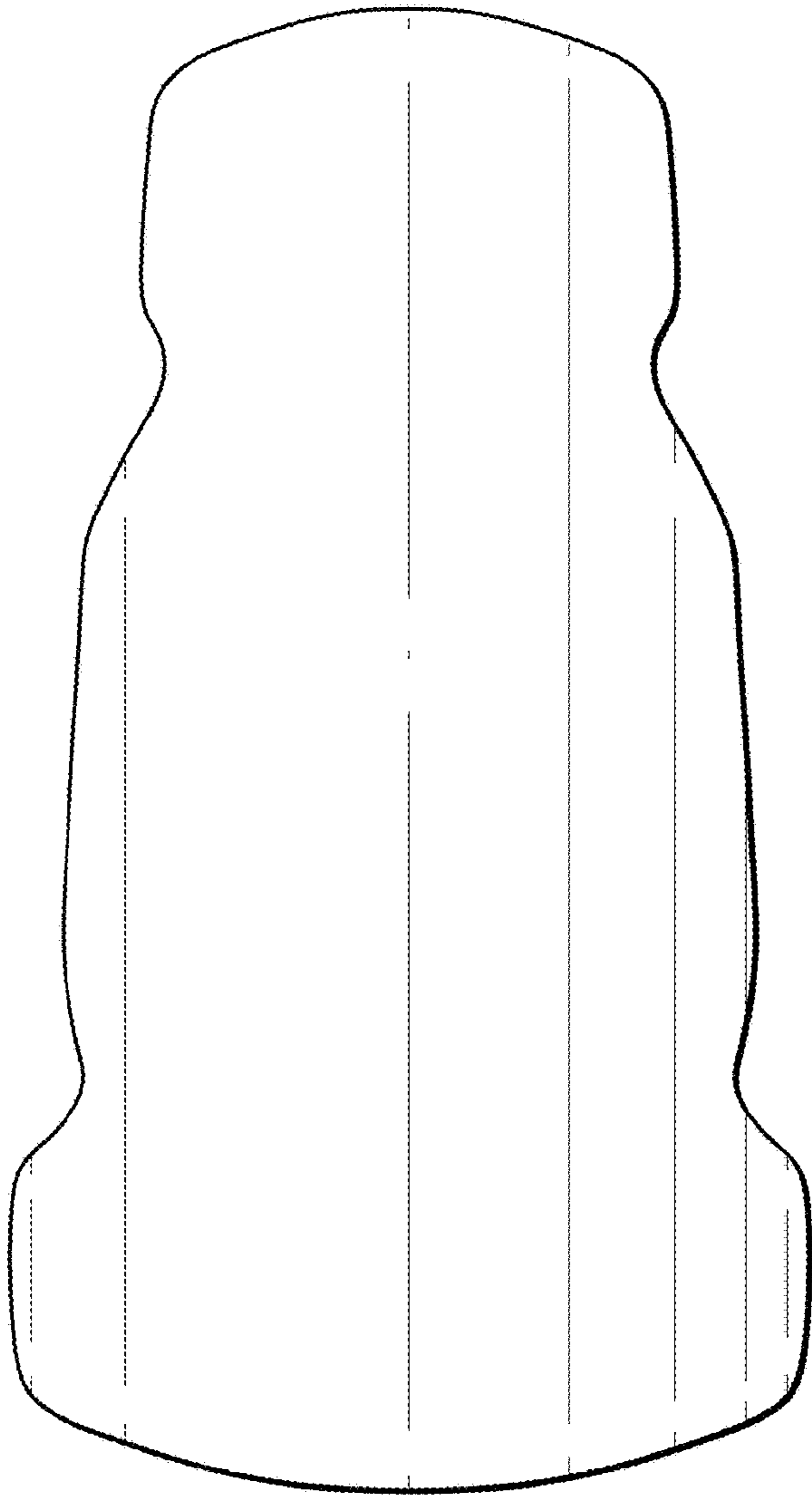

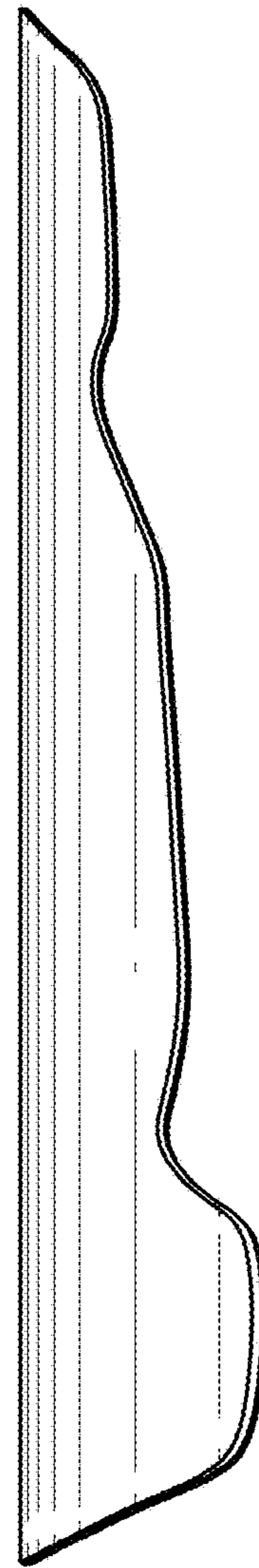

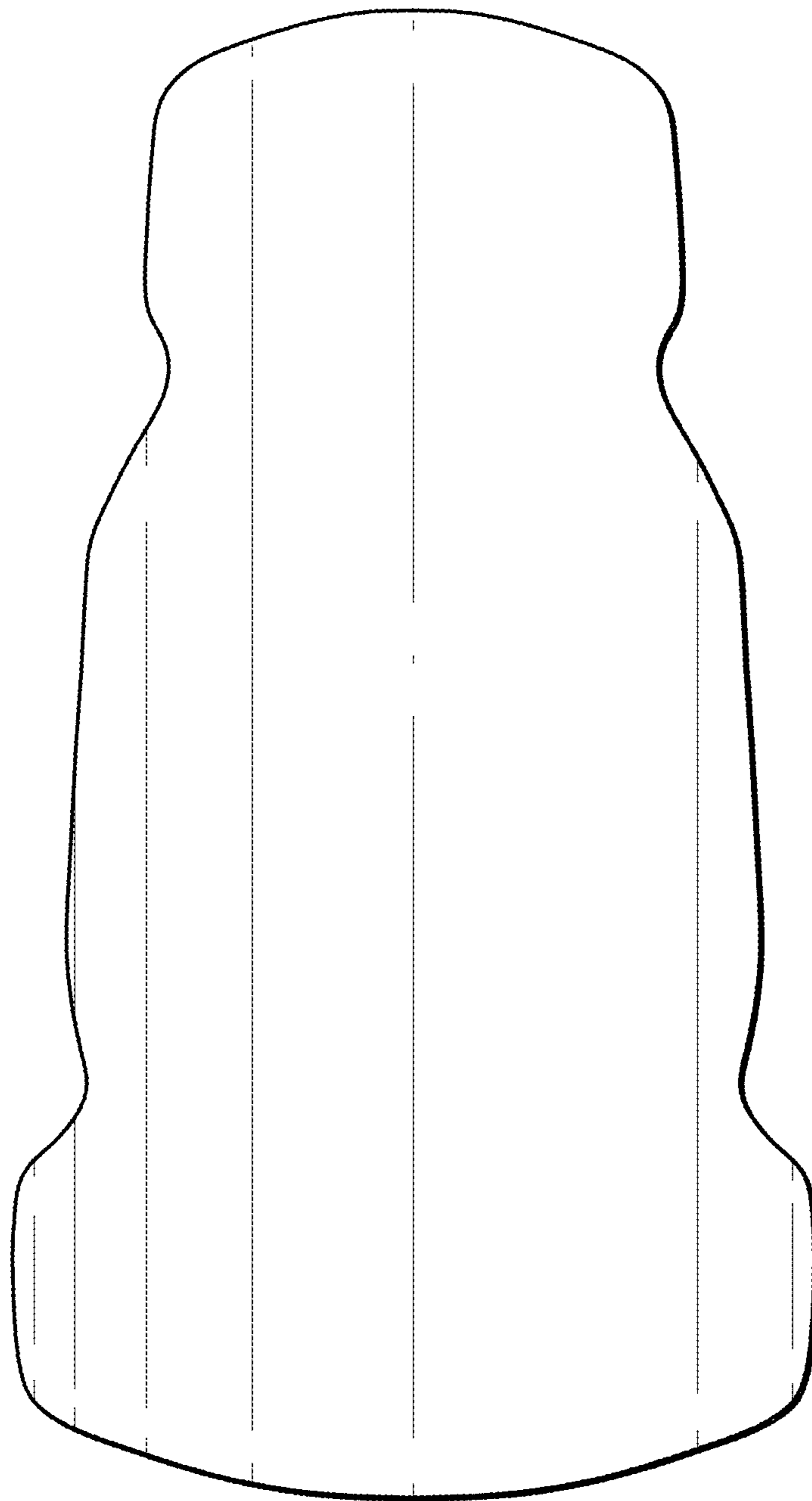

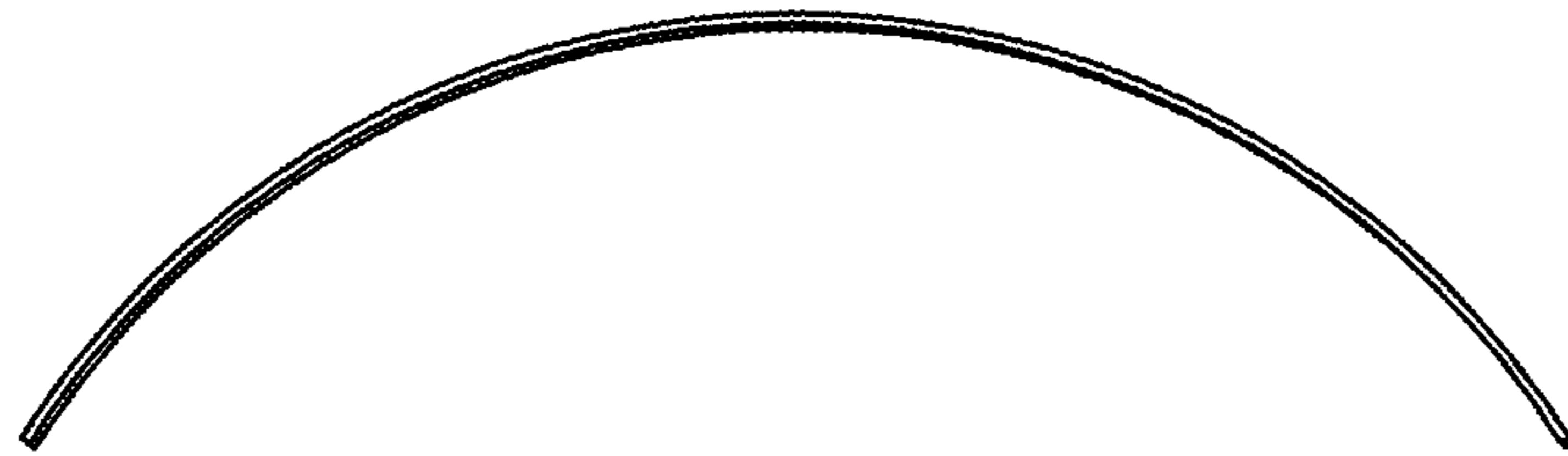
