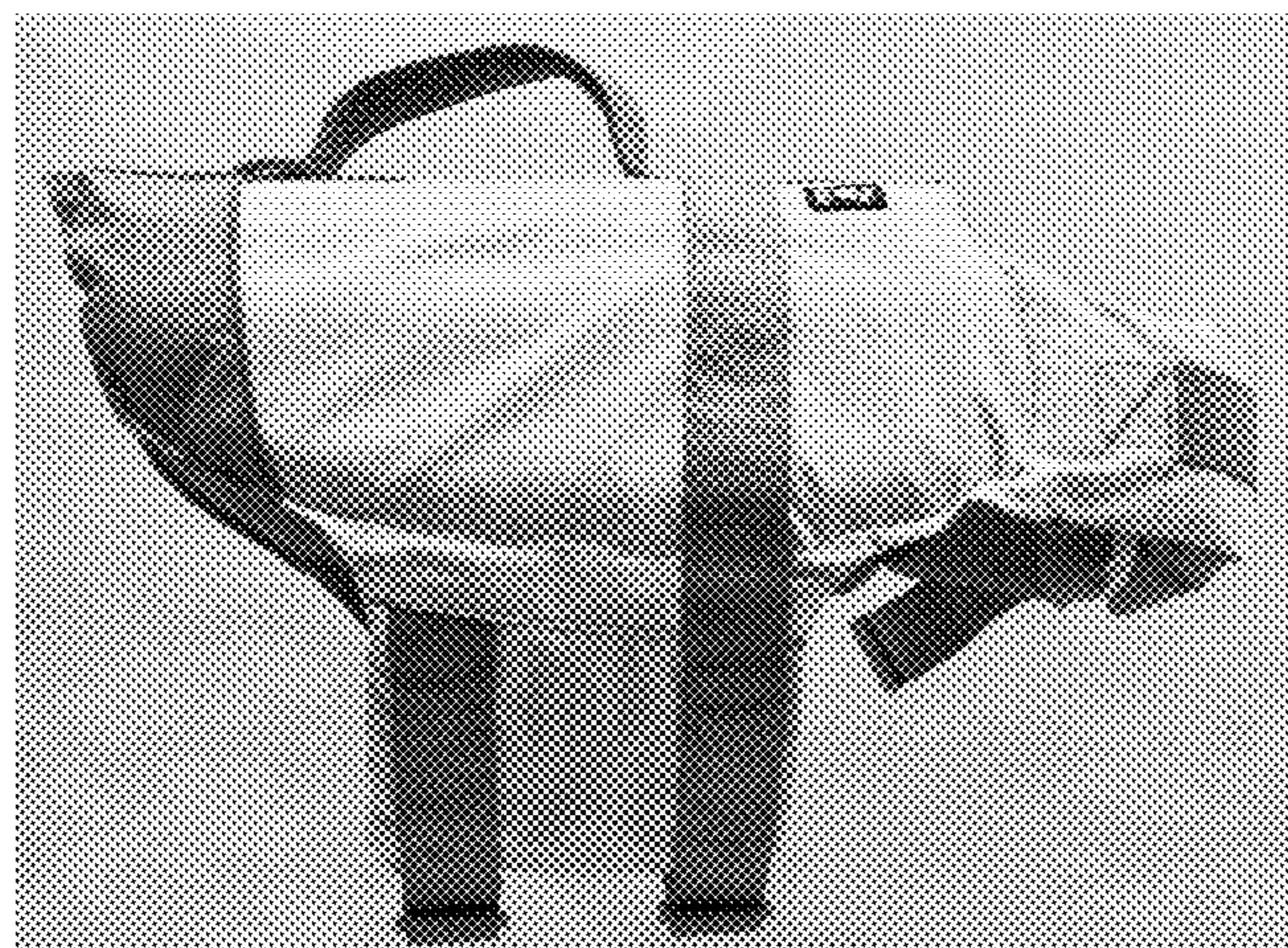
(57) **CLAIM**

The ornamental design for a life jacket for an animal, as shown and described.

**DESCRIPTION**

FIG. 1 is a right side view of the life jacket for an animal of our new design in the closed position;  
FIG. 2 is a left side view thereof;  
FIG. 3 is a top view thereof;  
FIG. 4 is a bottom view thereof;  
FIG. 5 is a top view of the life jacket for an animal in the open position showing the exterior surfaces of the straps extended away from each other and in the same plane;  
FIG. 6 is a bottom view of the life jacket for an animal of FIG. 5; and,  
FIG. 7 is a front view of the life jacket for an animal in the closed position.
