(57) **CLAIM**

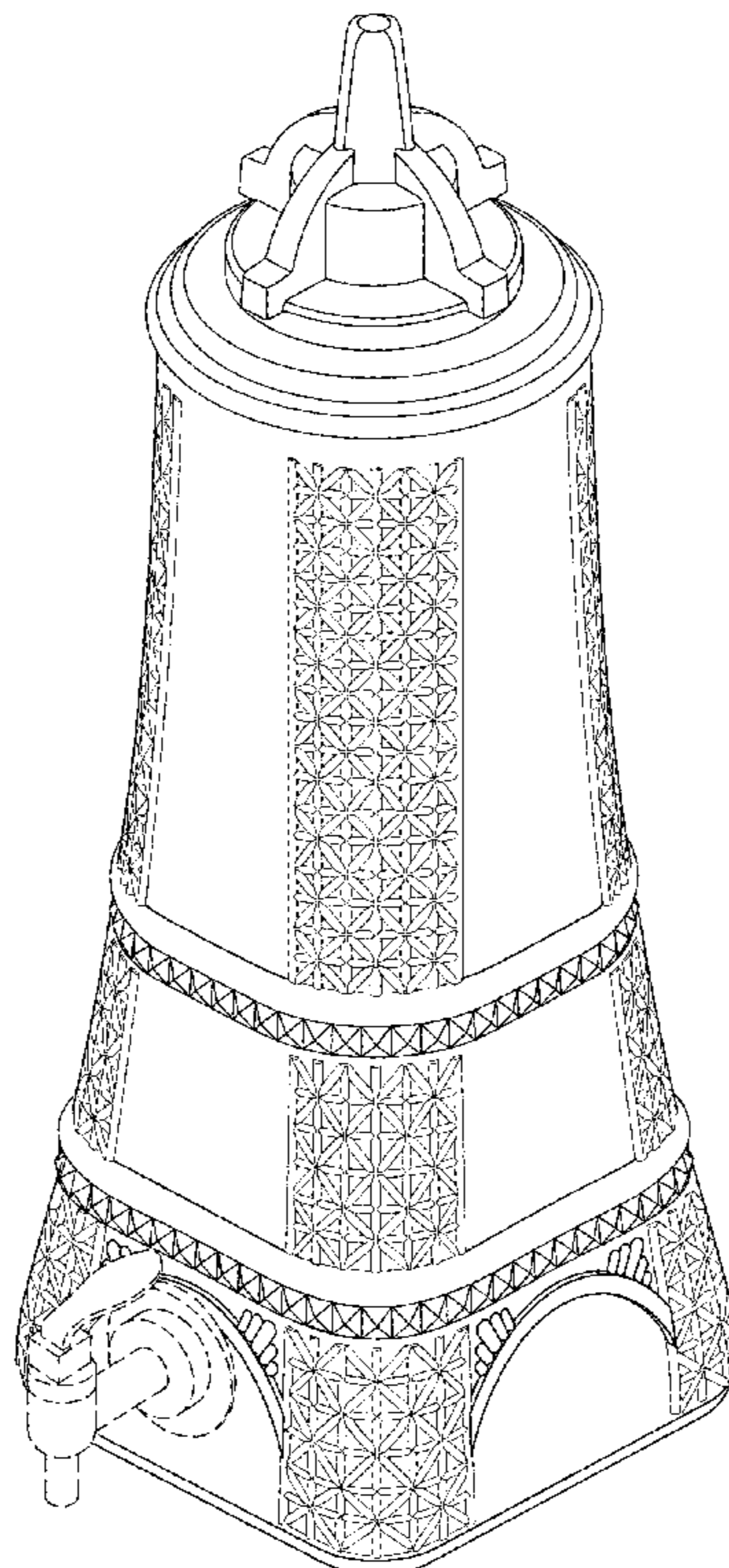
The ornamental design for an lighthouse beverage dispenser, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a lighthouse beverage dispenser showing my new design;

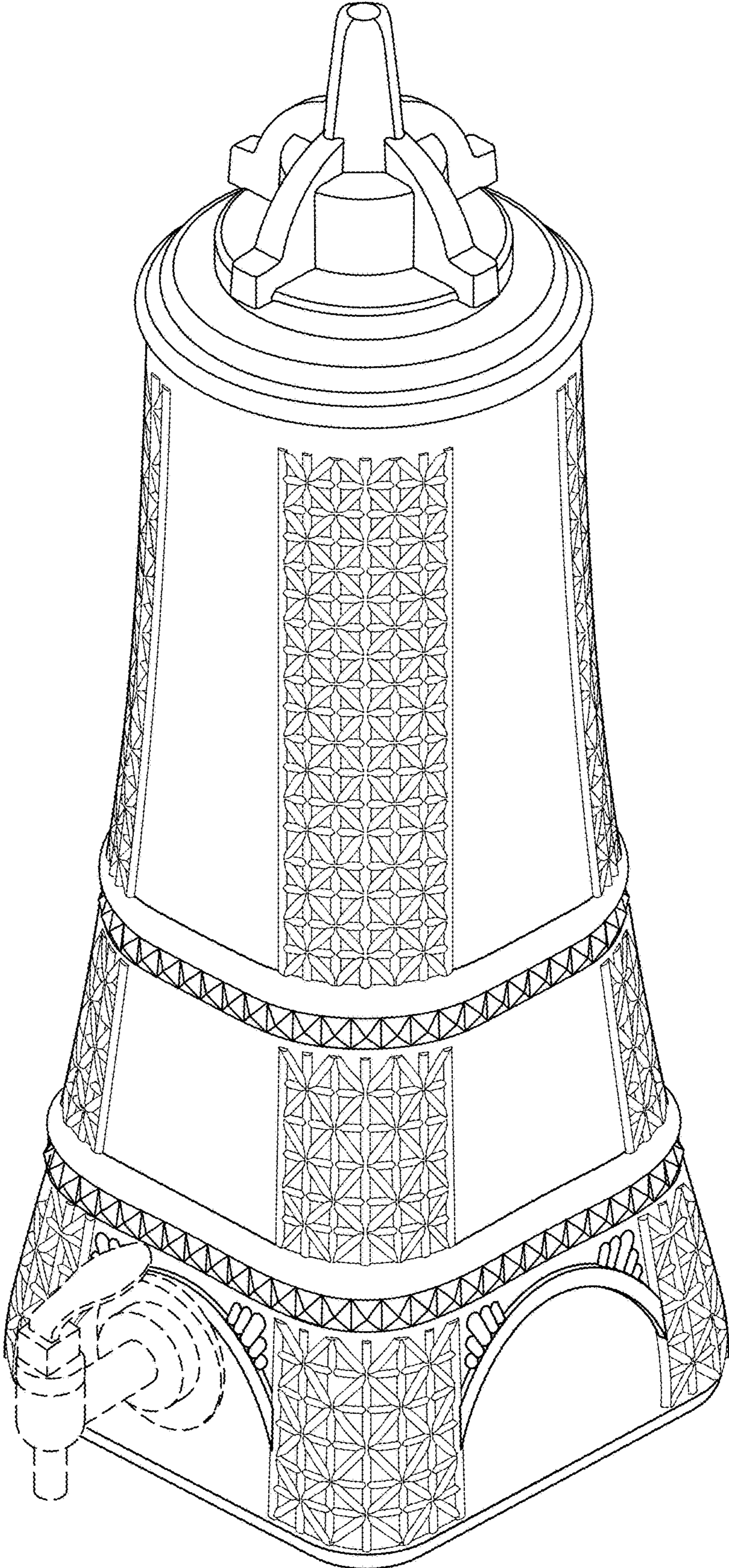

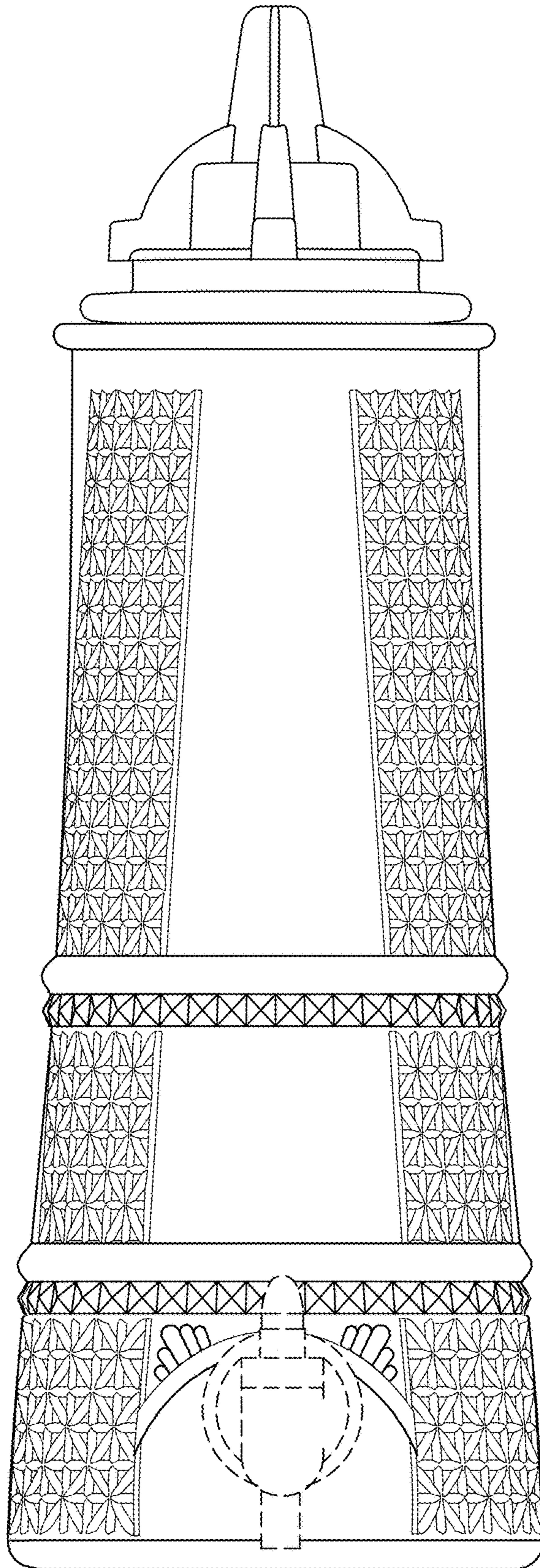

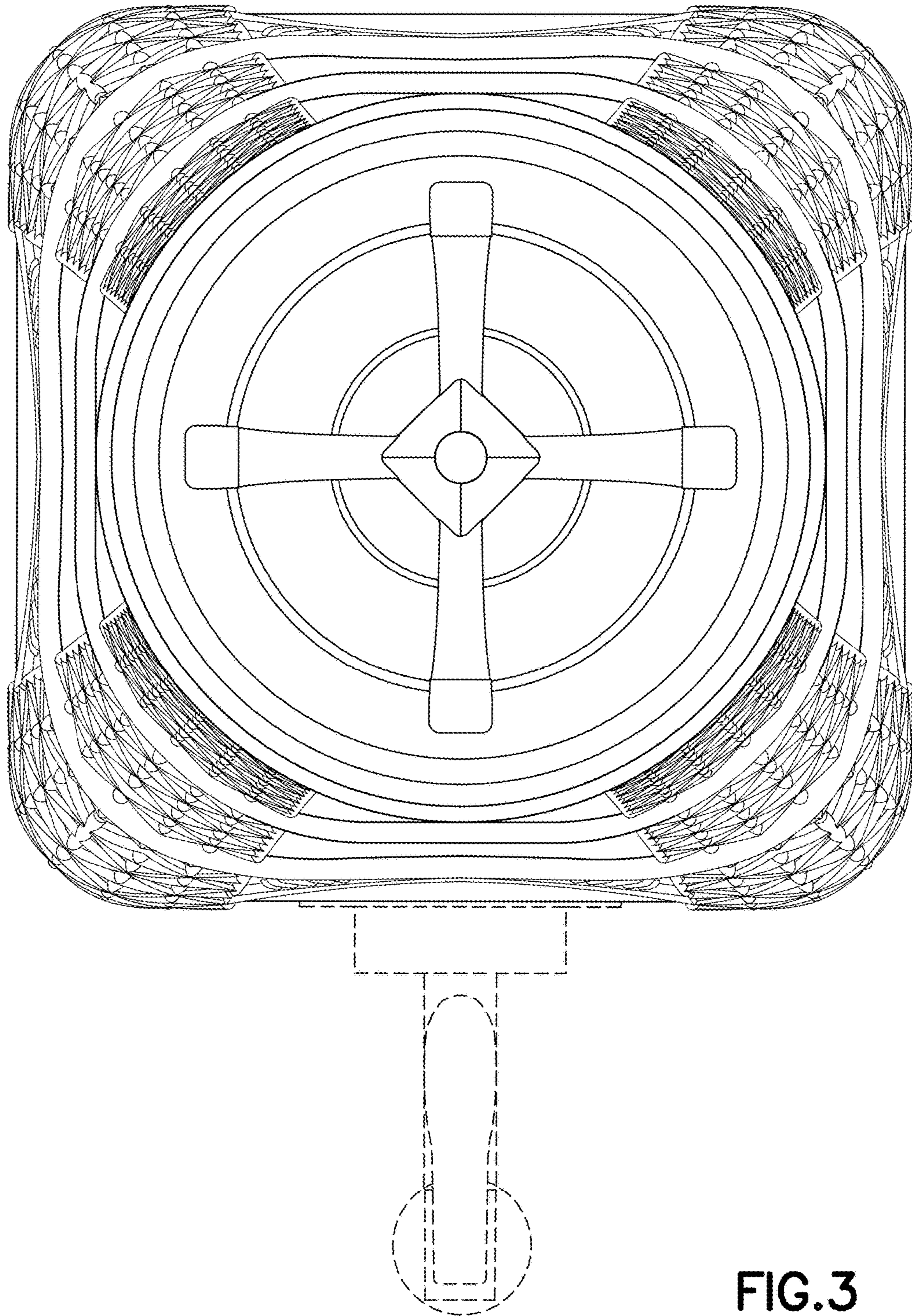

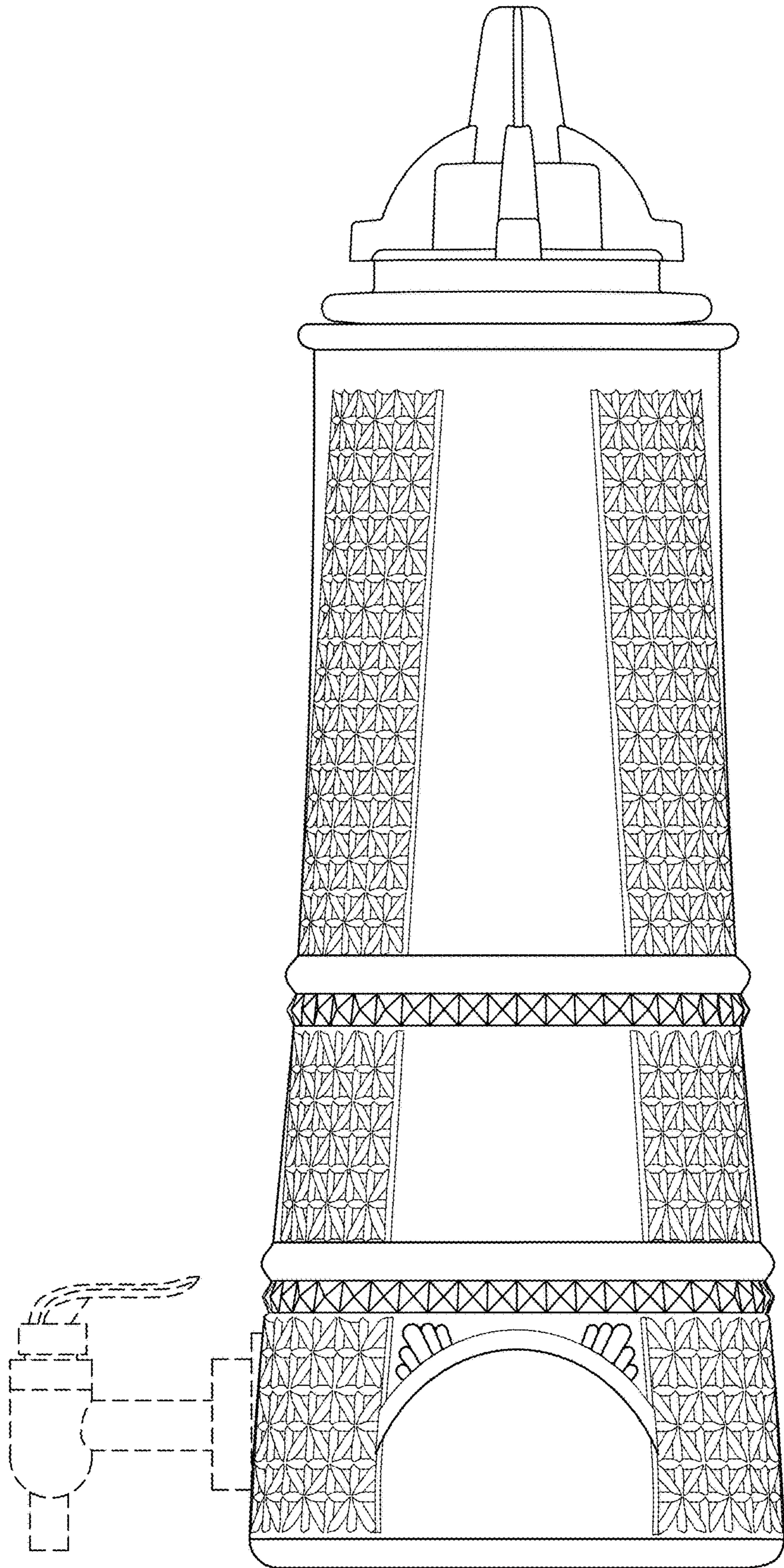

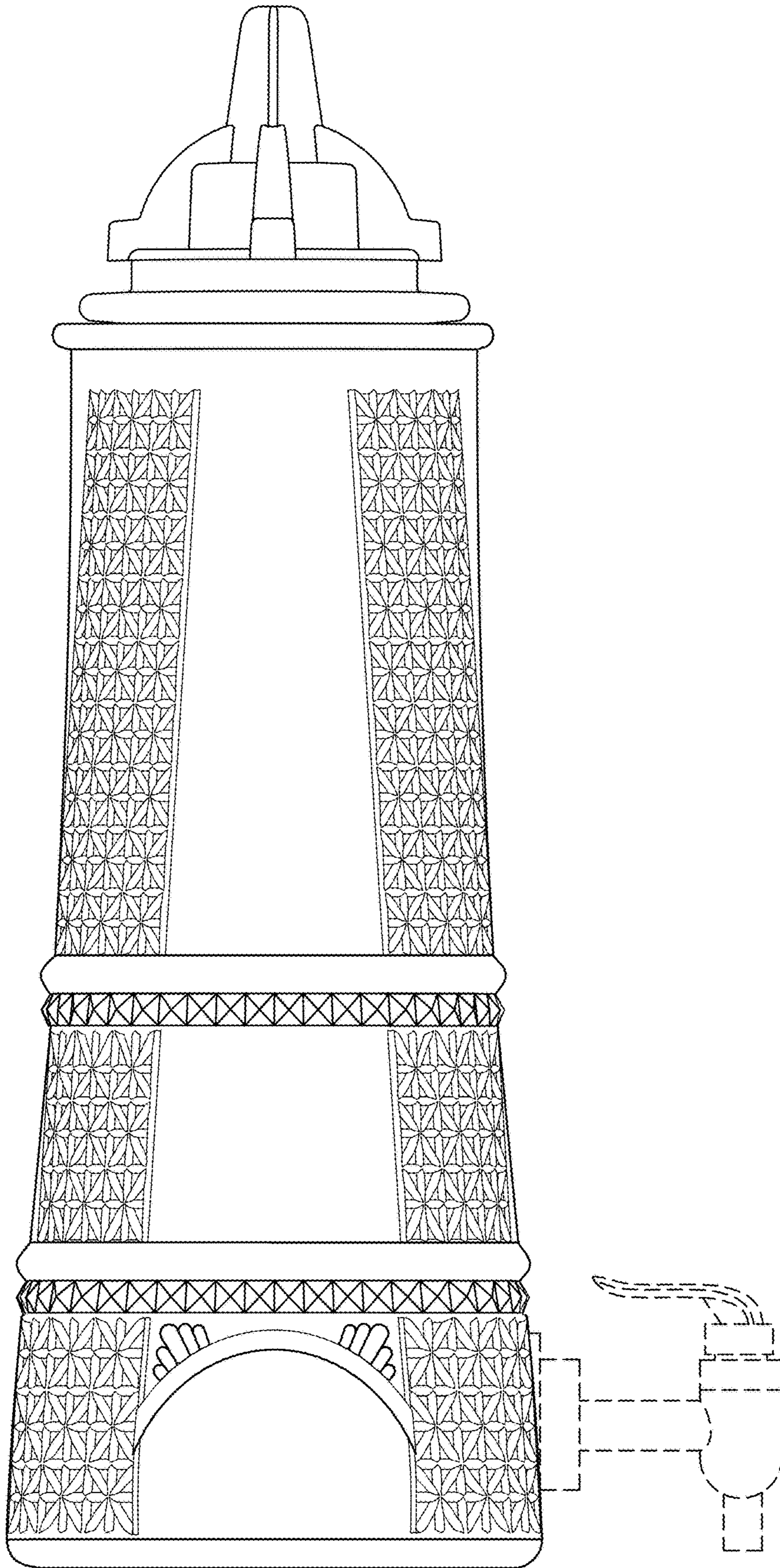

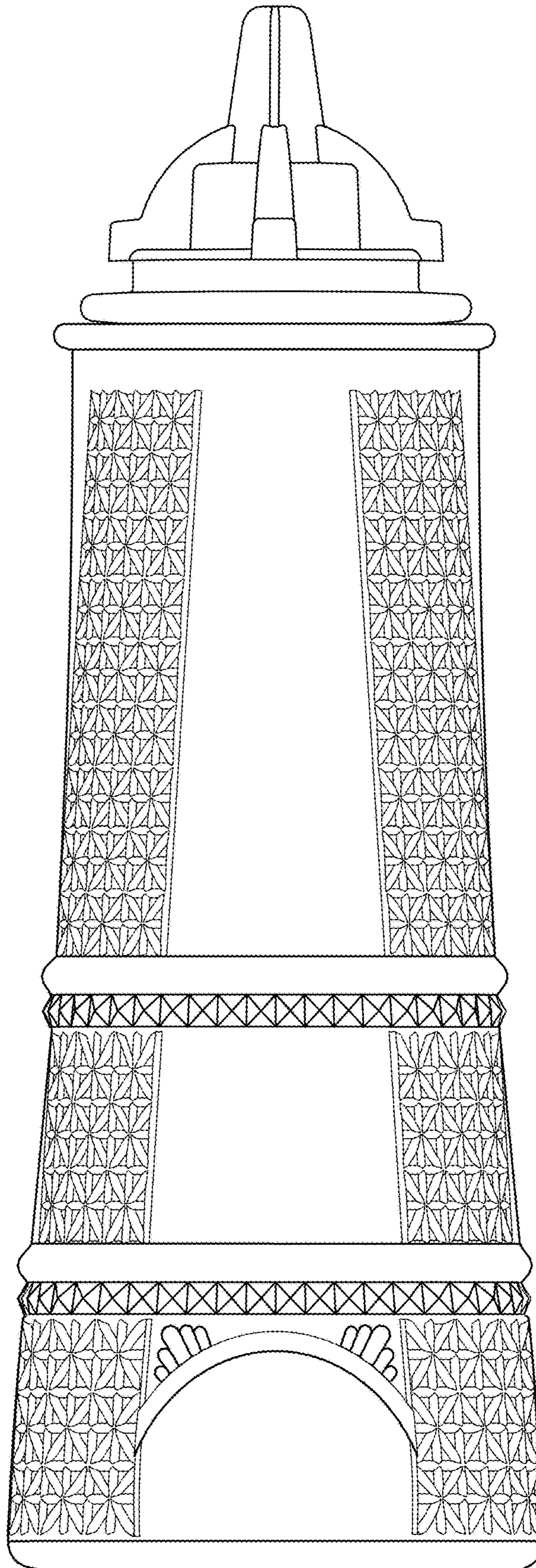

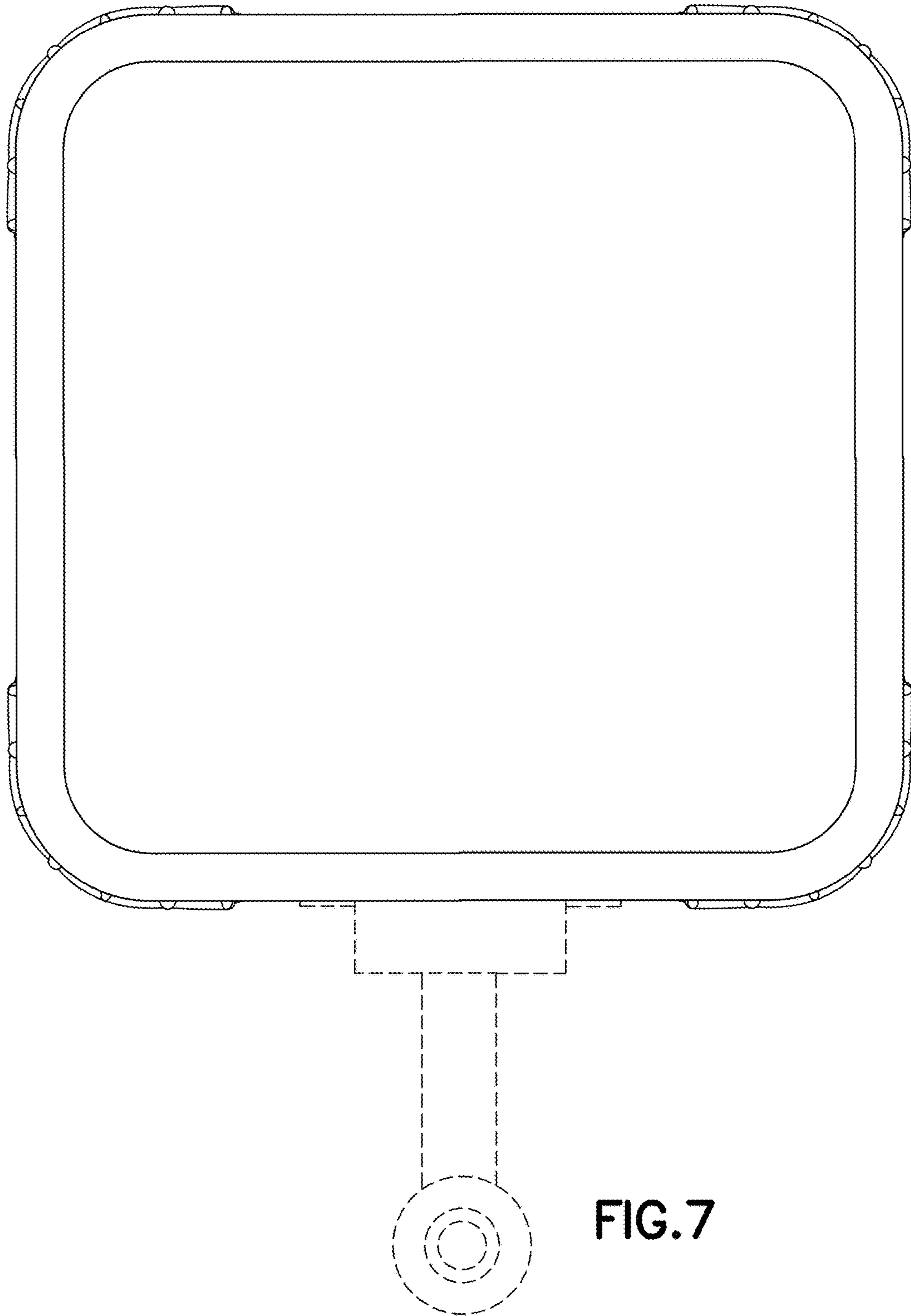
