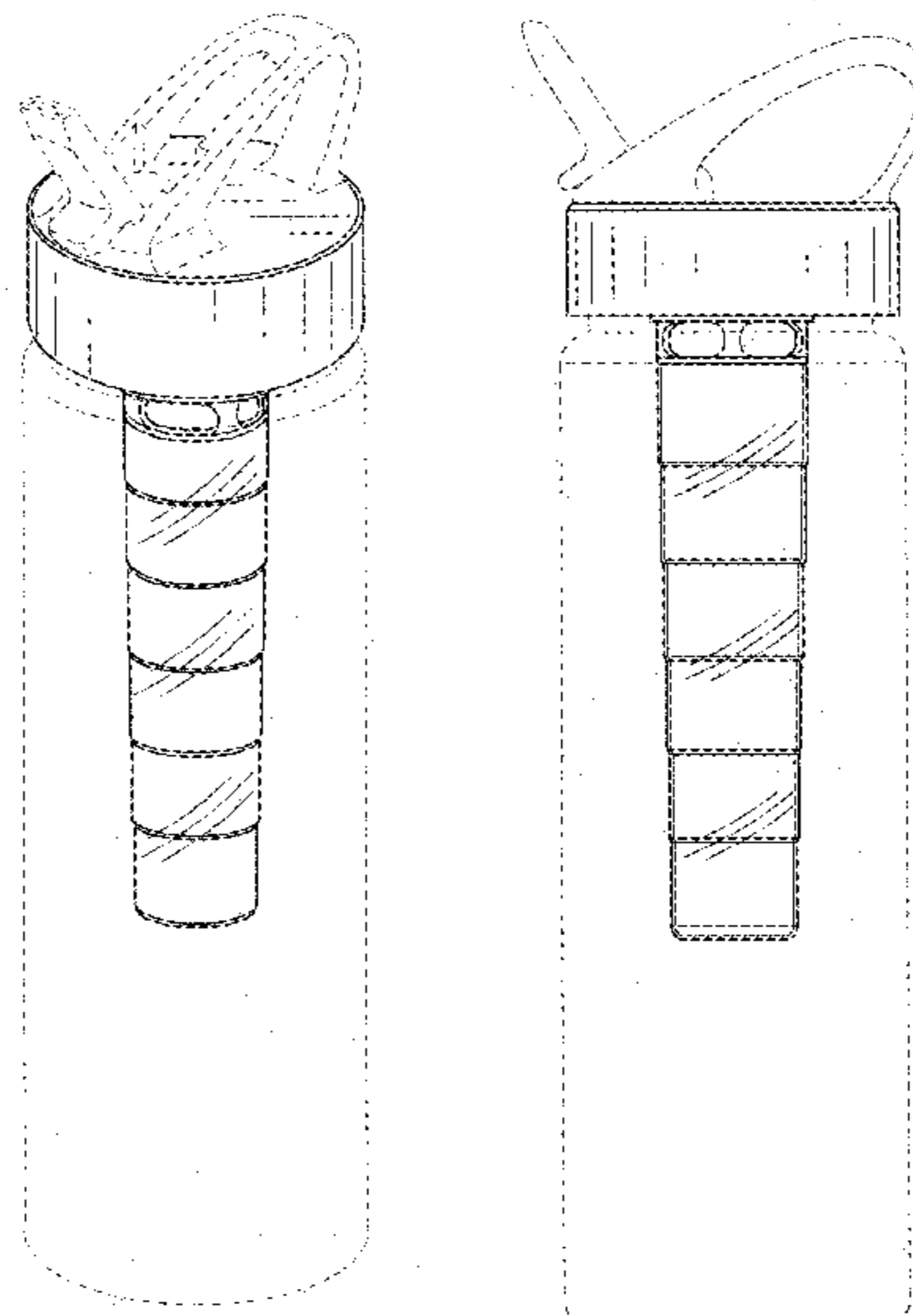
(57) **CLAIM**

The ornamental design for a drinking bottle lid including a coolant container, as shown and described.

**DESCRIPTION**

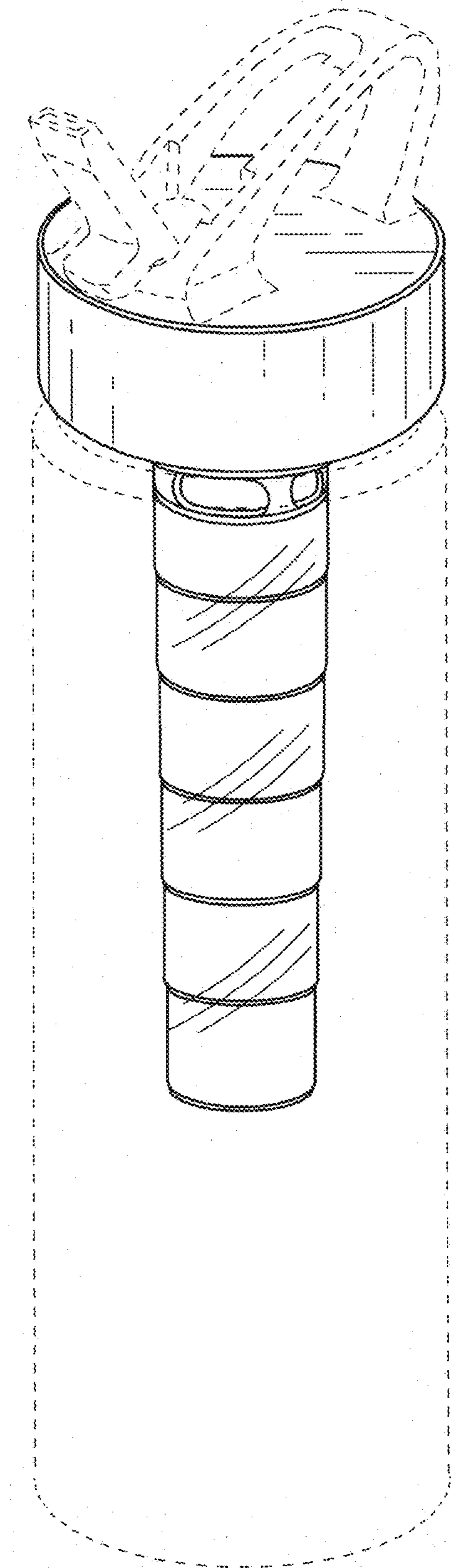

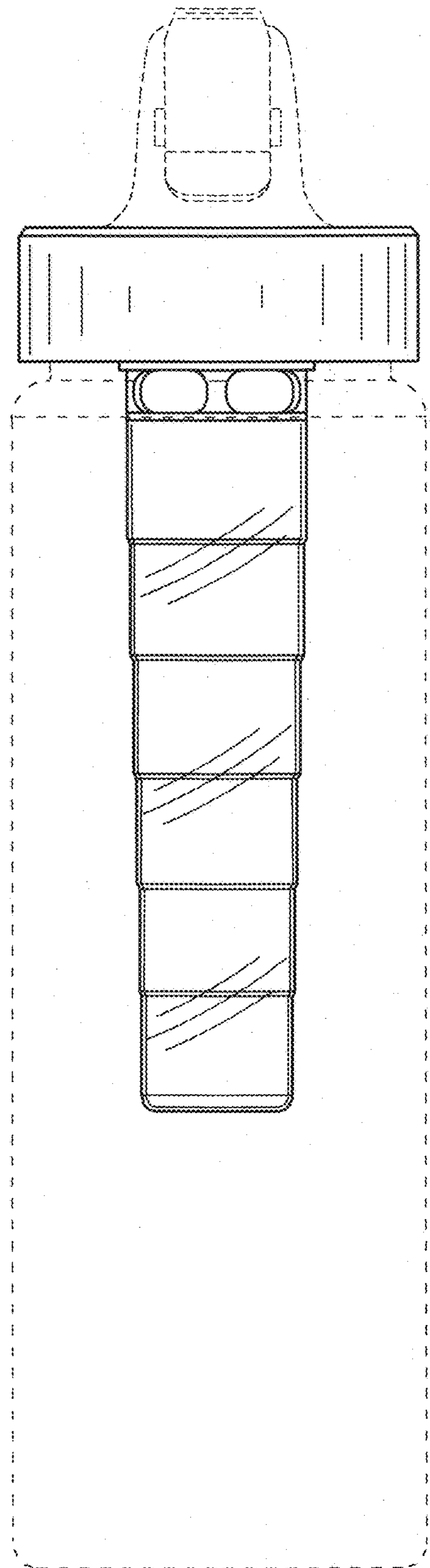

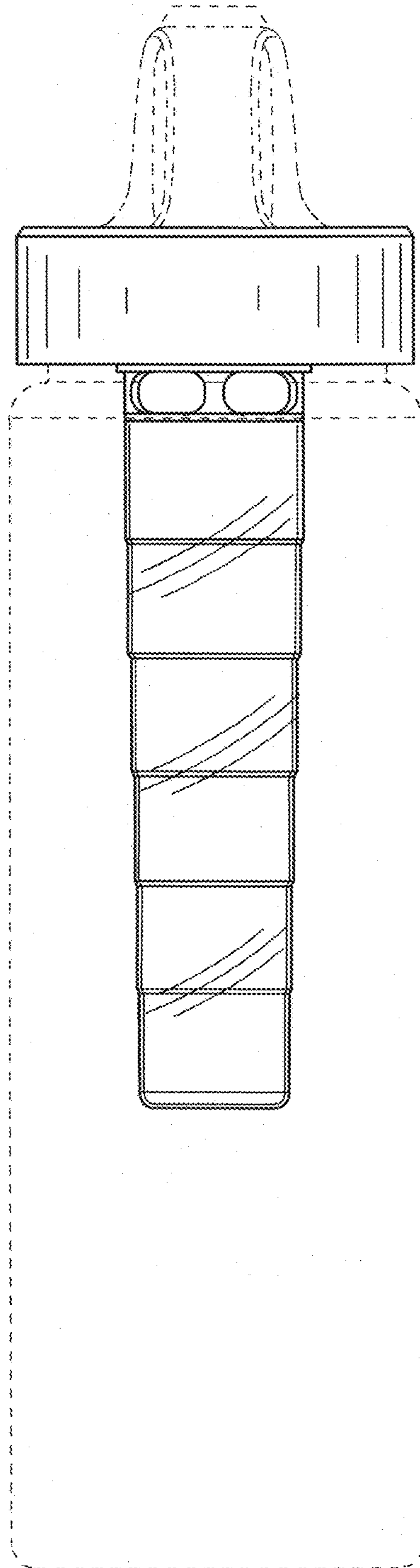
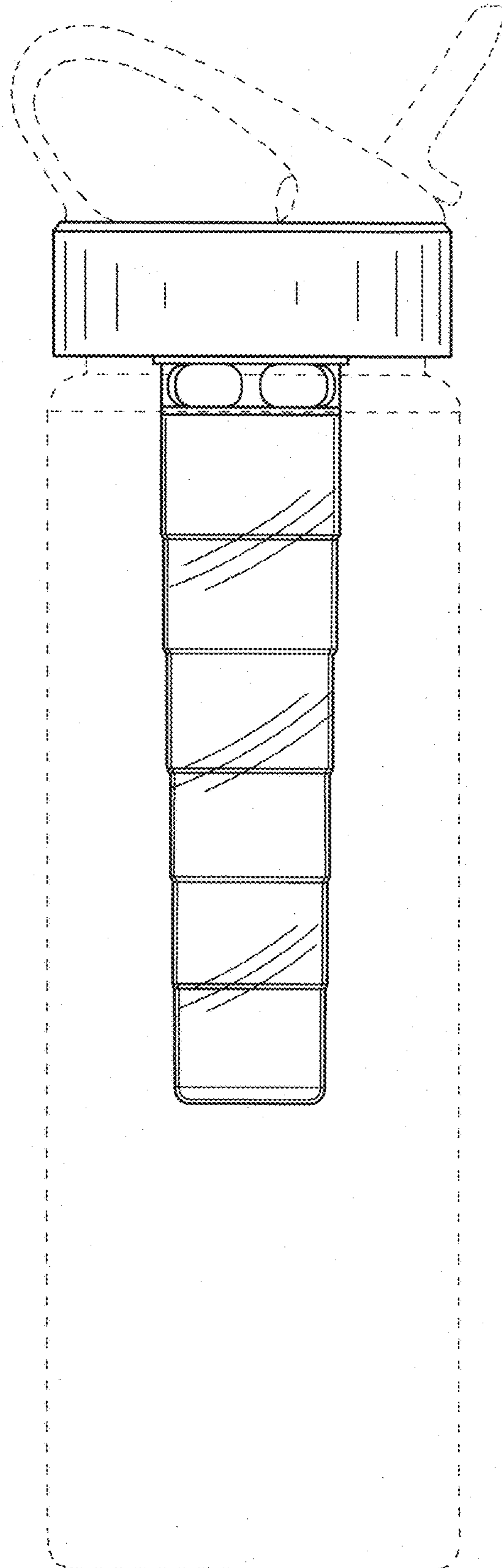

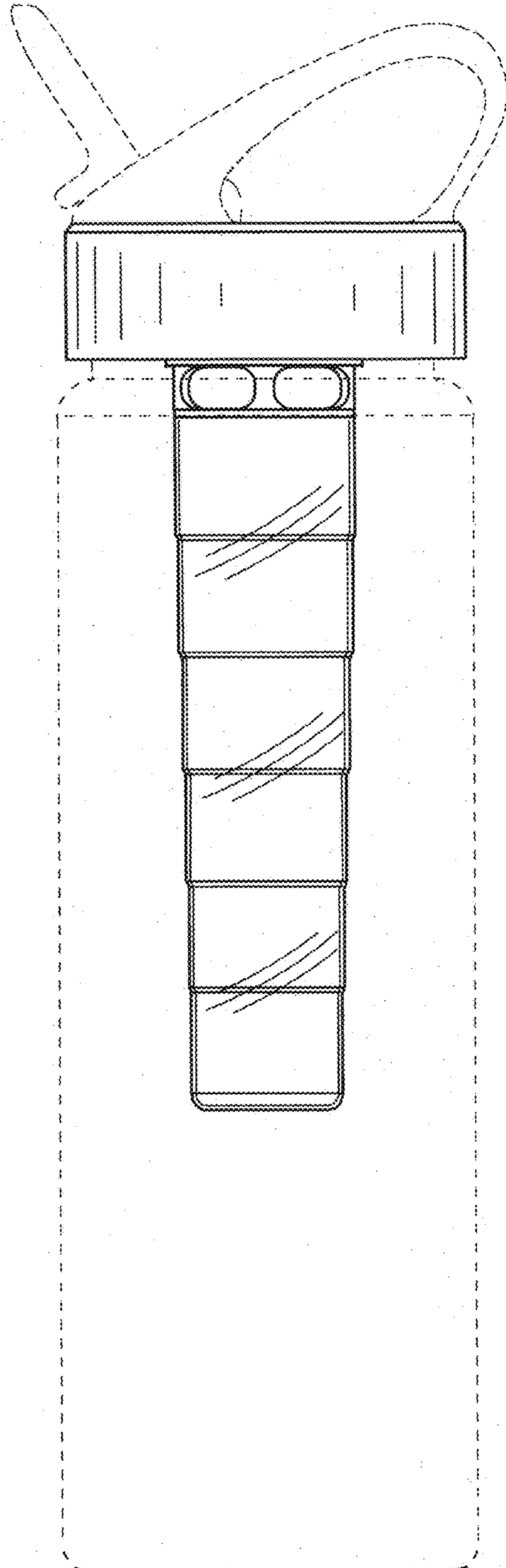
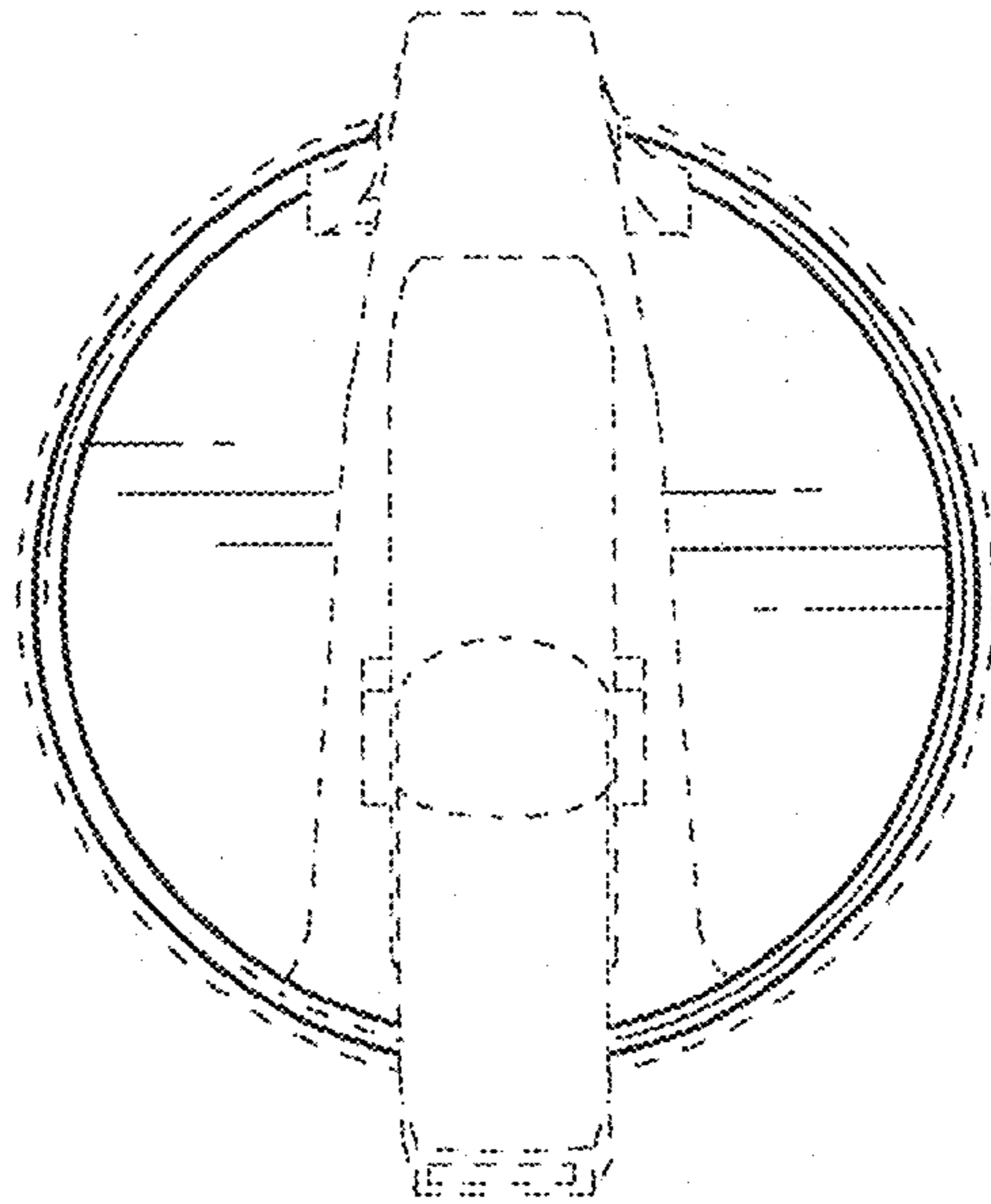
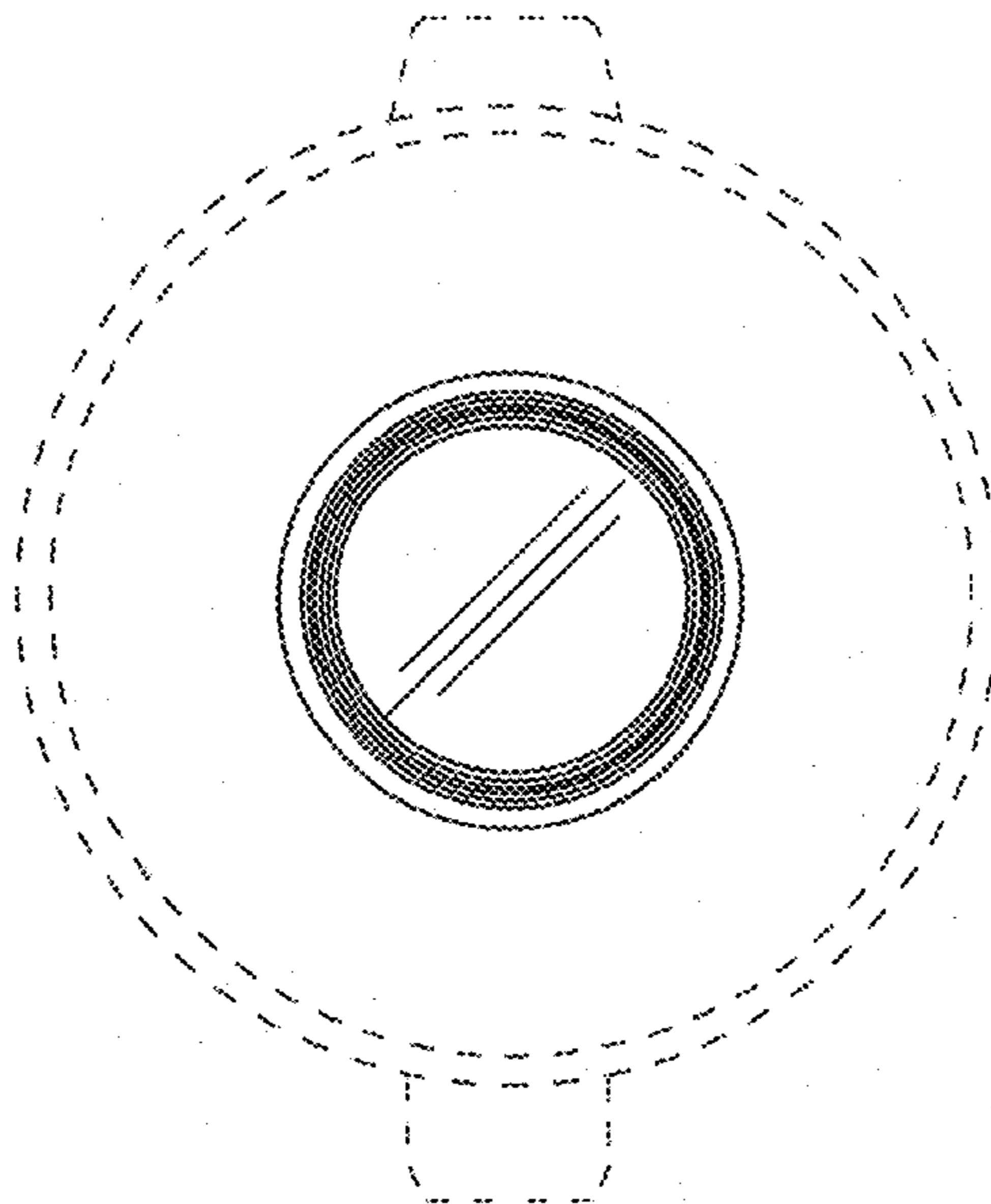

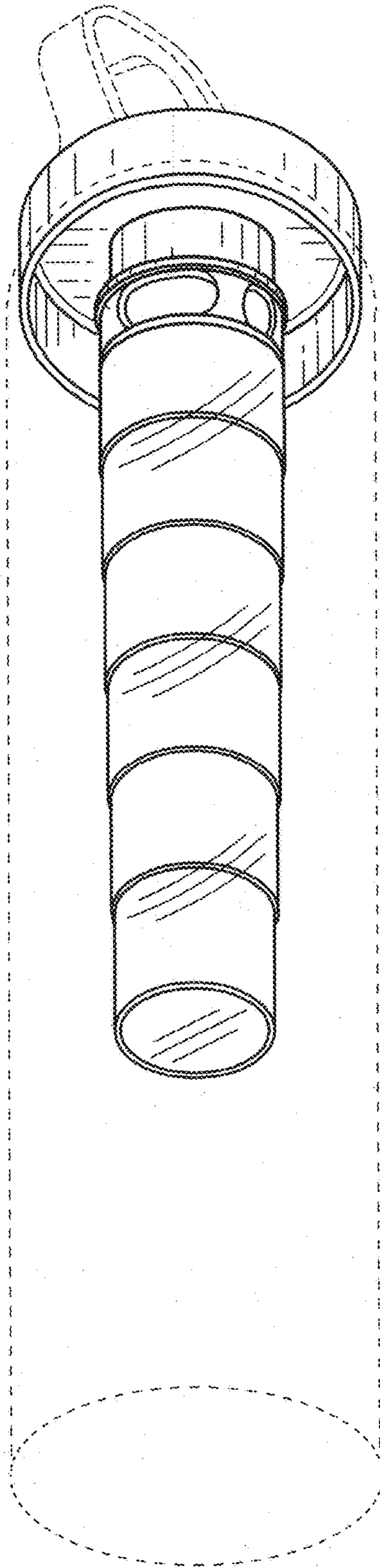
