FIG. 2 is a side elevational view of a perform for a bottle closure;

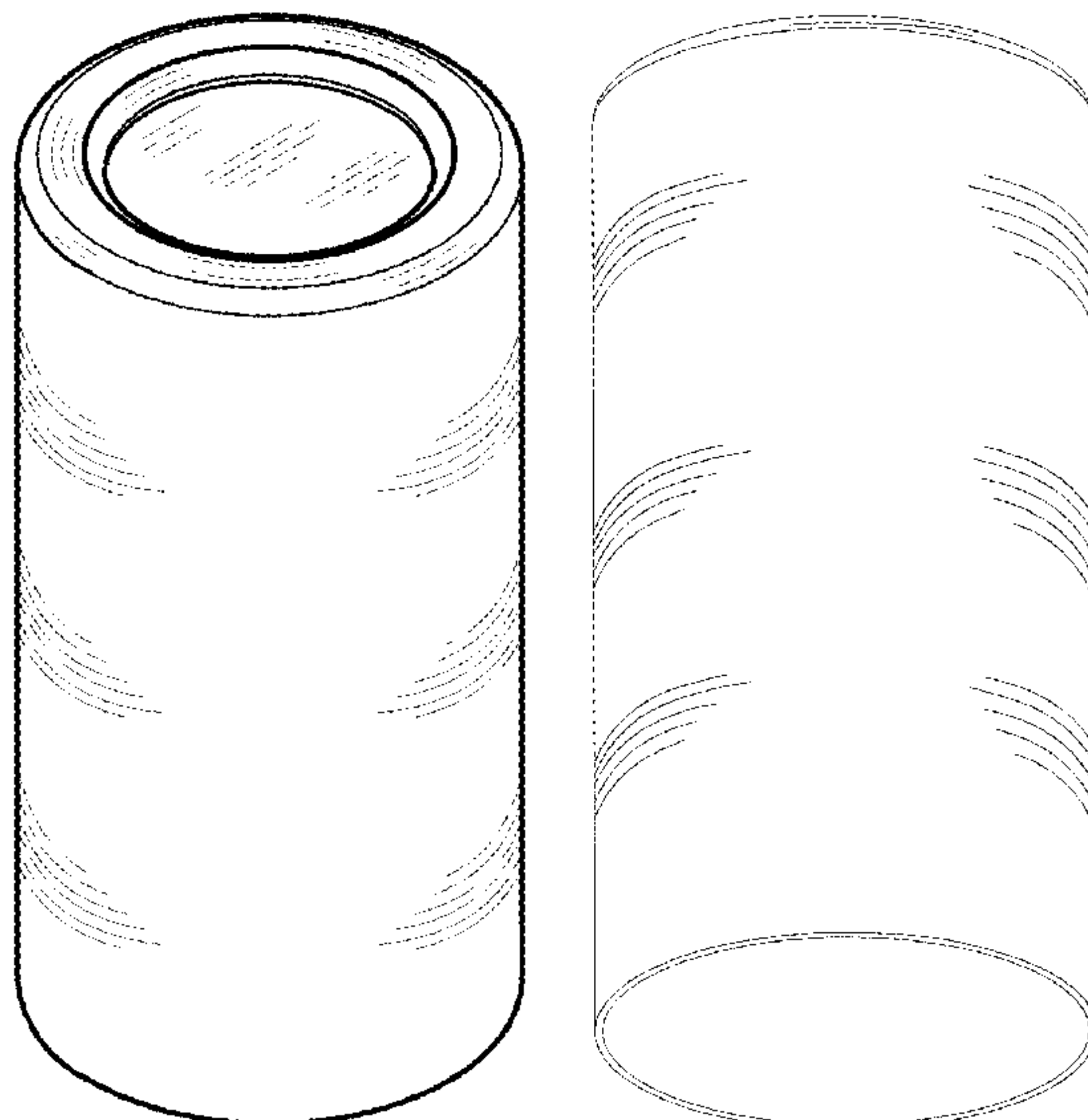
FIG. 3 is a top plan view thereof;

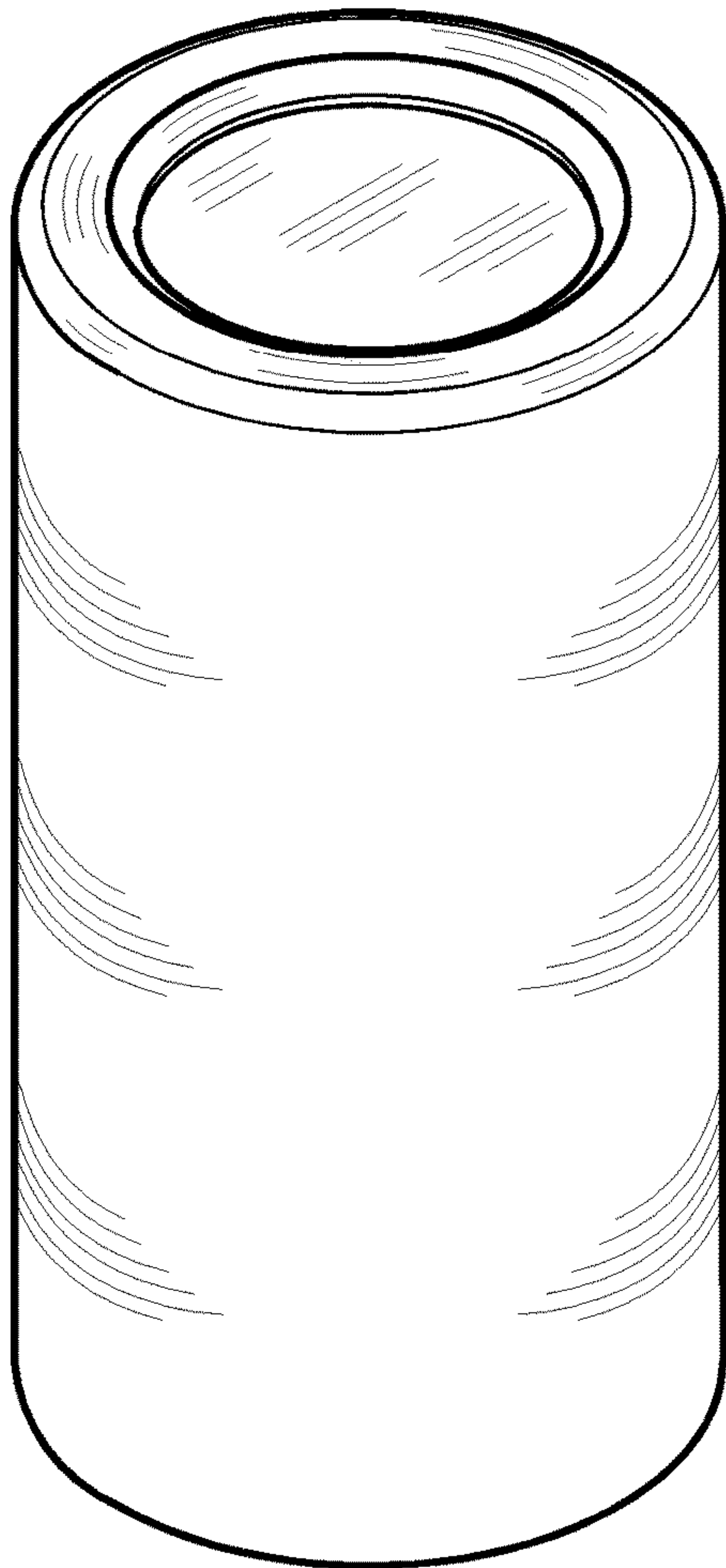

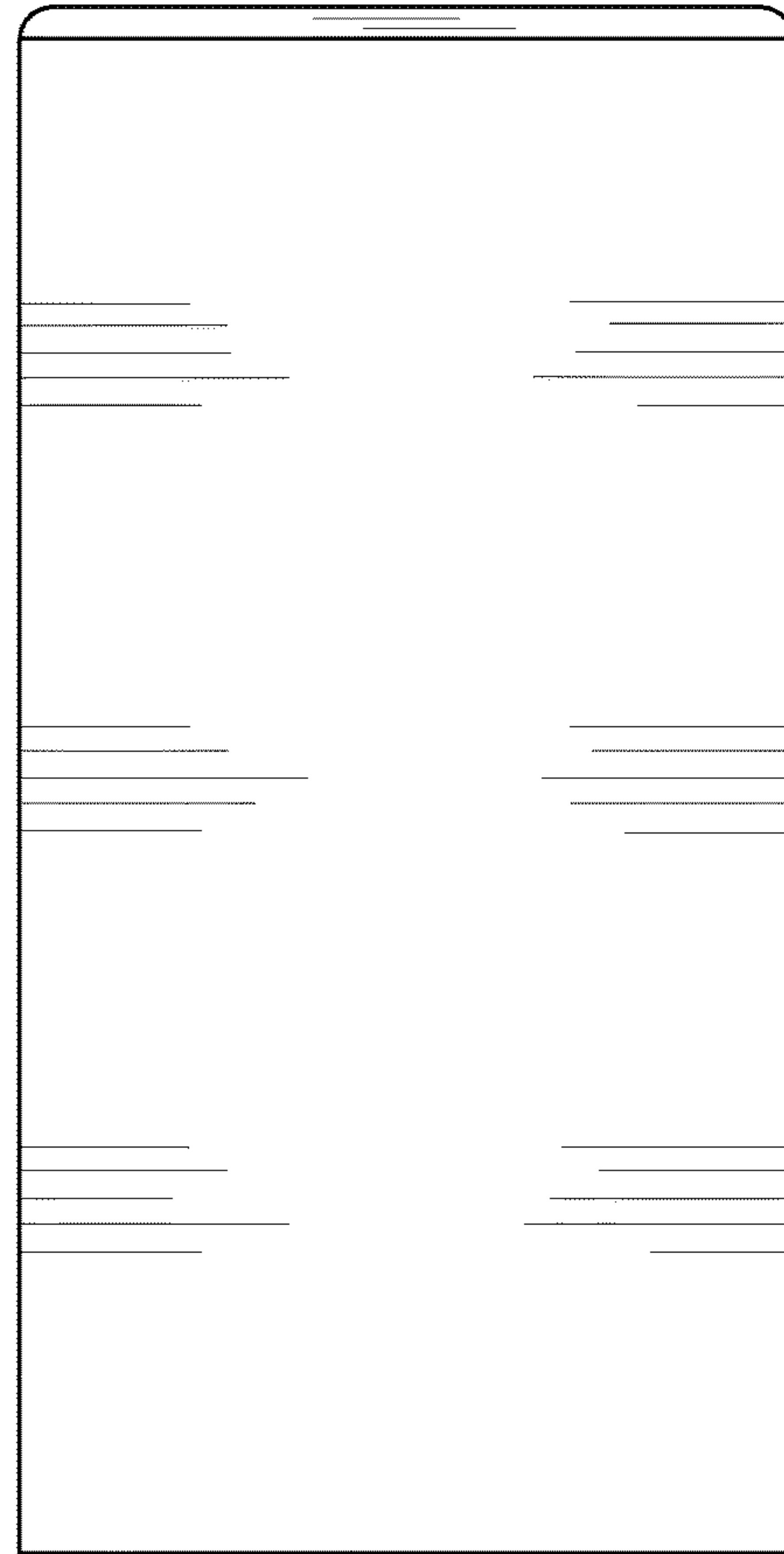

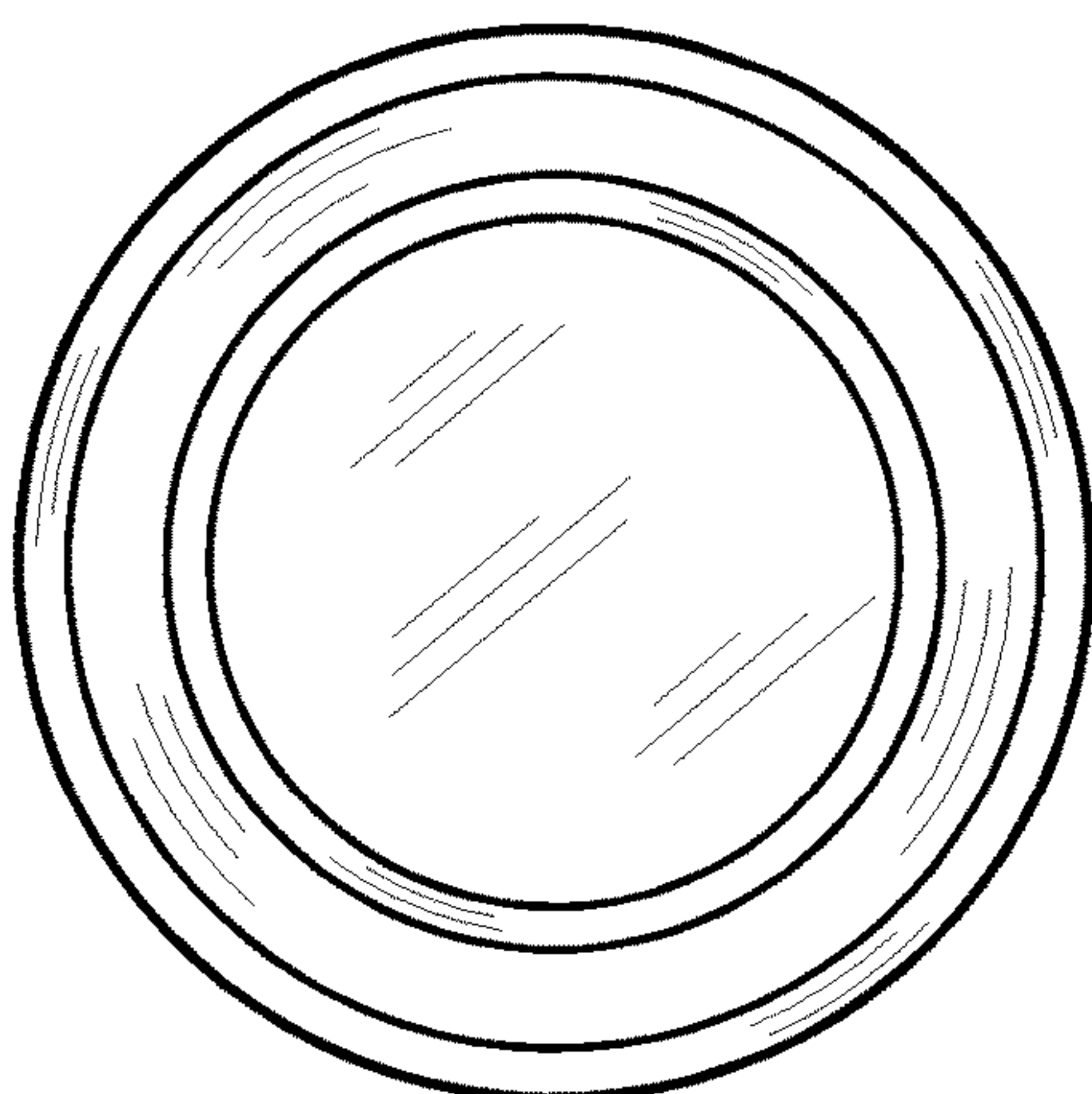

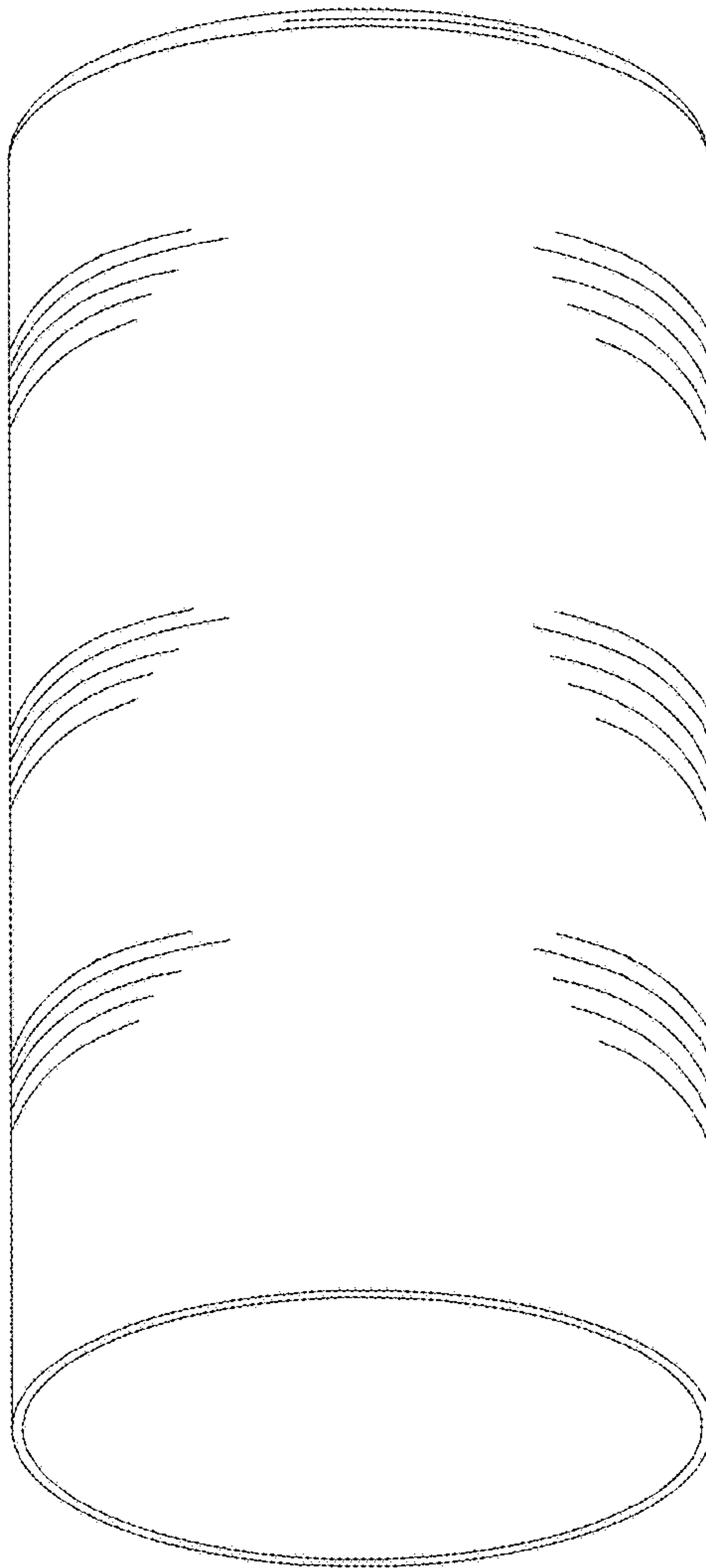

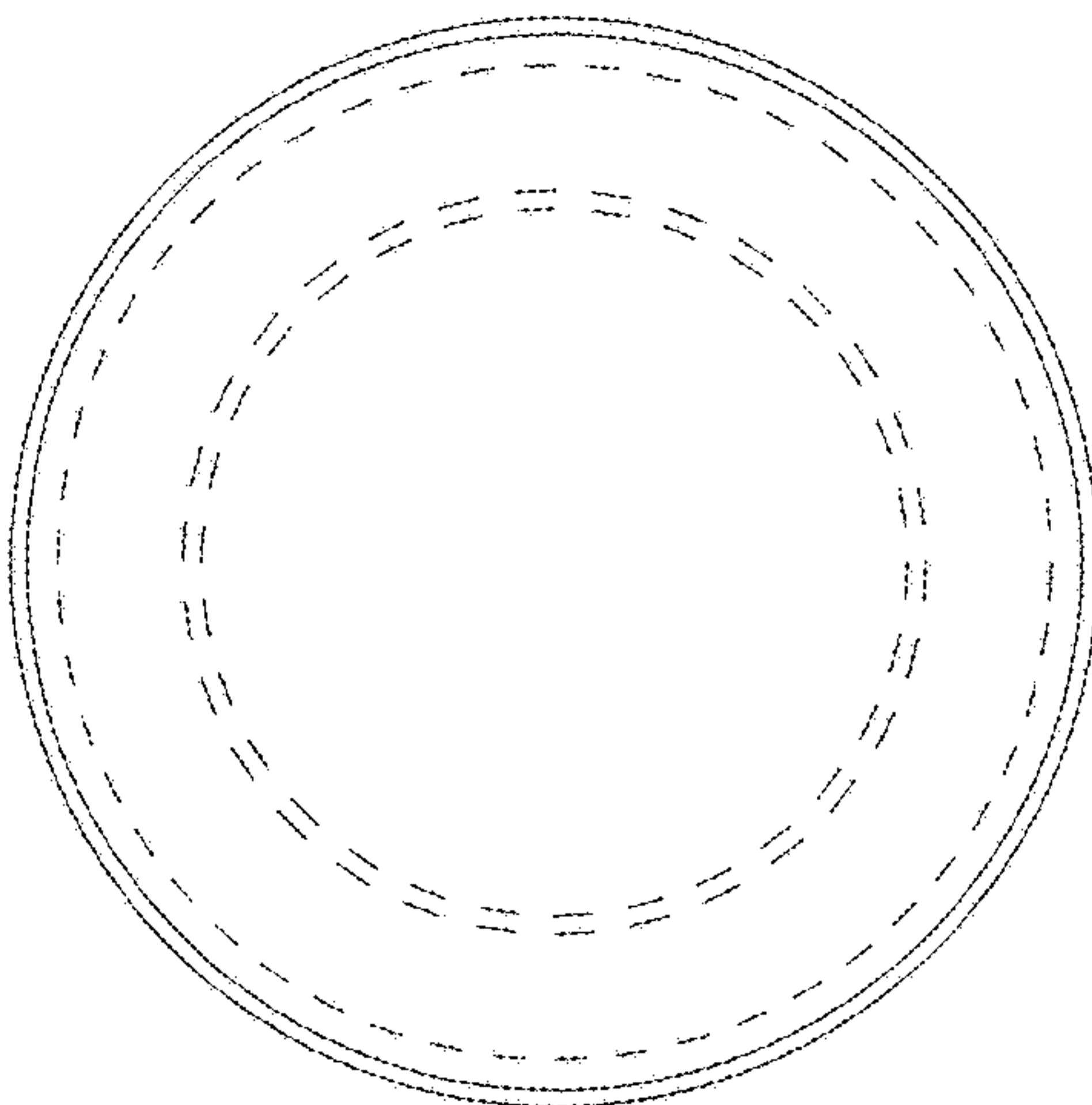
