**DESCRIPTION**

FIG. 1 is a front perspective view of a bottle, showing my design;

FIG. 2 is a rear perspective view thereof;

FIG. 3 is a front elevational view thereof;

FIG. 4 is a right side elevational view thereof, with the left side being a mirror image of the right side;

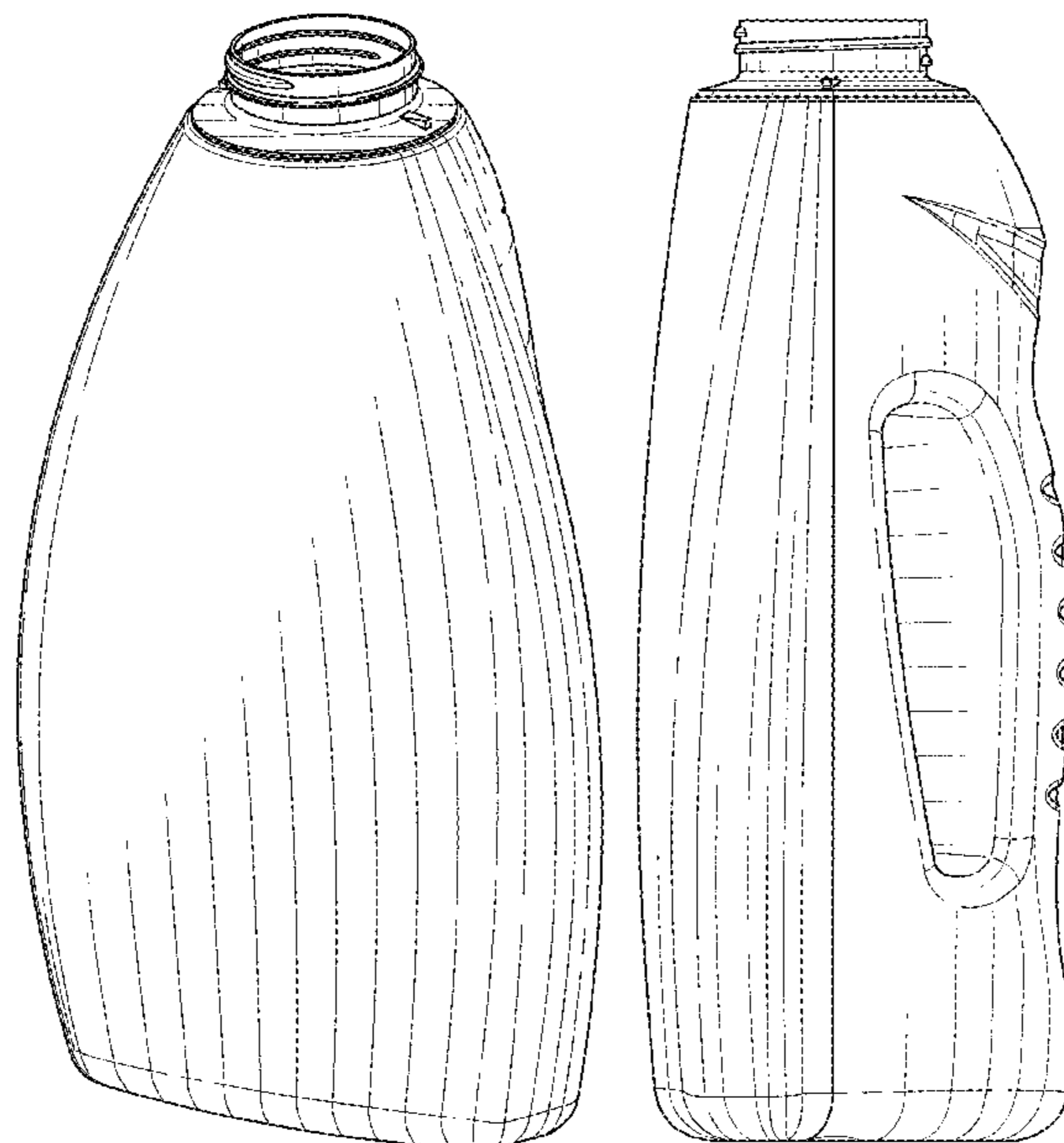
FIG. 5 is a rear elevational view thereof;

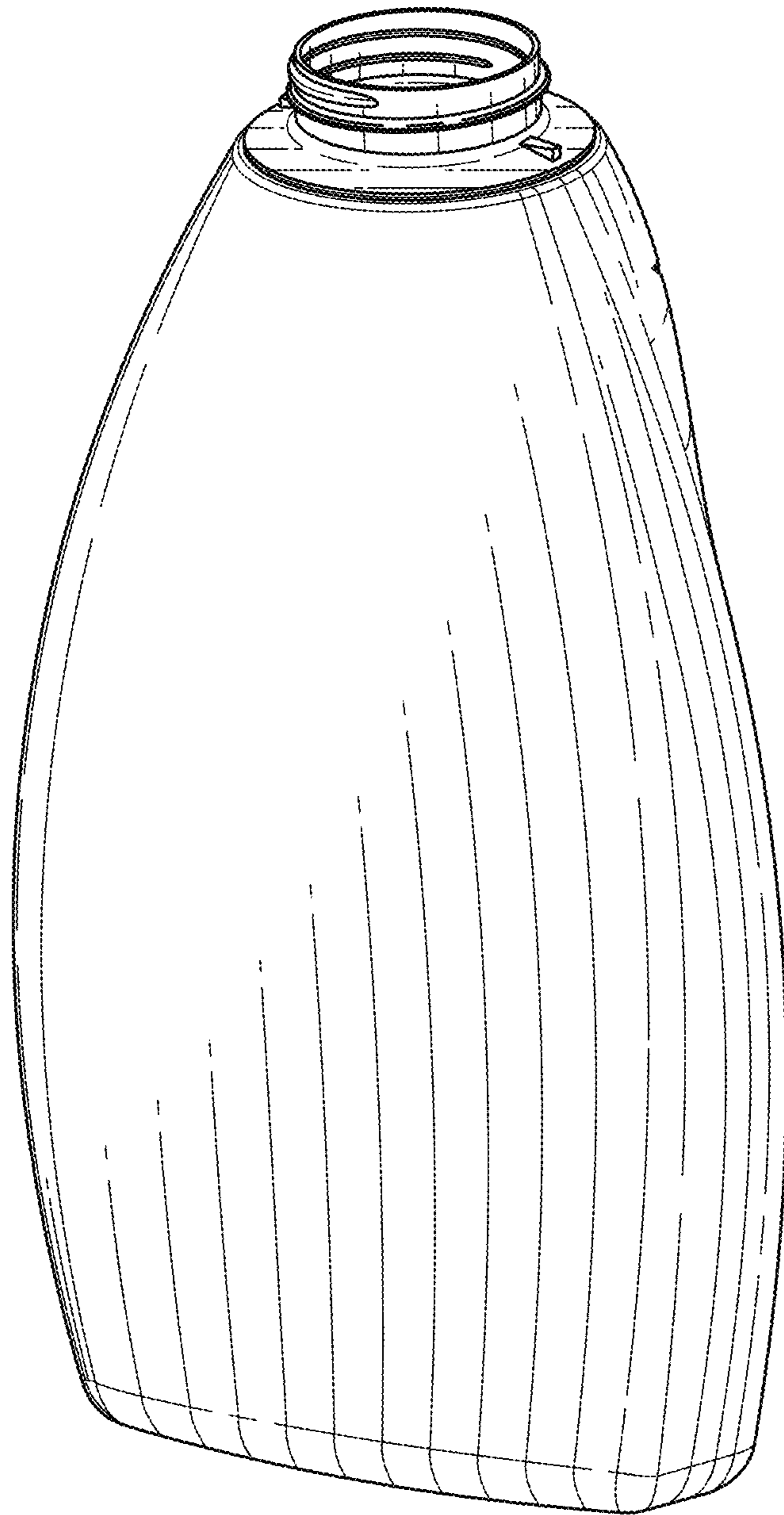

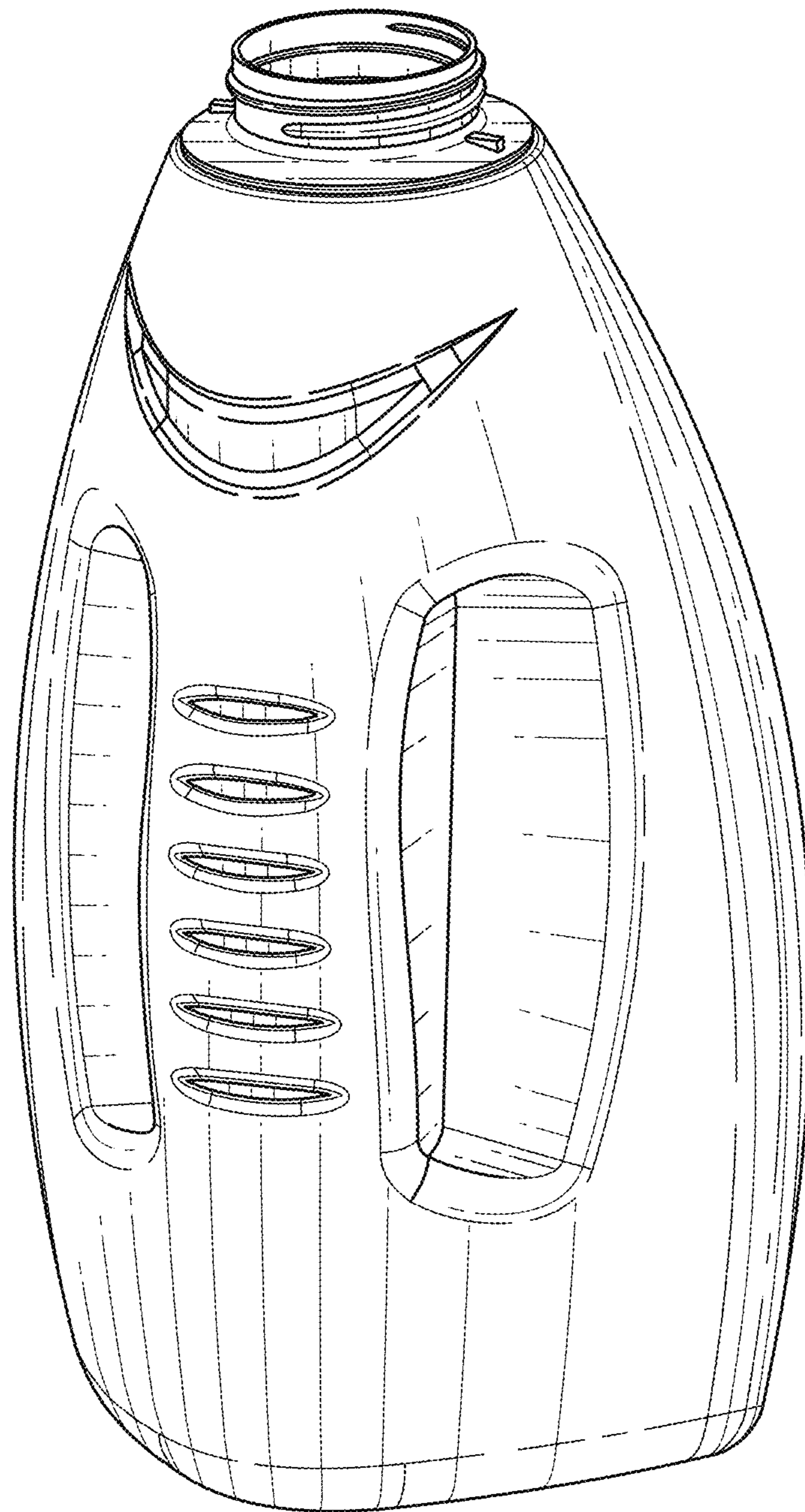

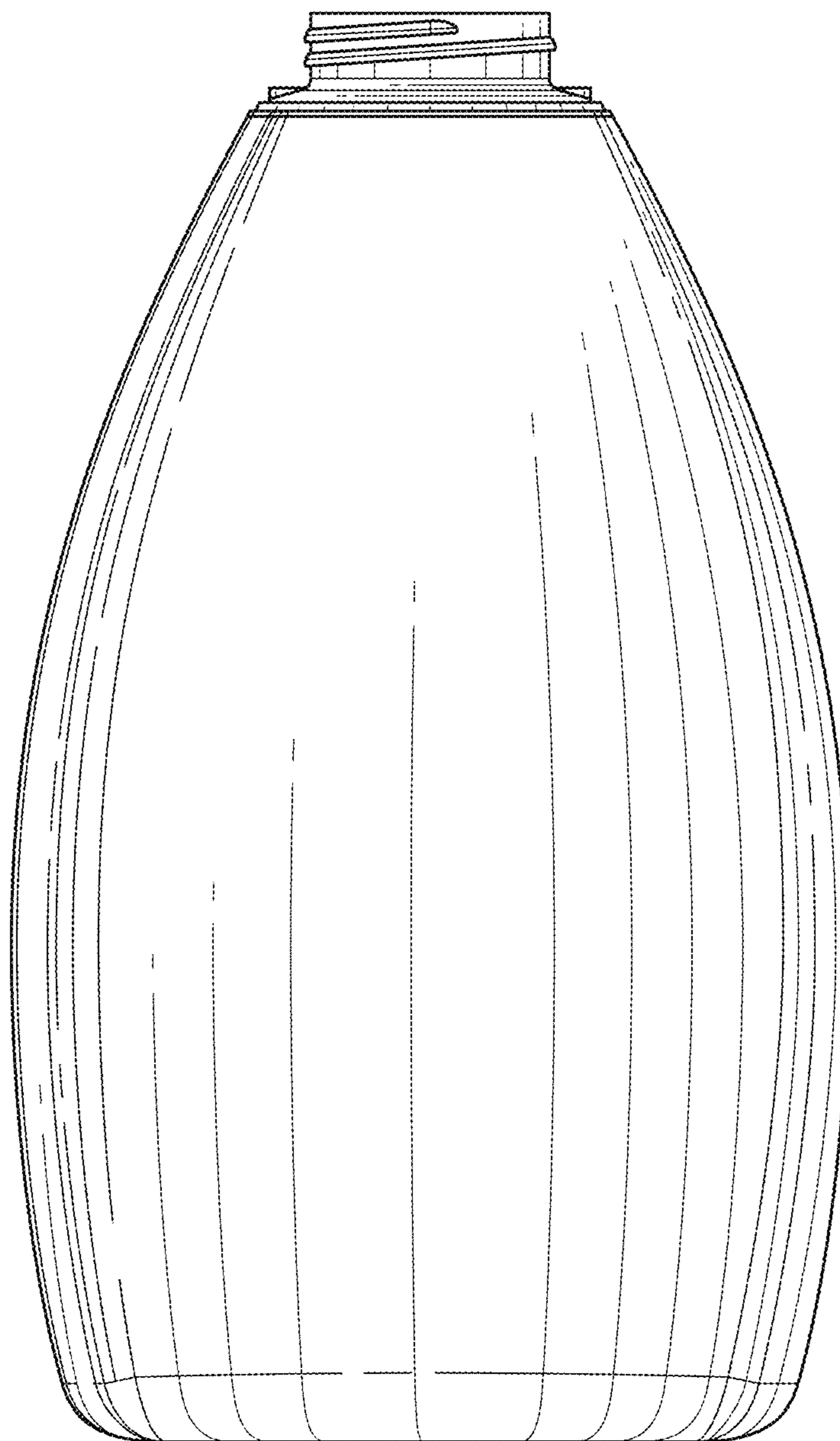

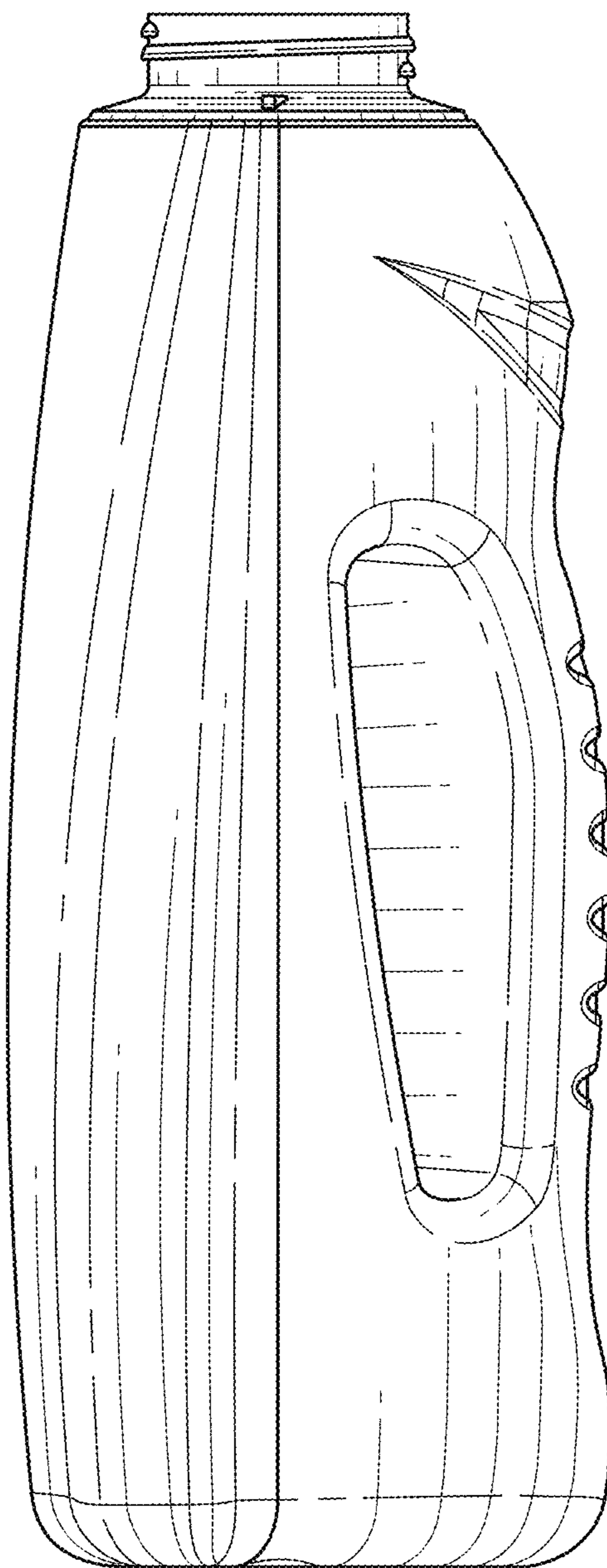

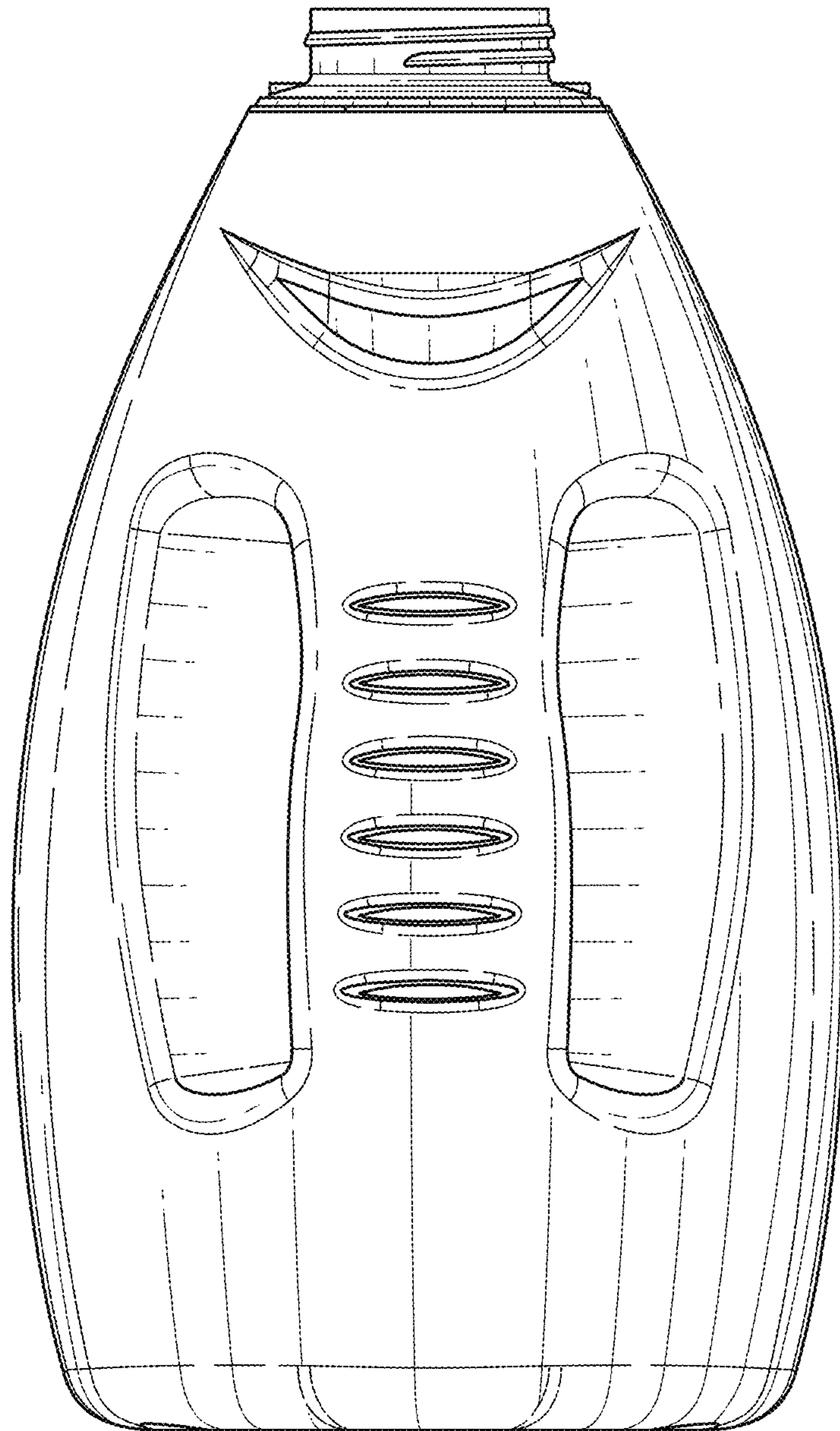

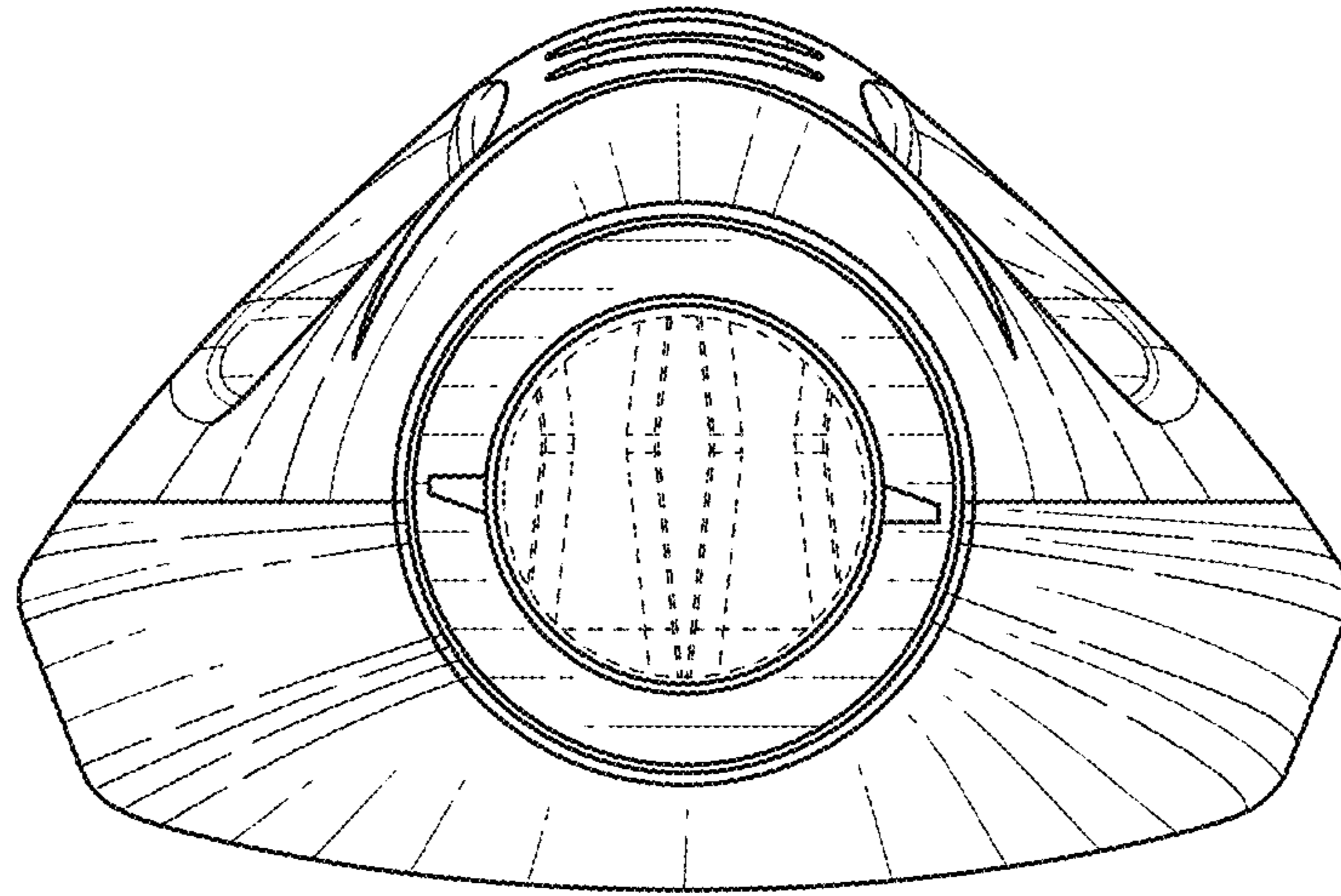

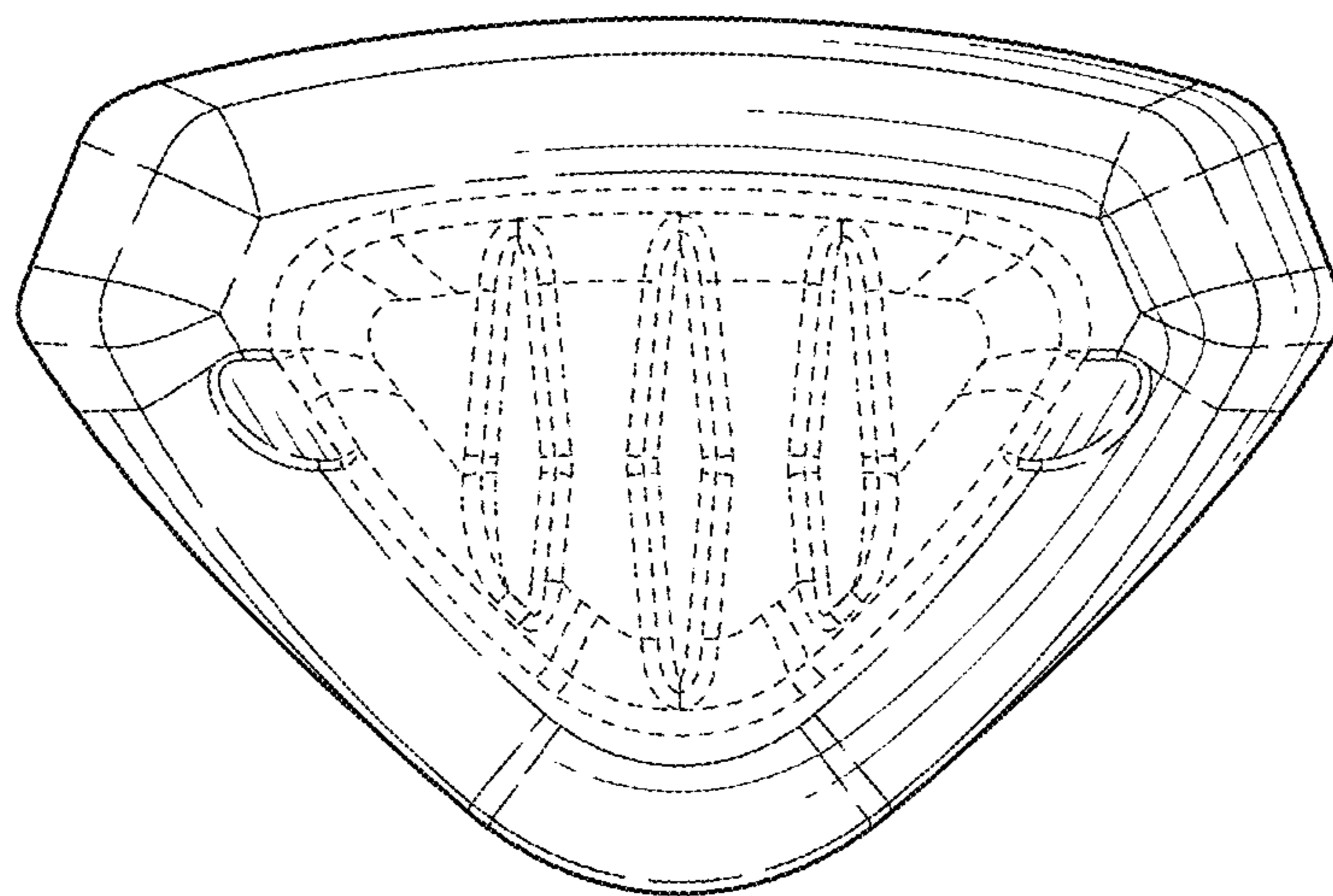
