FIG. 3 is a rear view of the grillwork;

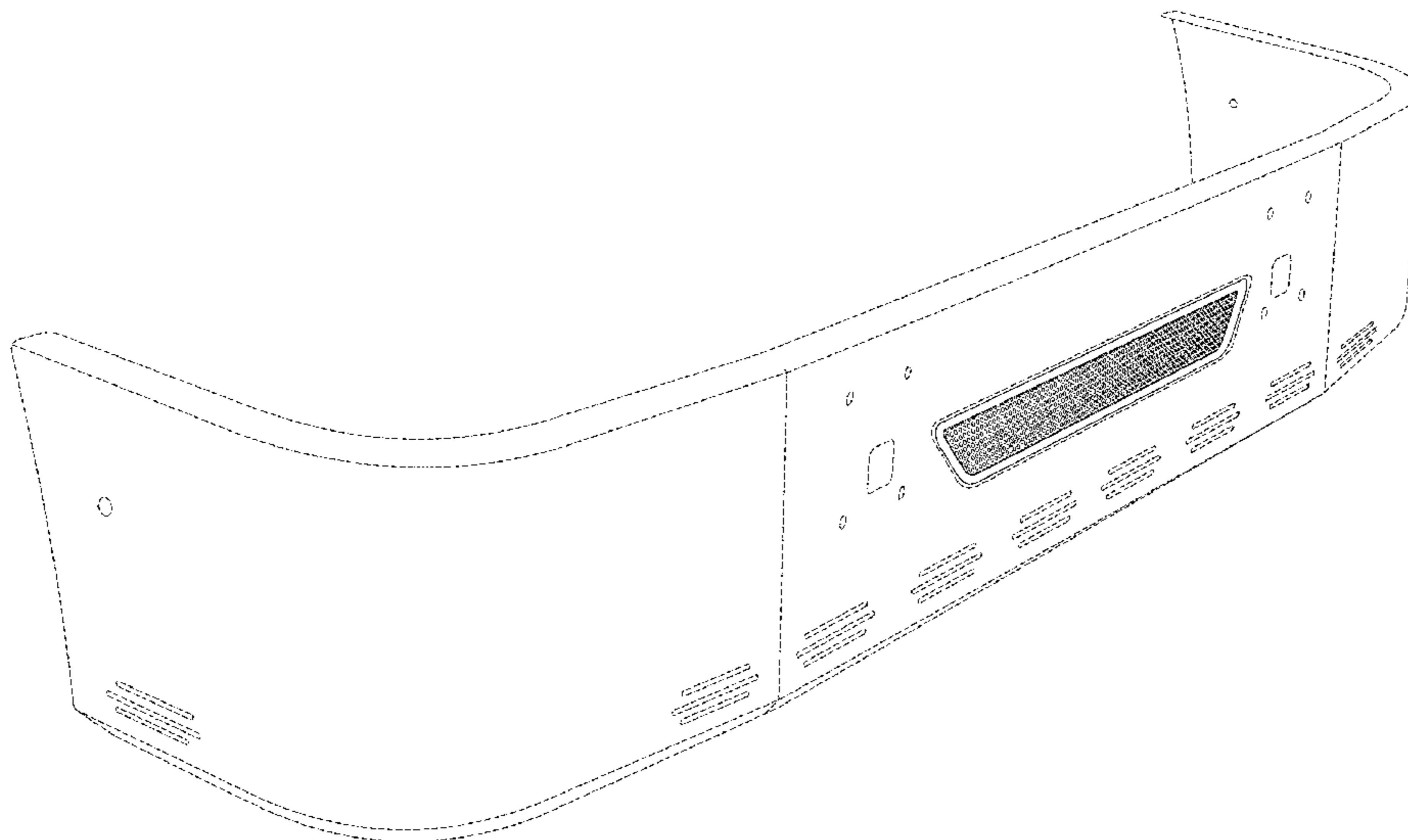
FIG. 4 is a top view of the grillwork;

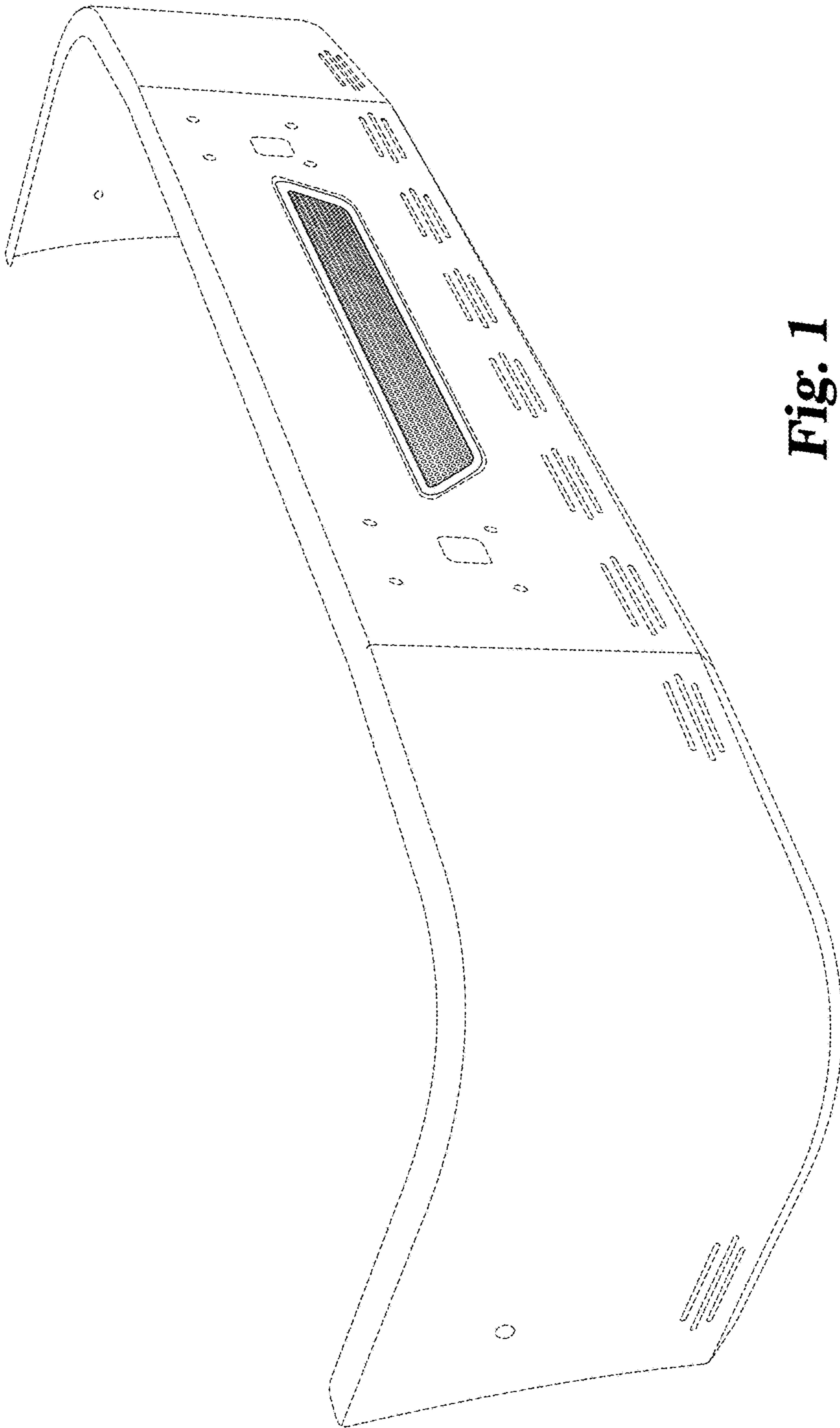
FIG. 5 is a bottom view of the grillwork;

FIG. 6 is a left side view of the grillwork; and,

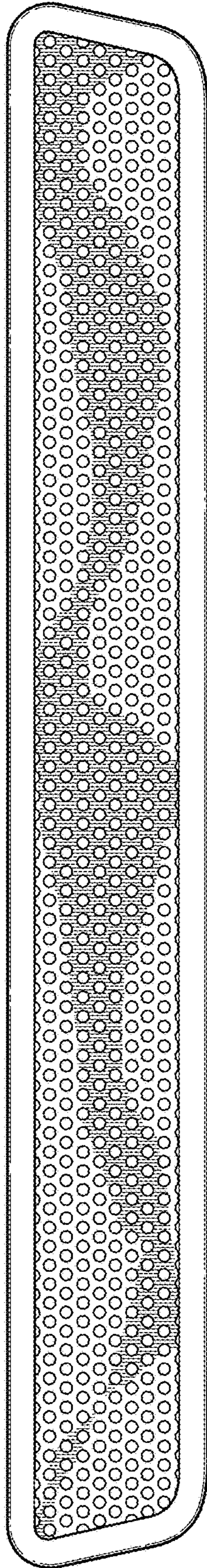
FIG. 7 is a right side view of the grillwork.

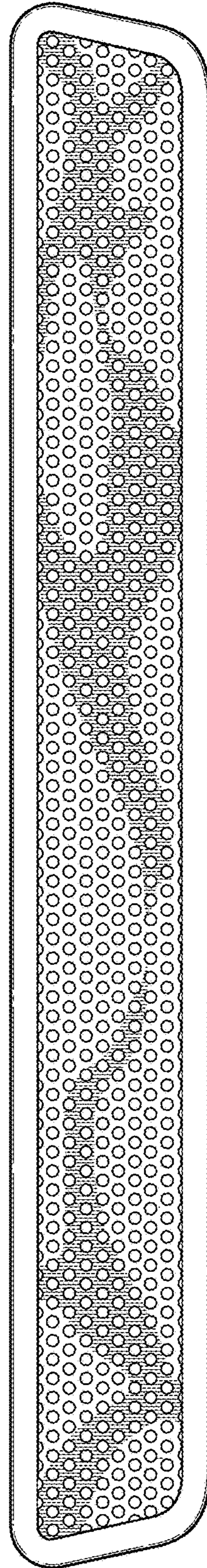

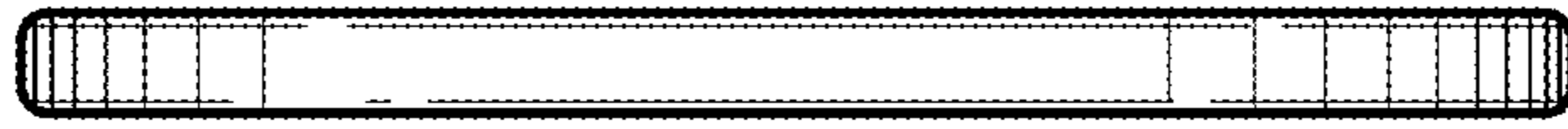
