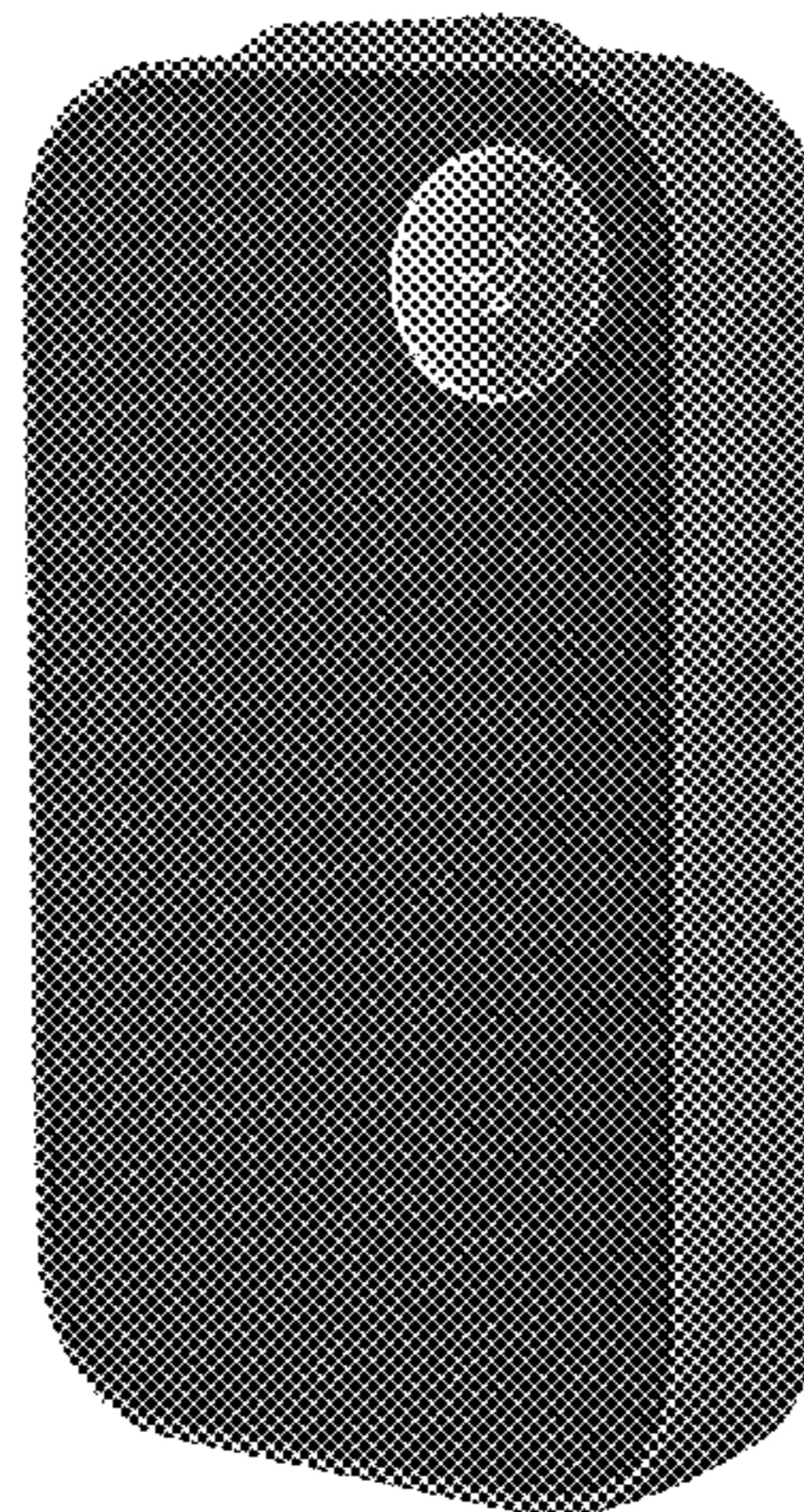
(57) **CLAIM**

**DESCRIPTION**

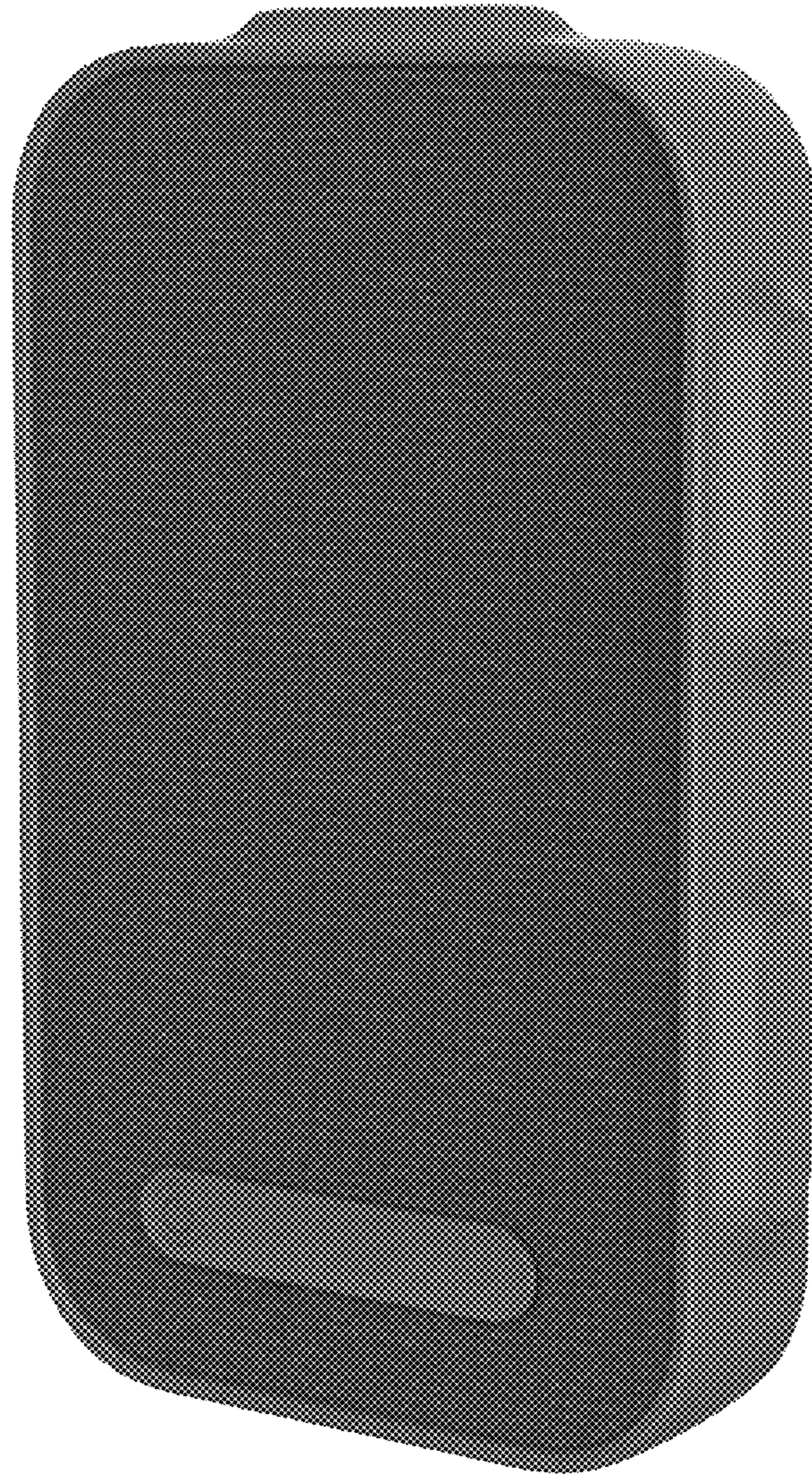
Figure 3.1 is a perspective view of a portable bluetooth speaker showing the new design;

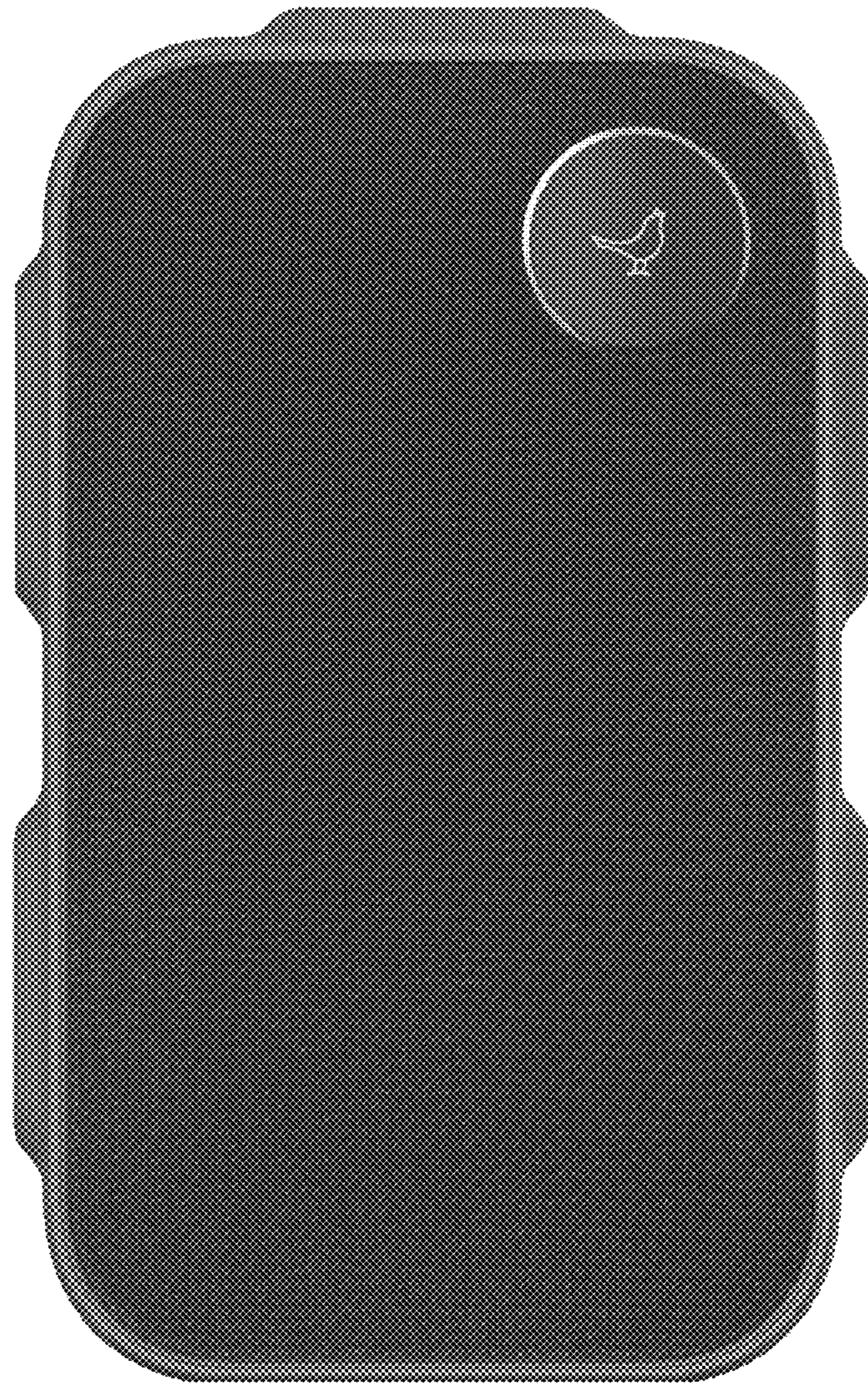


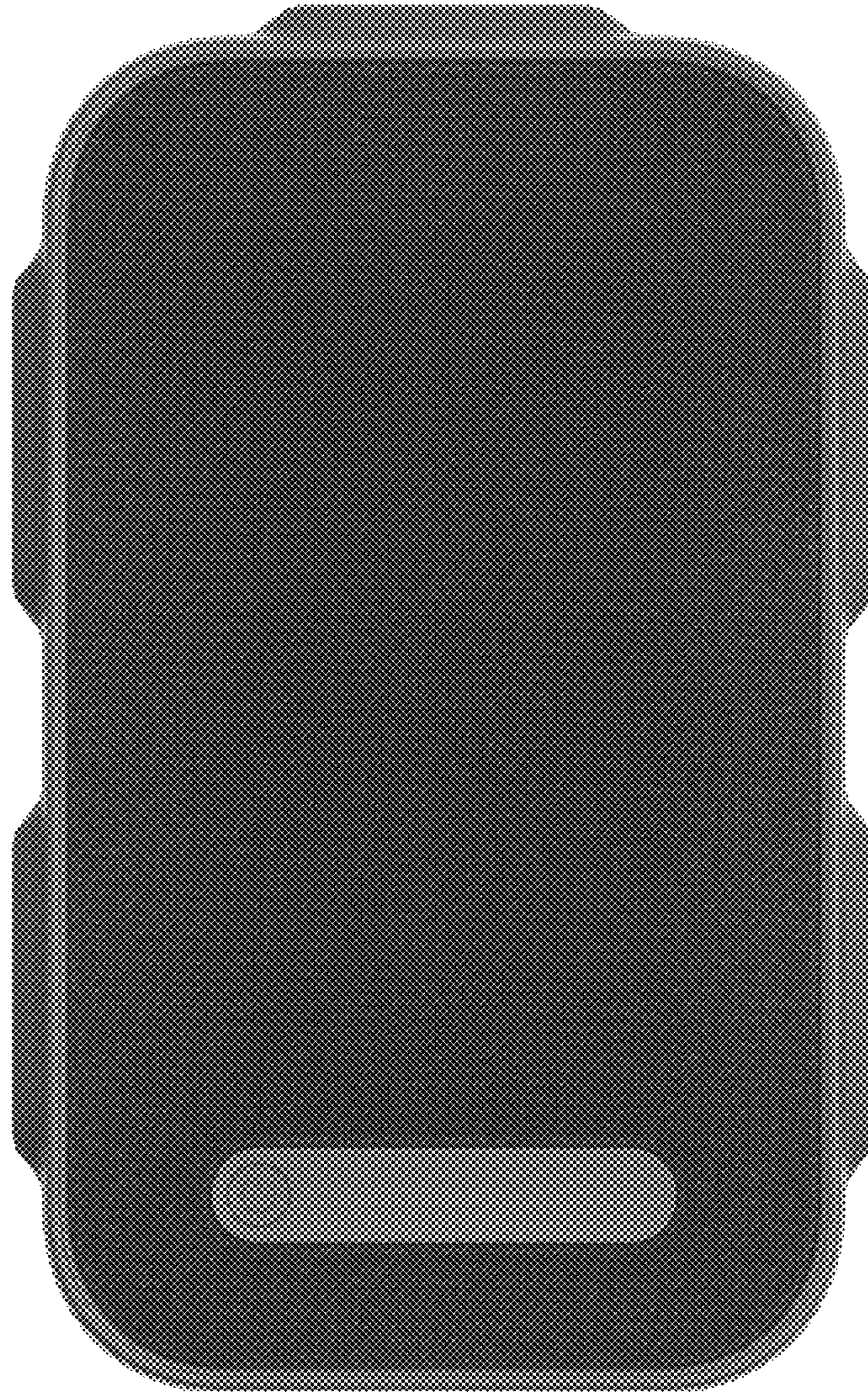

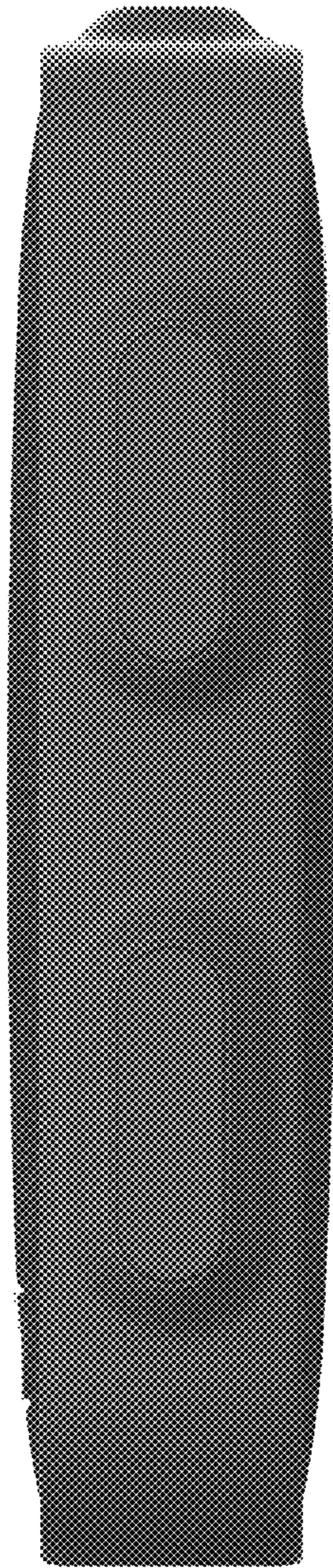

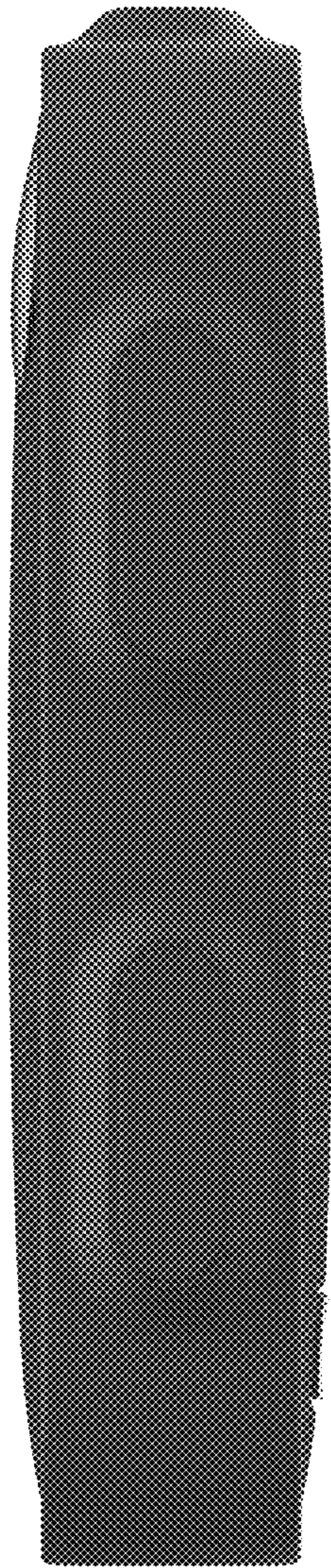




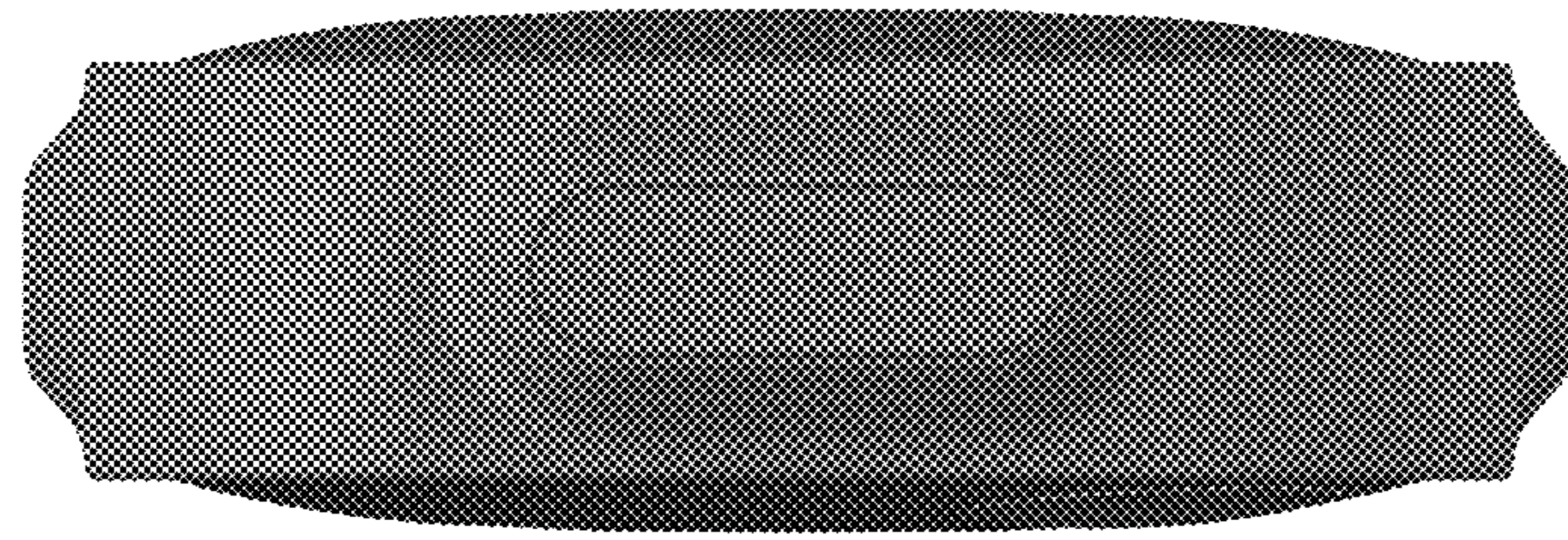

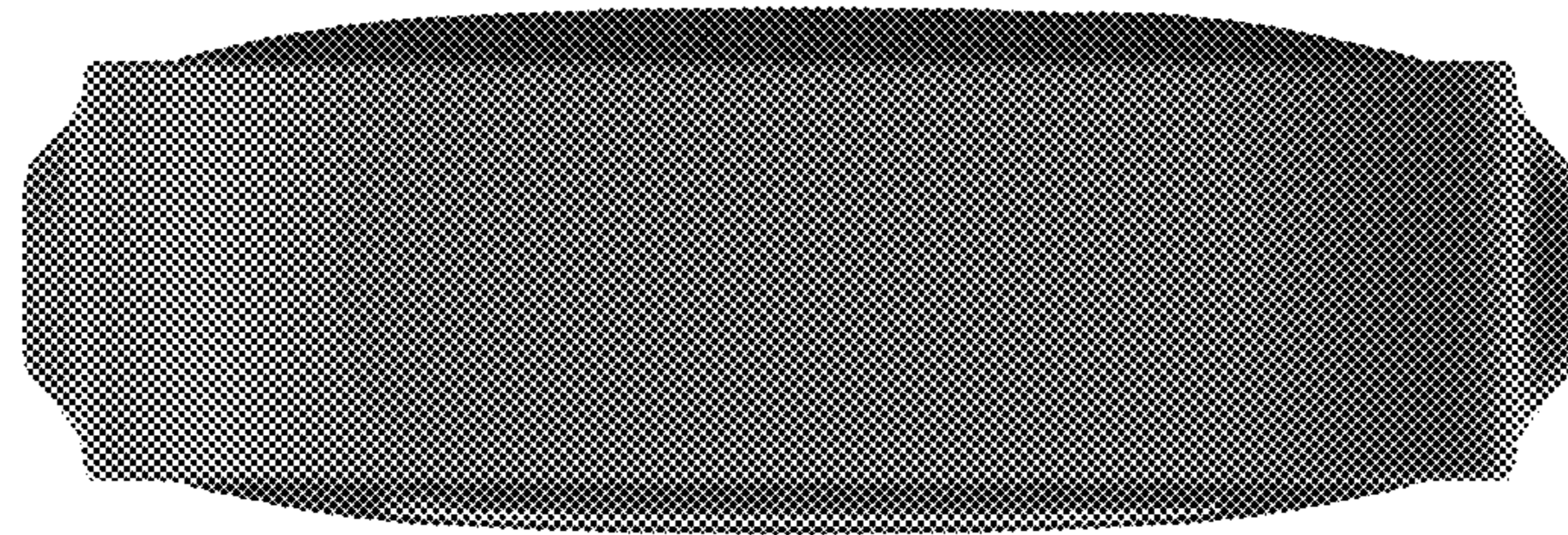
