DESCRIPTION

FIG. 1 is a front perspective view of a case for electronic
devices showing my new design;

case;

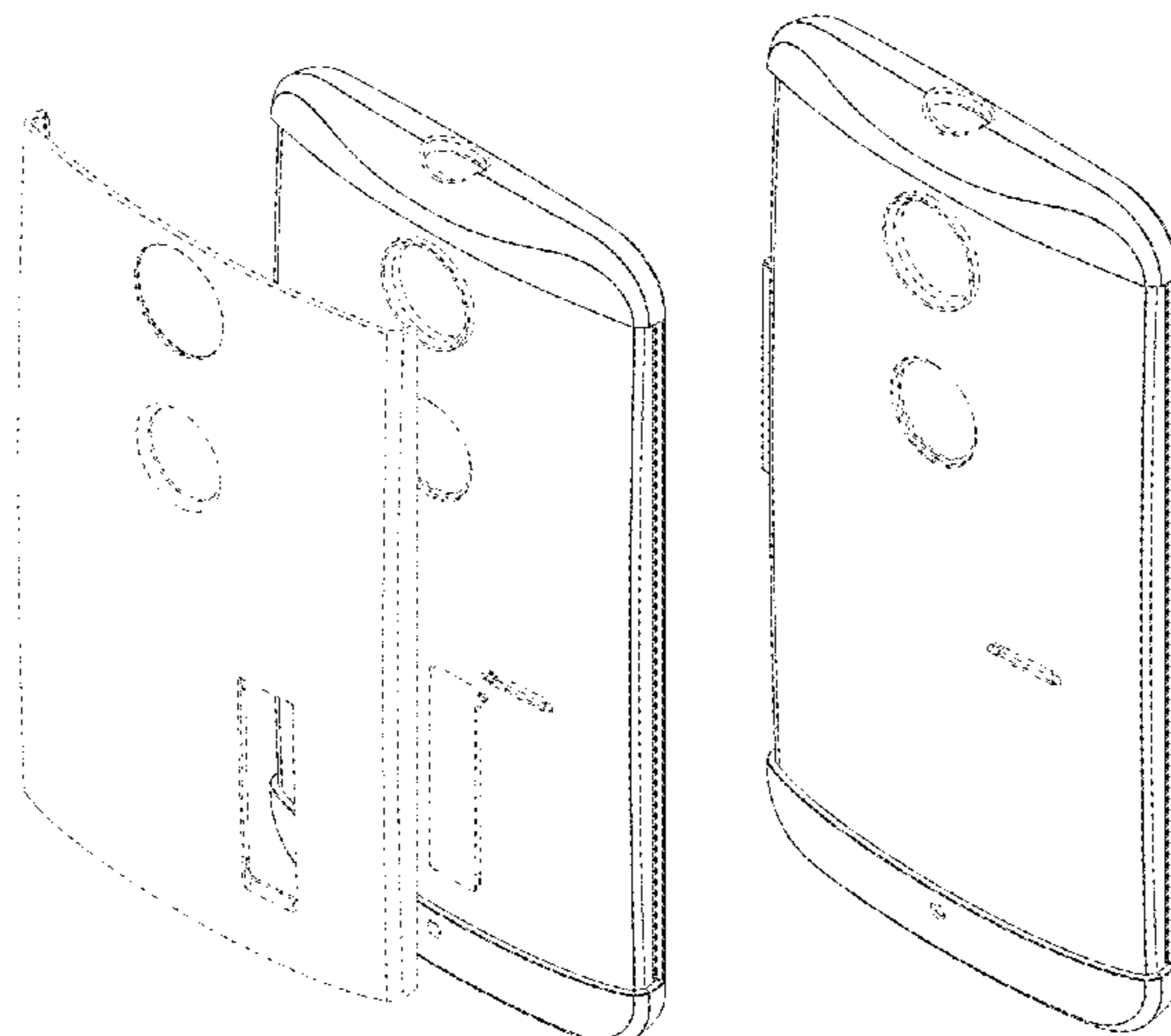
FIG. 14 is a rear perspective view of the support leg of the

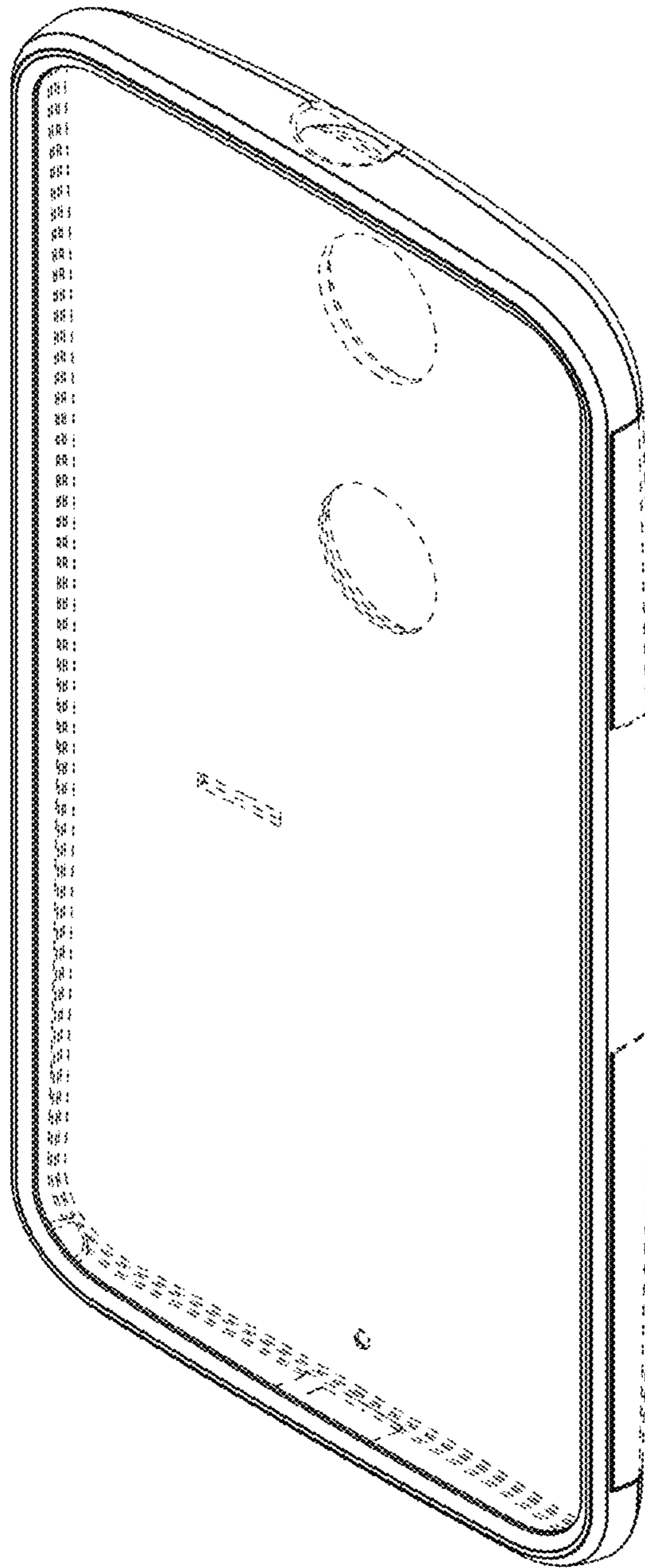

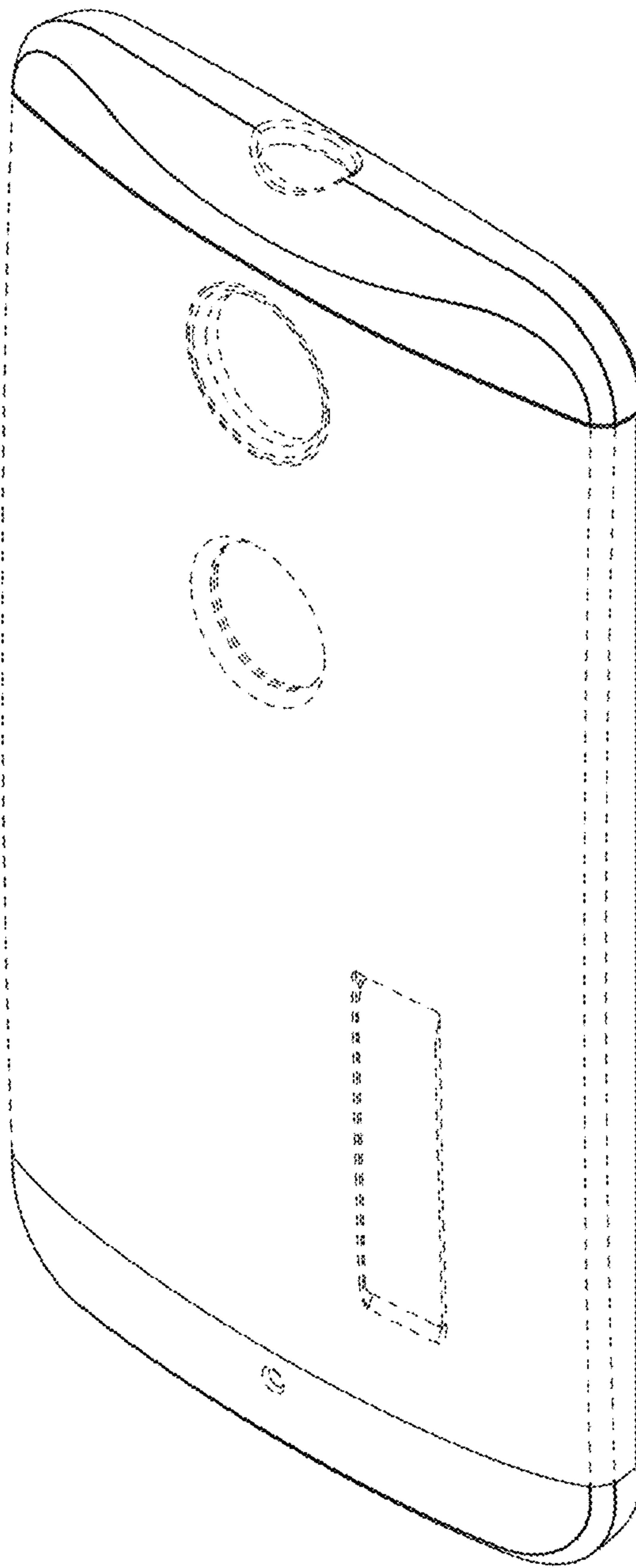

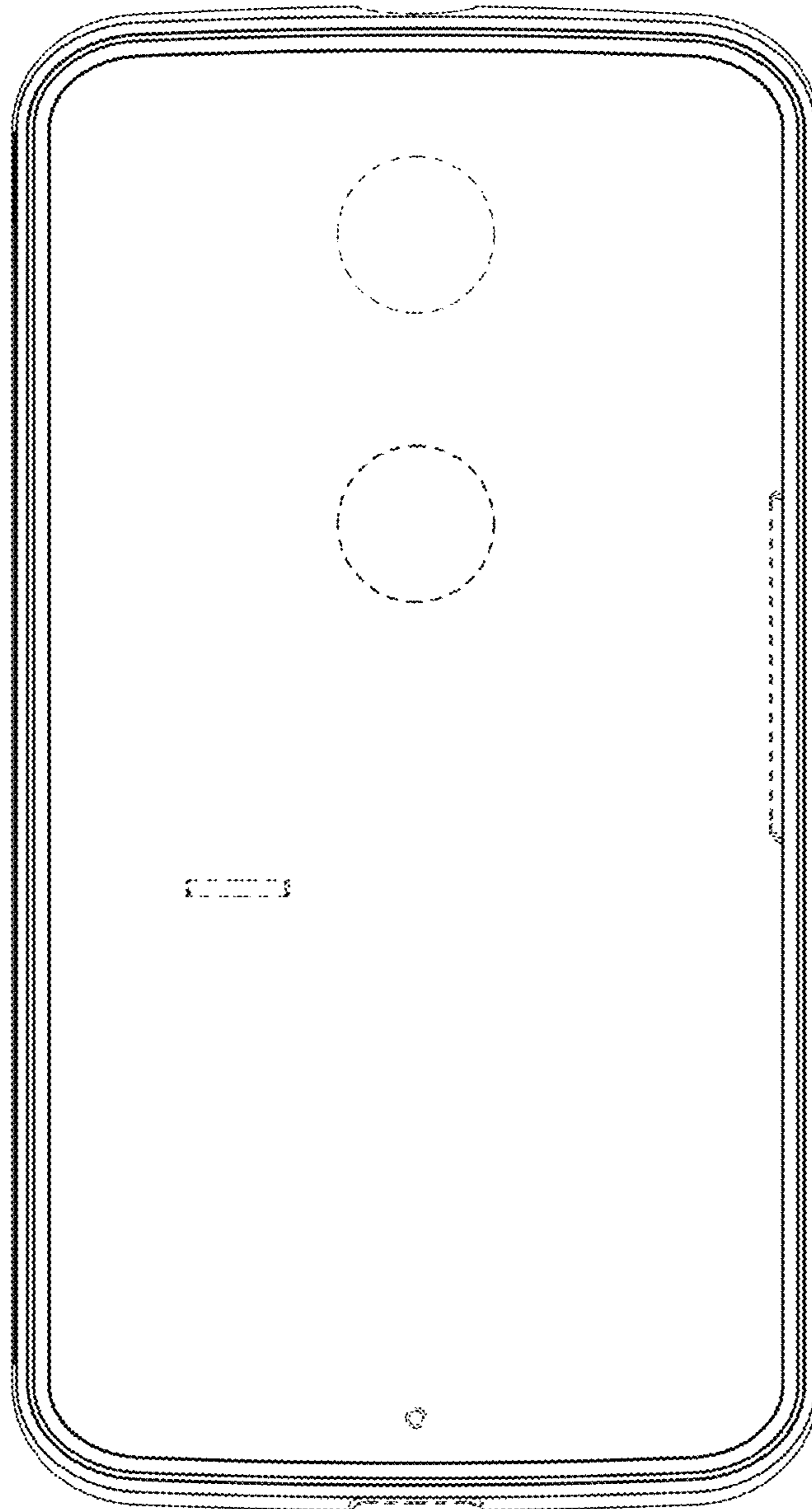

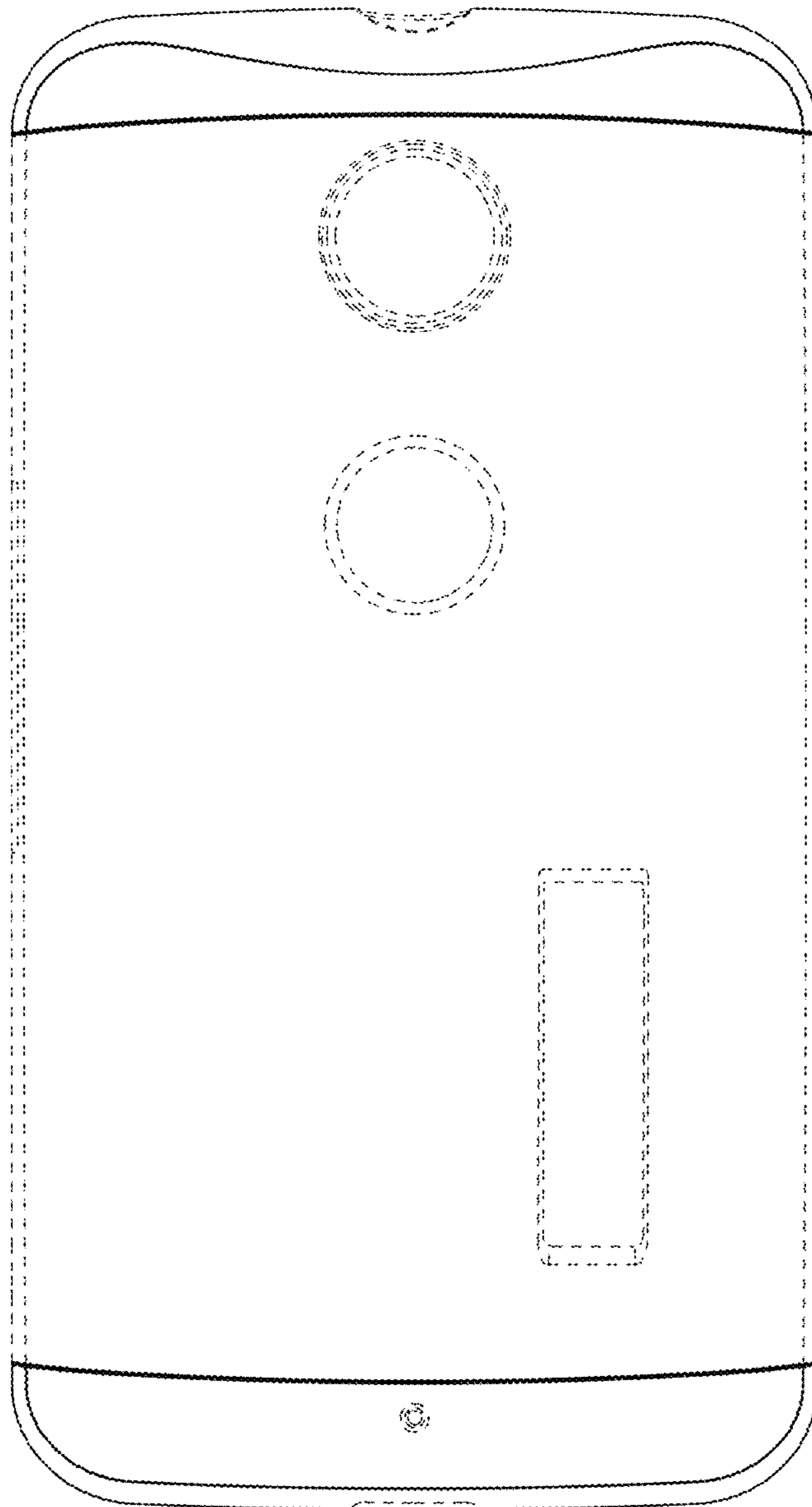

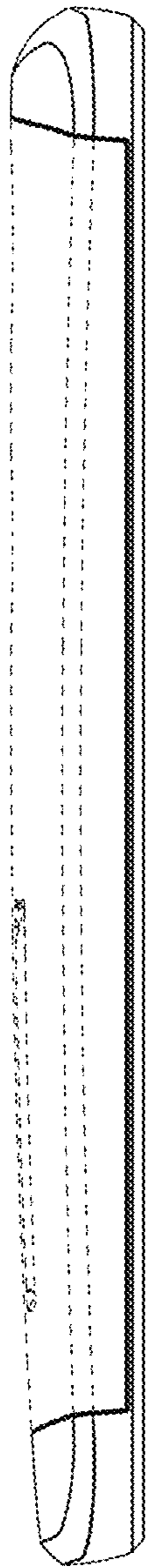

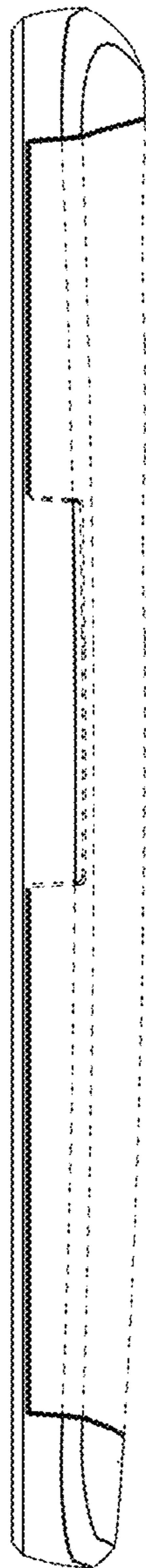

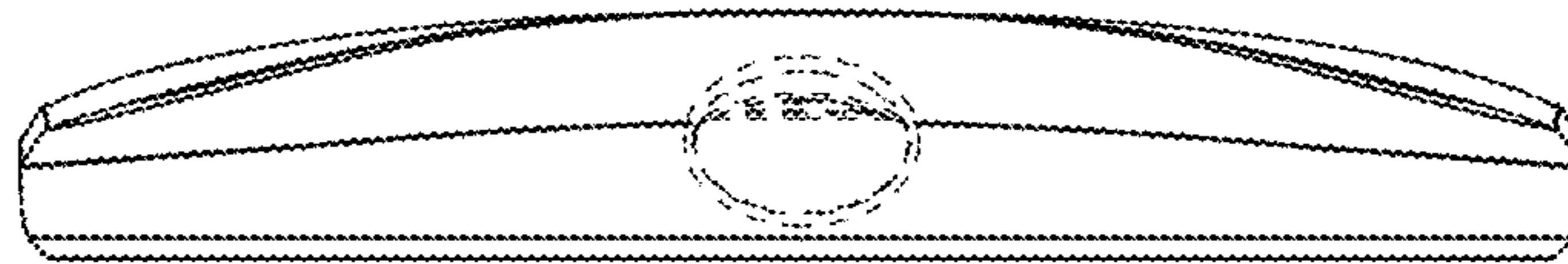

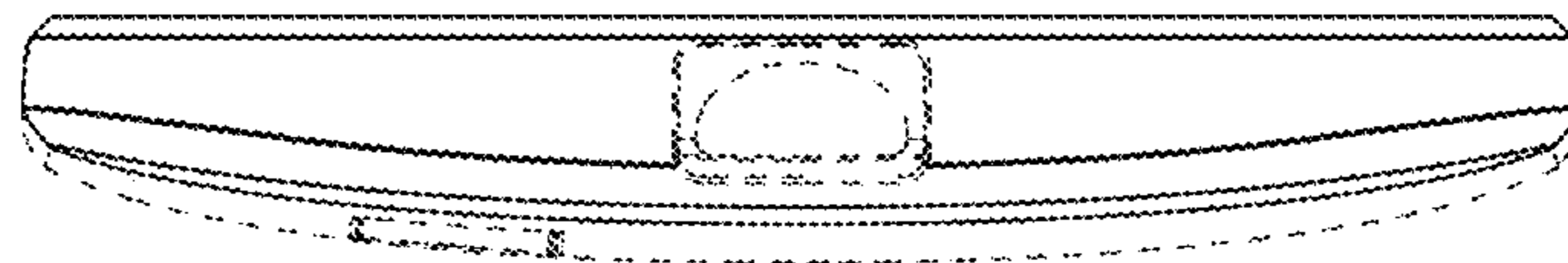

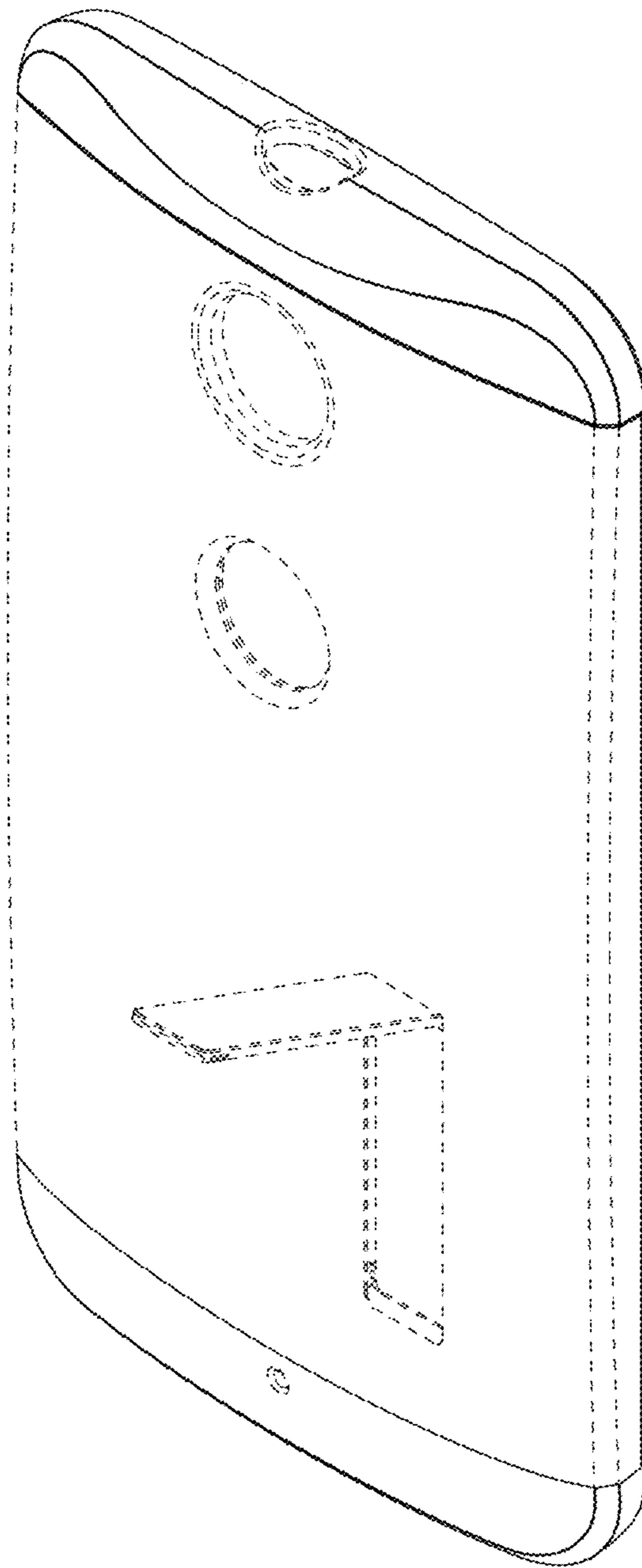

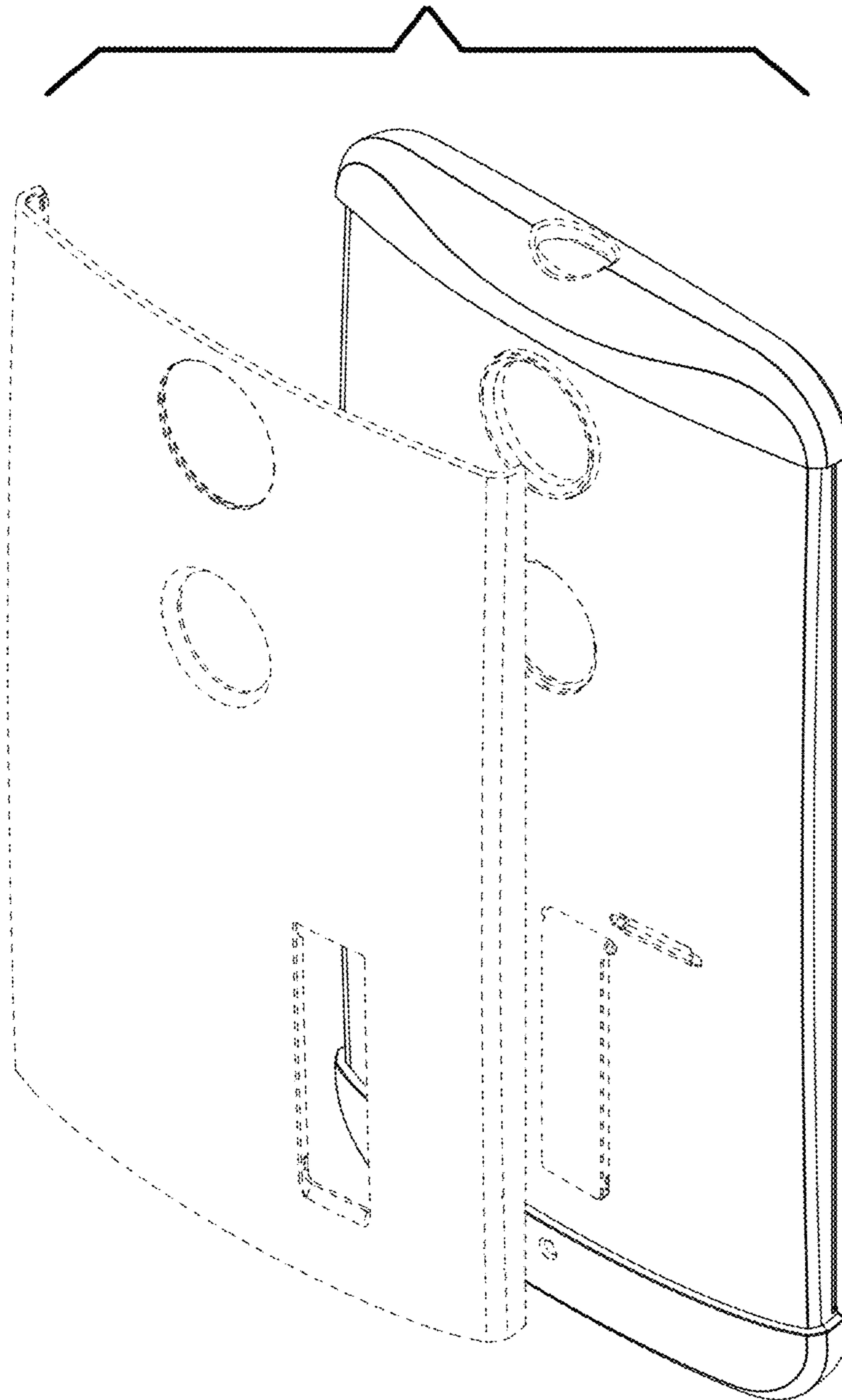

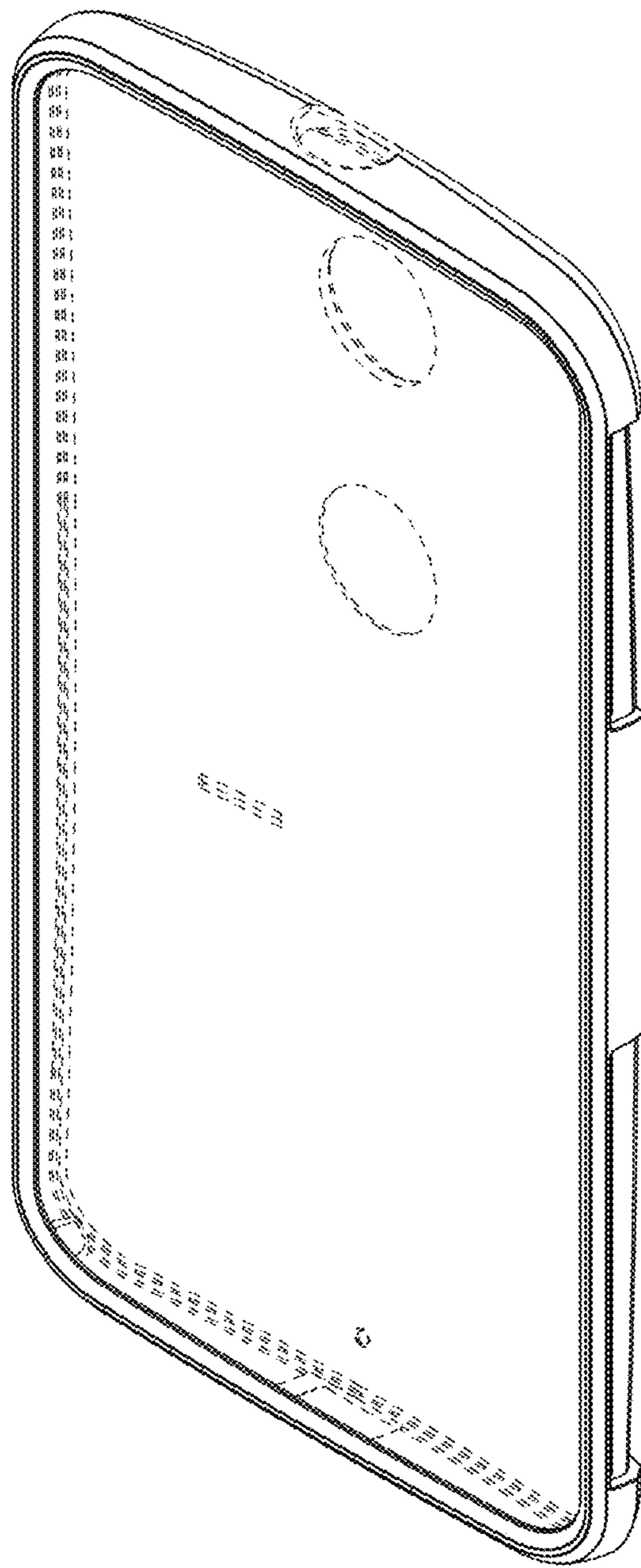

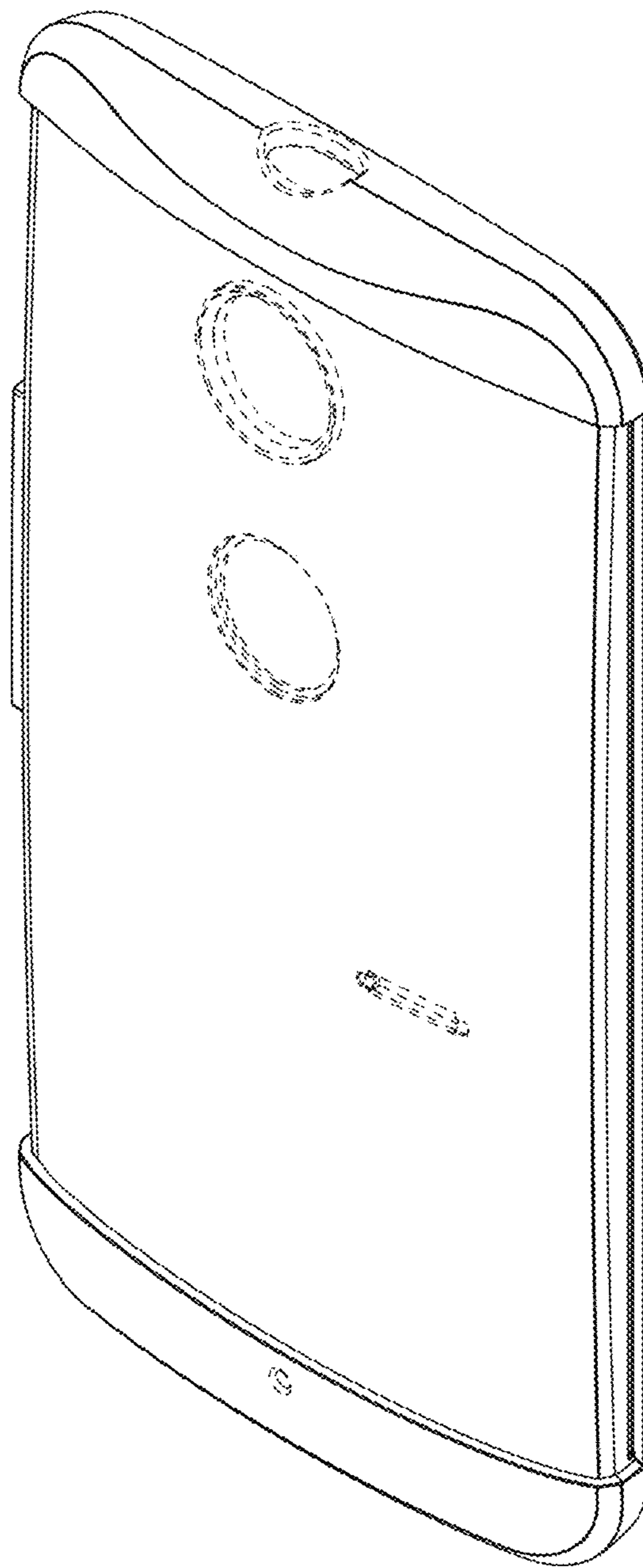

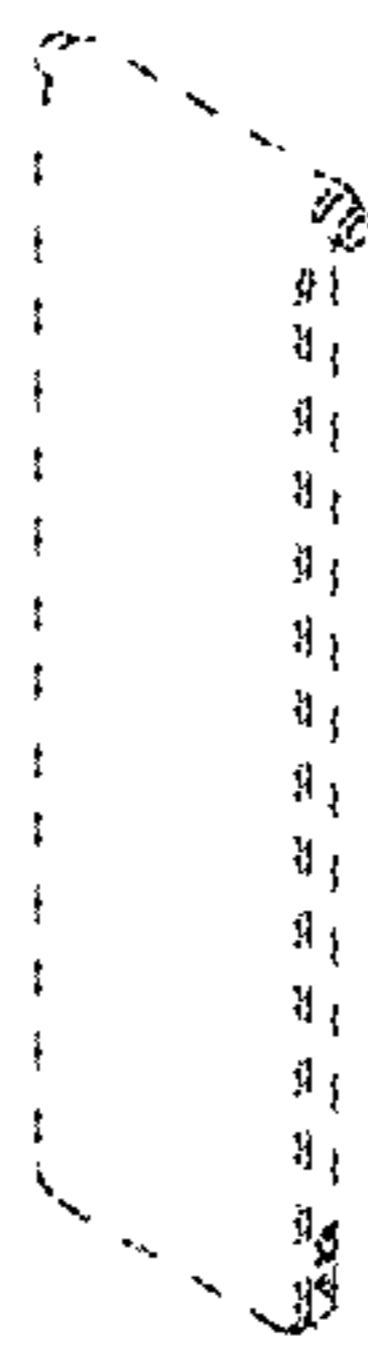

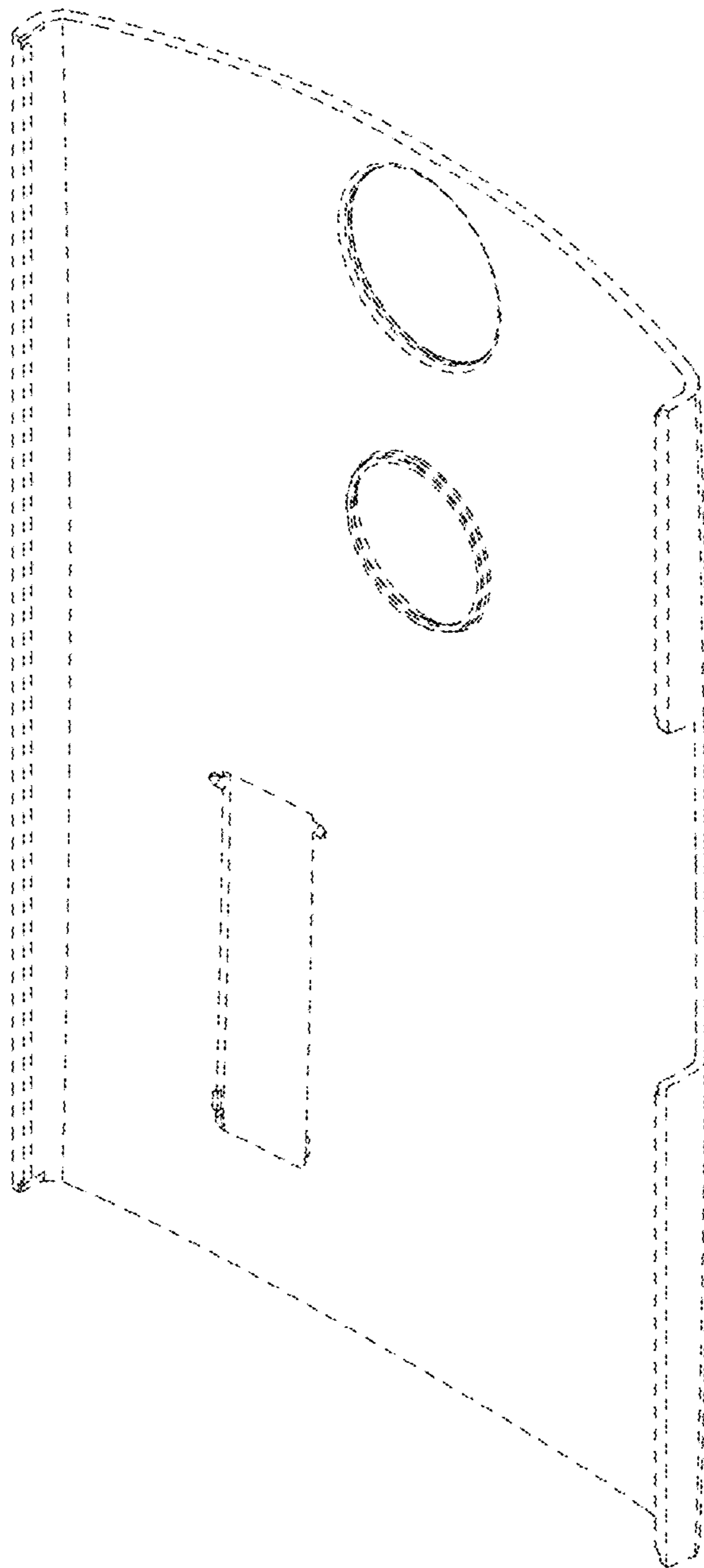
