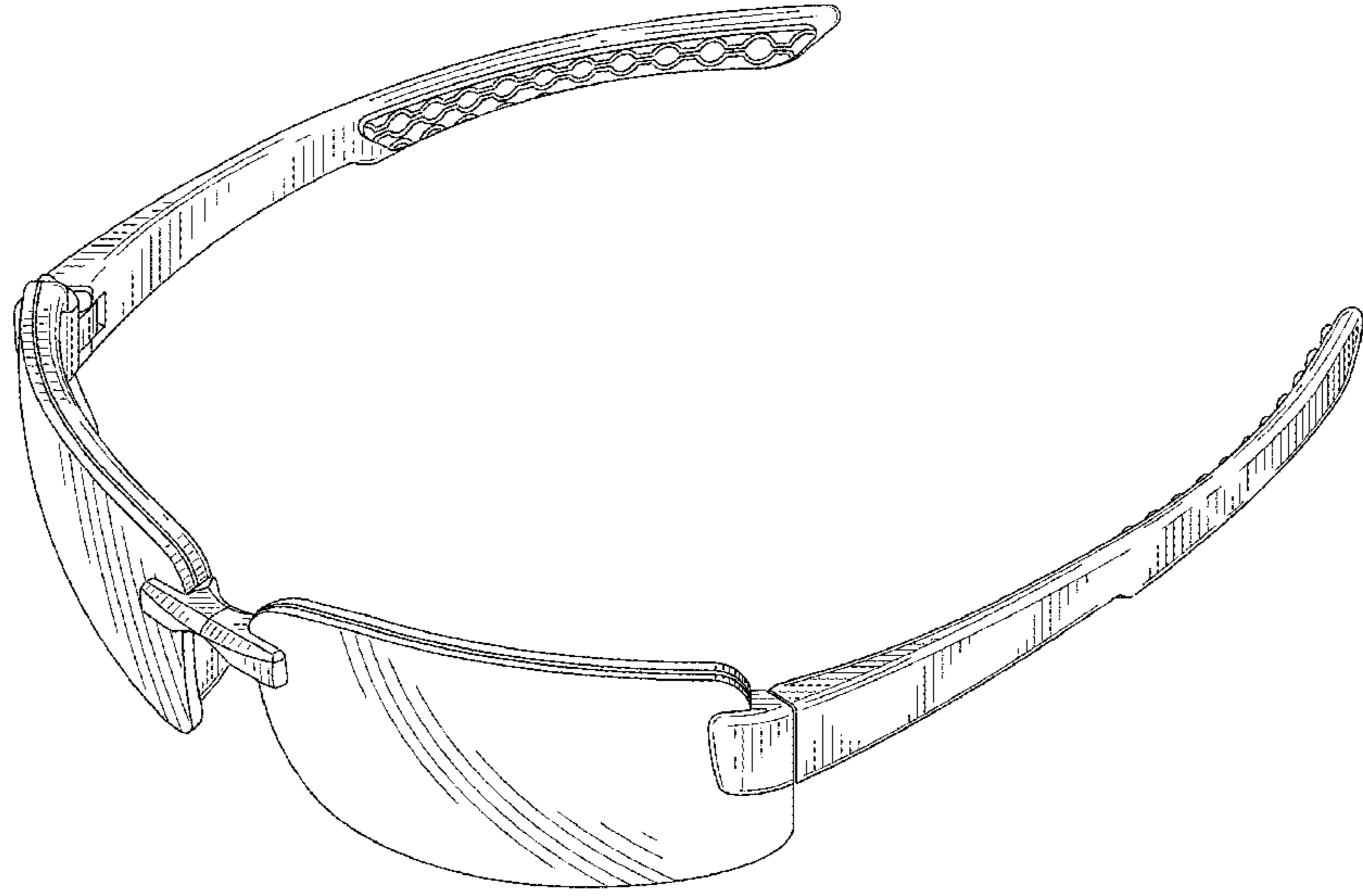

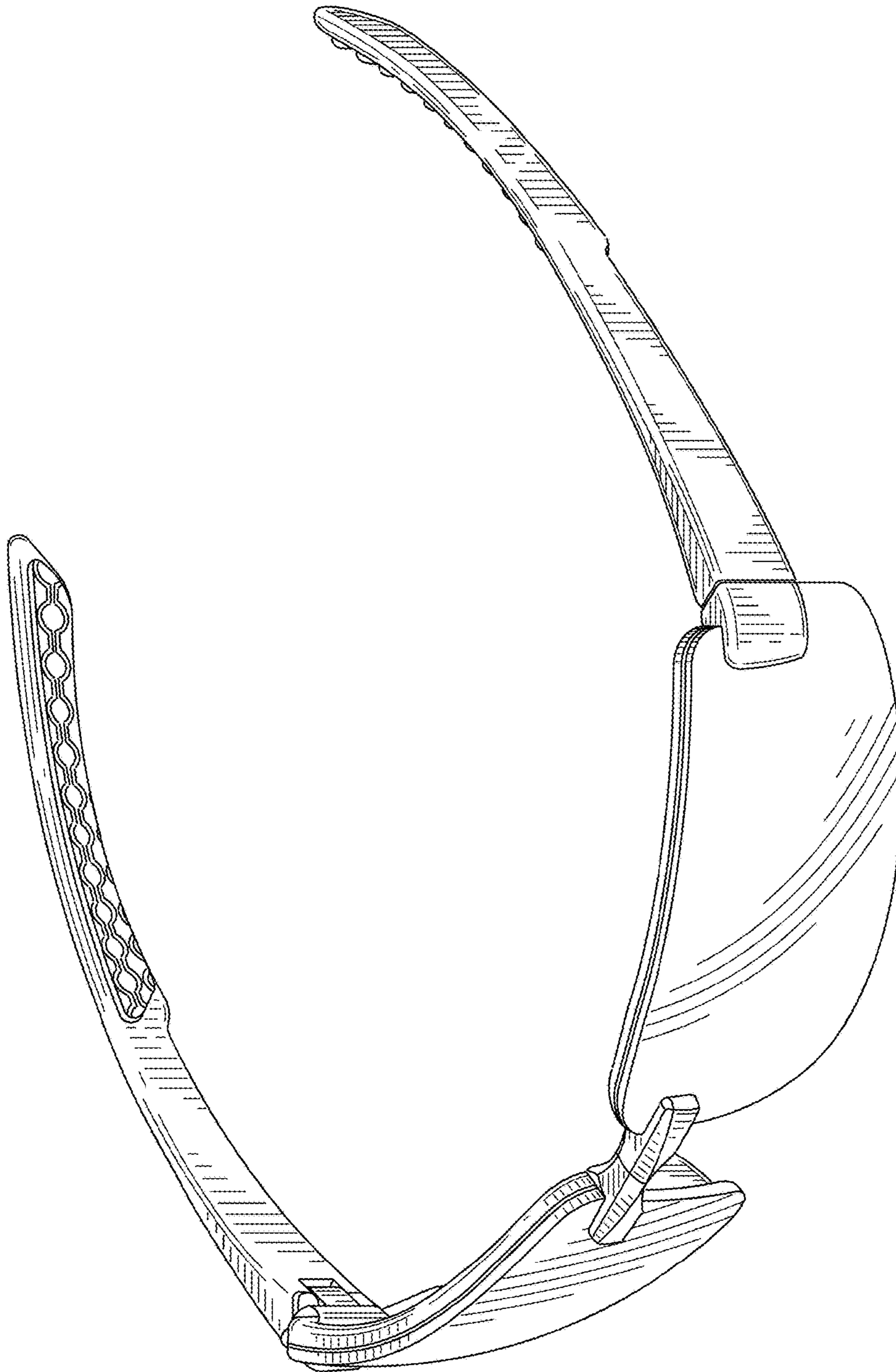
The ornamental design for safety glasses, as shown and described.

**DESCRIPTION**

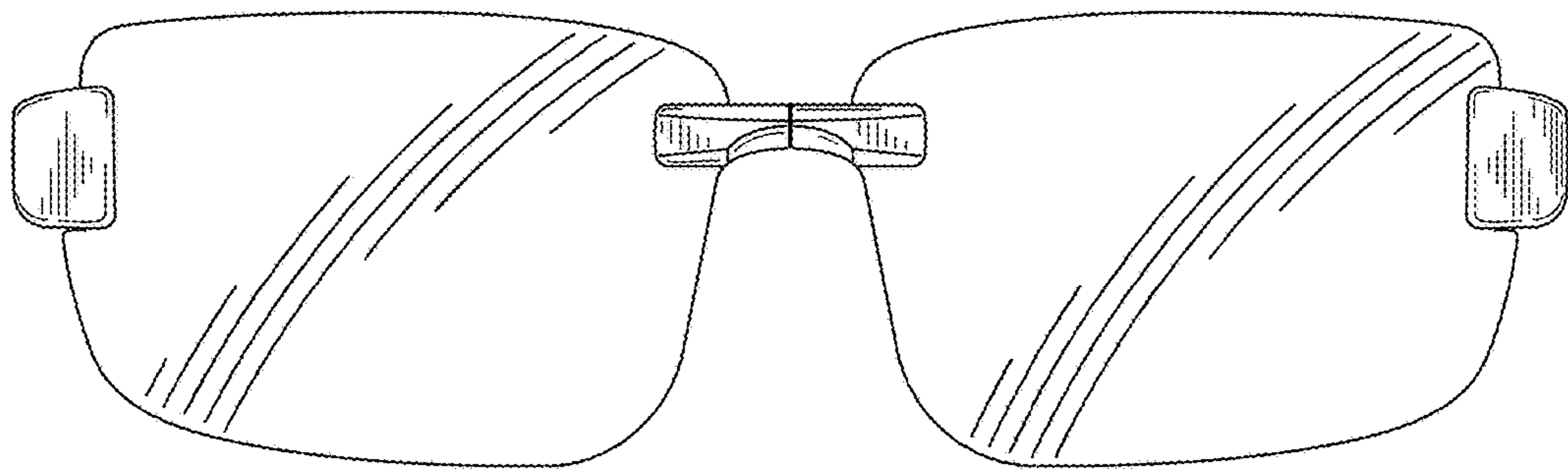
FIG. 1 is a perspective view of safety glasses according to my new design;

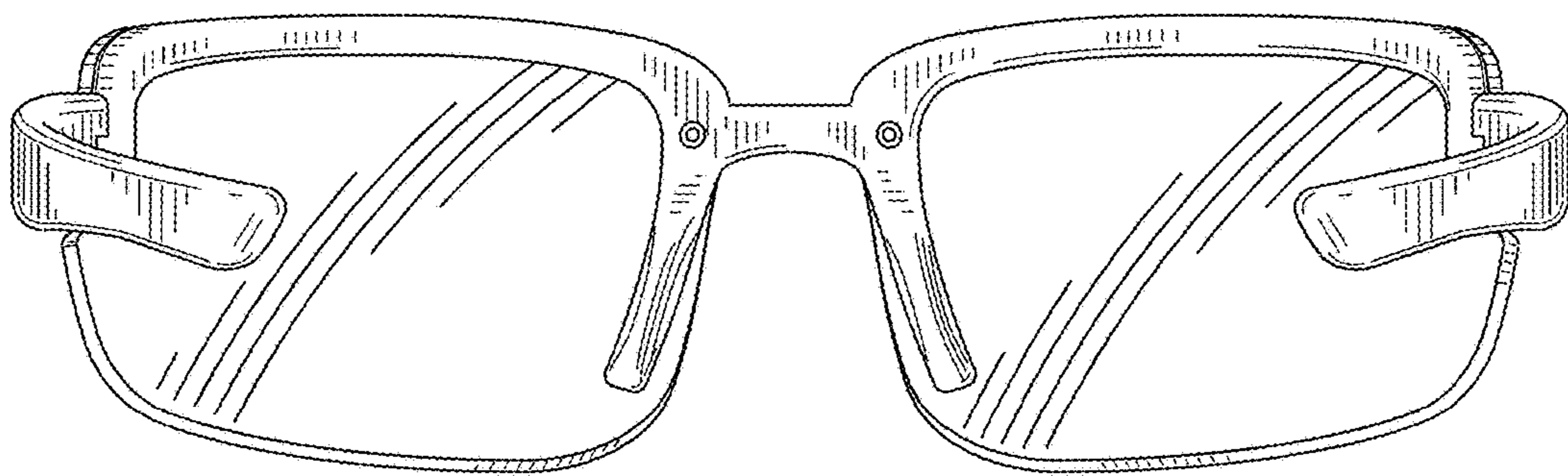




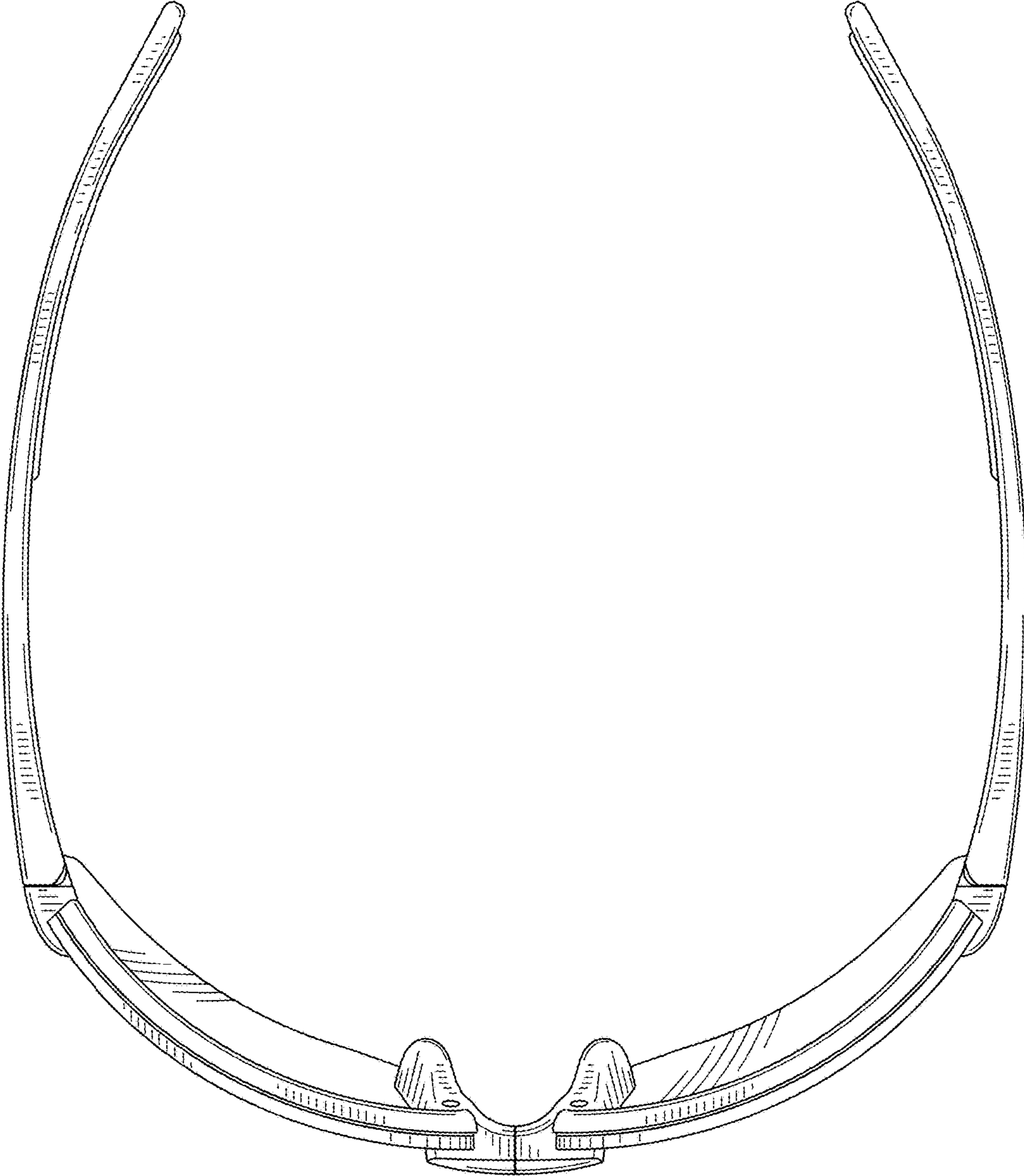

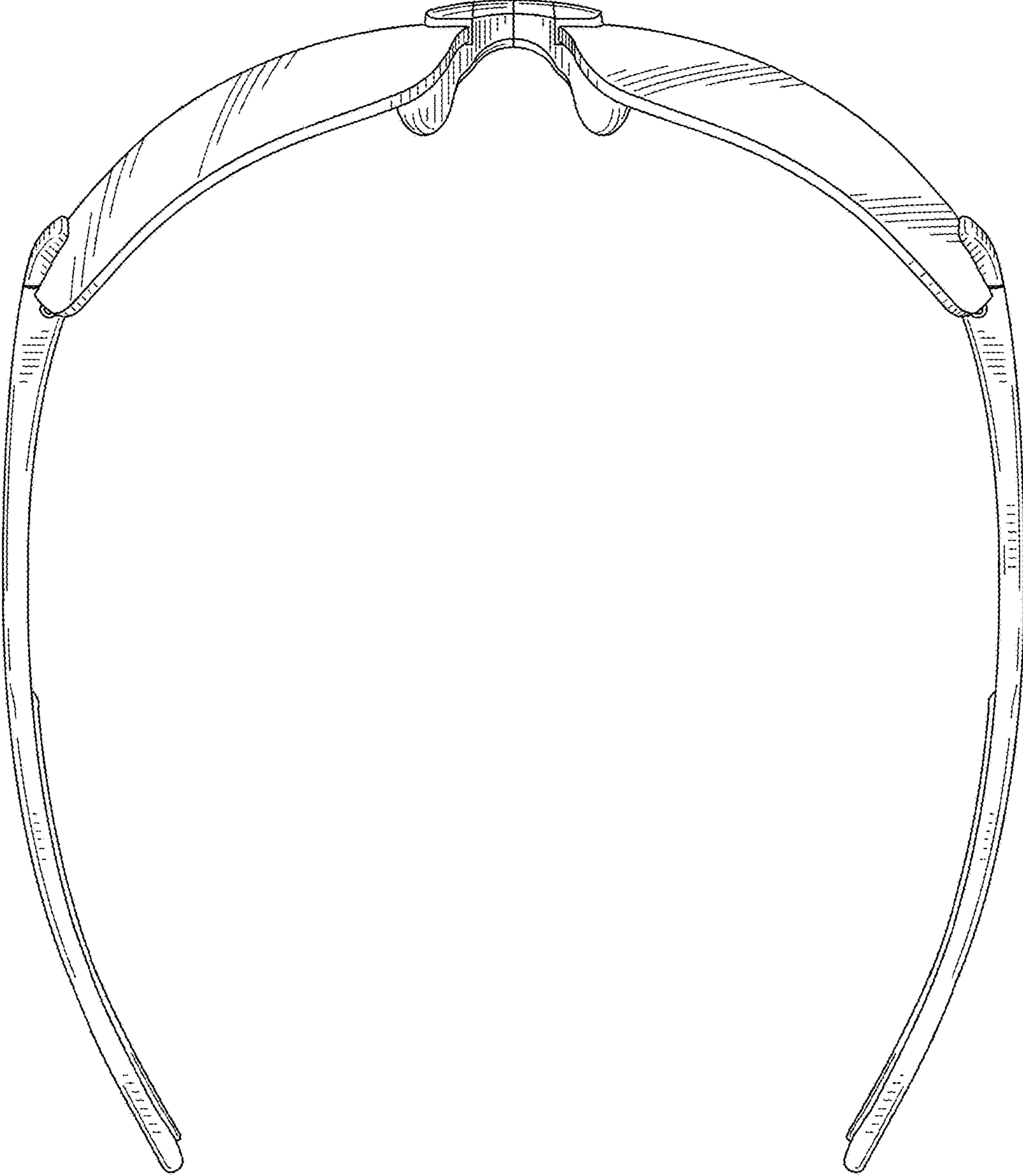

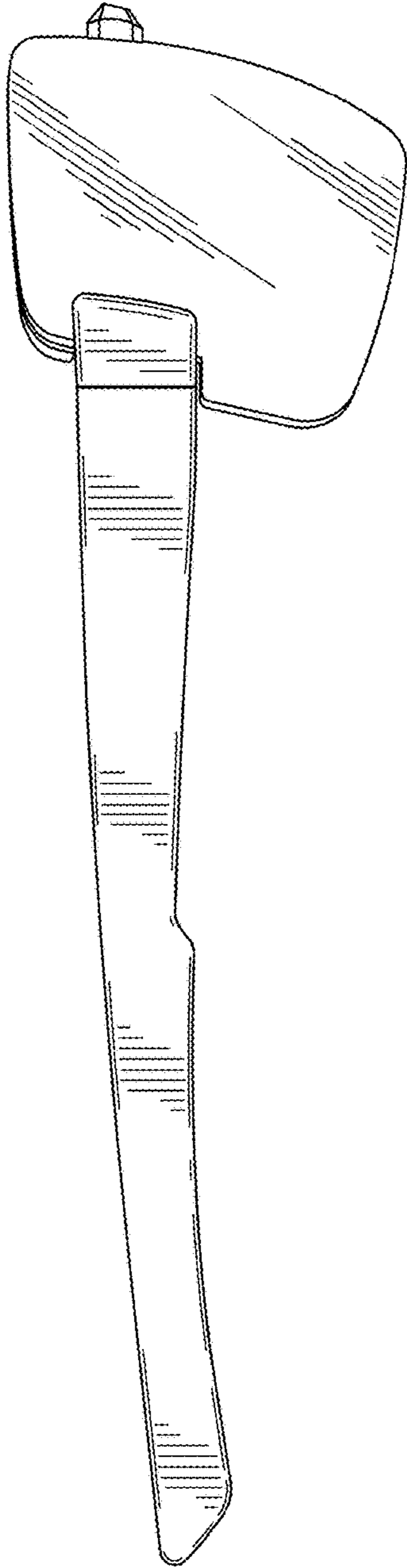

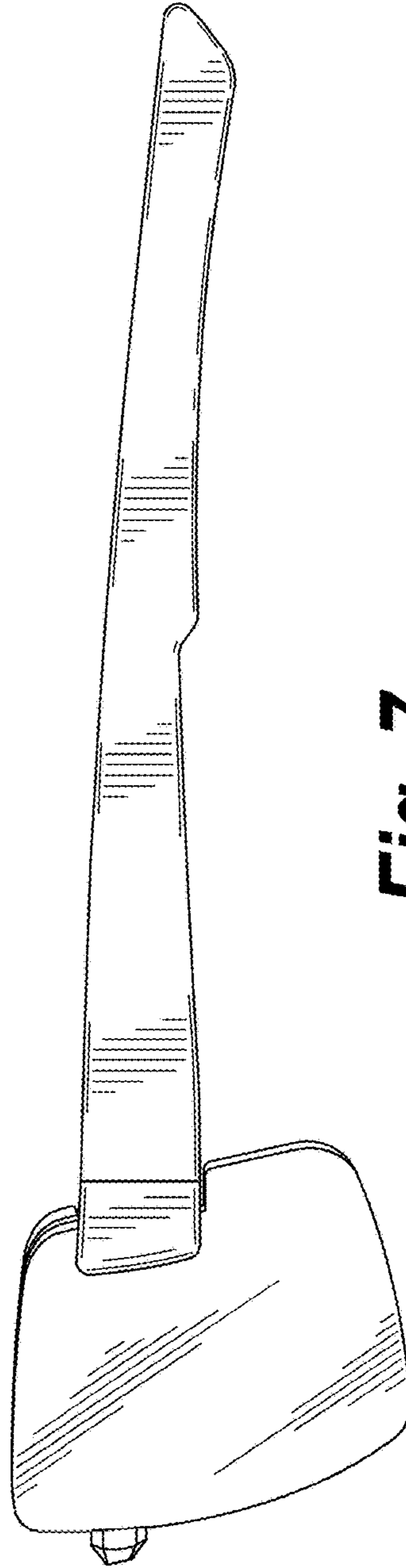
