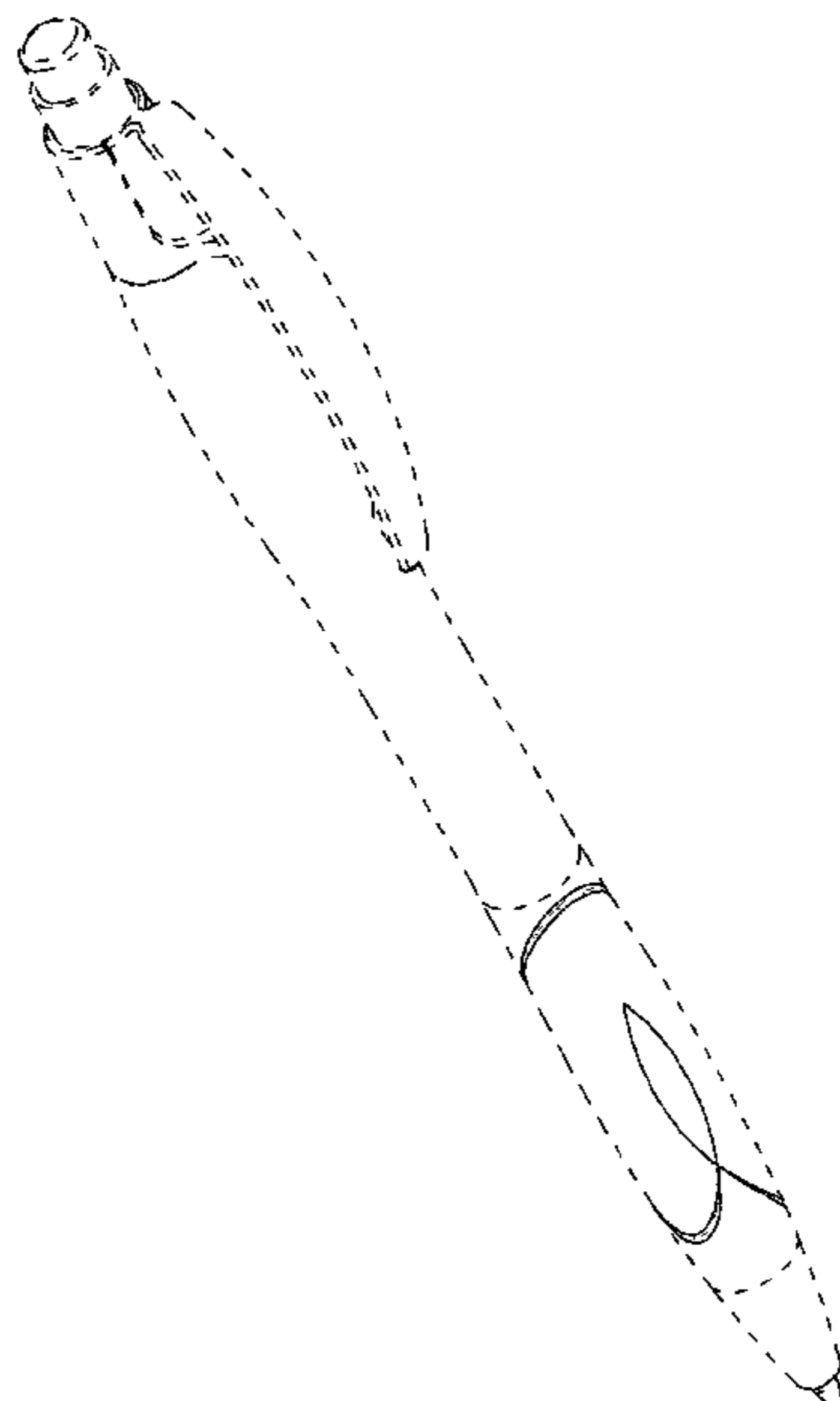
FIG. 1 is a perspective view of a writing instrument according to the present design;

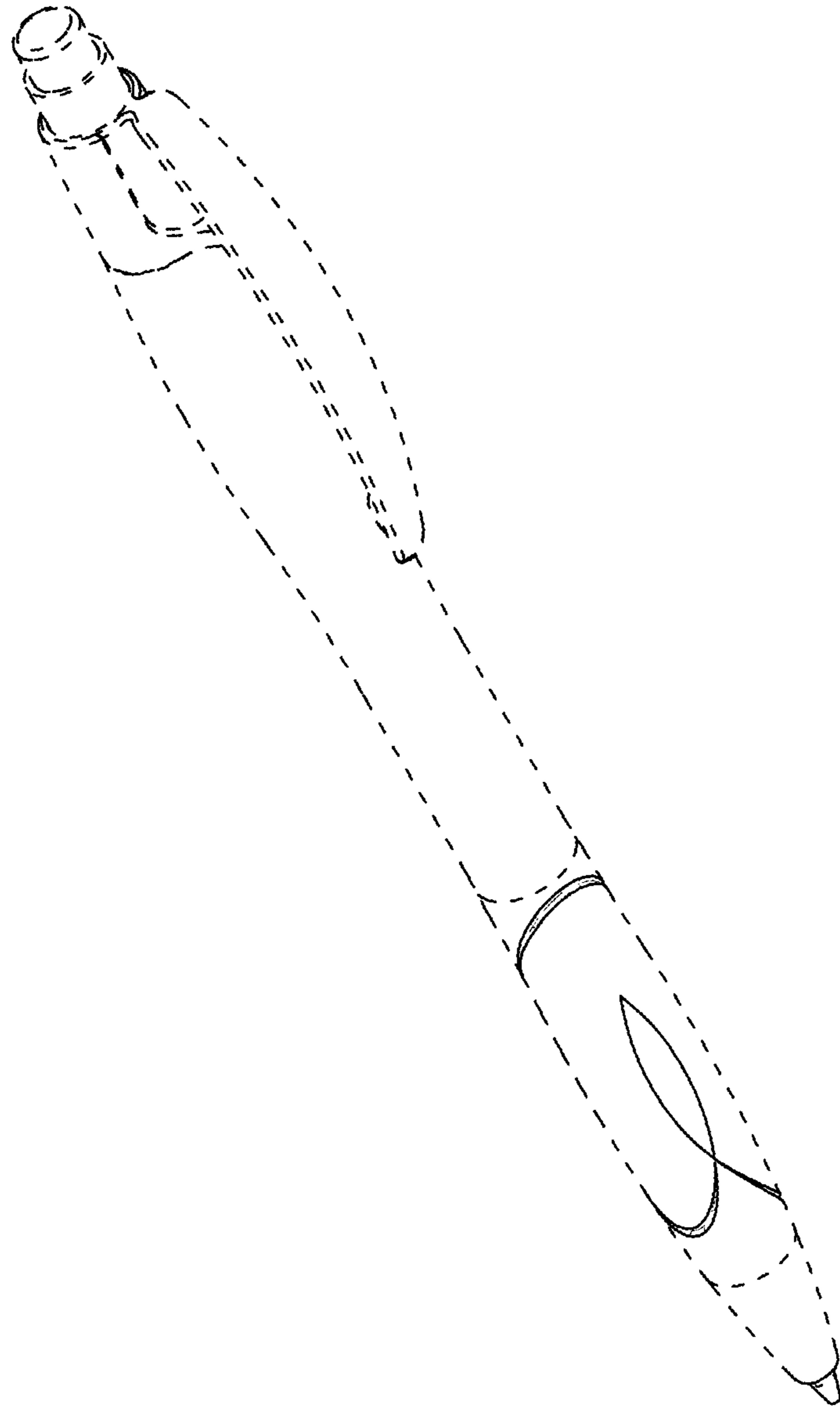

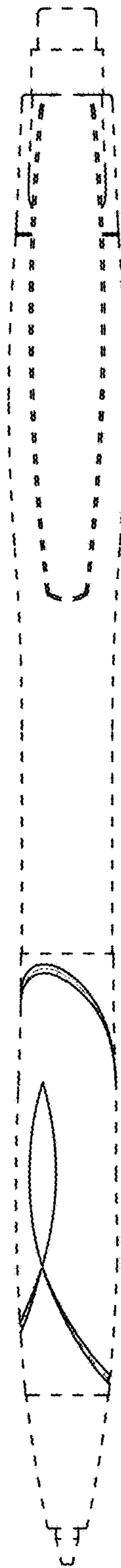
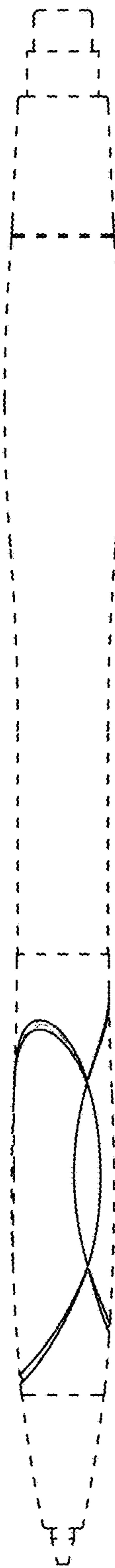

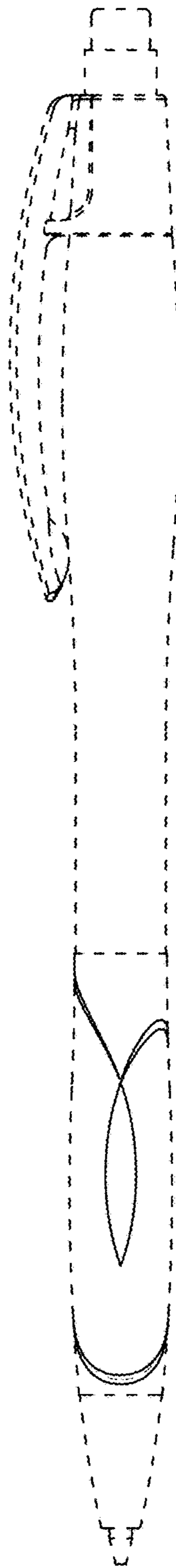
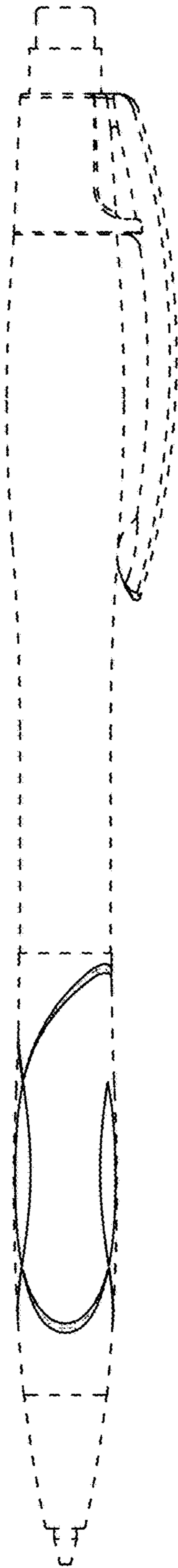
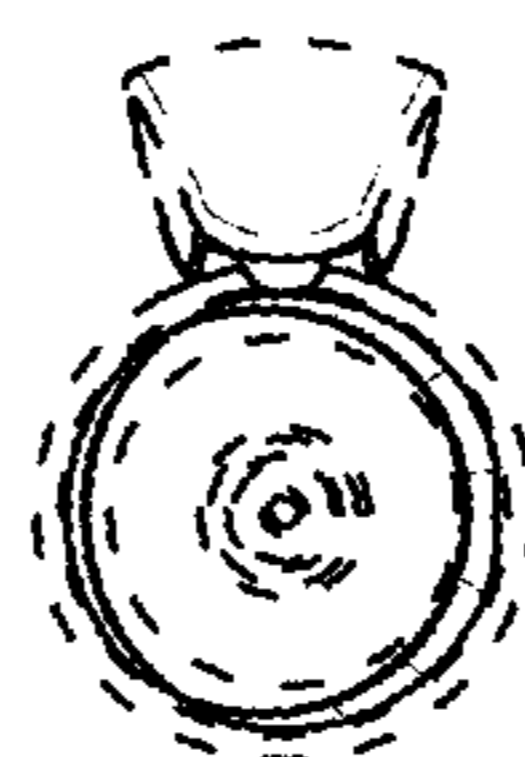
