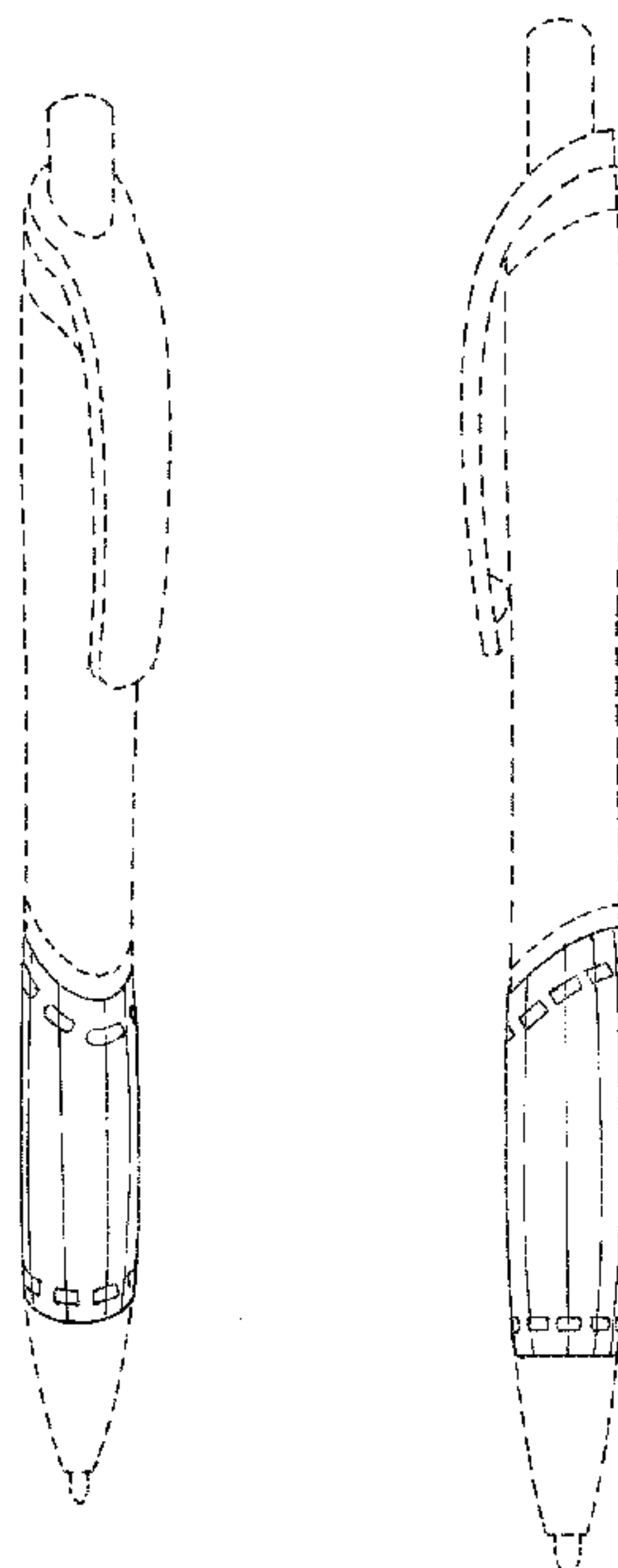

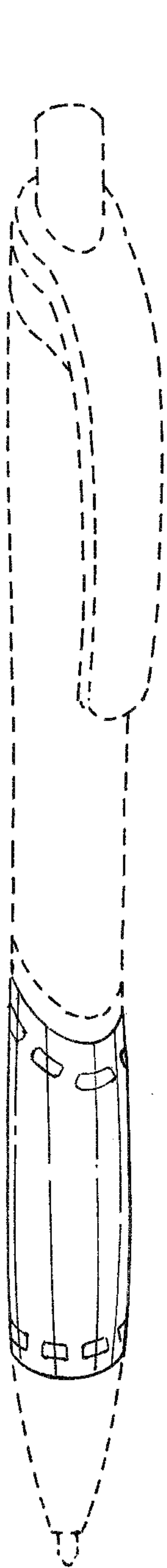
The ornamental design for a pen, as shown and described.

**DESCRIPTION**

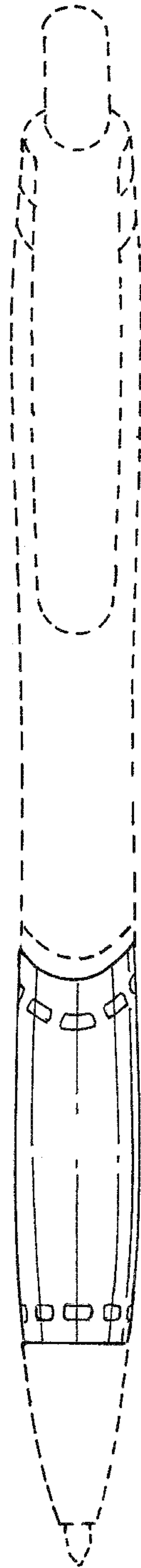
FIG. 1 is a top right side isometric view of a pen in accordance with the new design;

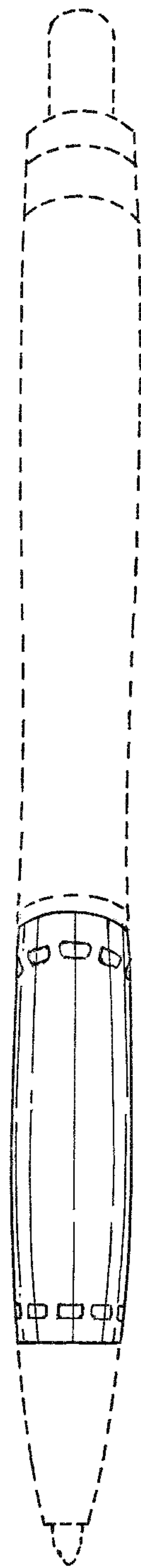




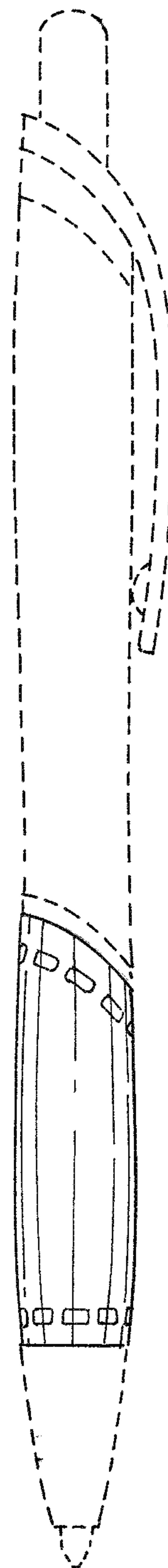

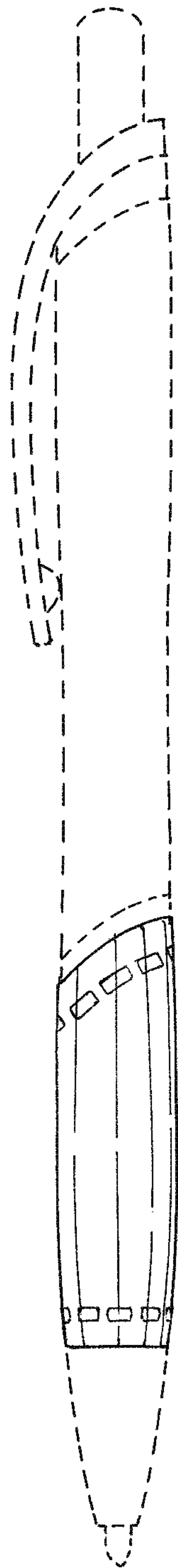

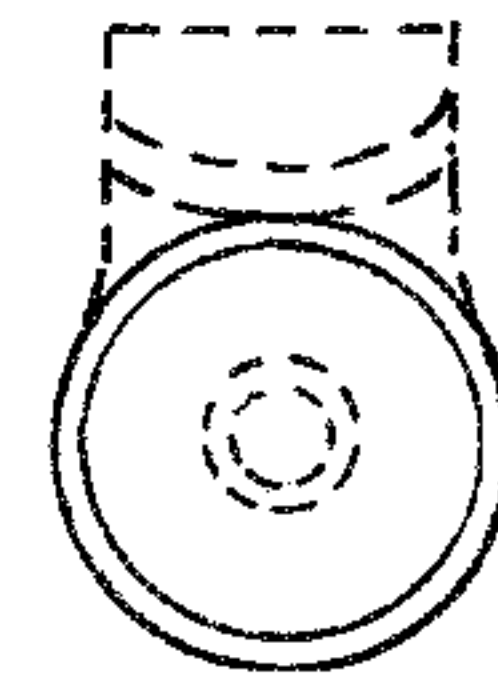
