DESCRIPTION

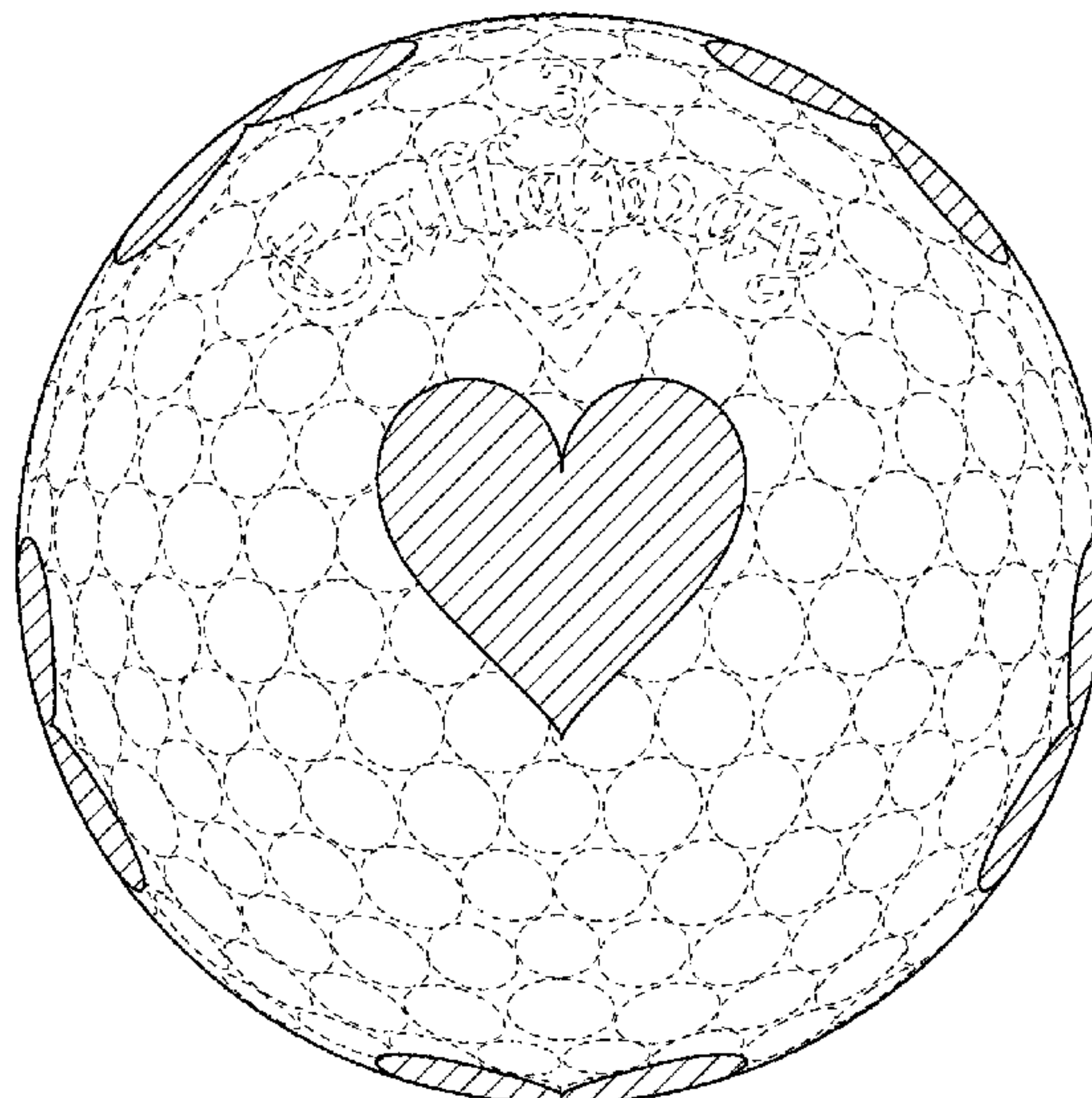
FIG. 1 is a top plan view of a golf ball showing our new design;

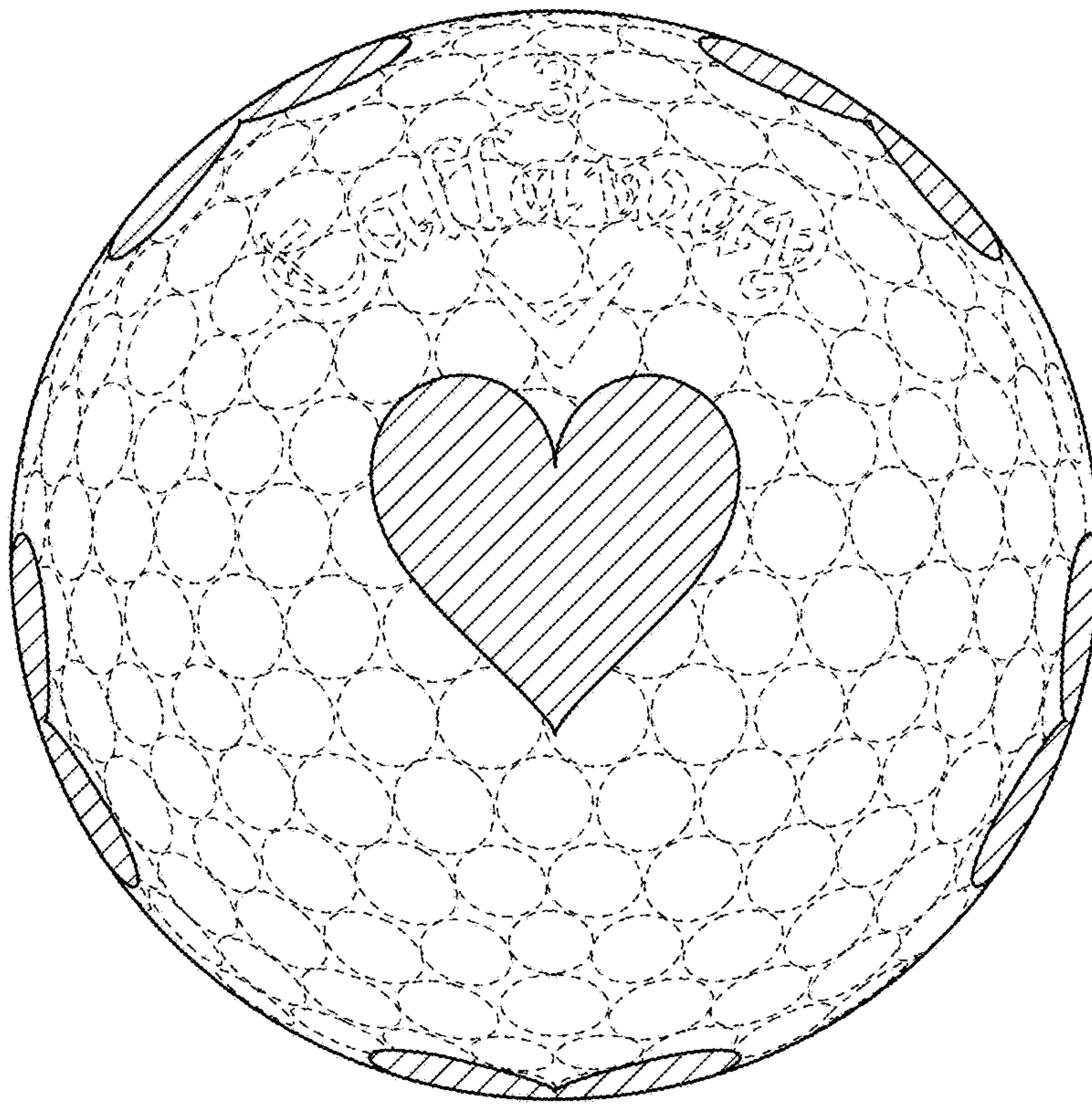

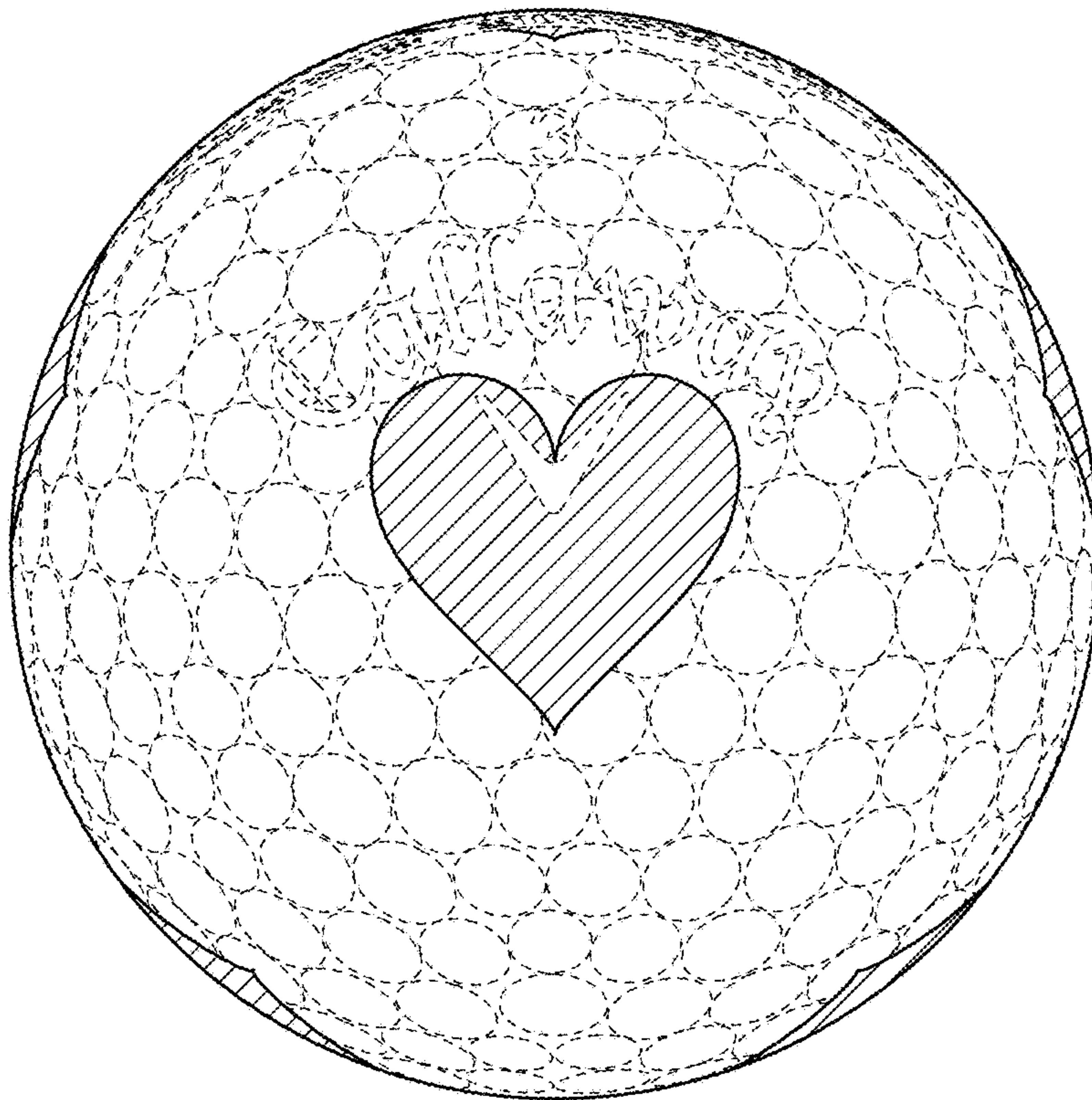

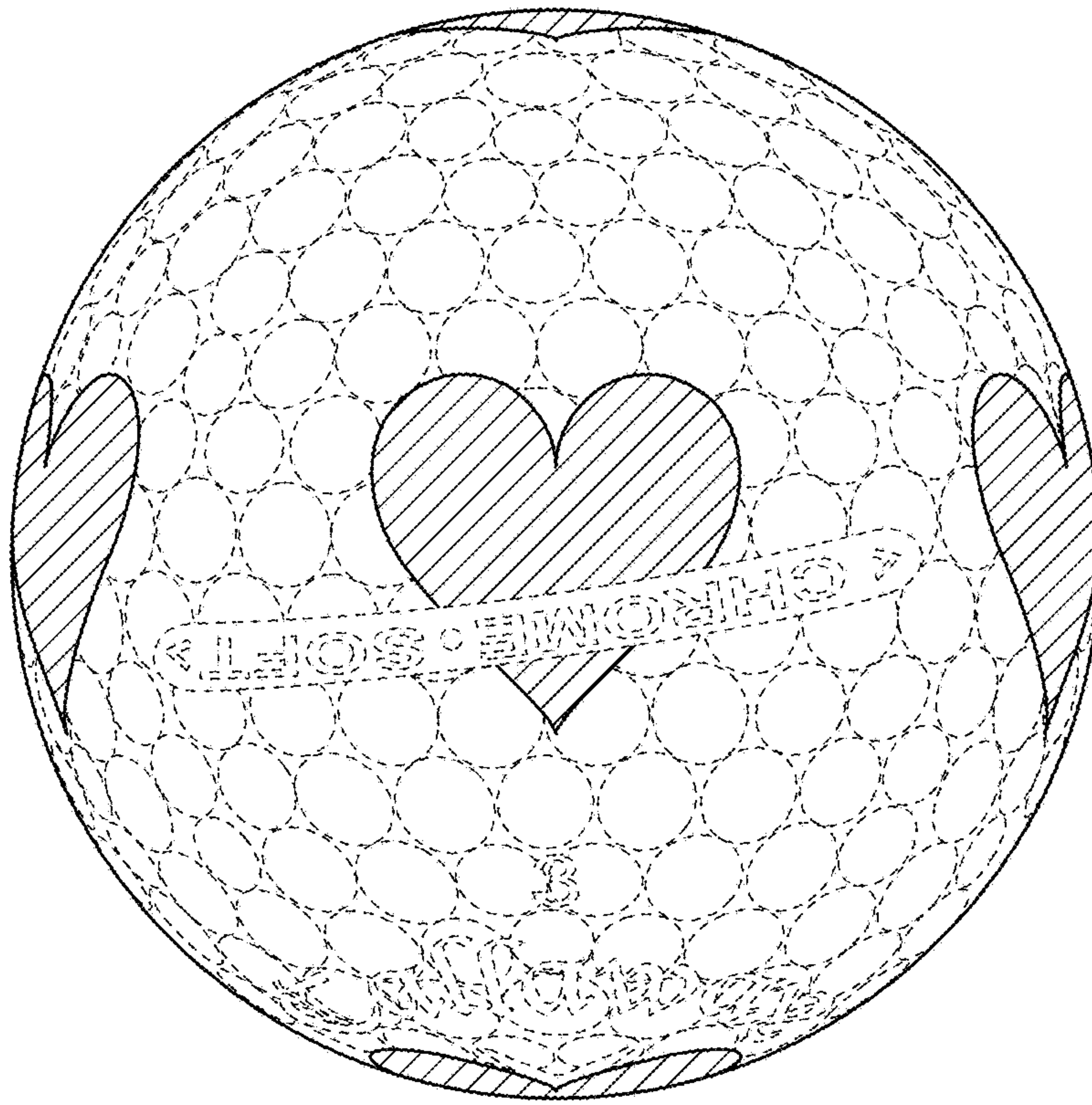

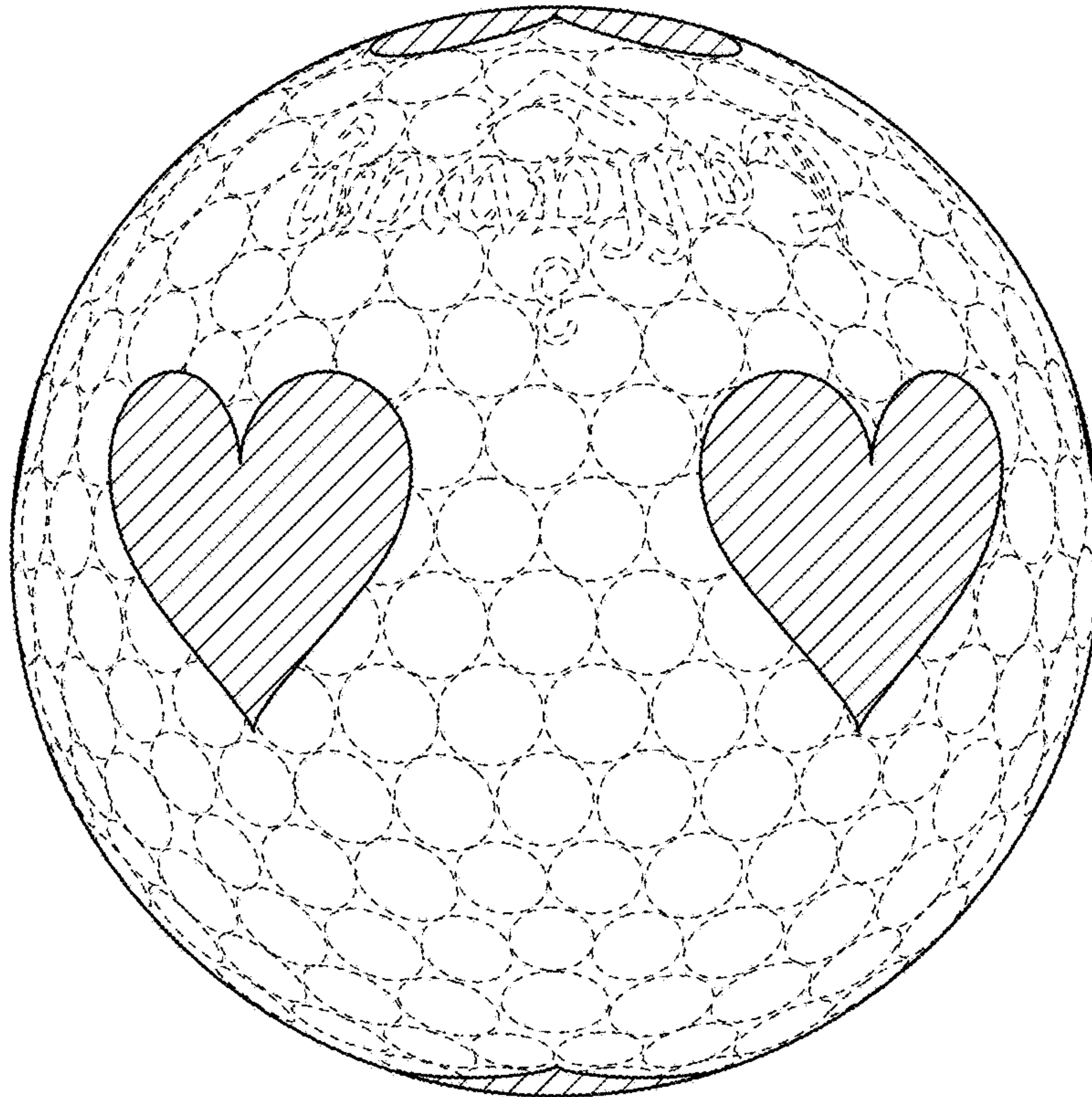

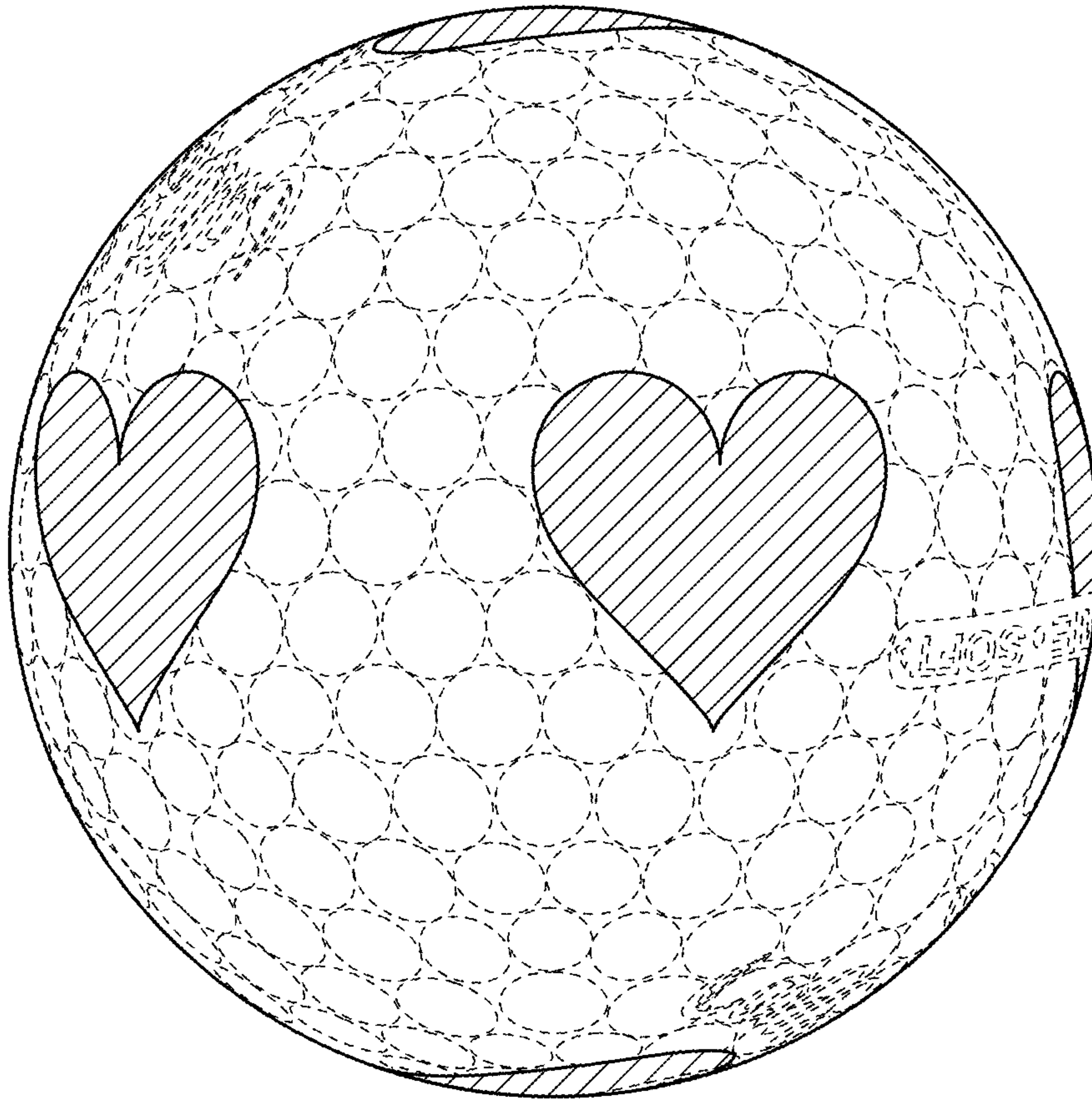
