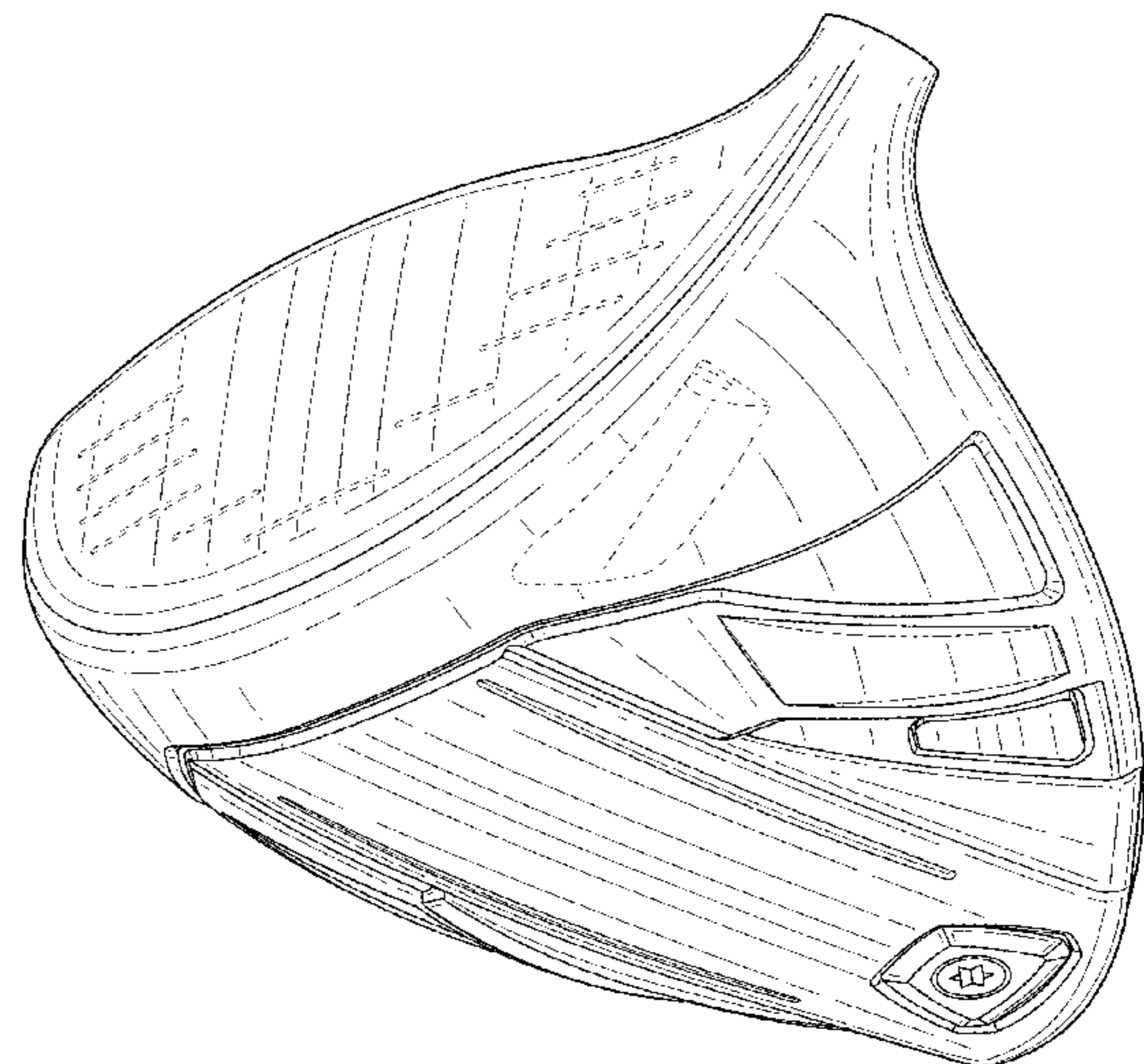
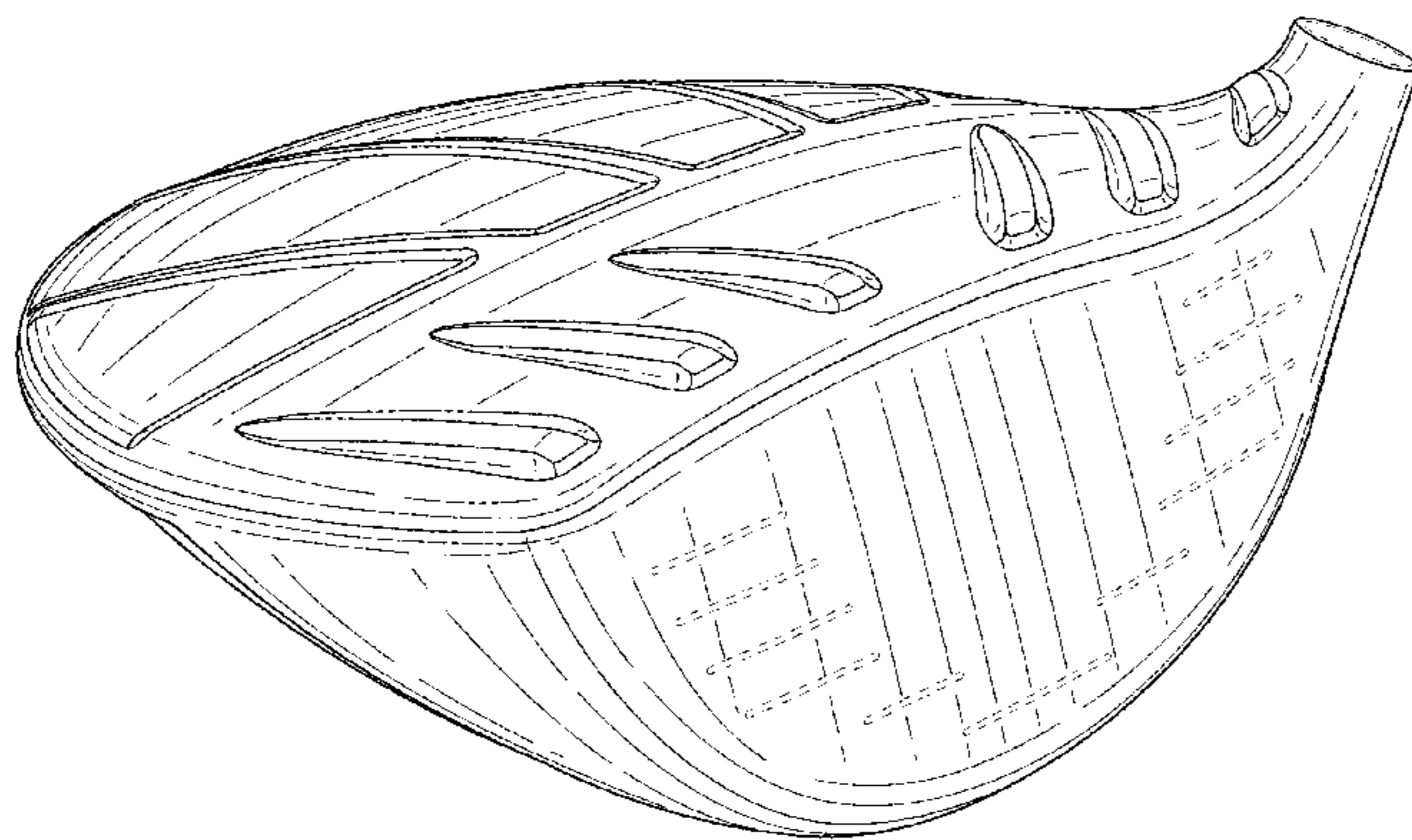
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a top perspective view of a golf club head; FIG. 2 is a bottom perspective view of the golf club head of FIG. 1; FIG. 3 is a front view of the golf club head of FIG. 1; FIG. 4 is a rear view of the golf club head of FIG. 1; FIG. 5 is a heel view of the golf club head of FIG. 1; FIG. 6 is a toe view of the golf club head of FIG. 1; FIG. 7 is a top view of the golf club head of FIG. 1; and, FIG. 8 is a bottom view of the golf club head of FIG. 1. 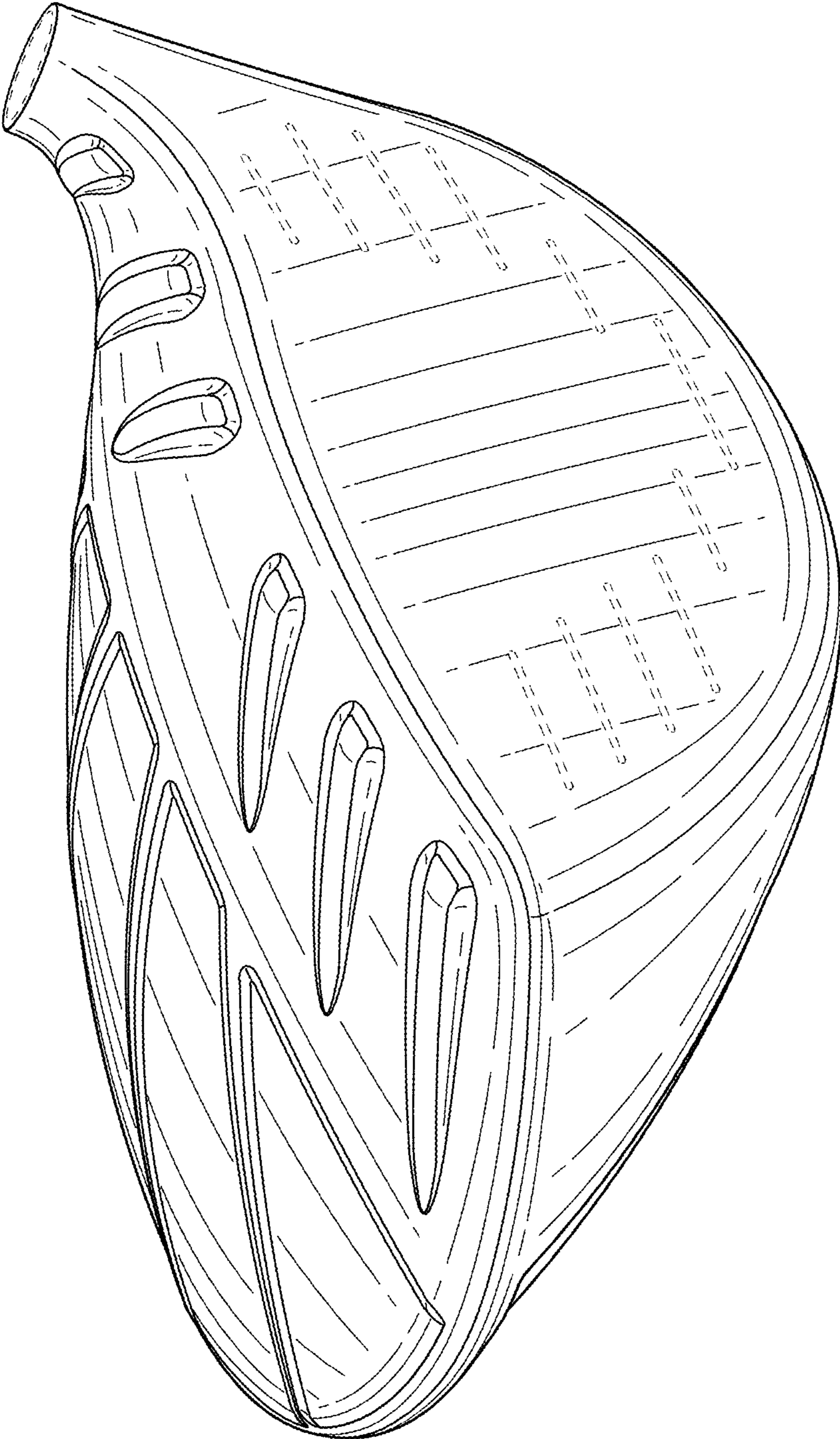

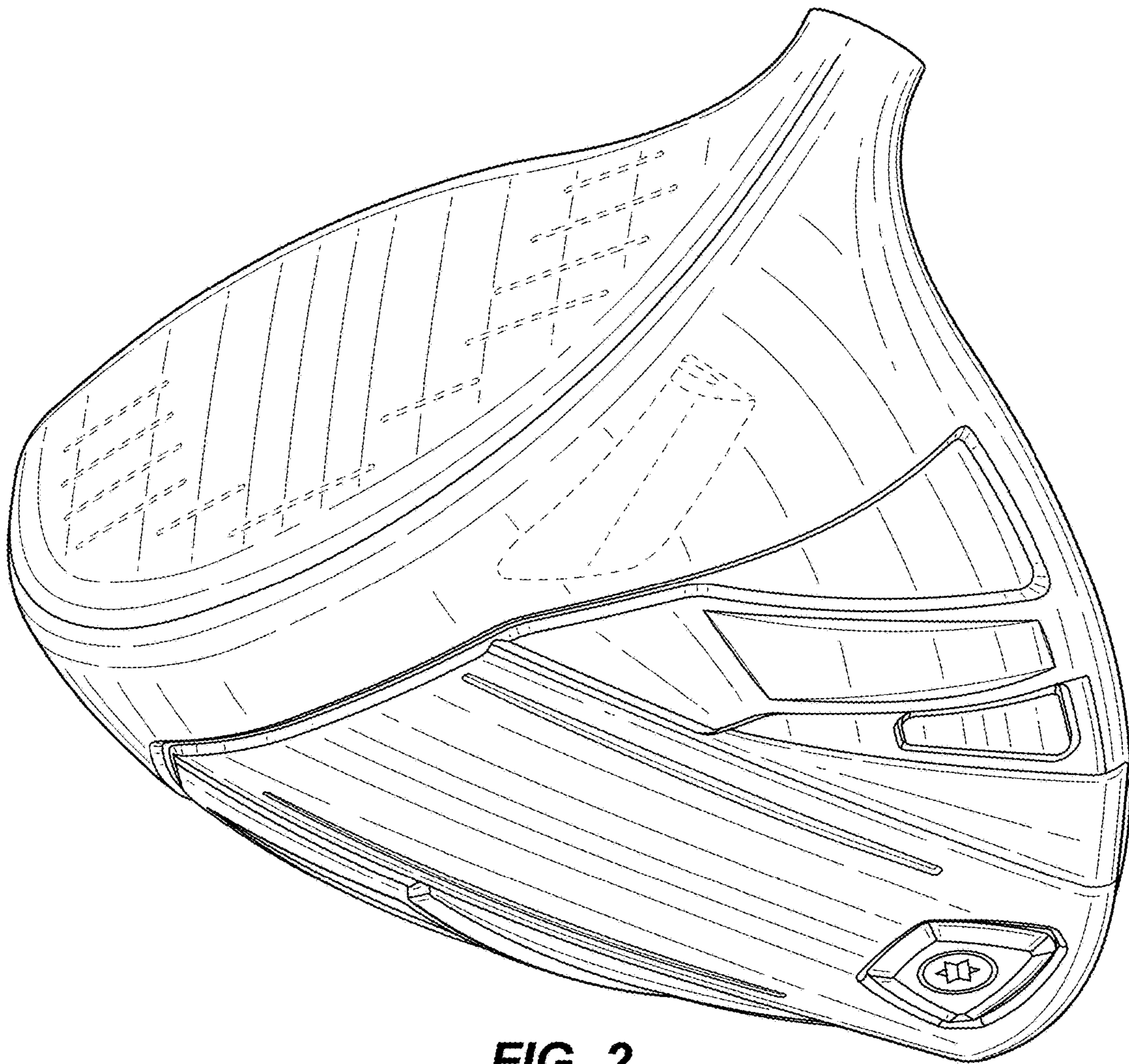
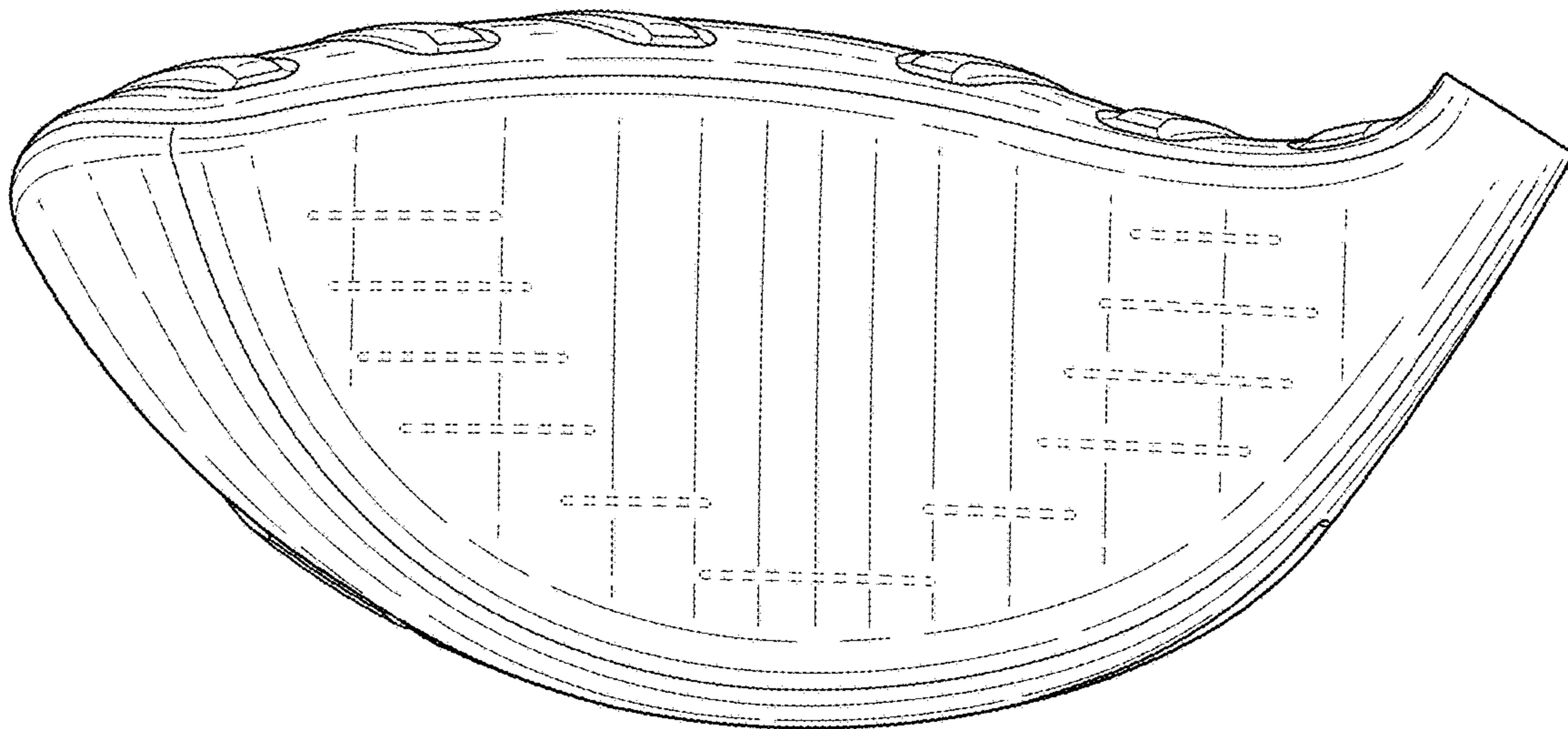
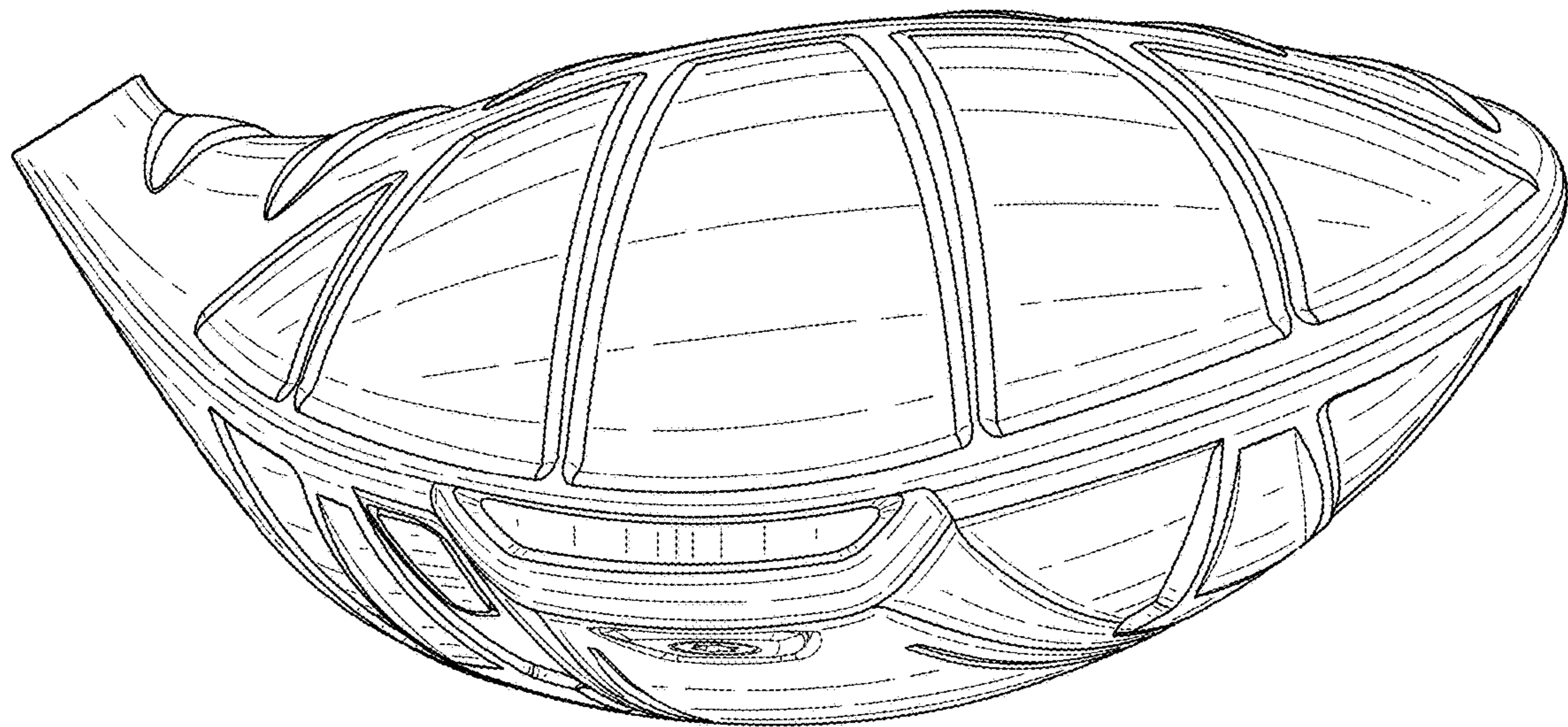


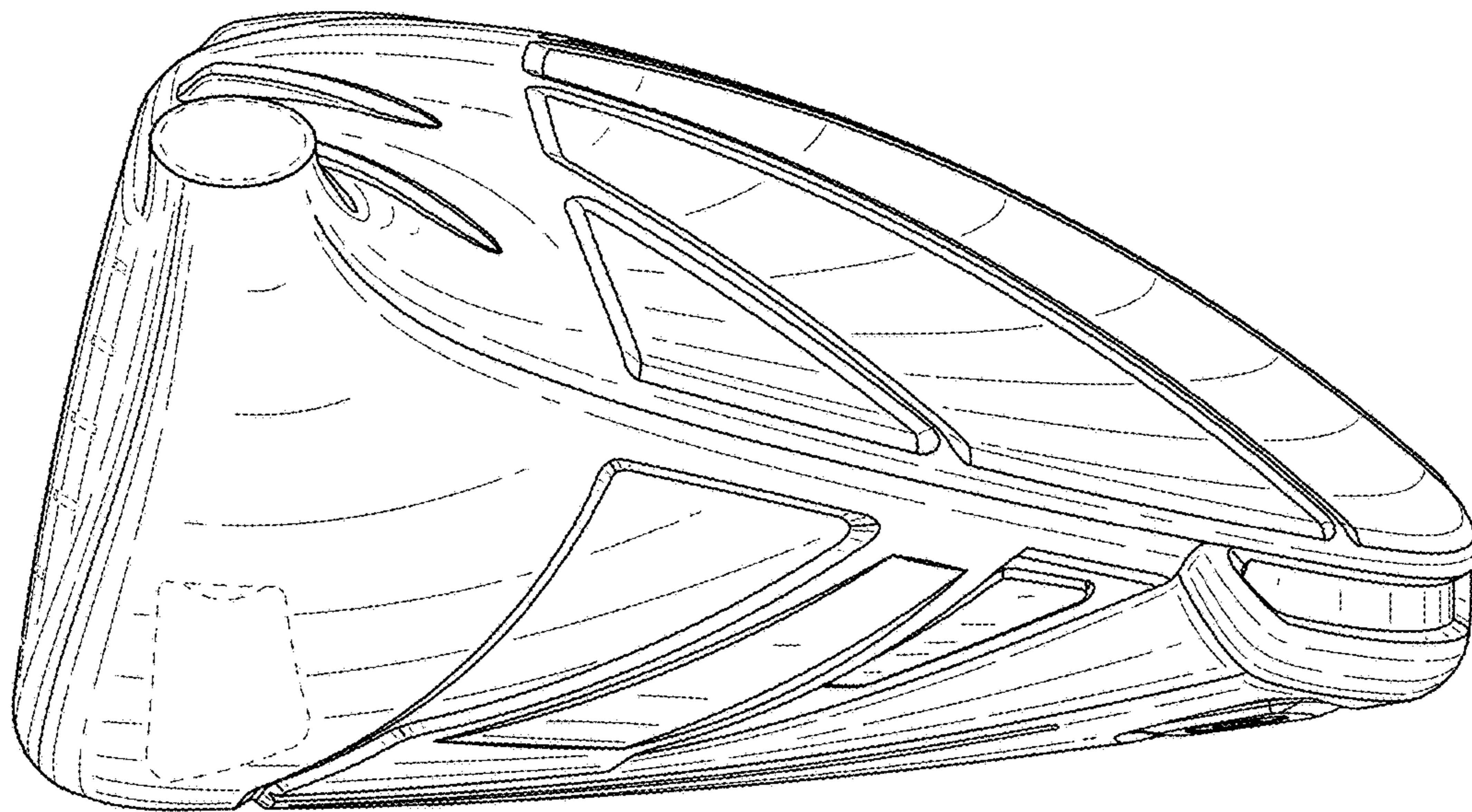

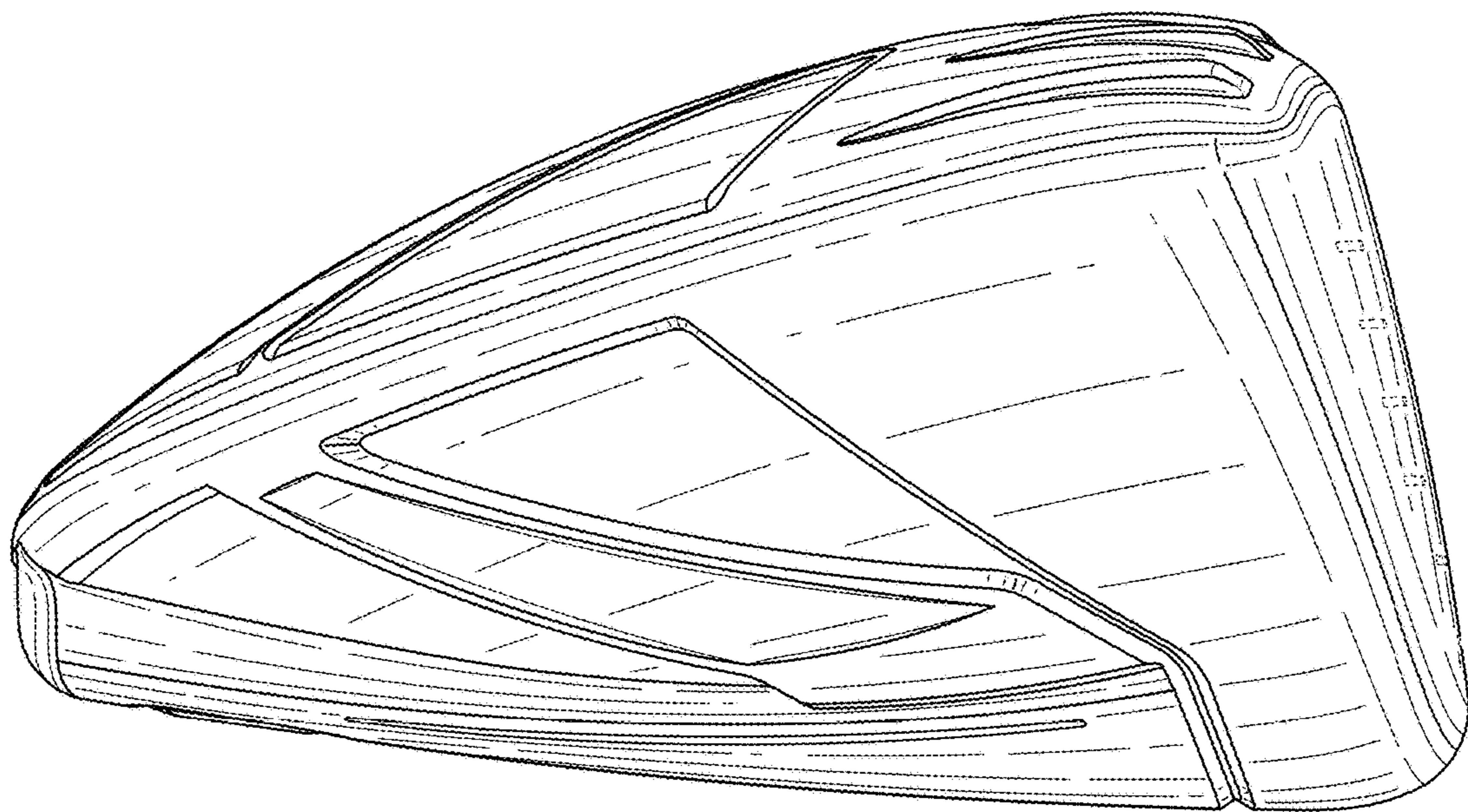

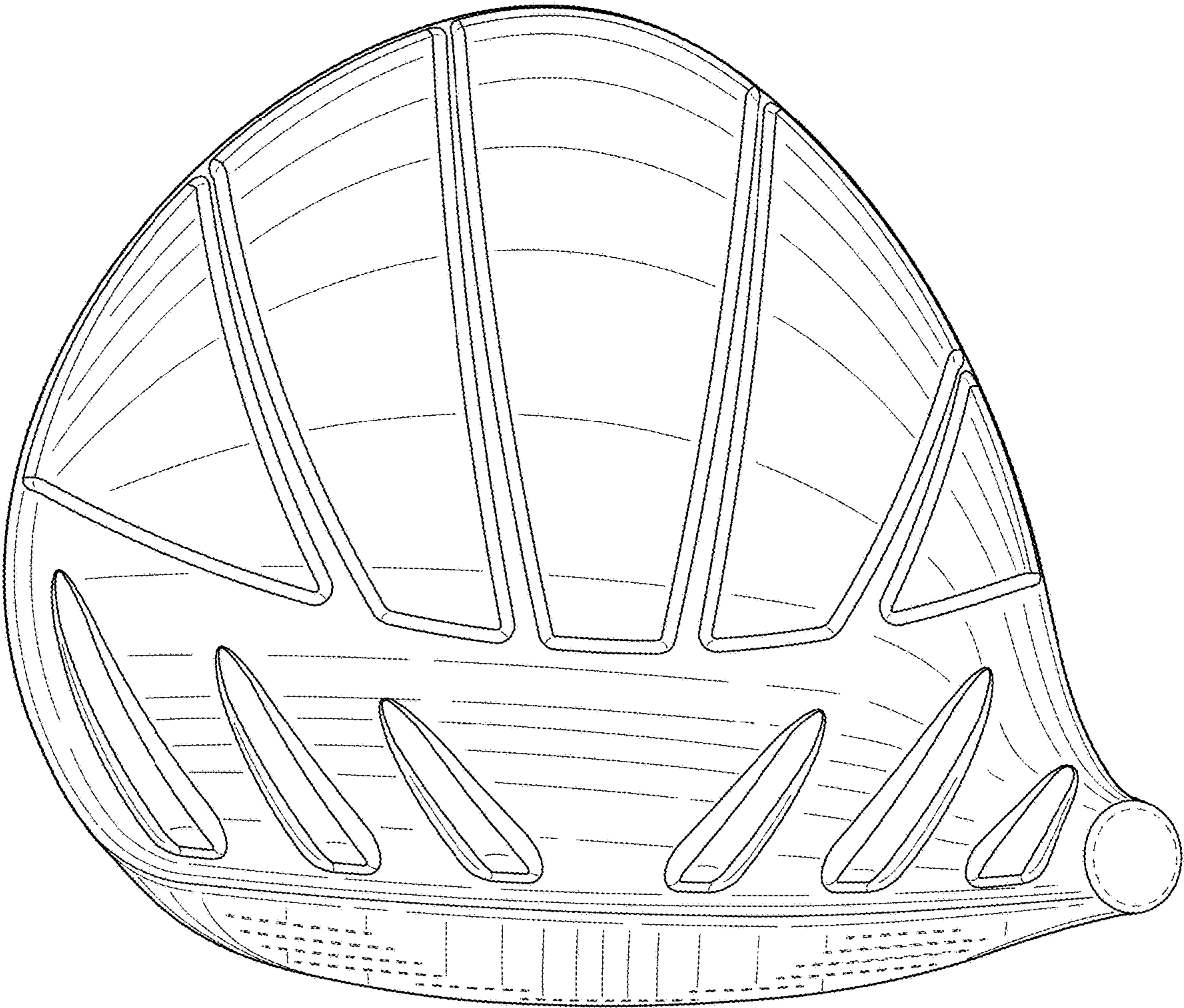

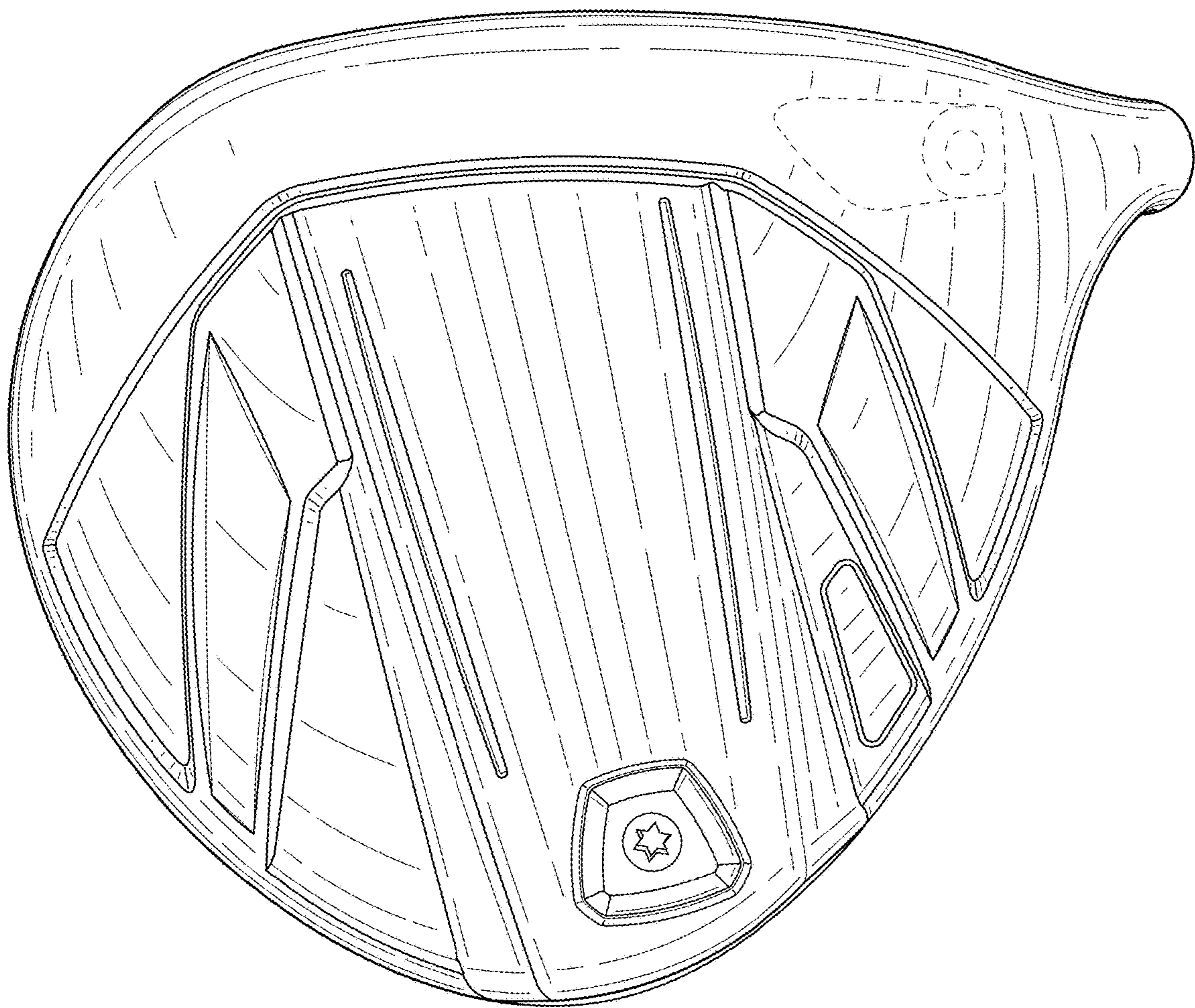
