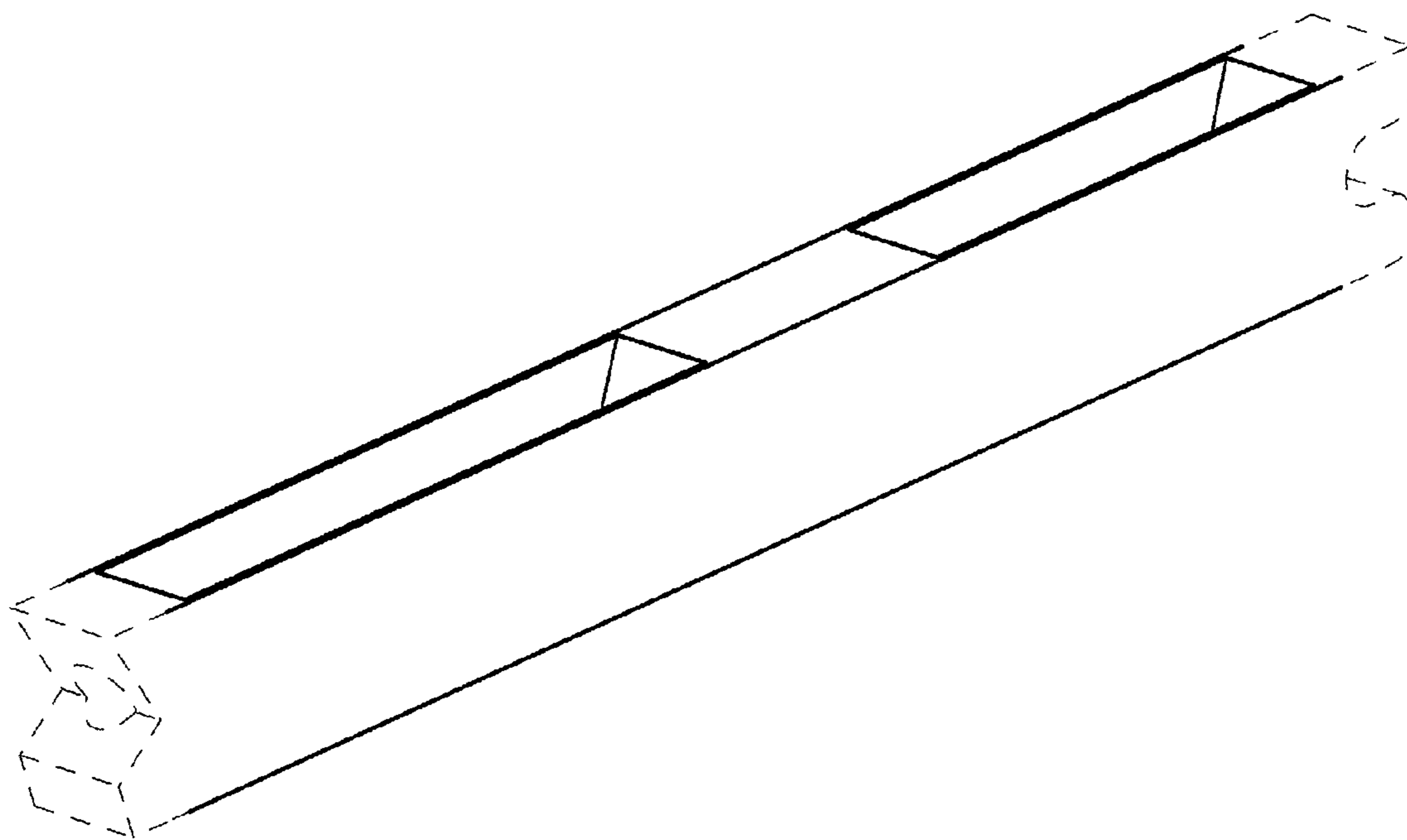
The ornamental design for a fin adapter for water craft, as shown and described.

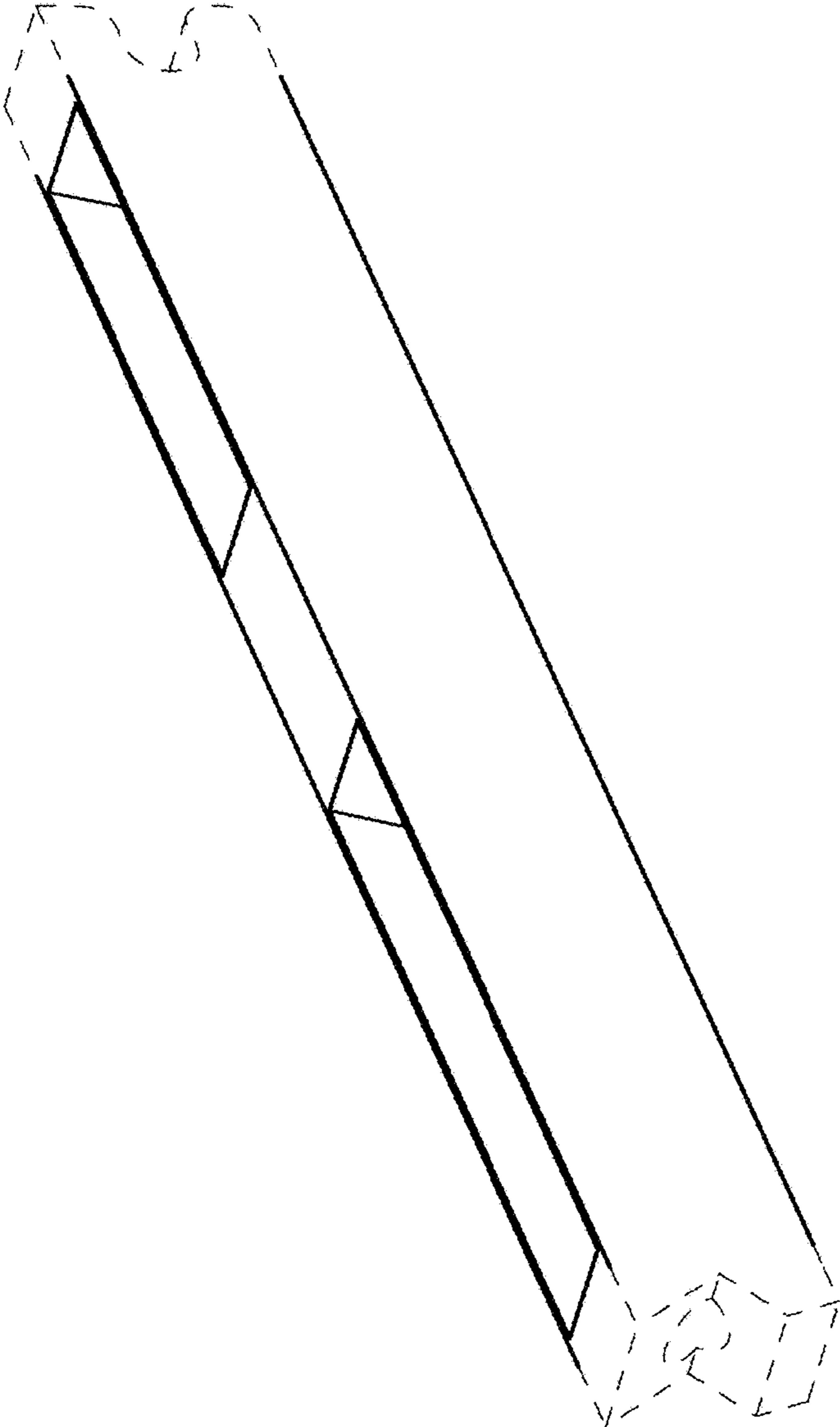

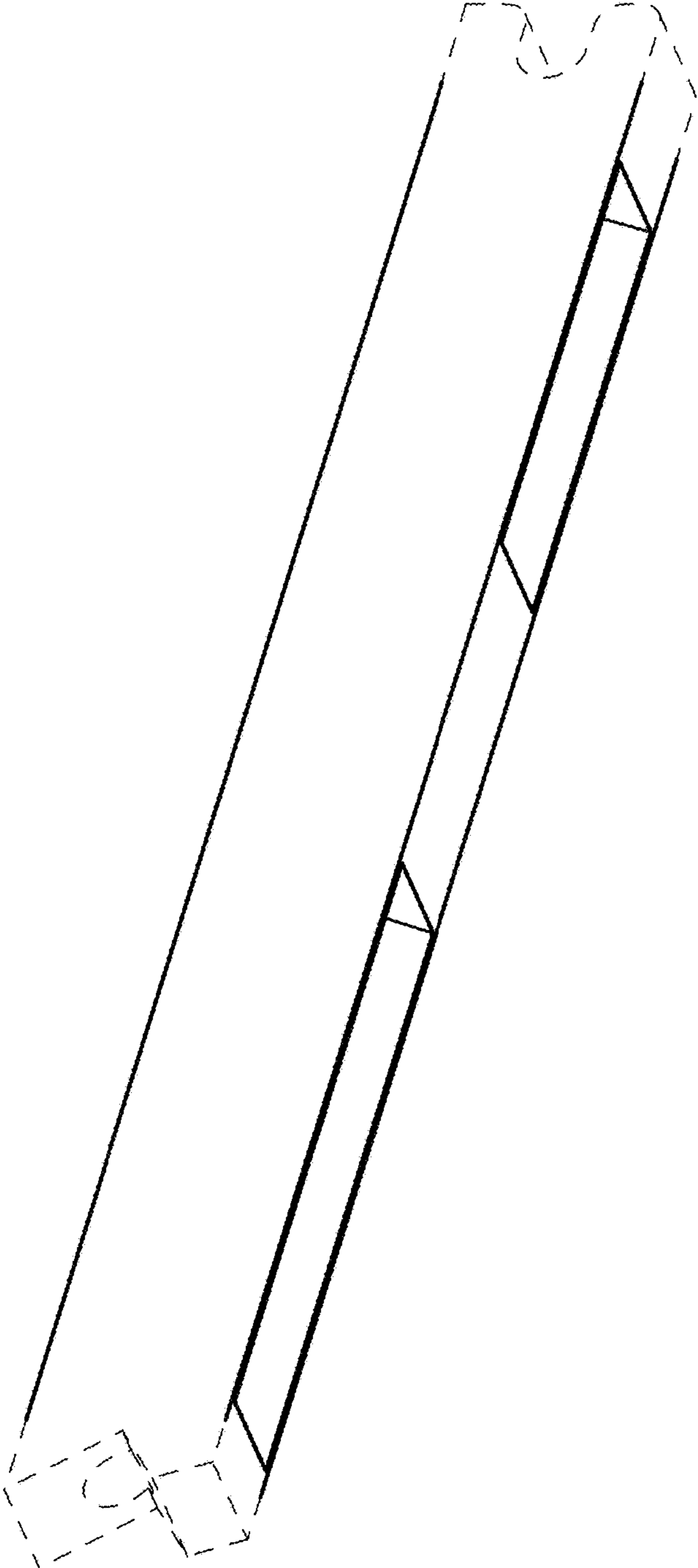

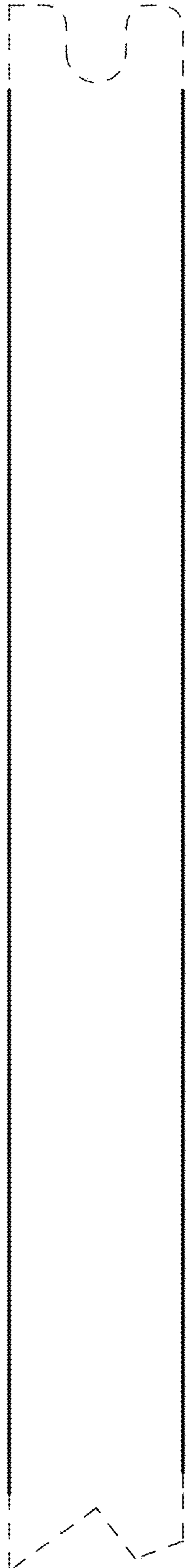

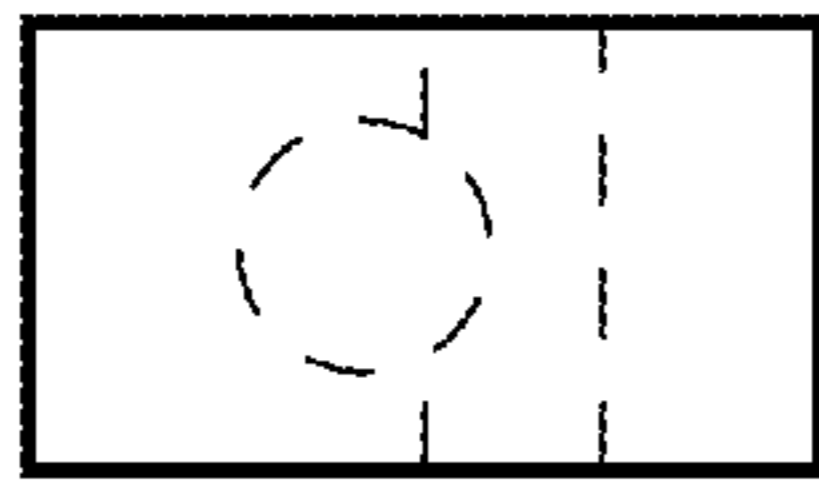

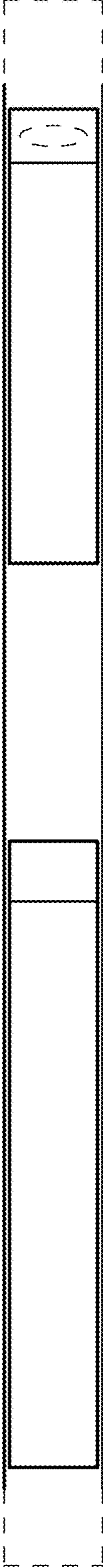

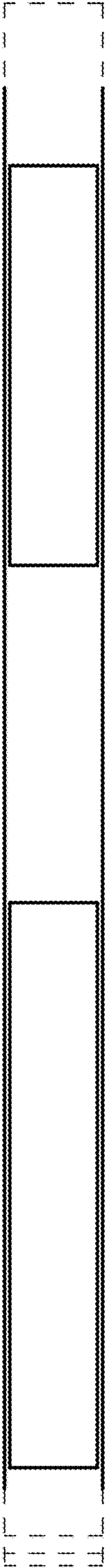
