The ornamental design for a faucet handle, as shown and described.

**DESCRIPTION**

FIG. 1 is a front and right side perspective view of a faucet handle showing the new design;  
FIG. 2 is a front elevational view thereof;

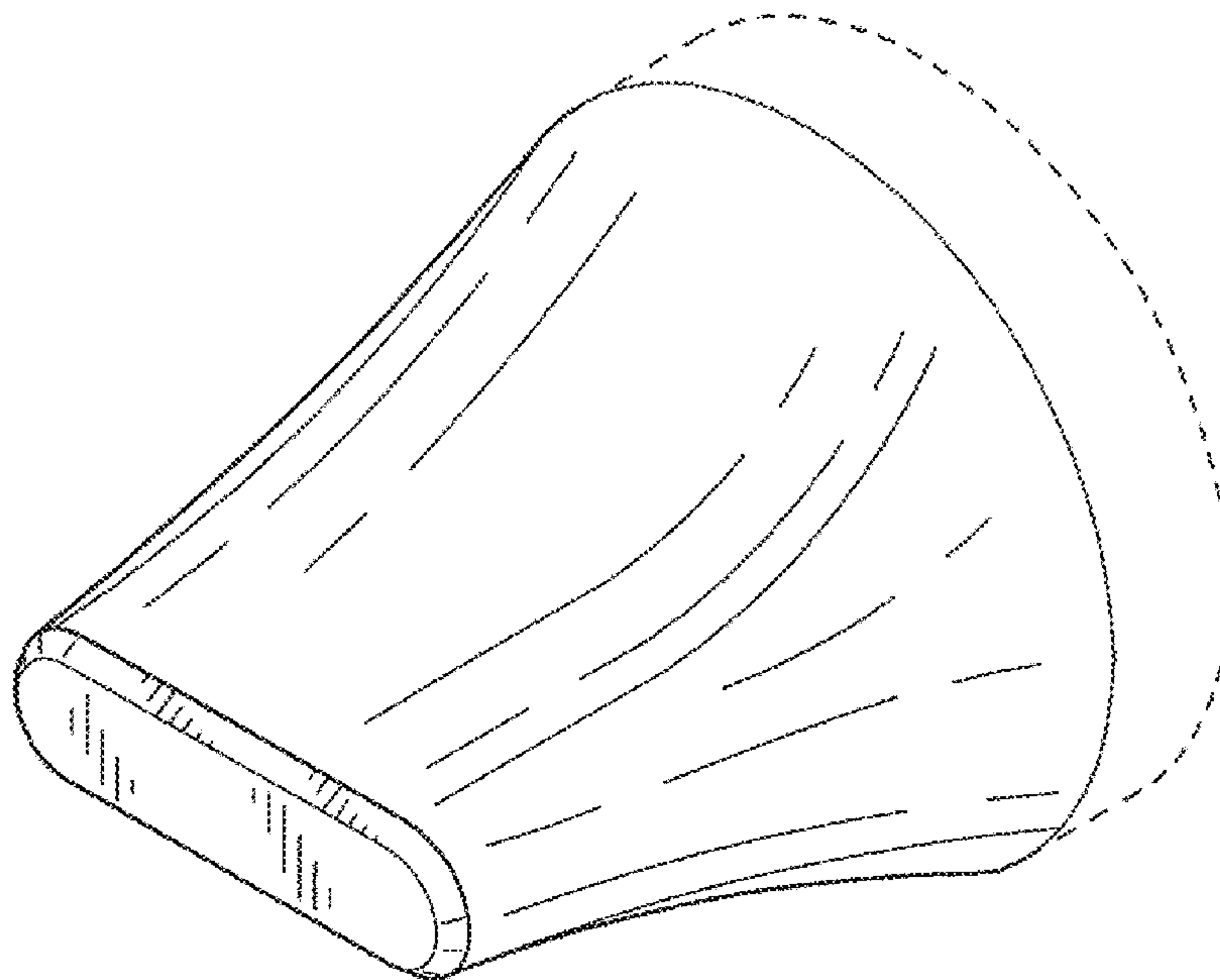

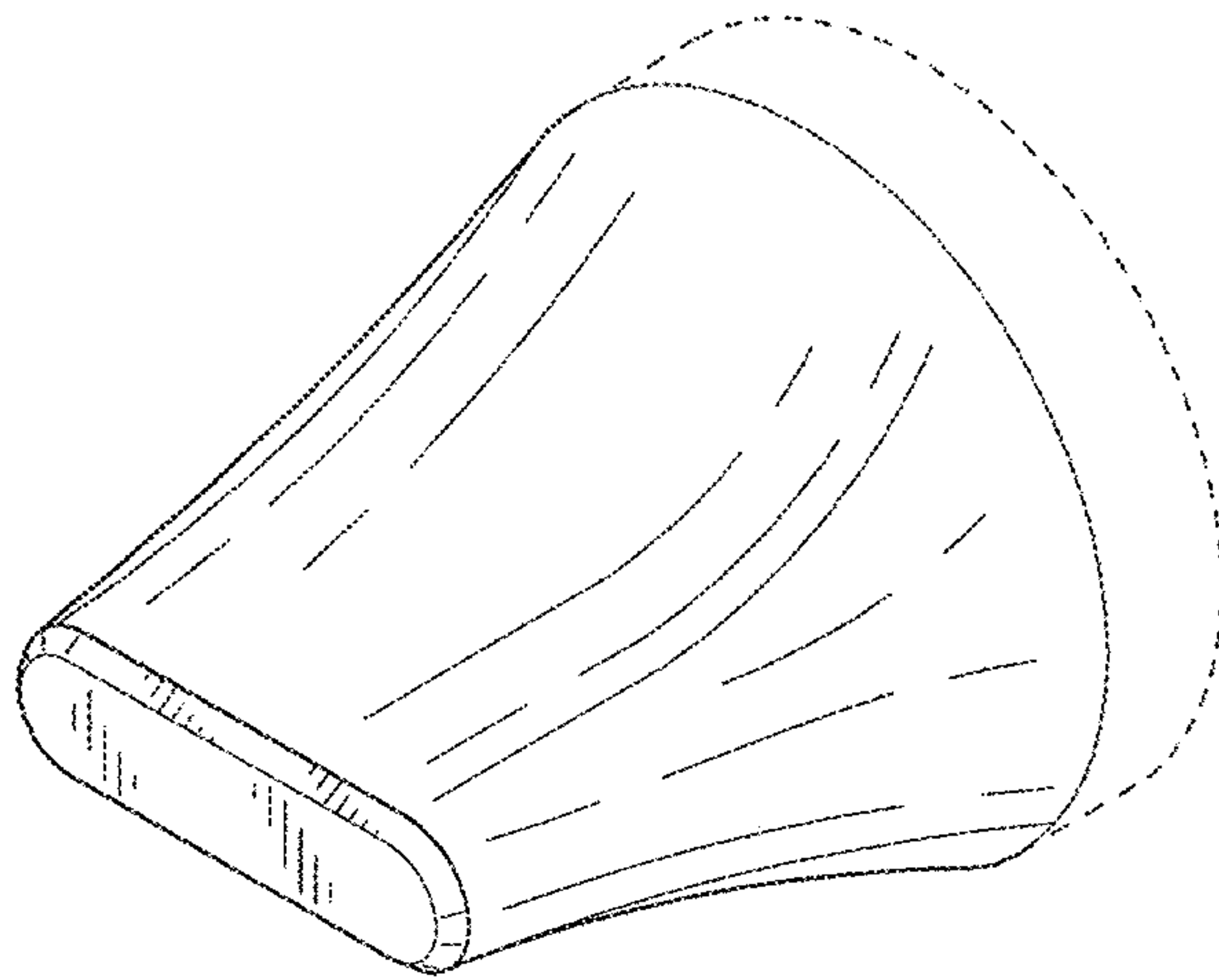

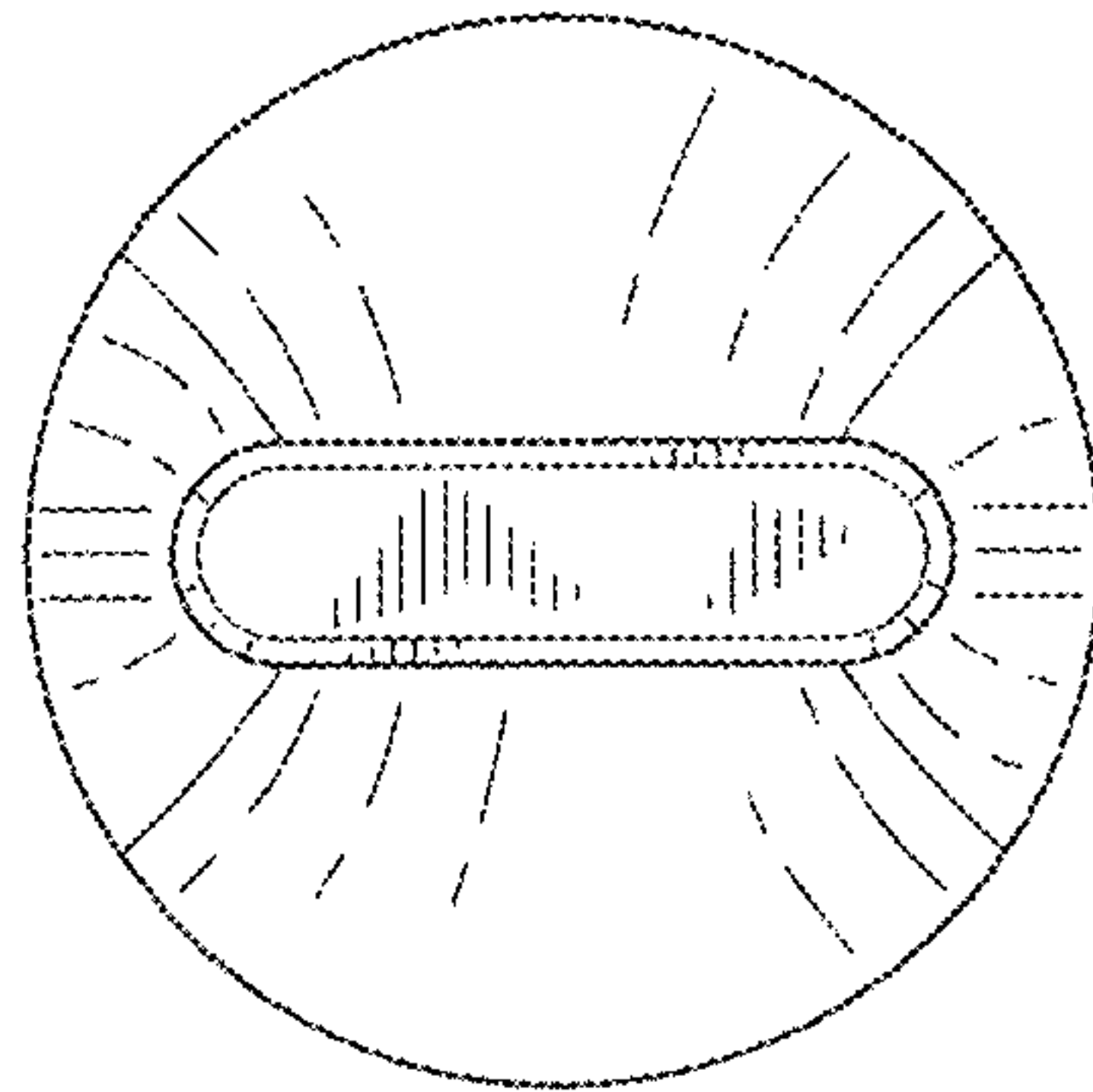

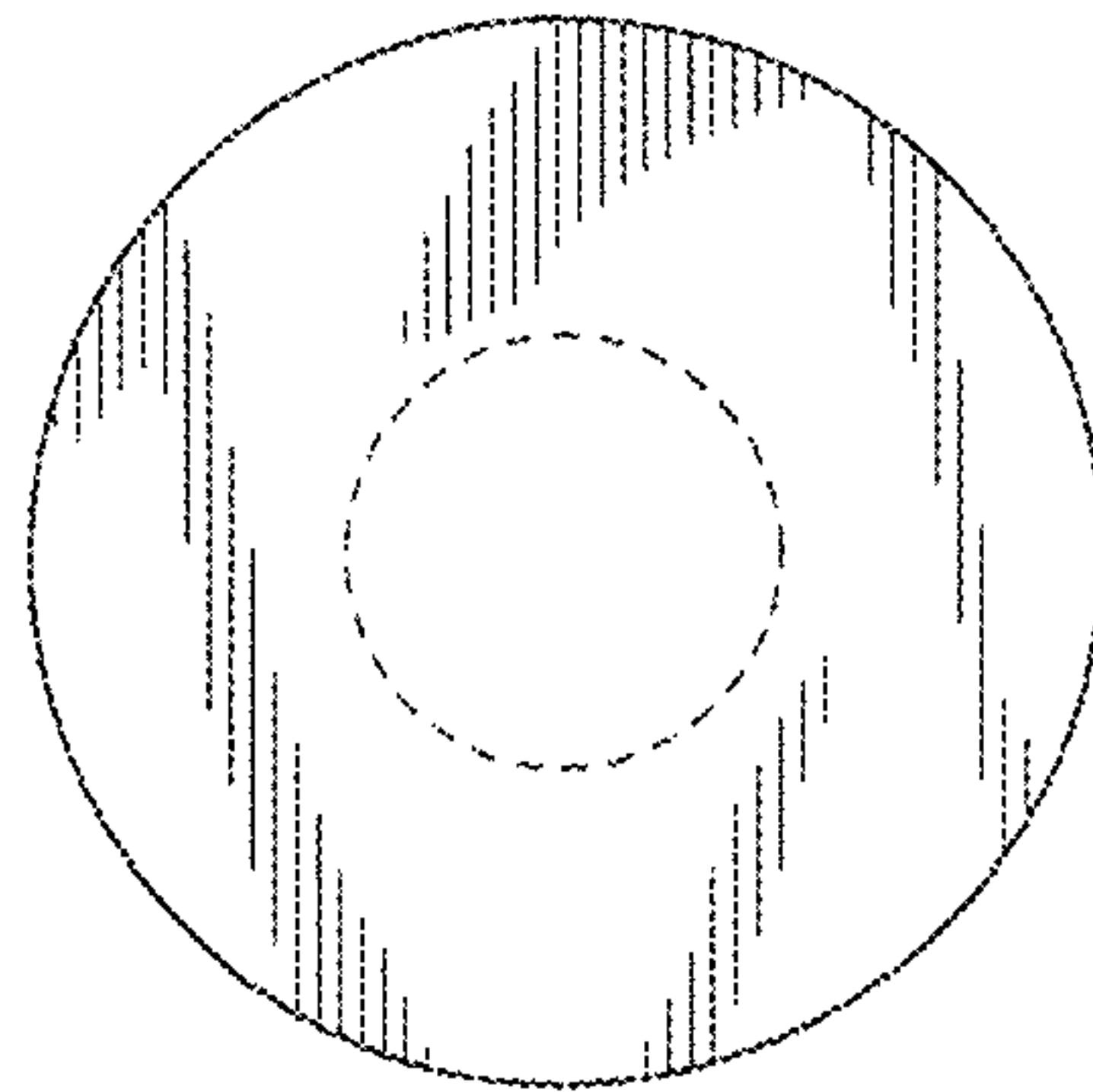

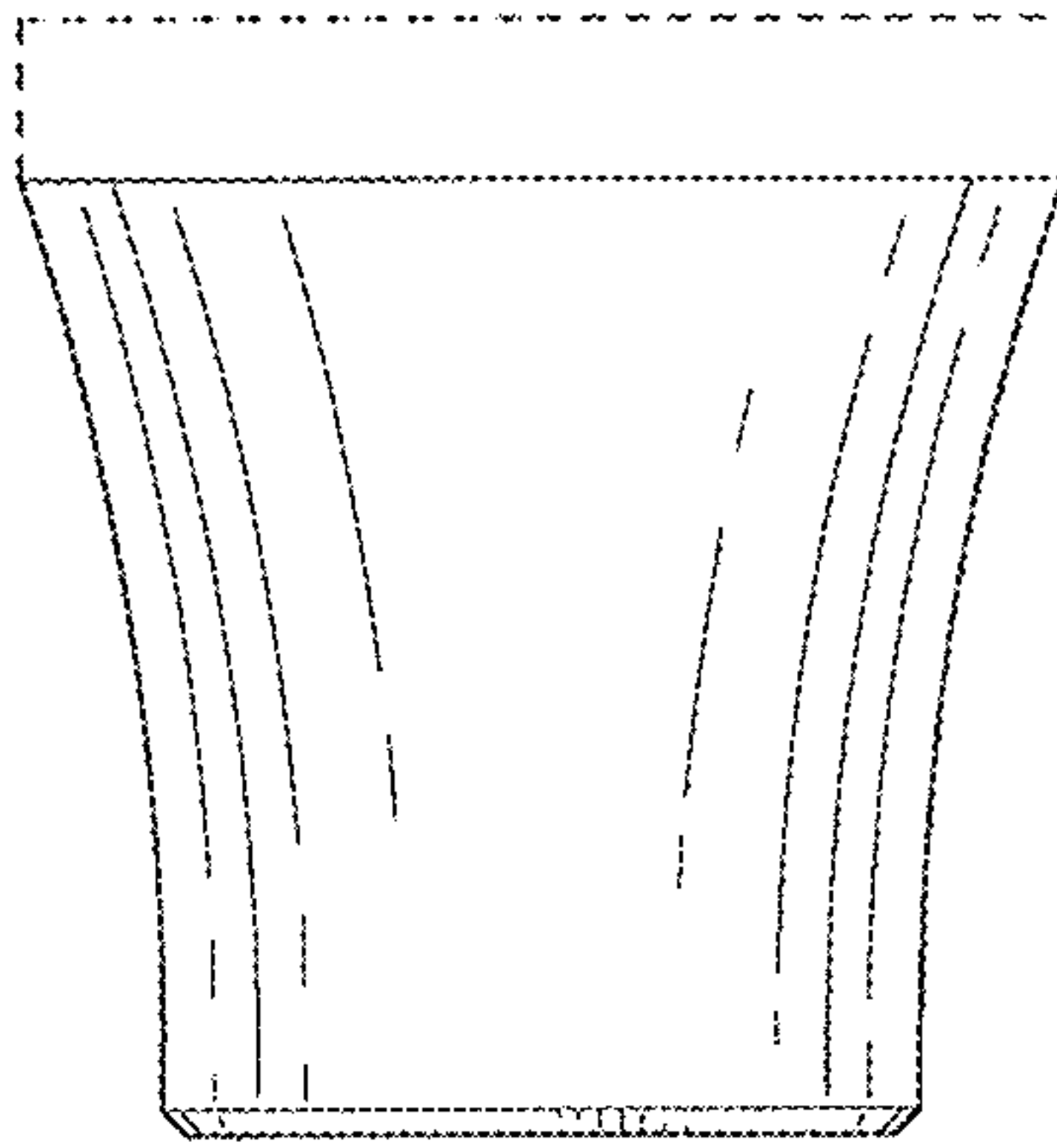

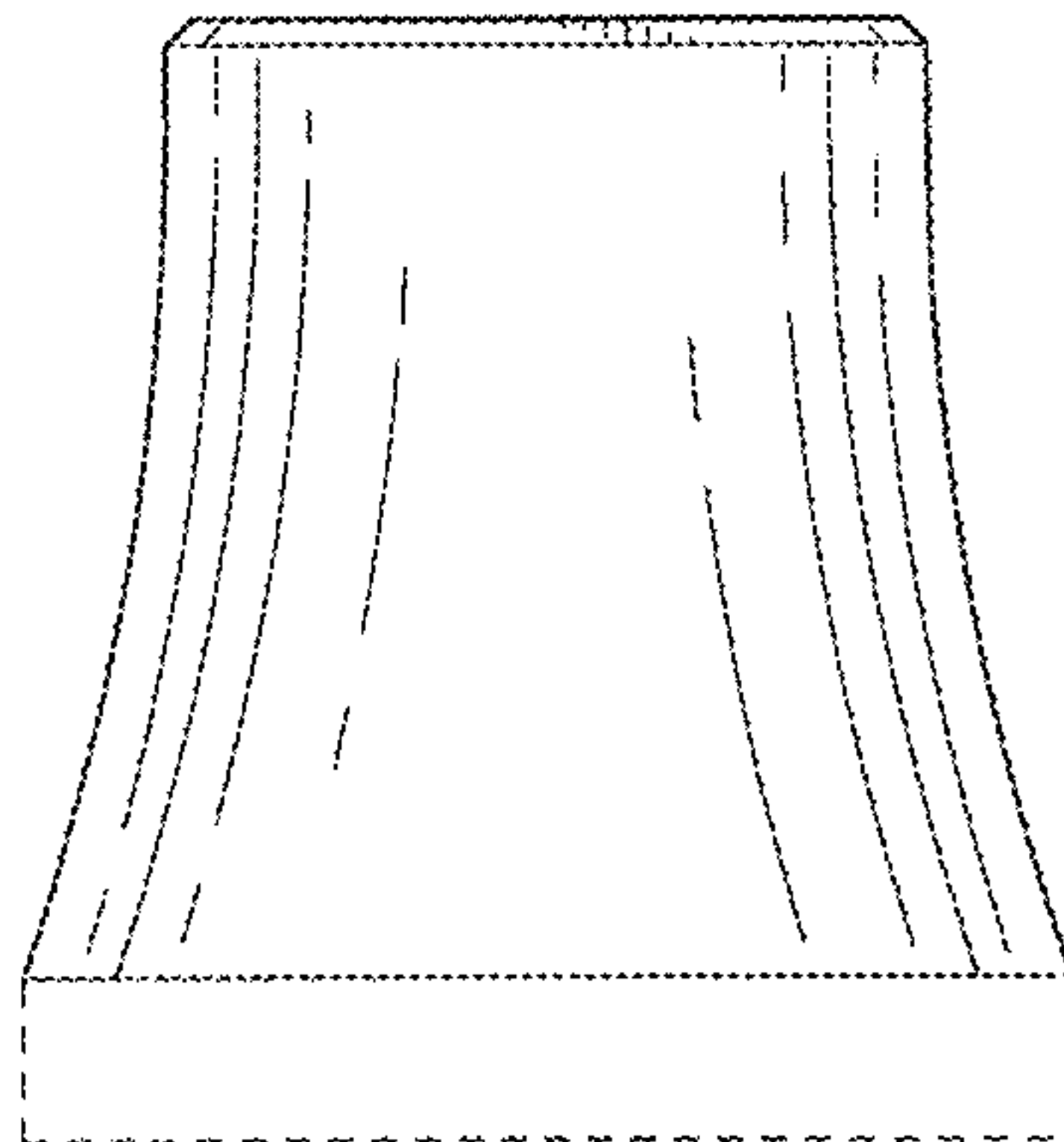

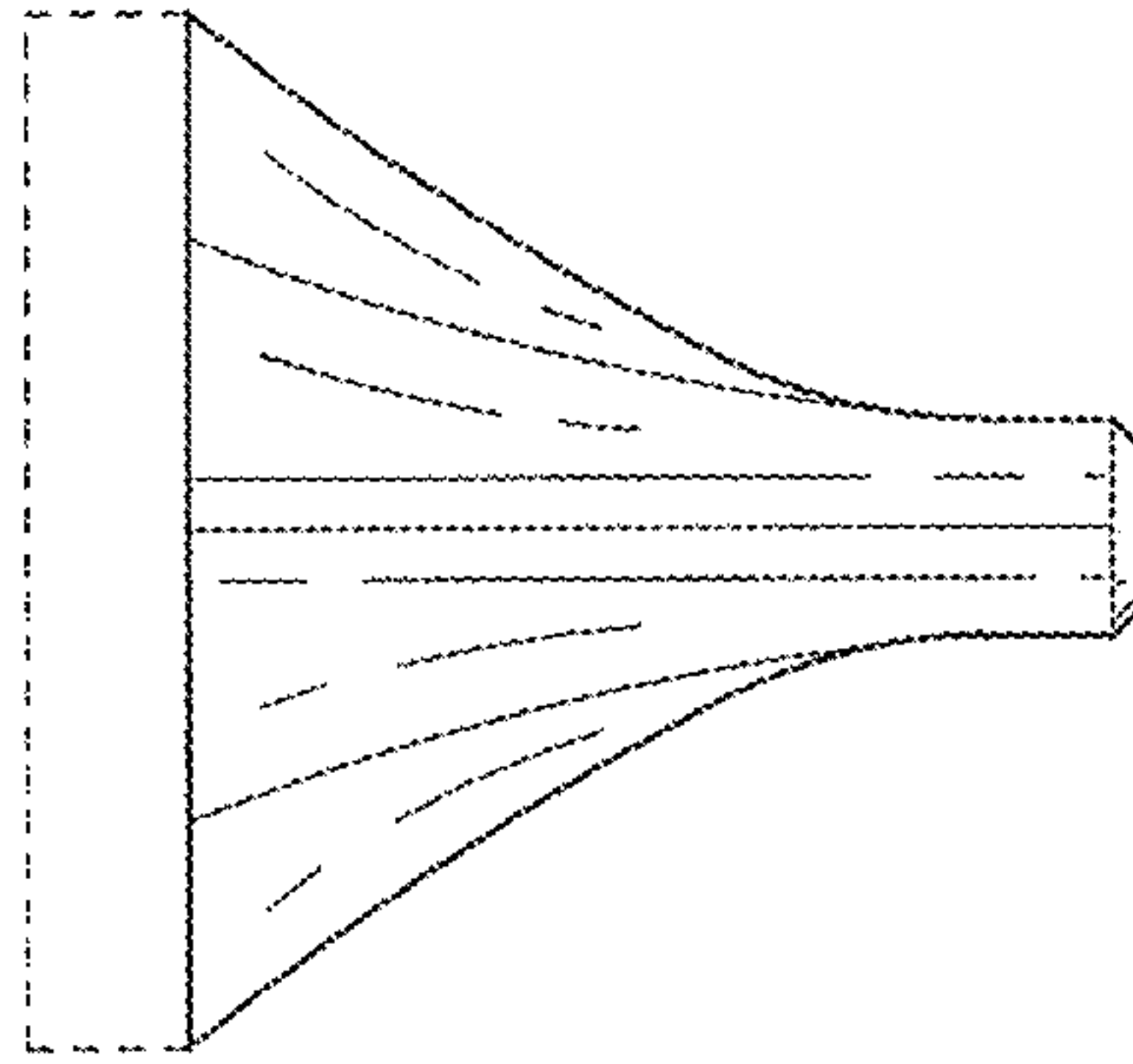
