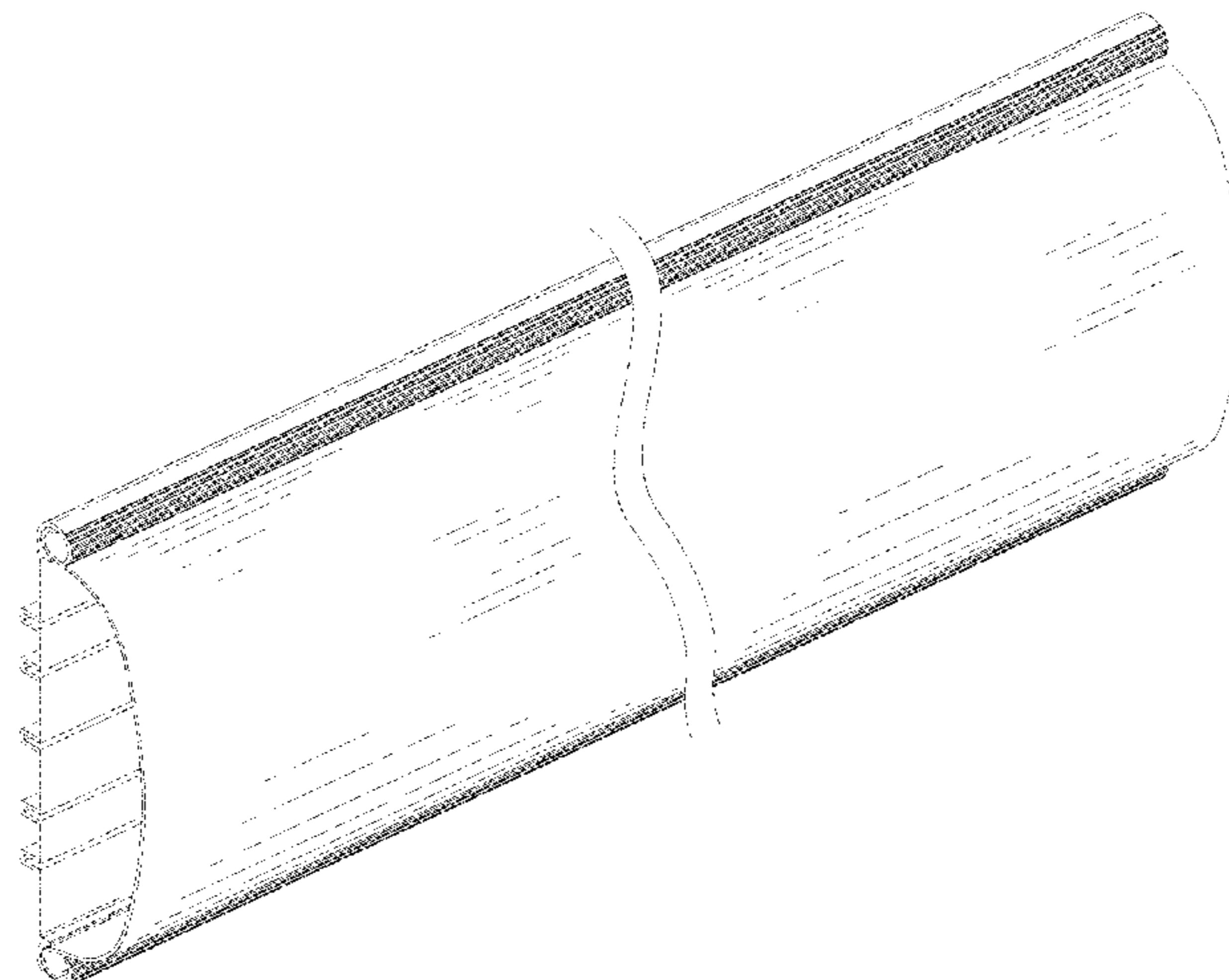
(57) **CLAIM**

The ornamental design for a light fixture, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a first embodiment of a light fixture;
FIG. 2 is a top view of a light fixture;
FIG. 3 is a bottom view of a light fixture;
FIG. 4 is a right side view of a light fixture;
FIG. 5 is a left side view of a light fixture;
FIG. 6 is a front view of a light fixture;

FIG. 9 is a top view of a light fixture;

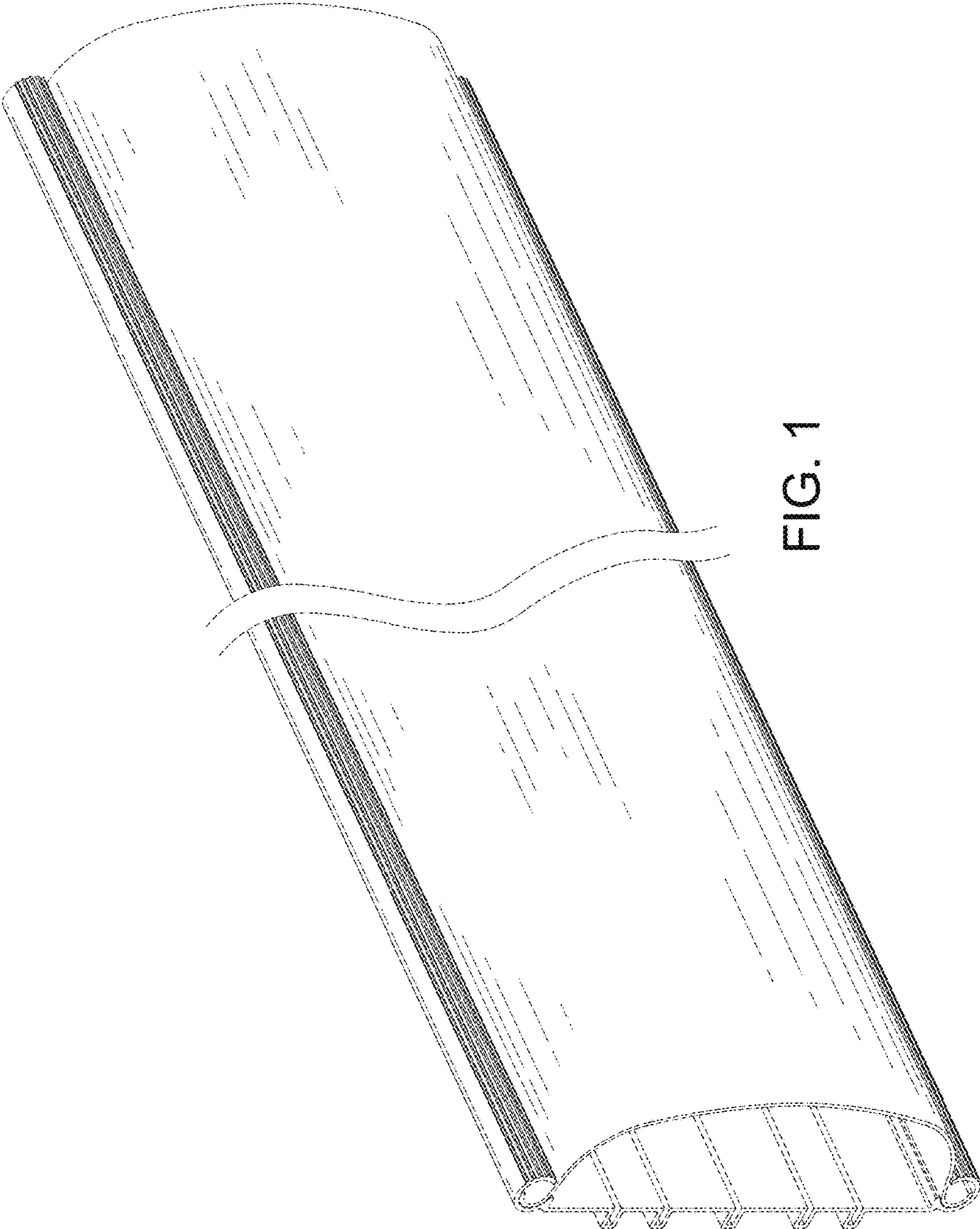

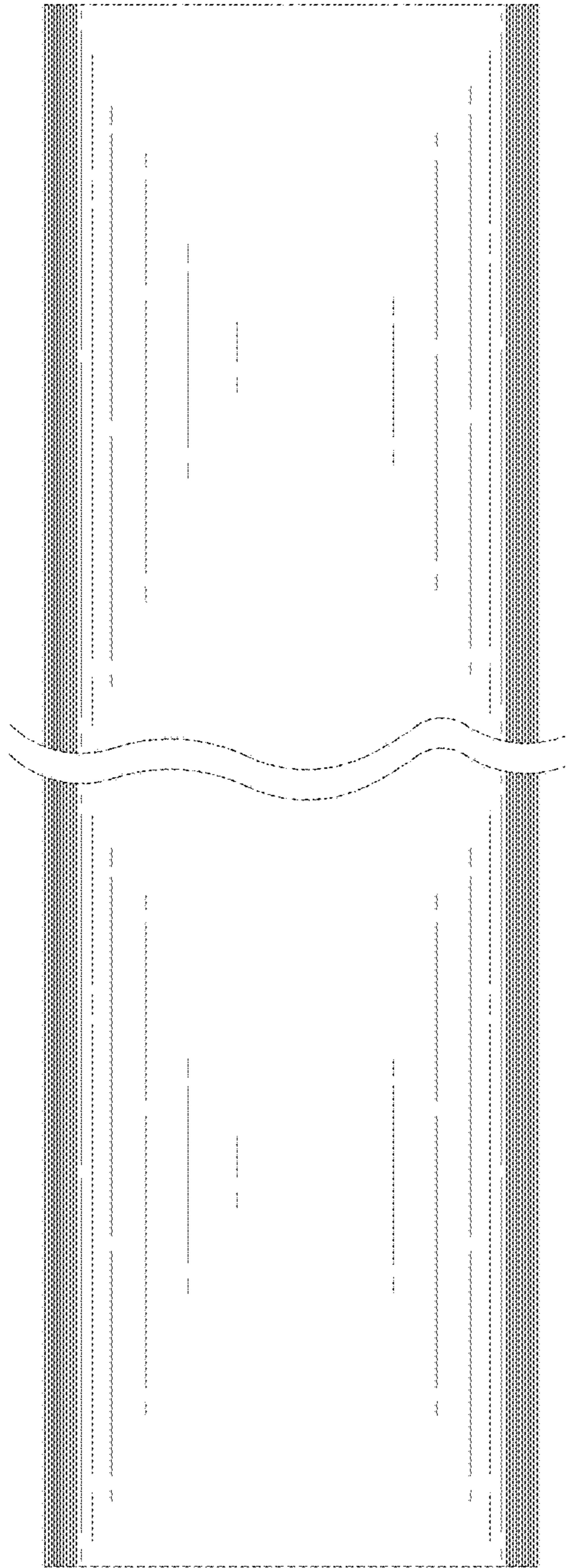

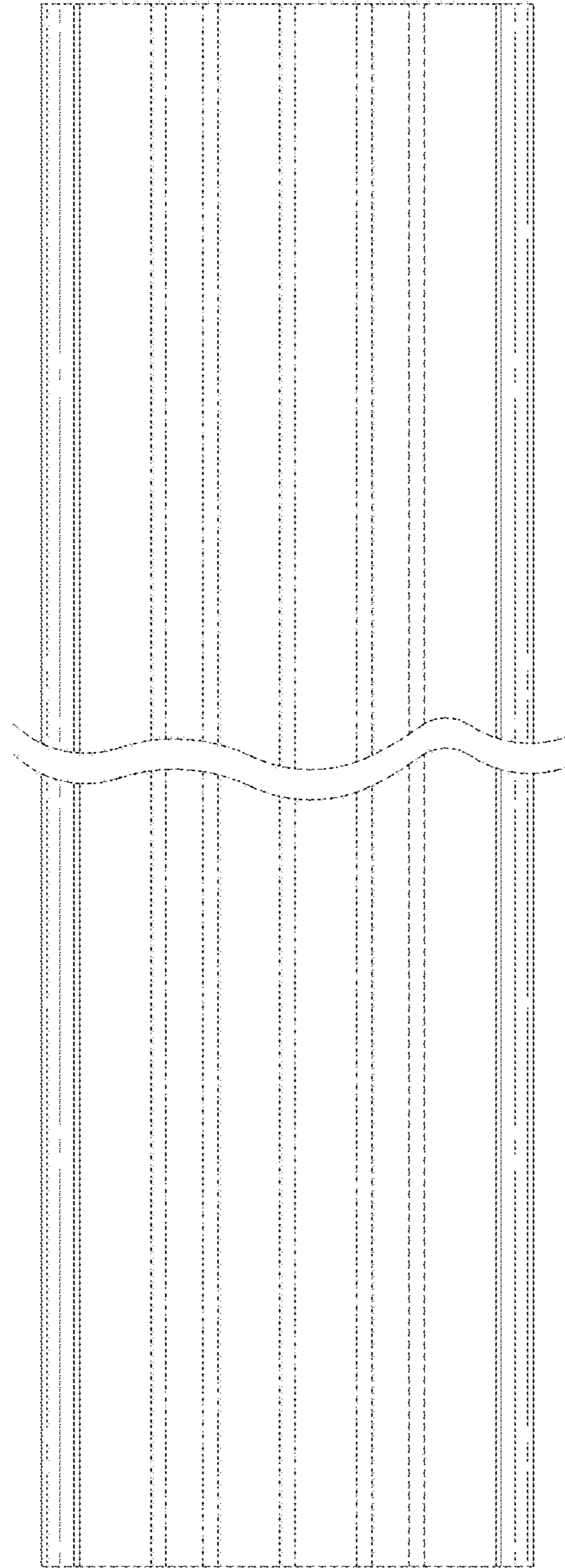

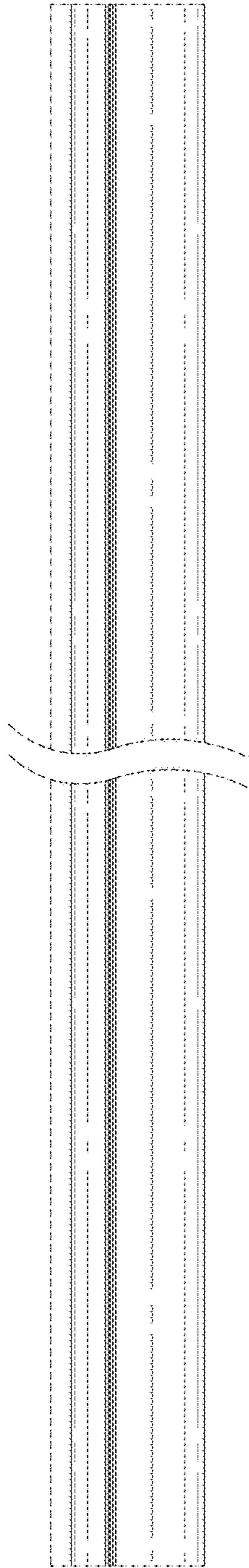

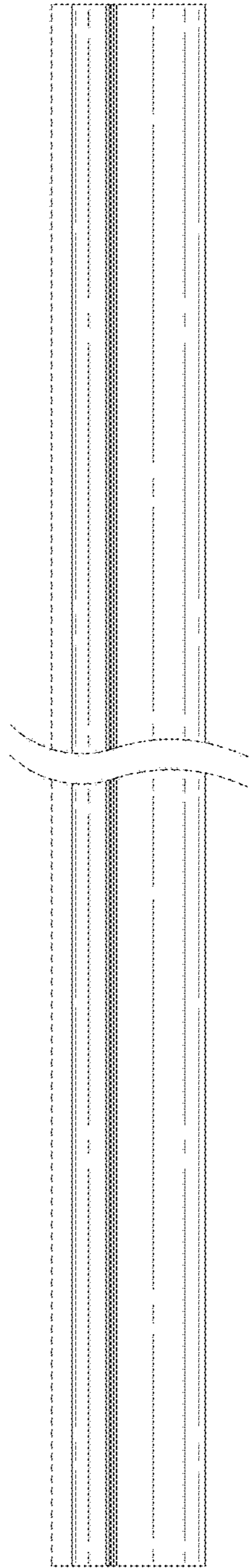

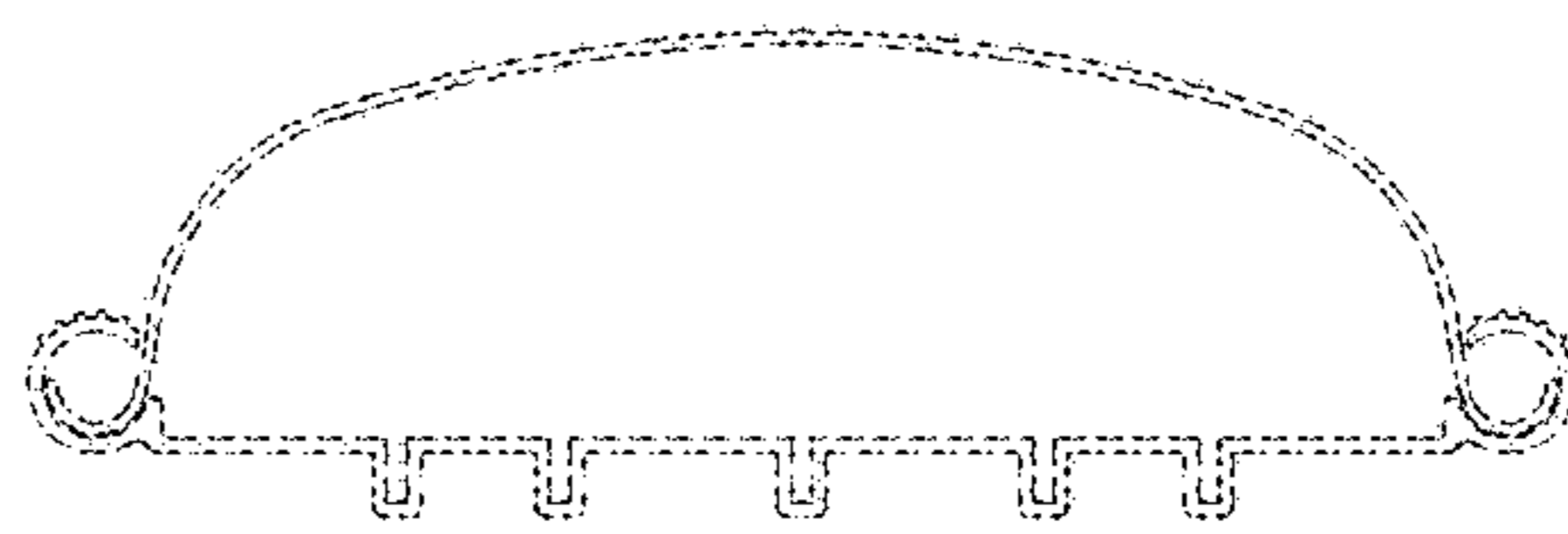

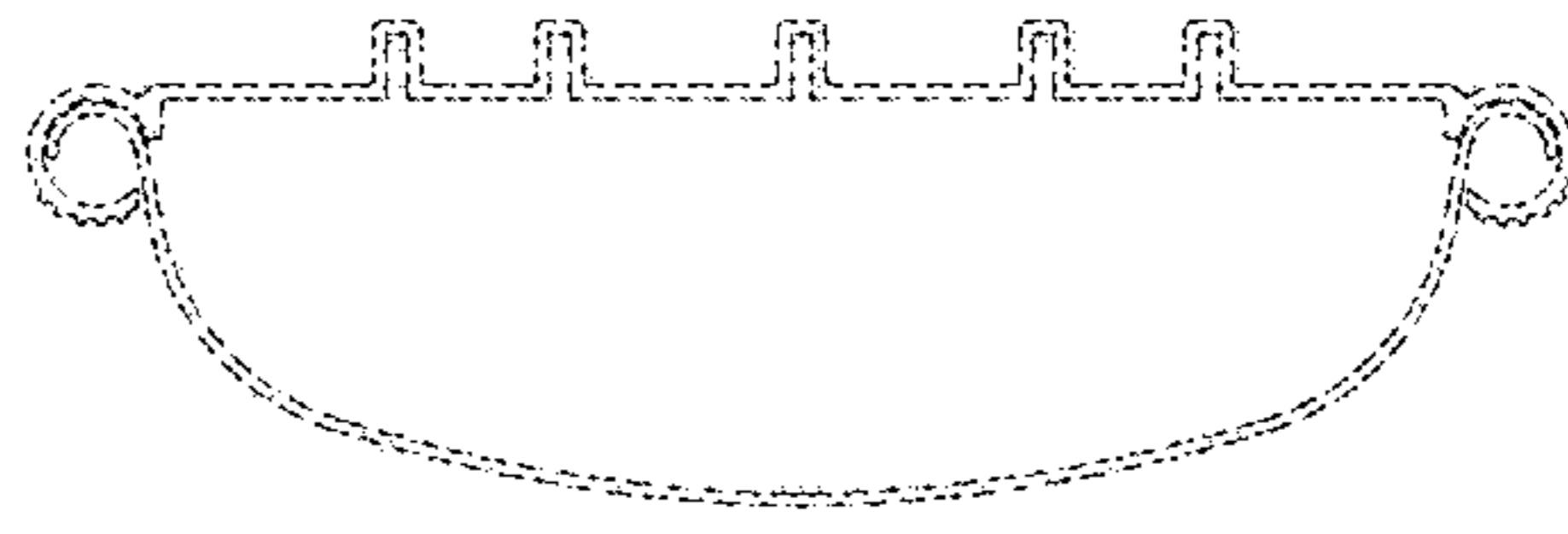

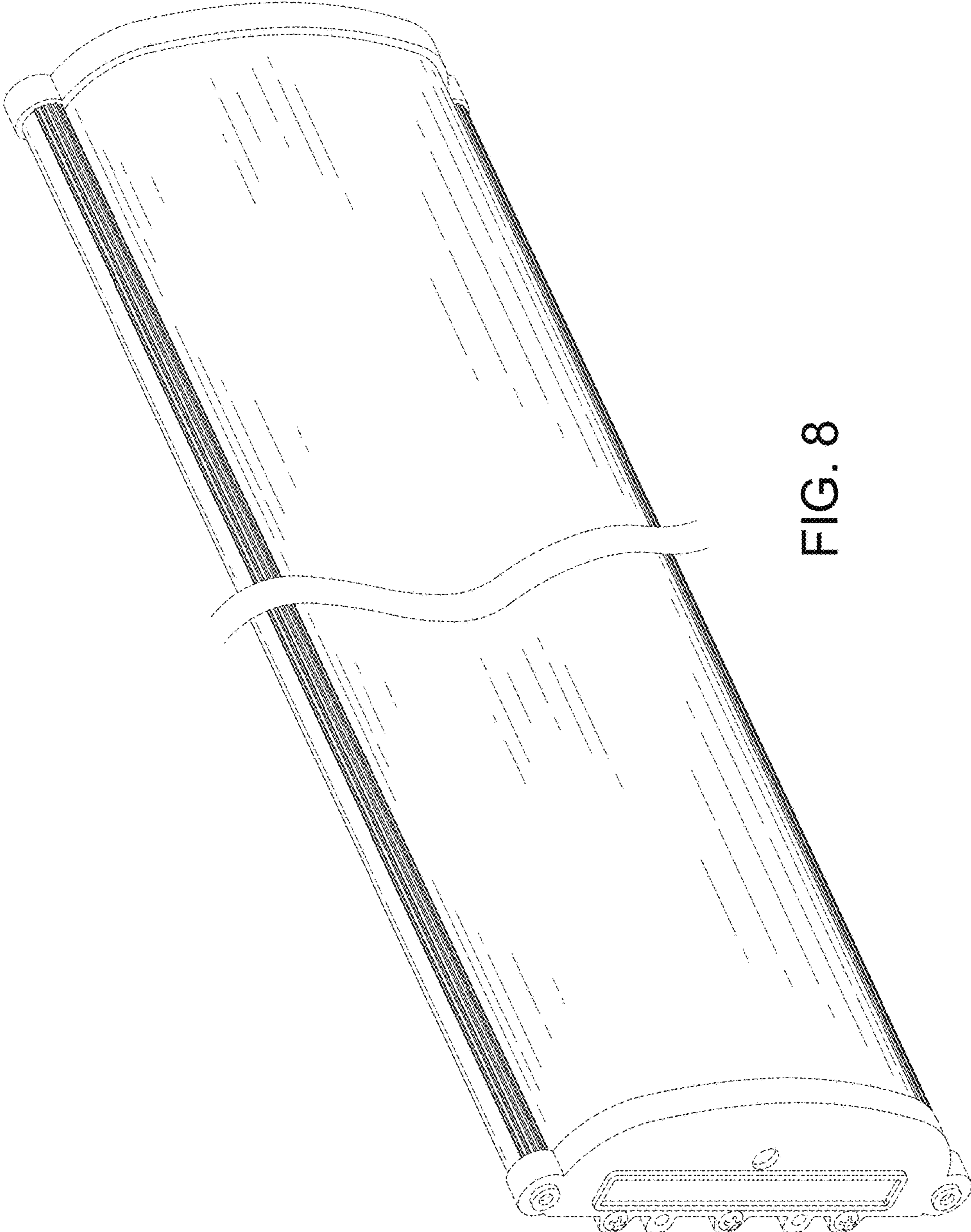

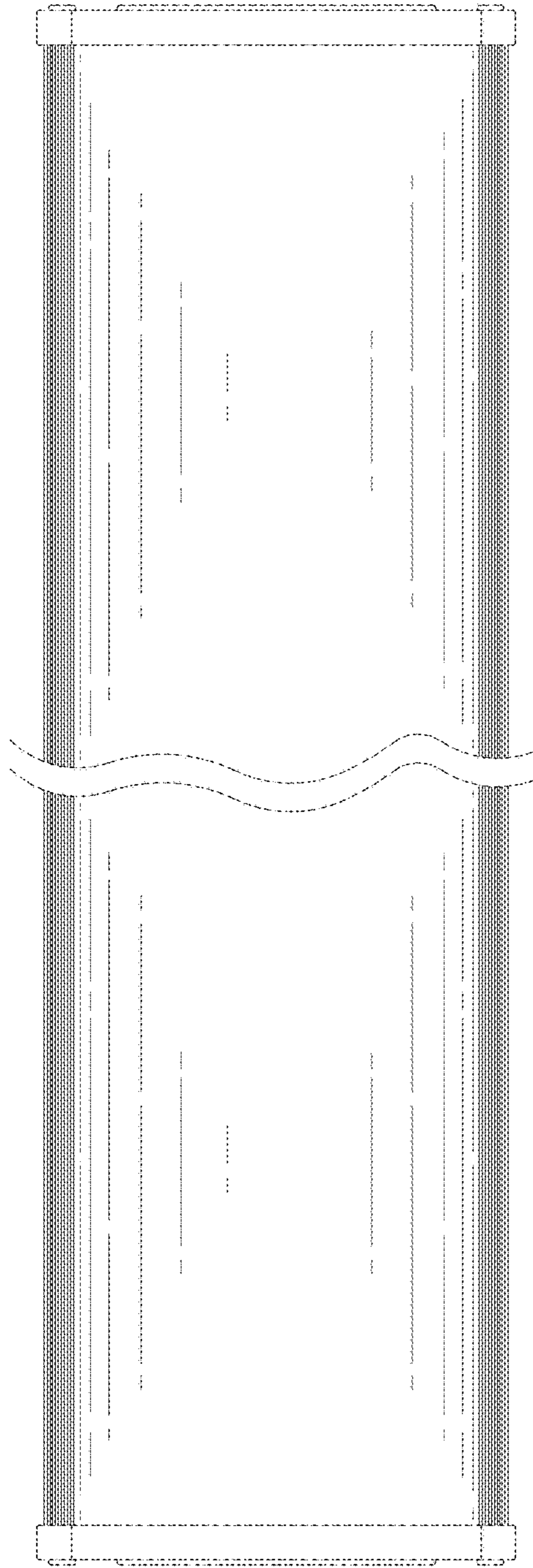

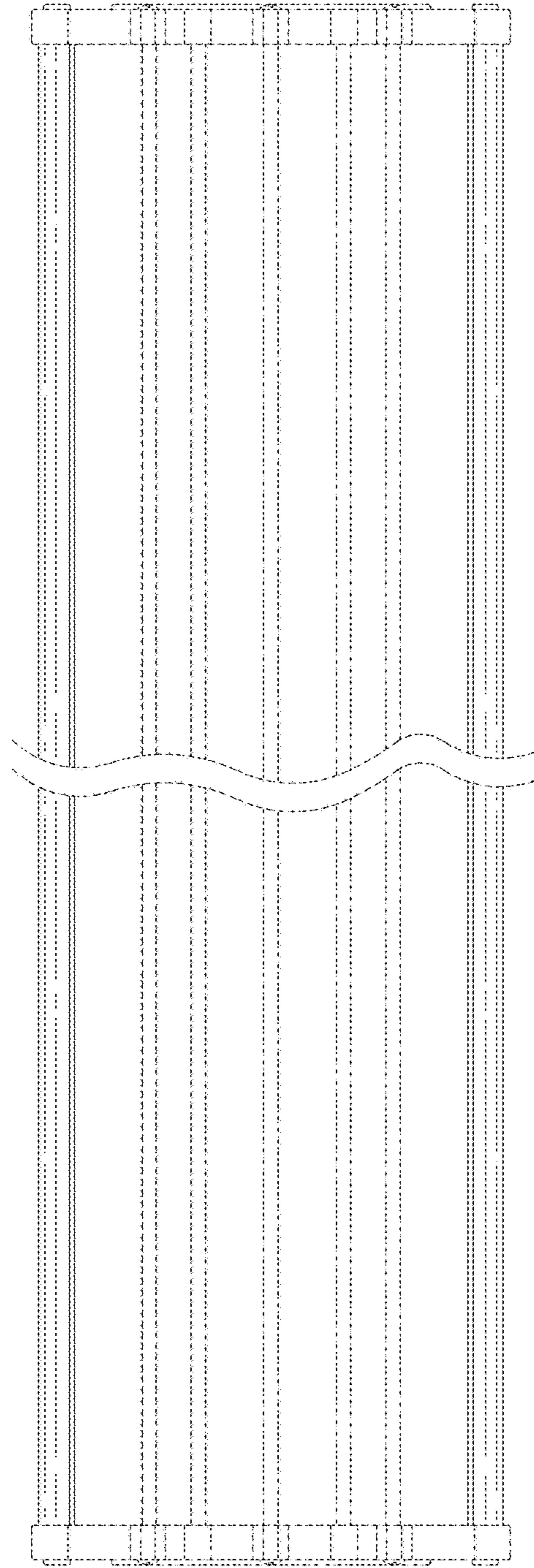

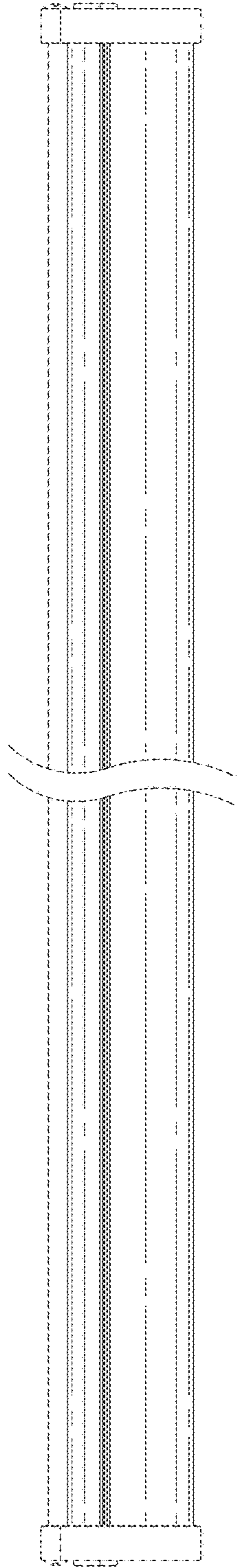

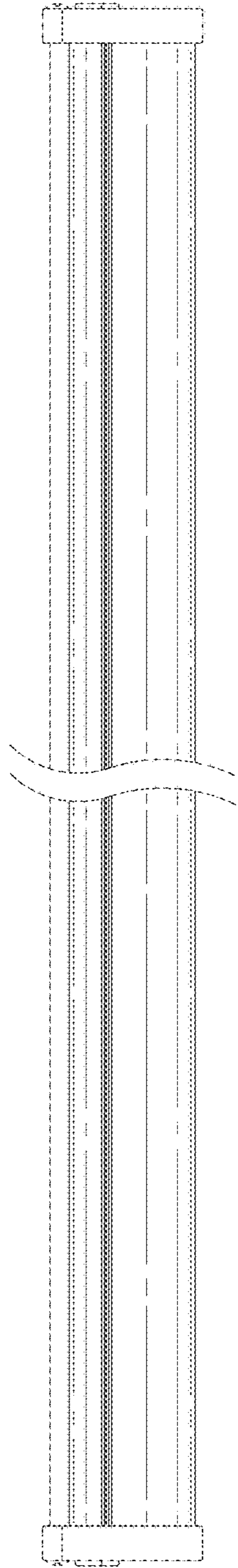

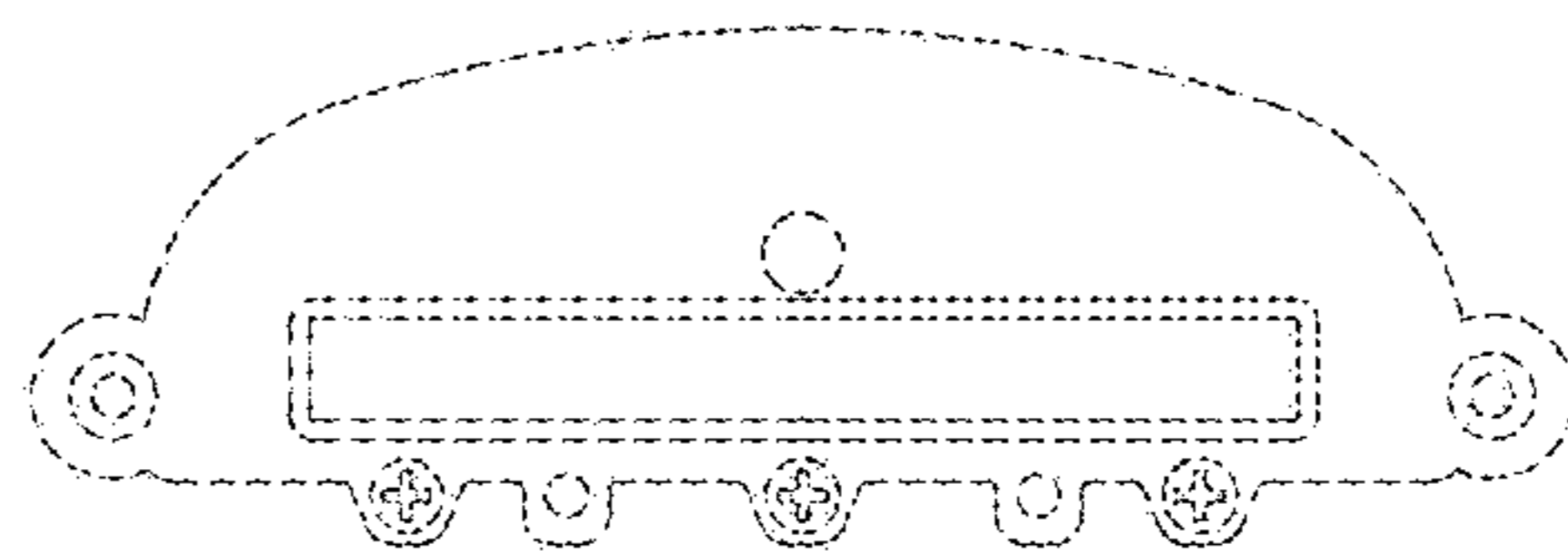

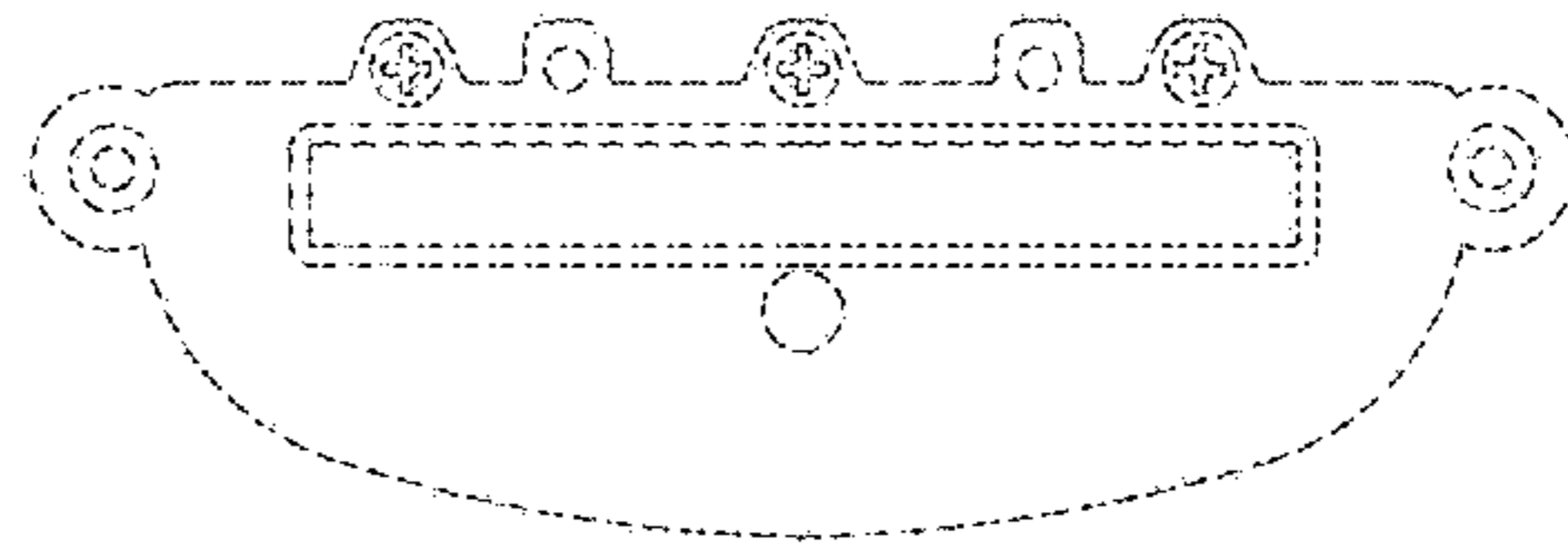
