(57) **CLAIM**

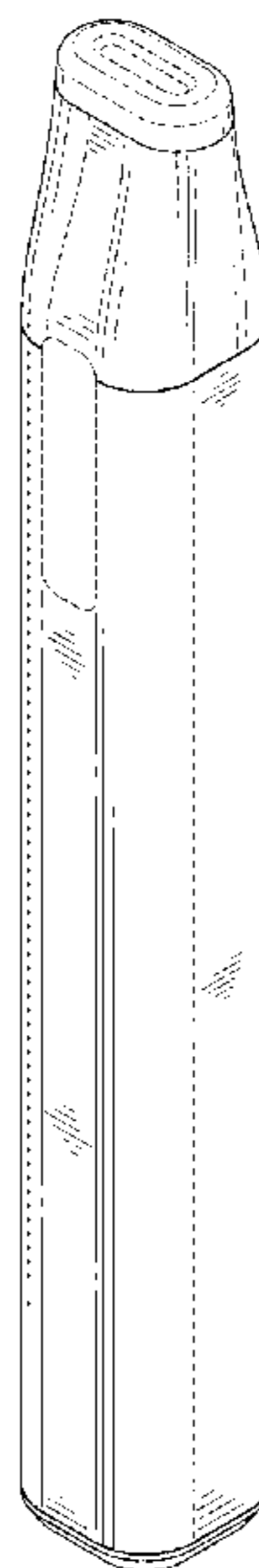
I claim the ornamental design for an electronic cigarette, substantially as shown and described.

DESCRIPTION

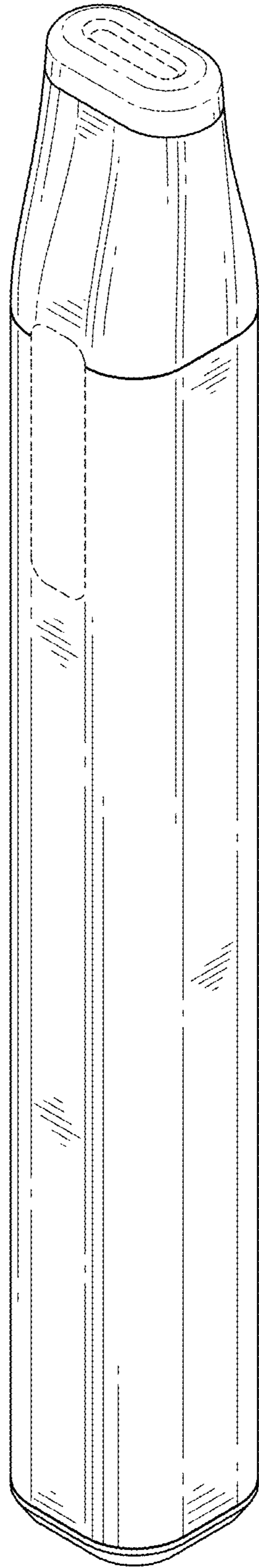

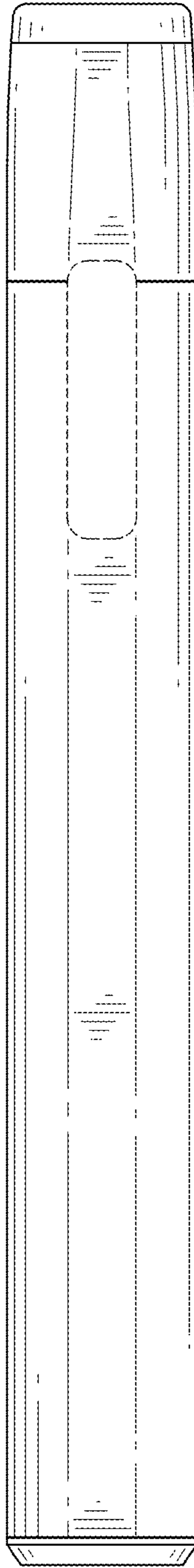

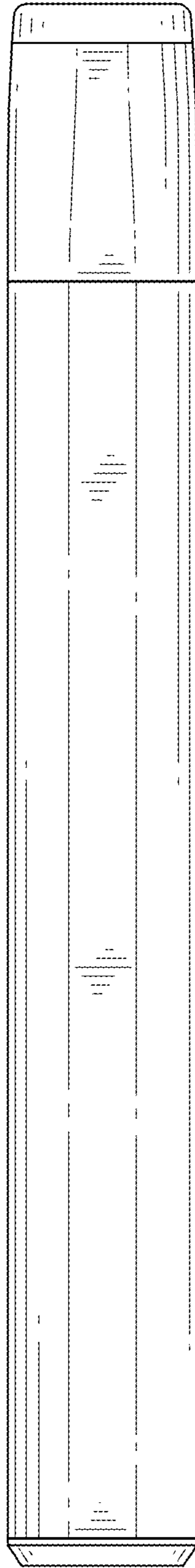

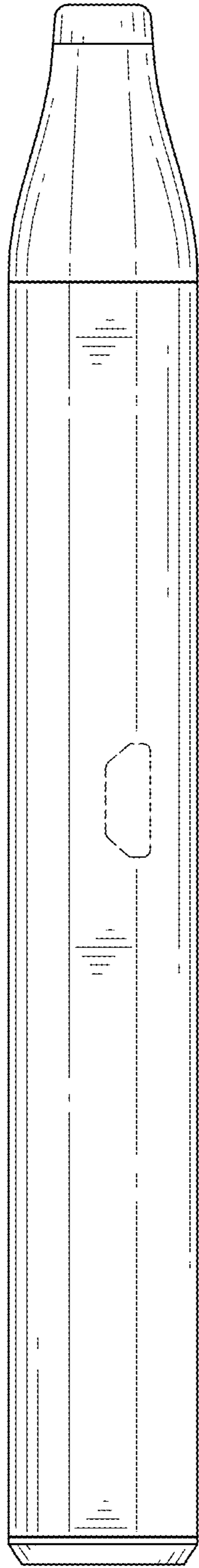

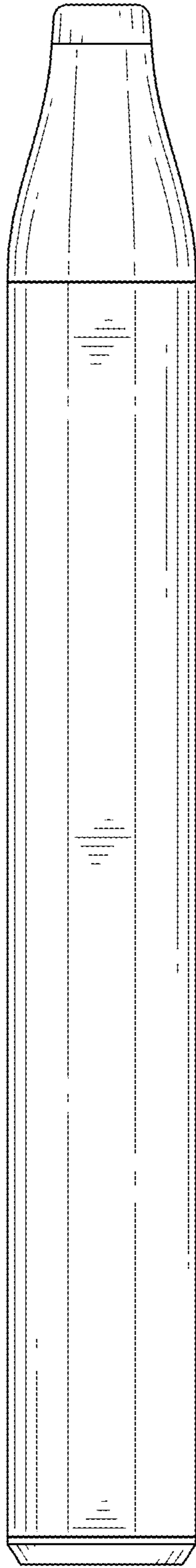

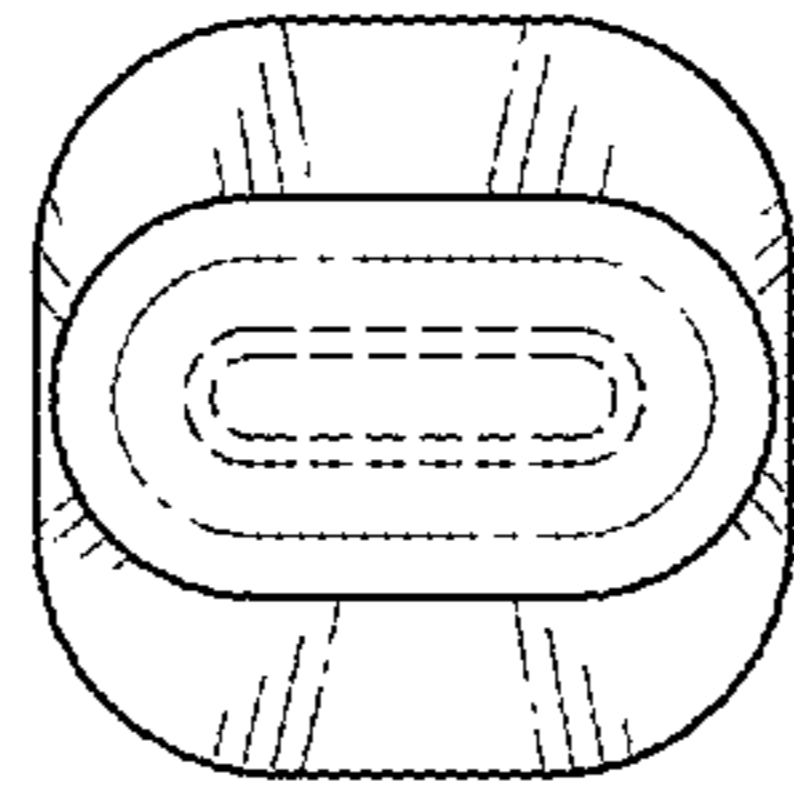

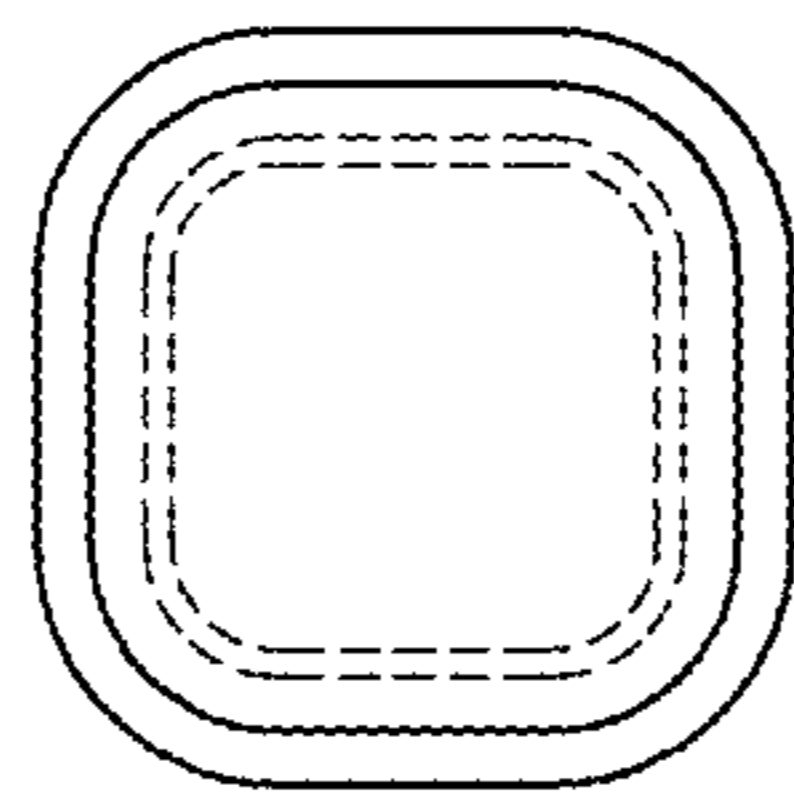
