FIG. 5 is a closed bottom view thereof;

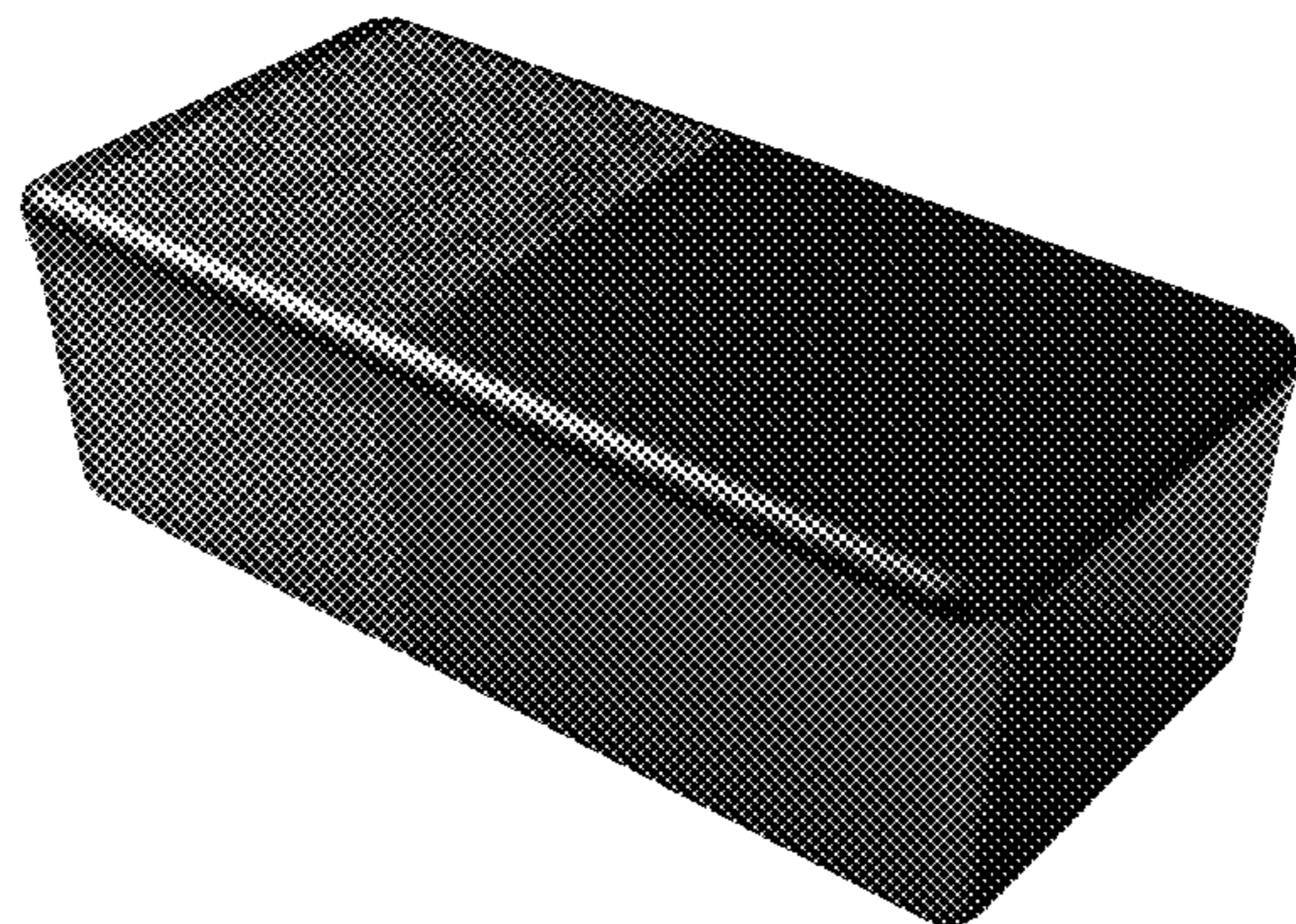
FIG. 6 is a top expanded open view thereof;

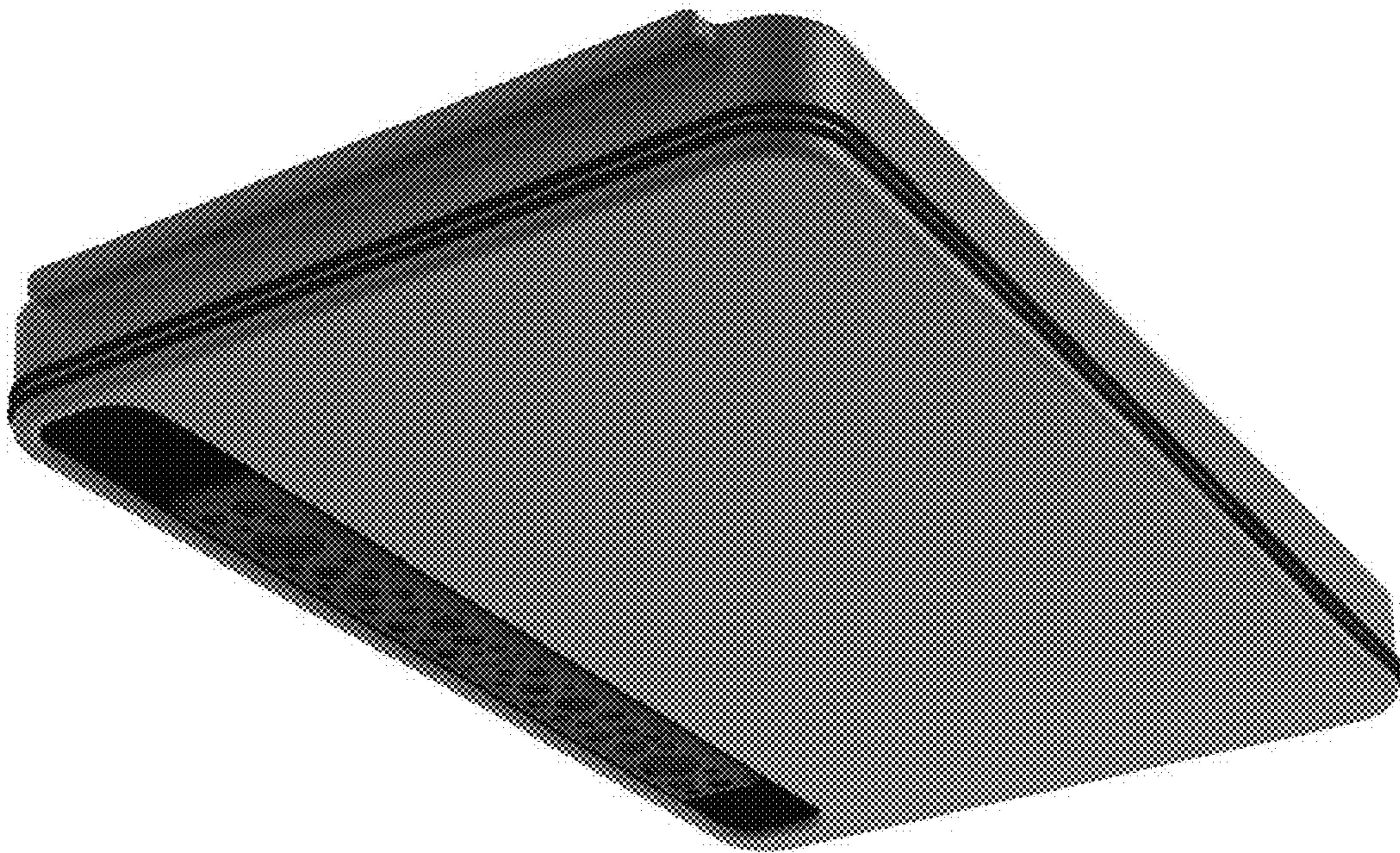

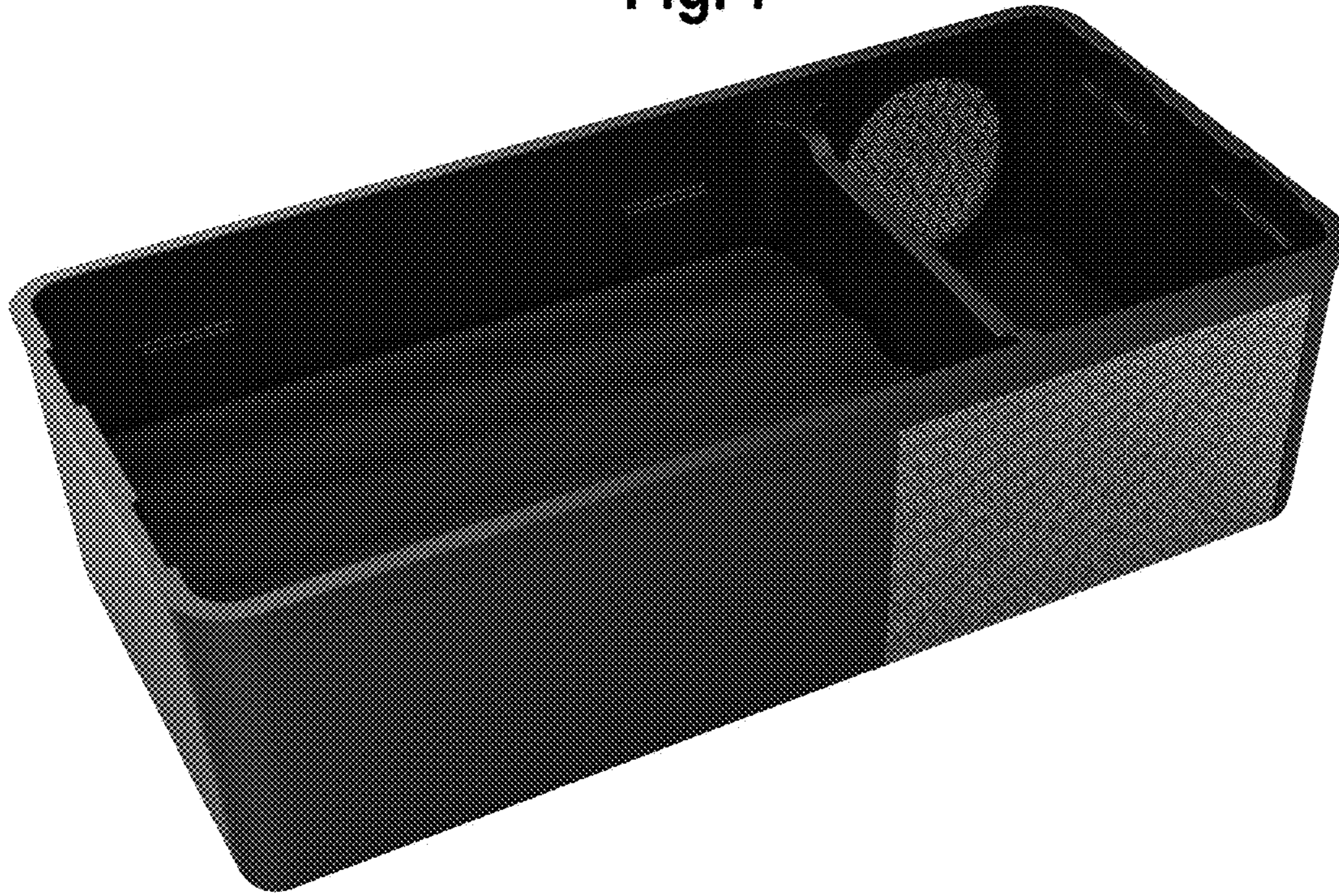

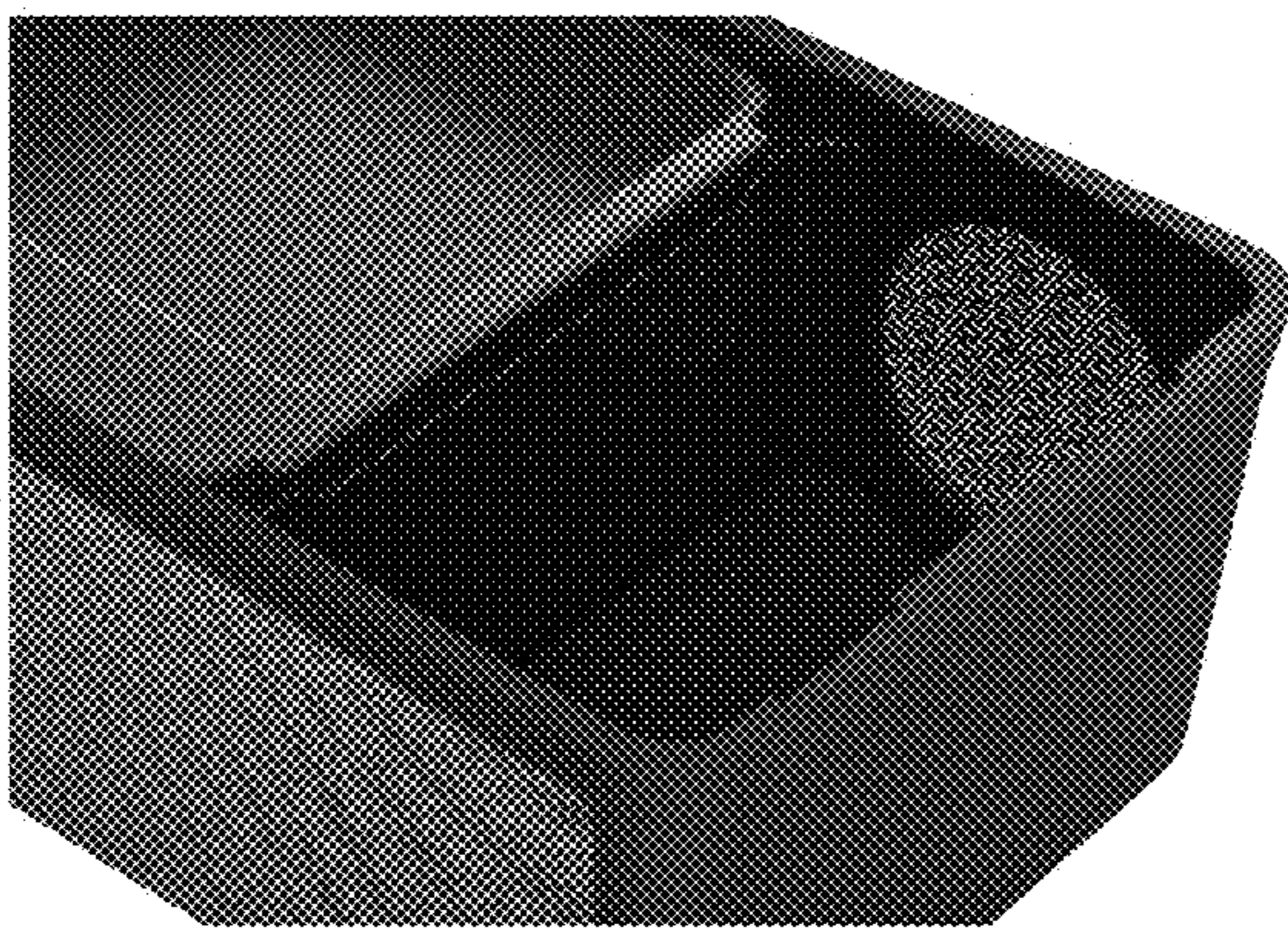
