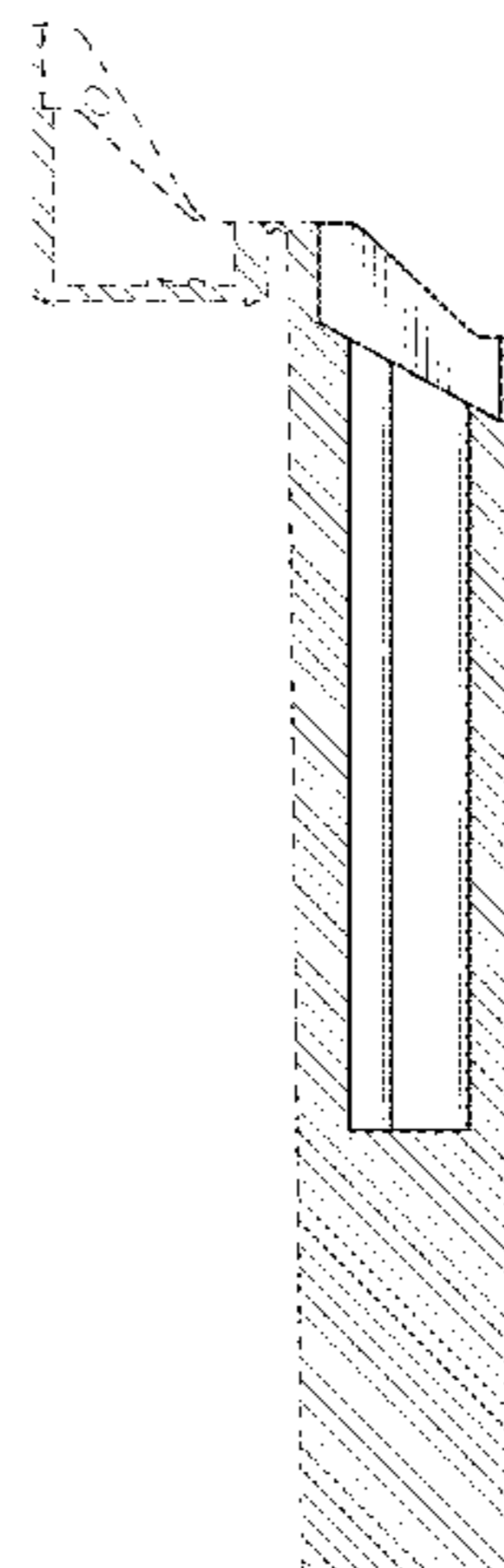
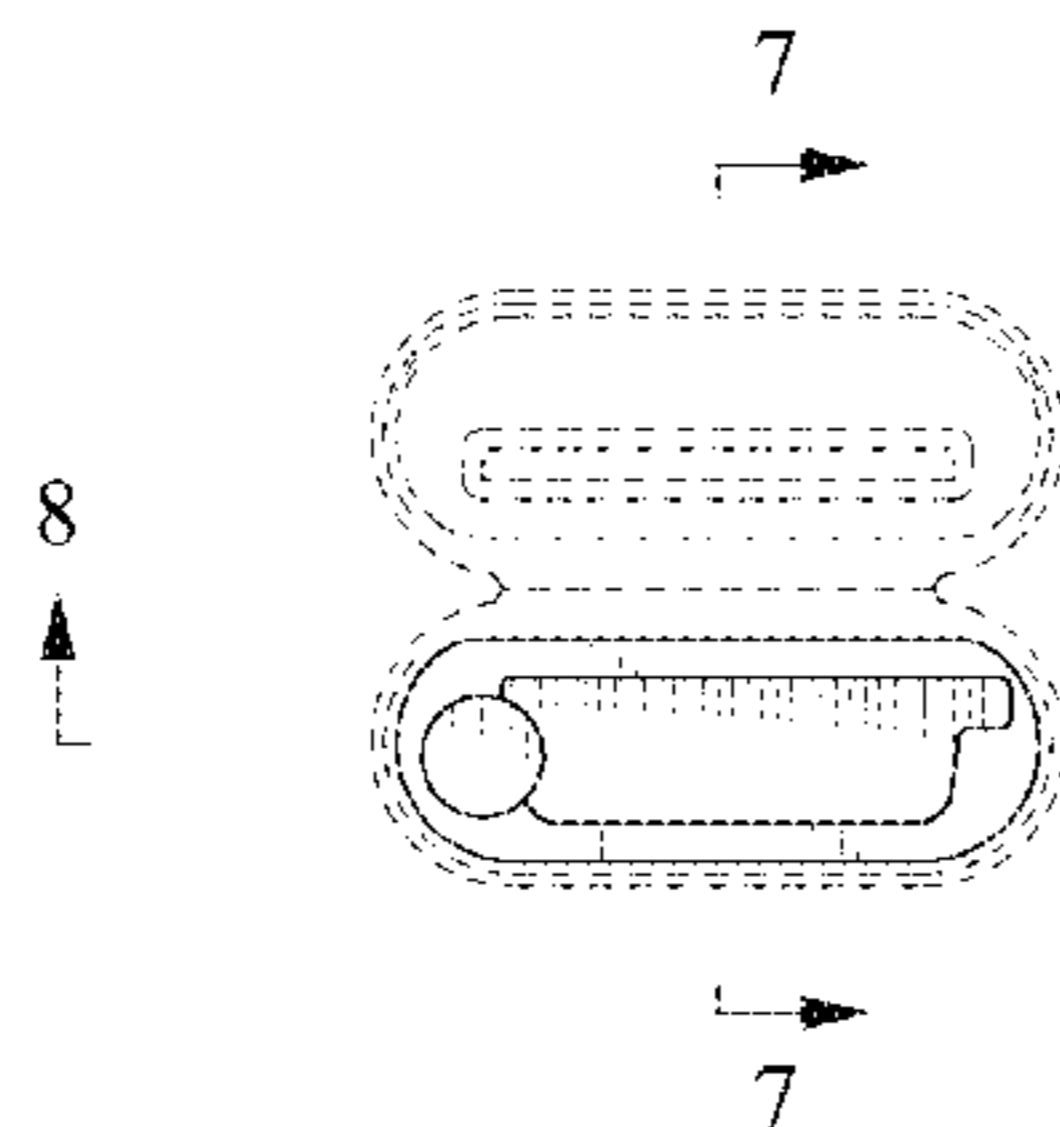
The ornamental design for a packaging container, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of a packaging container. FIG. 2 is a rear elevation view thereof. FIG. 3 is a left side elevation view thereof. FIG. 4 is a right side elevation view thereof. FIG. 5 is a top plan view thereof. FIG. 6 is a bottom plan view thereof. FIG. 7 is a cross-sectional view taken along the line 7-7 in FIG. 5 thereof. FIG. 8 is a cross-sectional view taken along the line 8-8 in FIG. 5 thereof. FIG. 9 is a perspective view with the lid closed. FIG. 10 is a front elevation view with the lid closed. FIG. 11 is a rear elevation view with the lid closed. FIG. 12 is a left elevation view with the lid closed. FIG. 13 is a right elevation view with the lid closed. FIG. 14 is a top plan view with the lid closed. FIG. 15 is a bottom plan view with the lid closed. FIG. 16 is a cross-sectional view taken along the line 16-16 in FIG. 14 thereof; and, FIG. 17 a cross-sectional view of the packaging container of FIG. 8 in an environment of use.

The broken lines shown in the drawings illustrate portions of the packaging container that form no part of claimed design.

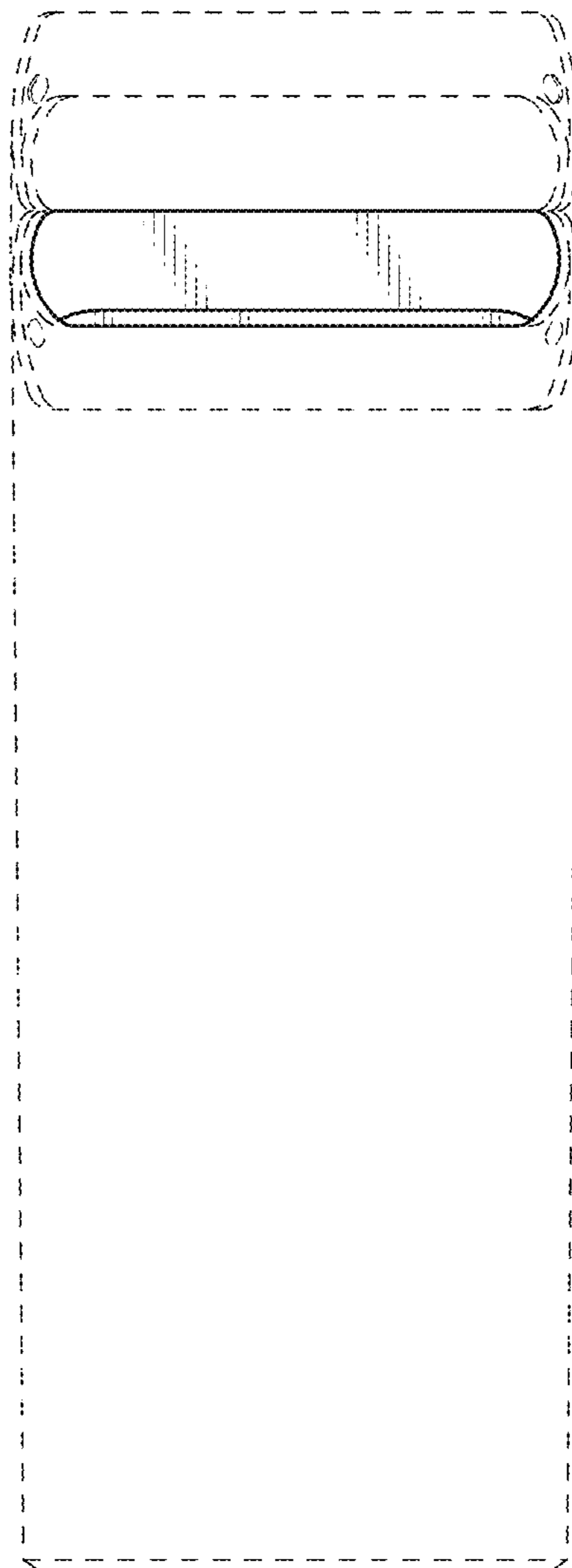

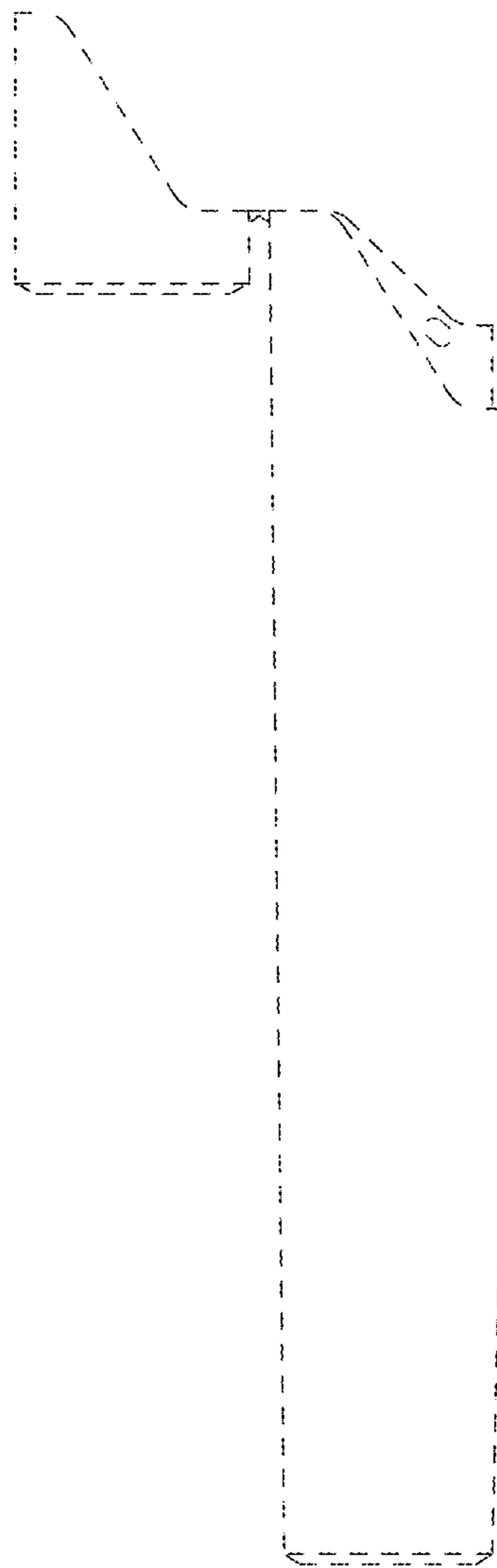

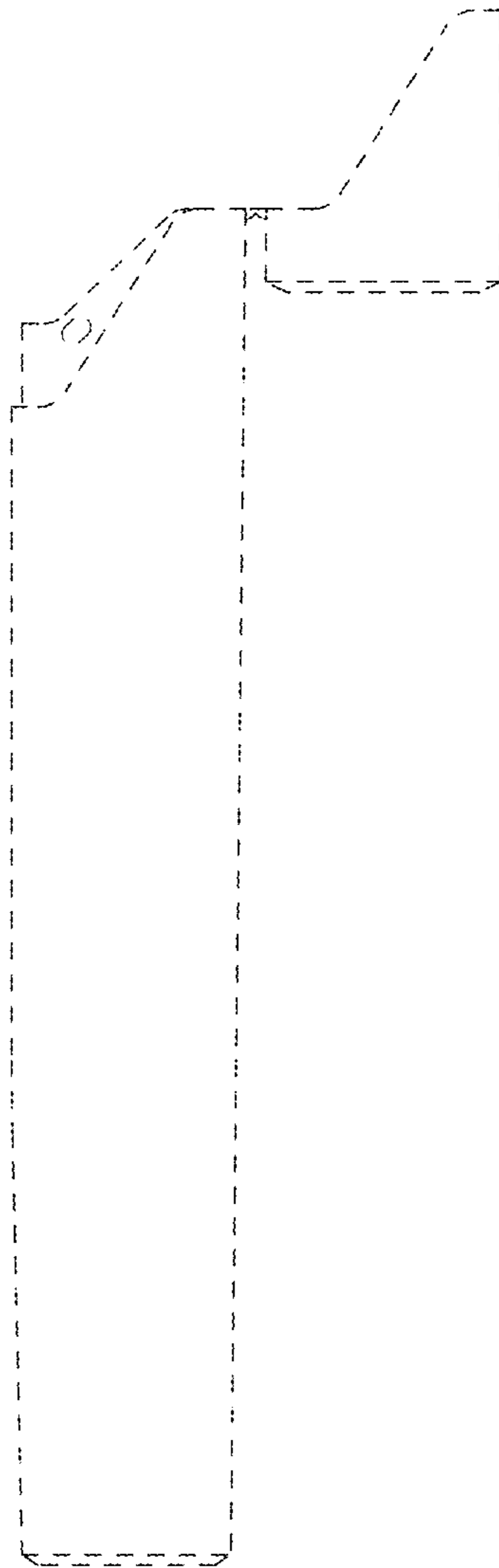

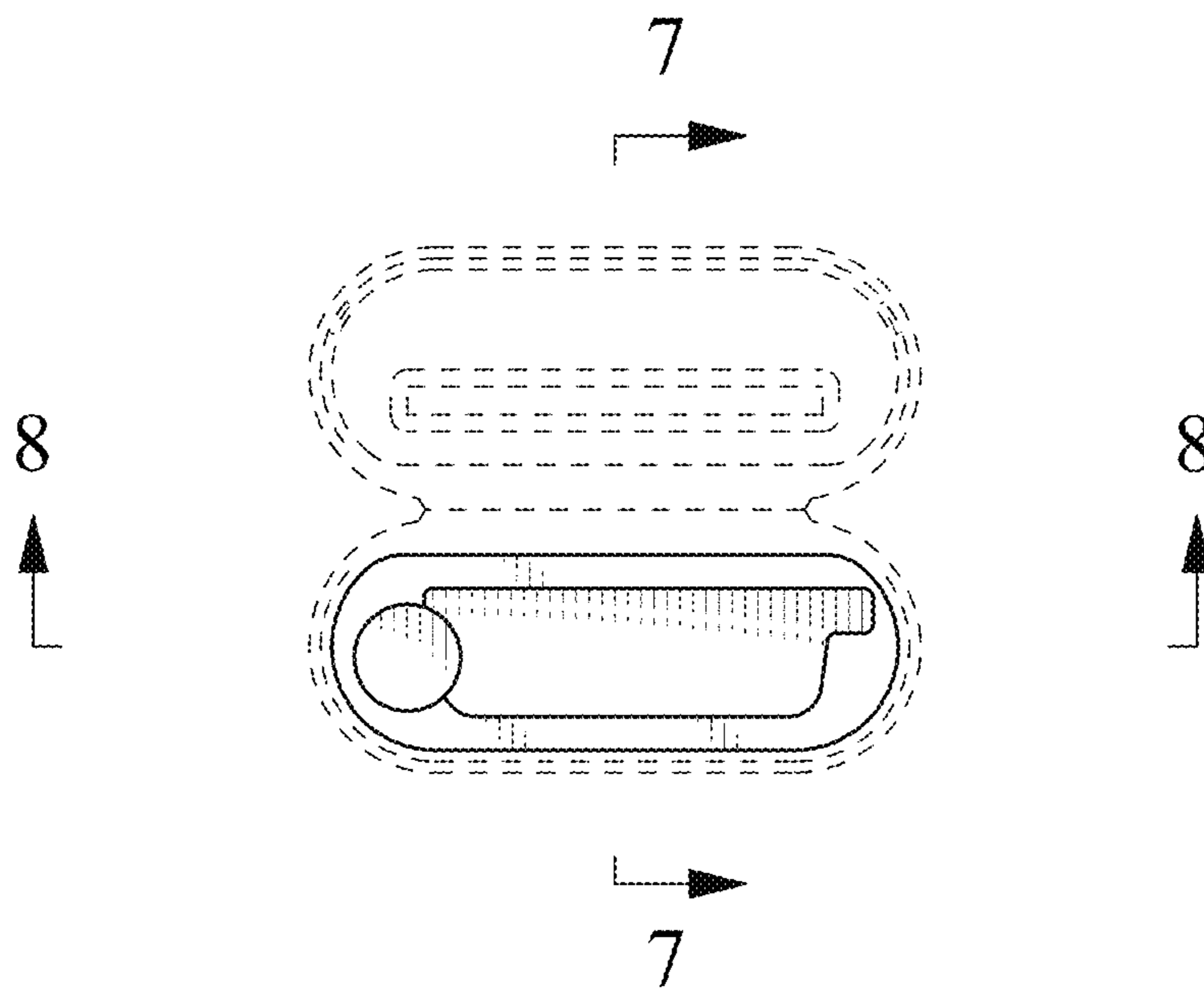

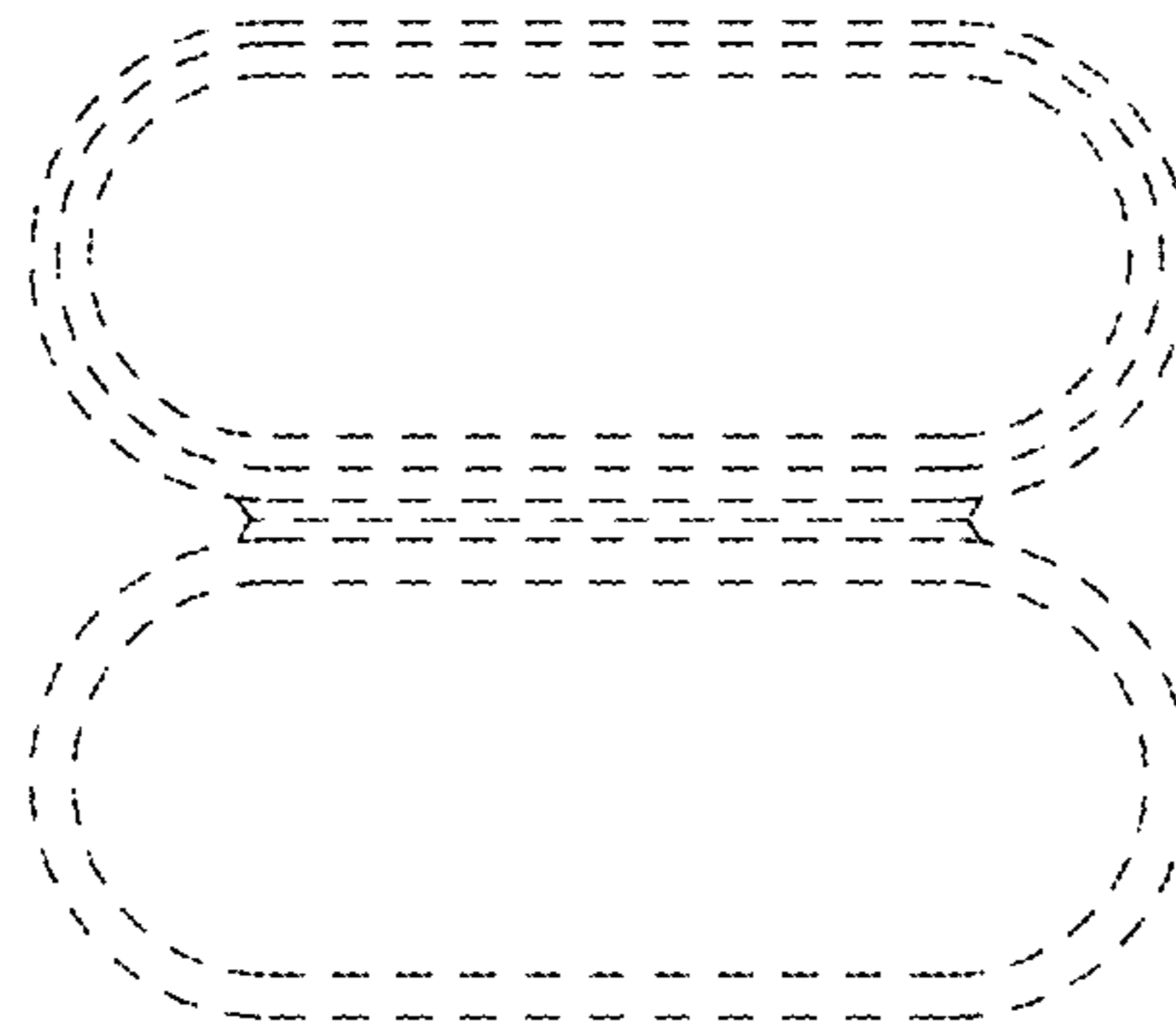

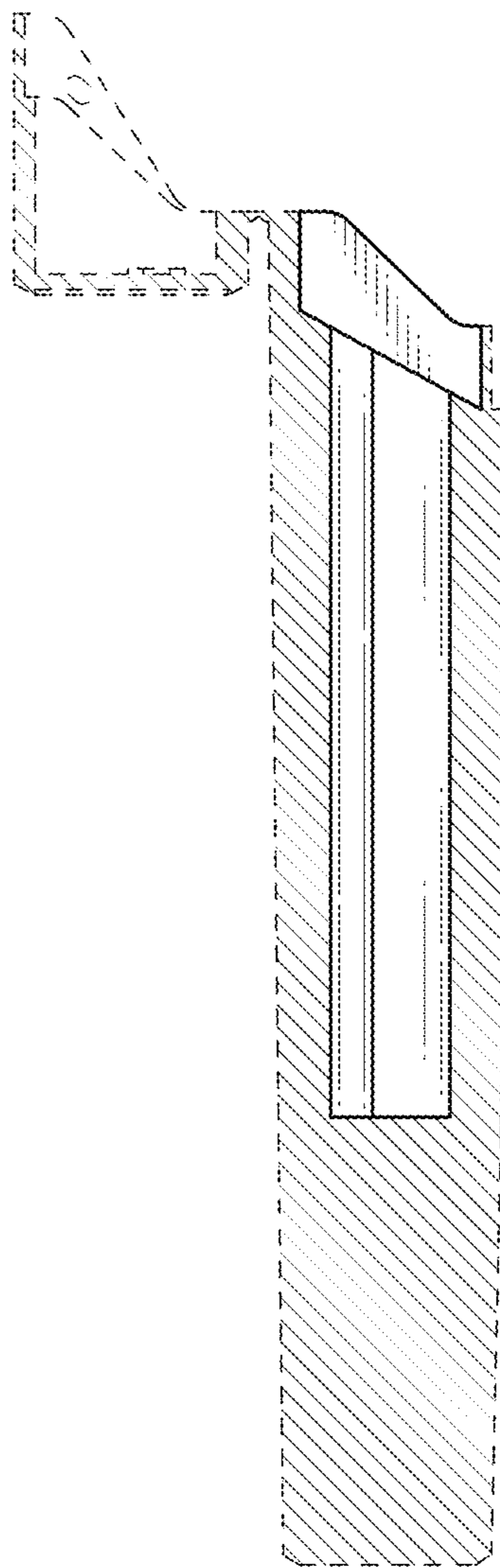

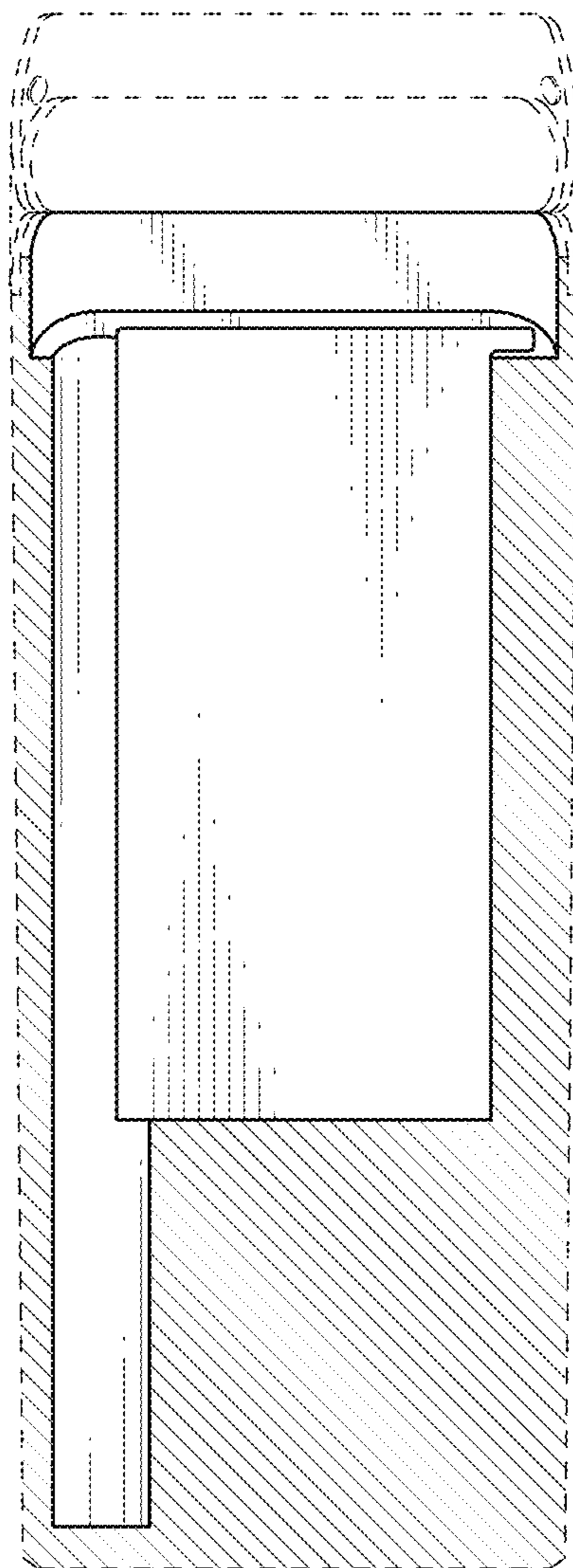

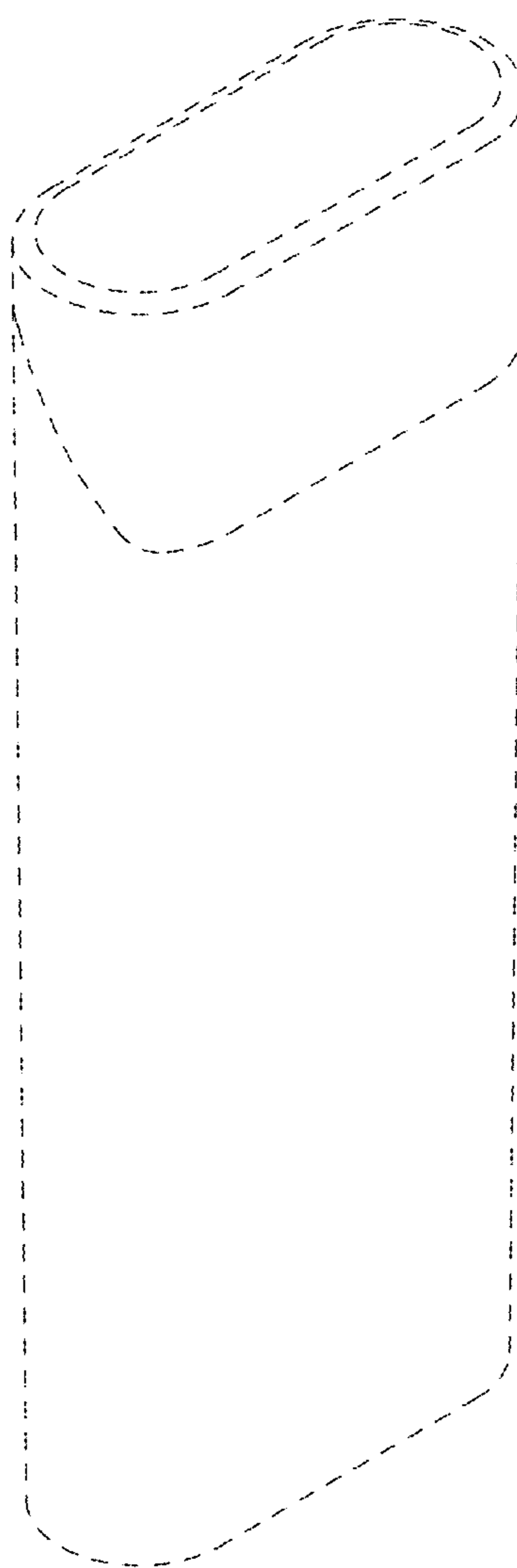

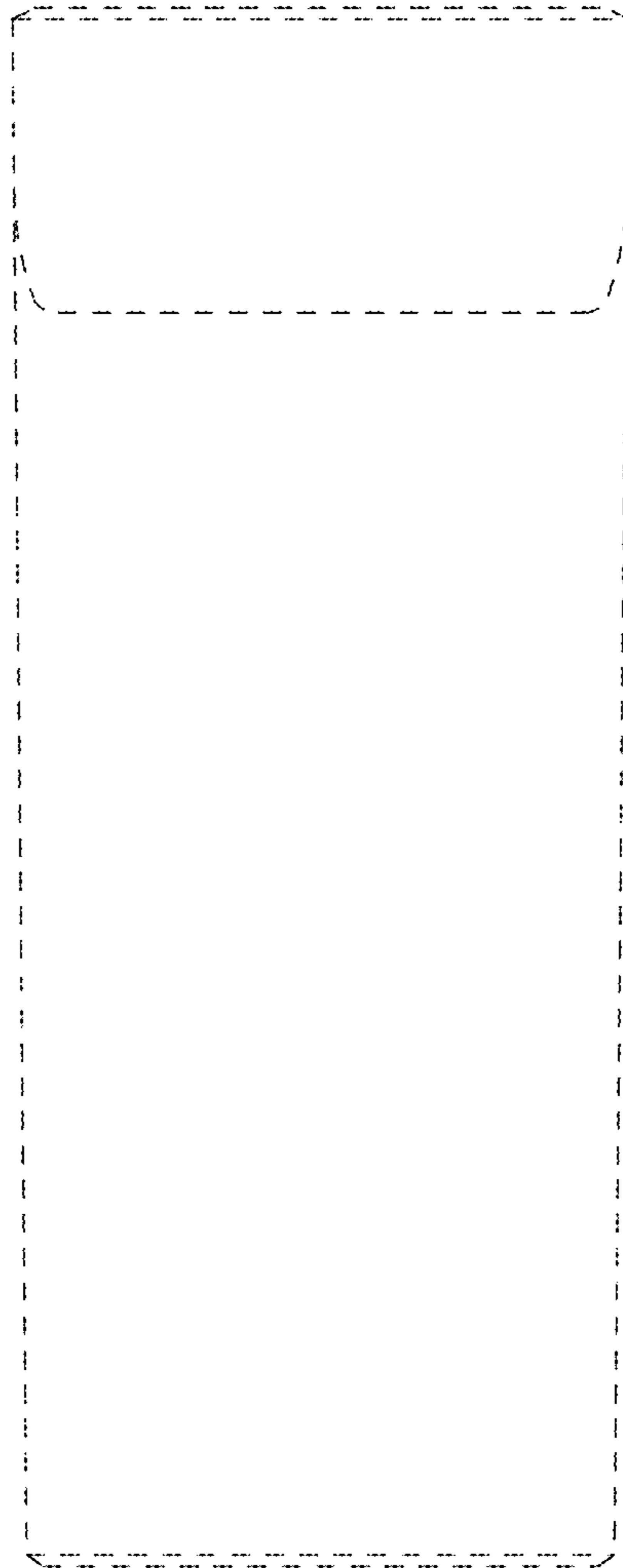

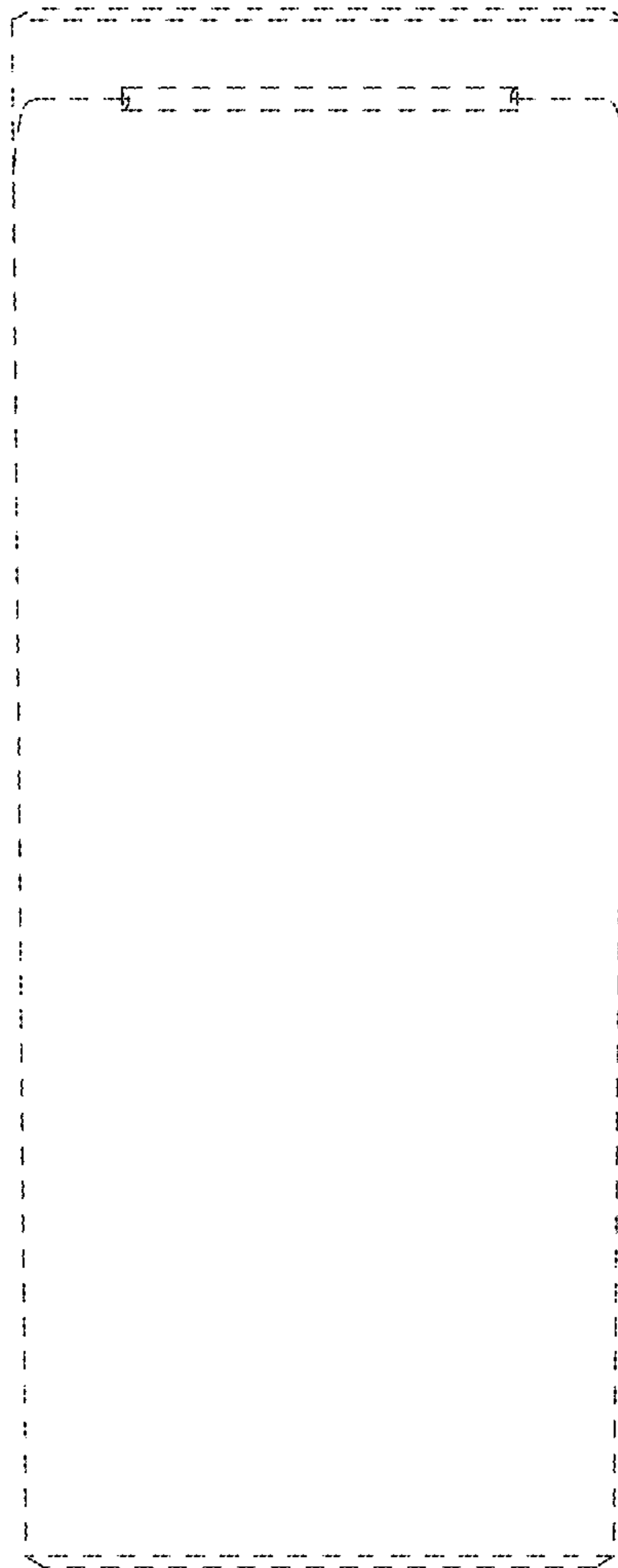

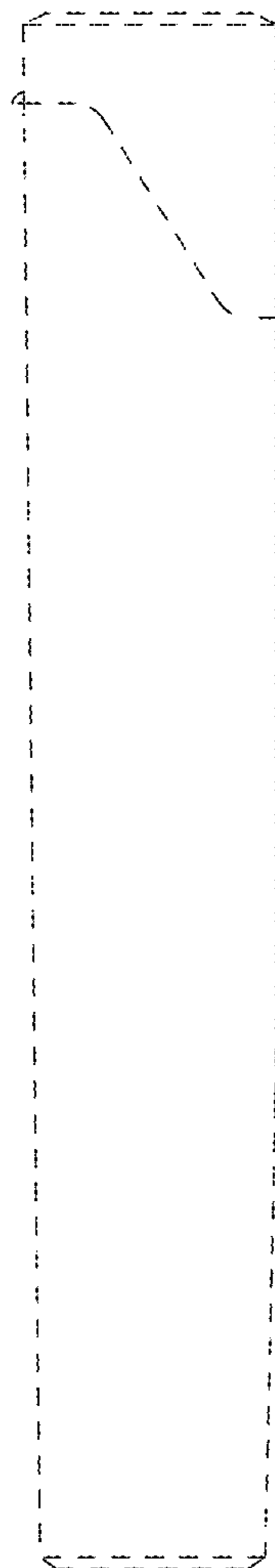

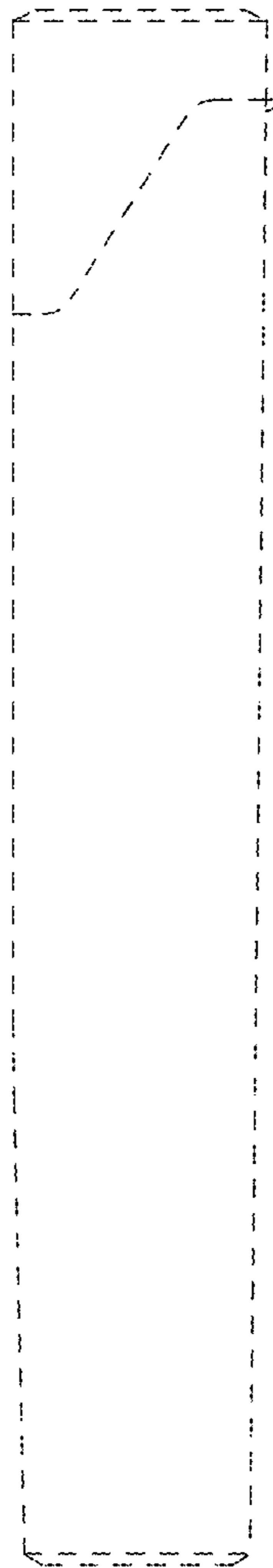

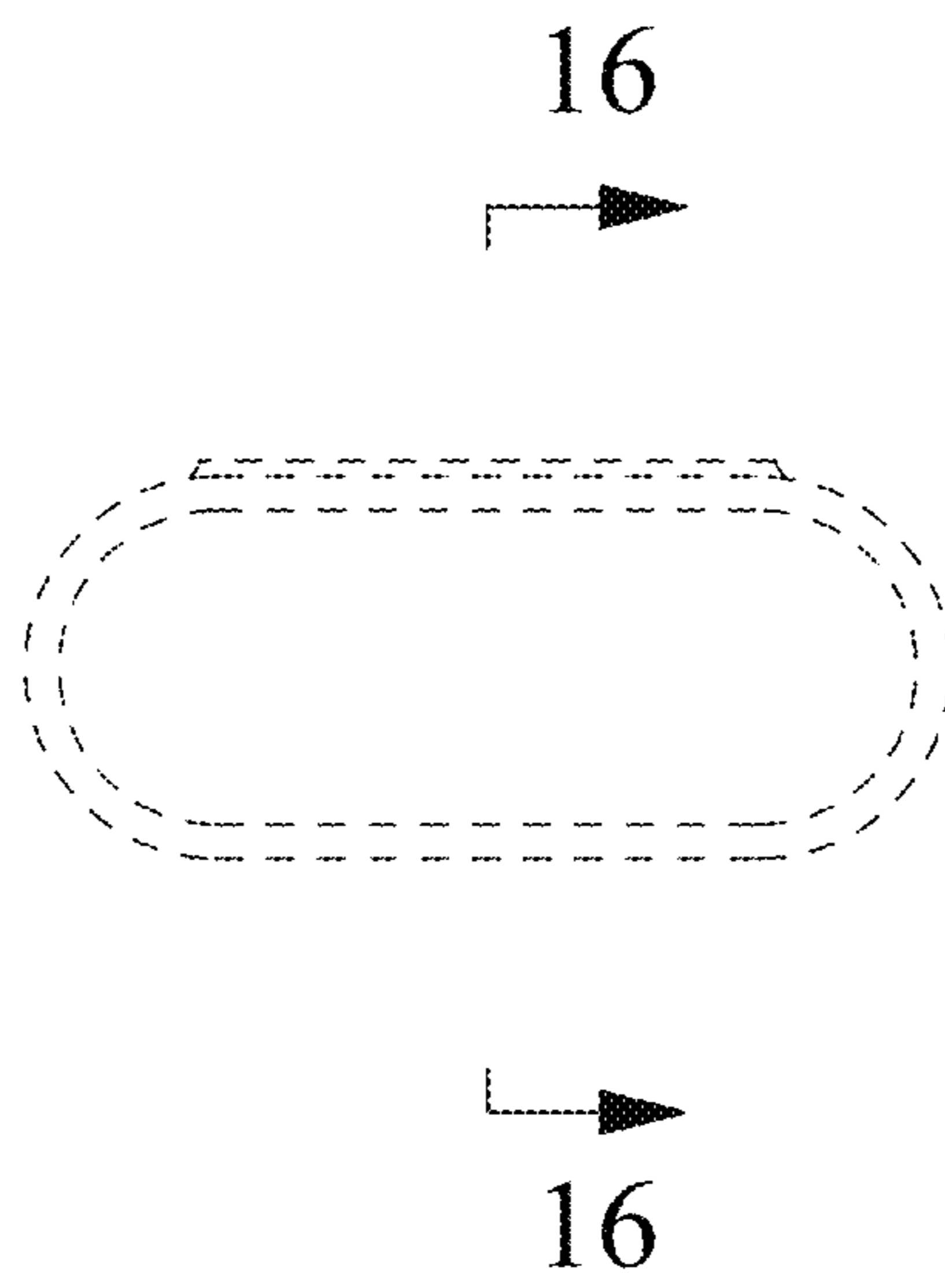

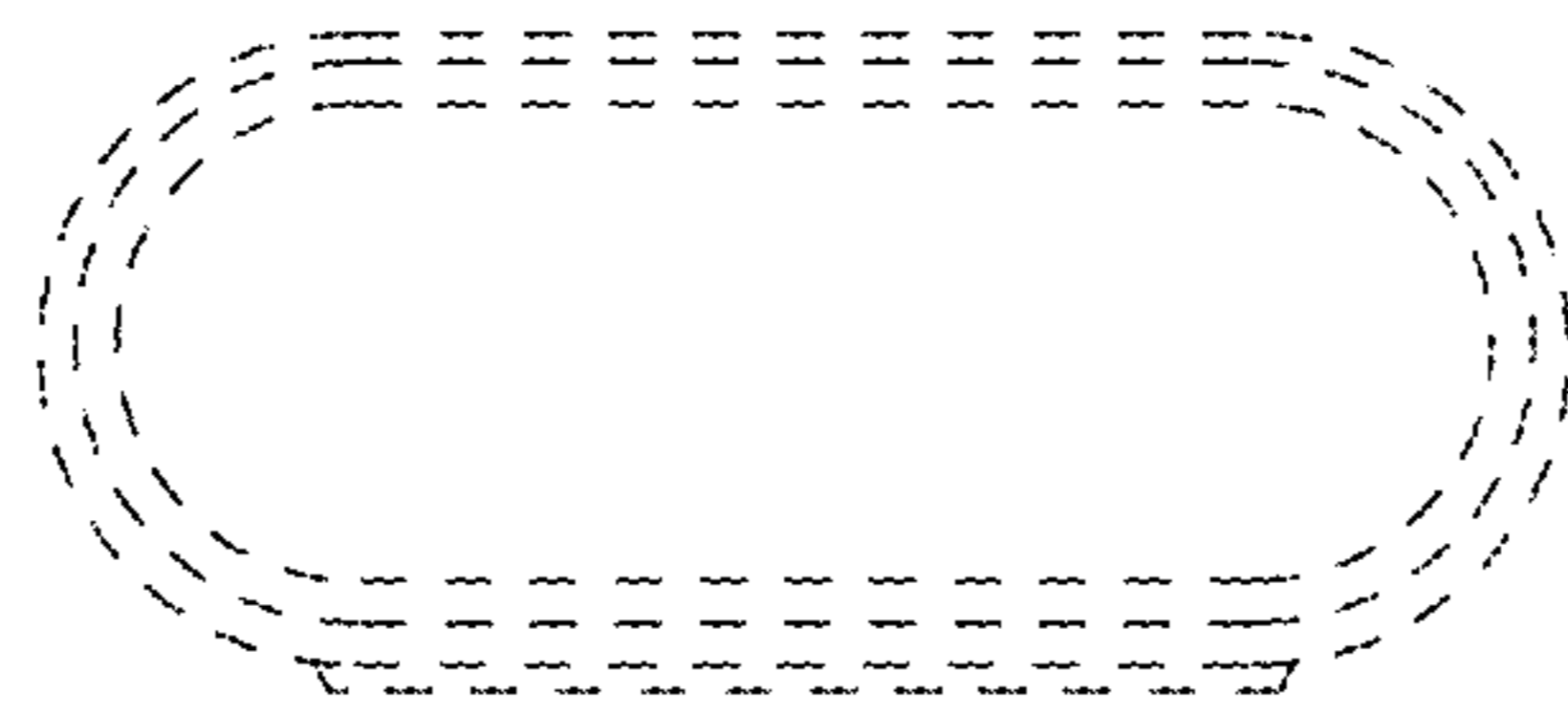

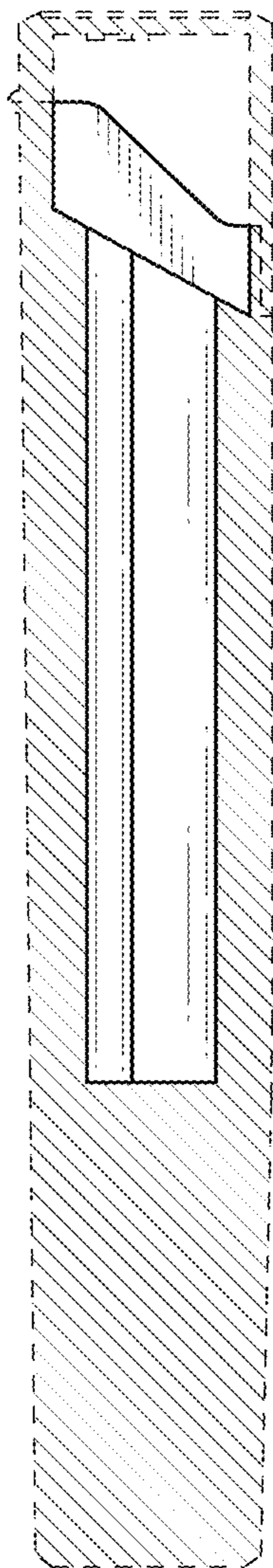
