(57) **CLAIM**

We claim the ornamental design for a cosmetic applicator, substantially as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of cosmetic applicator showing the new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a back elevational view thereof;
FIG. 4 is a right side elevational view thereof;
FIG. 5 is a left side elevational view thereof;
FIG. 6 is a bottom view thereof; and,
FIG. 7 is a top view thereof.
The broken lines depict portions of the cosmetic applicator that form no part of the claim.

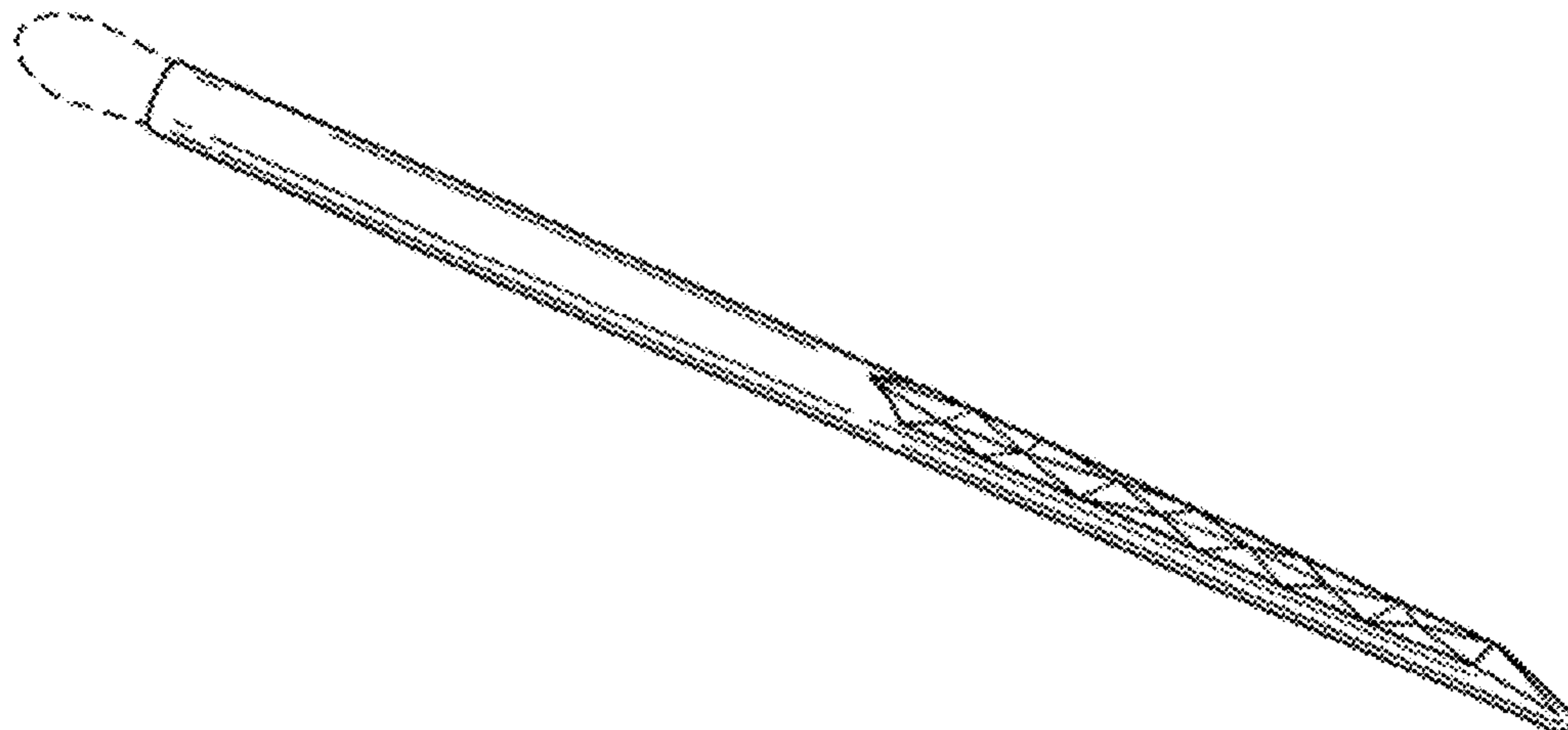

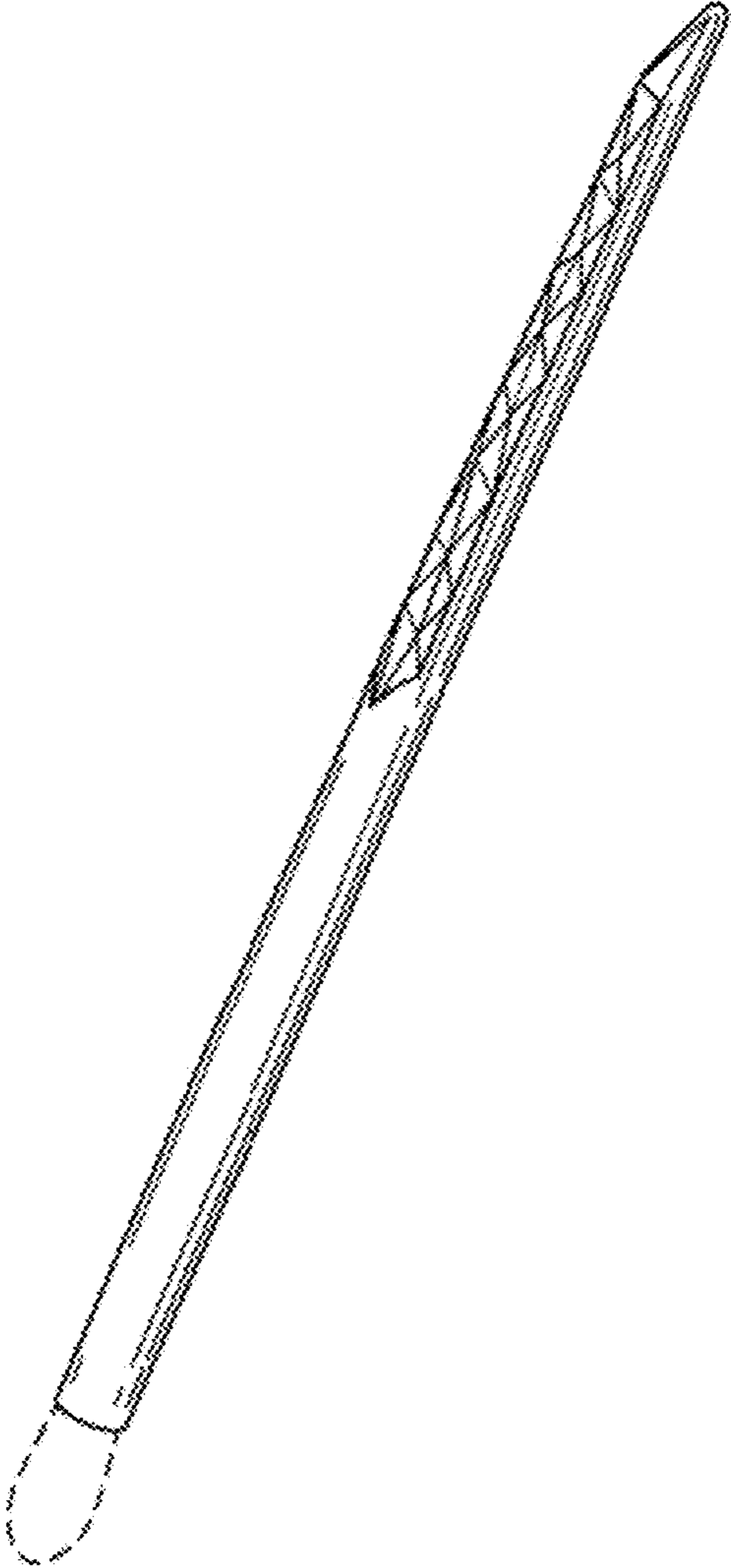

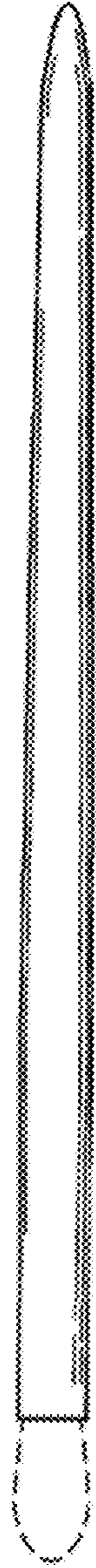

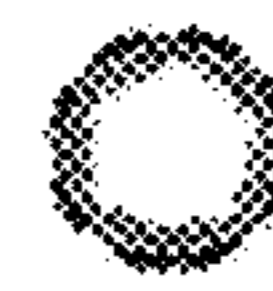
