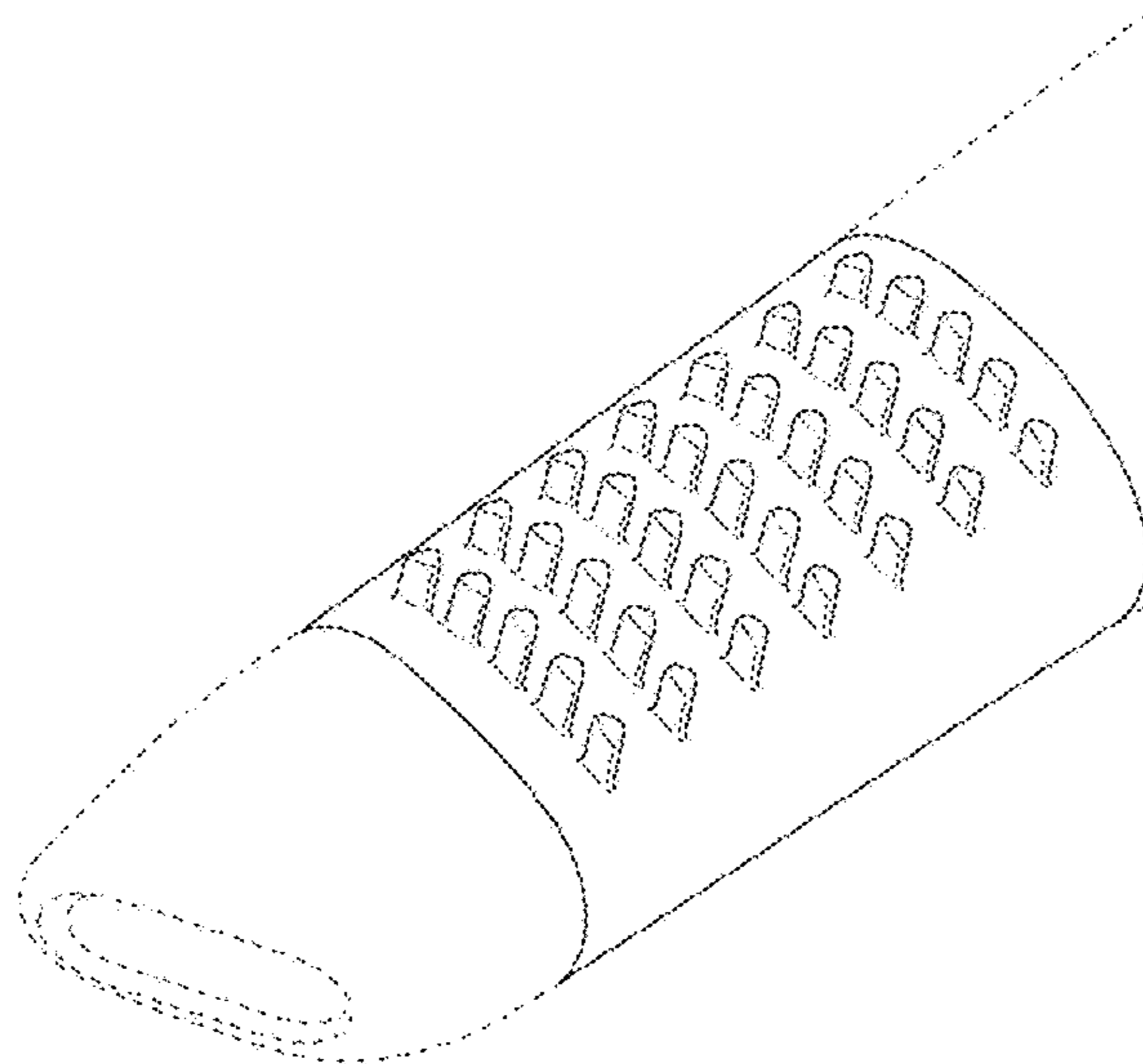

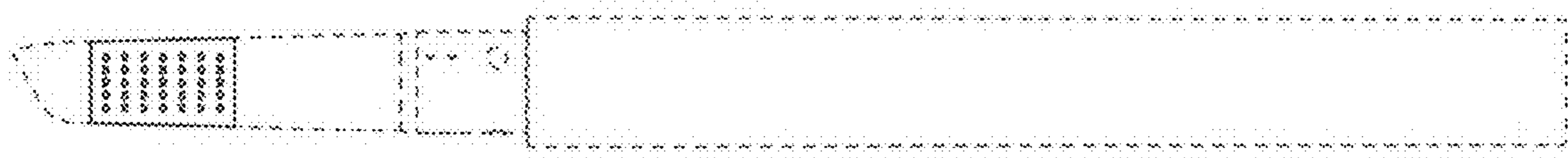

numbered 1.7.

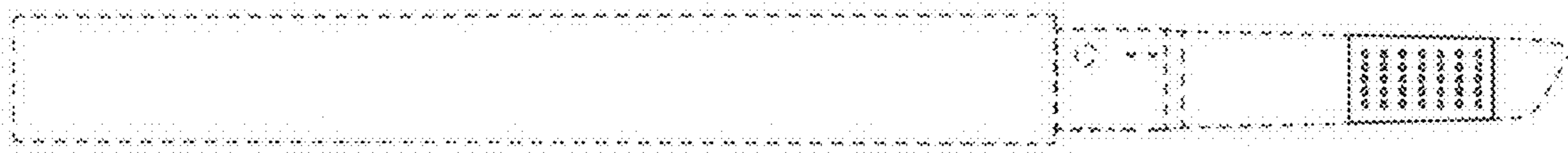

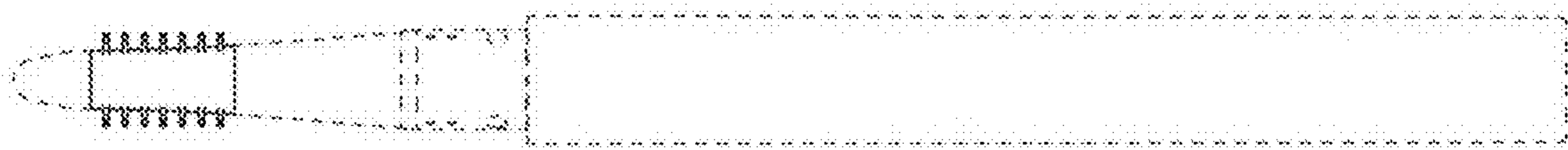

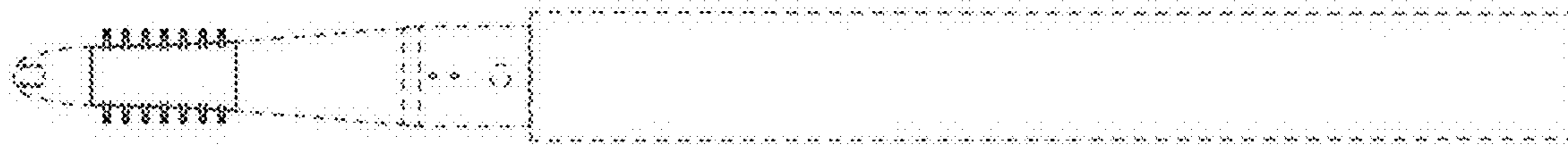

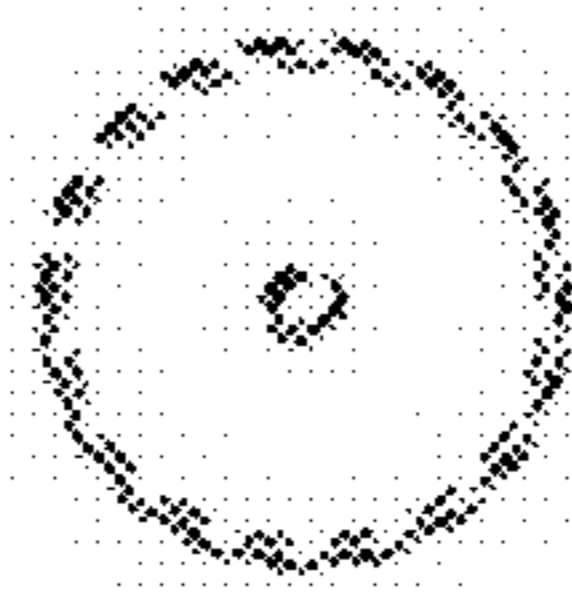

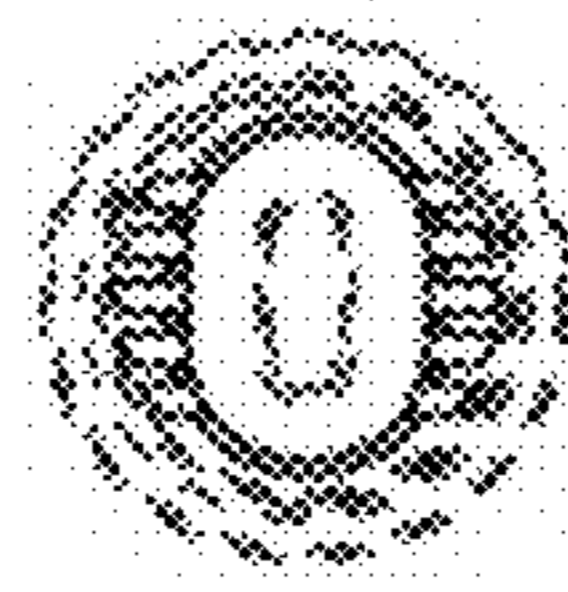

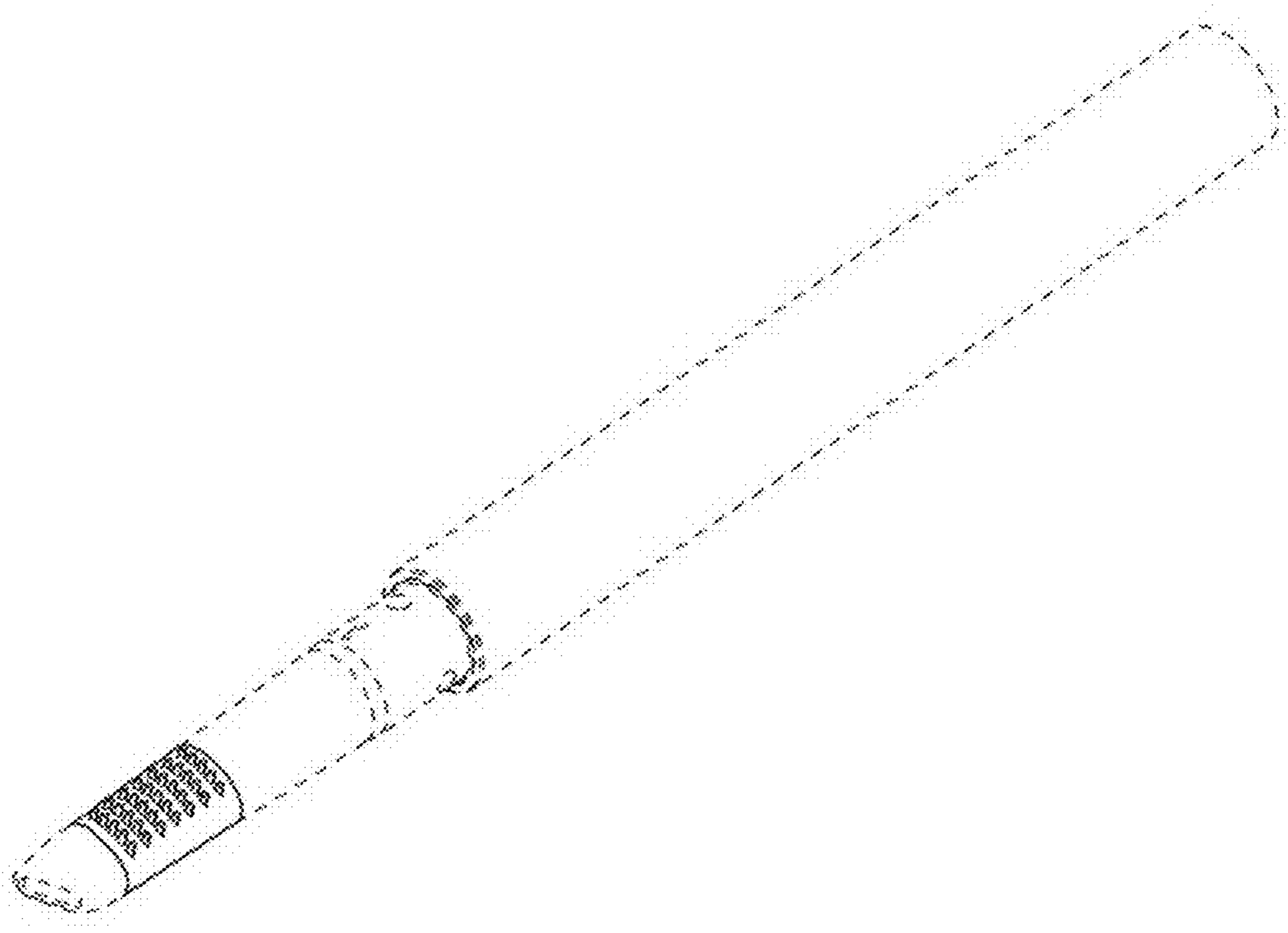

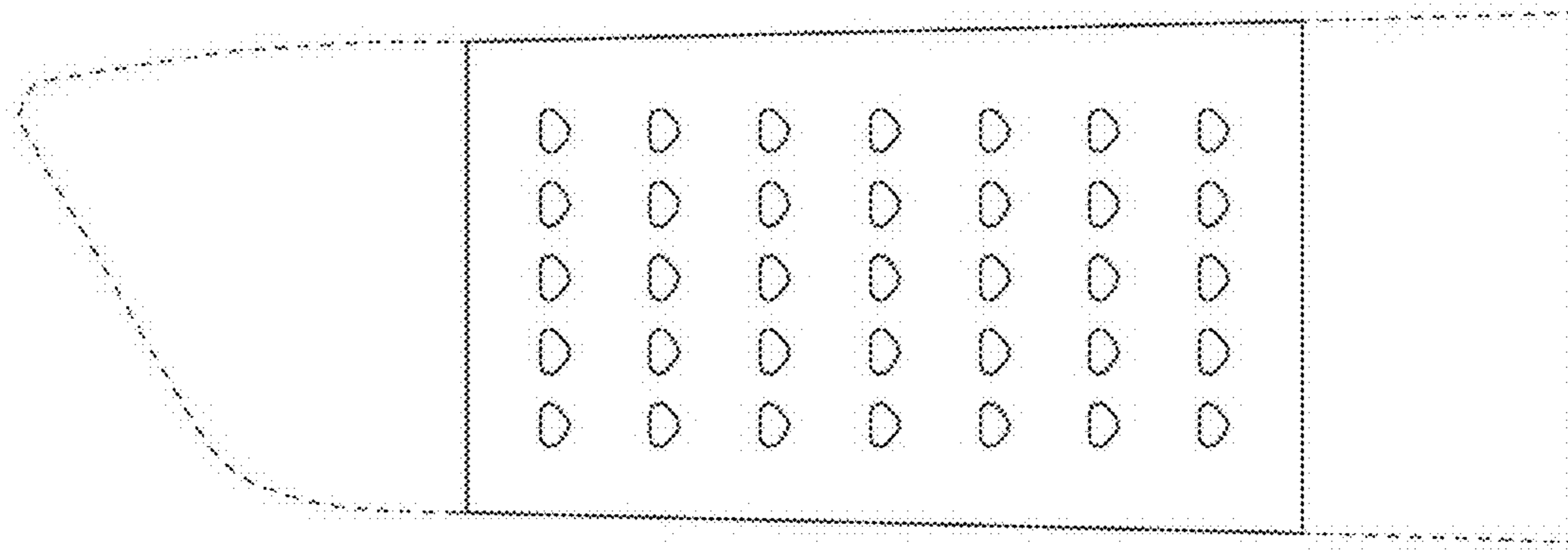

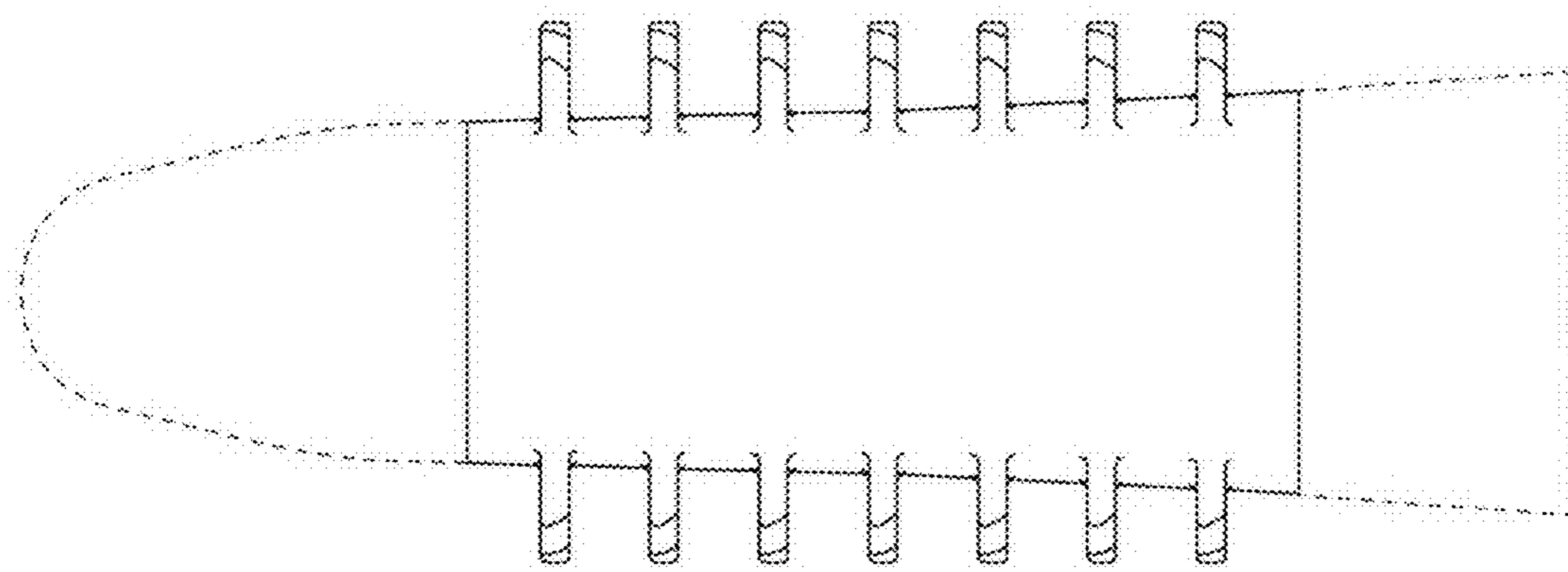

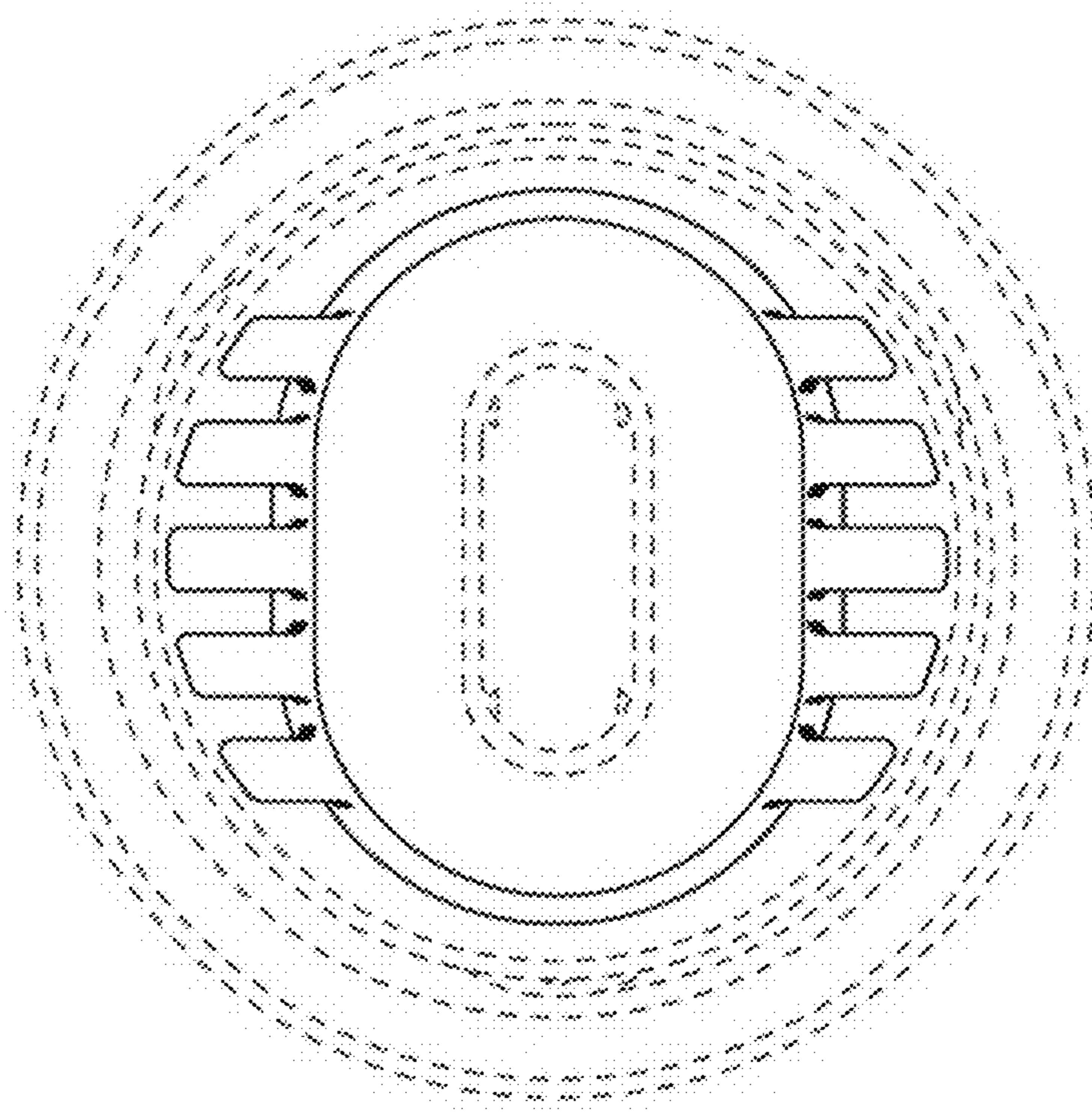
