(57) **CLAIM**

The ornamental design for a swimsuit top, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a swimsuit top showing the new design according to one embodiment of the present invention in folded form;

FIG. 2 is a front view of the swimsuit top of FIG. 1 in folded form;

FIG. 3 is a rear view of the swimsuit top of FIG. 1;

FIG. 4 is a first side view of the swimsuit top of FIG. 1;

FIG. 5 is a second, opposing side view of the swimsuit top of FIG. 1;

FIG. 6 is a top view of the swimsuit top of FIG. 1;

FIG. 7 is a bottom view swimsuit top of FIG. 1;

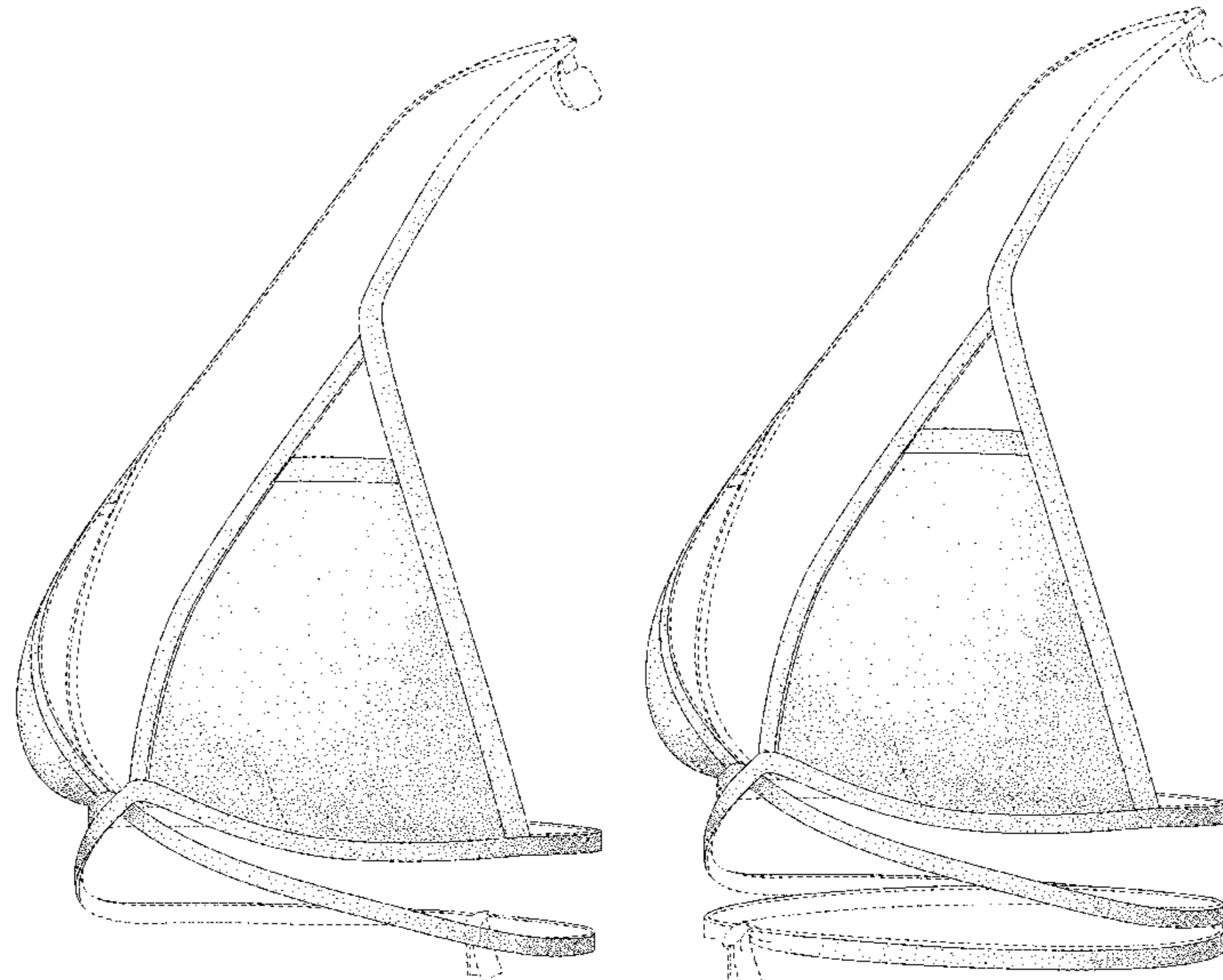
FIG. 8 is a perspective view of the swimsuit top of FIG. 1 illustrating an alternative configuration; and,

FIG. 9 is a front plan view of the swimsuit of top of FIG. 1 in unwrapped form.

The surface stiplings of FIGS. 1-9 are provided to show the surface contours of the swimsuit top.

The broken lines shown on the swimsuit top are unclaimed features of the article.

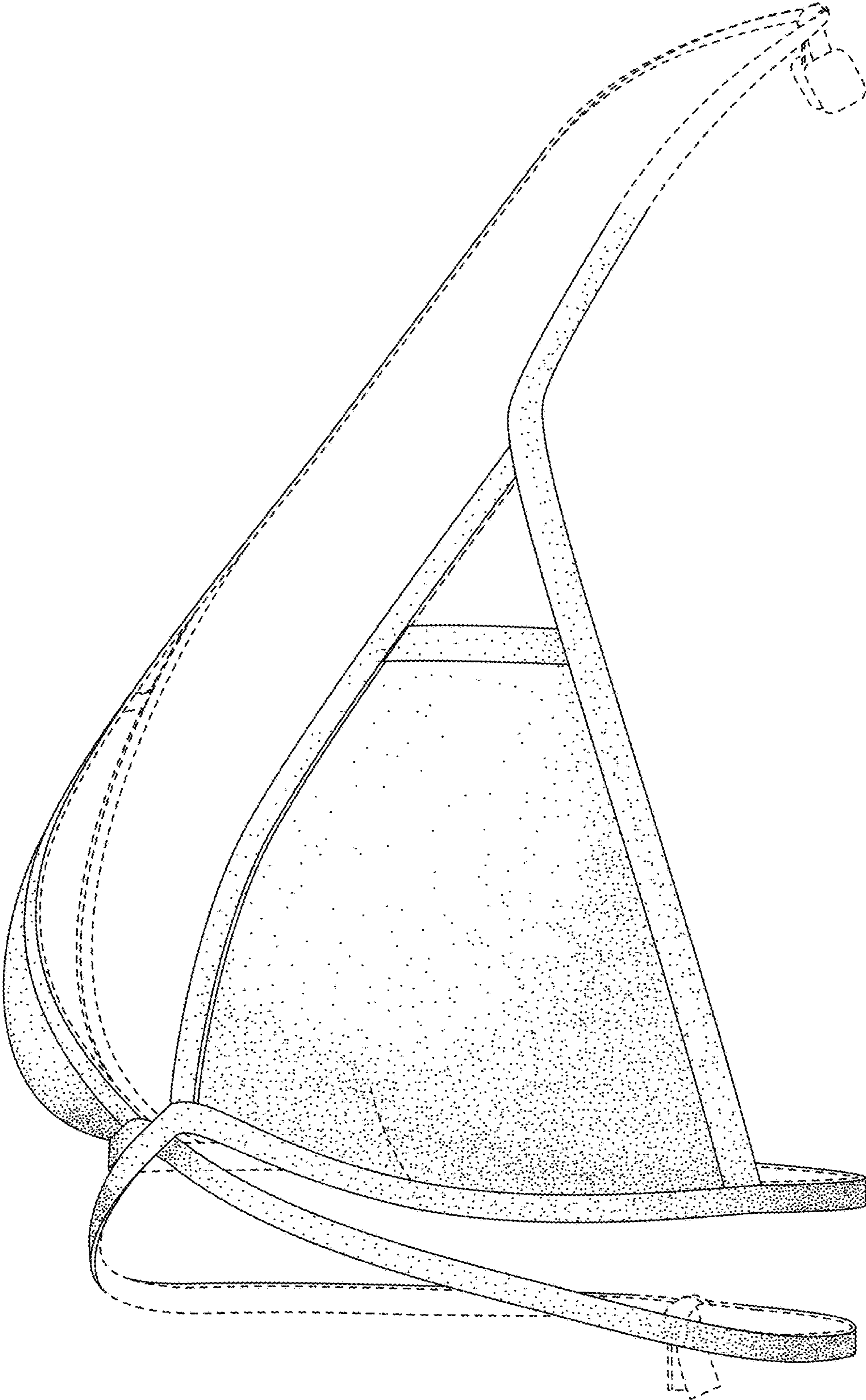

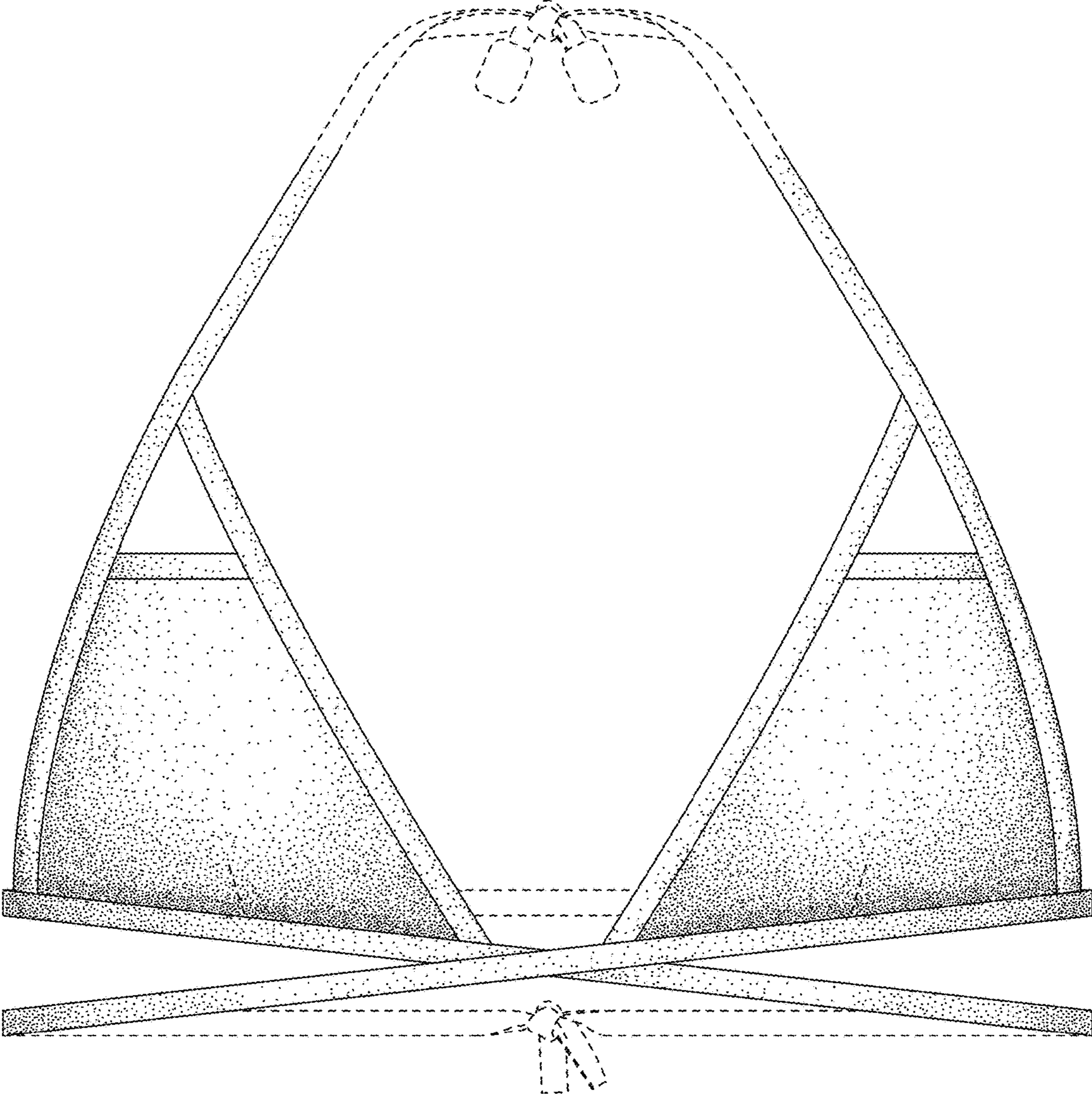

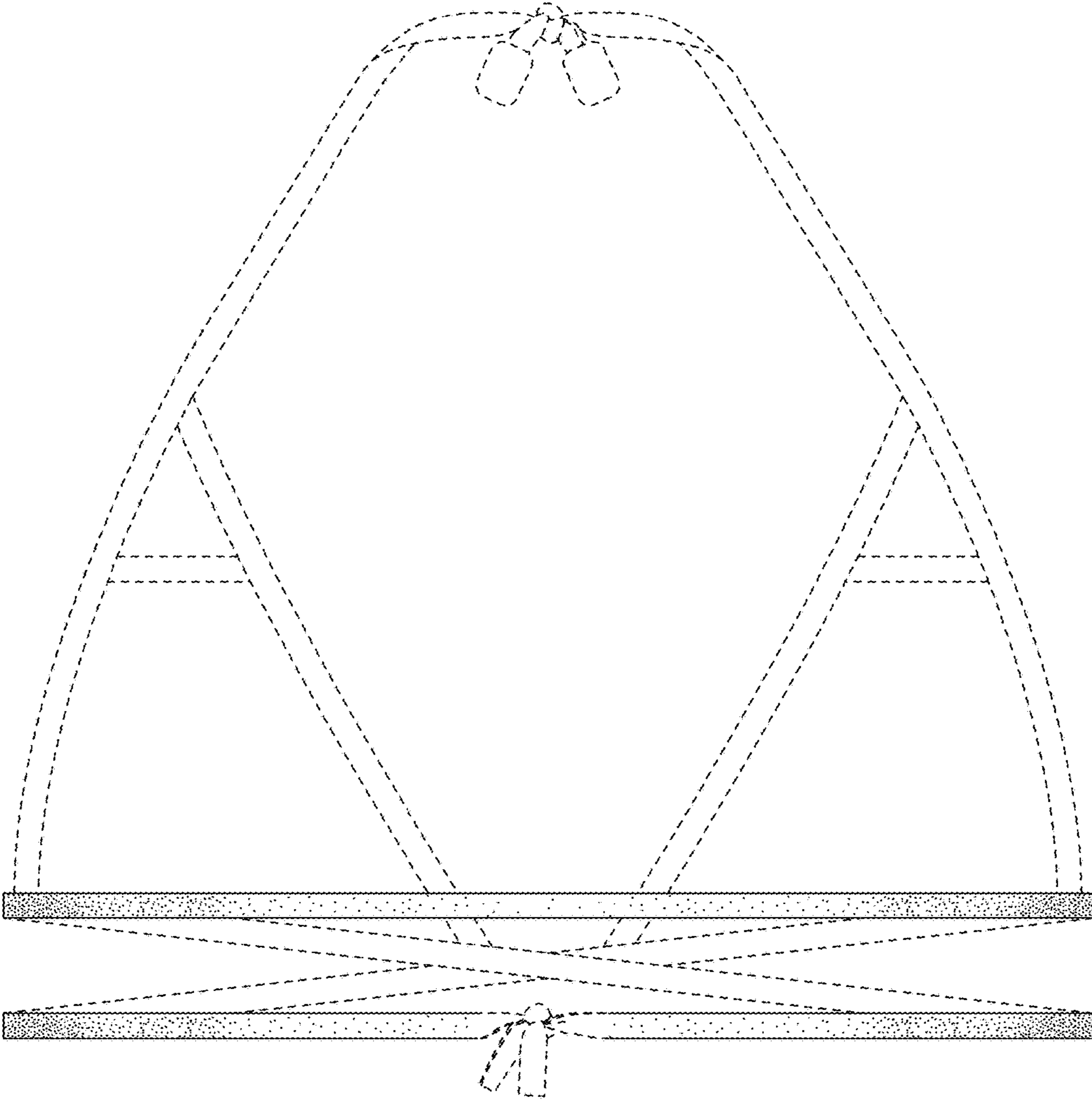

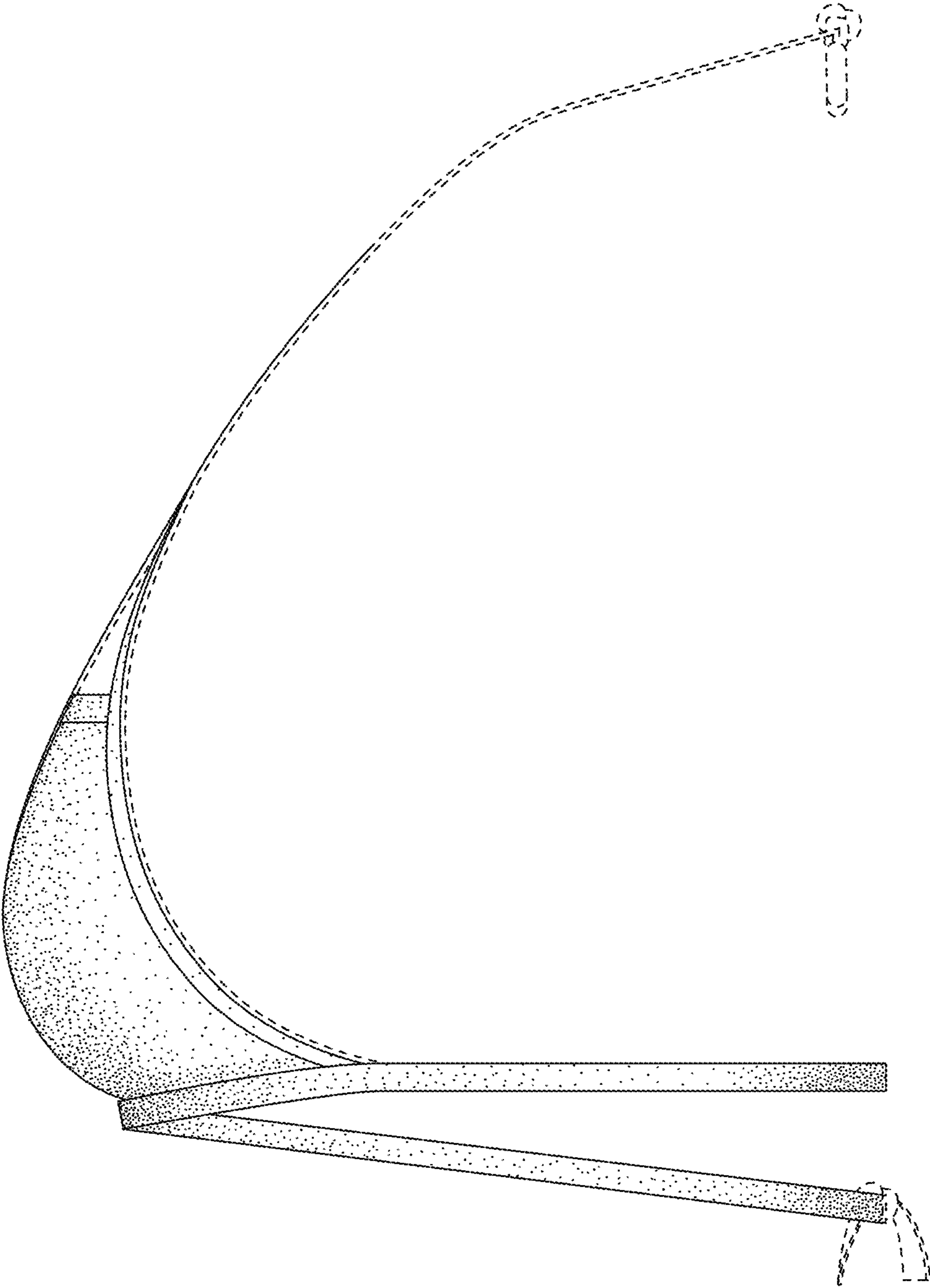

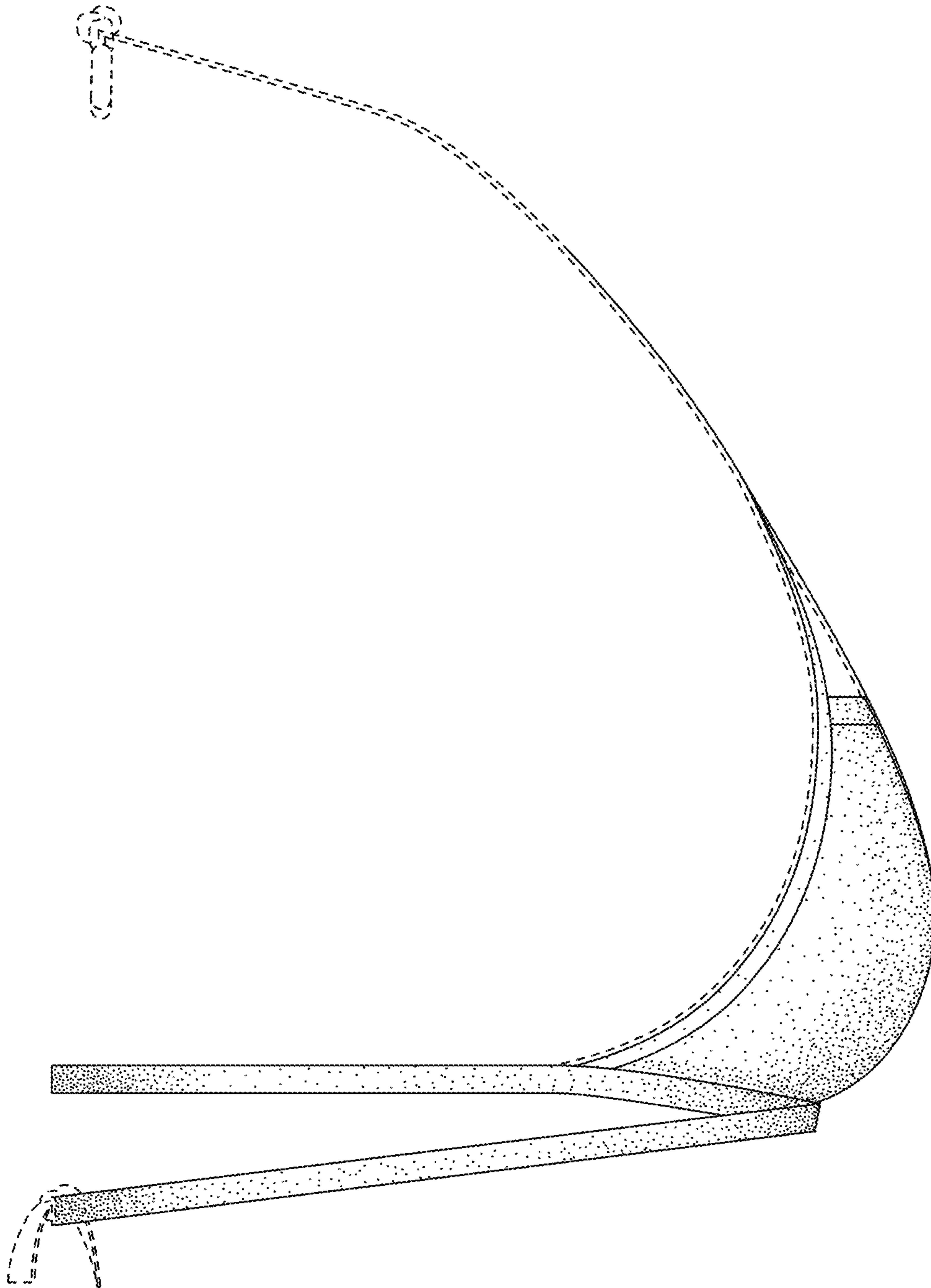

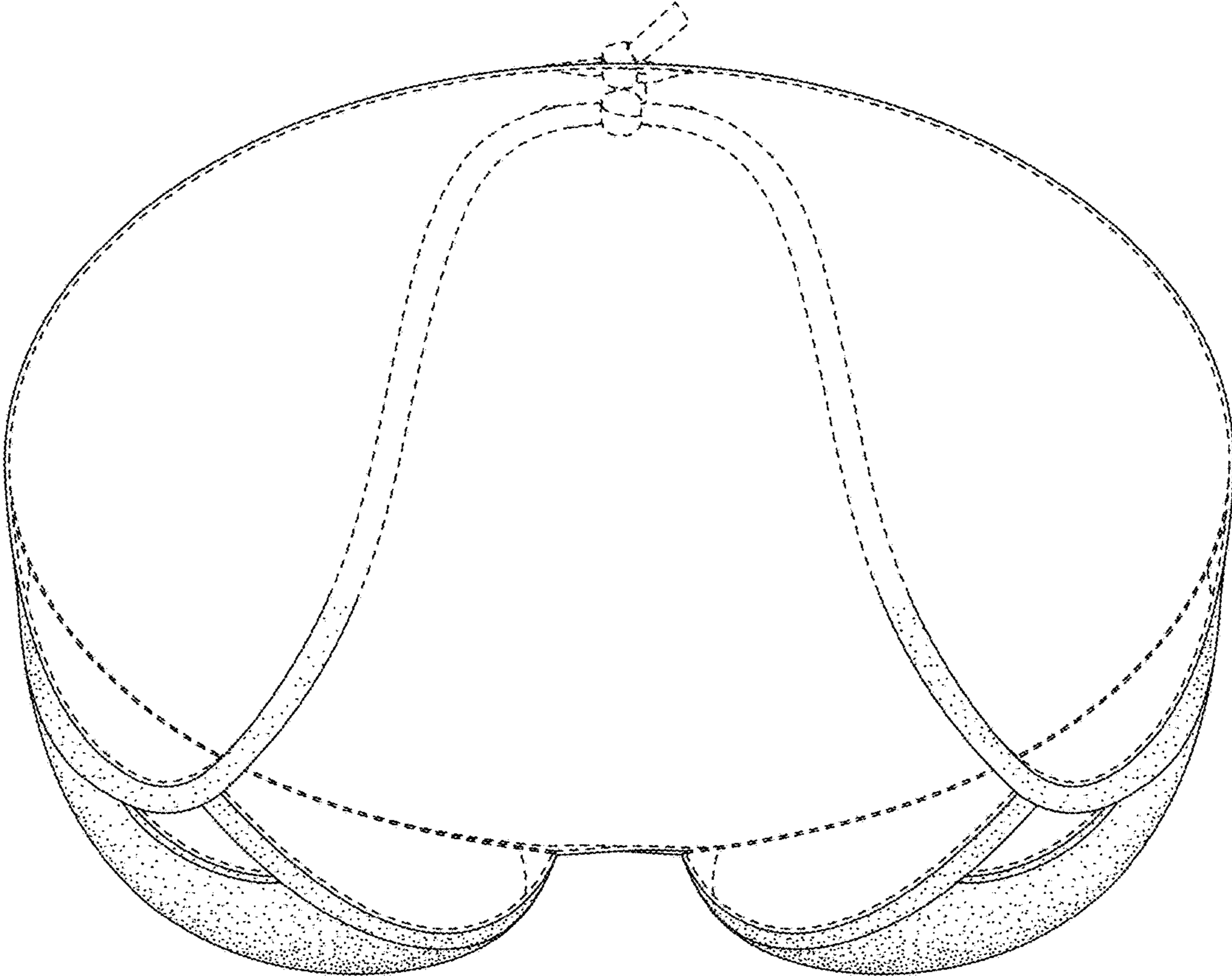

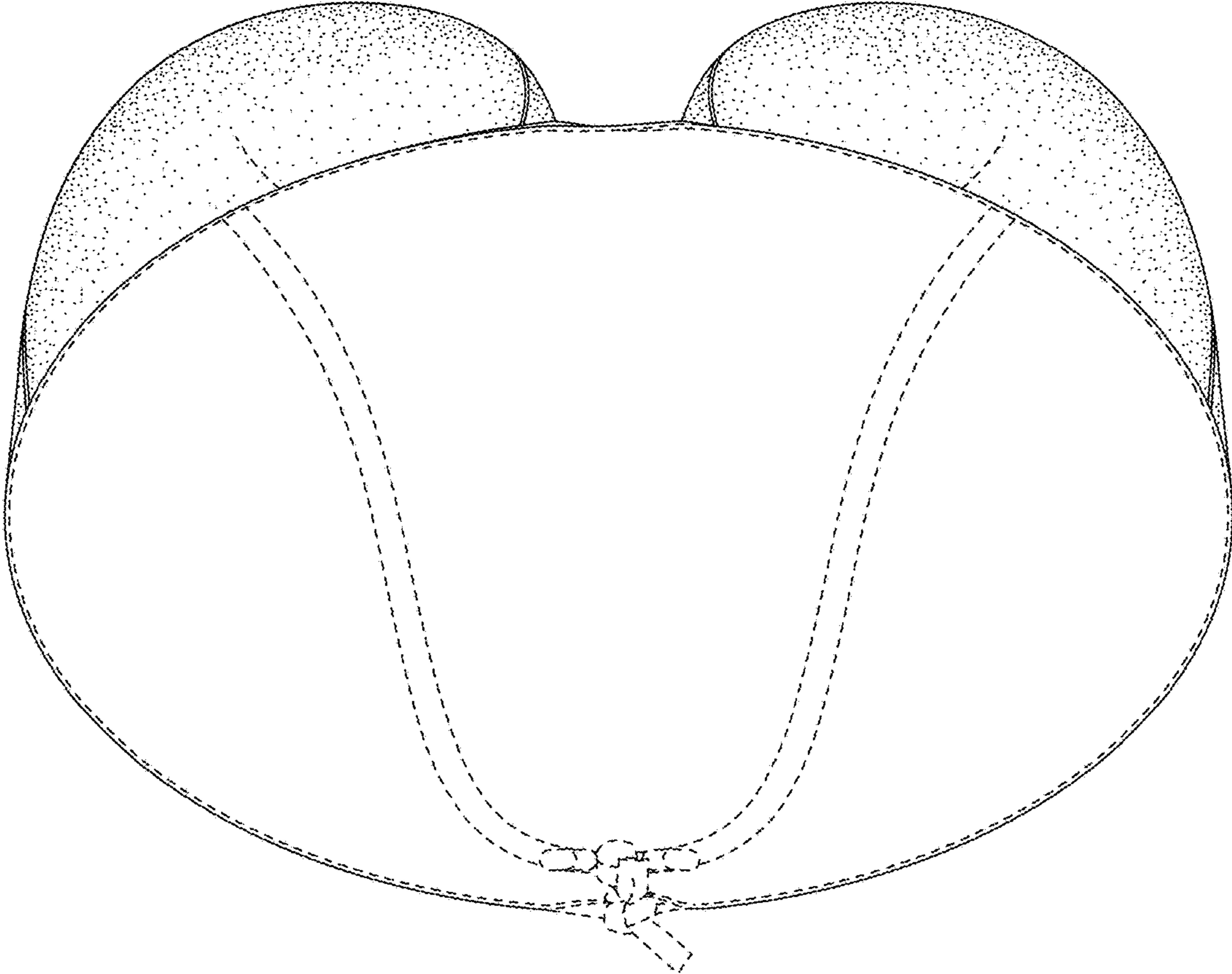

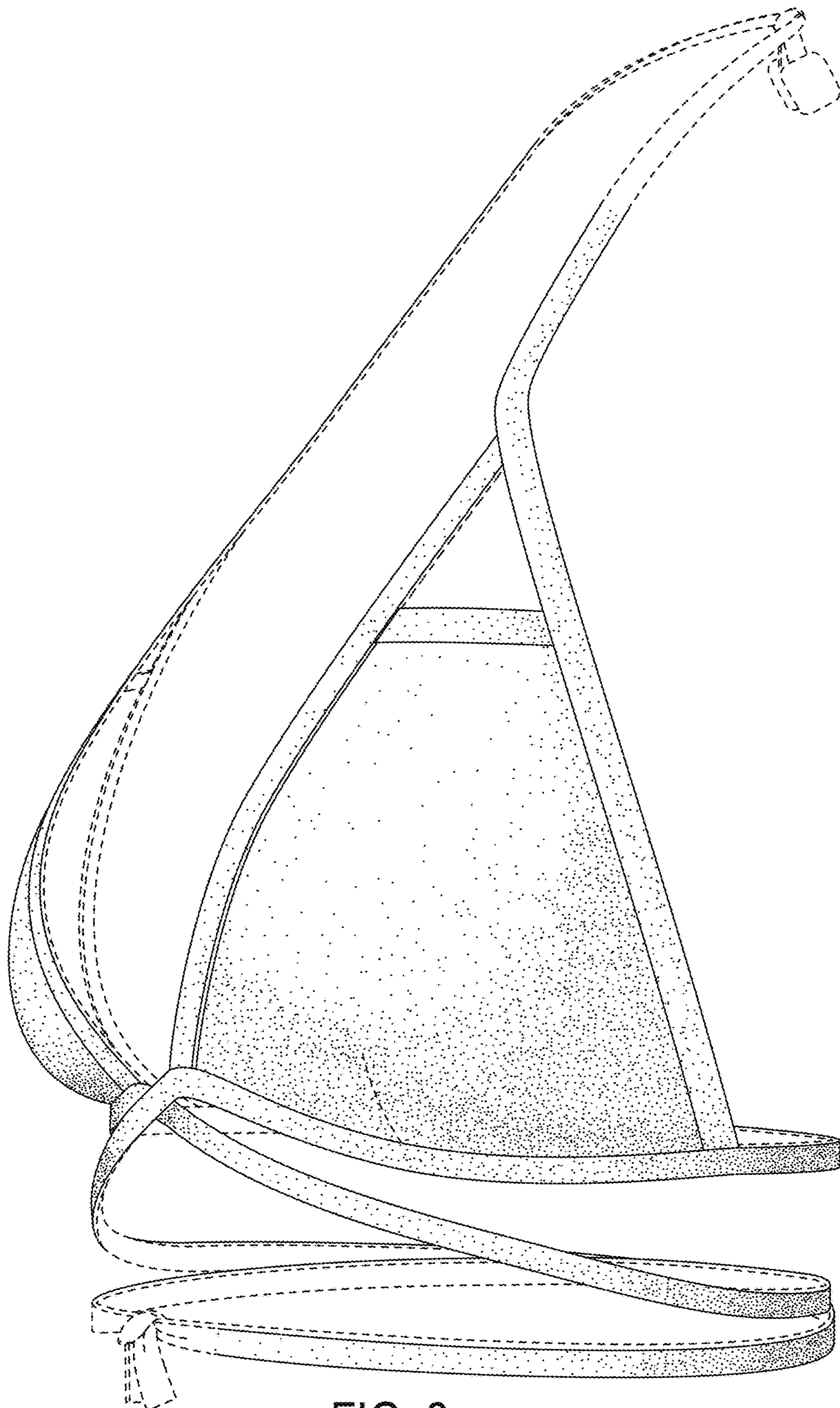

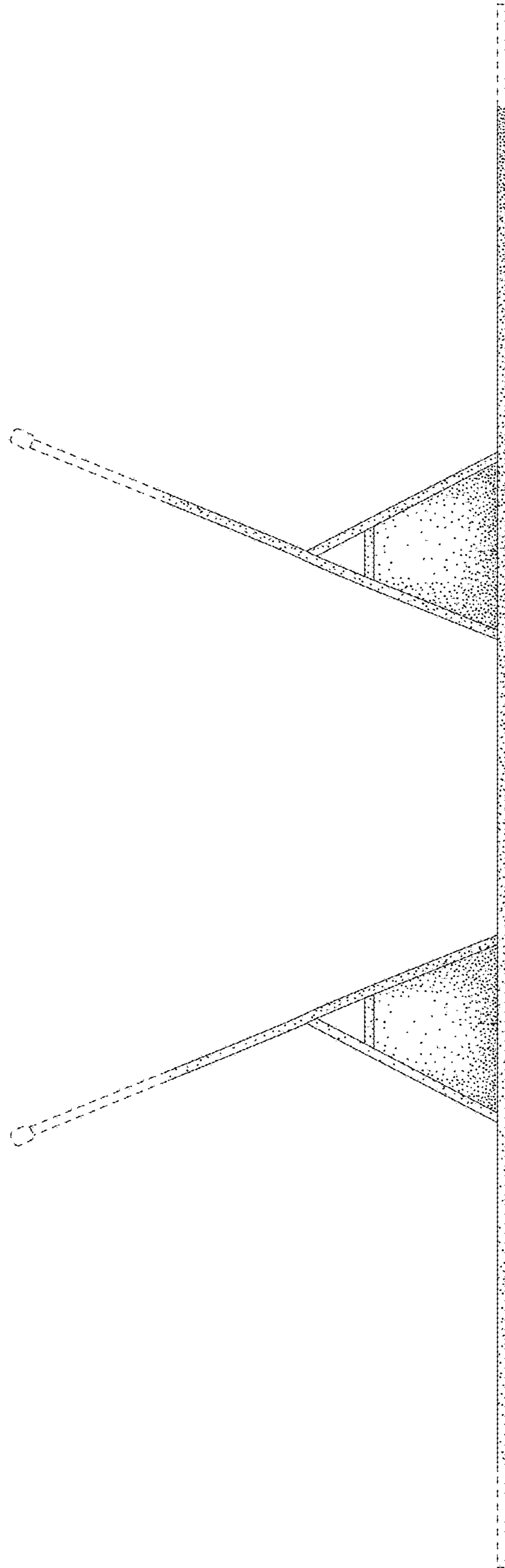
