DESCRIPTION

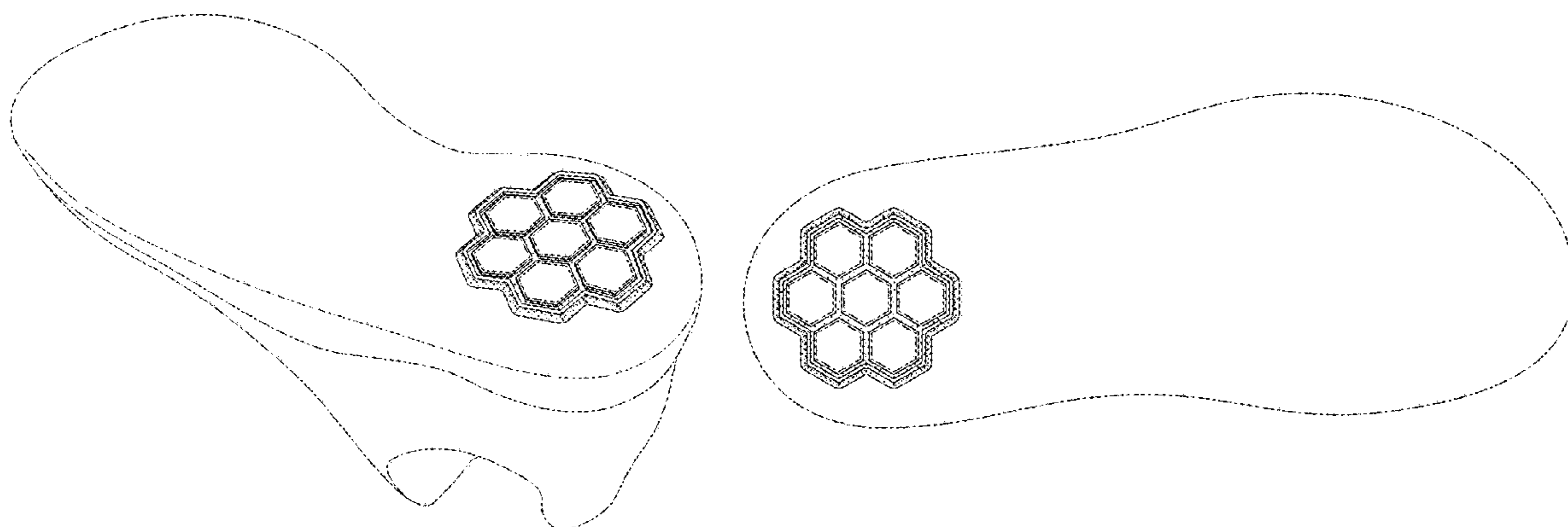
FIG. 1 is a rear perspective view of a shoe outsole showing my new design;

FIG. 2 is bottom view thereof; and,

FIG. 3 is a front perspective view thereof.

The broken lines immediately adjacent to the shaded area define the bounds of the claimed design and form no part thereof. The broken lines showing the remainder of the shoe represent unclaimed subject matter and form no part of the claimed design. The seven unshaded regions within the shaded area that are demarcated by broken lines form no part of the claimed design.

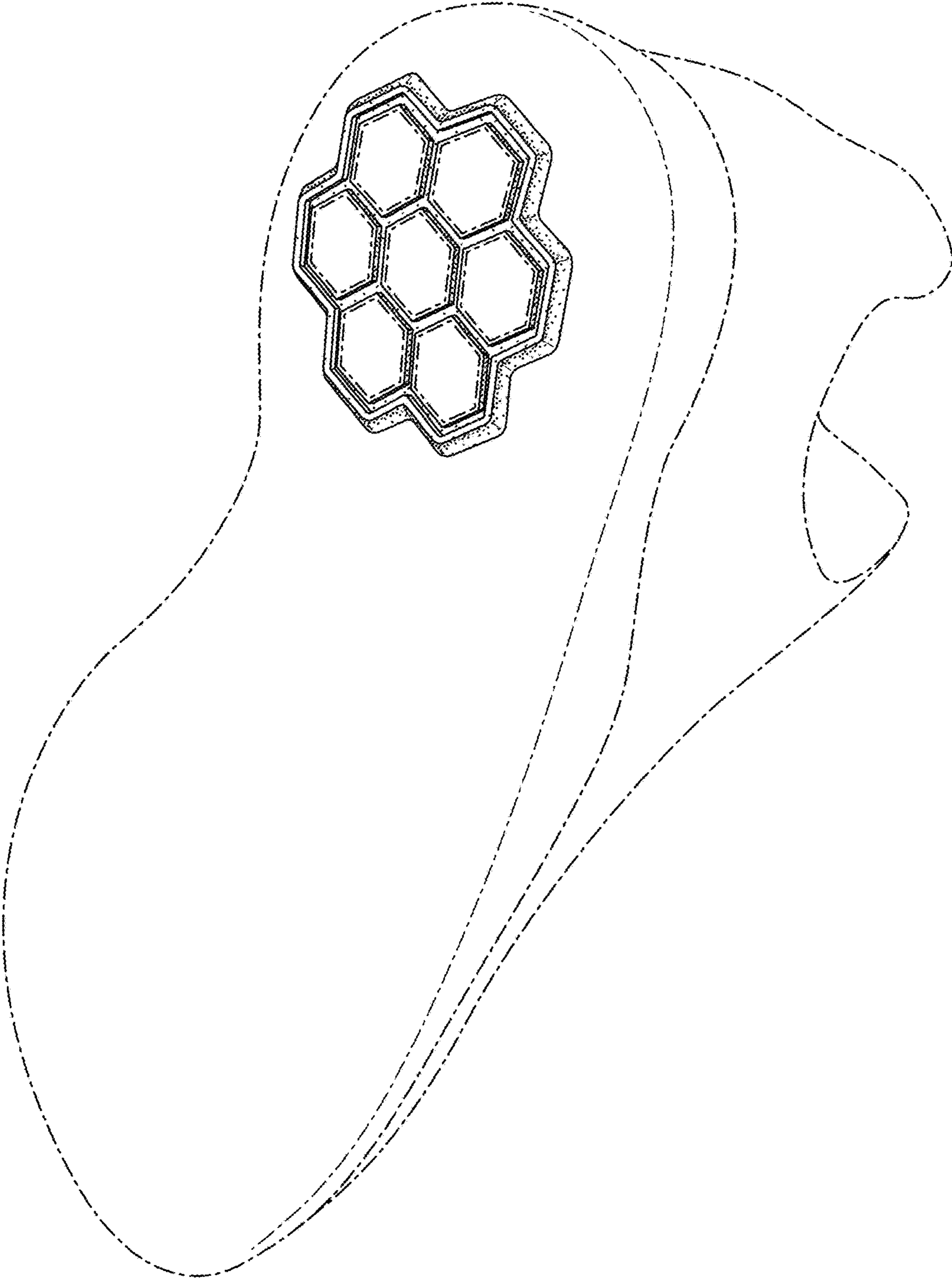

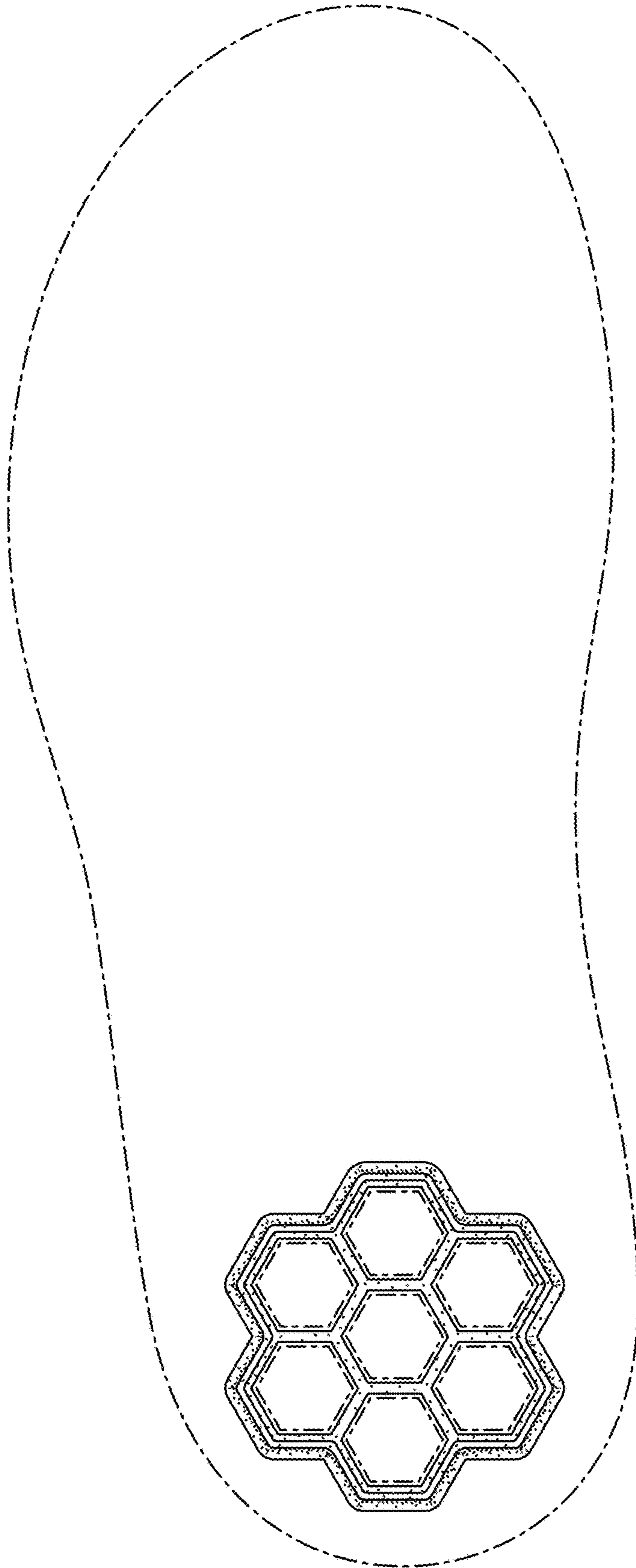

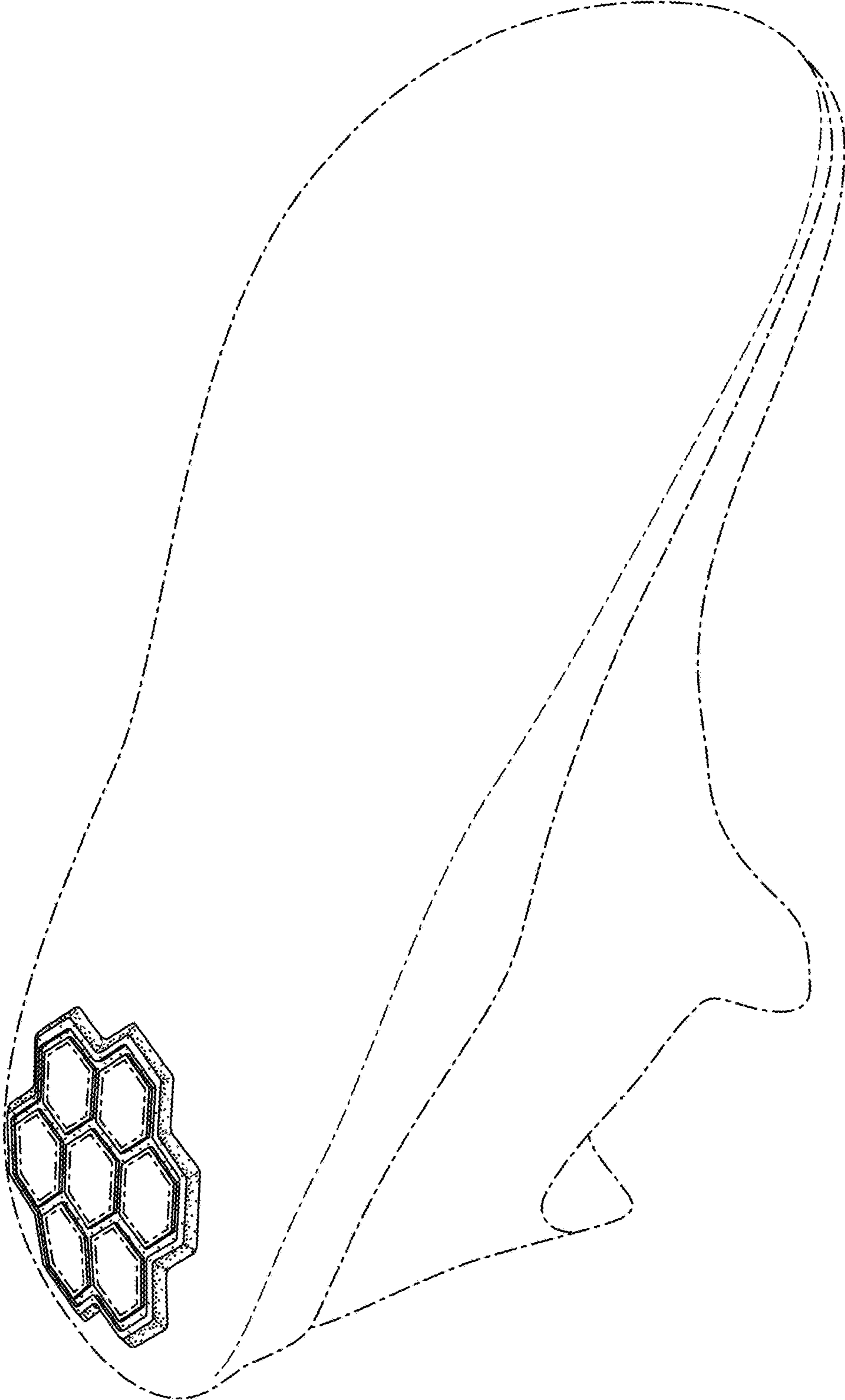
