**DESCRIPTION**

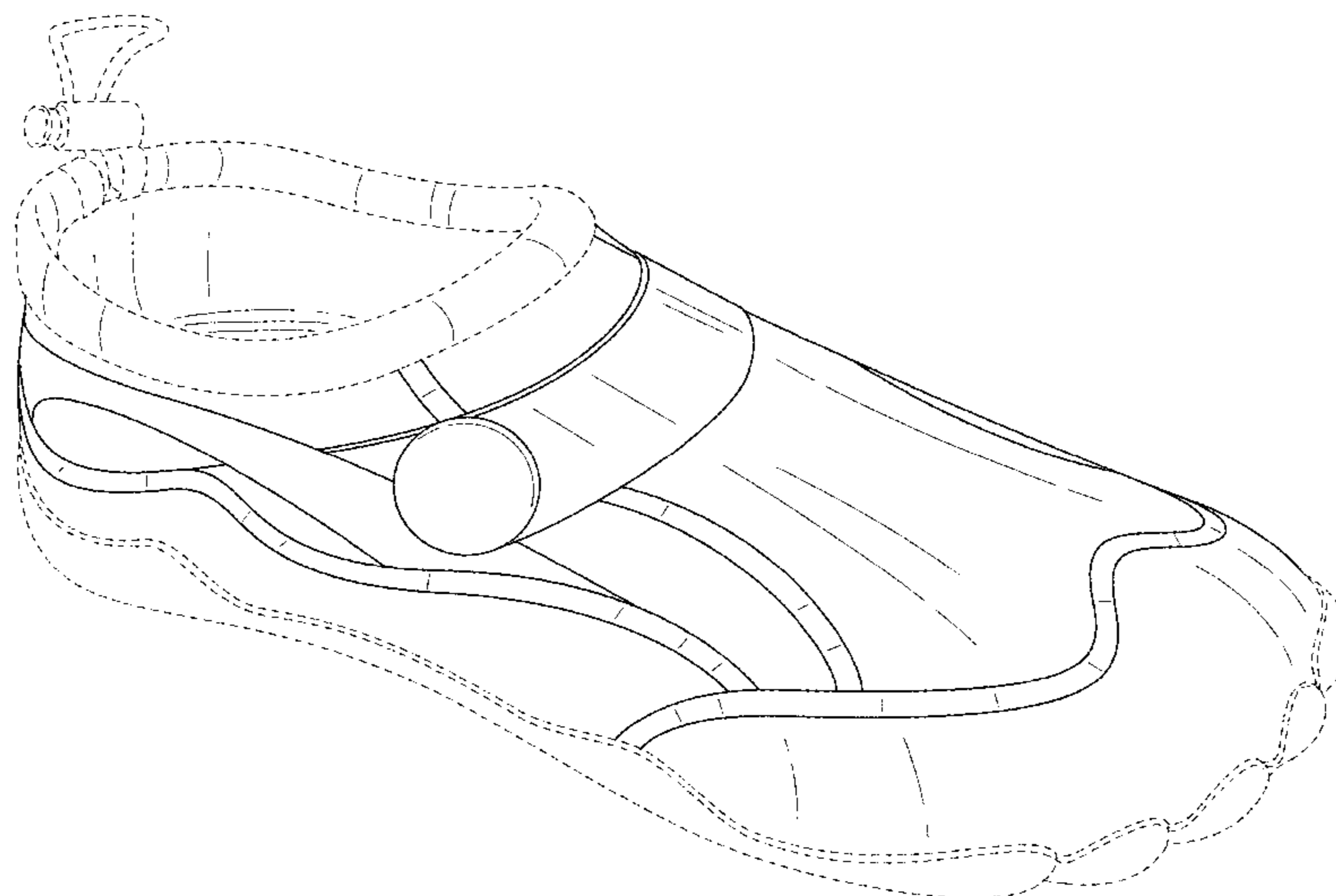

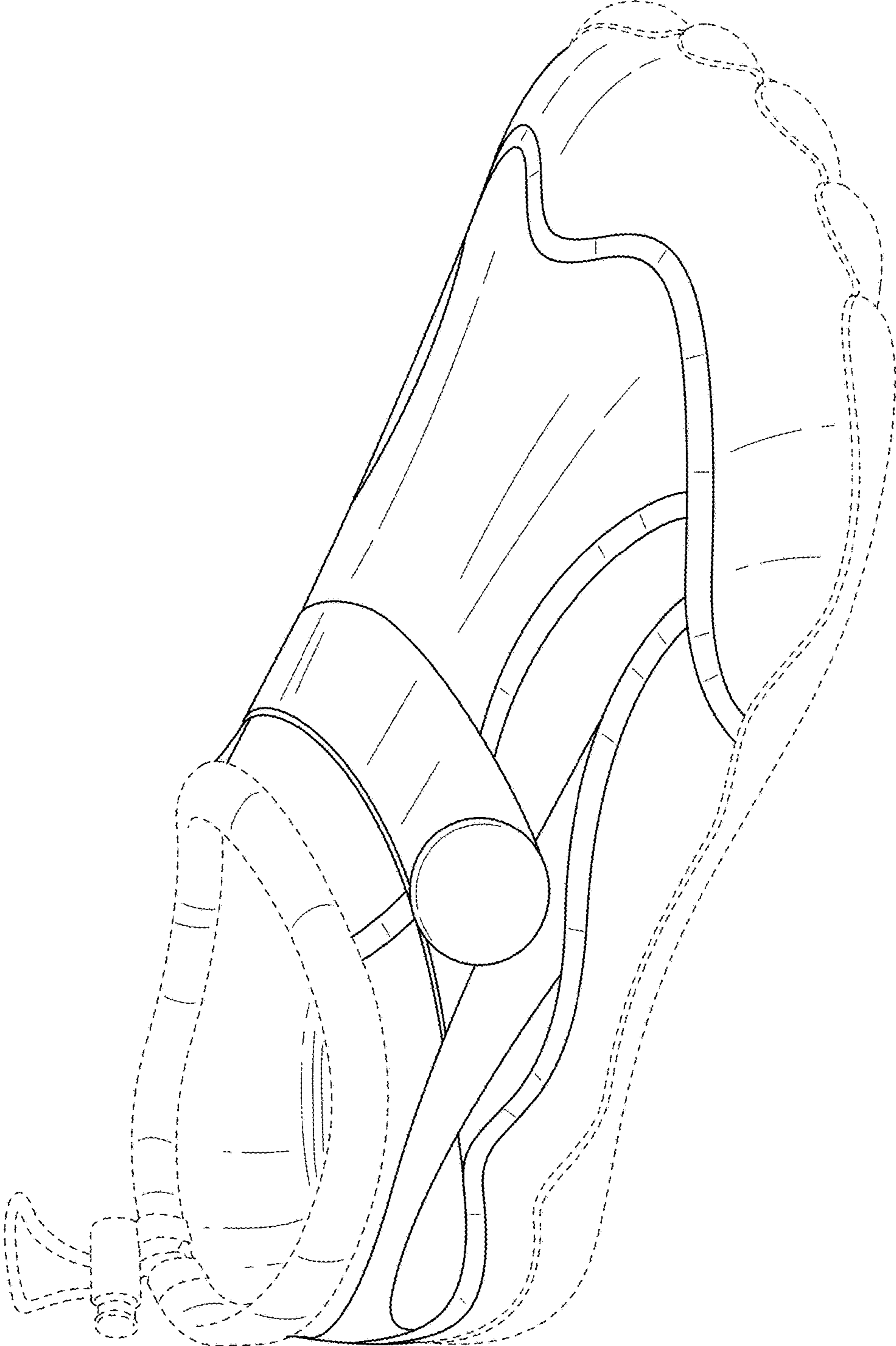

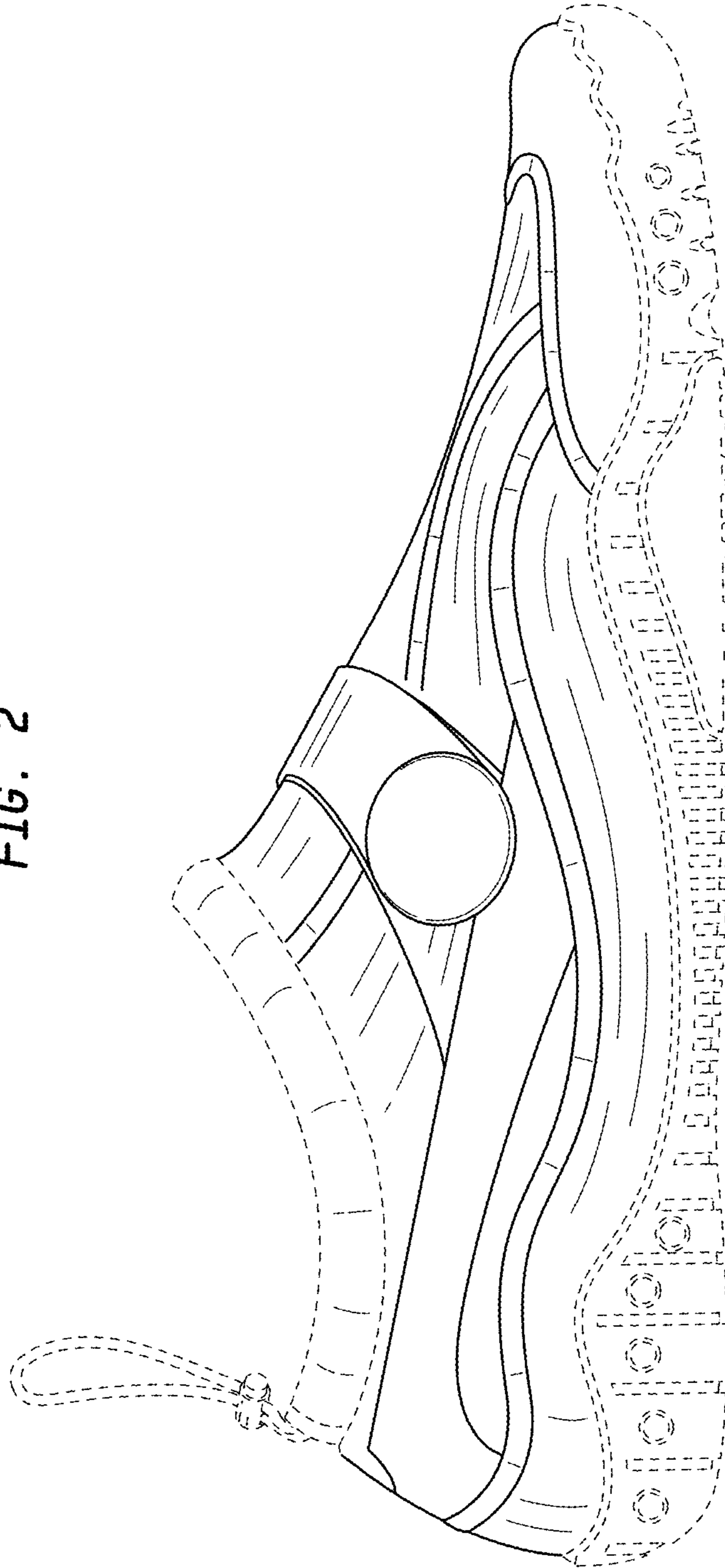
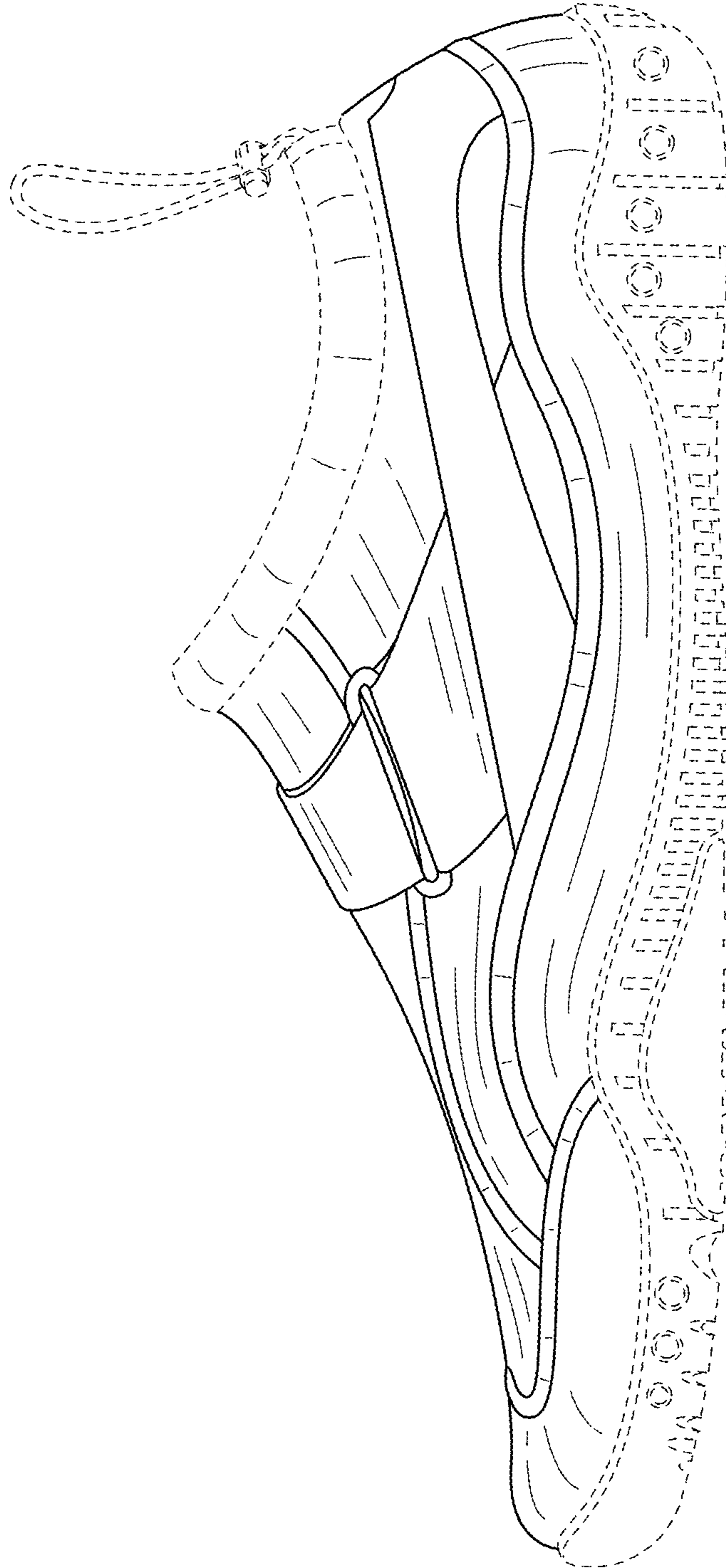
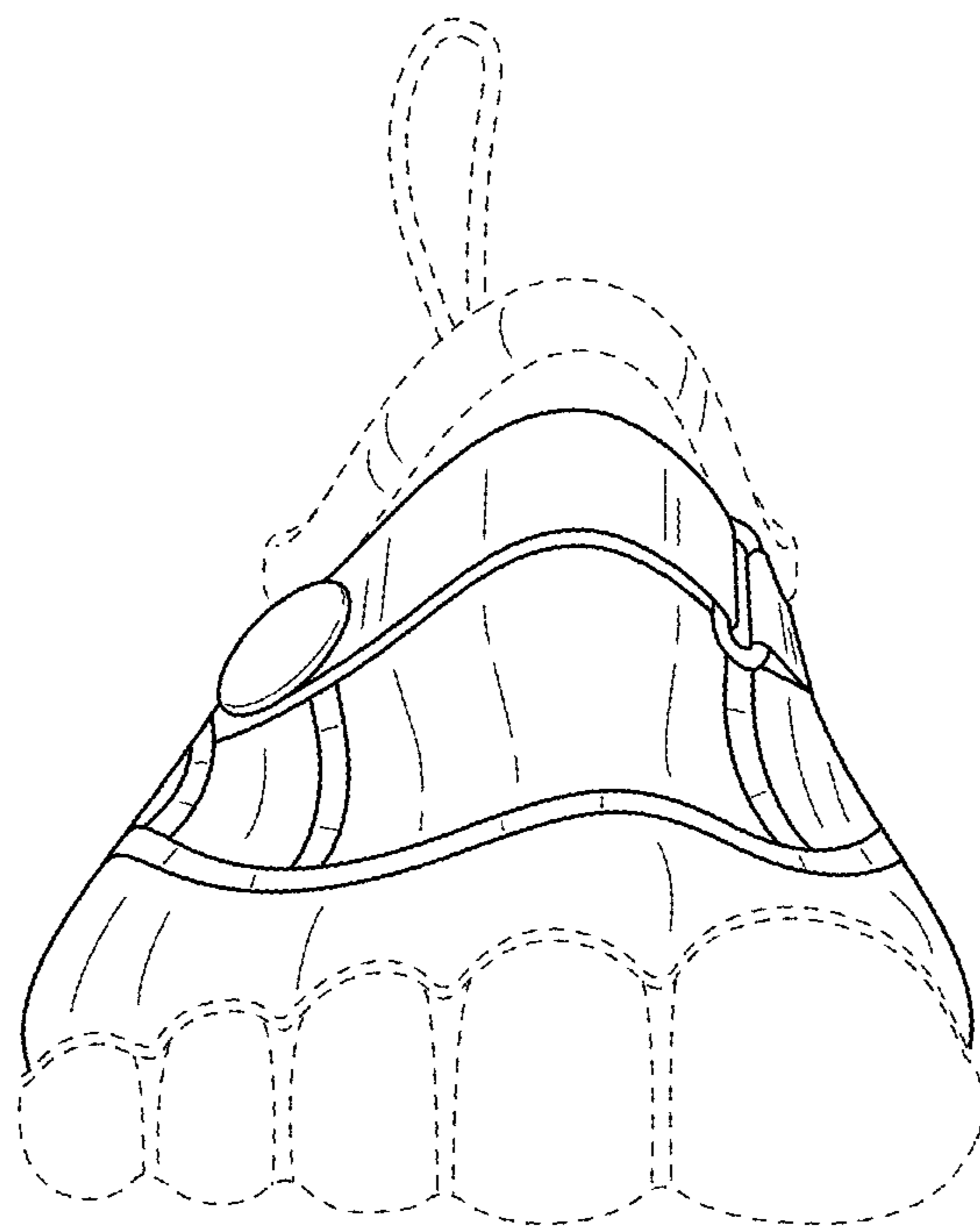

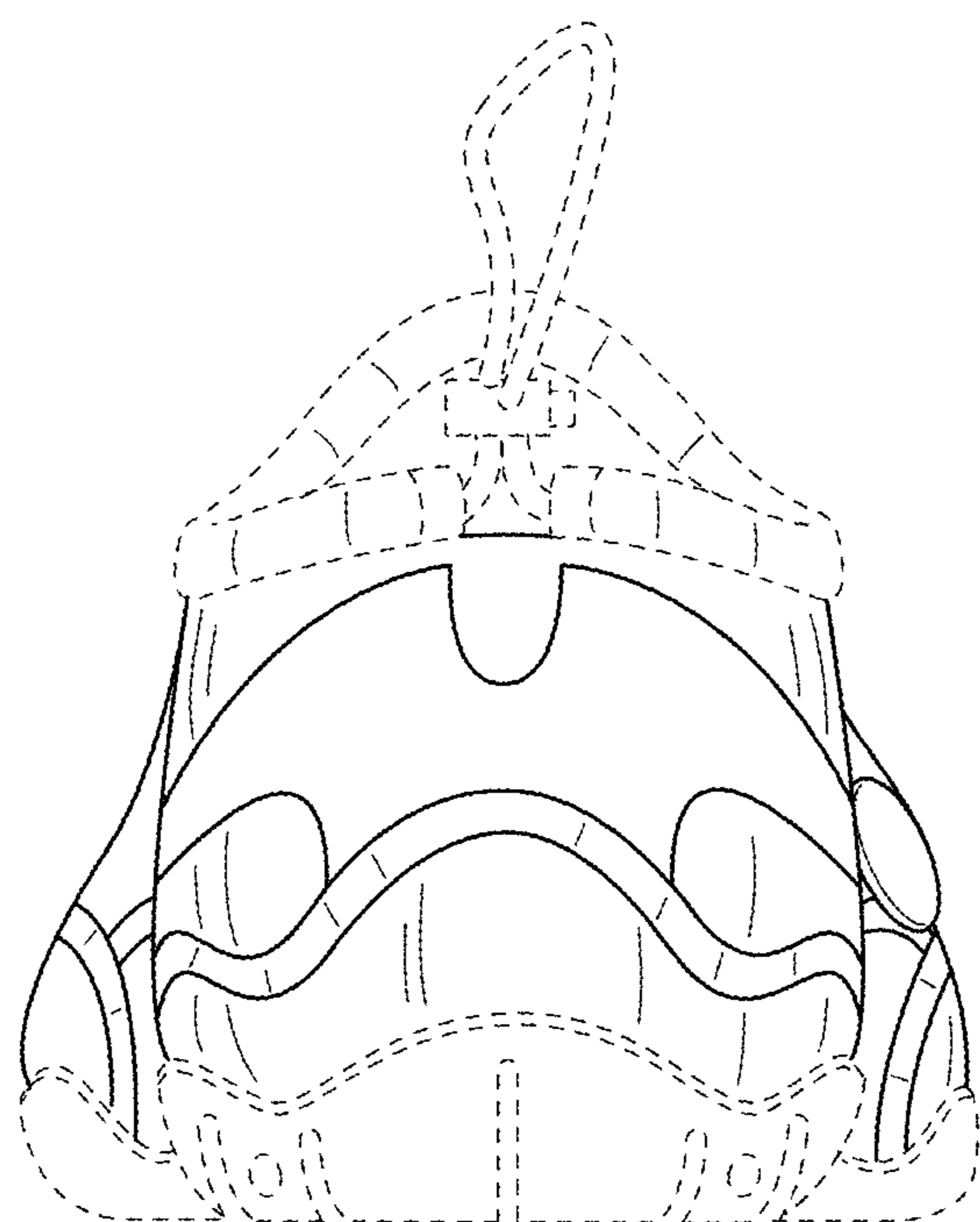

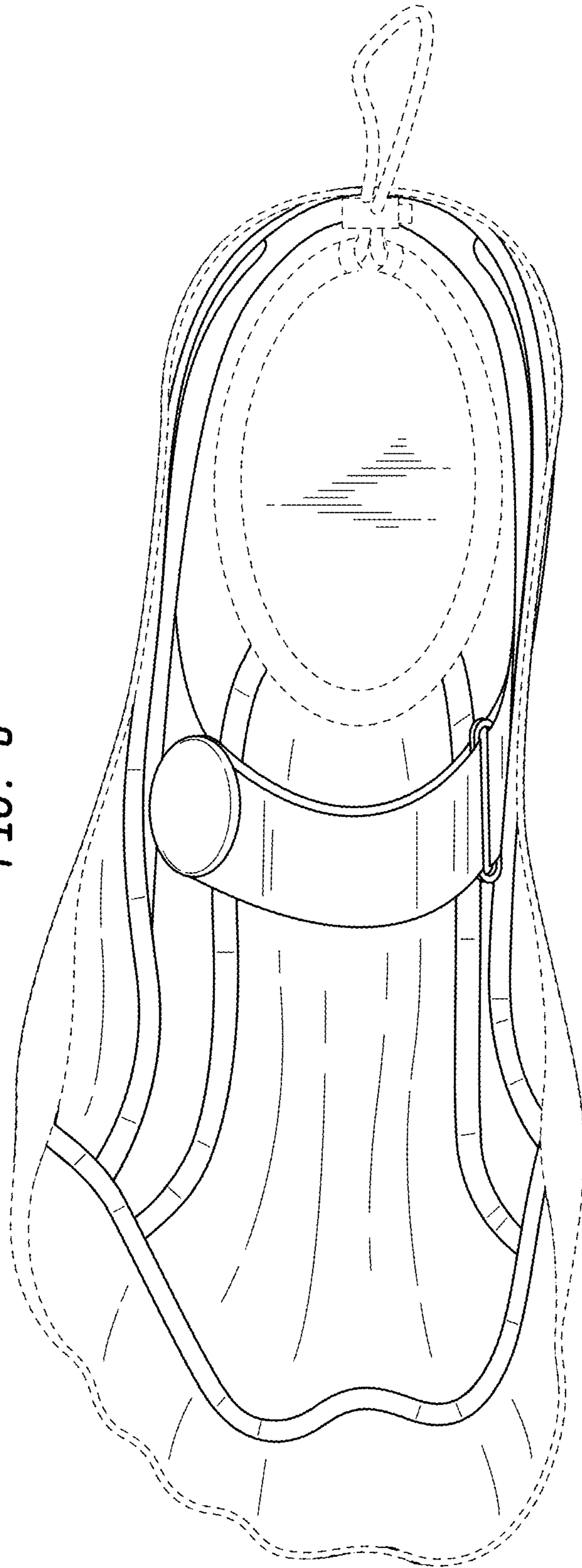
