The ornamental design for a nightstand, as shown and described.

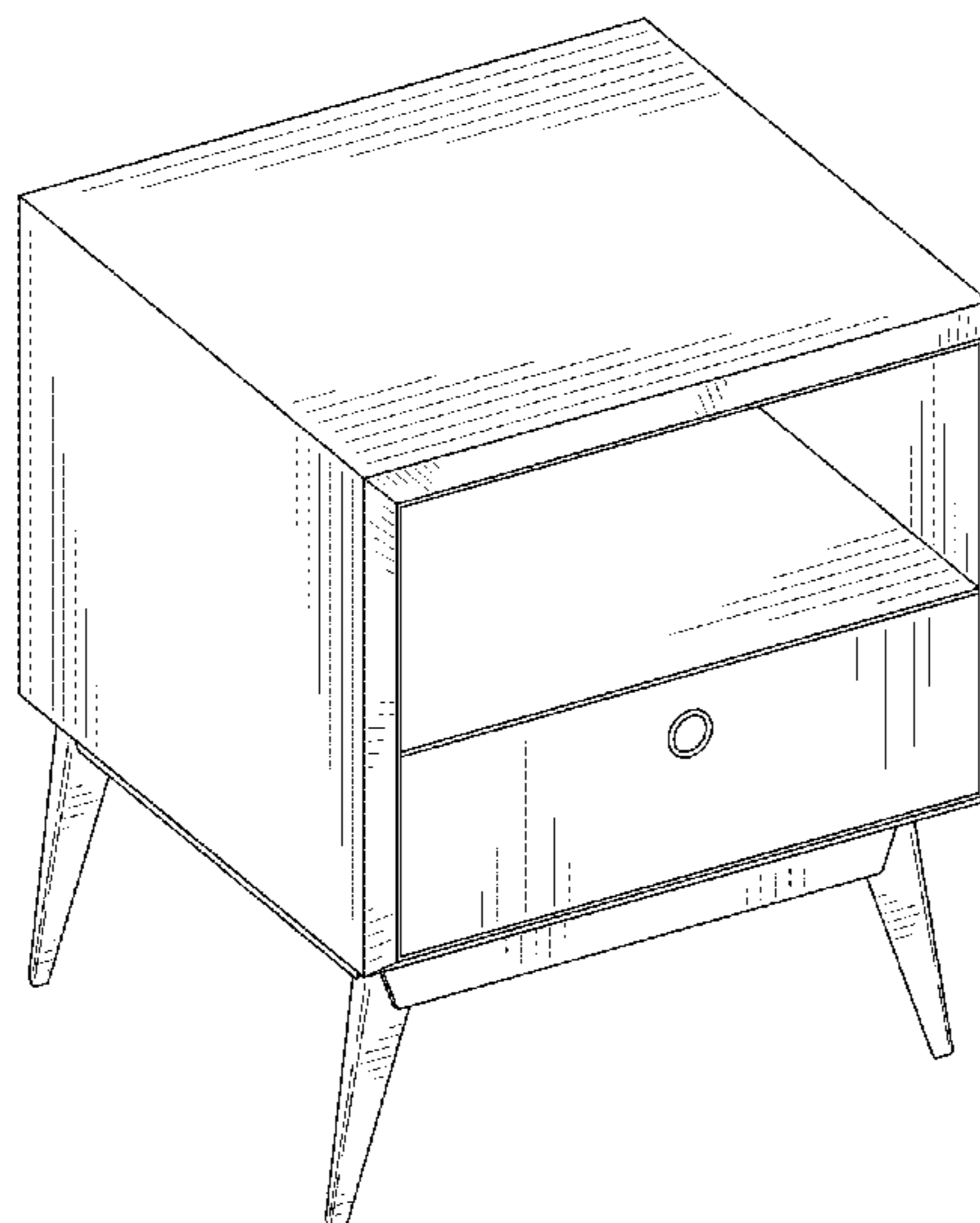
DESCRIPTION

FIG. 1 is a perspective view of the nightstand; FIG. 2 is a front elevational view of the nightstand; FIG. 3 is a rear elevational view of the nightstand; FIG. 4 is a left side elevational view of the nightstand, the opposite side of which is a mirror image; FIG. 5 is a top plan view of the nightstand; and, FIG. 6 is a bottom plan view of the nightstand.

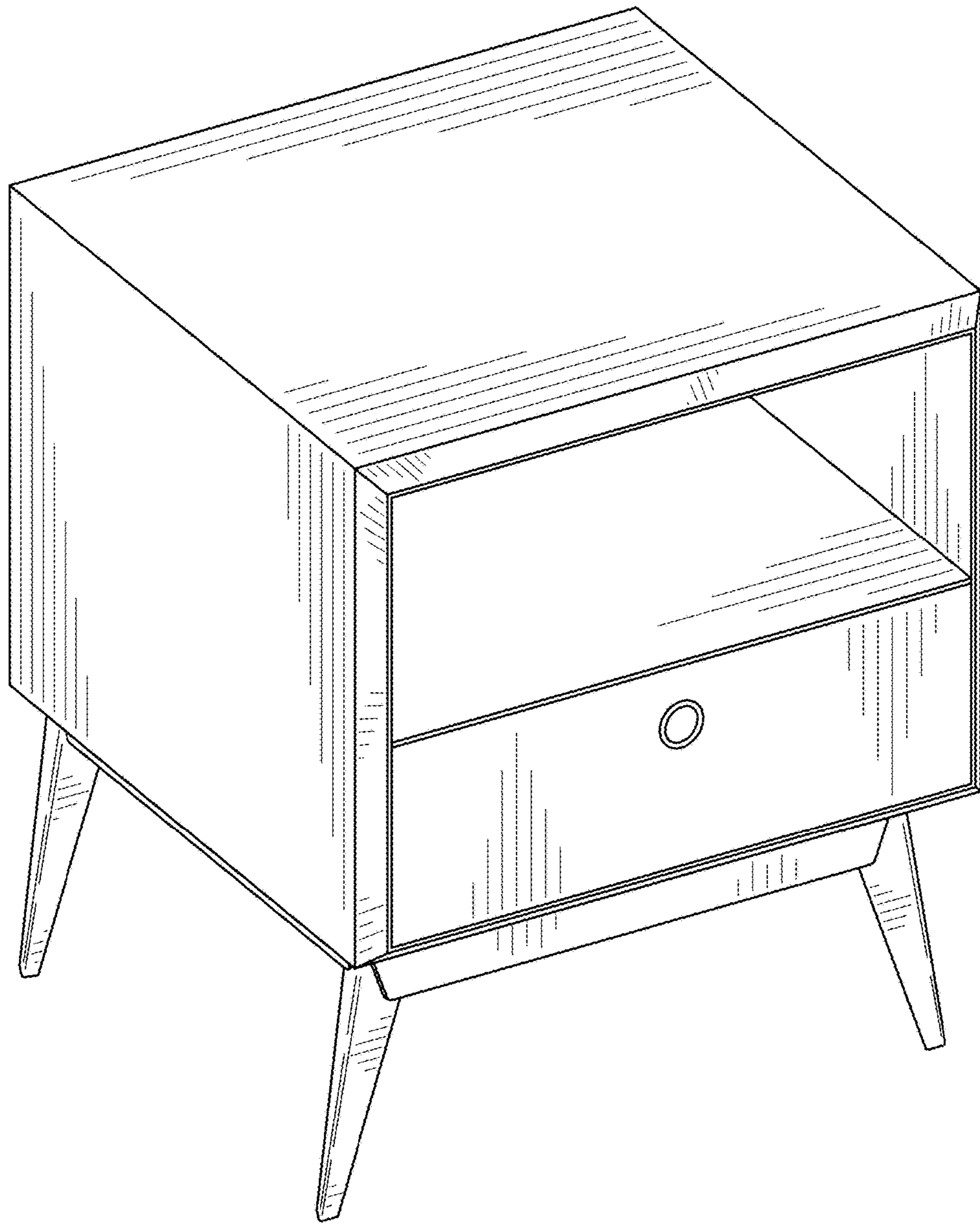

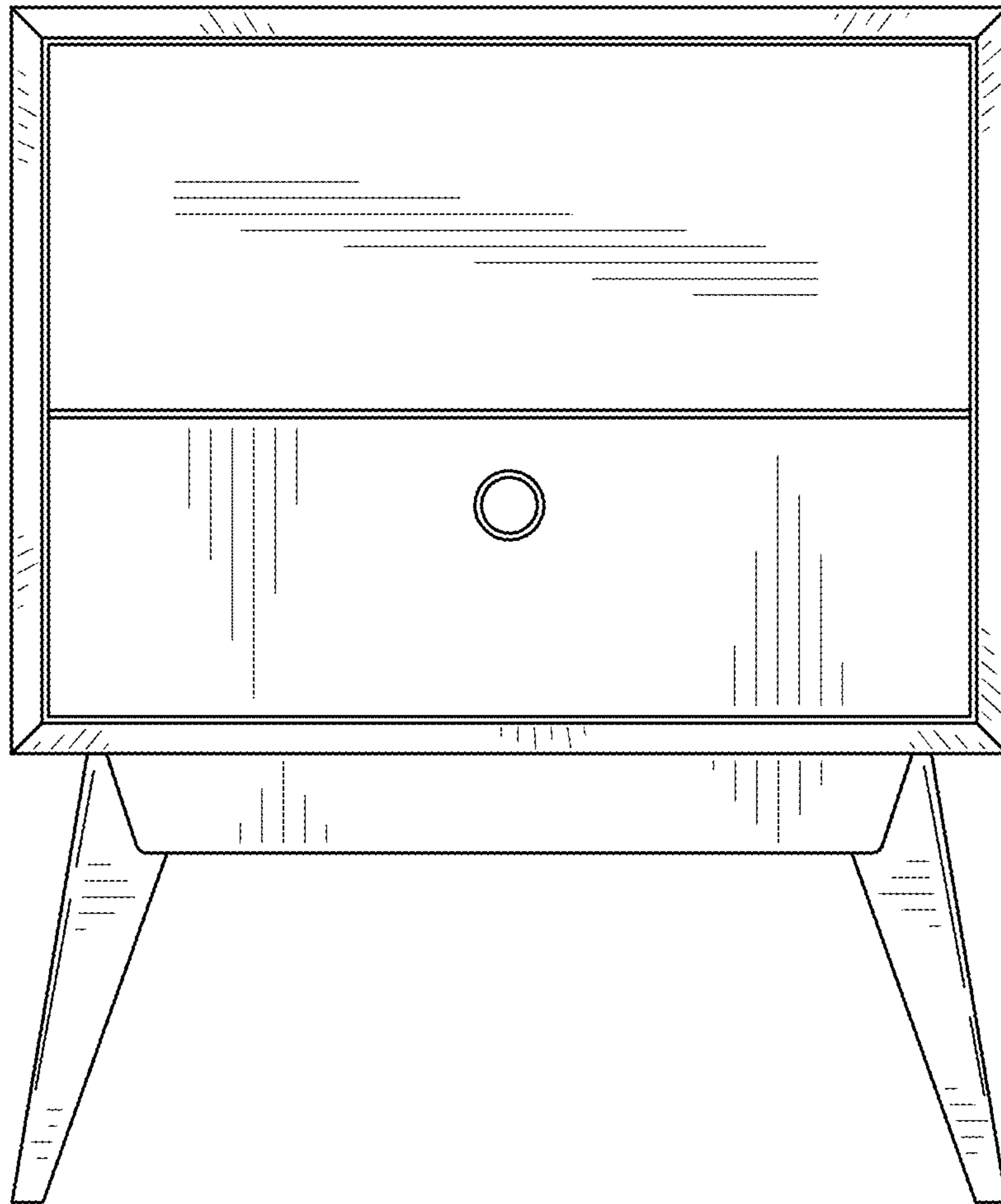

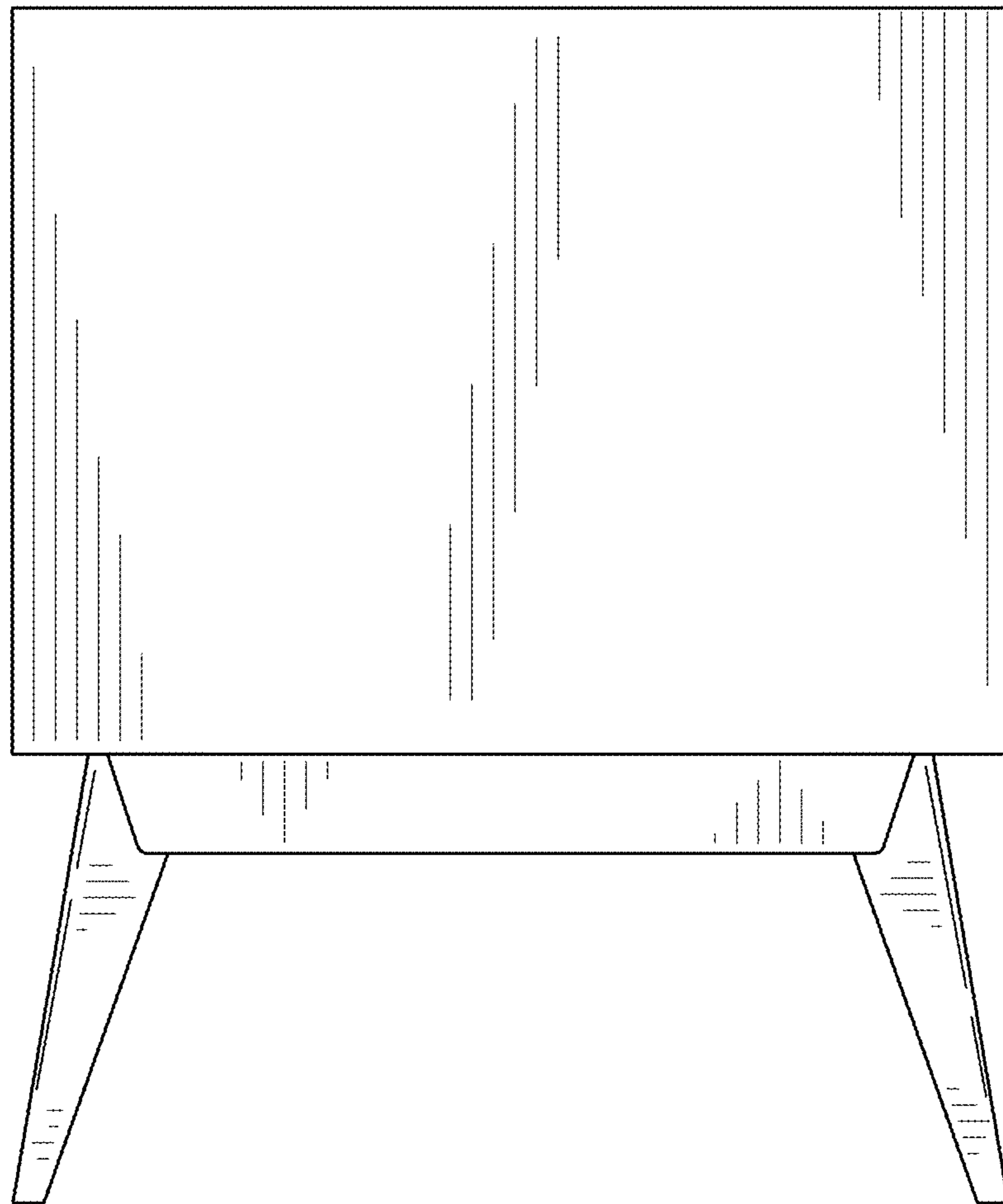

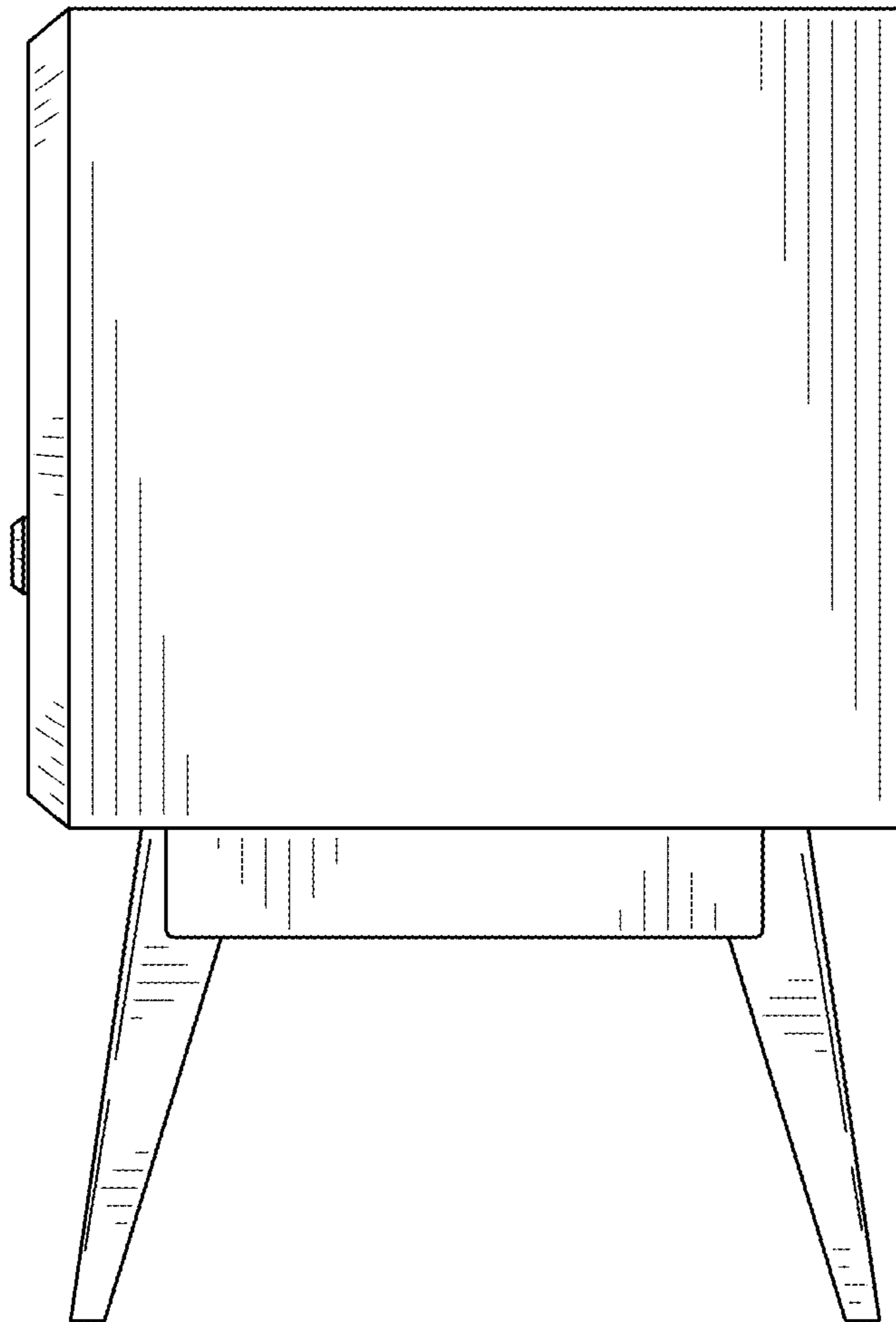

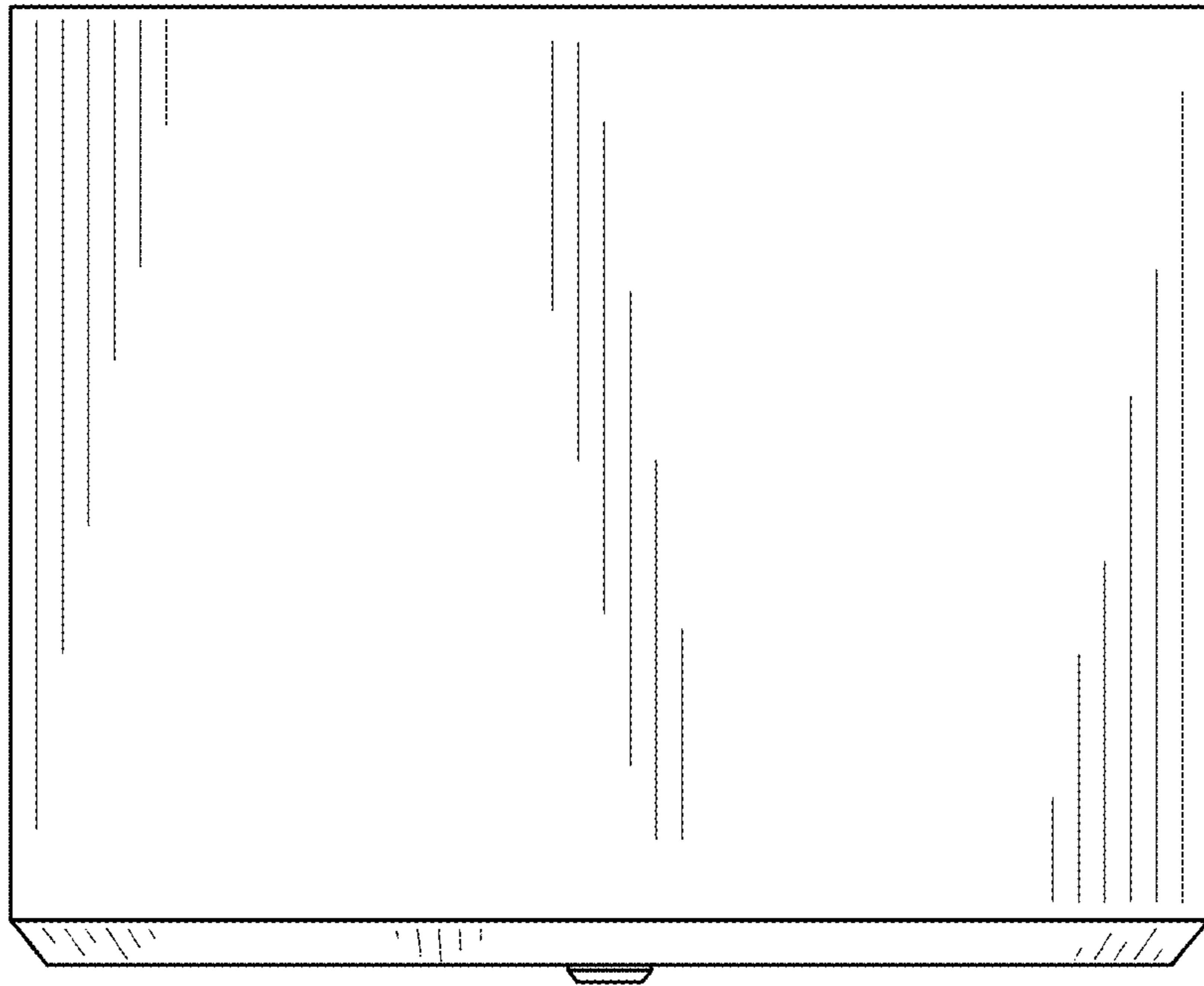

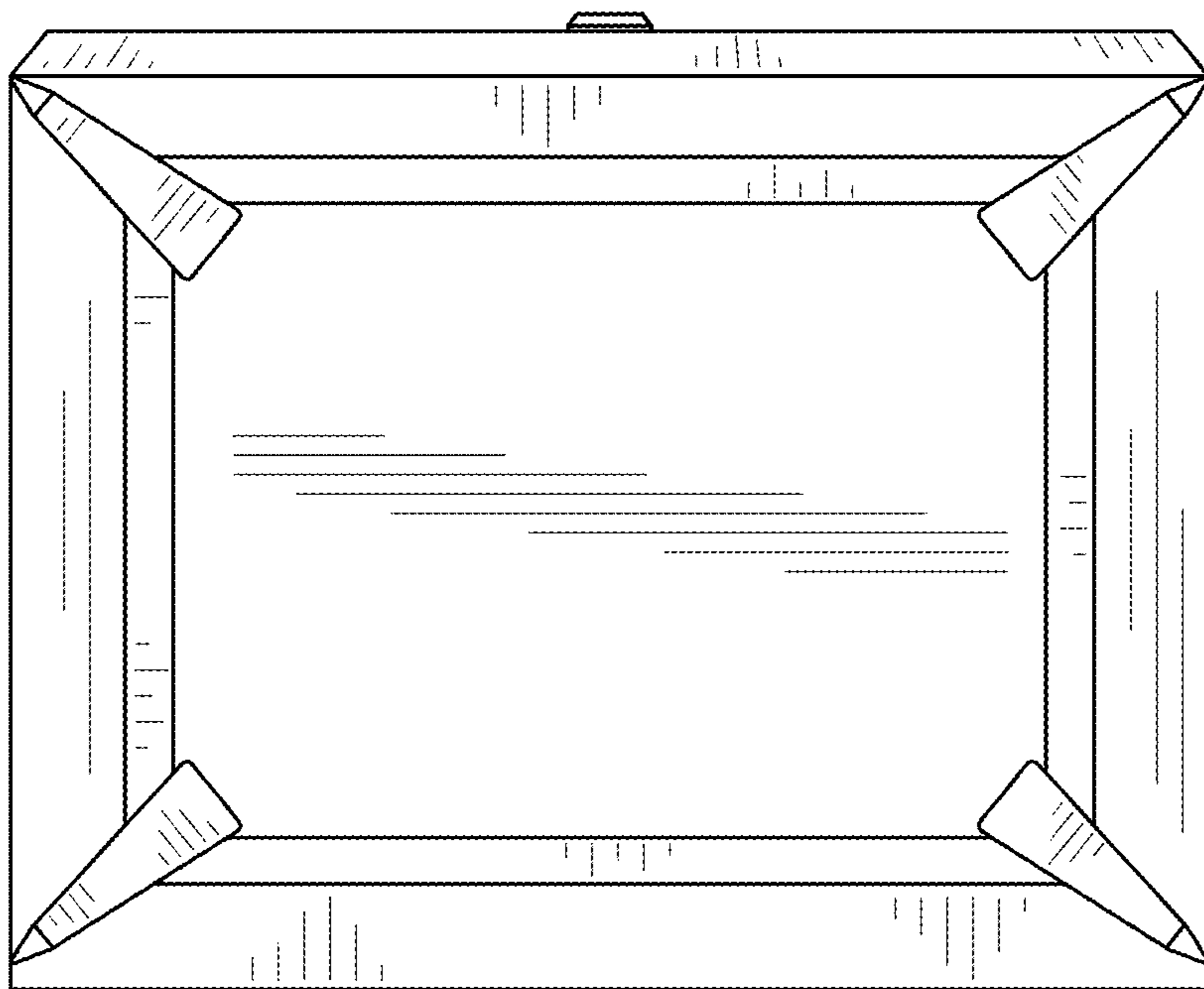
