**DESCRIPTION**

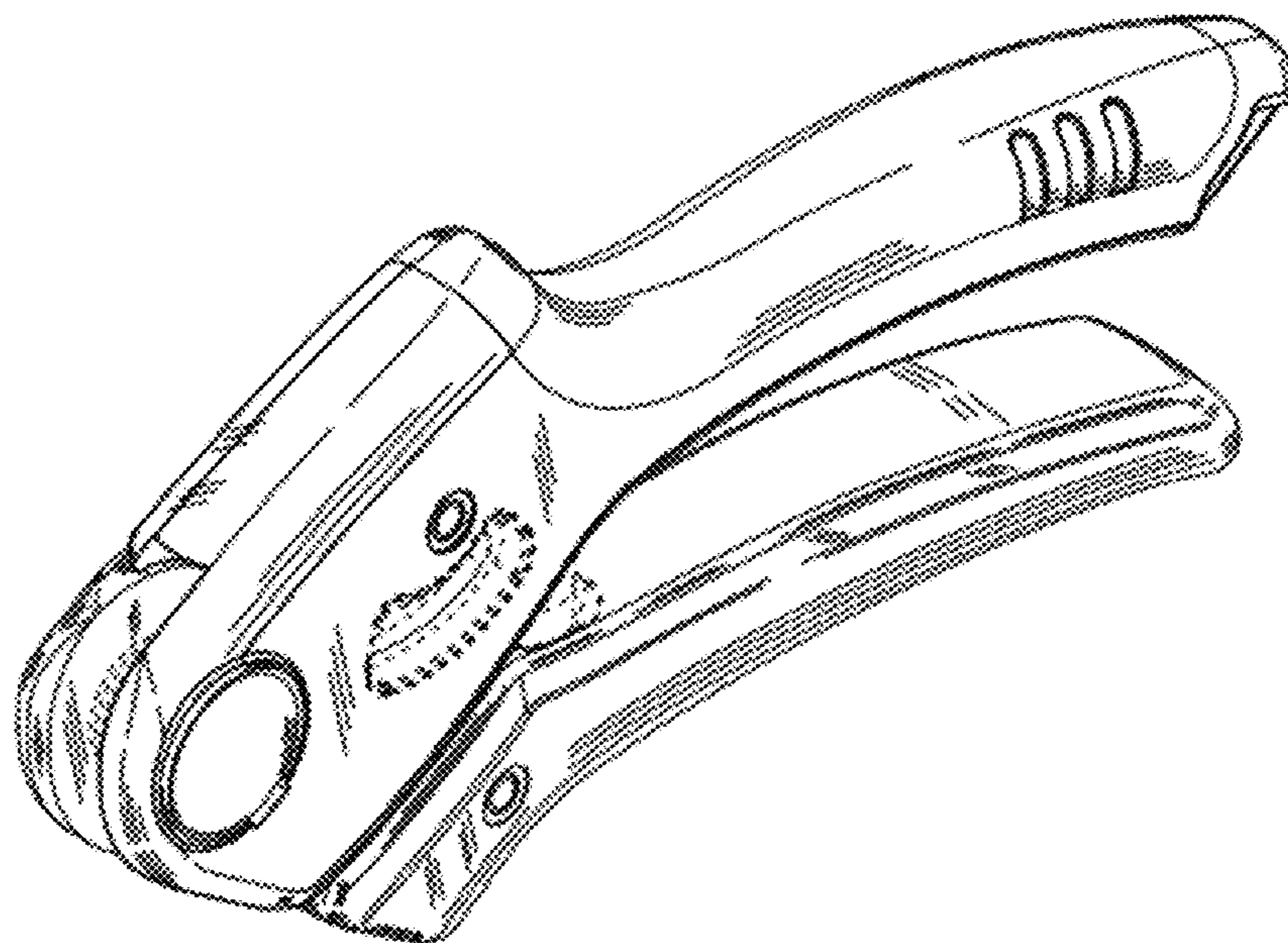
FIG. 1 is a front view of an garden shears showing my new design.

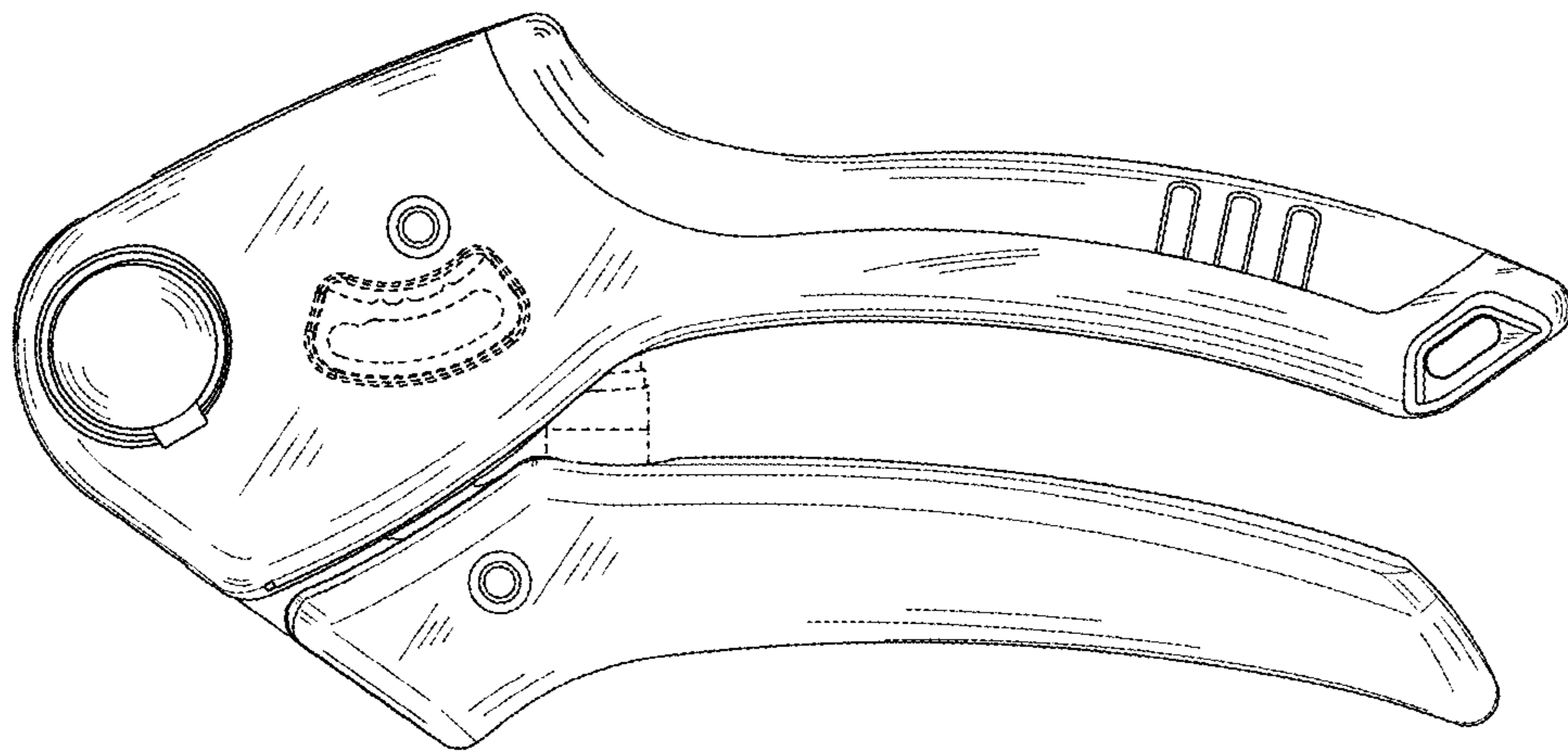

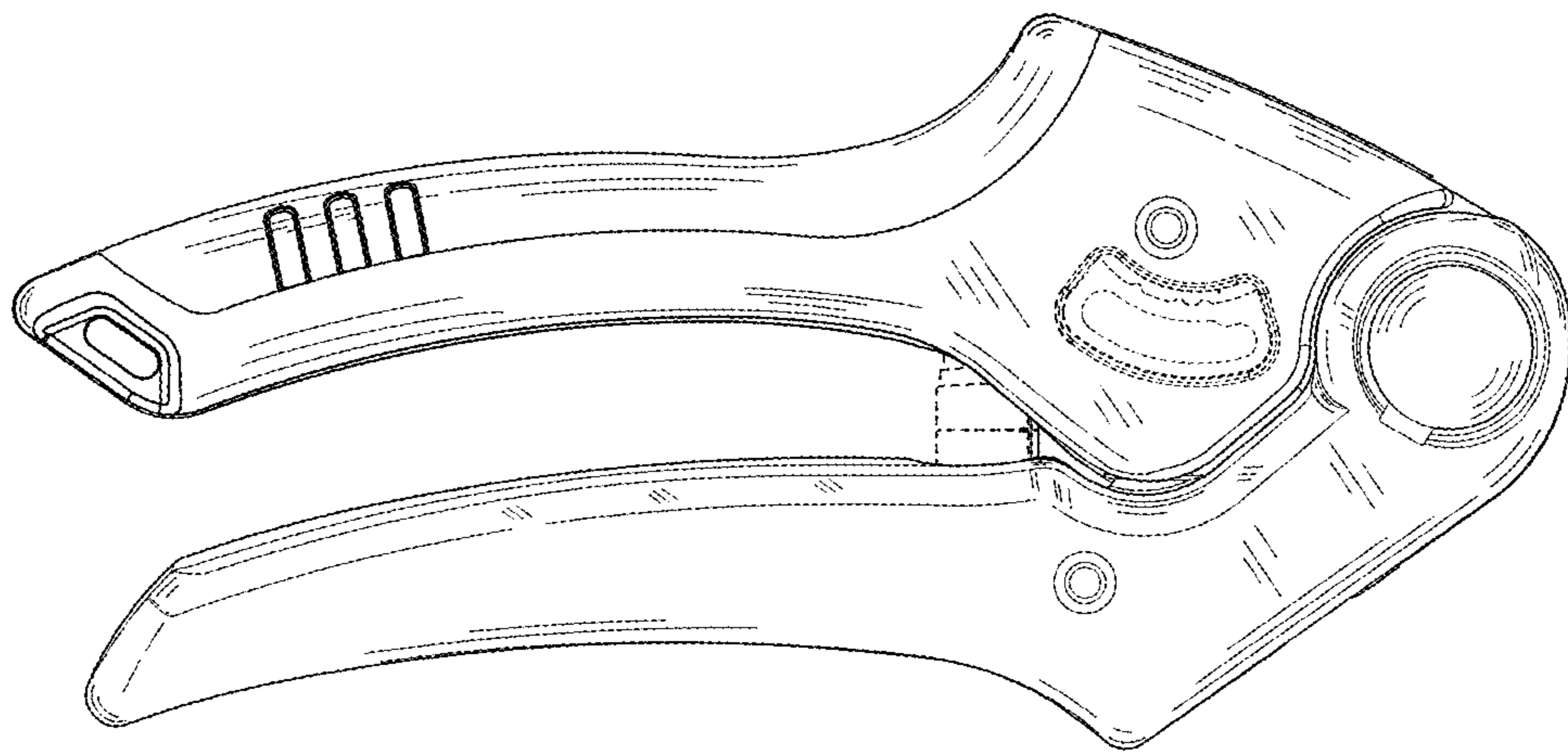

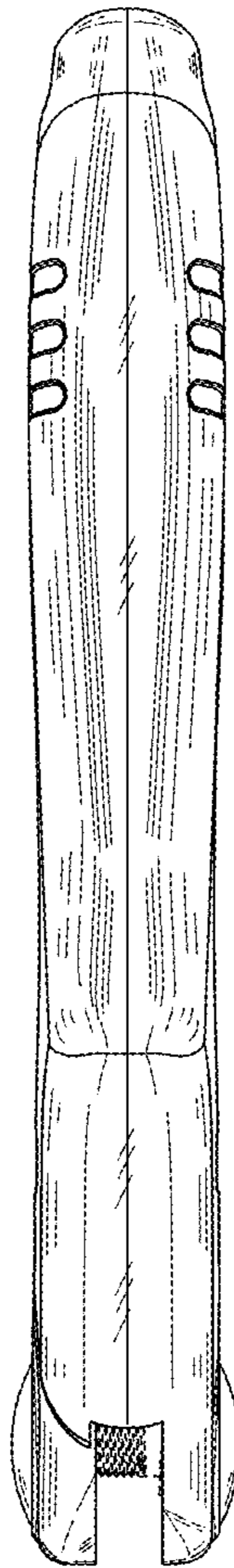

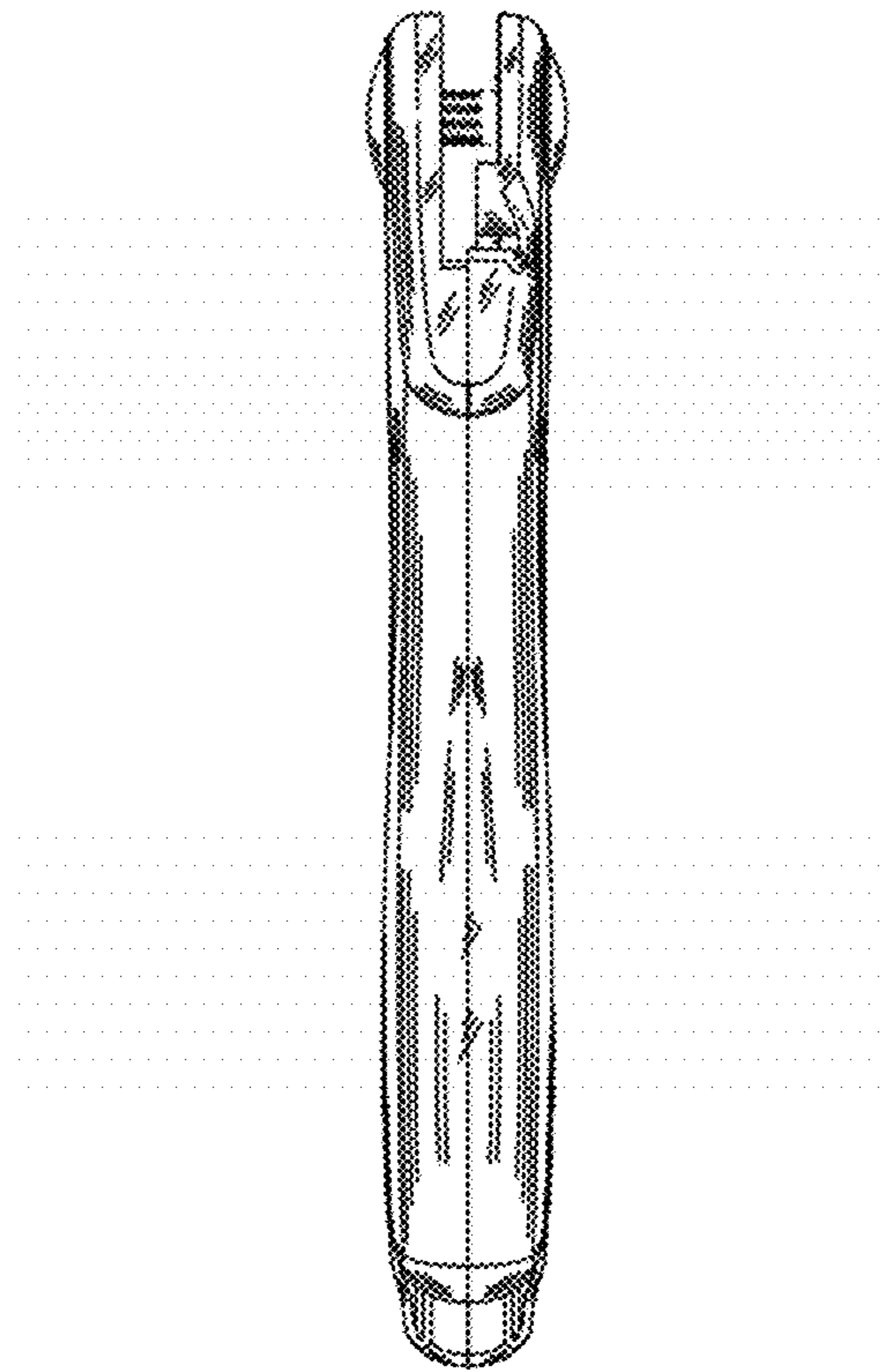

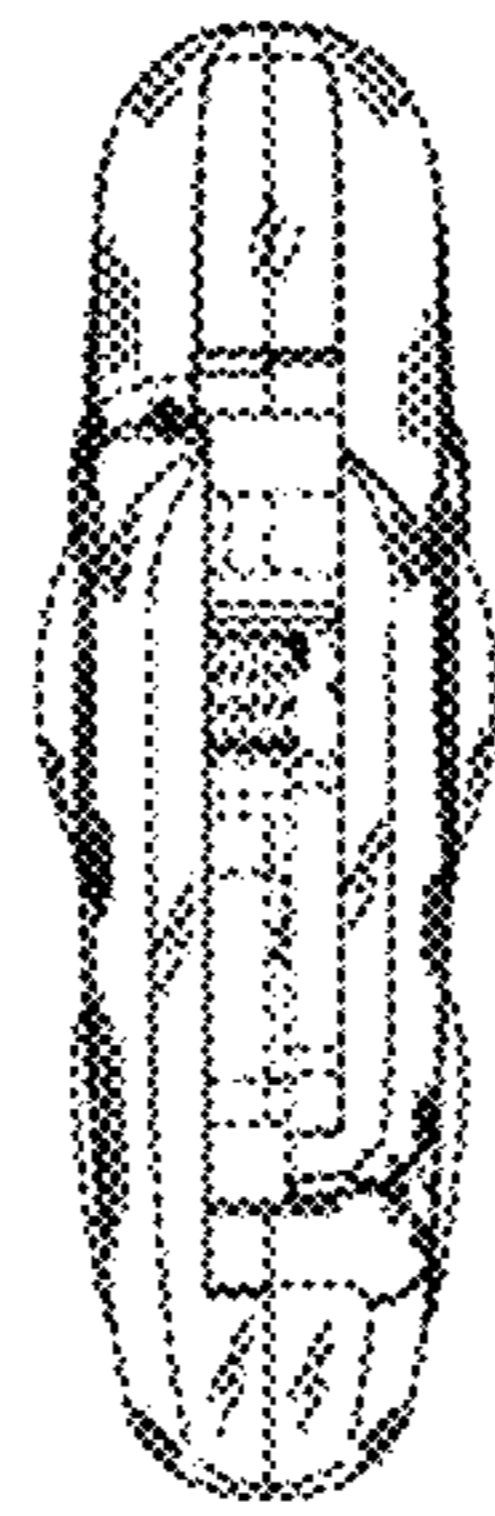

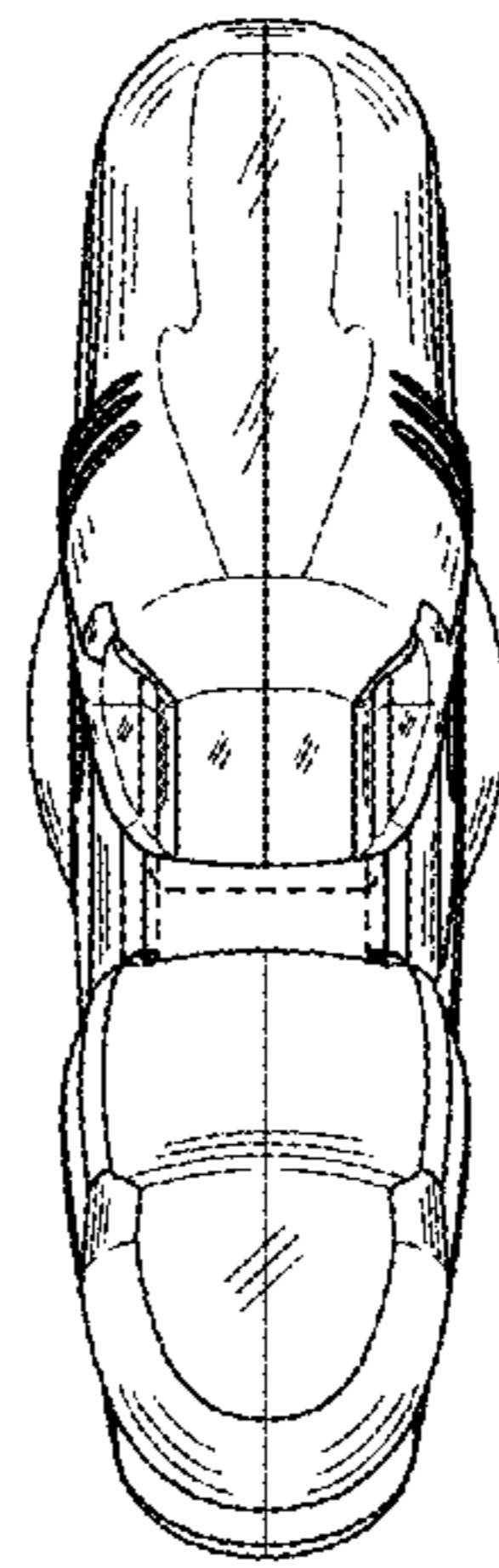

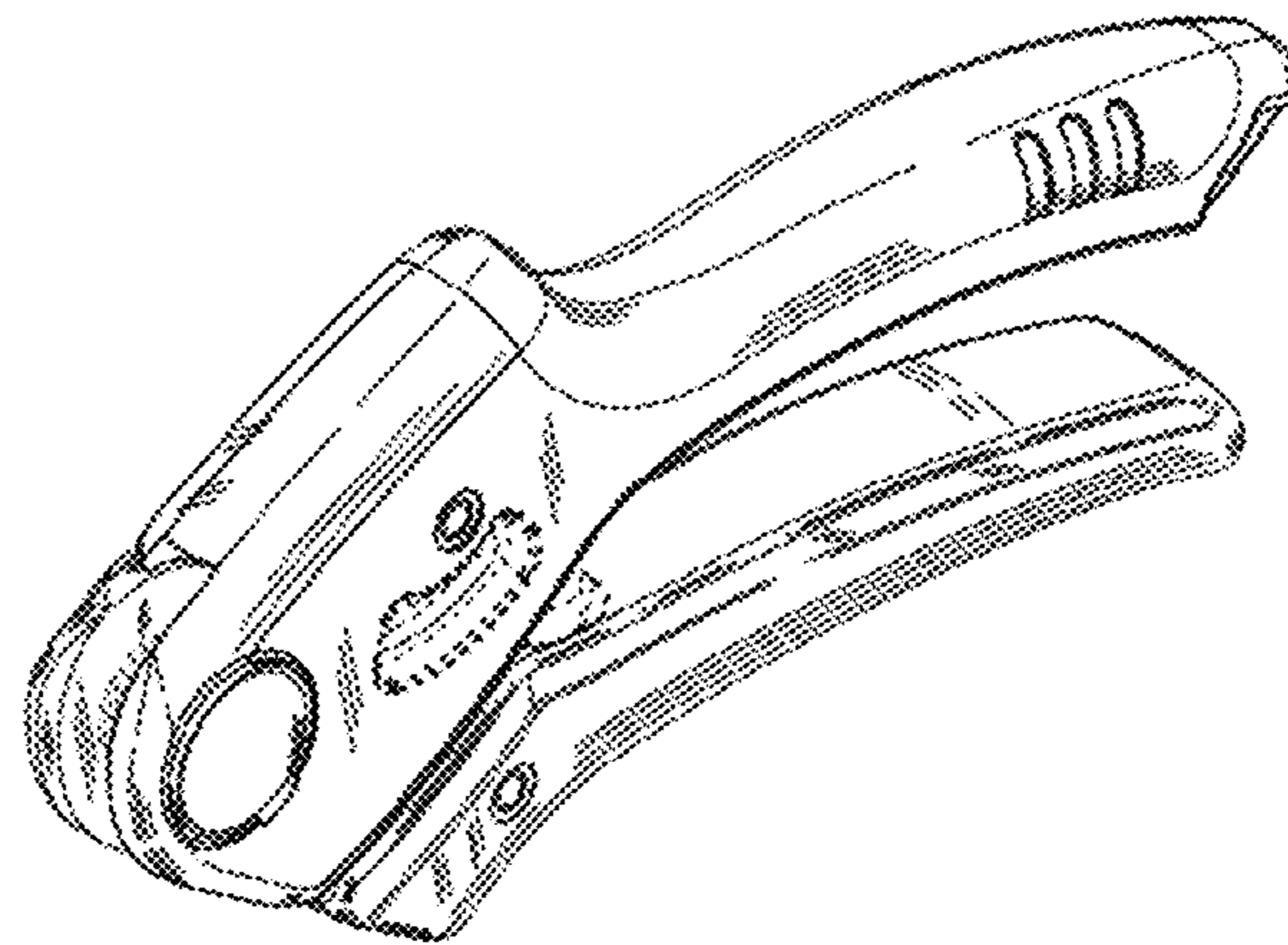

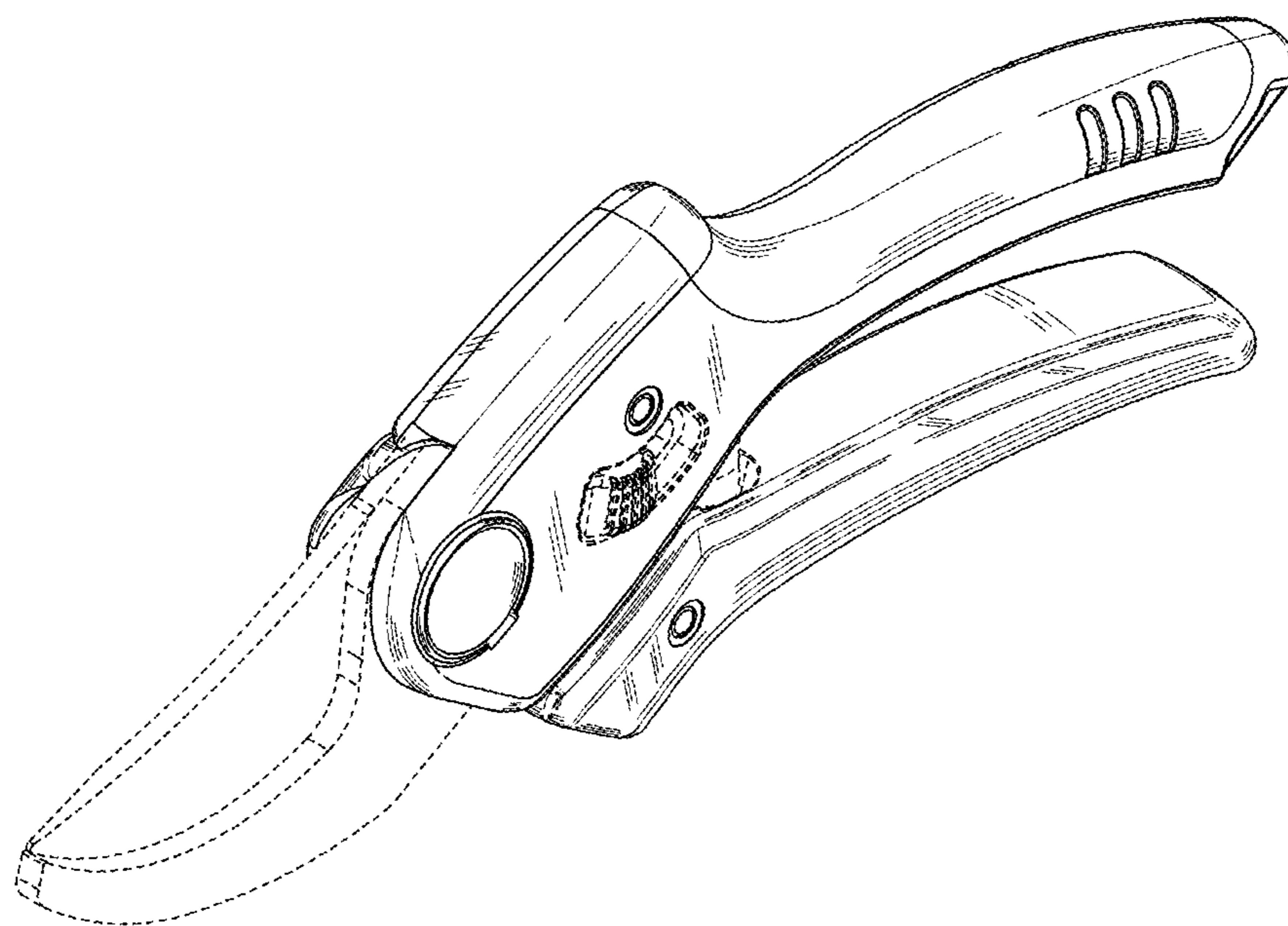

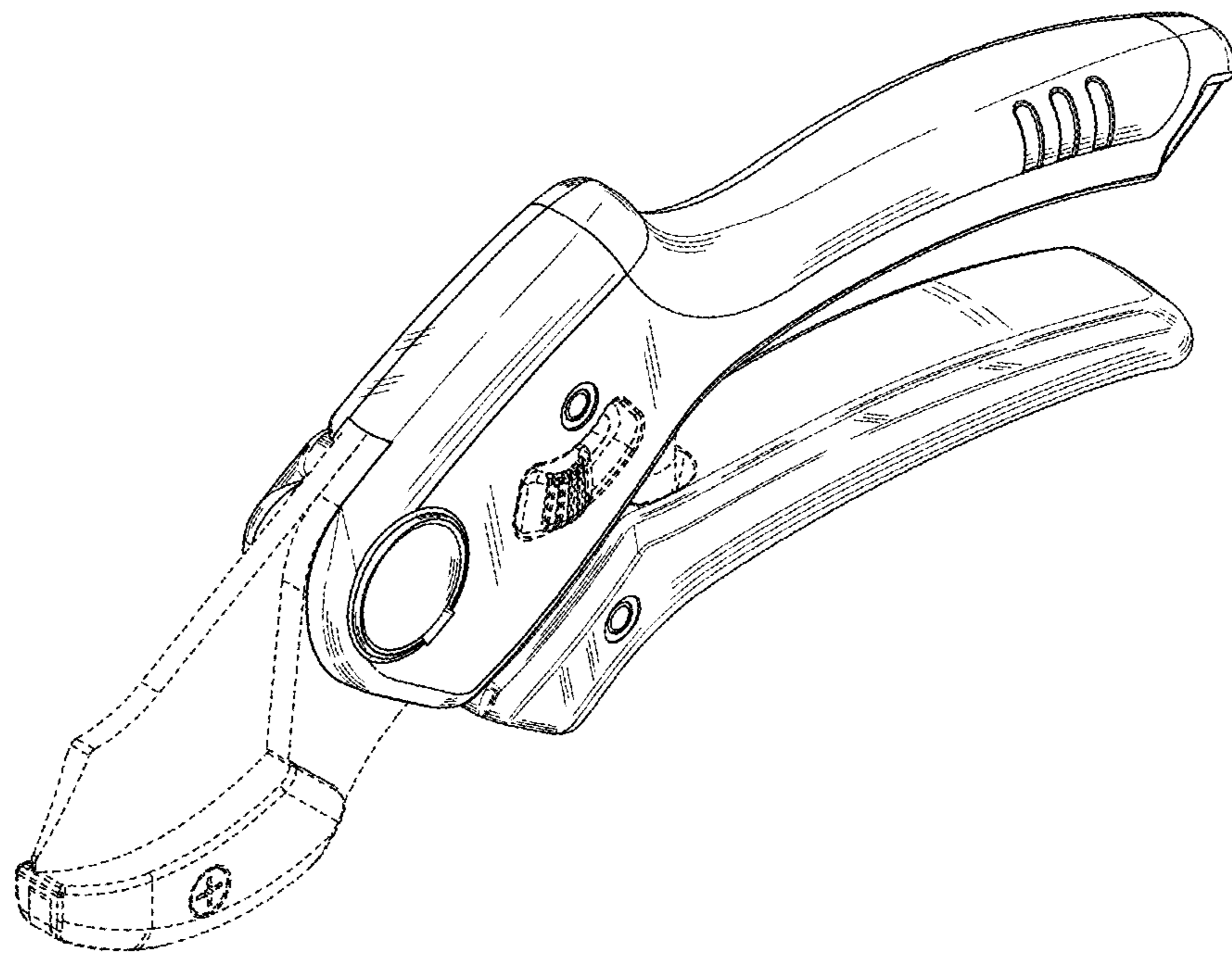
